The ornamental design for a vehicle quarter fender, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle quarter fender showing our new design;

FIG. 2 is an enlarged right side elevation view thereof;

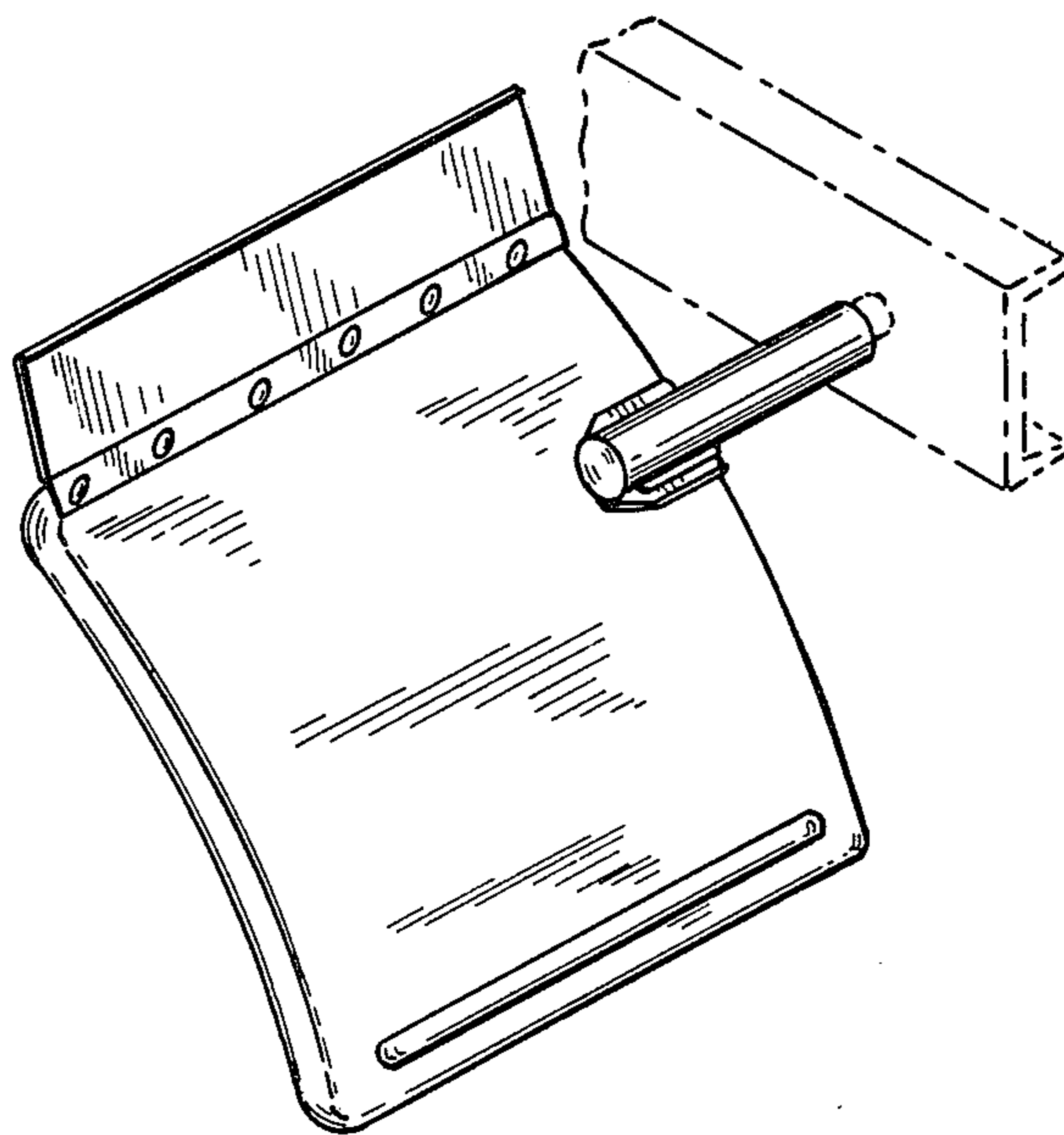
FIG. 3 is an enlarged left side elevation view thereof;

FIG. 4 is an enlarged top plan view thereof;

FIG. 5 is an enlarged bottom plan view thereof; and

FIG. 6 is a perspective view of a vehicle quarter fender showing a second embodiment of our new design the sole difference being in the omission of the top front deflector shield.

The broken lines in the drawing are for illustrative purposes only and form no part of the claimed design.



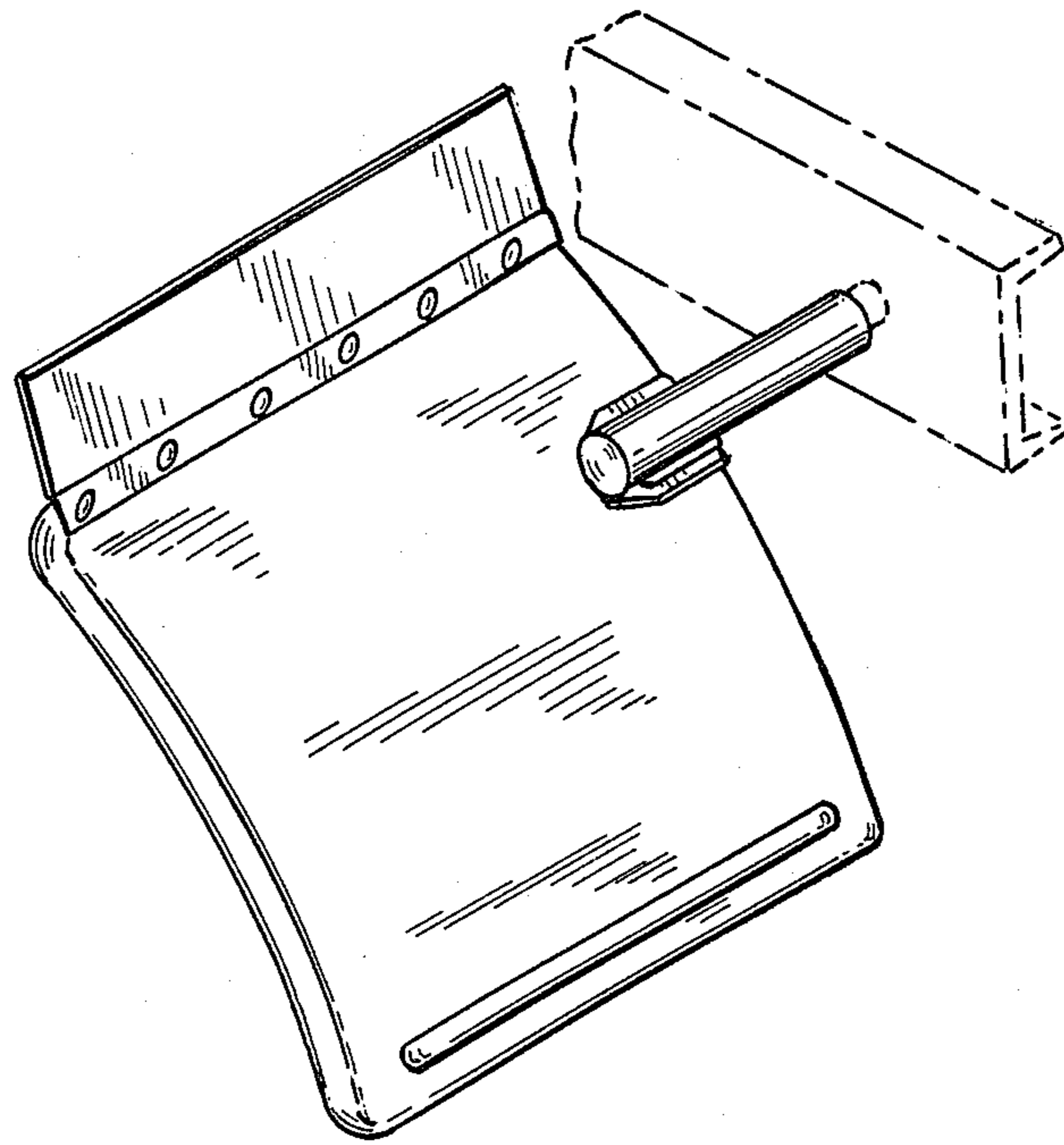

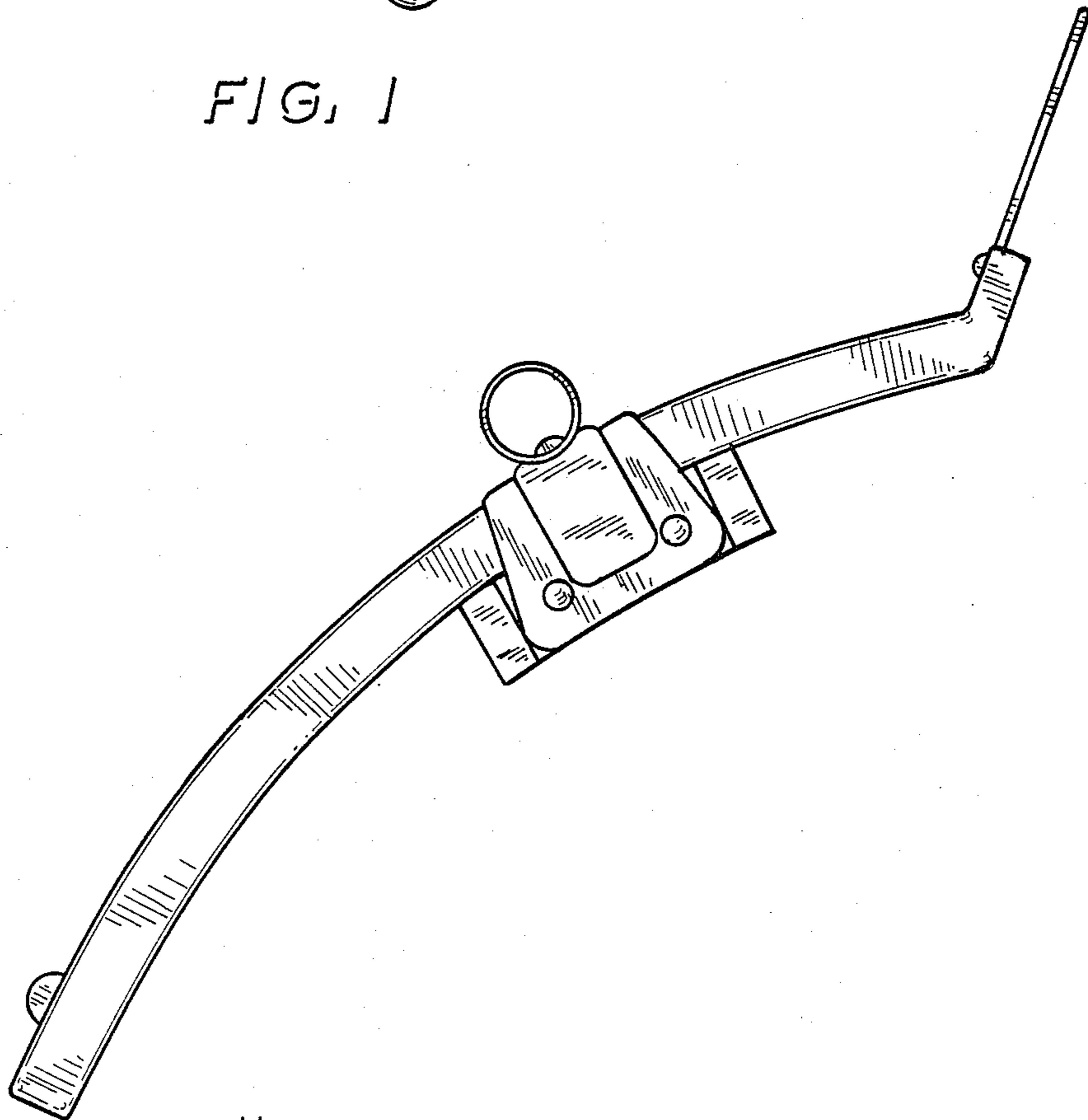

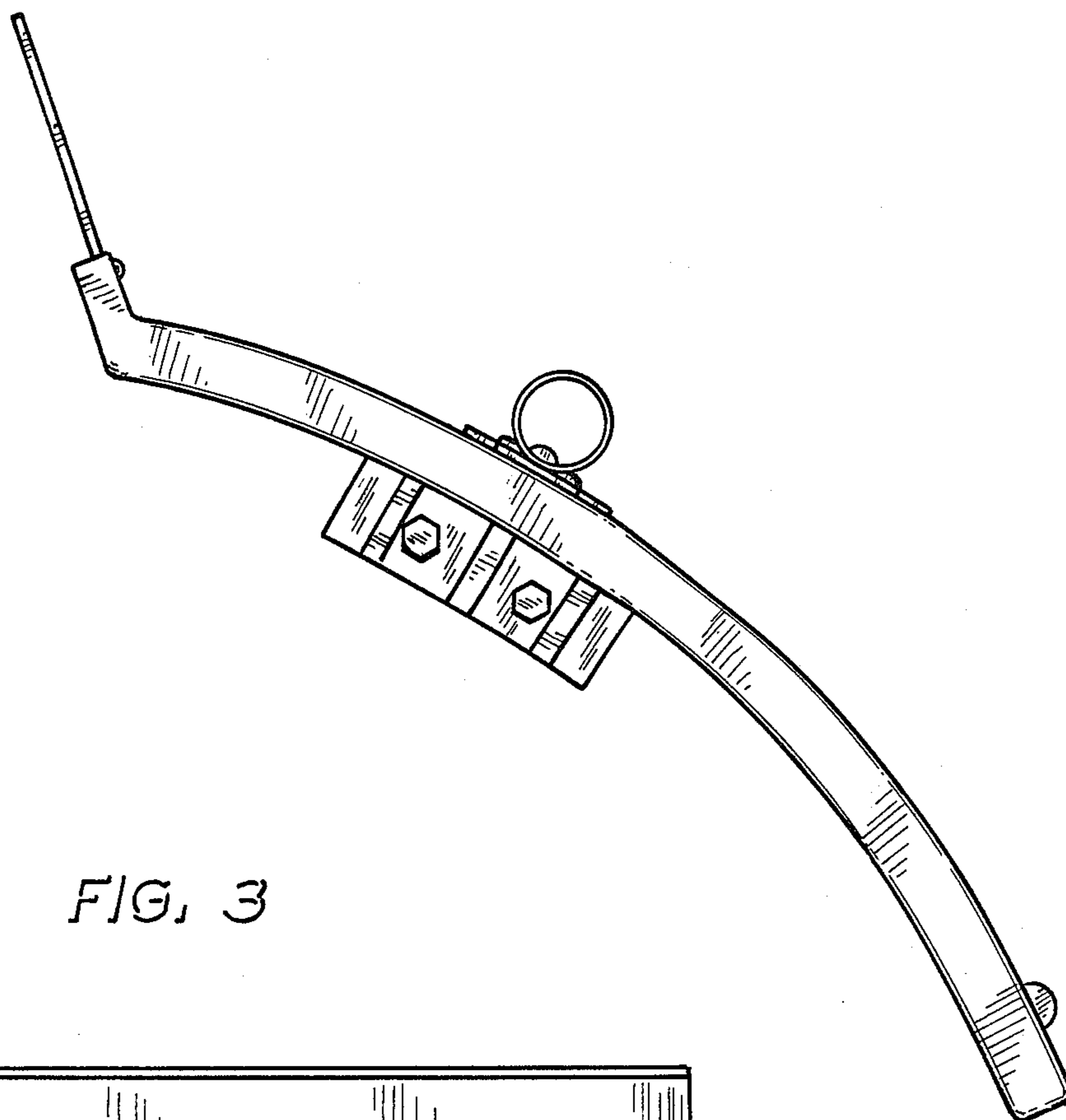

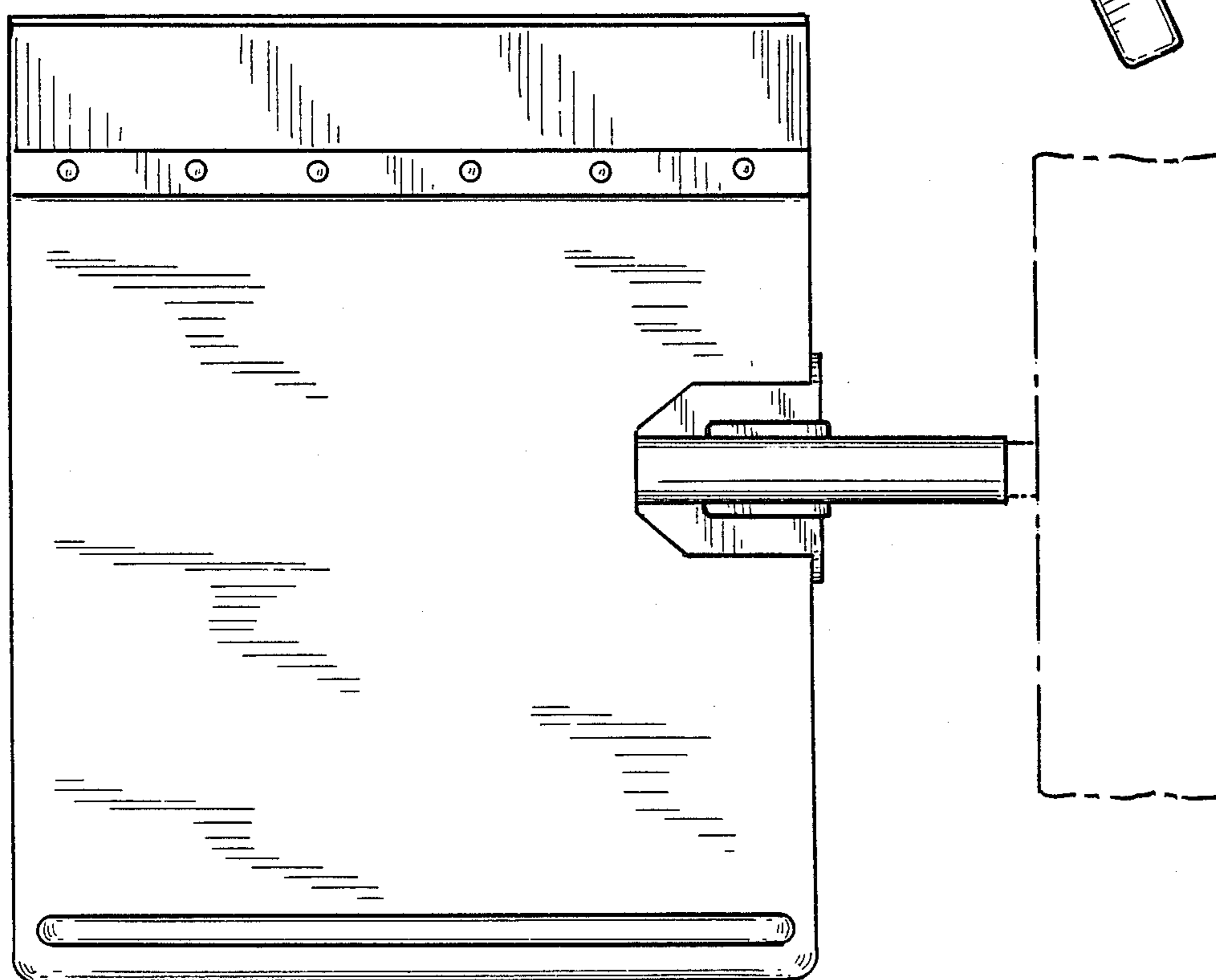

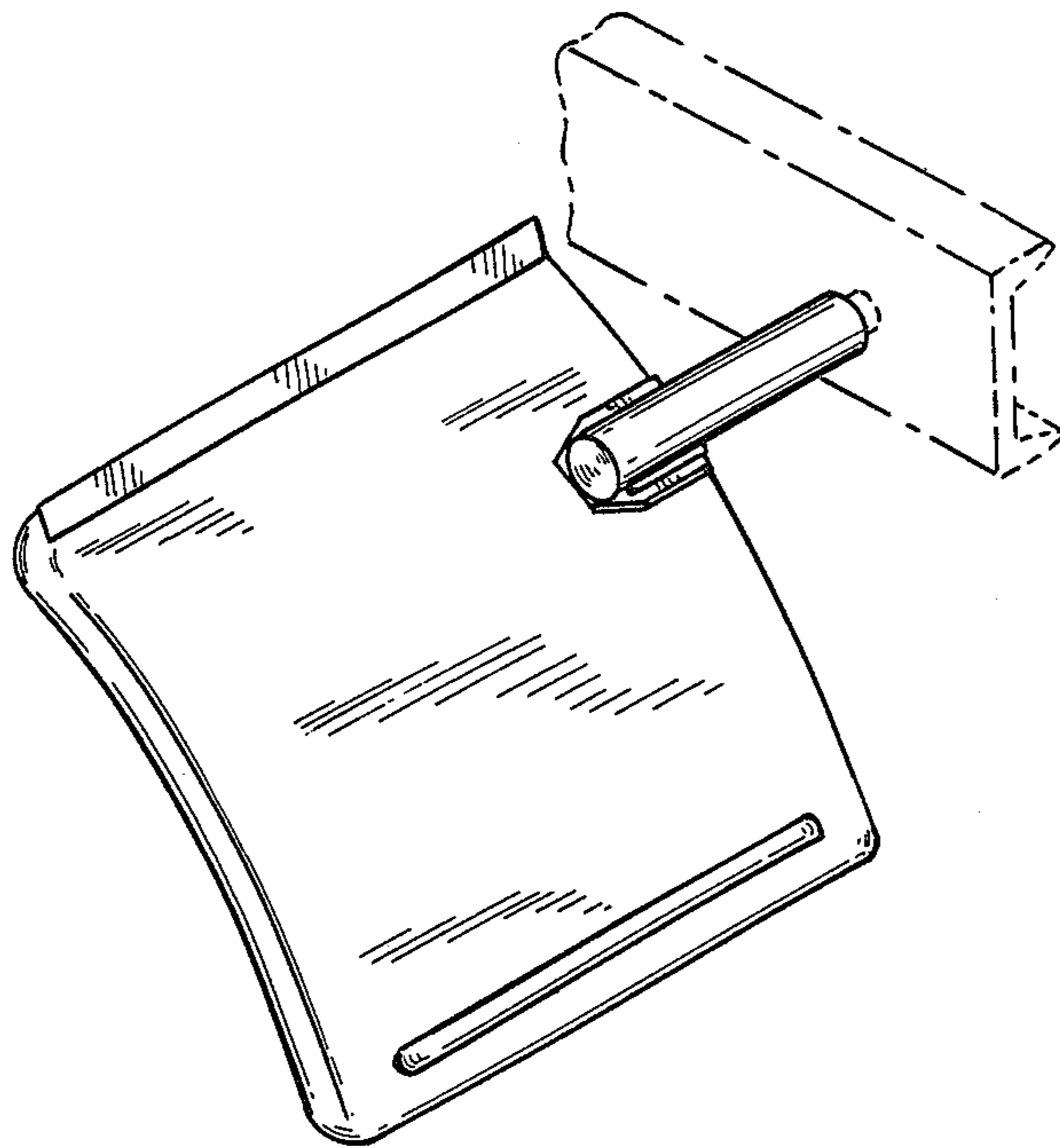

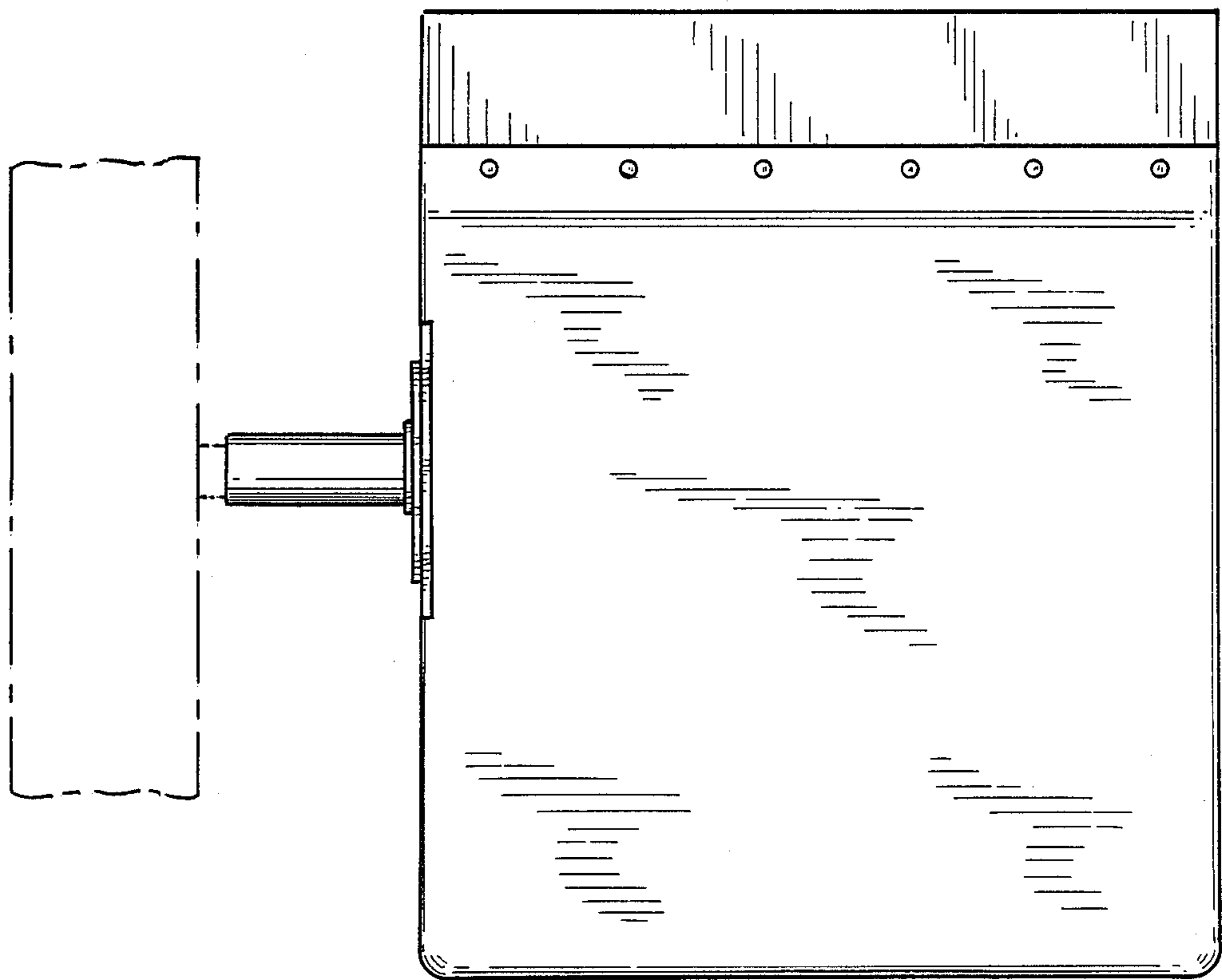
