The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing my new design;
 FIG. 2 is a side elevation, the opposite side being a mirror image thereof;
 FIG. 3 is a front elevation thereof;
 FIG. 4 is a rear elevation view thereof;
 FIG. 5 is a top view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a perspective view of a first modified form of the bottle;
 FIG. 8 is a side elevational view of the right side of FIG. 7;
 FIG. 9 is a side elevational view of the left side of FIG. 7;
 FIG. 10 is a rear elevational view of FIG. 7;
 FIG. 11 is a front elevational view of FIG. 7;

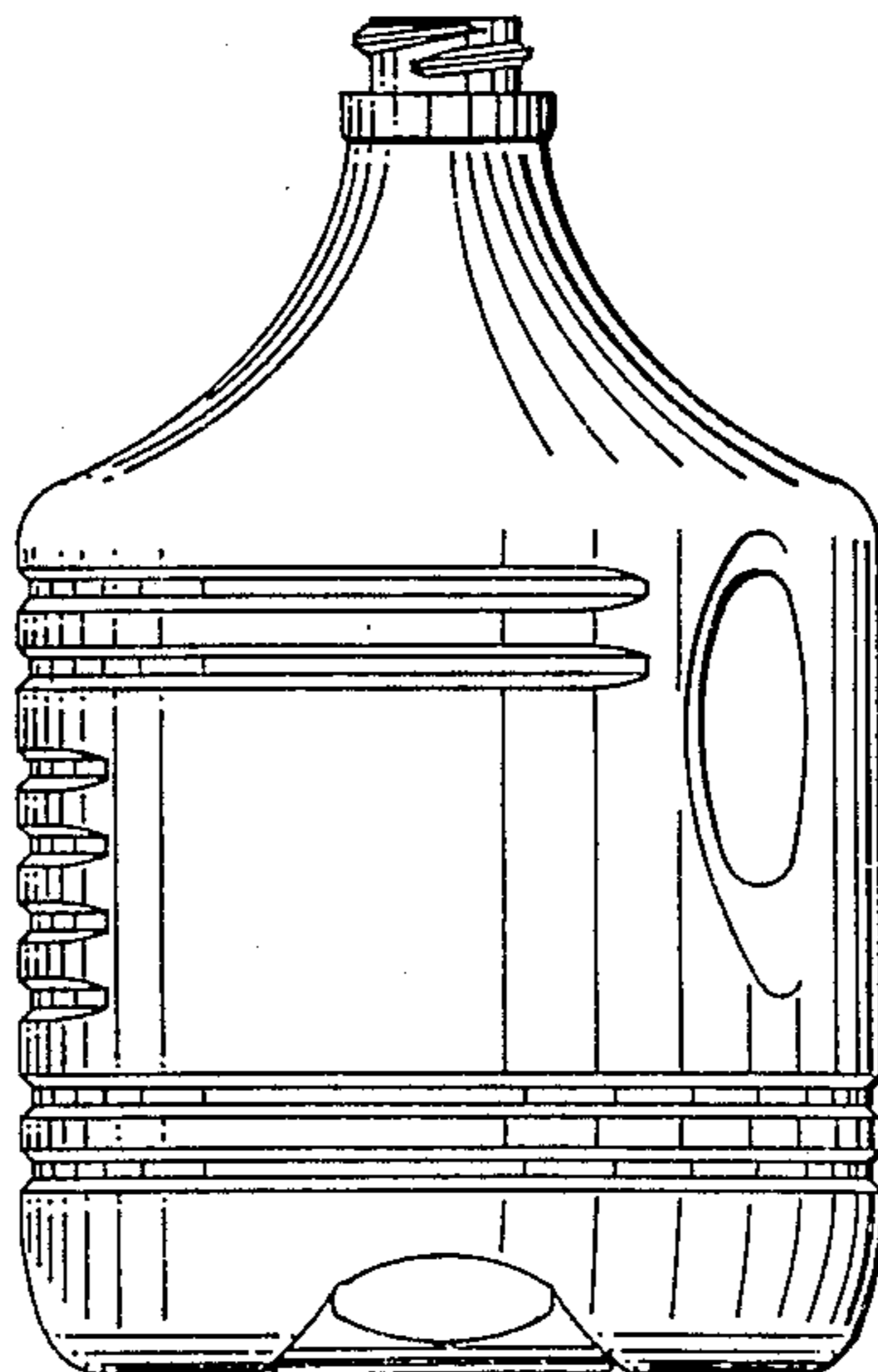


FIG. 12 is a top view of FIG. 7;

FIG. 19 is a top view of FIG. 14.

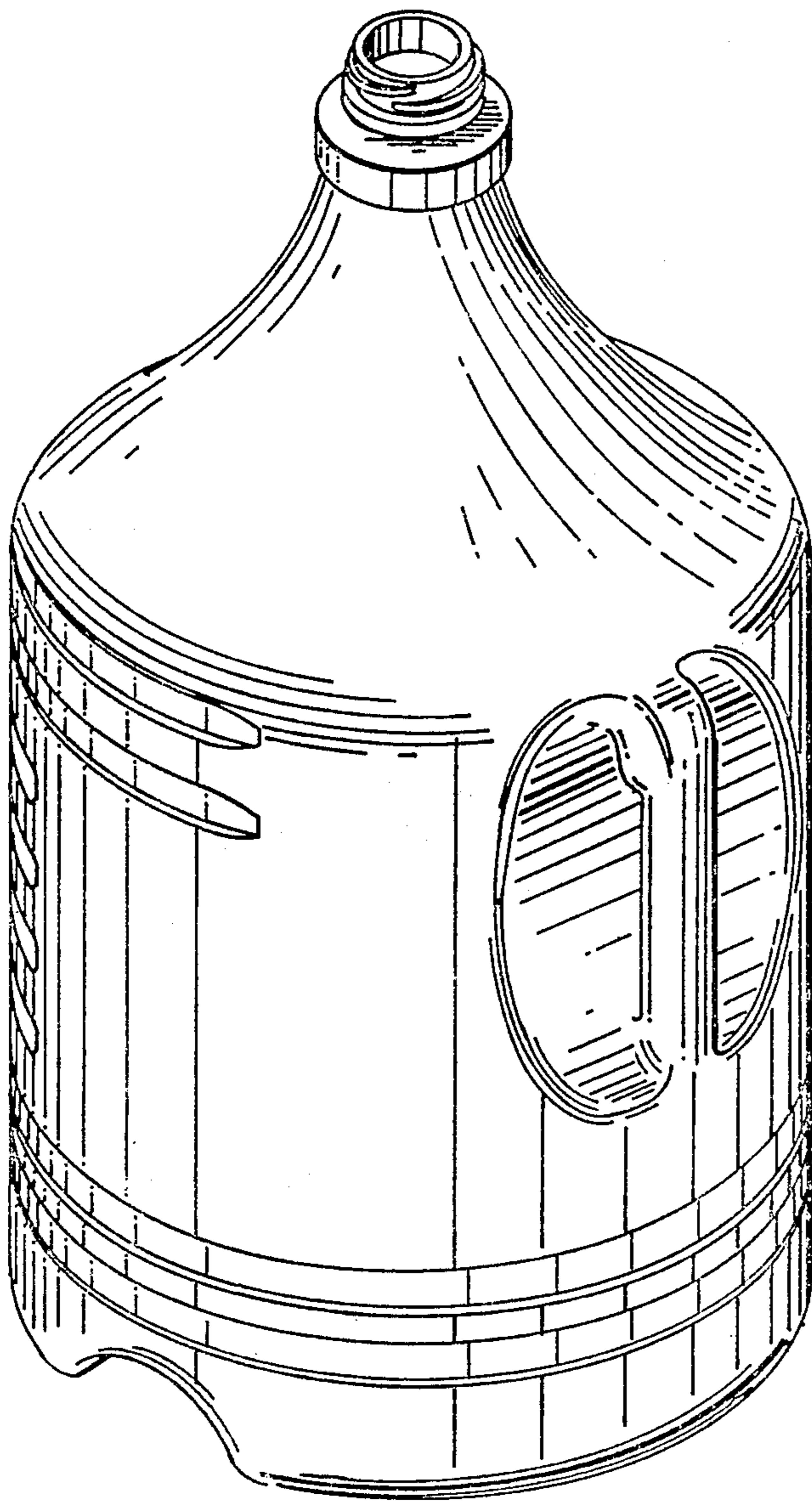

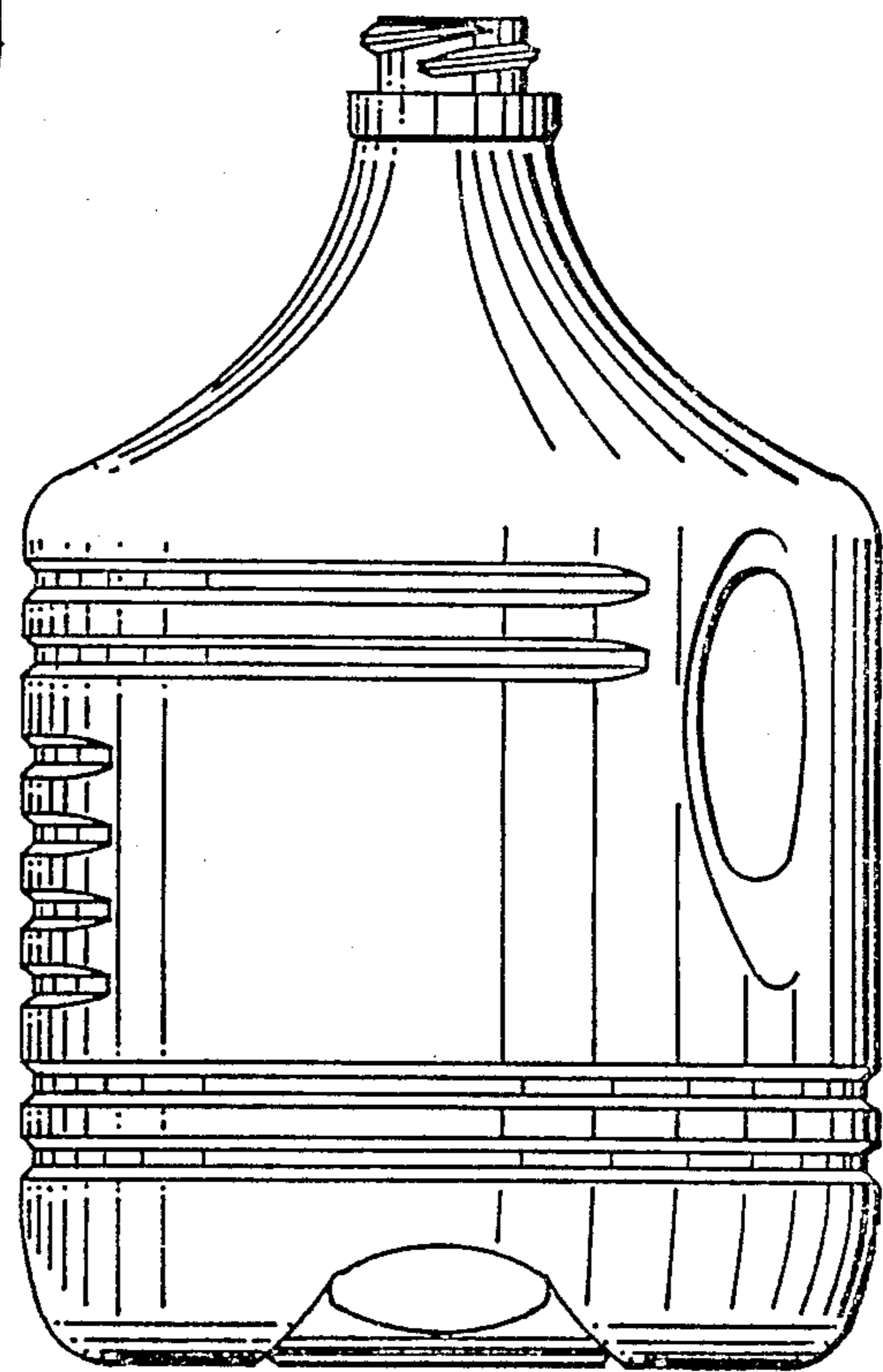

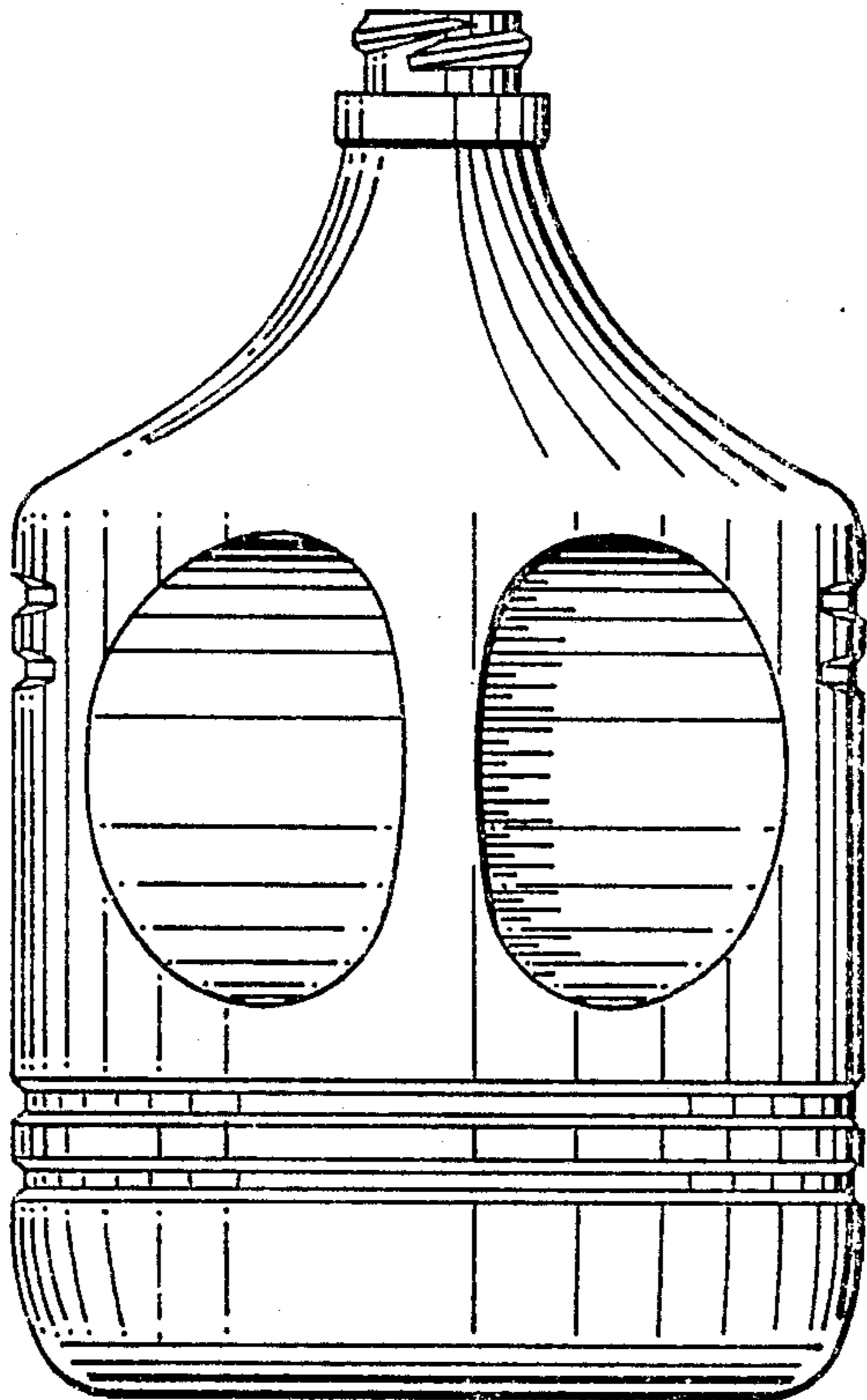

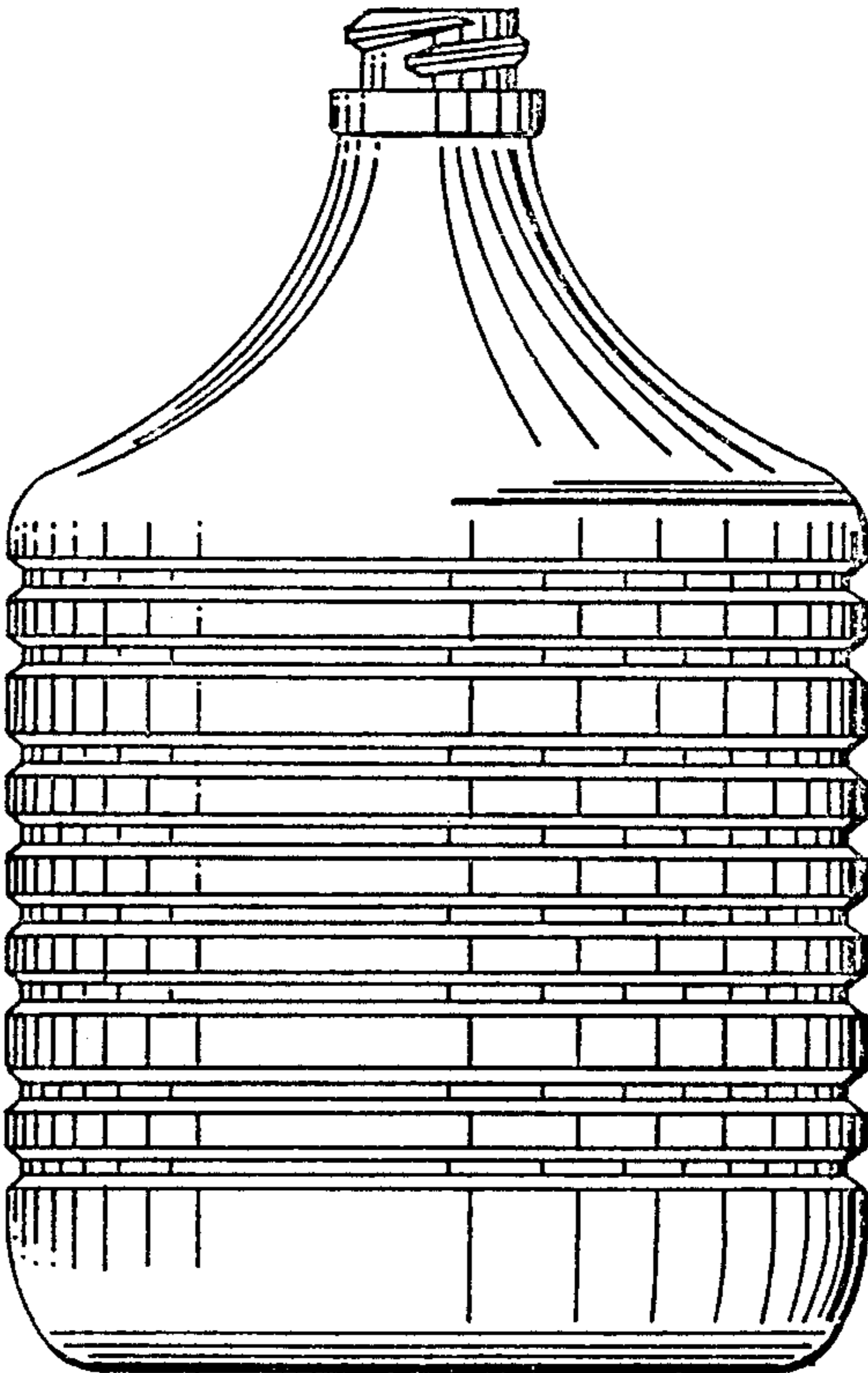

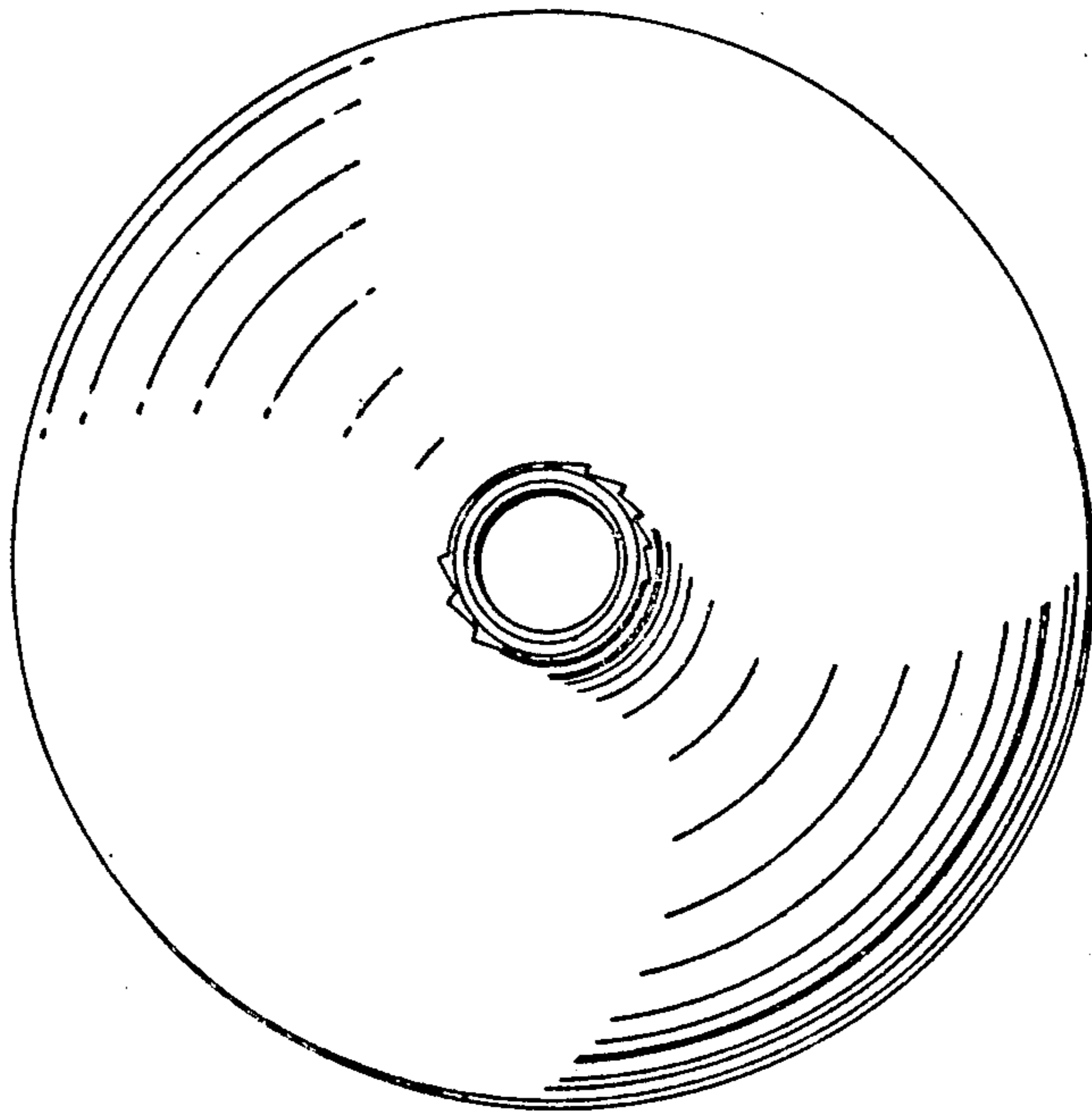
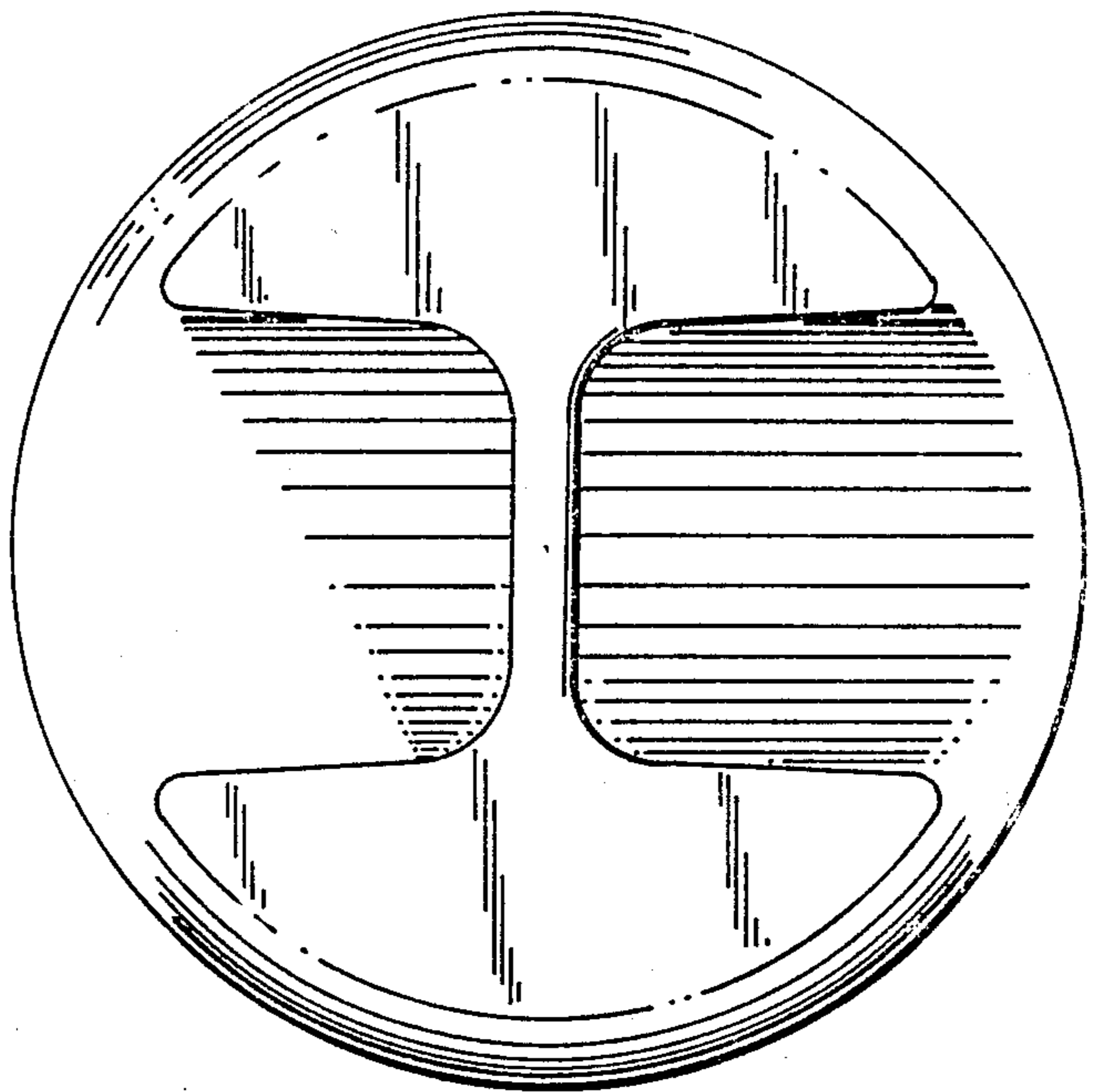

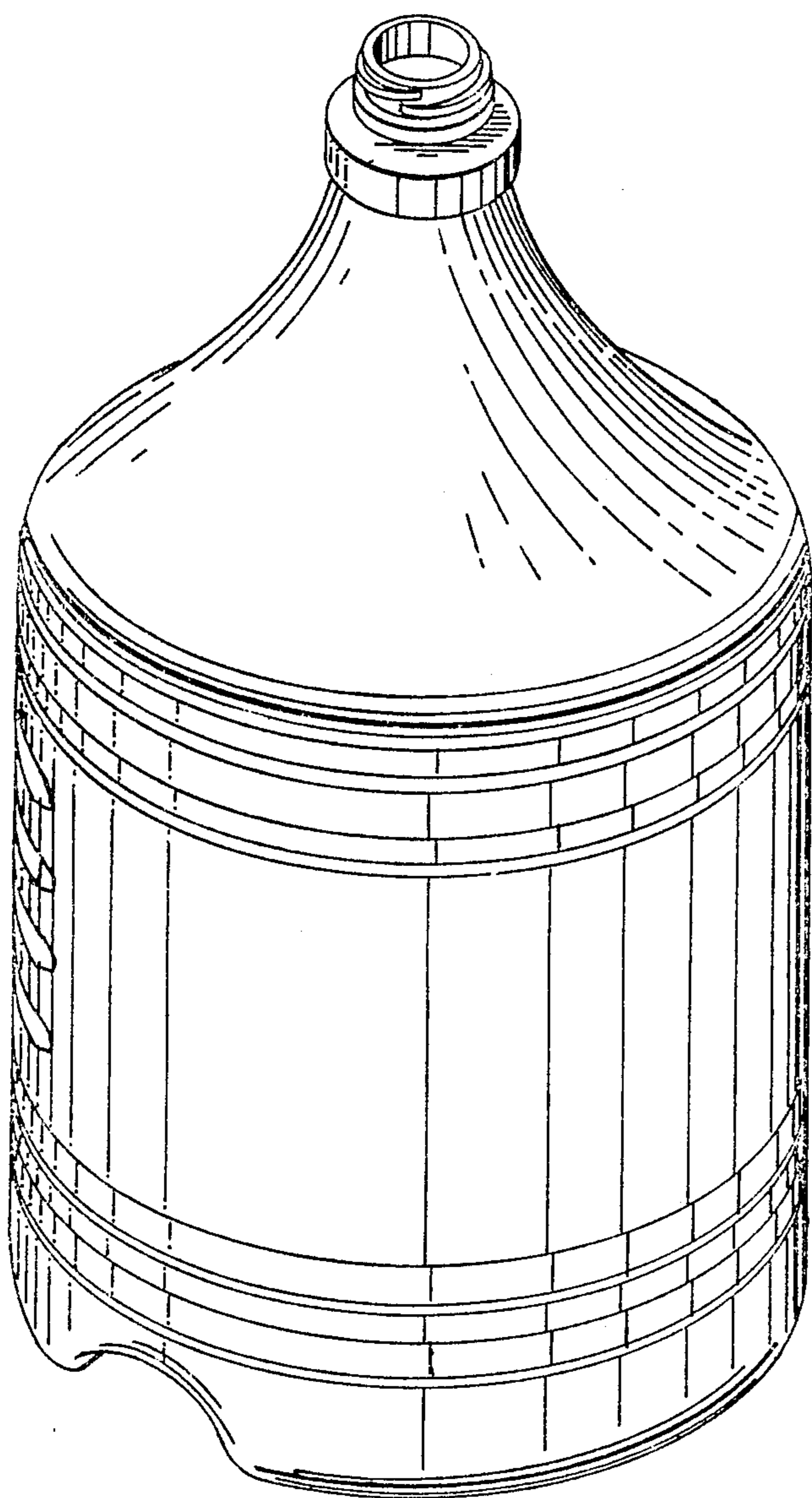

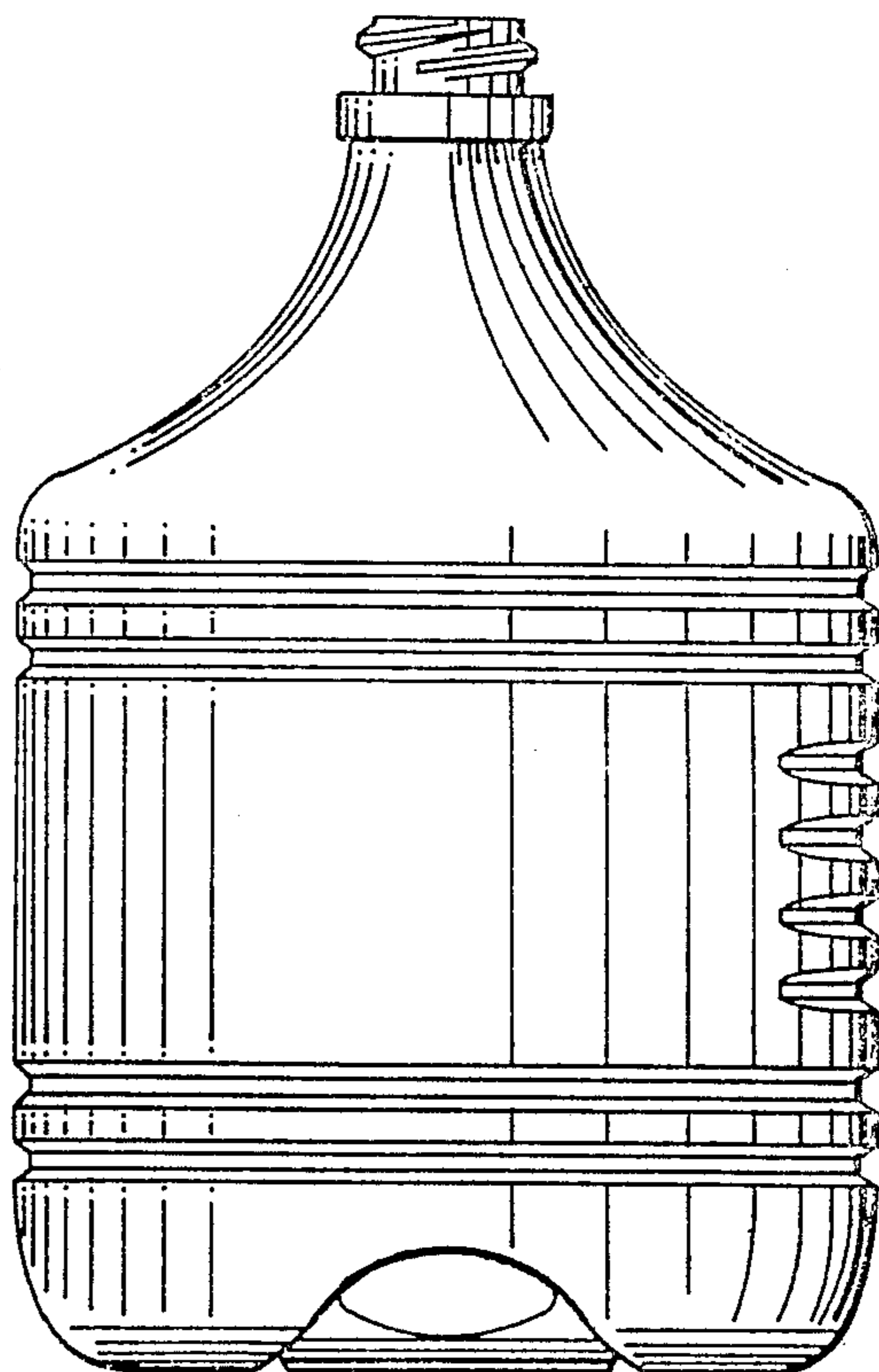

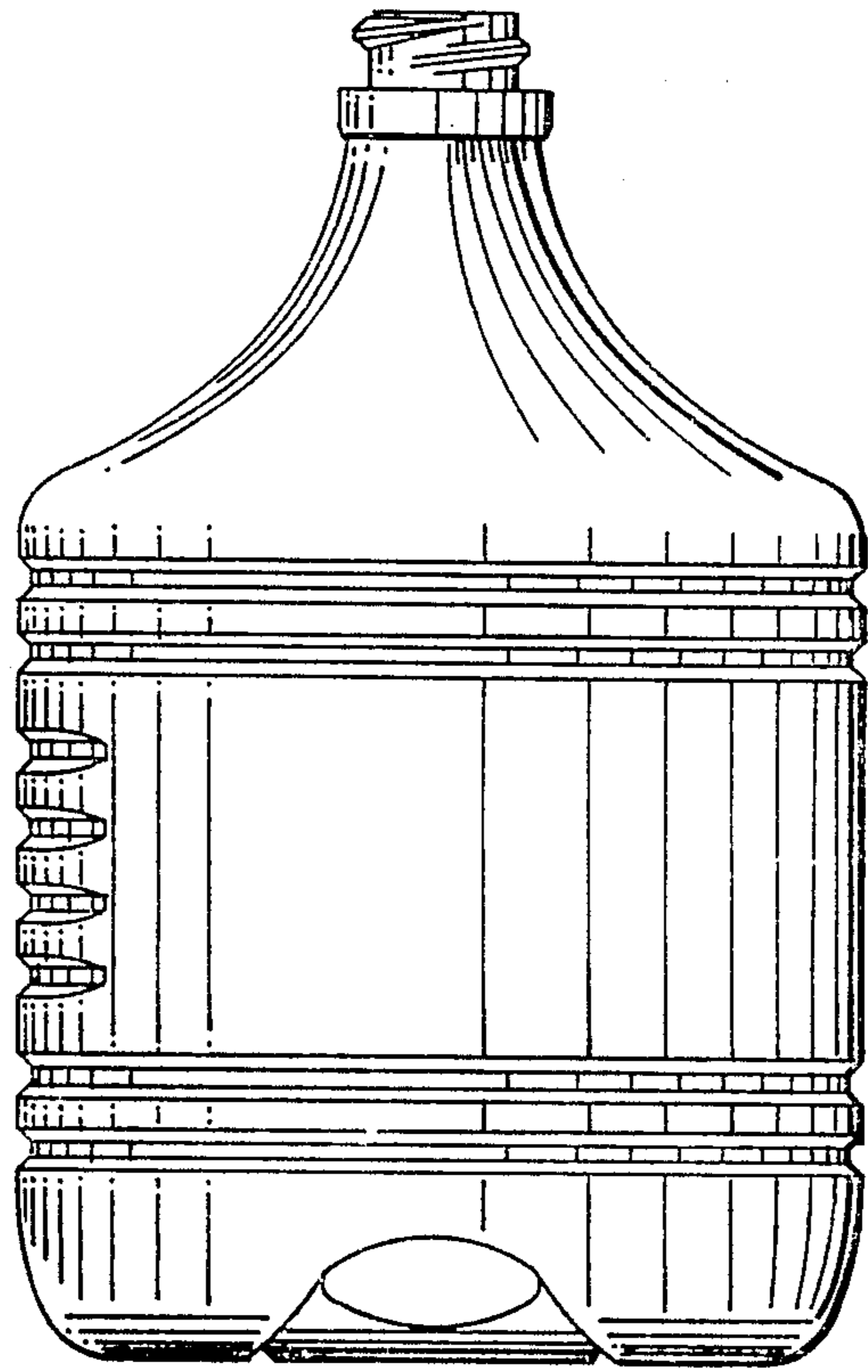

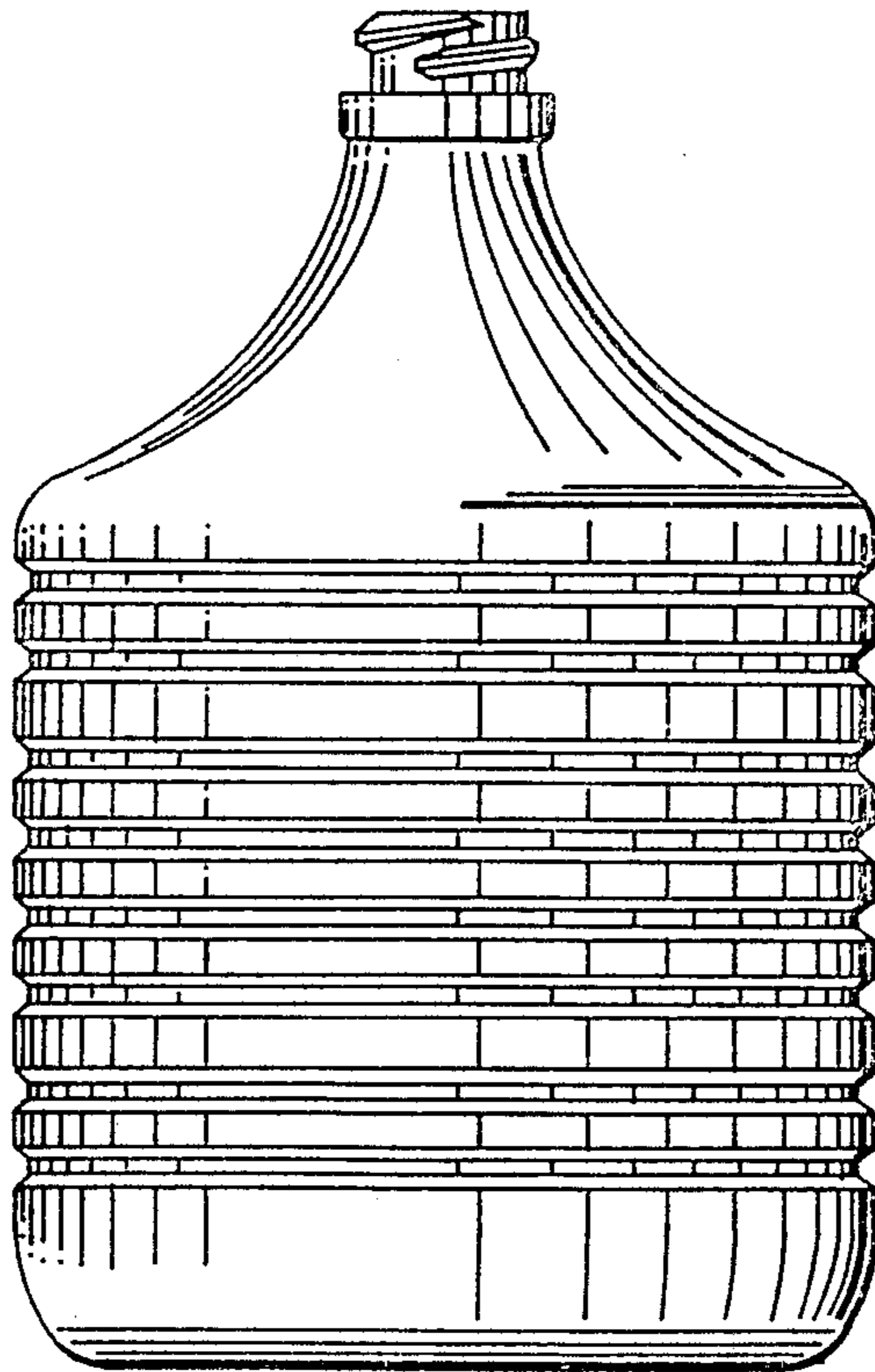

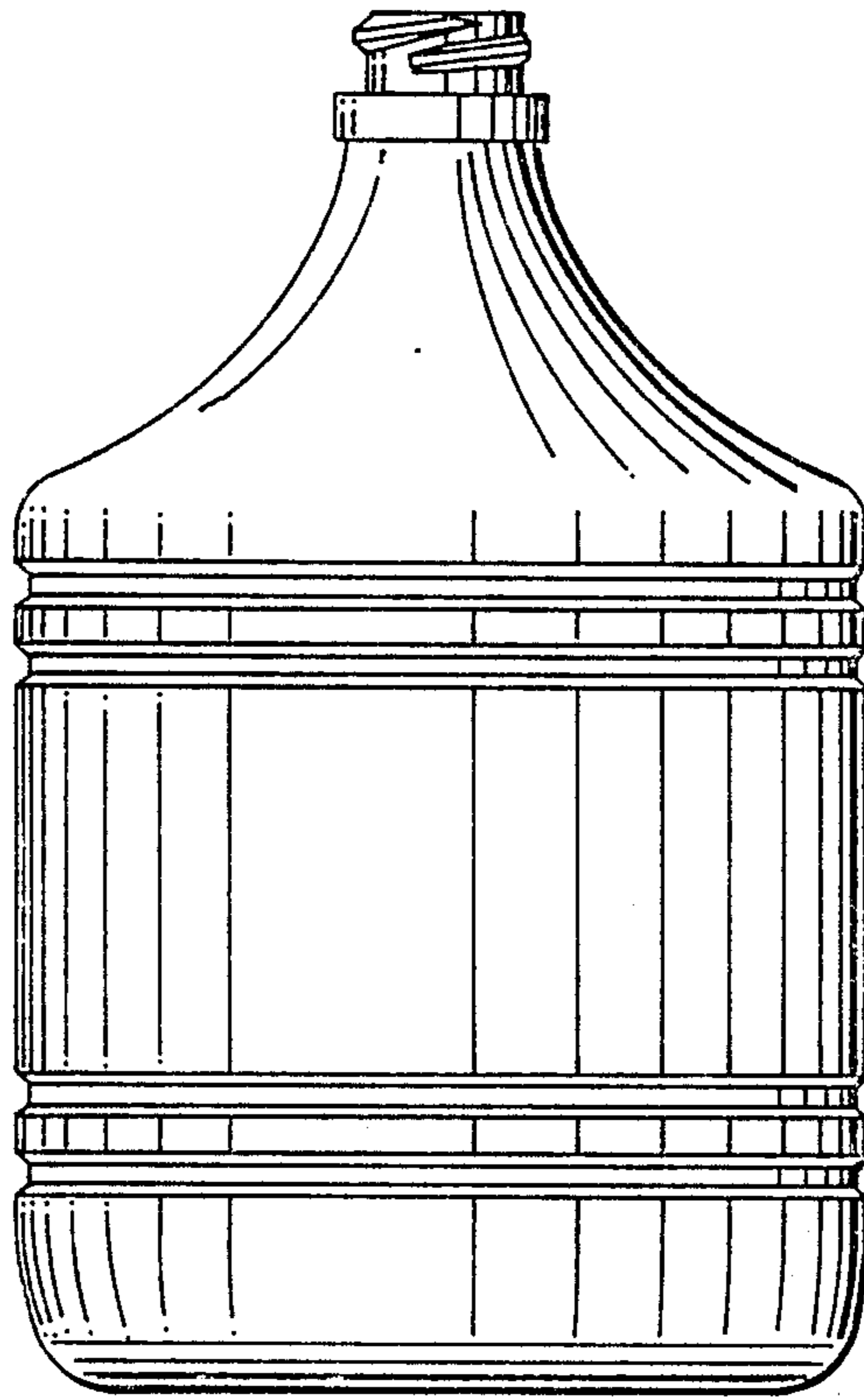

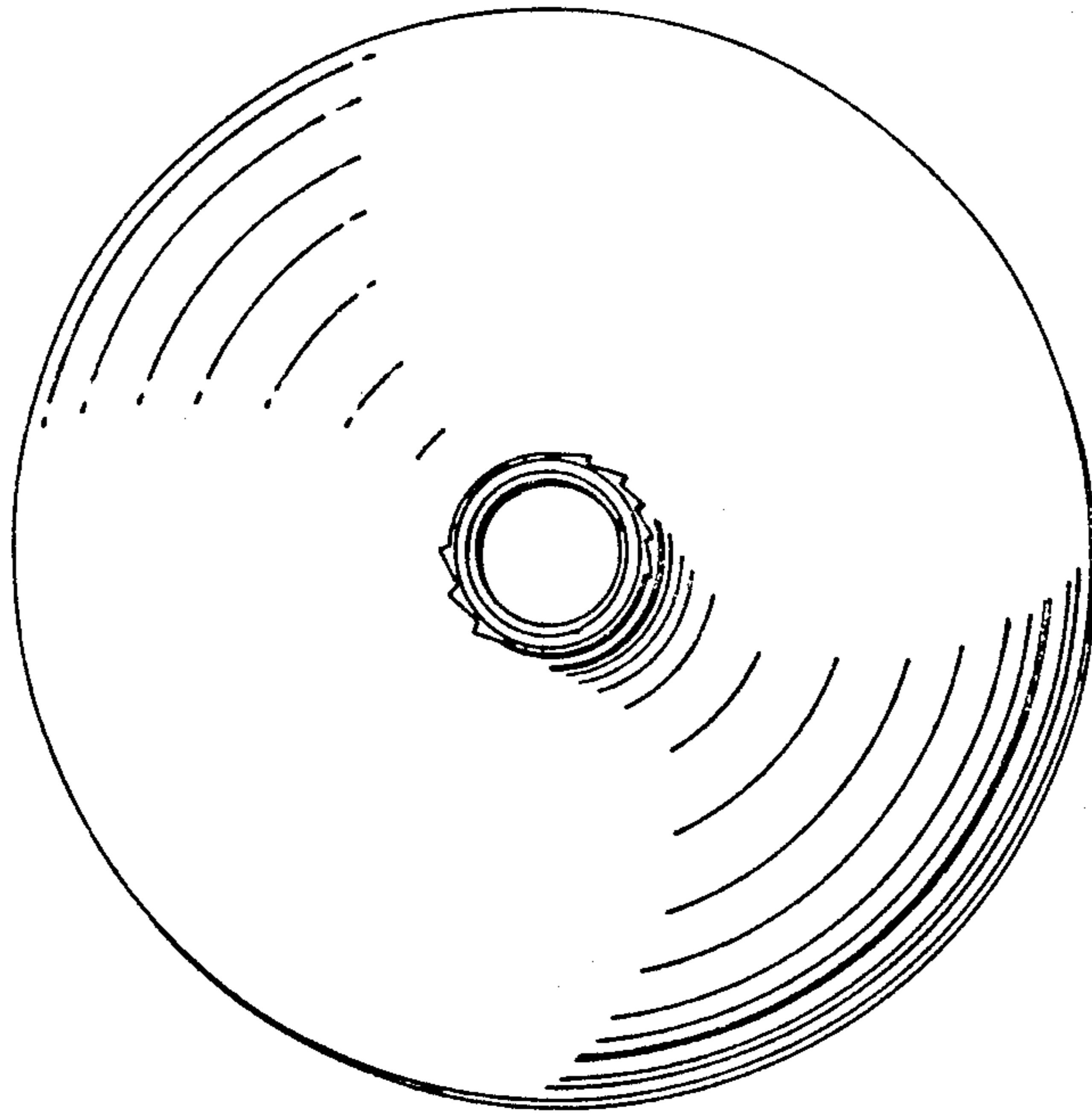
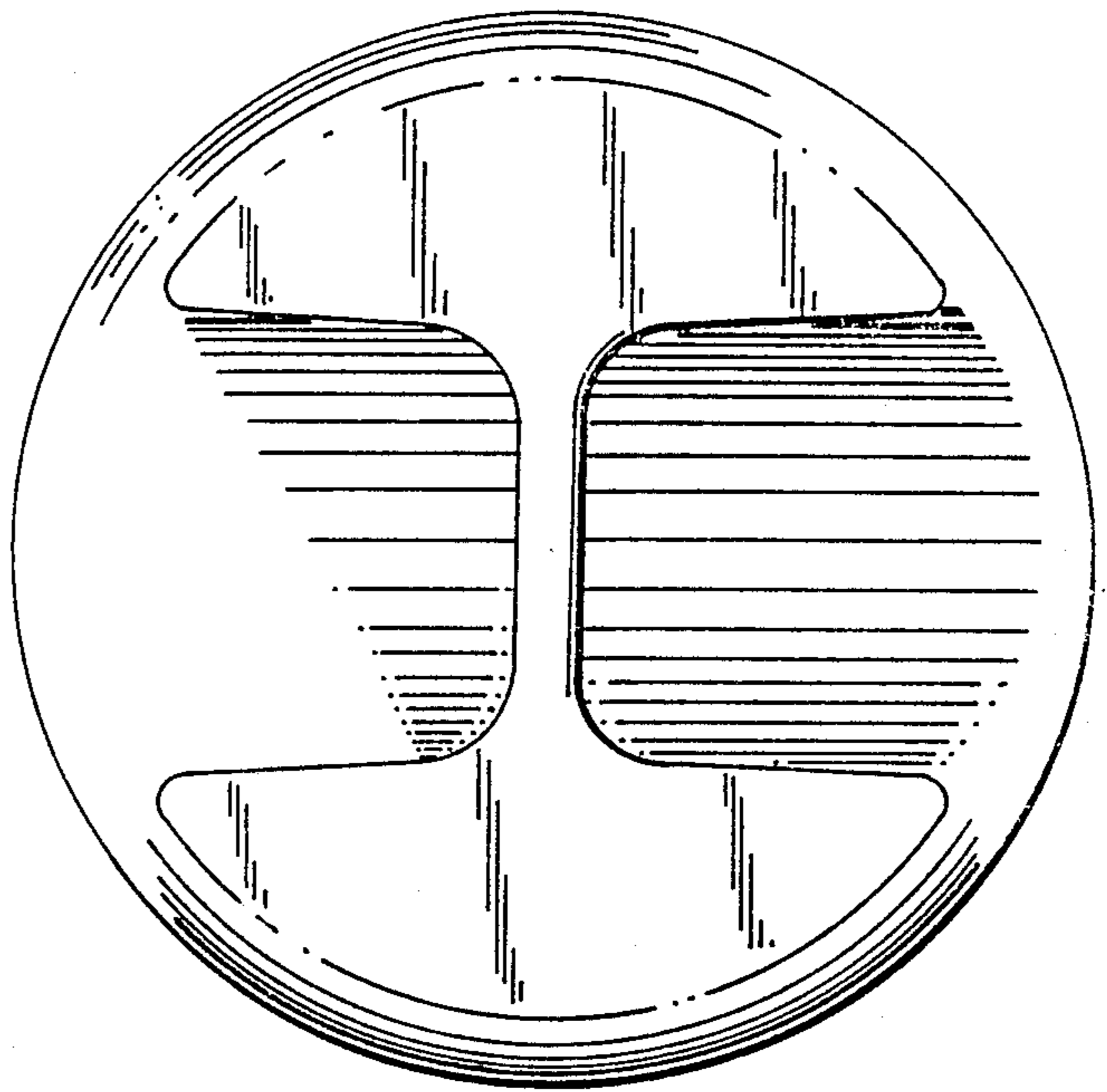

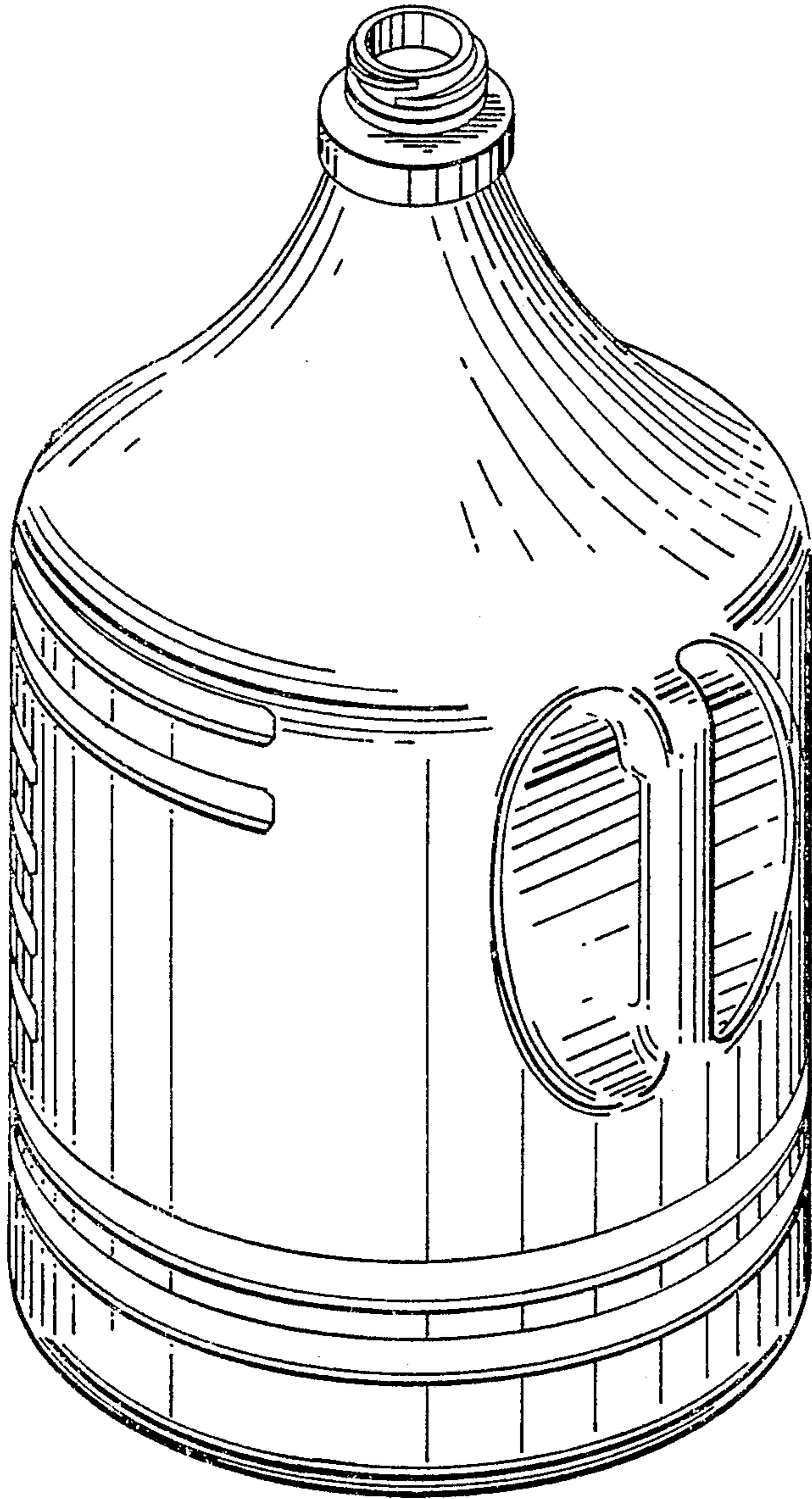

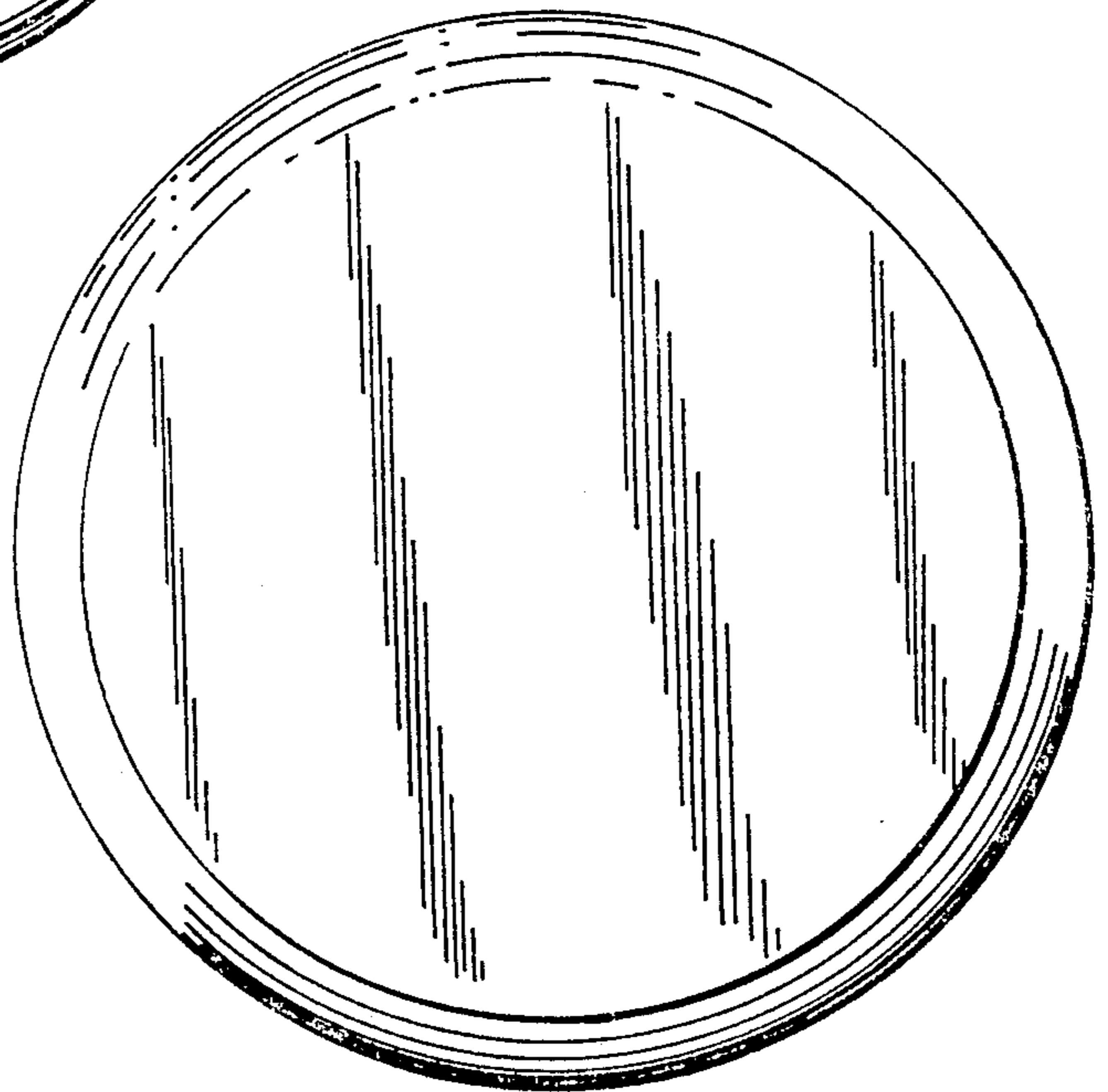

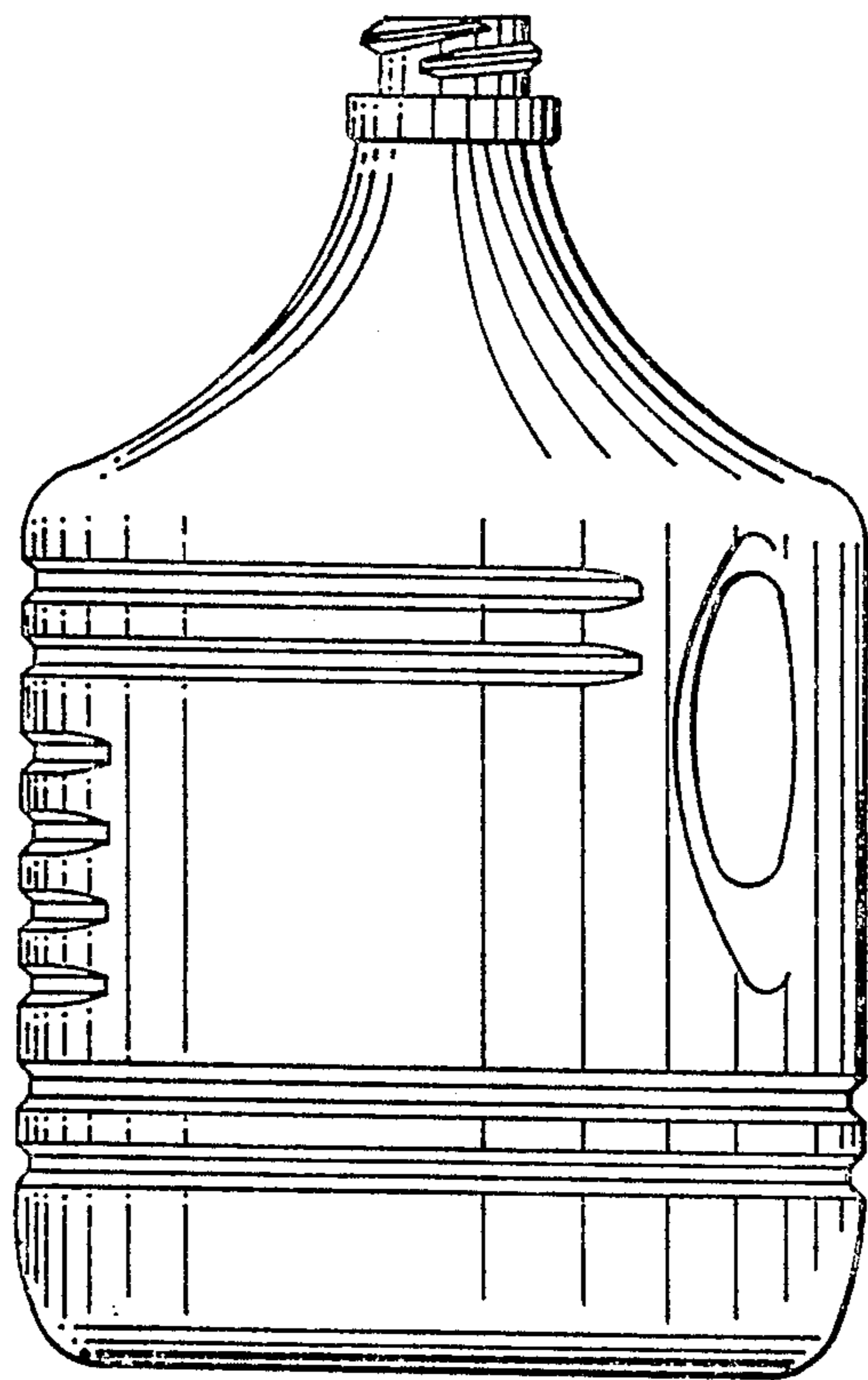

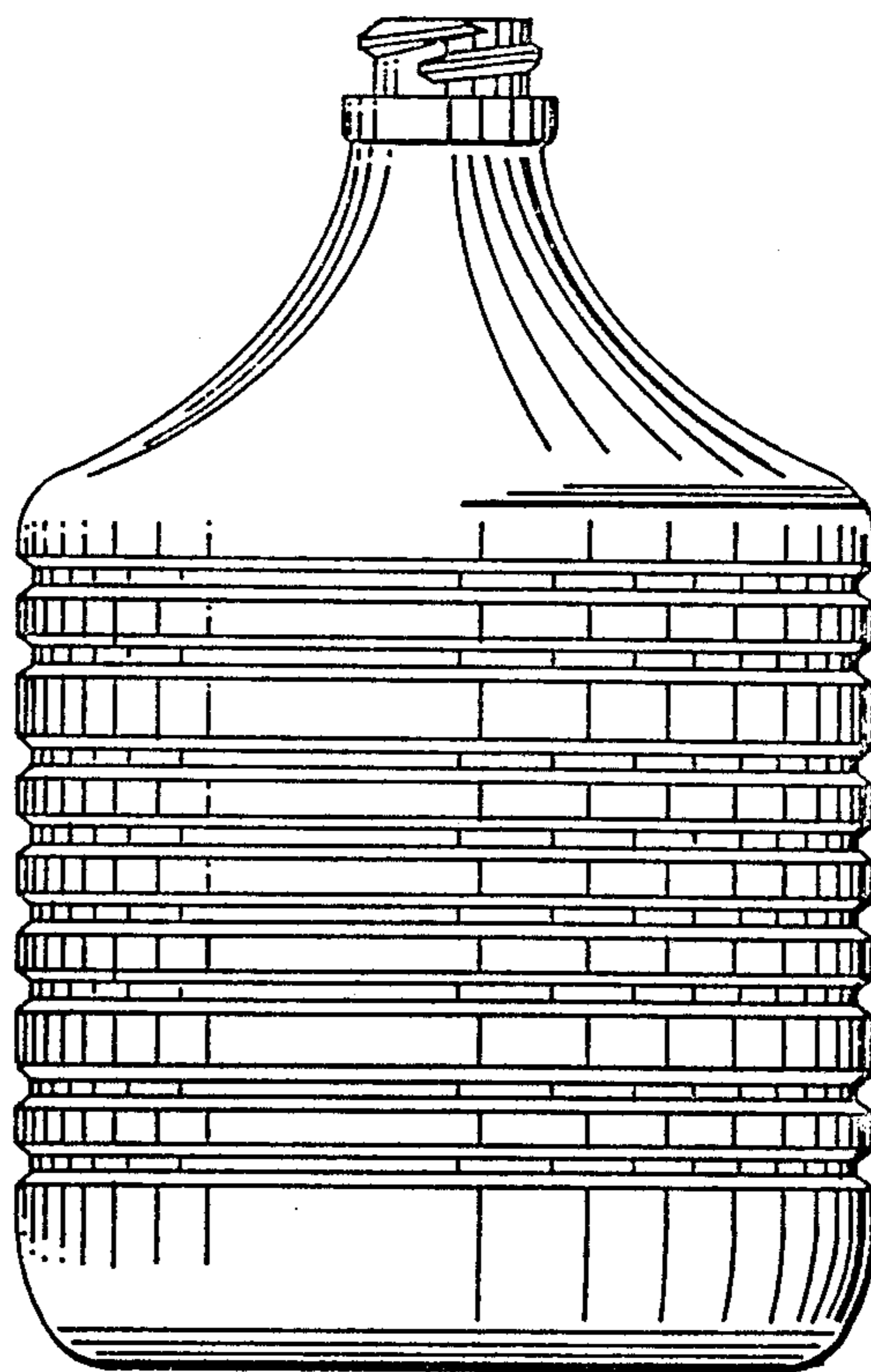

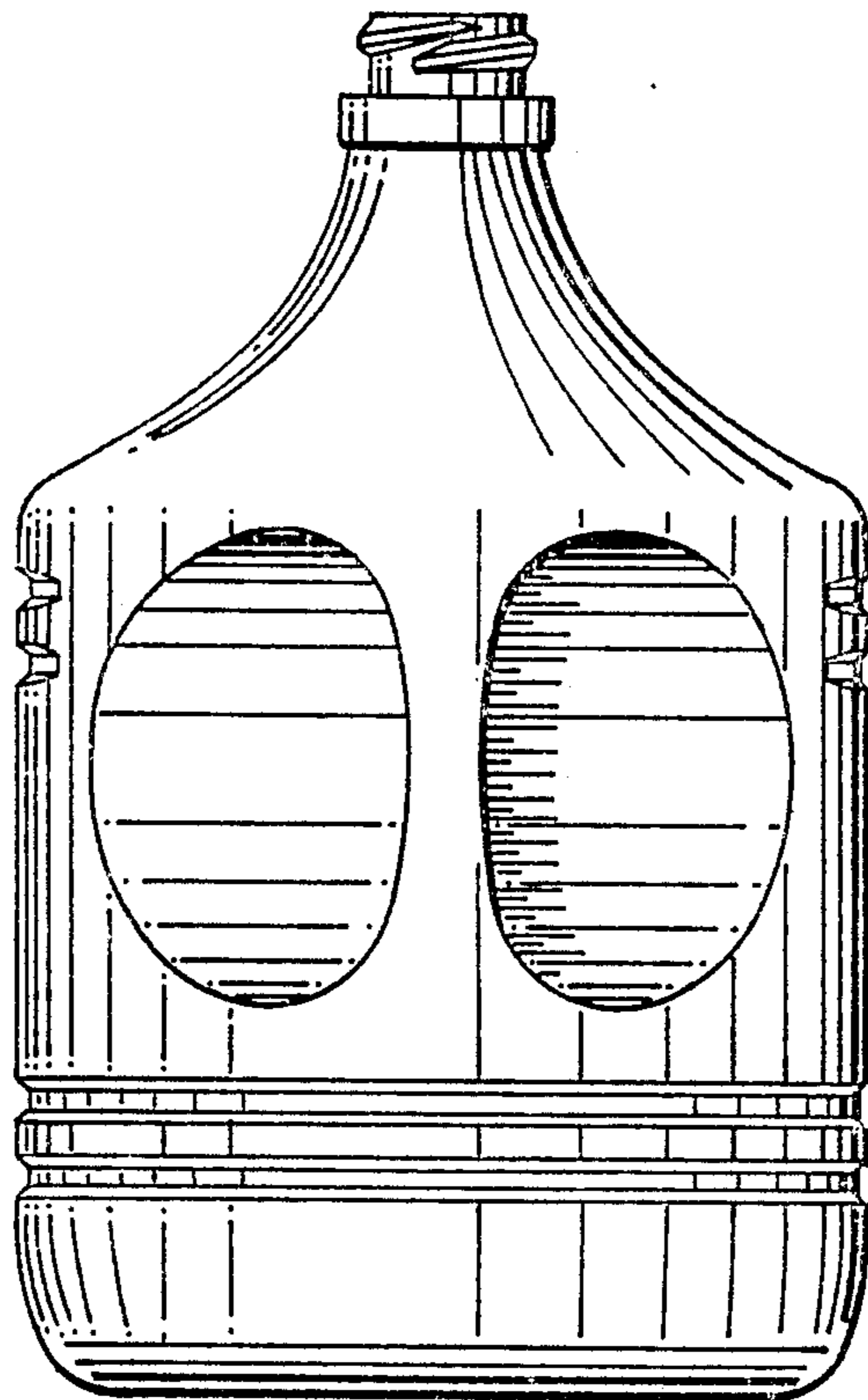
