[57] CLAIM

The ornamental design for an interior door panel for a van, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an interior door panel for a van showing my new design;

FIG. 2 is a front elevation view thereof on a reduced scale;

FIG. 3 is a right side elevation view of FIG. 2;

FIG. 4 is a left side elevation view of FIG. 2;

FIG. 5 is a top plan view of FIG. 2;

FIG. 6 is a bottom plan view of FIG. 2;

FIG. 7 is a perspective view of an interior door panel for a van showing a second embodiment of my new design;

FIG. 8 is a front elevation view of FIG. 7 on a reduced scale;

FIG. 9 is a left side elevation view of FIG. 8;

FIG. 10 is a top plan view of FIG. 8;

FIG. 11 is a bottom plan view of FIG. 8;

FIG. 12 is a perspective view of an interior door panel for a van showing a third embodiment of my new design;

FIG. 13 is a front elevation view of FIG. 12 on a reduced scale;

FIG. 14 is a left side elevation view of FIG. 13;

FIG. 15 is a top plan view of FIG. 13; and

FIG. 16 is a bottom plan view of FIG. 13.

The rear of the interior door panel for a van is substantially plain and unornamented.

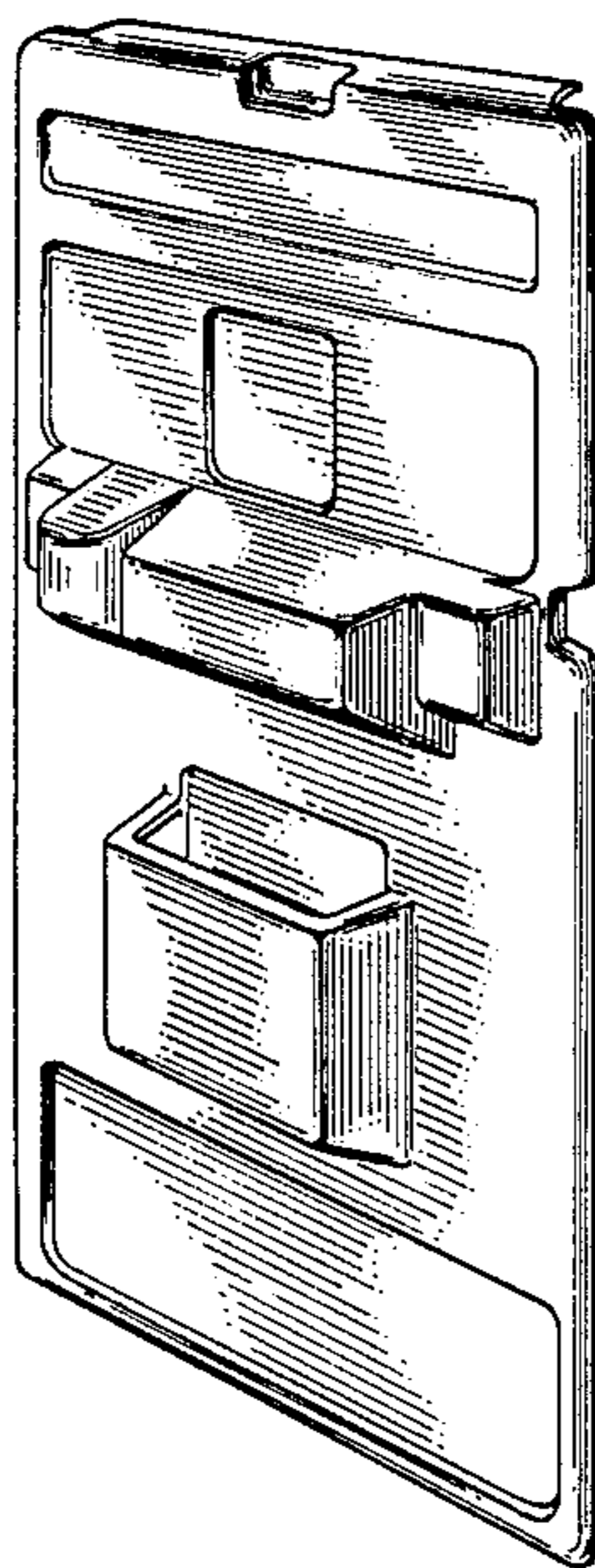

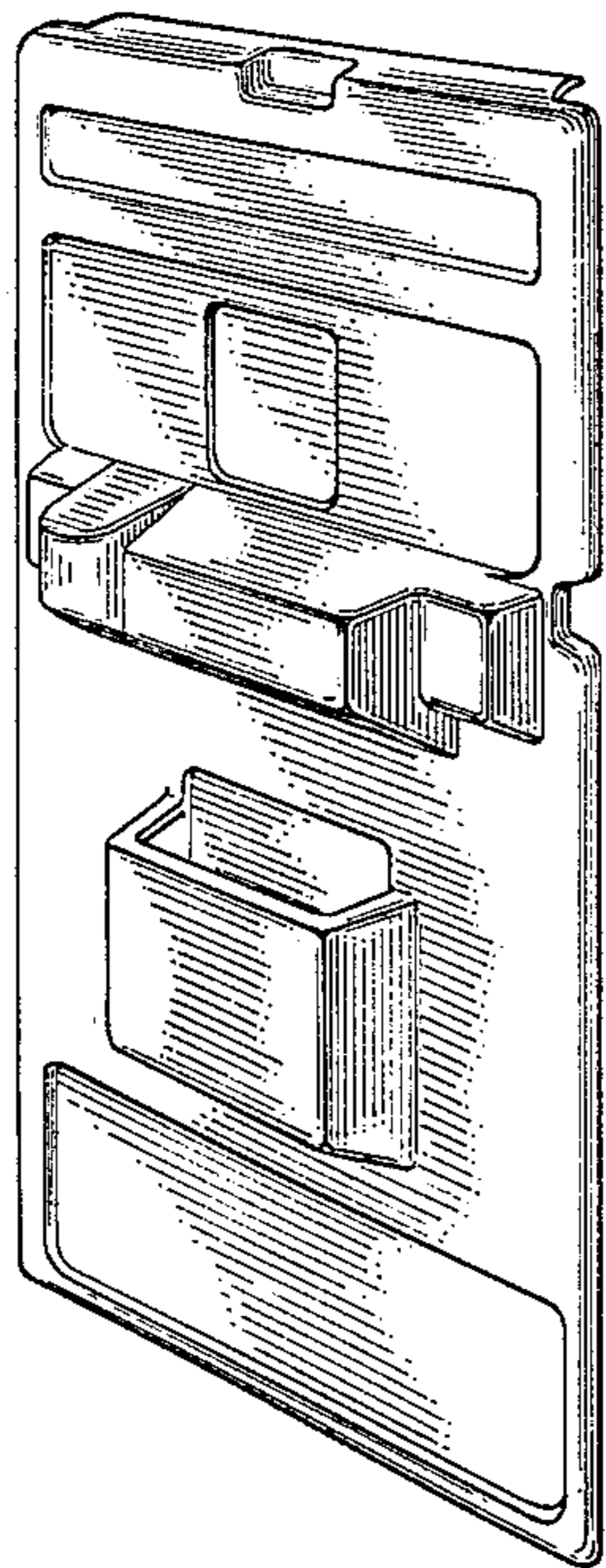

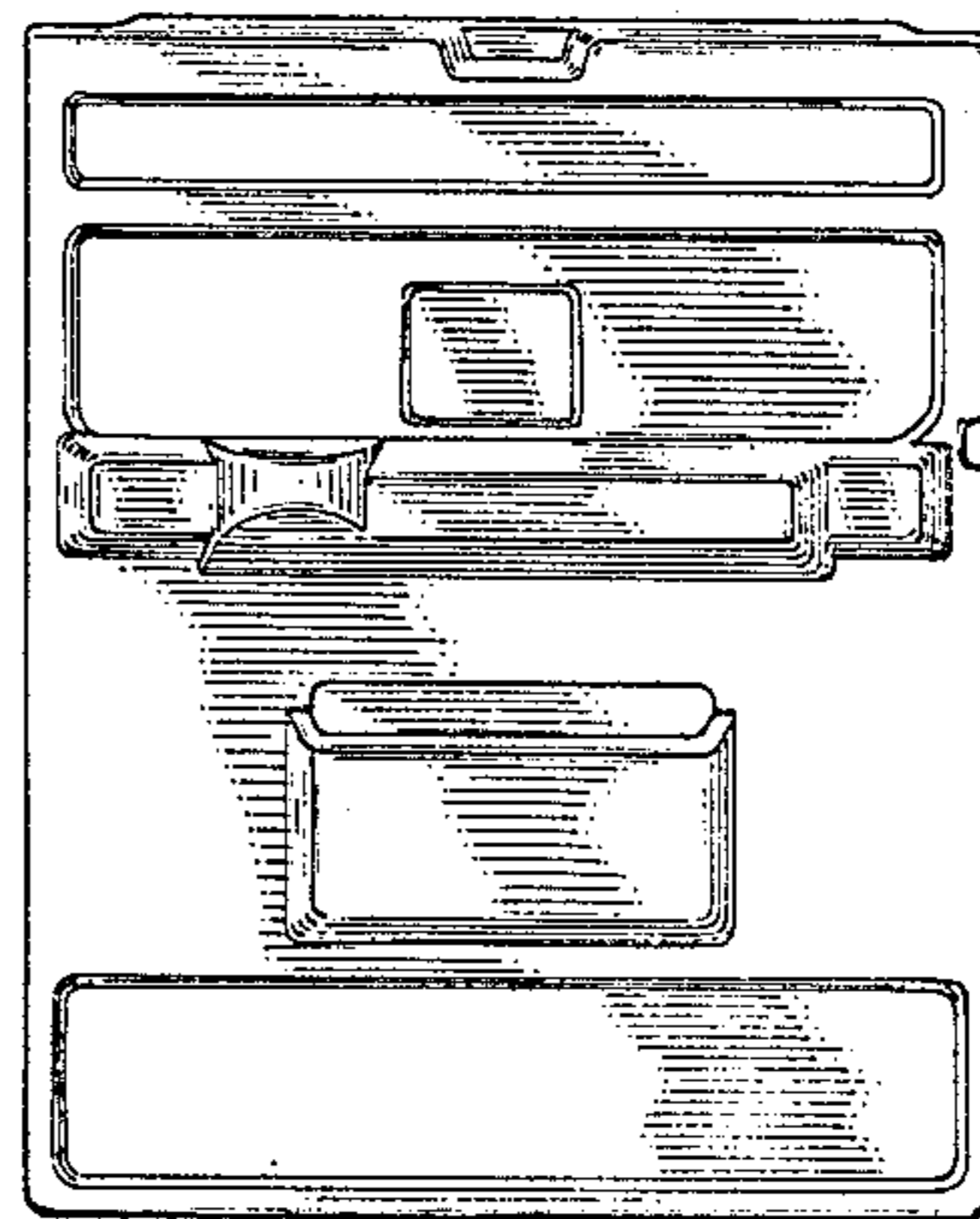

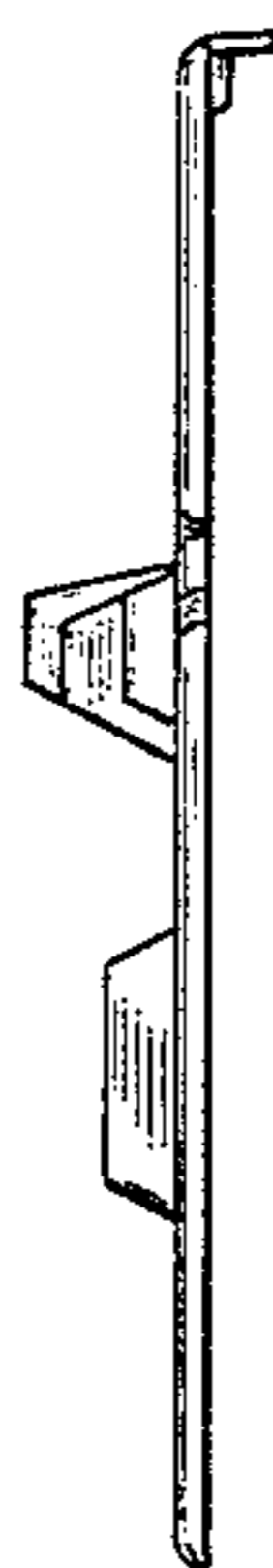

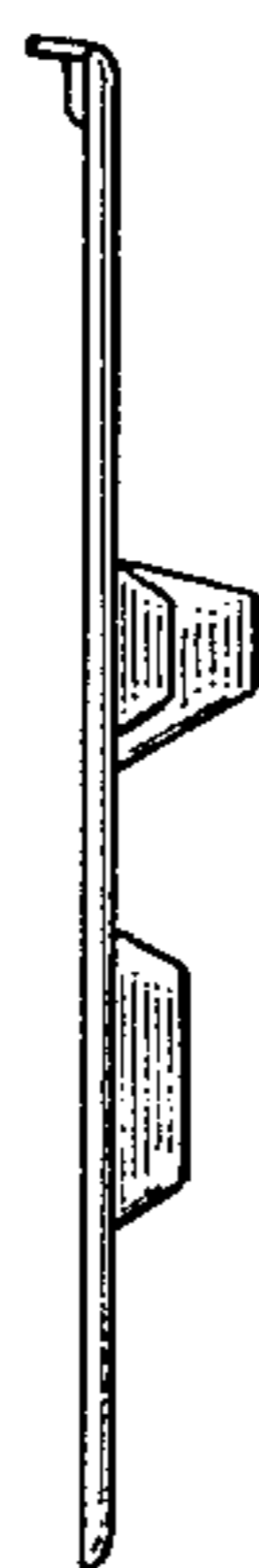

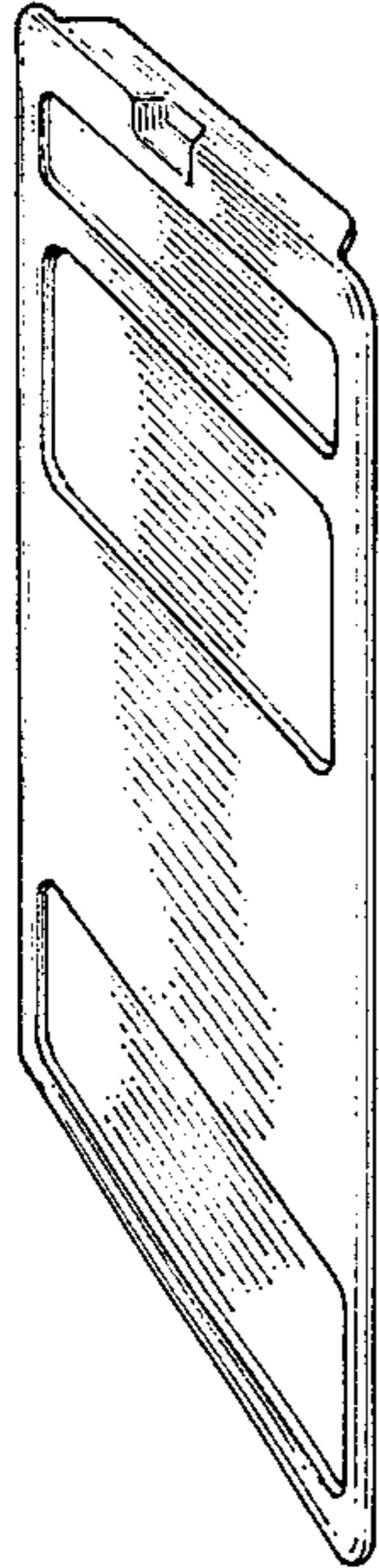

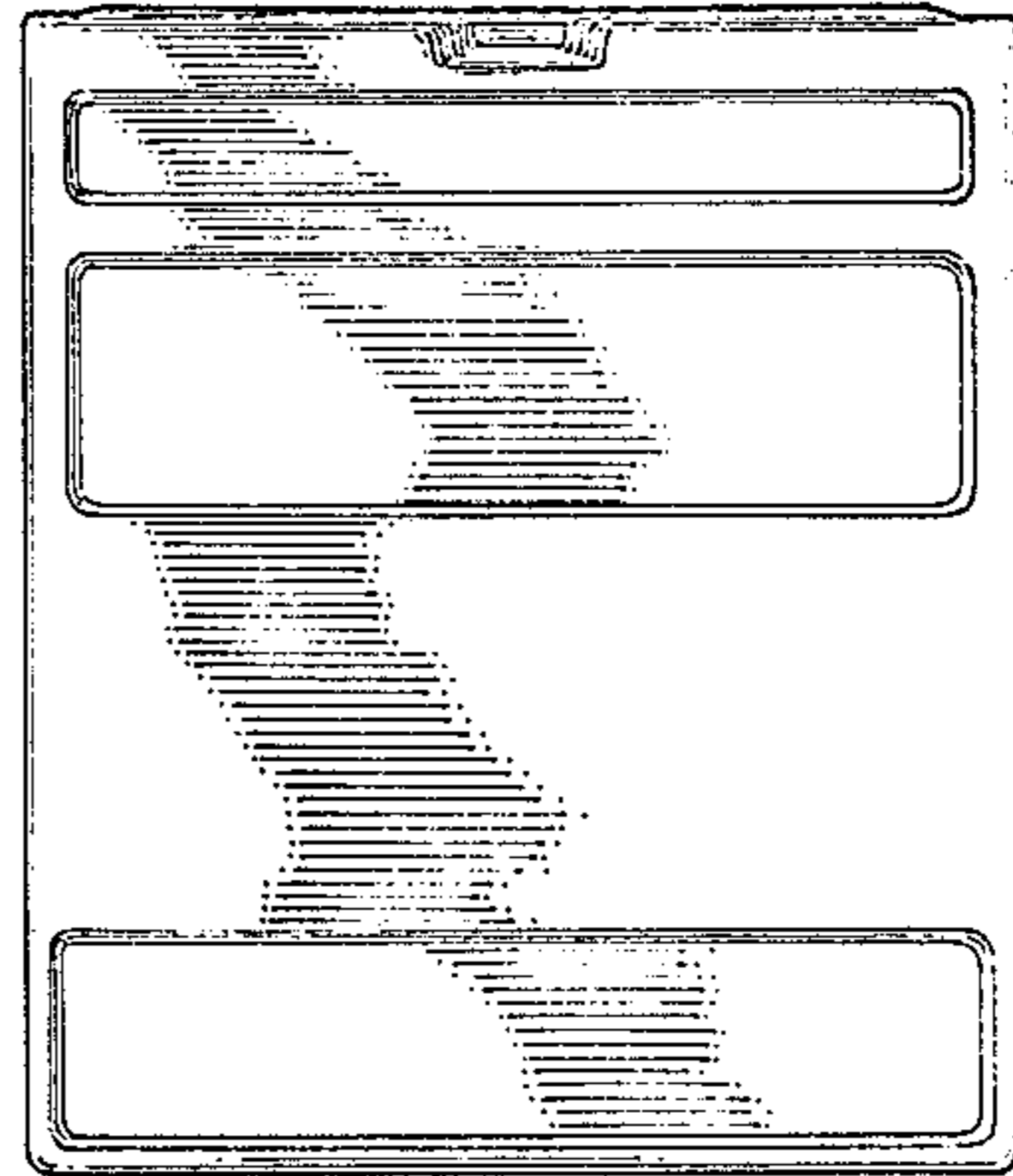

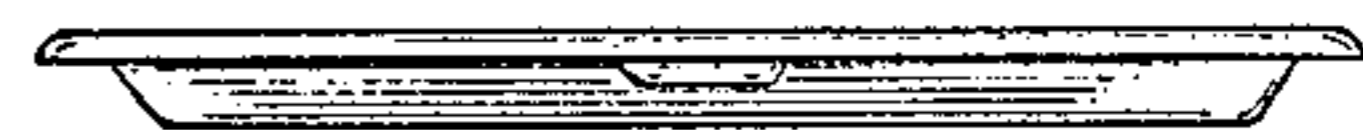

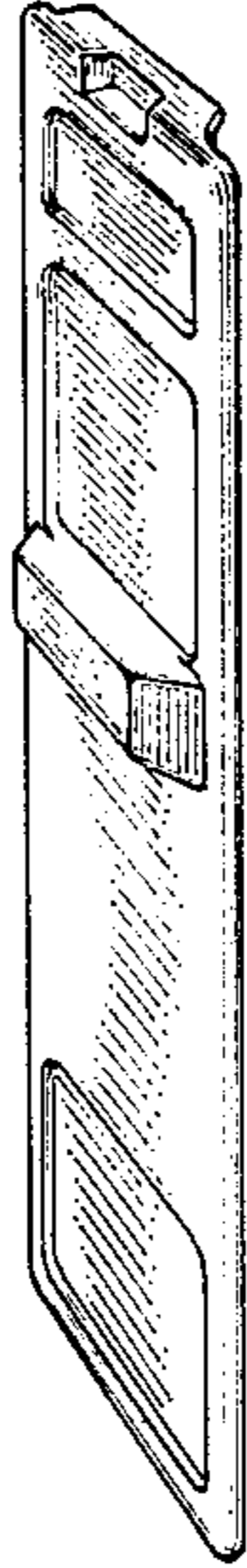

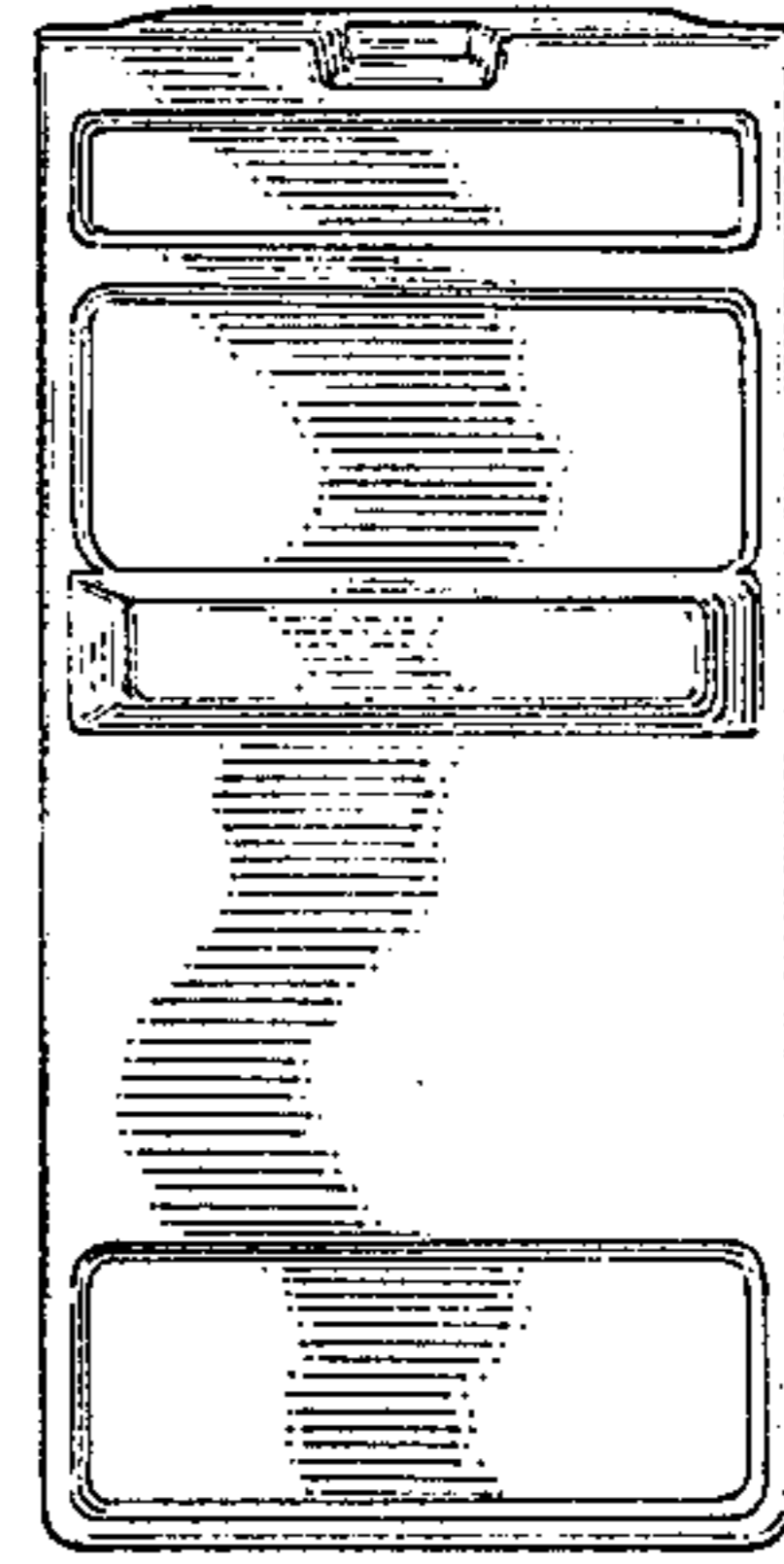

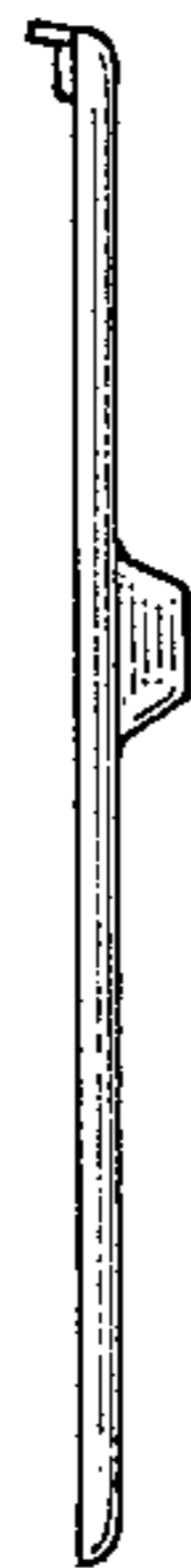
