[57] CLAIM

The ornamental design for a water purifier cabinet or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a water purifier cabinet or similar article showing our new design;

FIG. 2 is a bottom, front and right side perspective view thereof, with the rear panel omitted for convenience of illustration;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a right side elevational view thereof, the left side being a mirror image of that shown;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a sectional view thereof, taken along line 8—8 of FIG. 4;

FIG. 9 is an enlarged fragmentary sectional view thereof, taken along line 9—9 of FIG. 4;

FIG. 10 is a top plan view thereof, with the top and rear panels omitted for convenience of illustration;

FIG. 11 is a rear elevational view of FIG. 10;

FIG. 12 is a bottom, rear and left side perspective view of the top panel thereof; and

FIG. 13 is a top, rear and right side perspective view of the rear panel thereof.

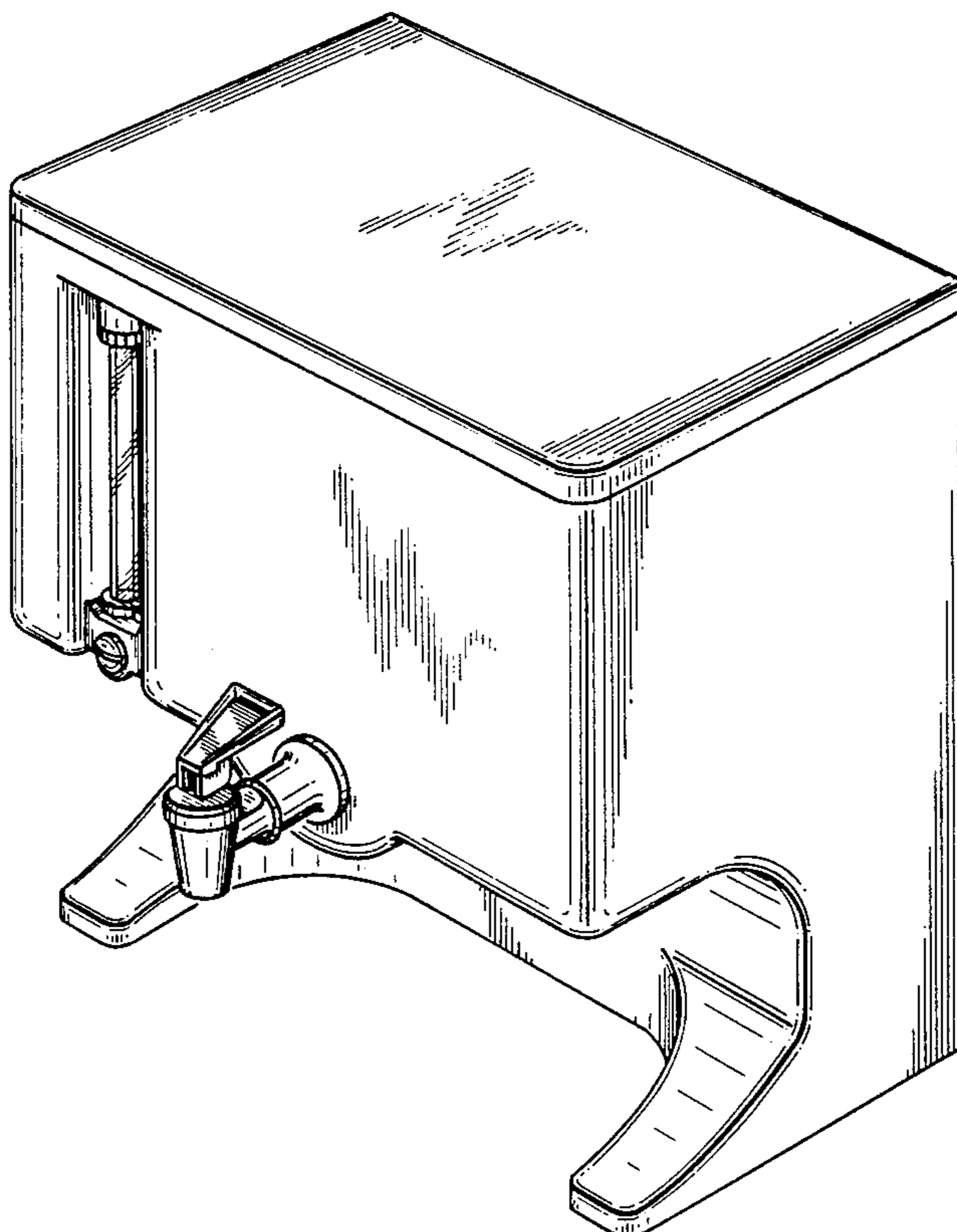

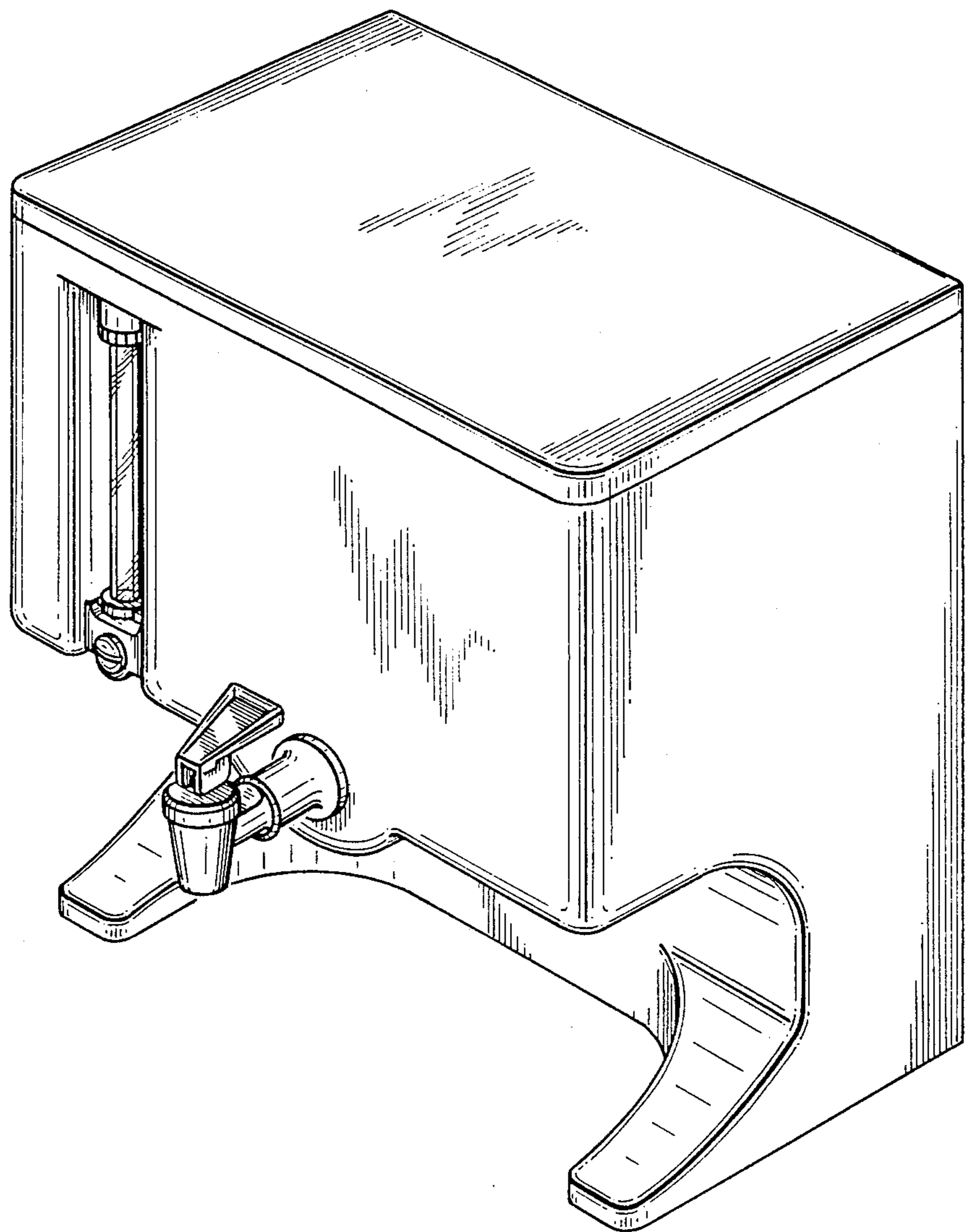

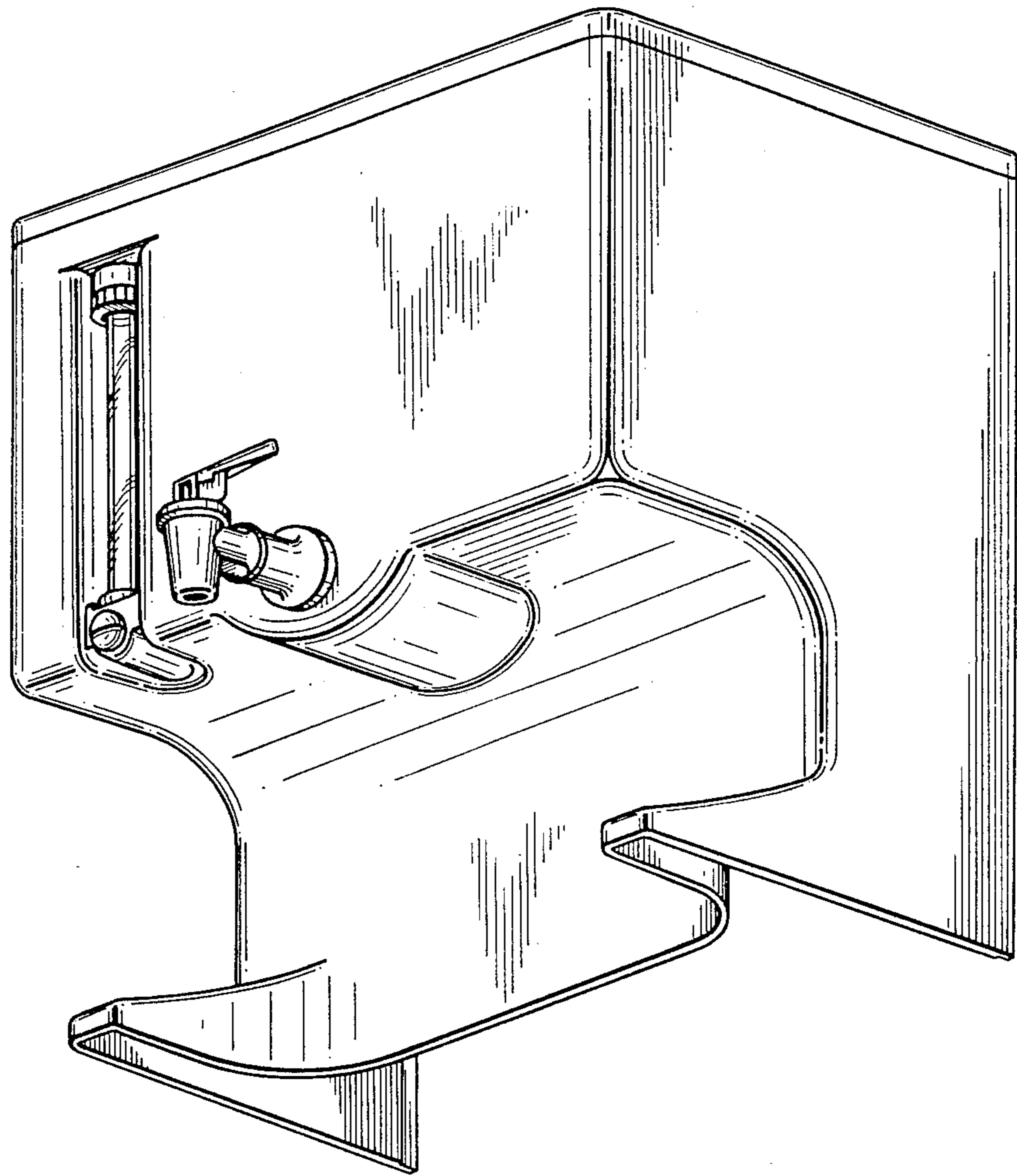

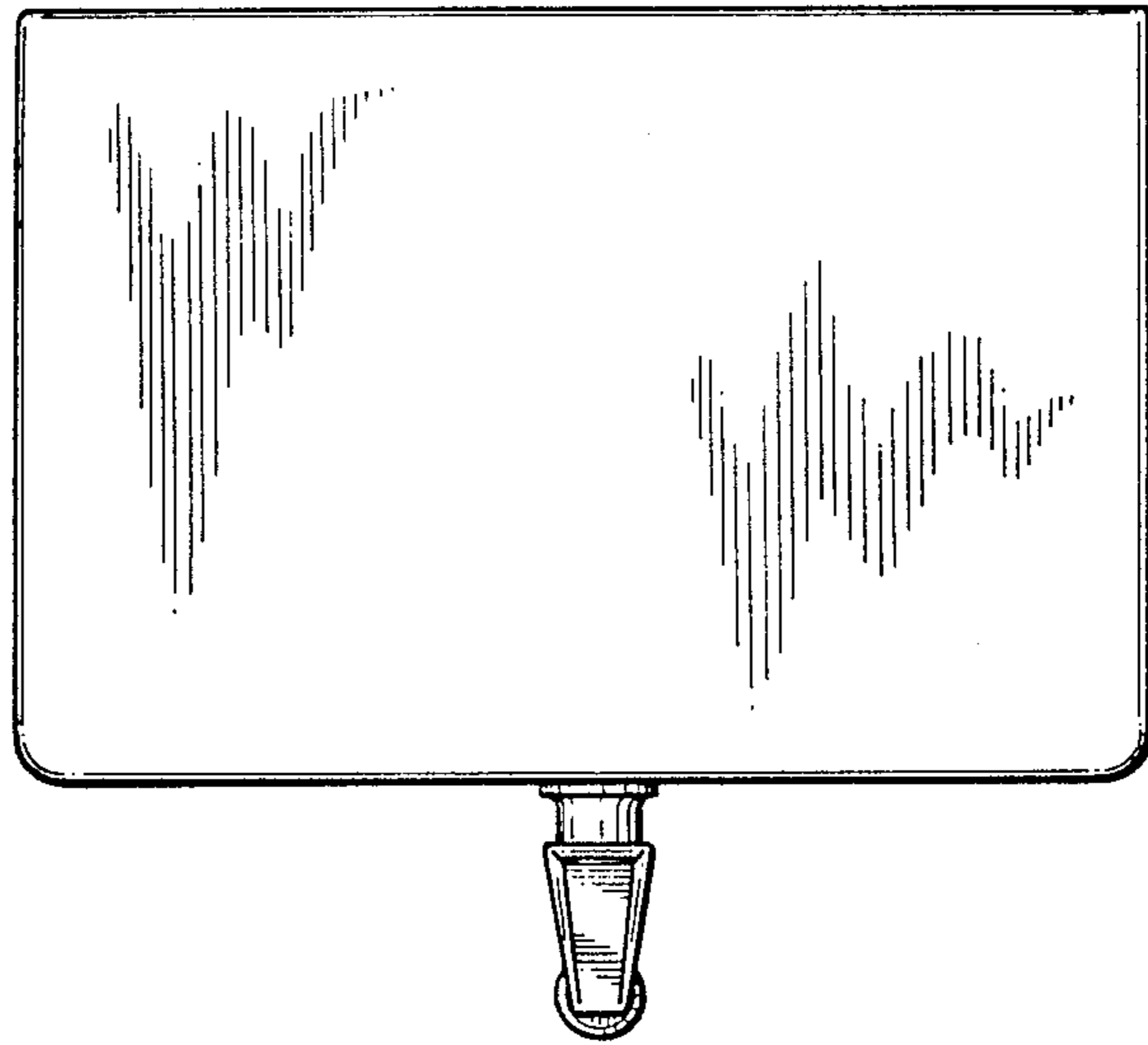
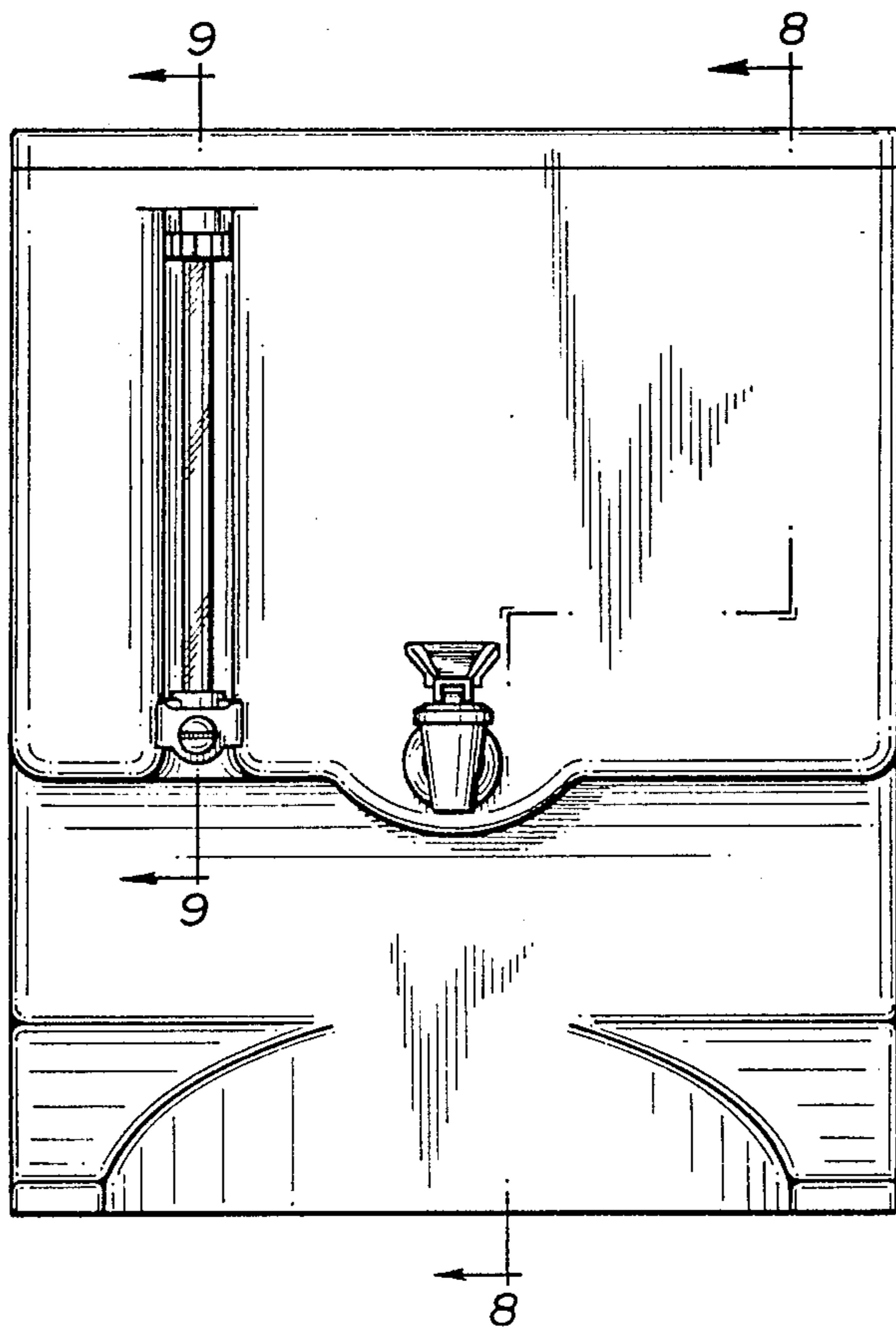

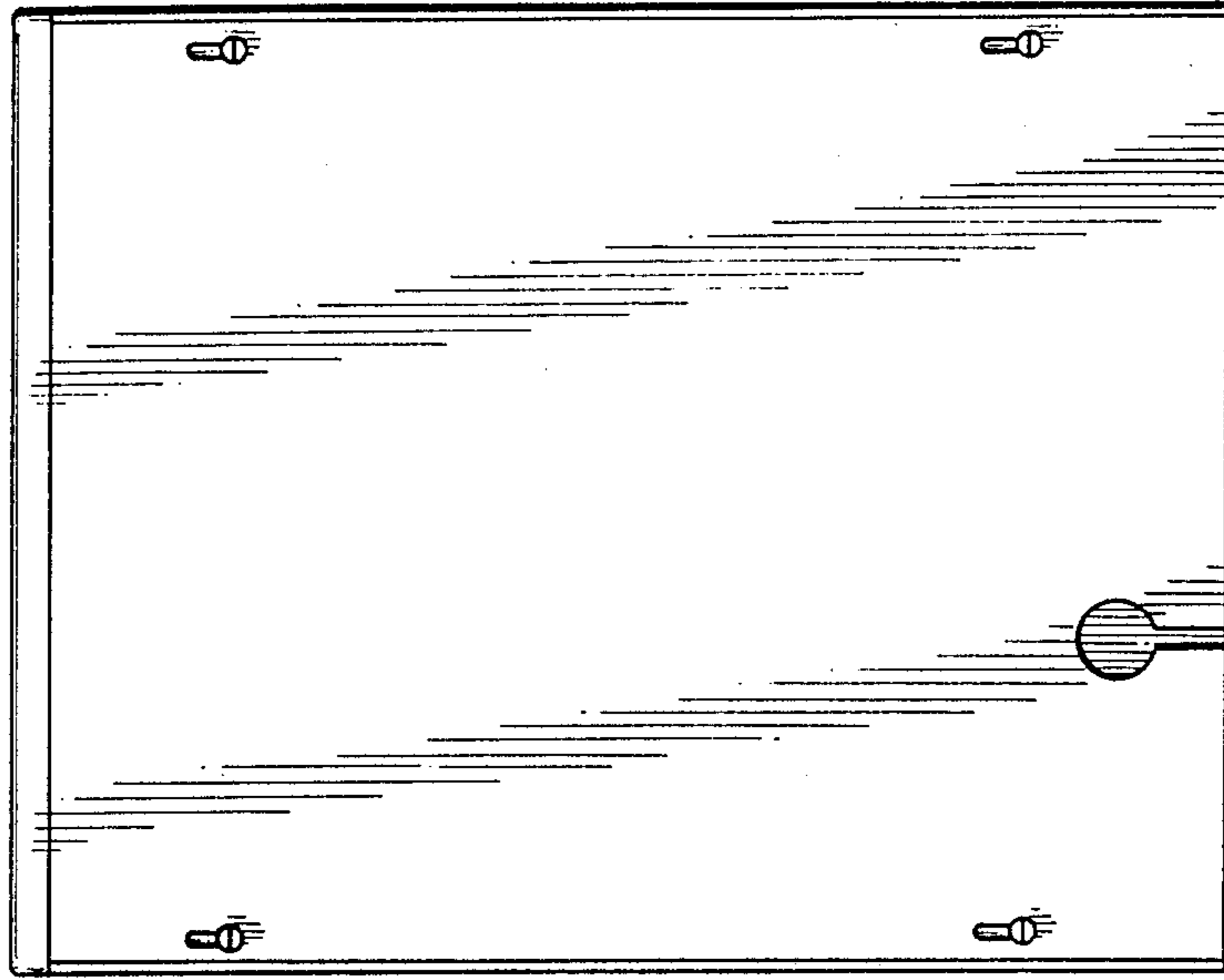

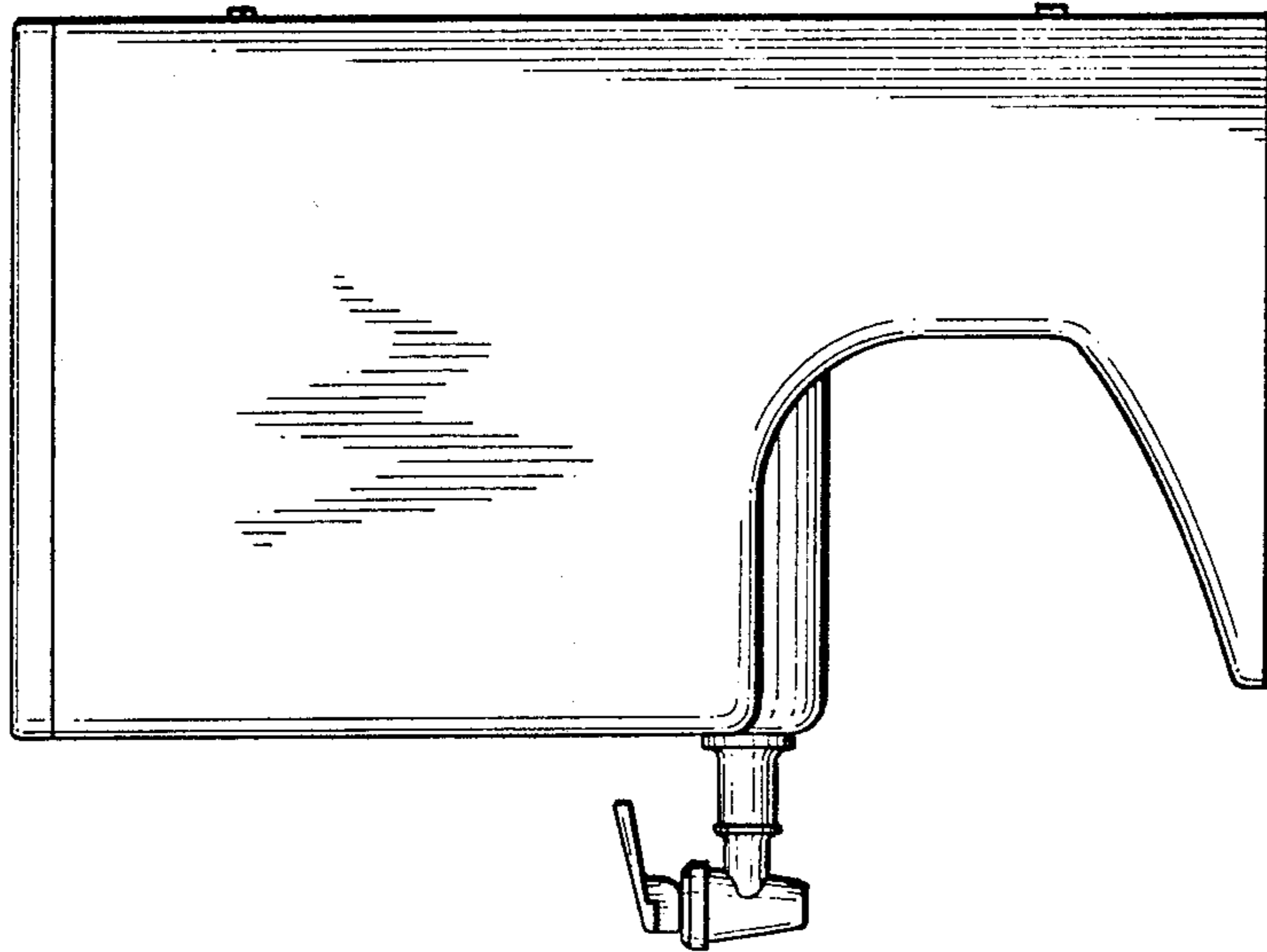

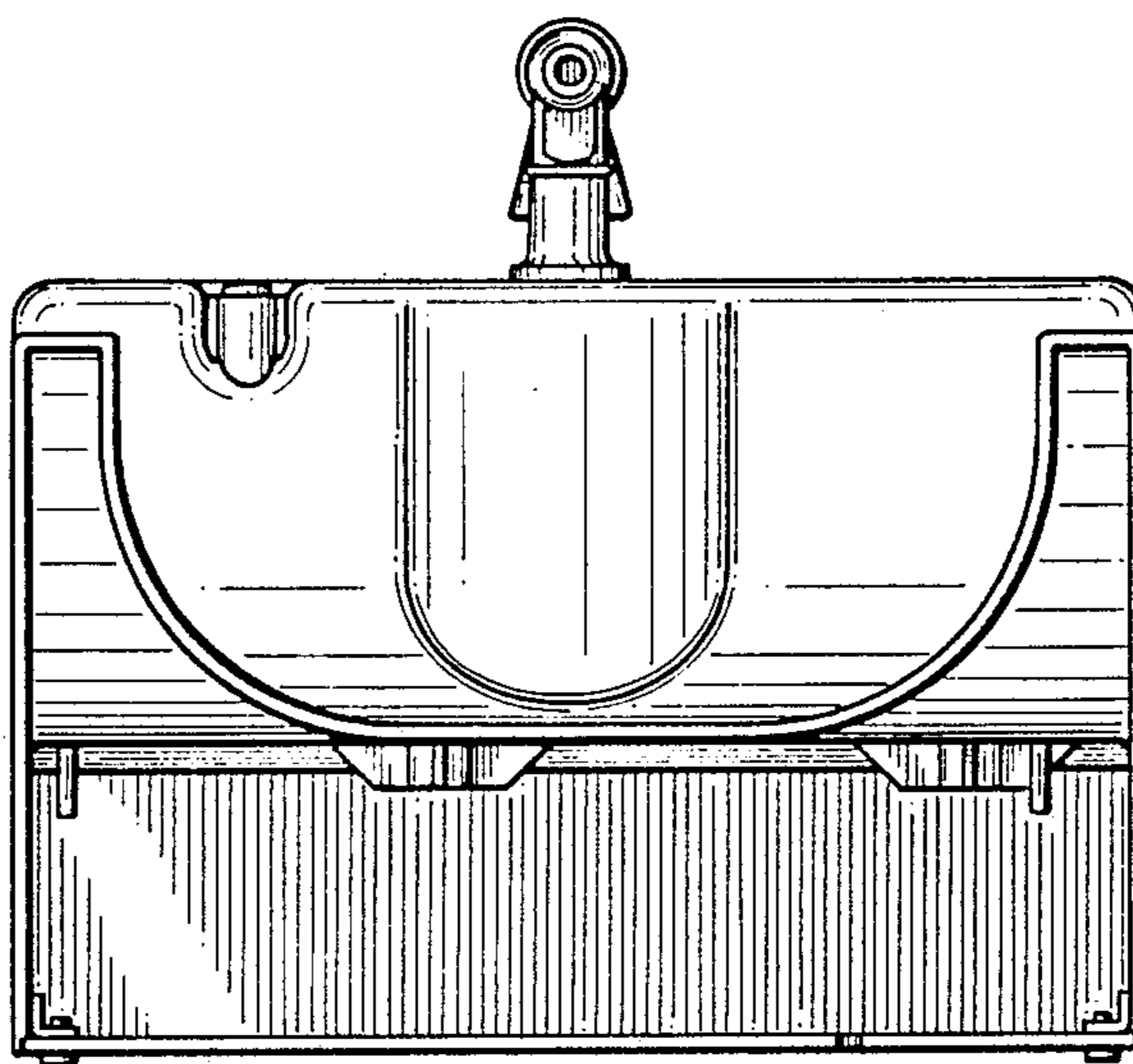

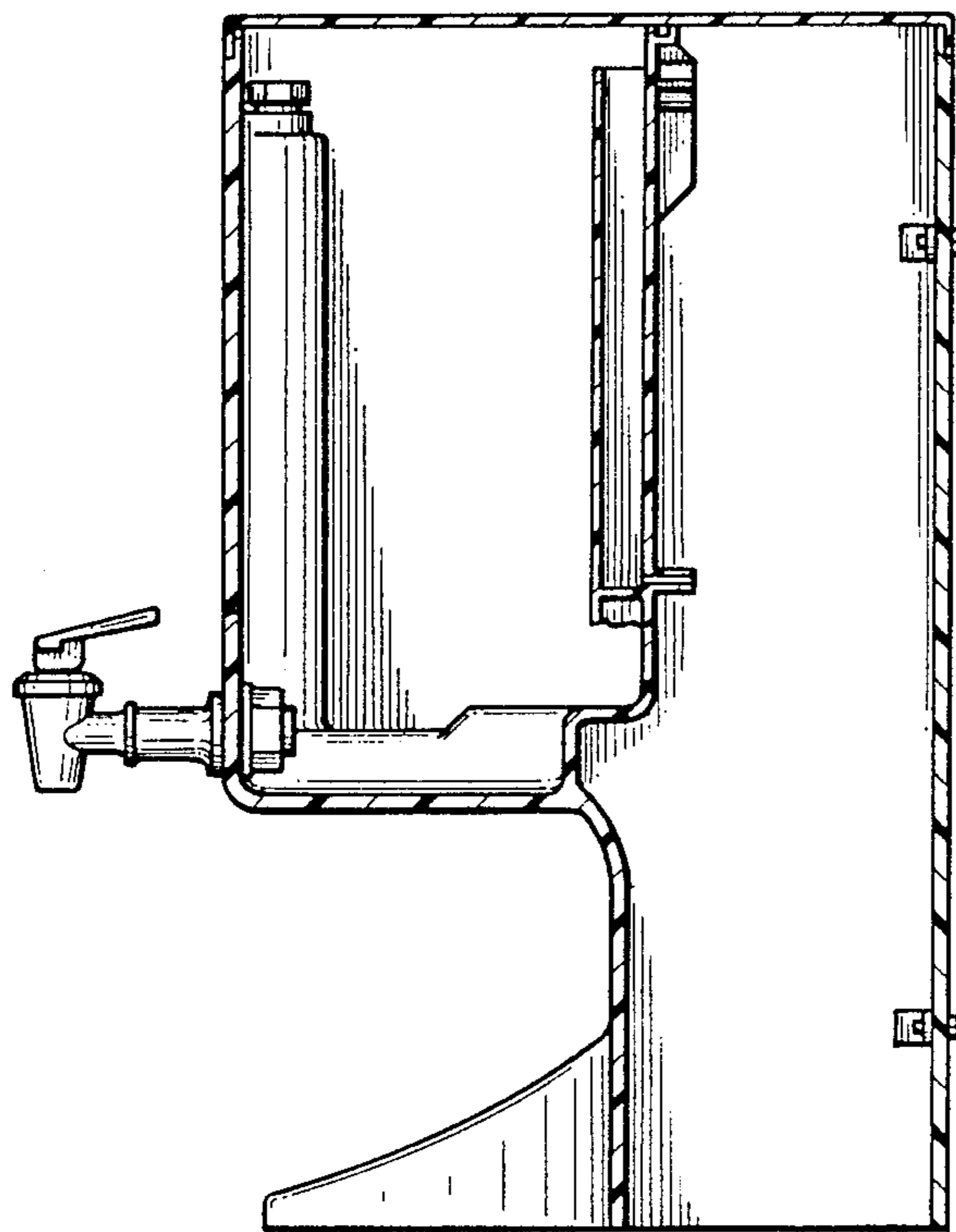

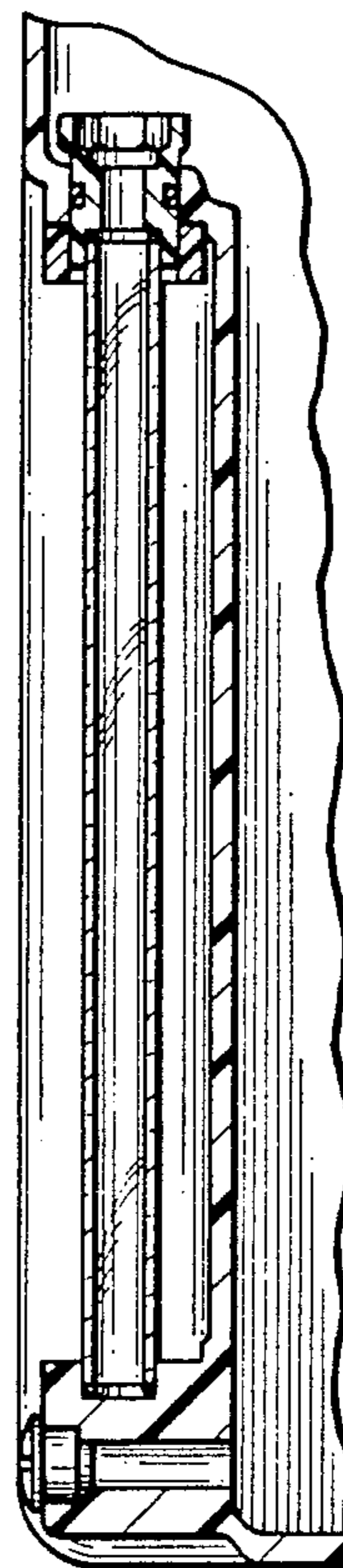

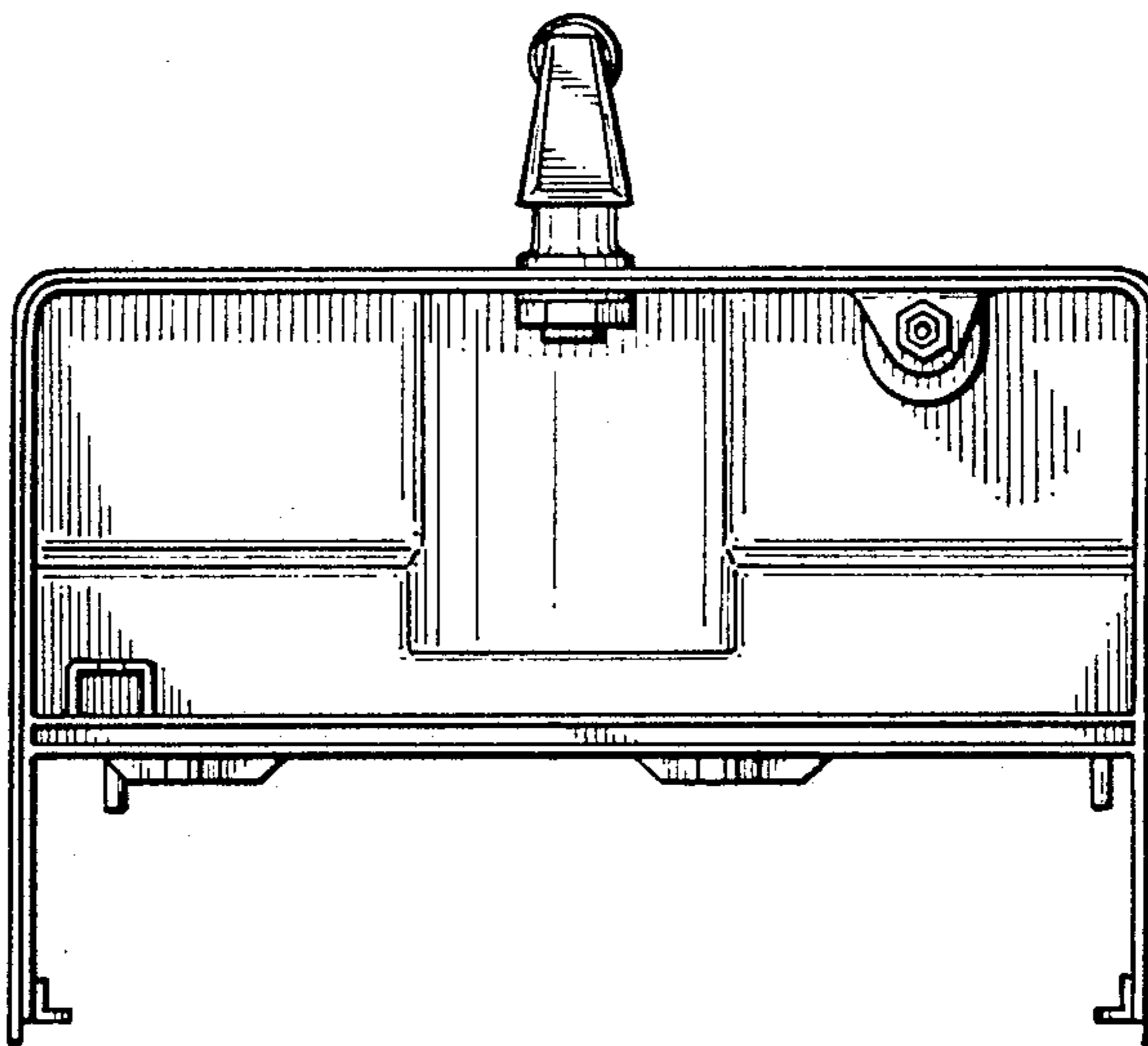

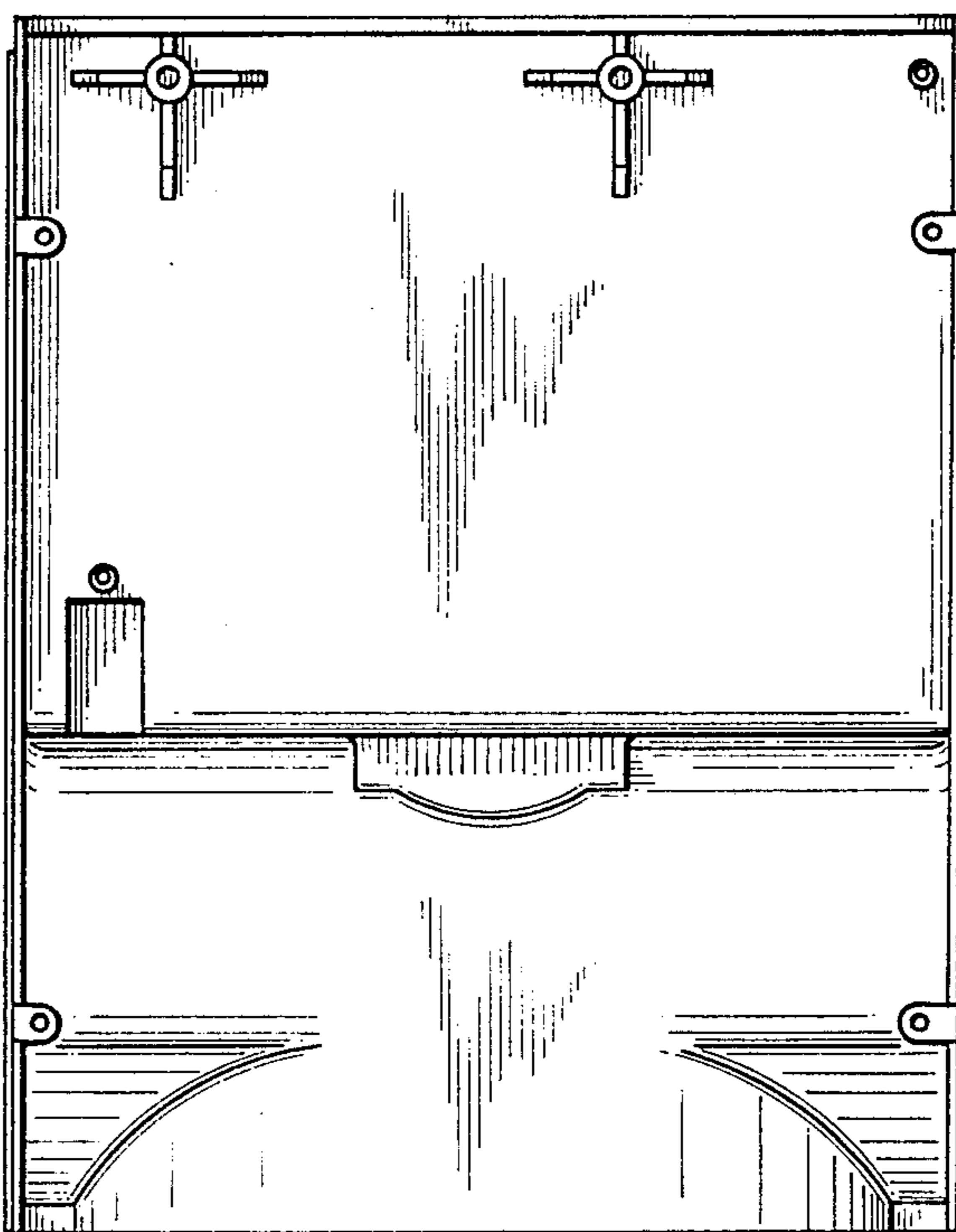

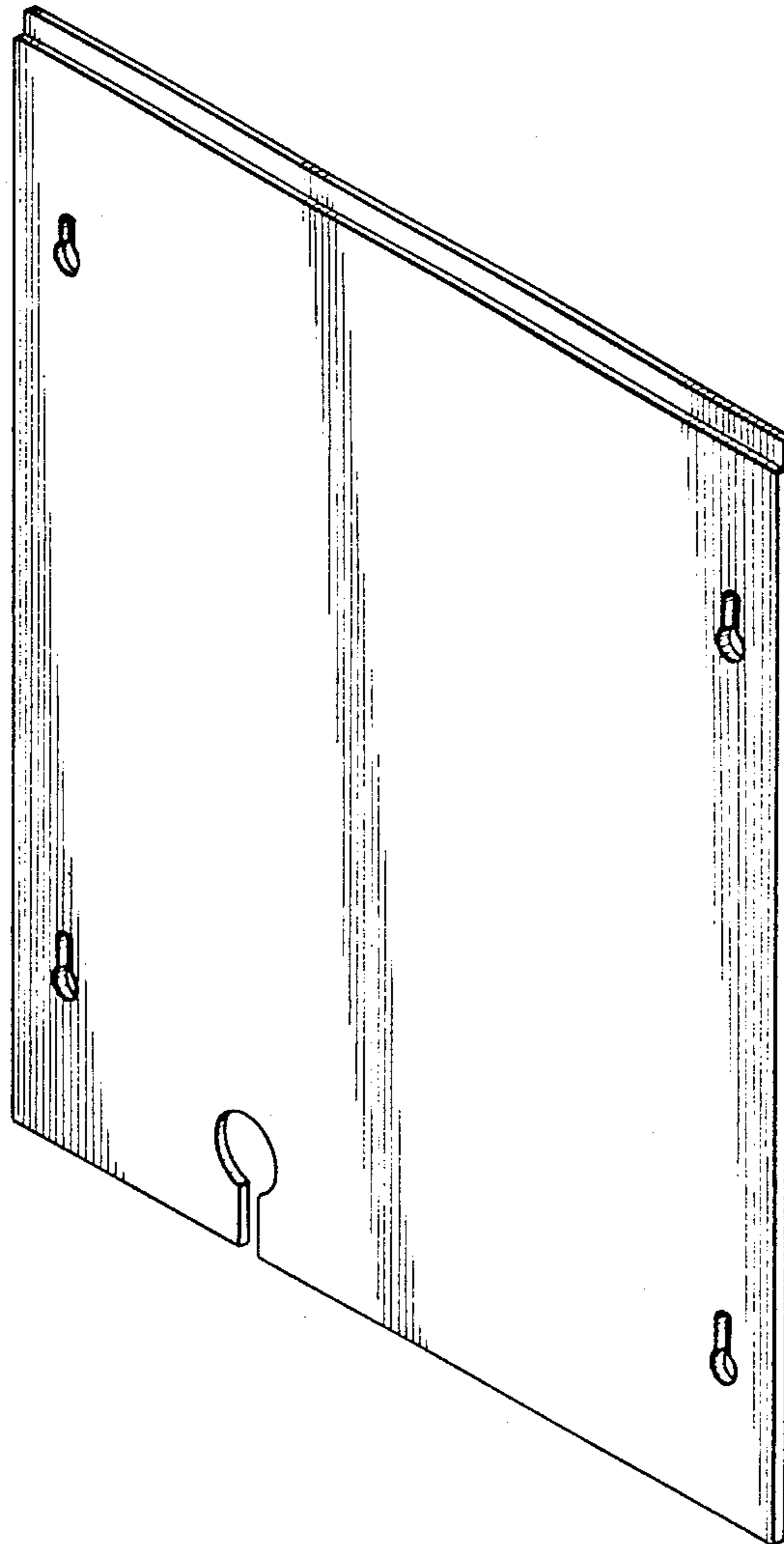
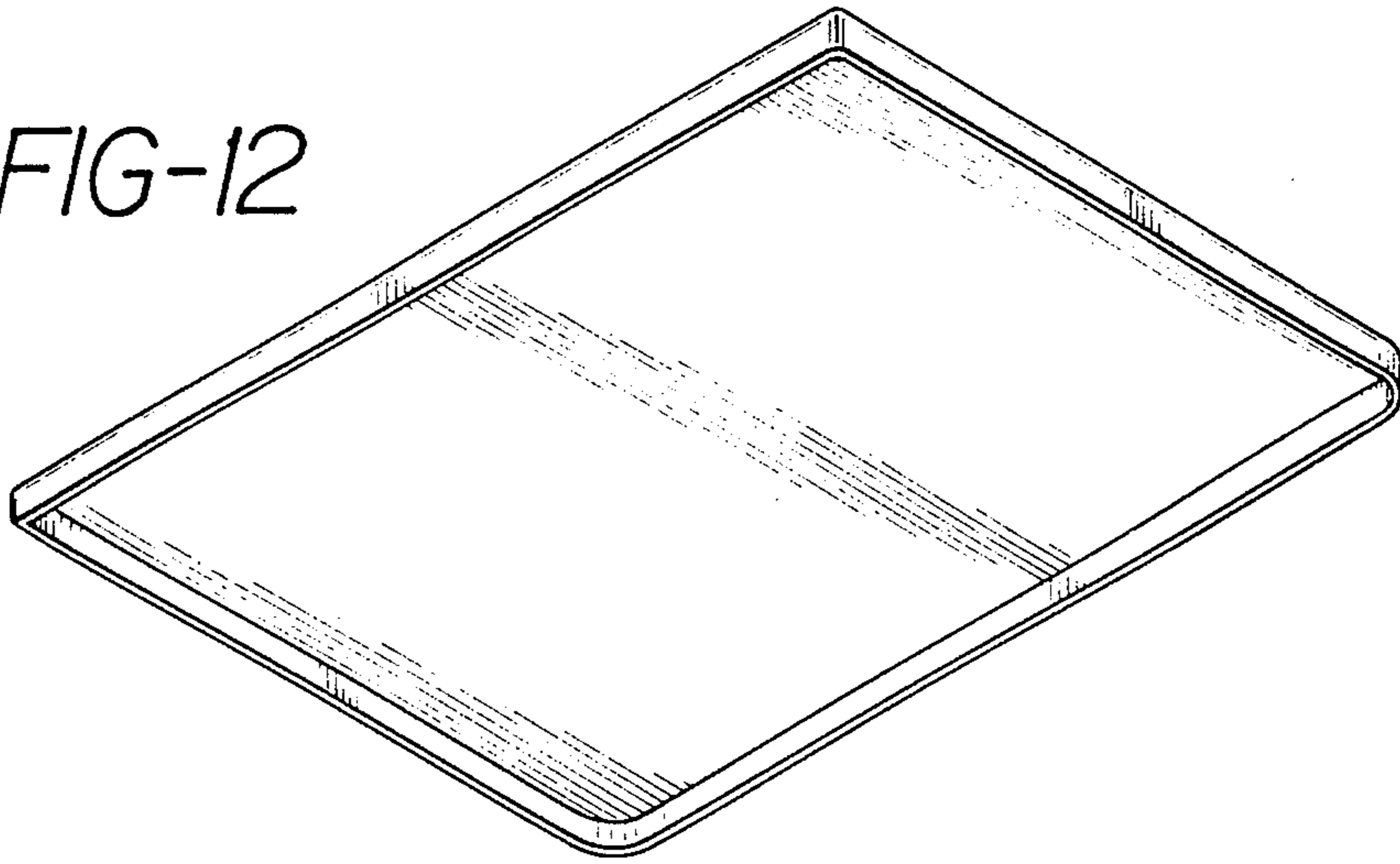
