The ornamental design for a compact fluorescent lamp, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, and right side perspective view of a compact fluorescent lamp showing our new design;

FIG. 3 is a front elevational view thereof, the rear being a mirror image;

FIG. 13 is a bottom, front, and right side perspective view of a third embodiment of our new design;

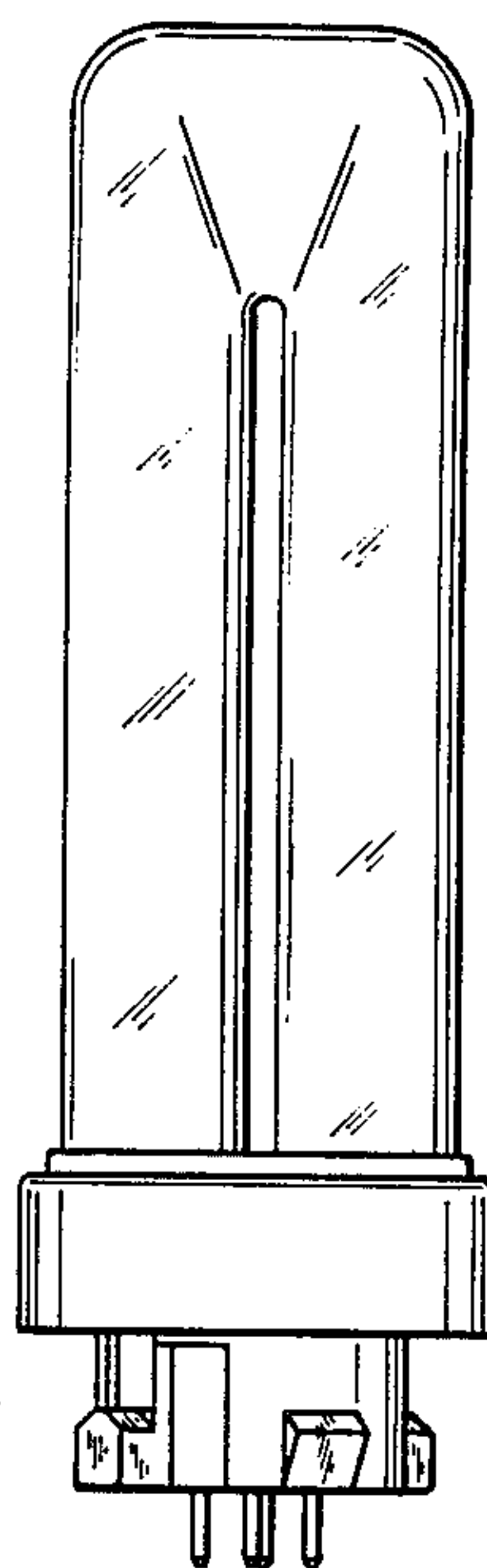
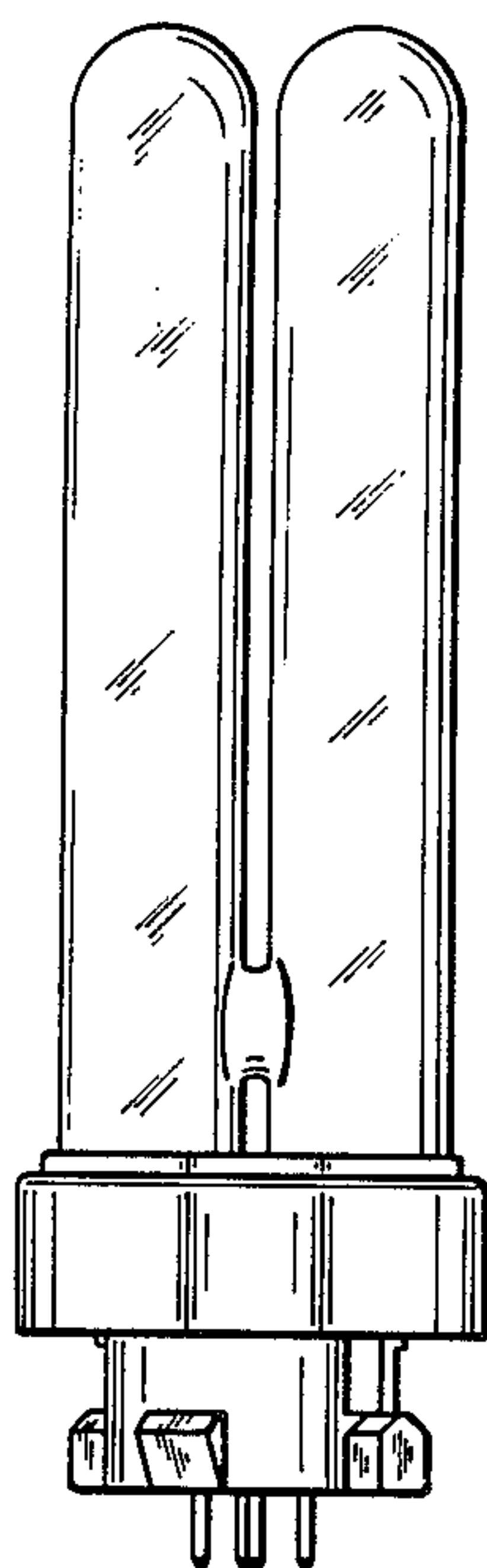
FIG. 14 is a right side elevational view thereof;

FIG. 18 is a left side elevational view thereof.



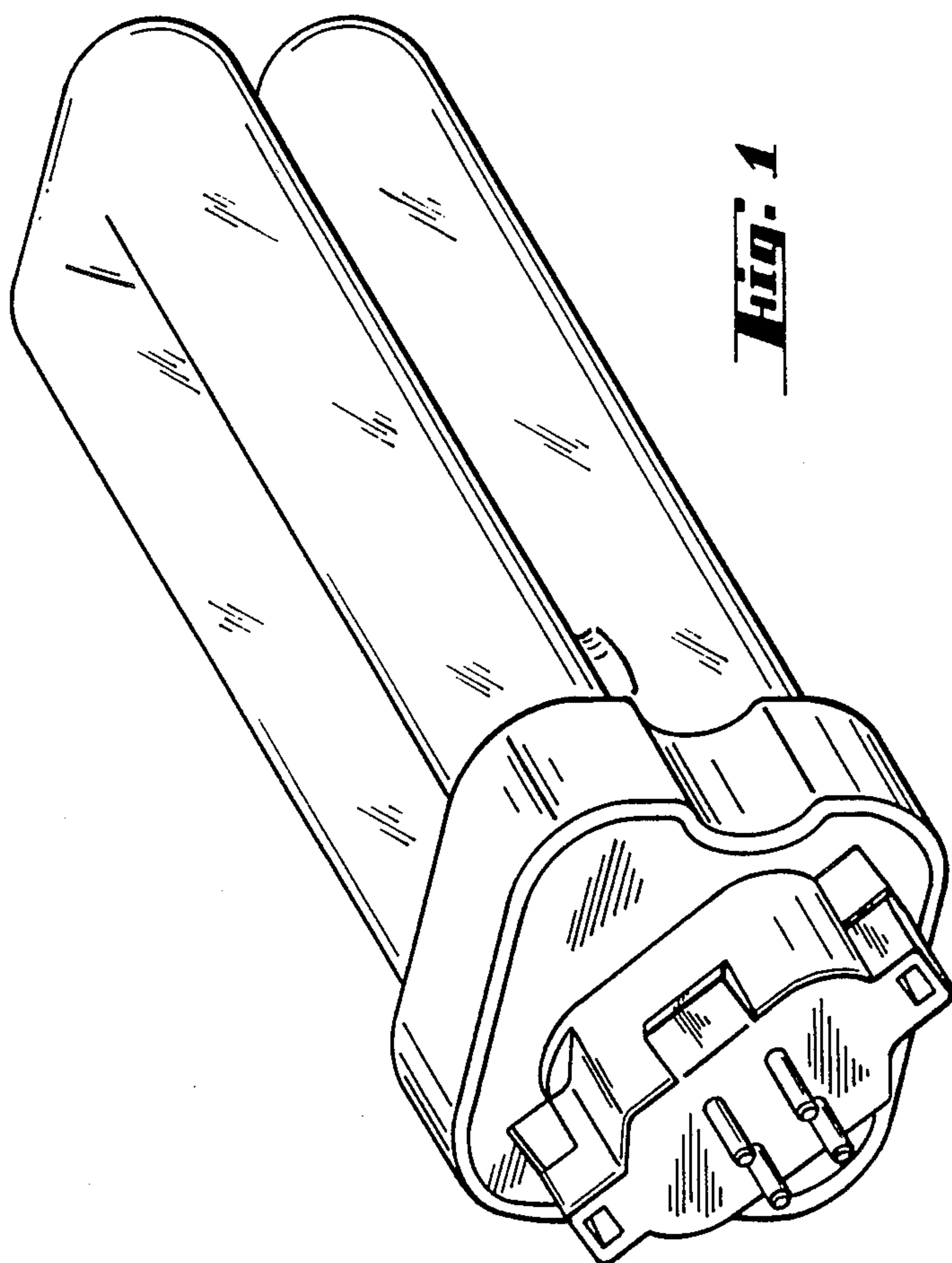

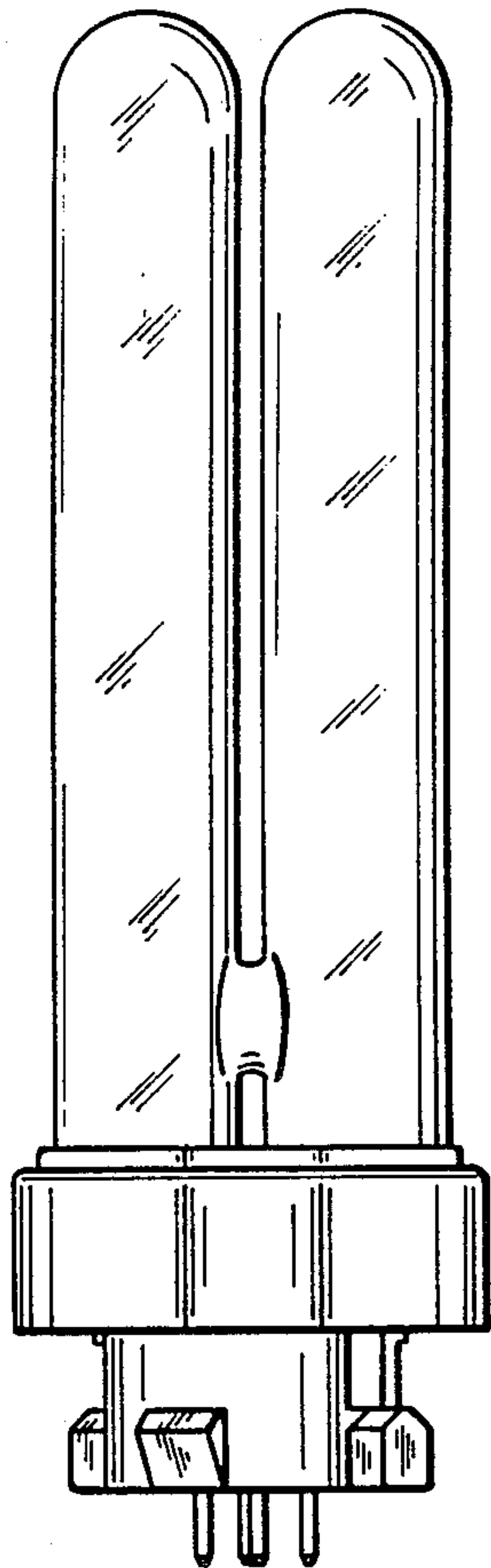

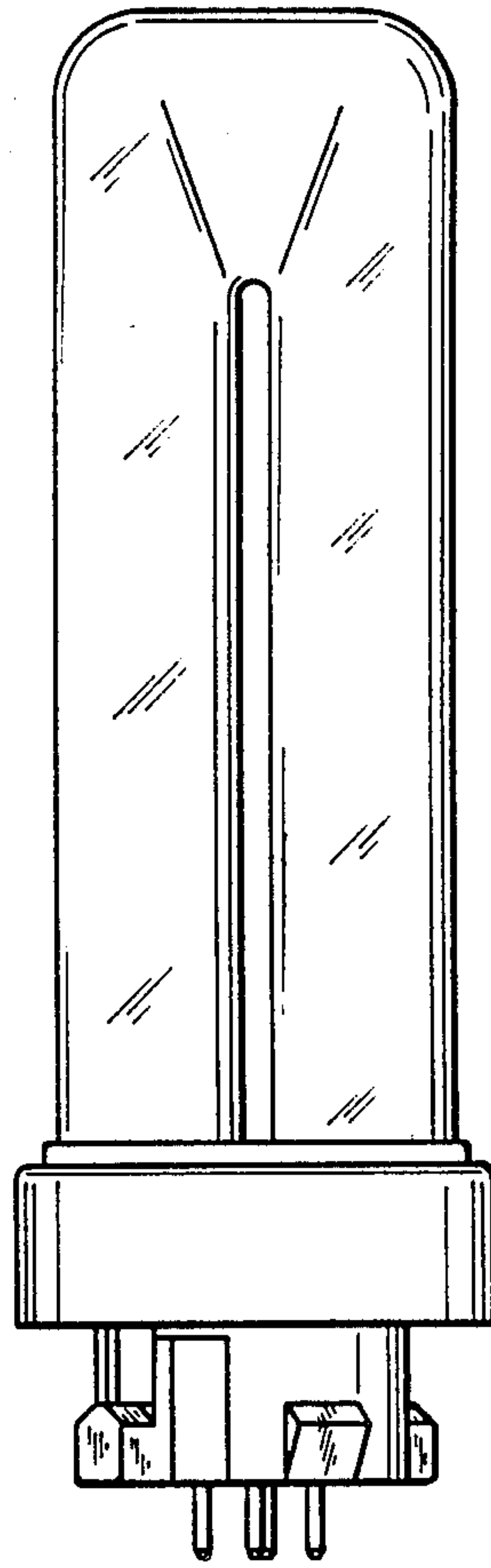

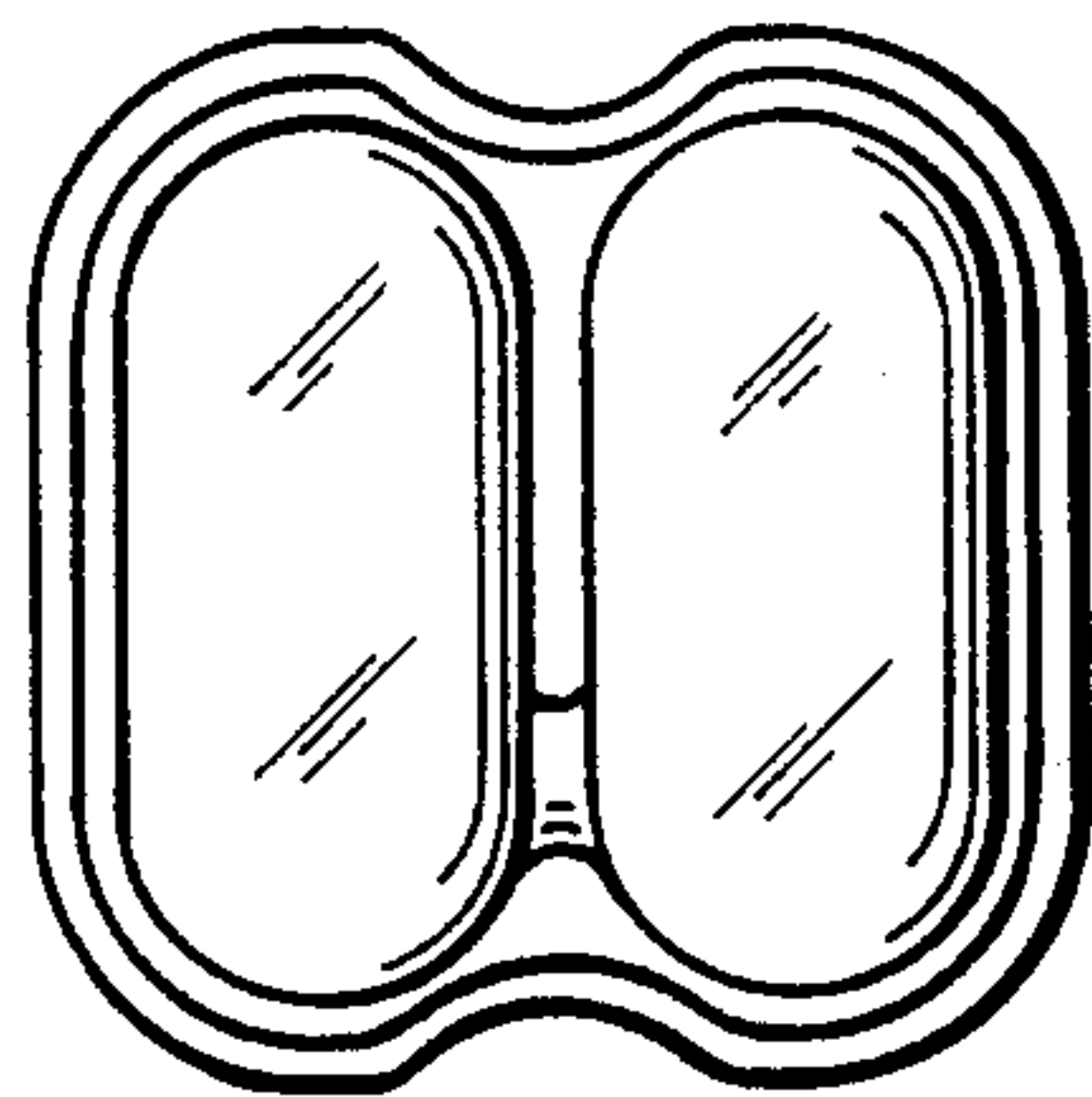

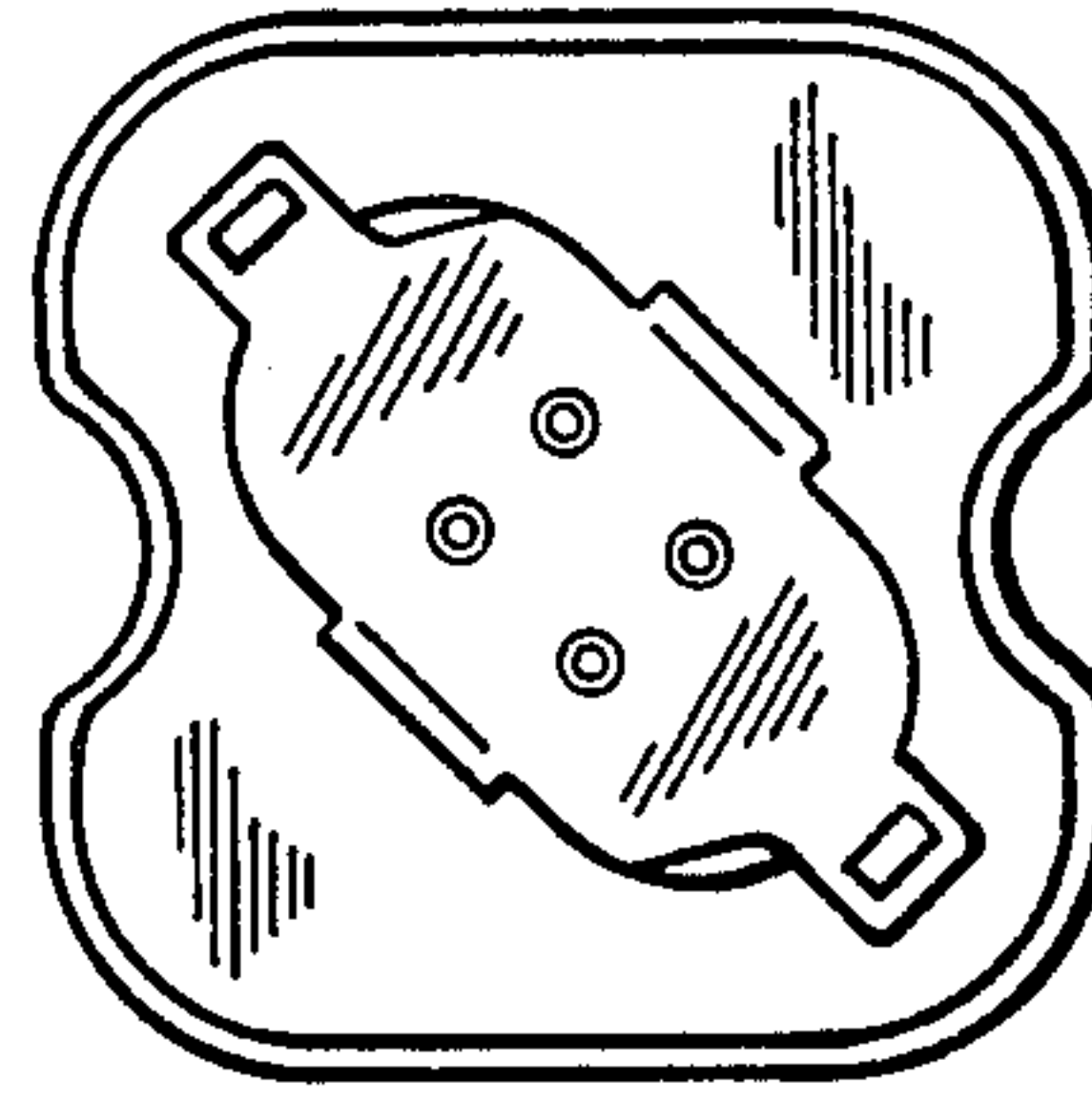

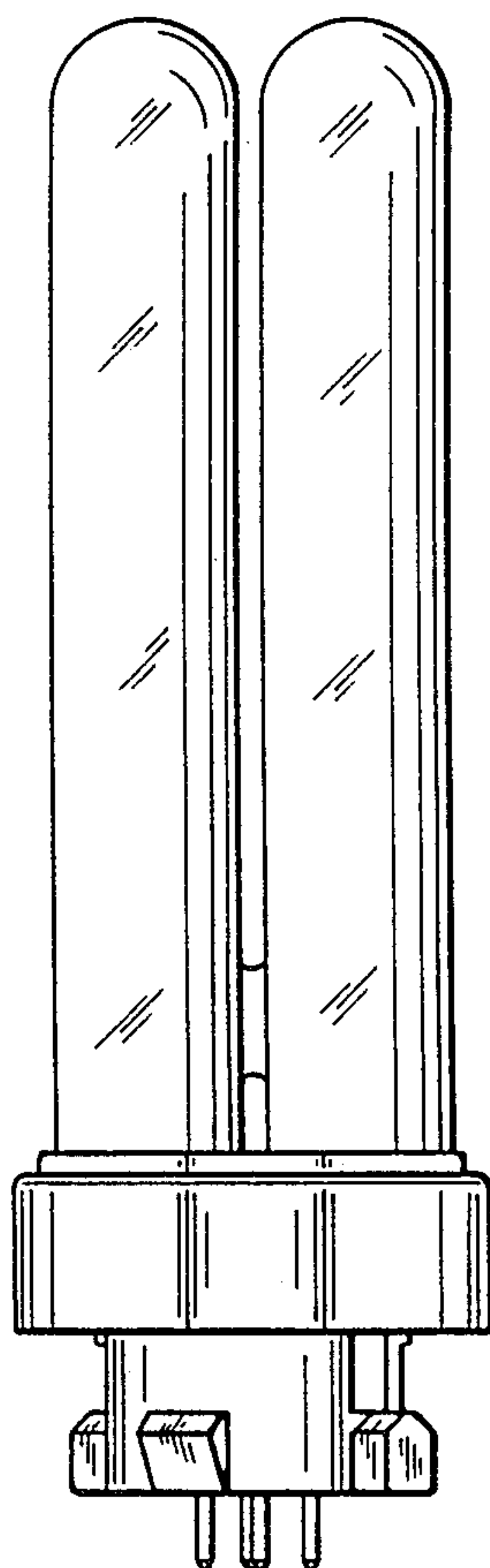

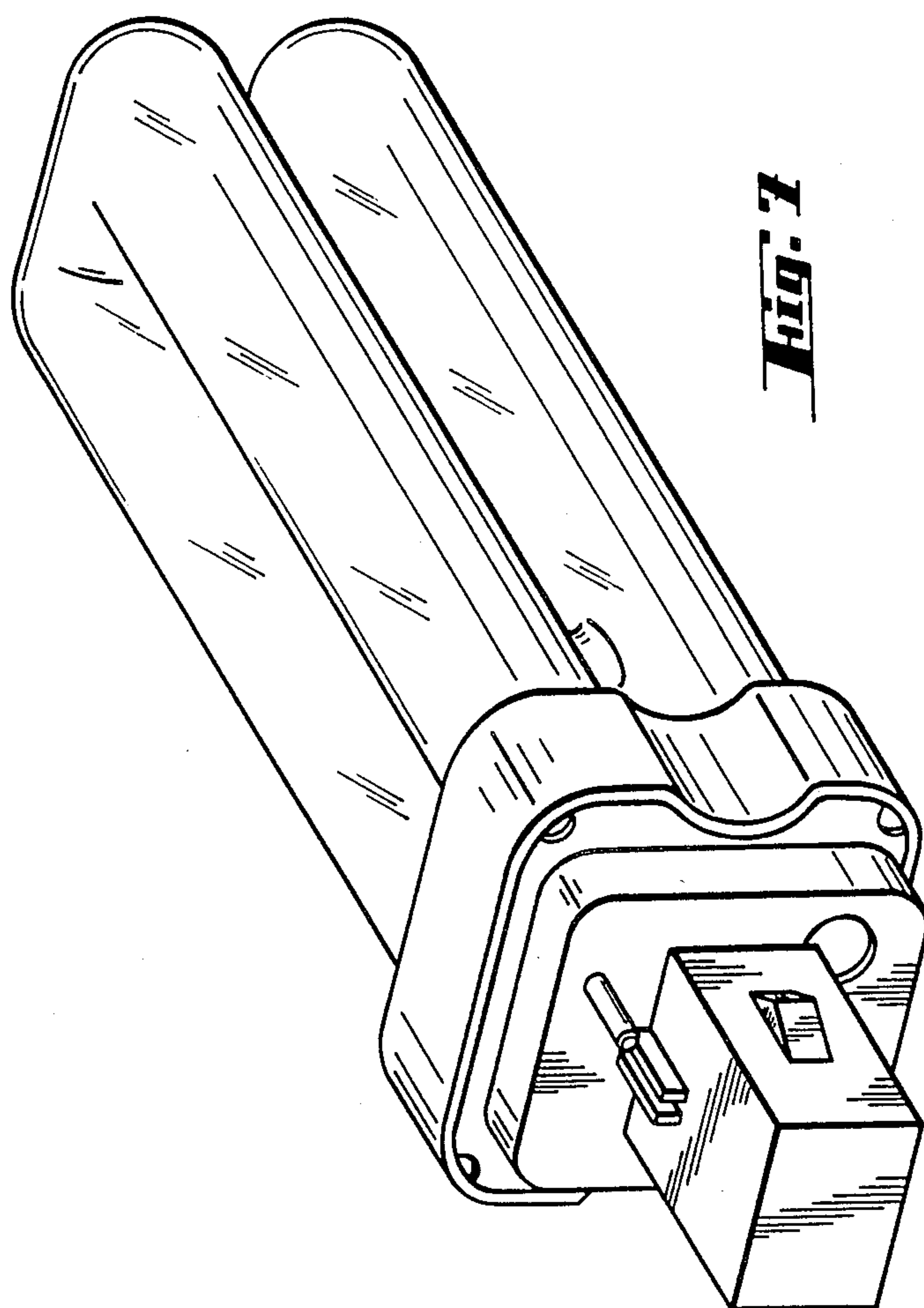

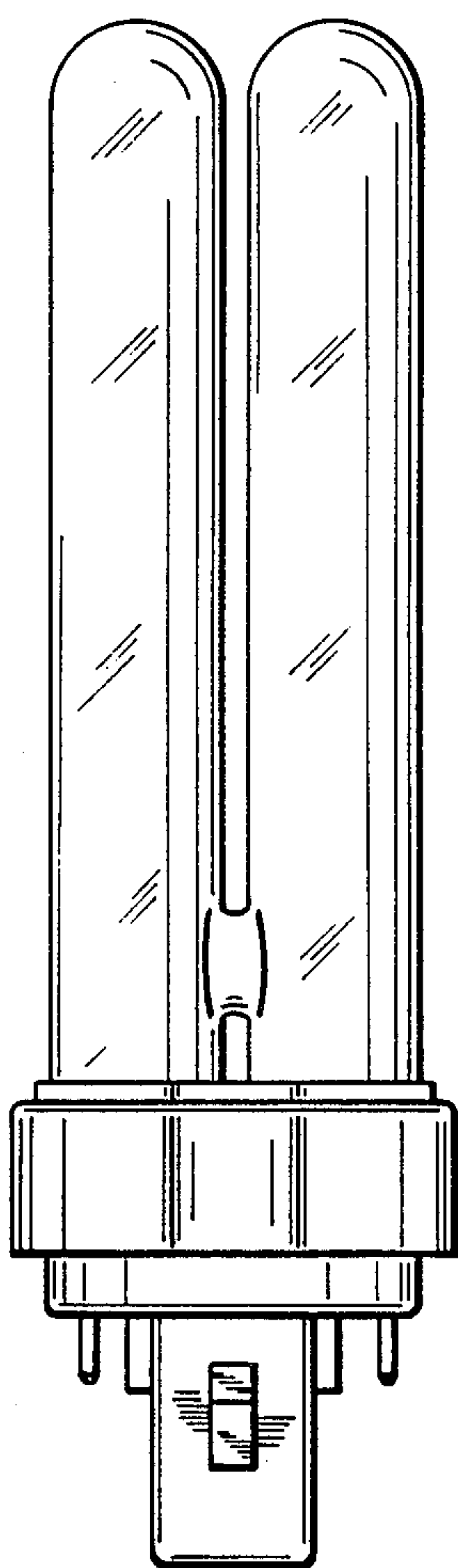

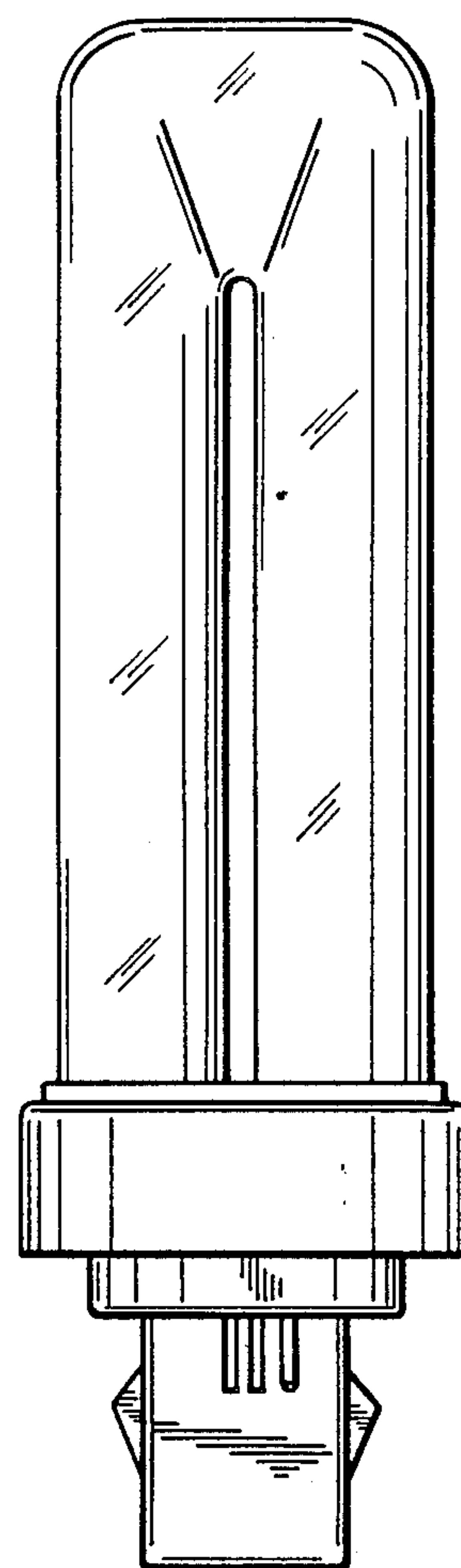

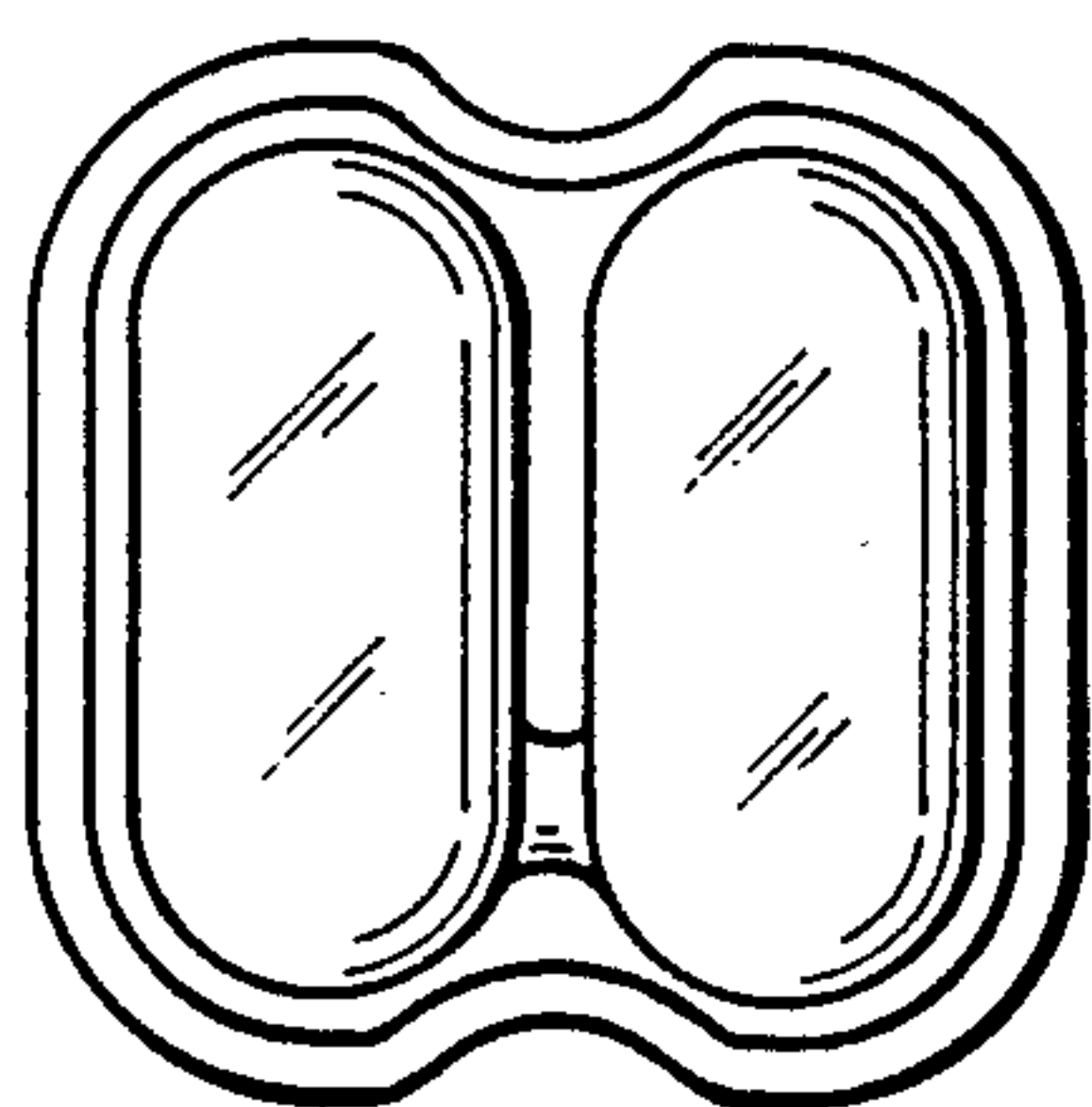

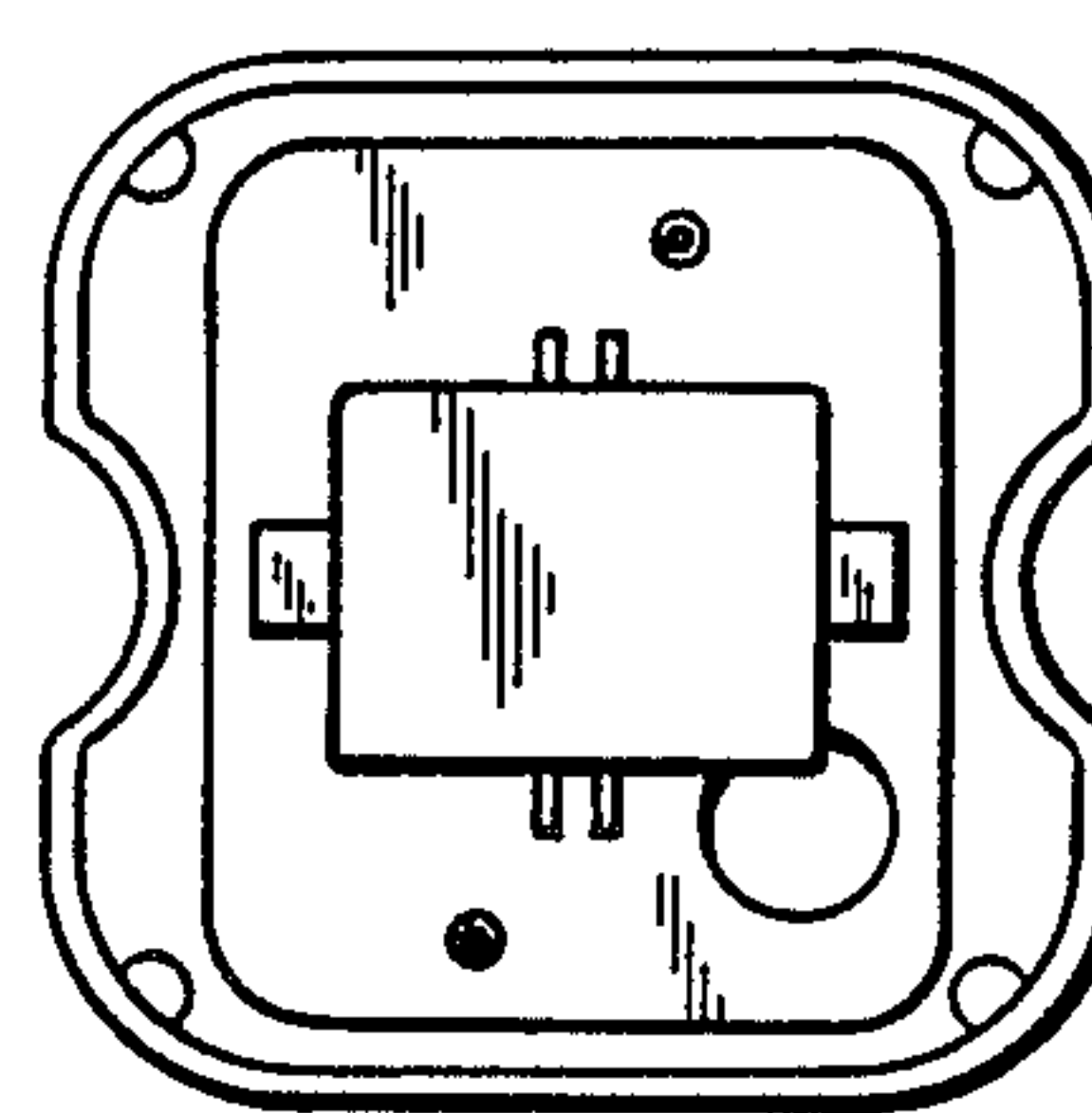

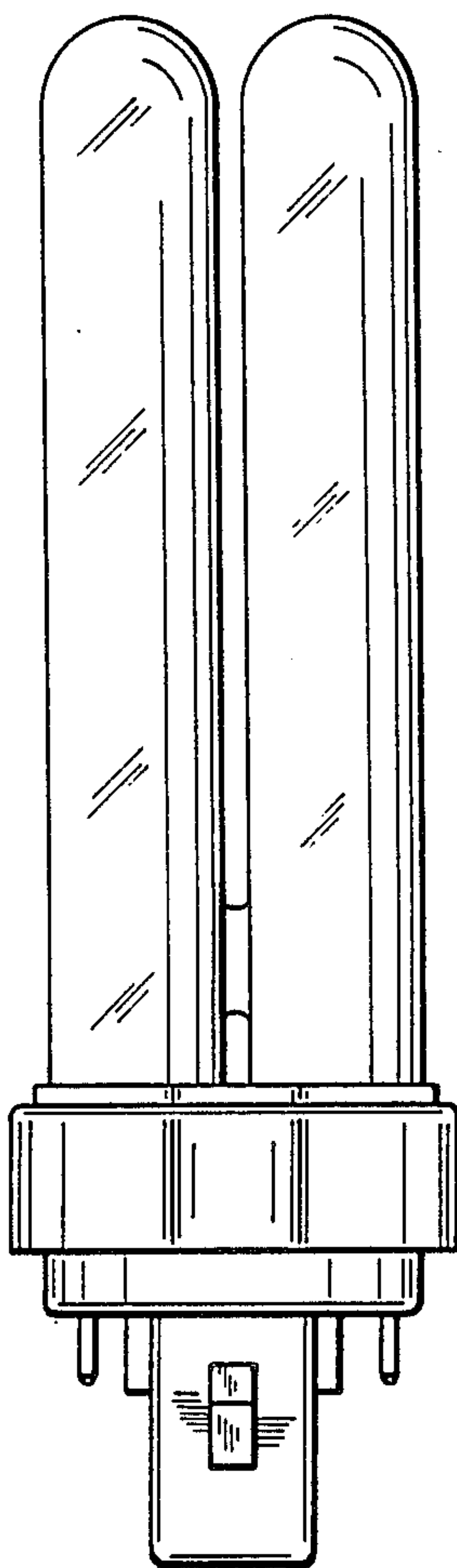

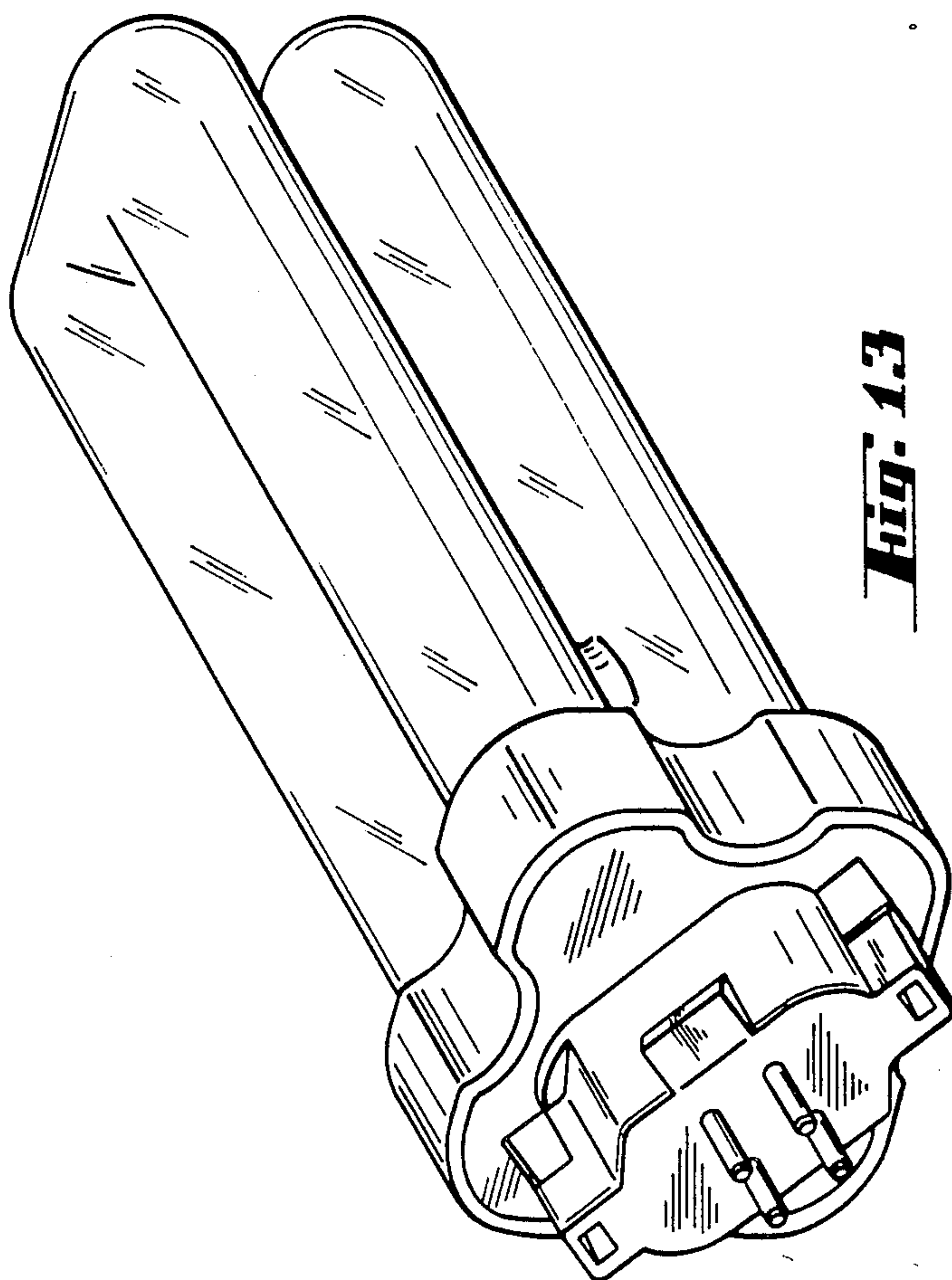

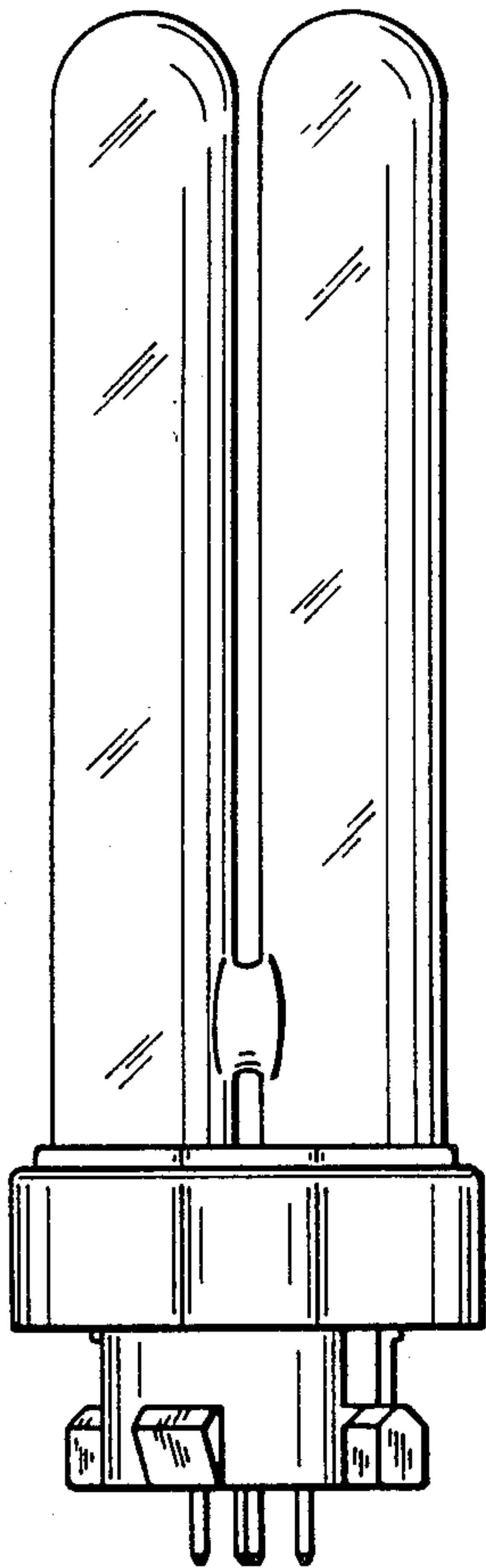

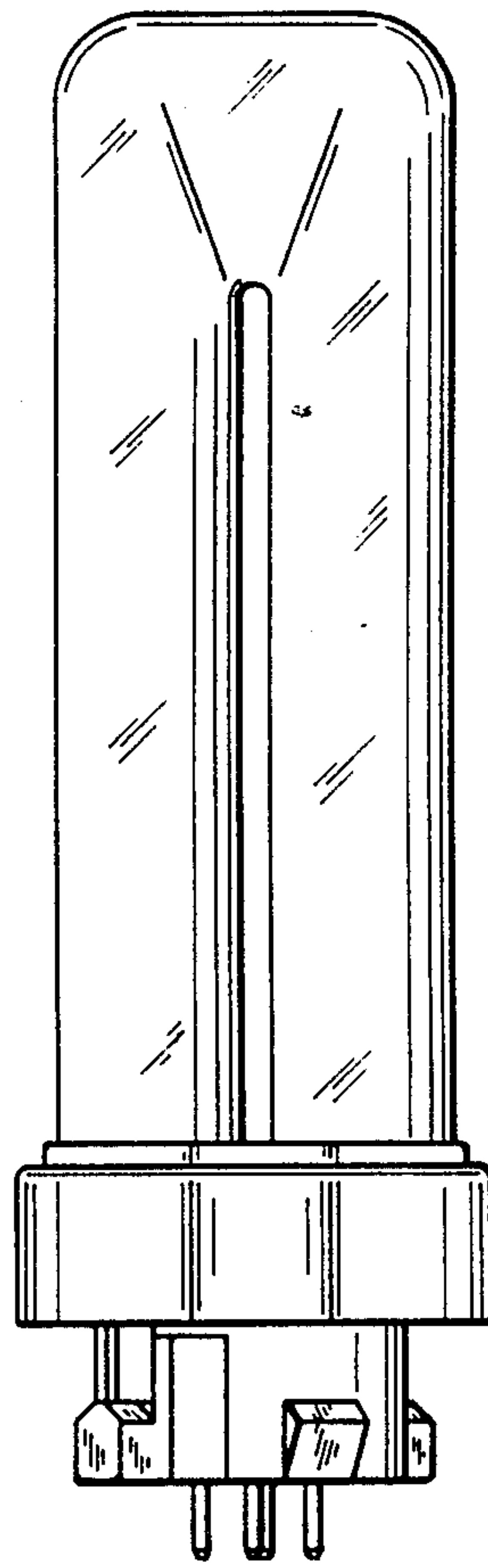

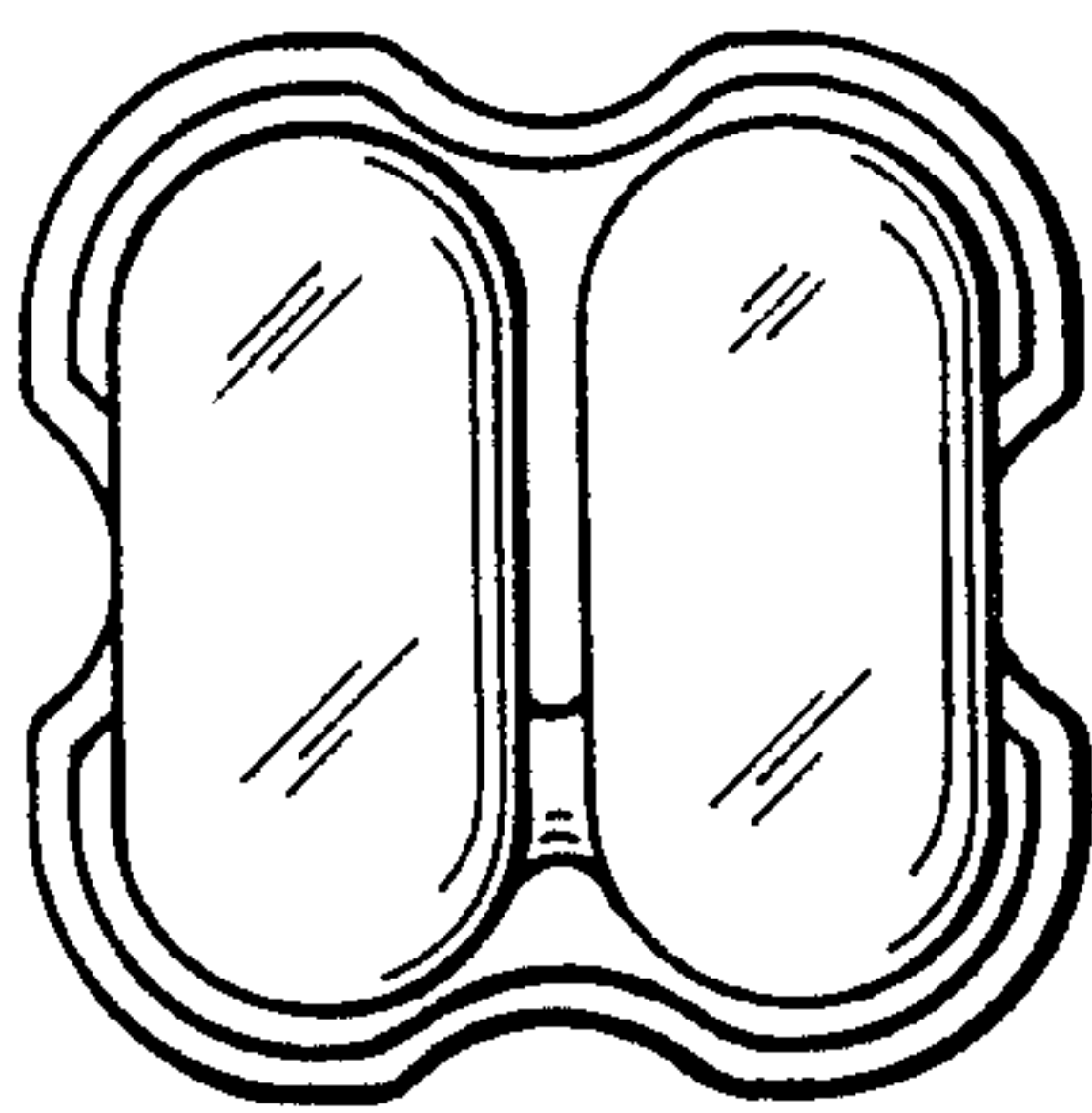

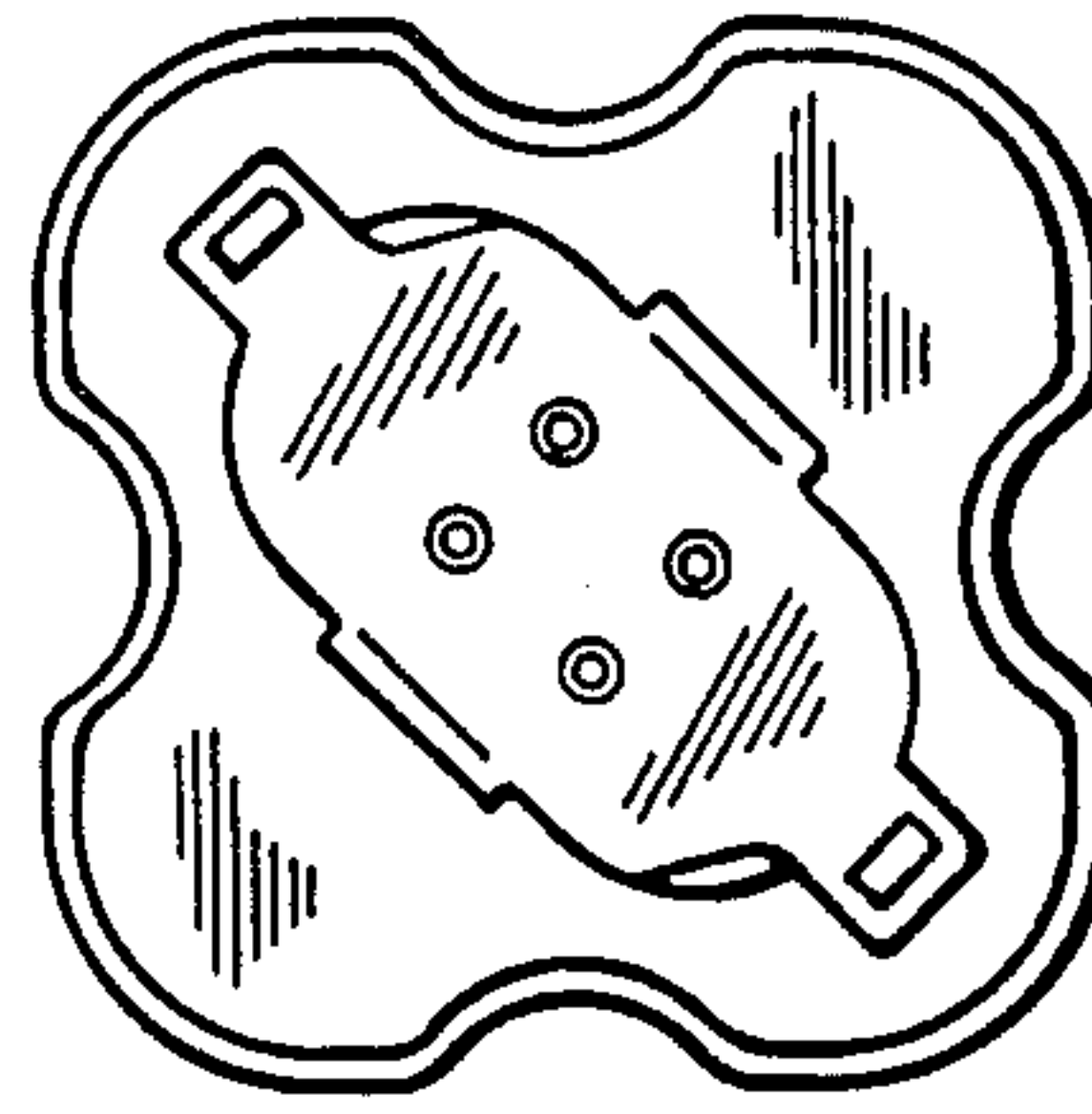

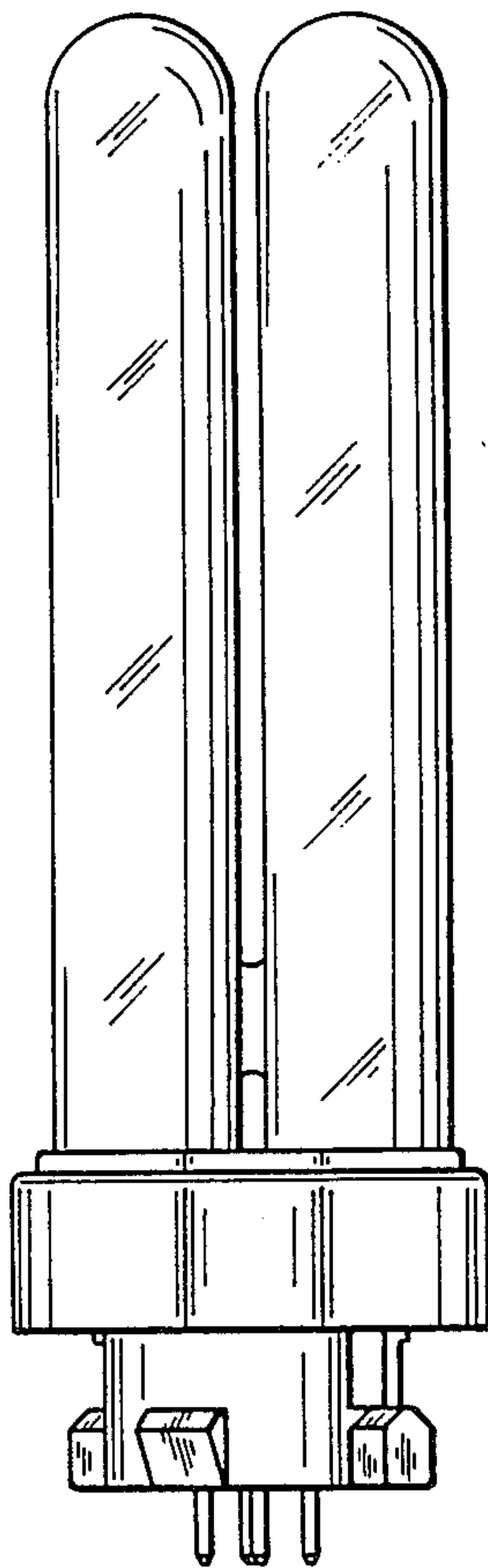
