**DESCRIPTION**

FIG. 1 is a front elevation of a tote box showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a rear side elevation thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a right side elevation thereof;  
 FIG. 6 is a left side elevation thereof; and  
 FIG. 7 is a sectional elevation taken along line 7—7 of FIG. 2.

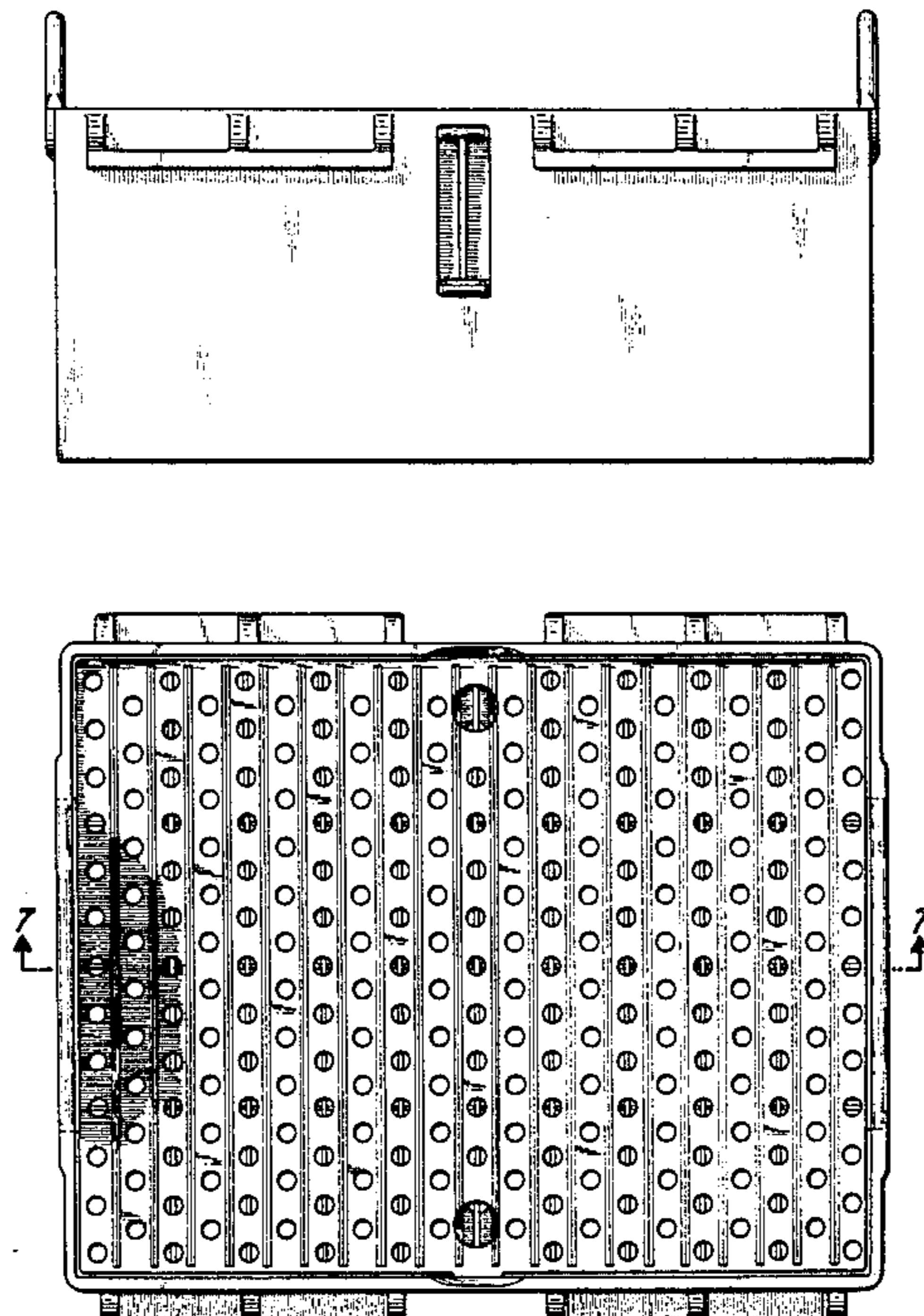

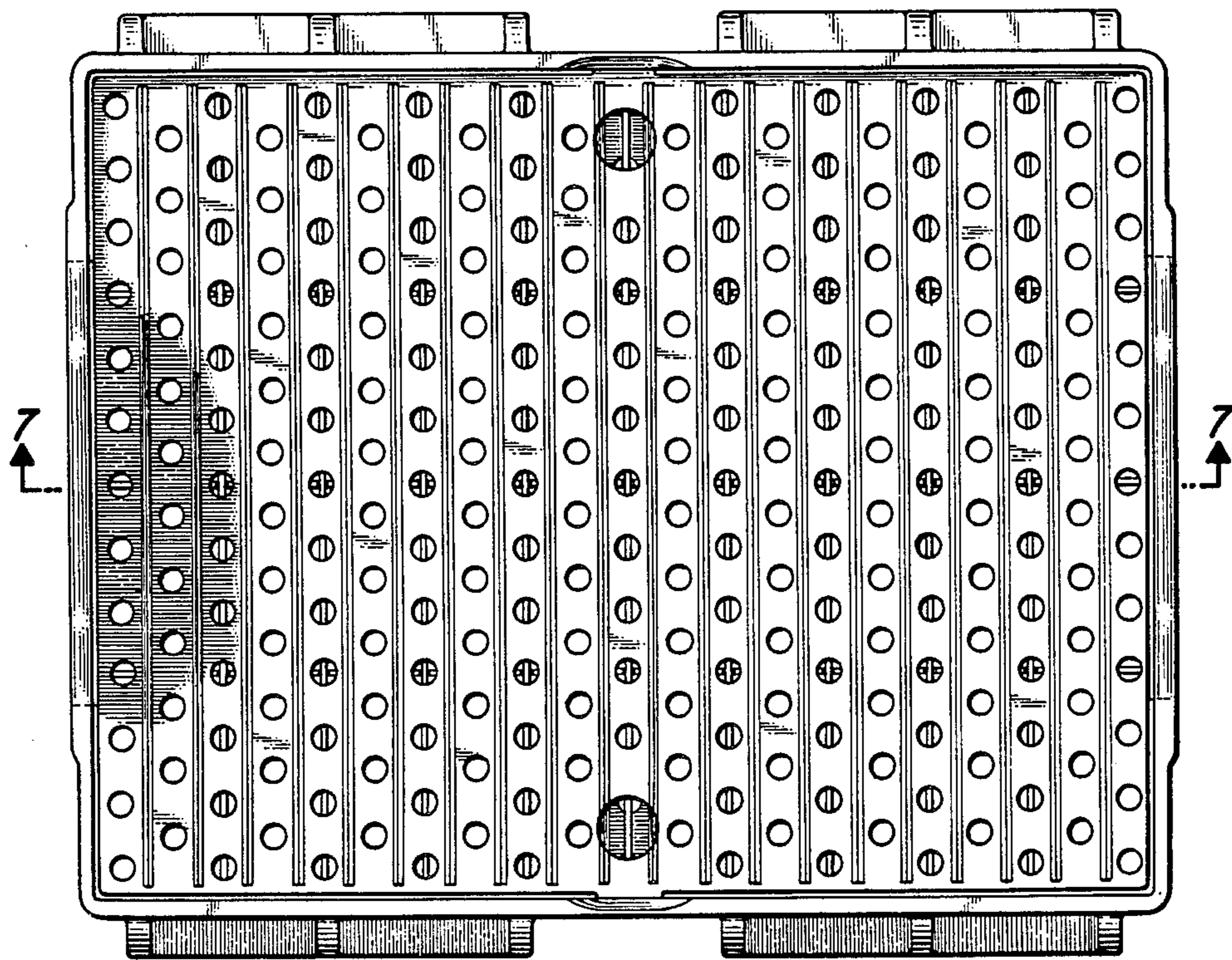
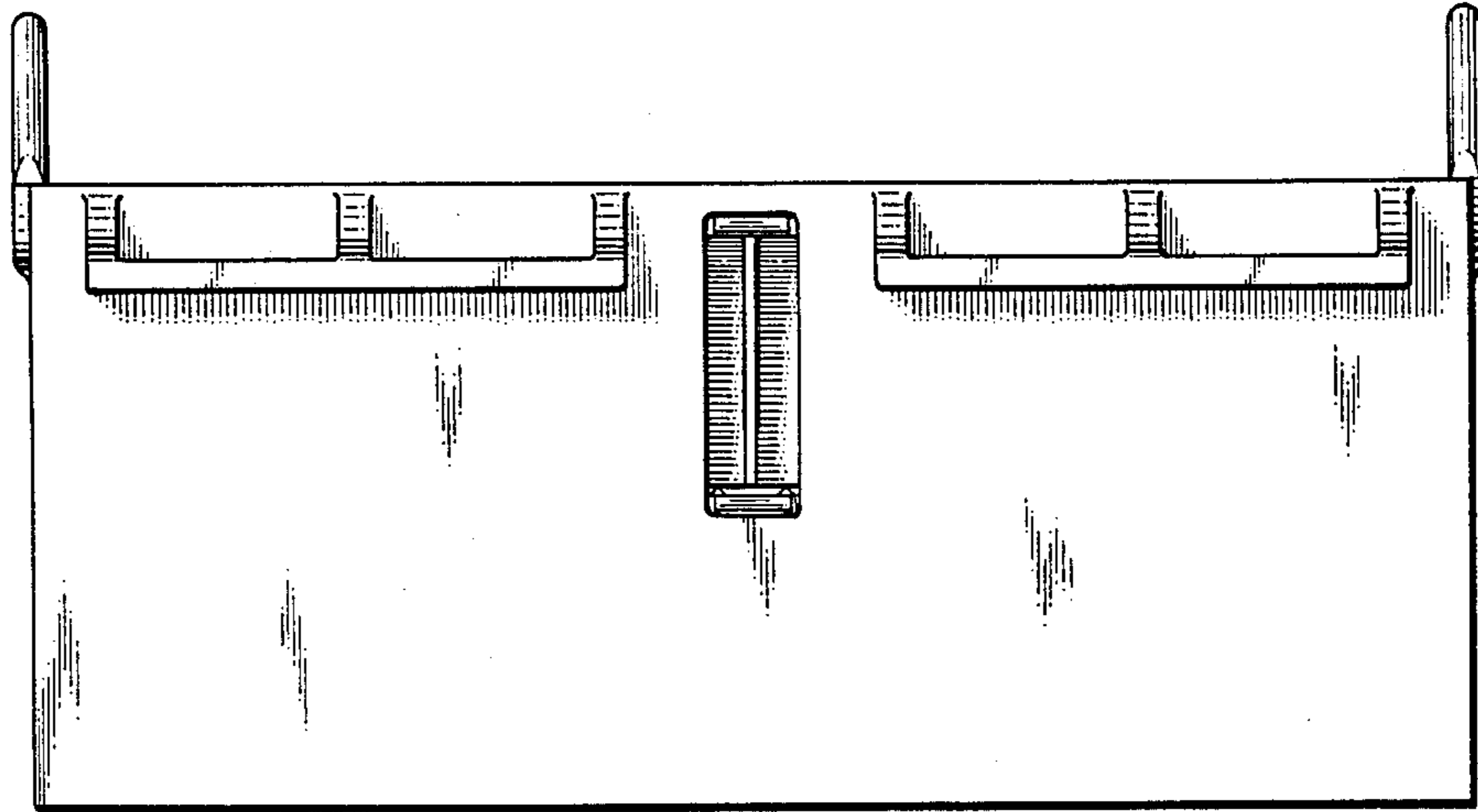

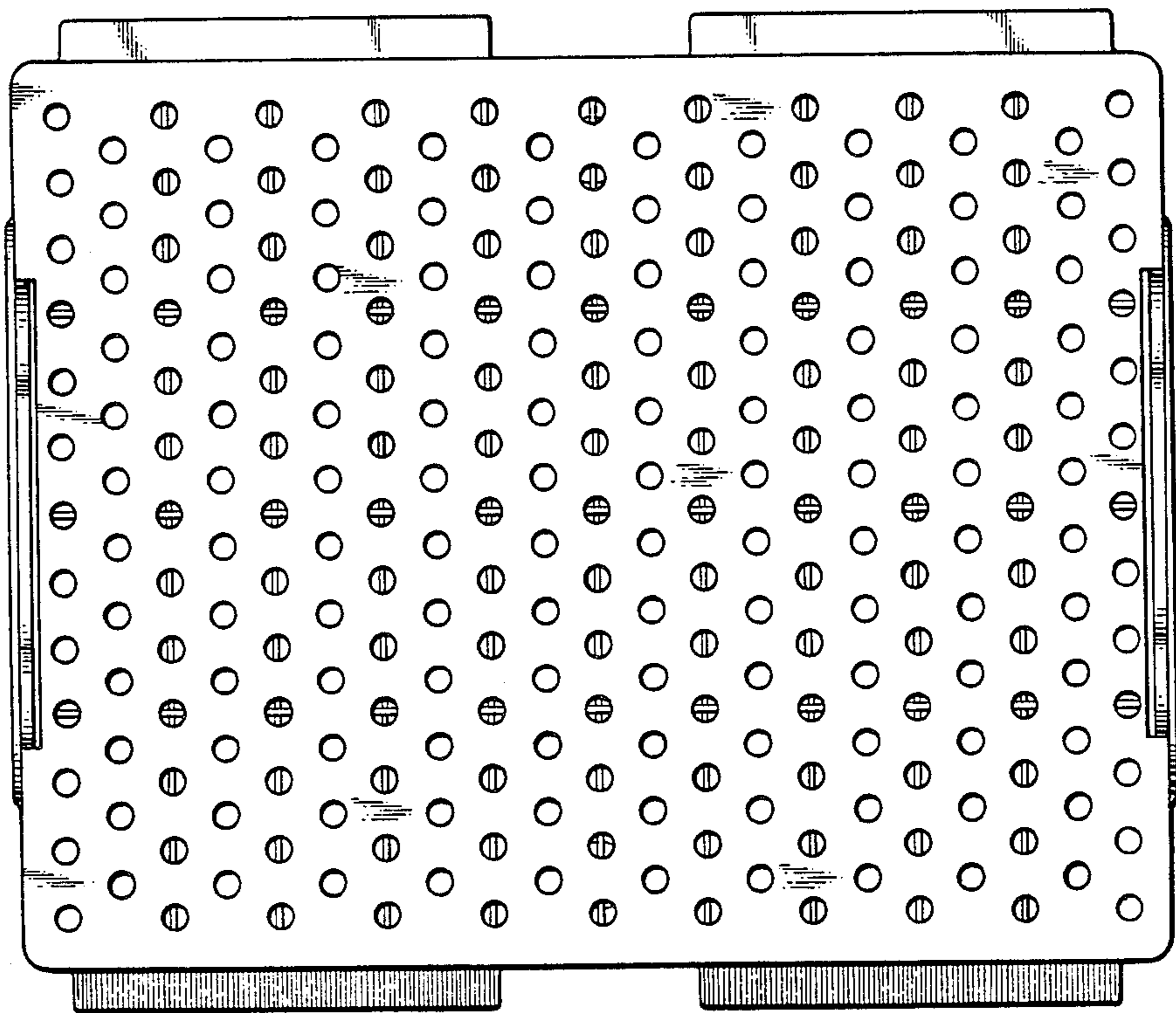
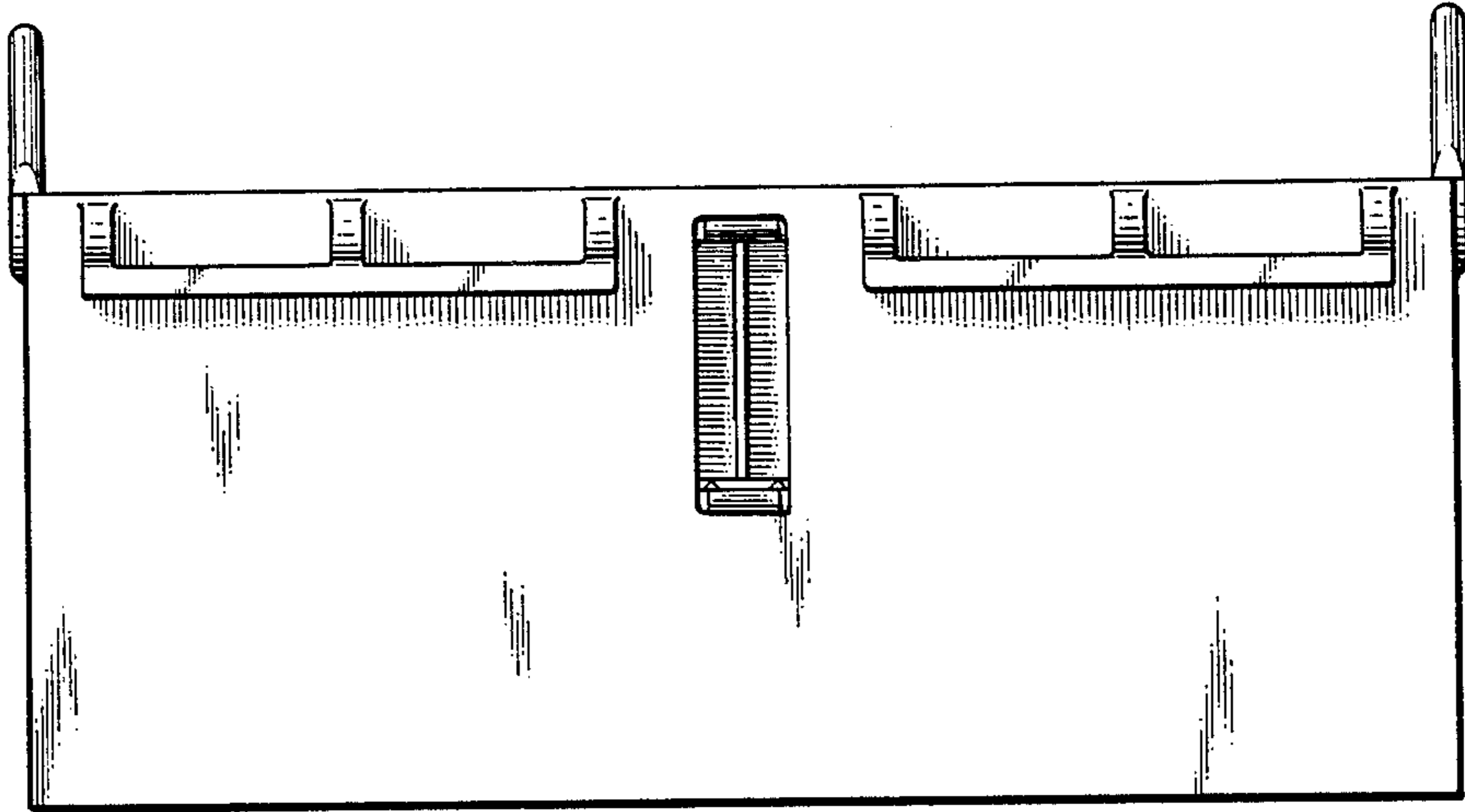

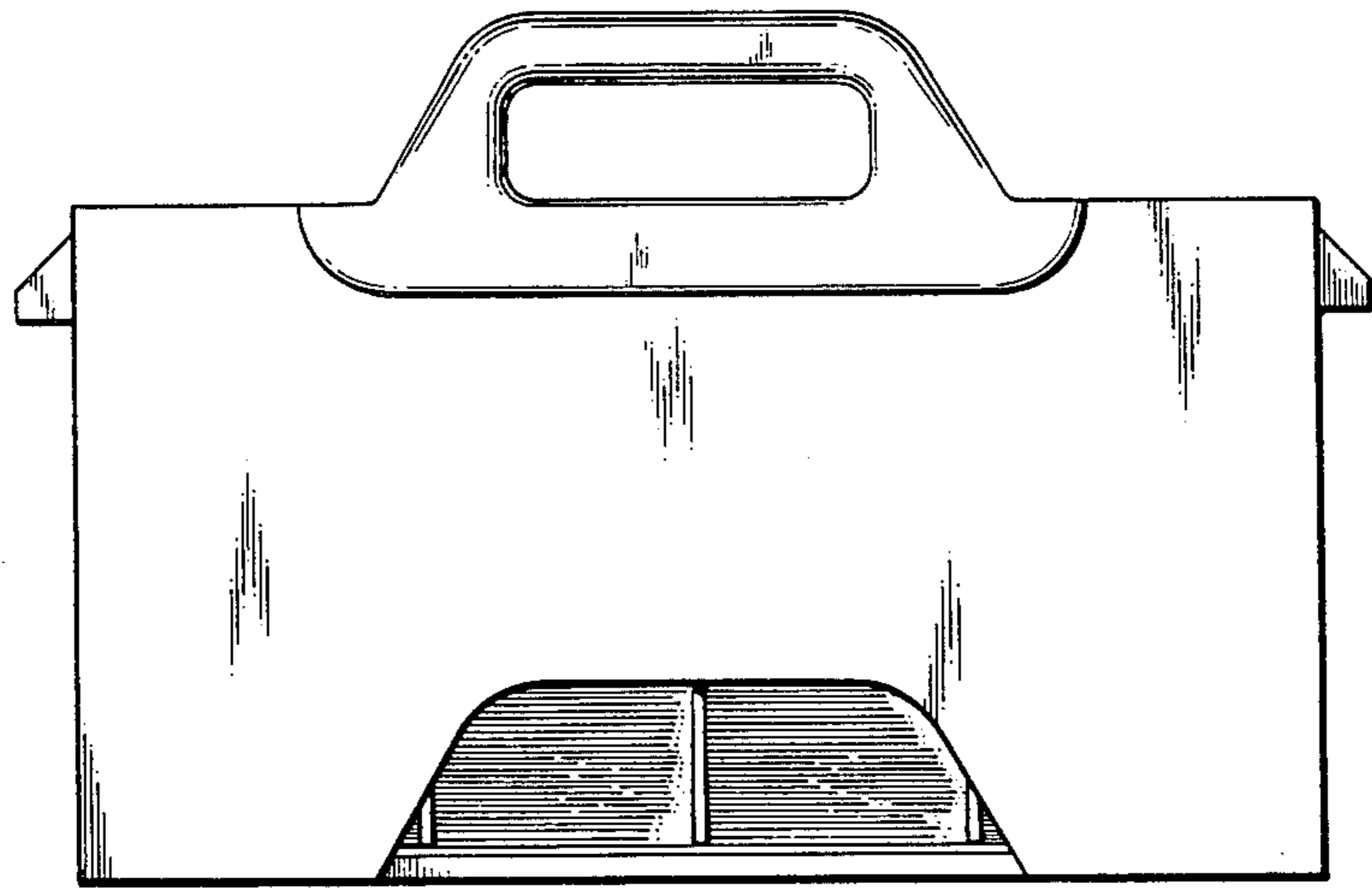
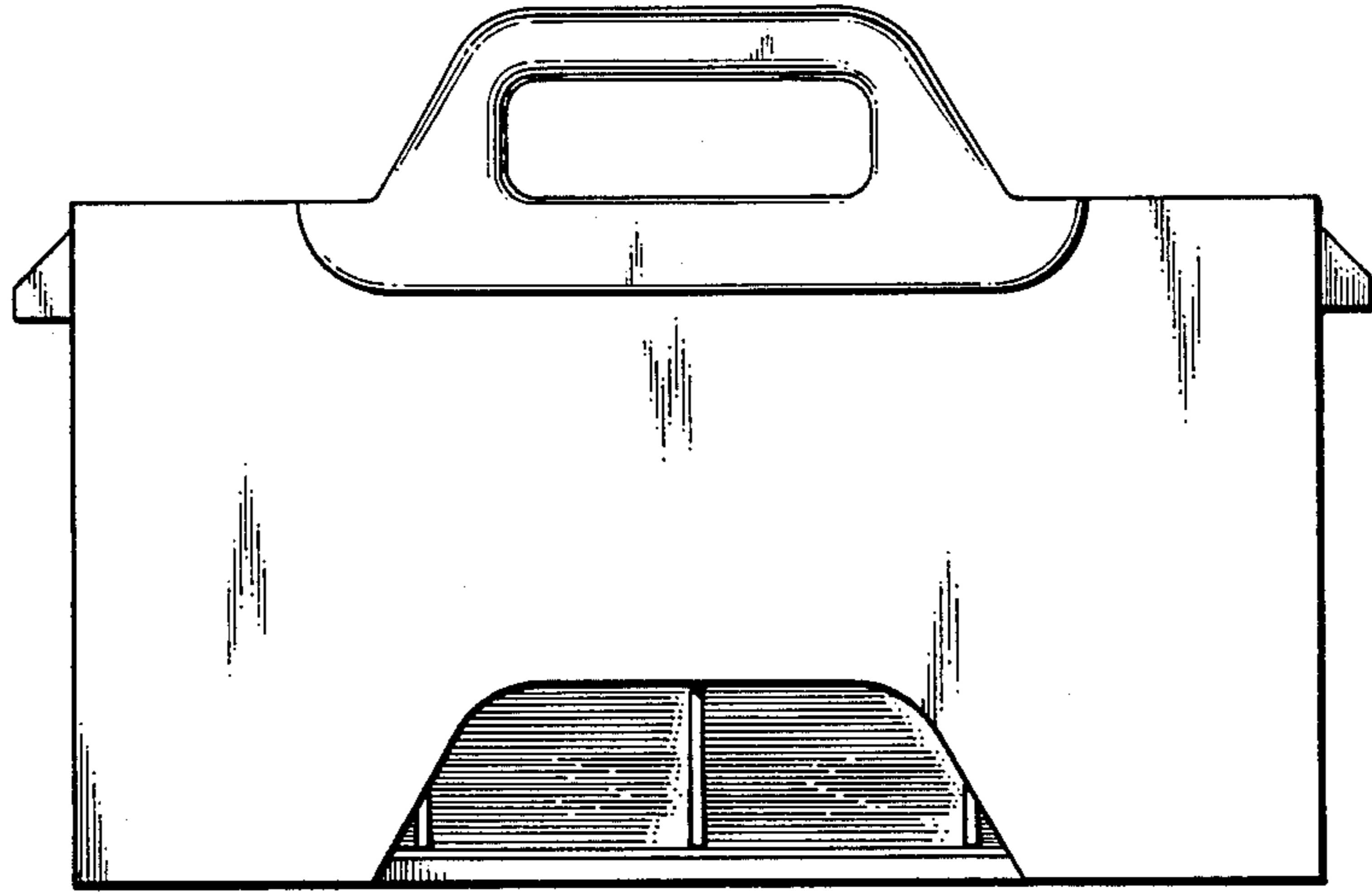

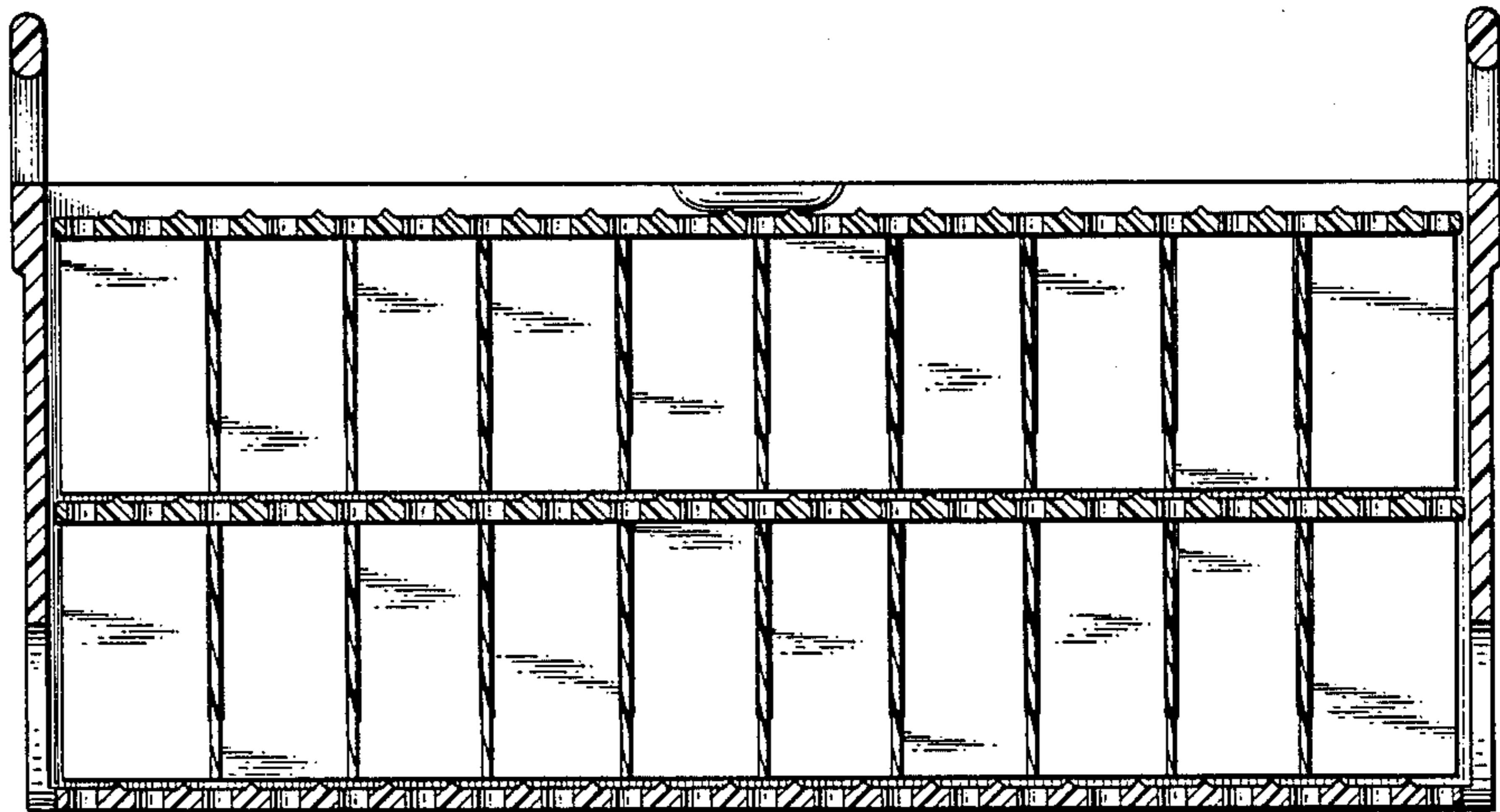
