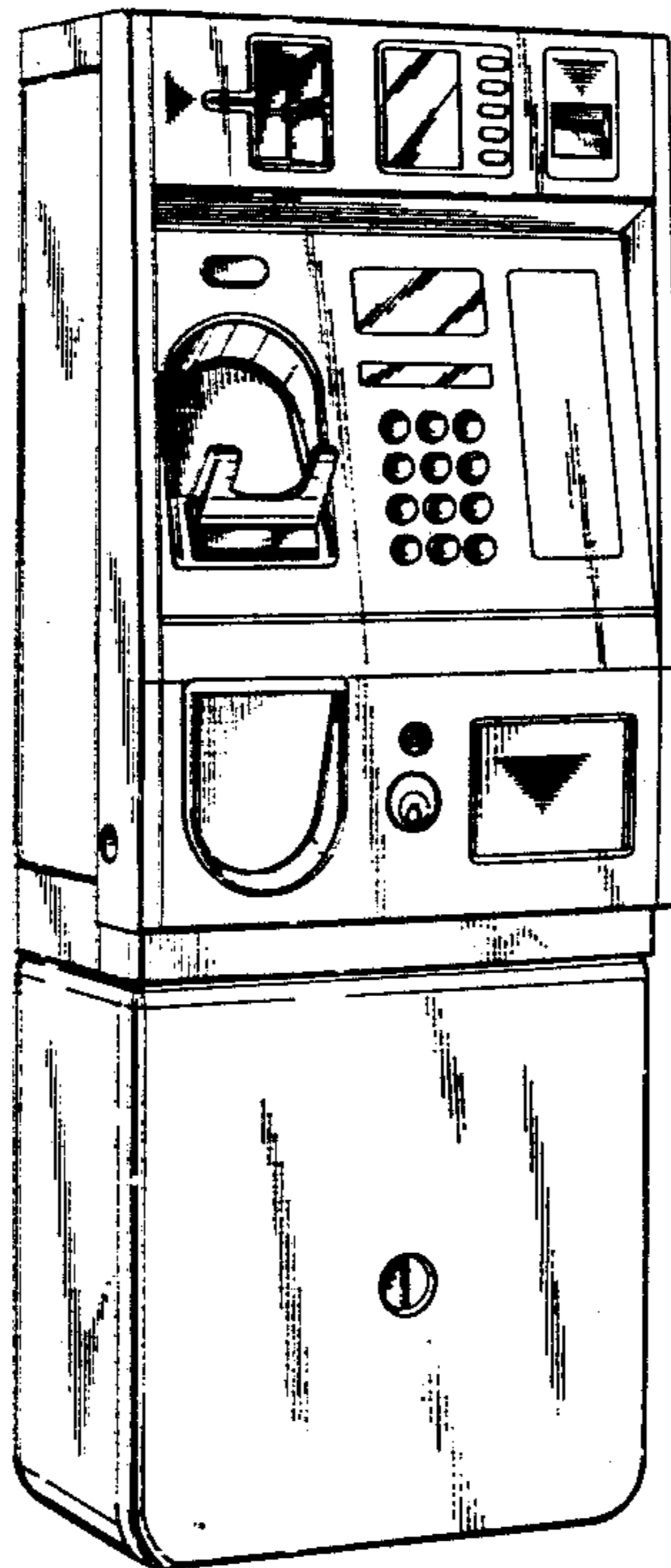

[57] CLAIM

The ornamental design for a public pay telephone stand with alternative payment means, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a public pay telephone stand with alternative payment means showing my new design; and
 FIG. 2 is a left side, front perspective view thereof.
 The undisclosed rear and bottom sides are plain and unadorned.



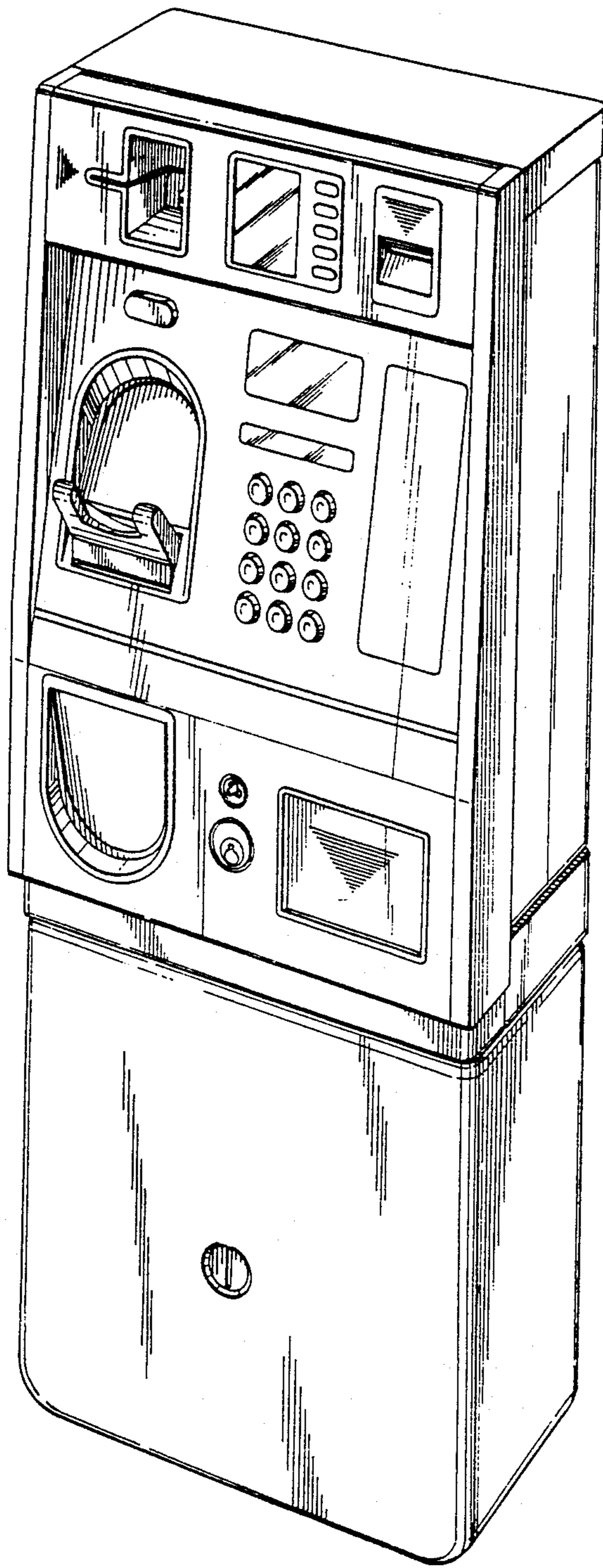

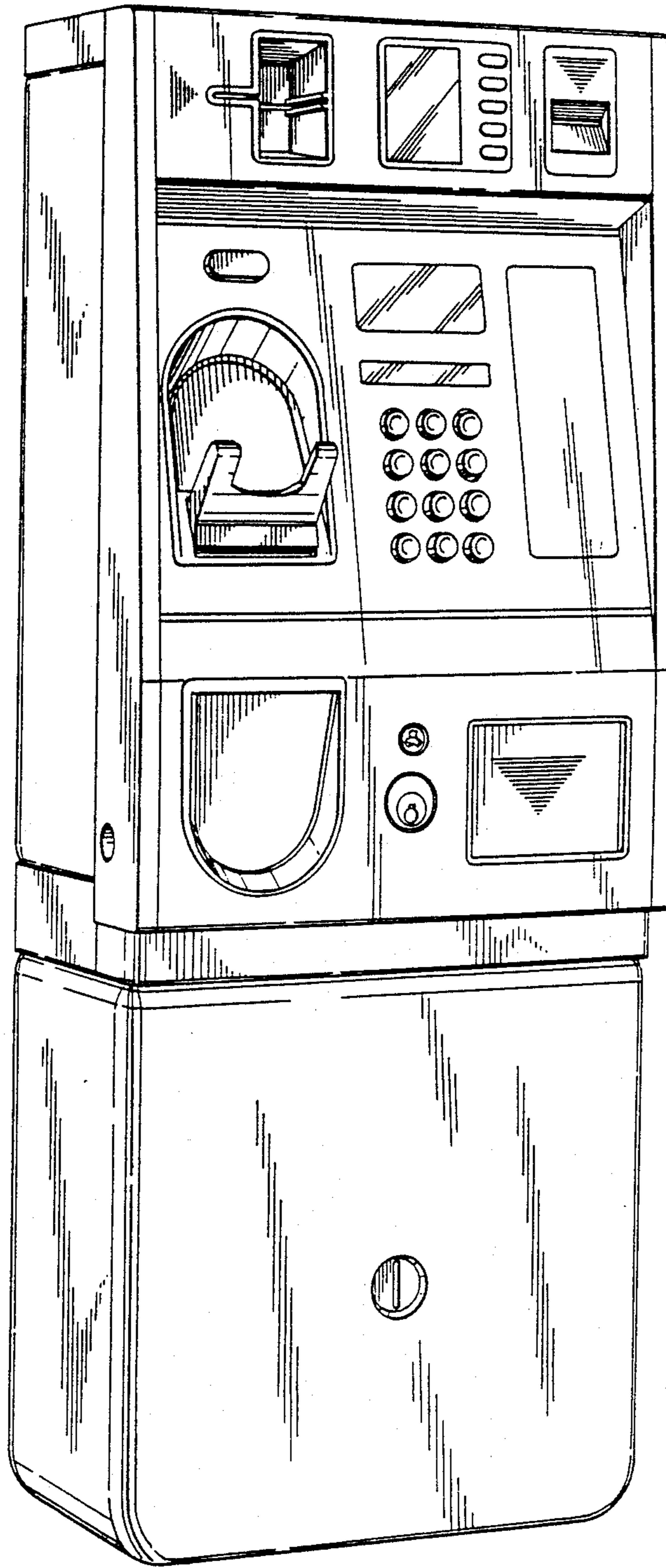
