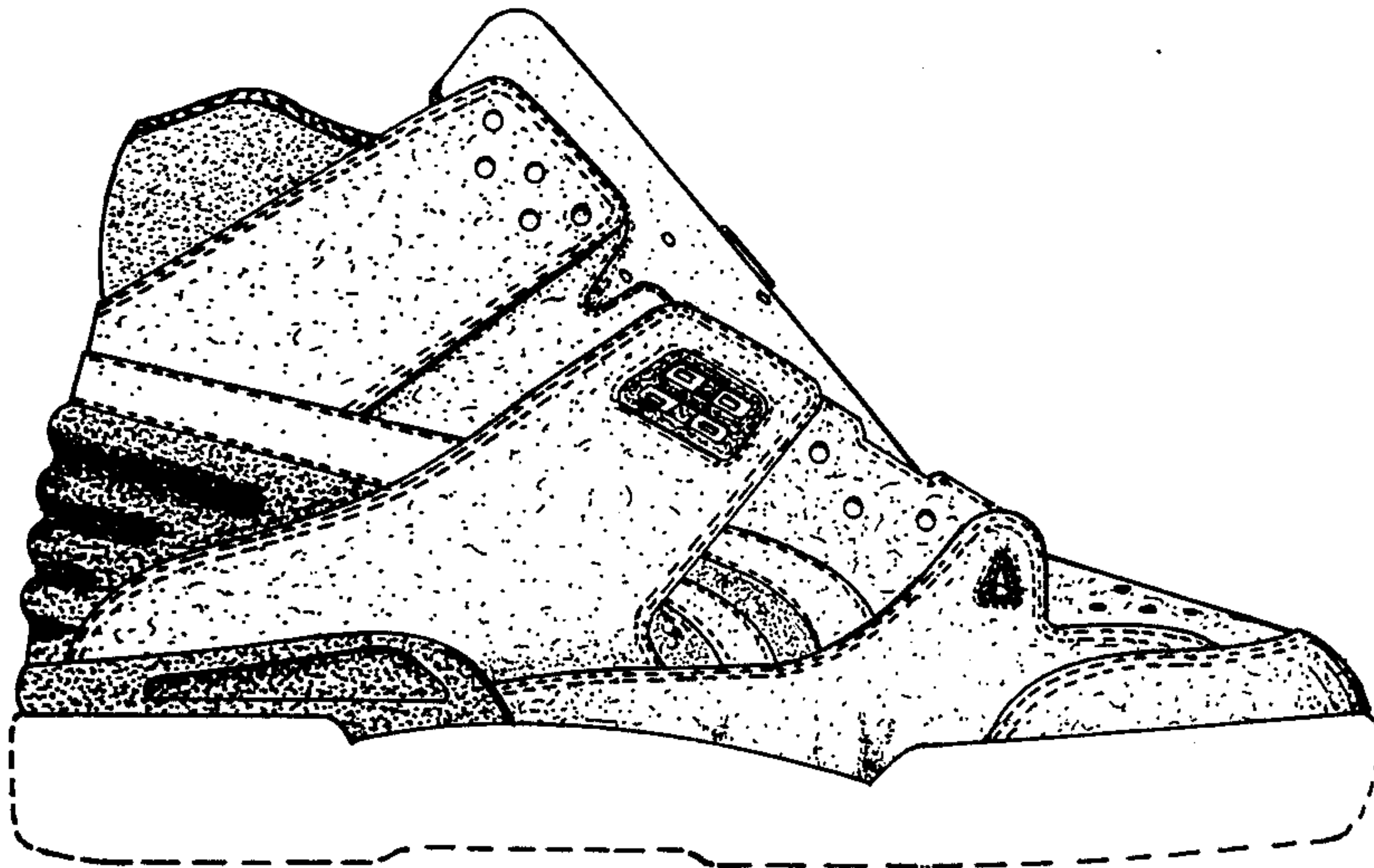

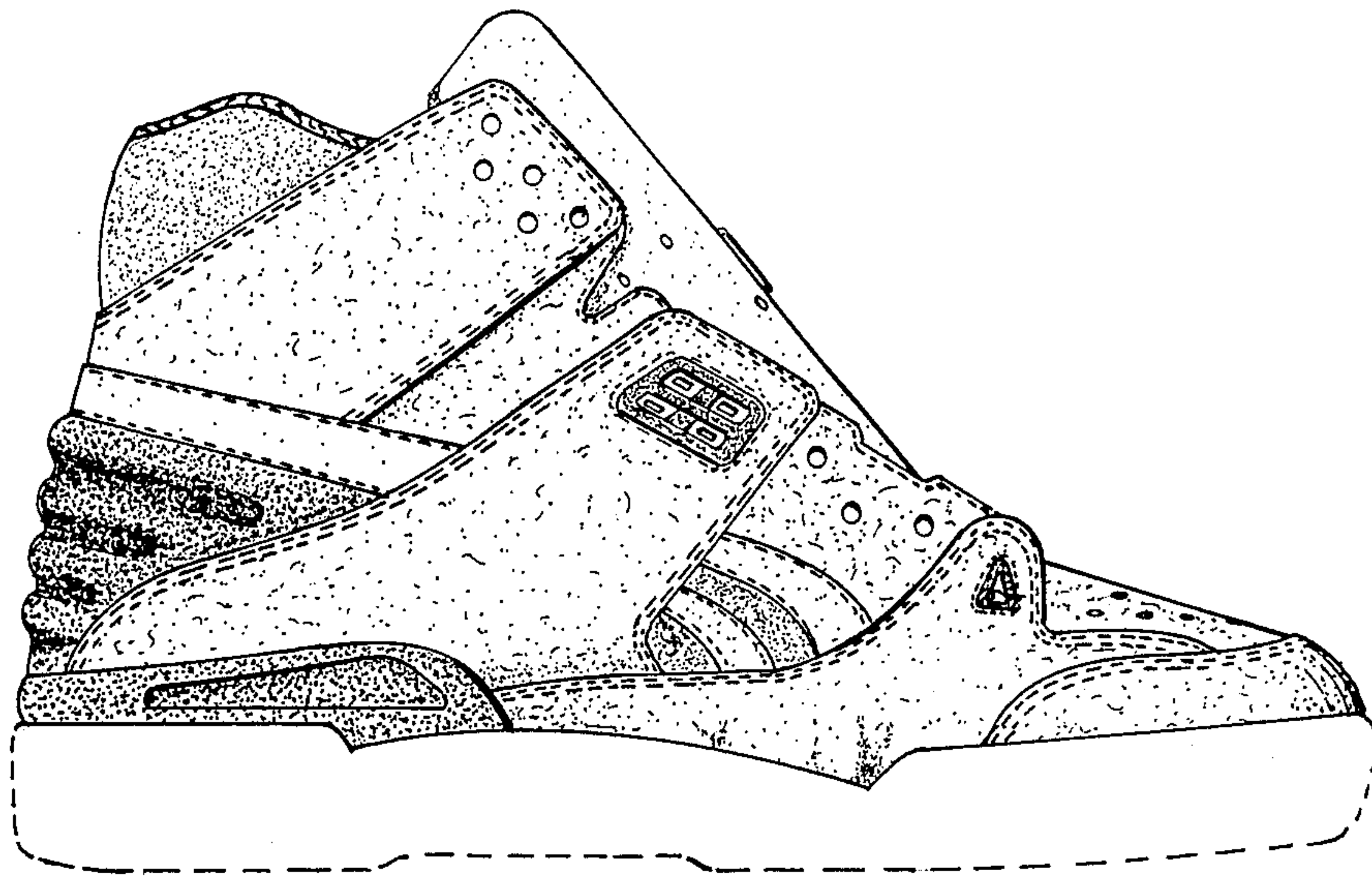
[57] **CLAIM**

The ornamental design for a shoe upper, as shown and described.

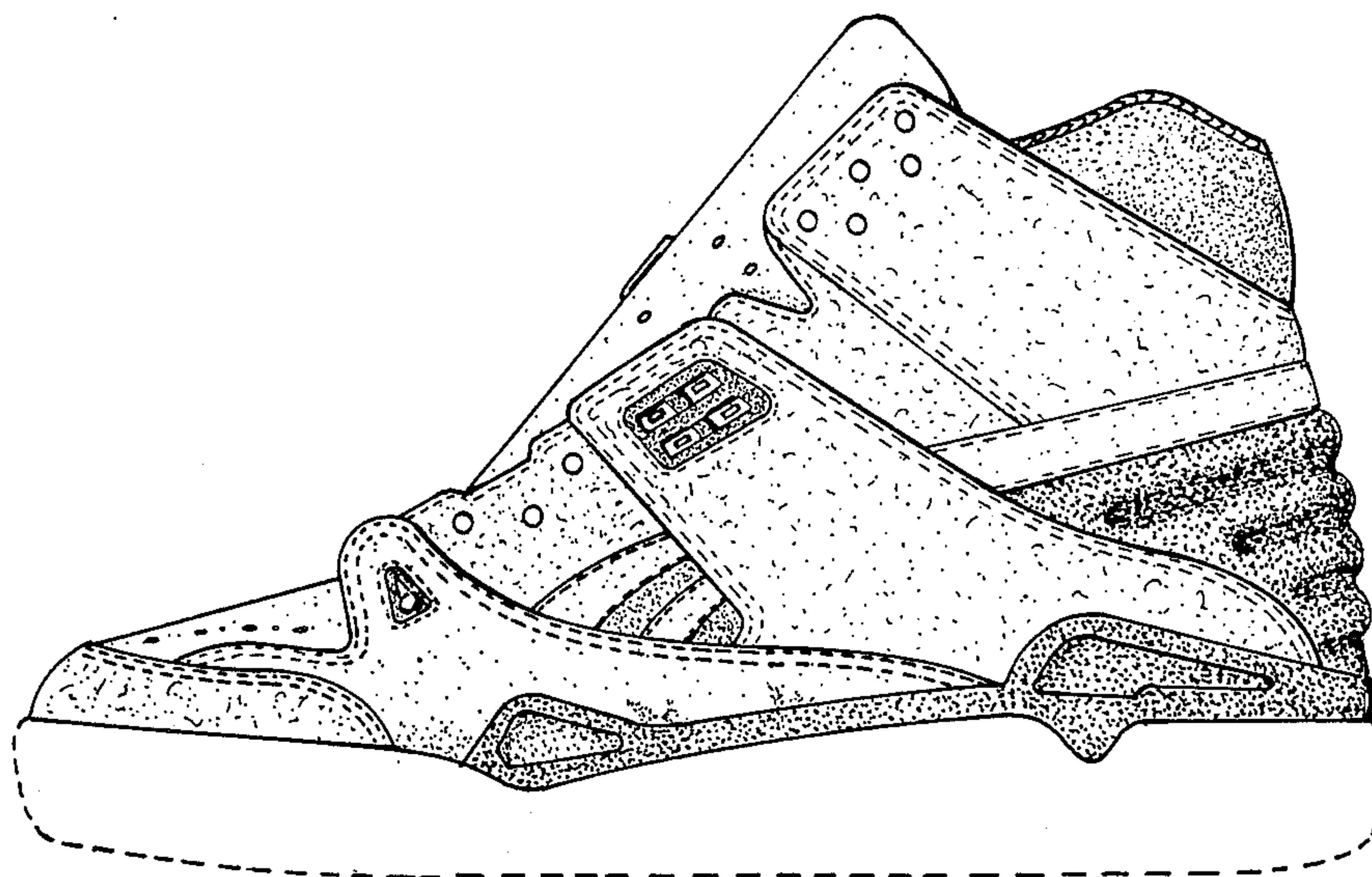
**DESCRIPTION**

The broken line showing of a shoe sole in the Figures is environmental only and does not form part of the claimed design.

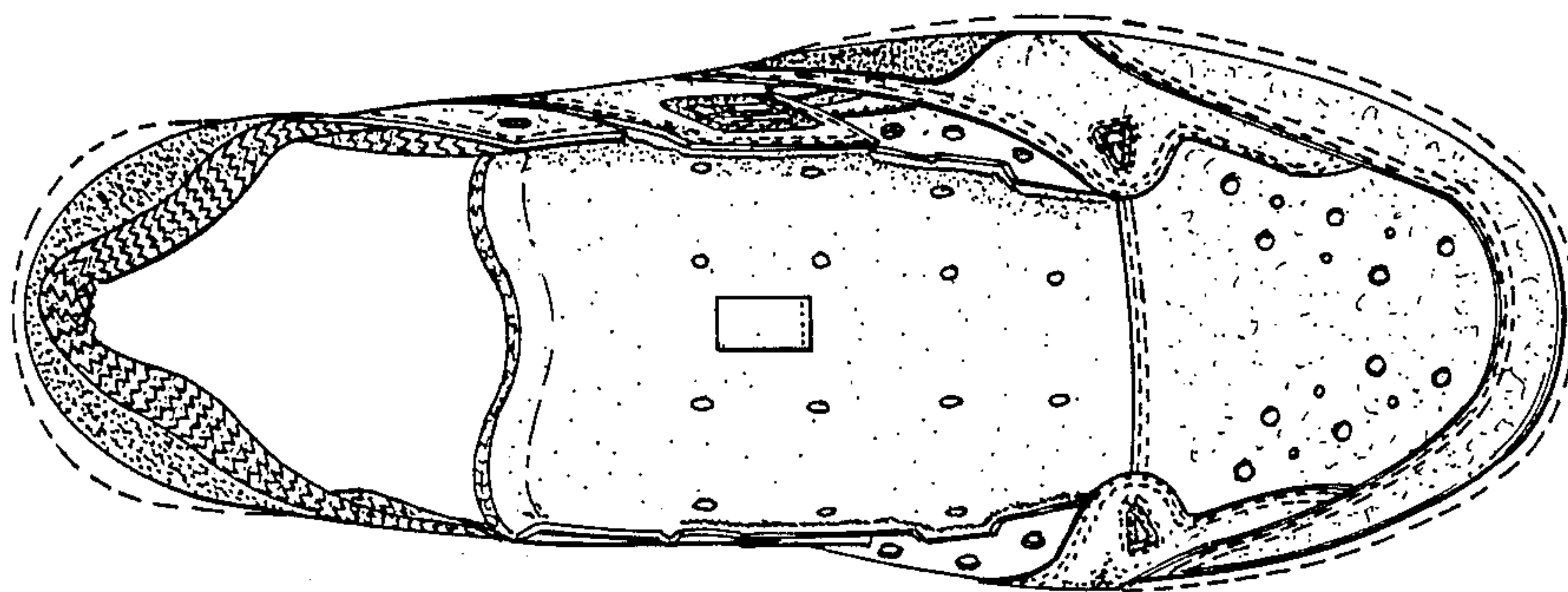

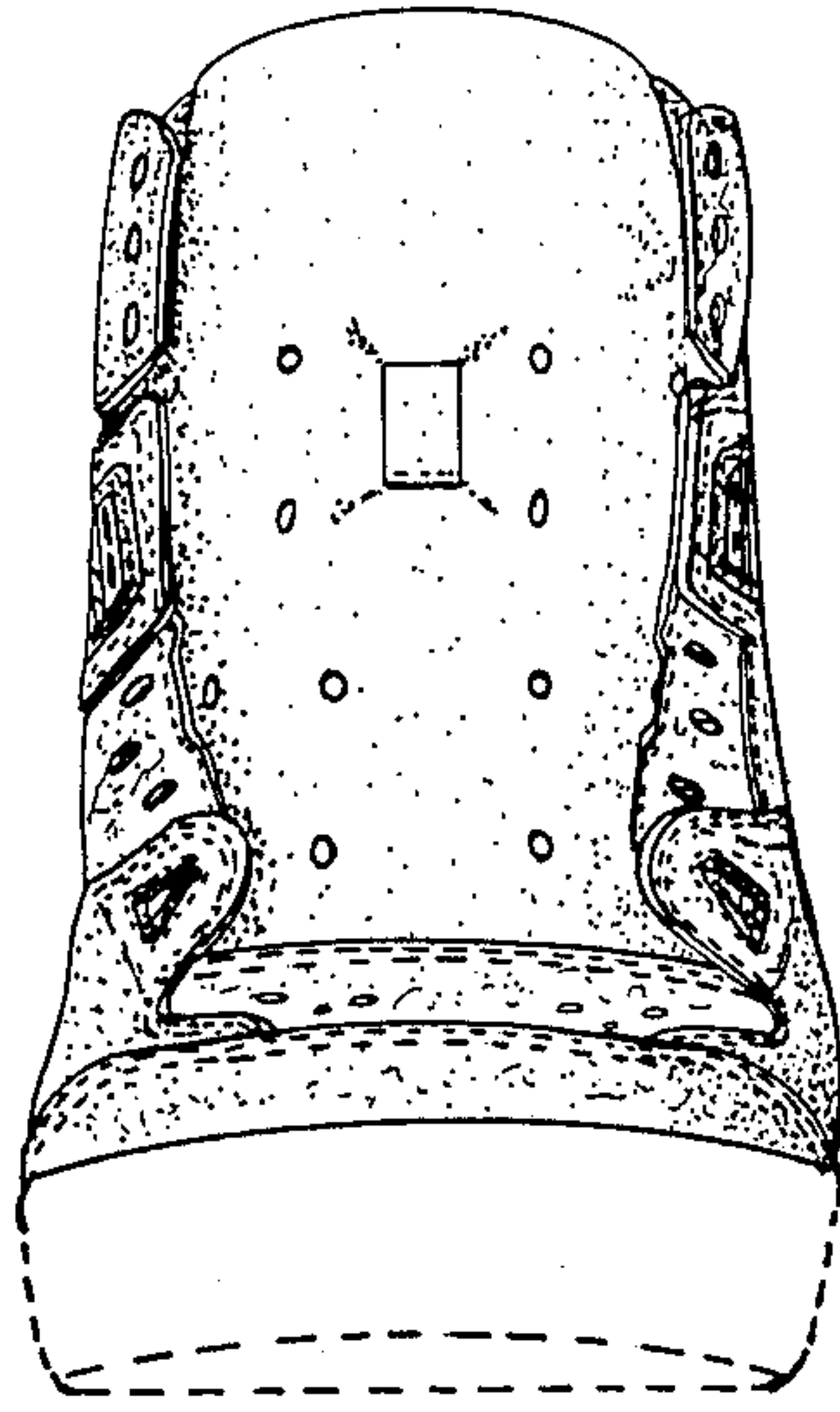

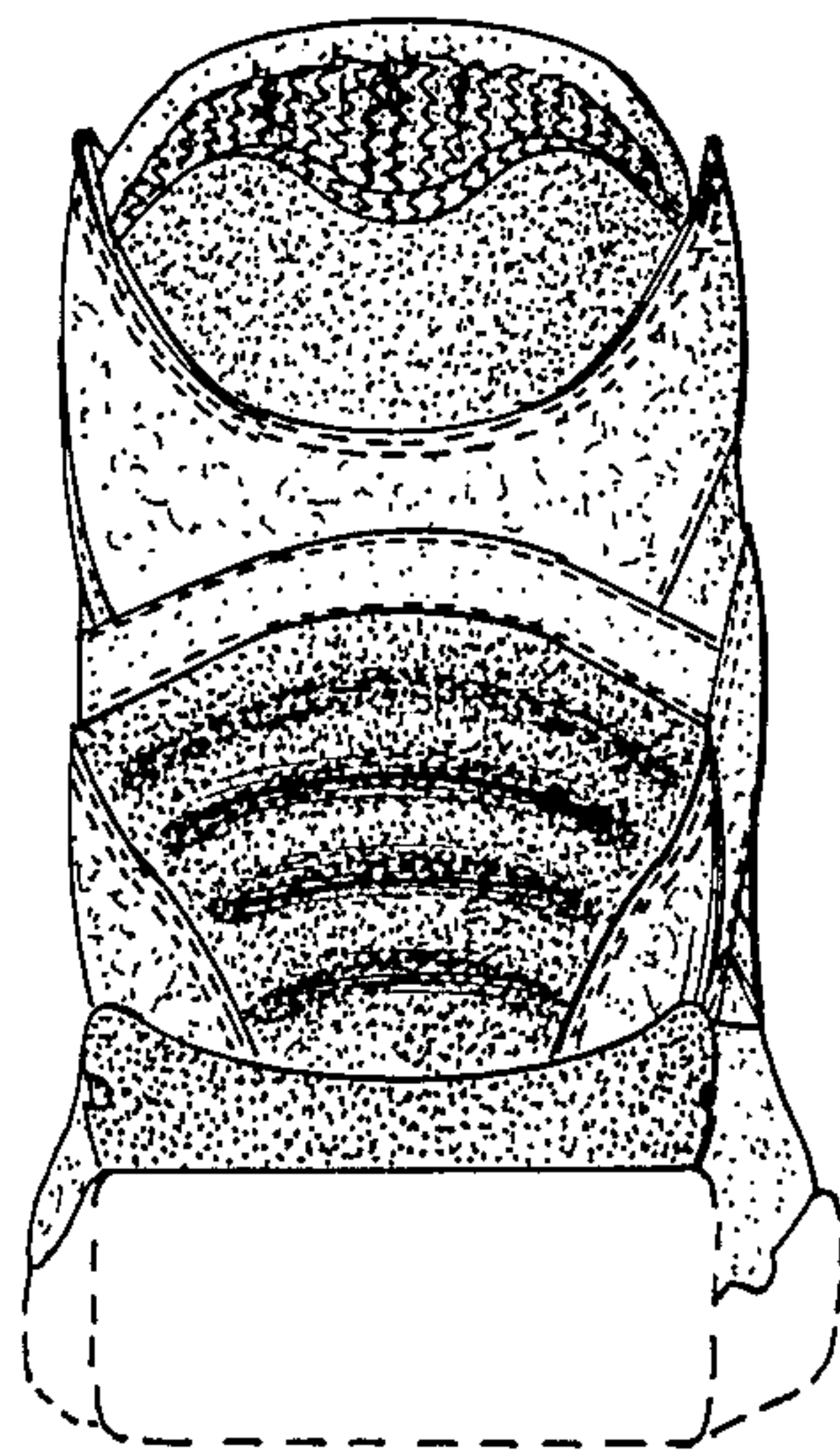
