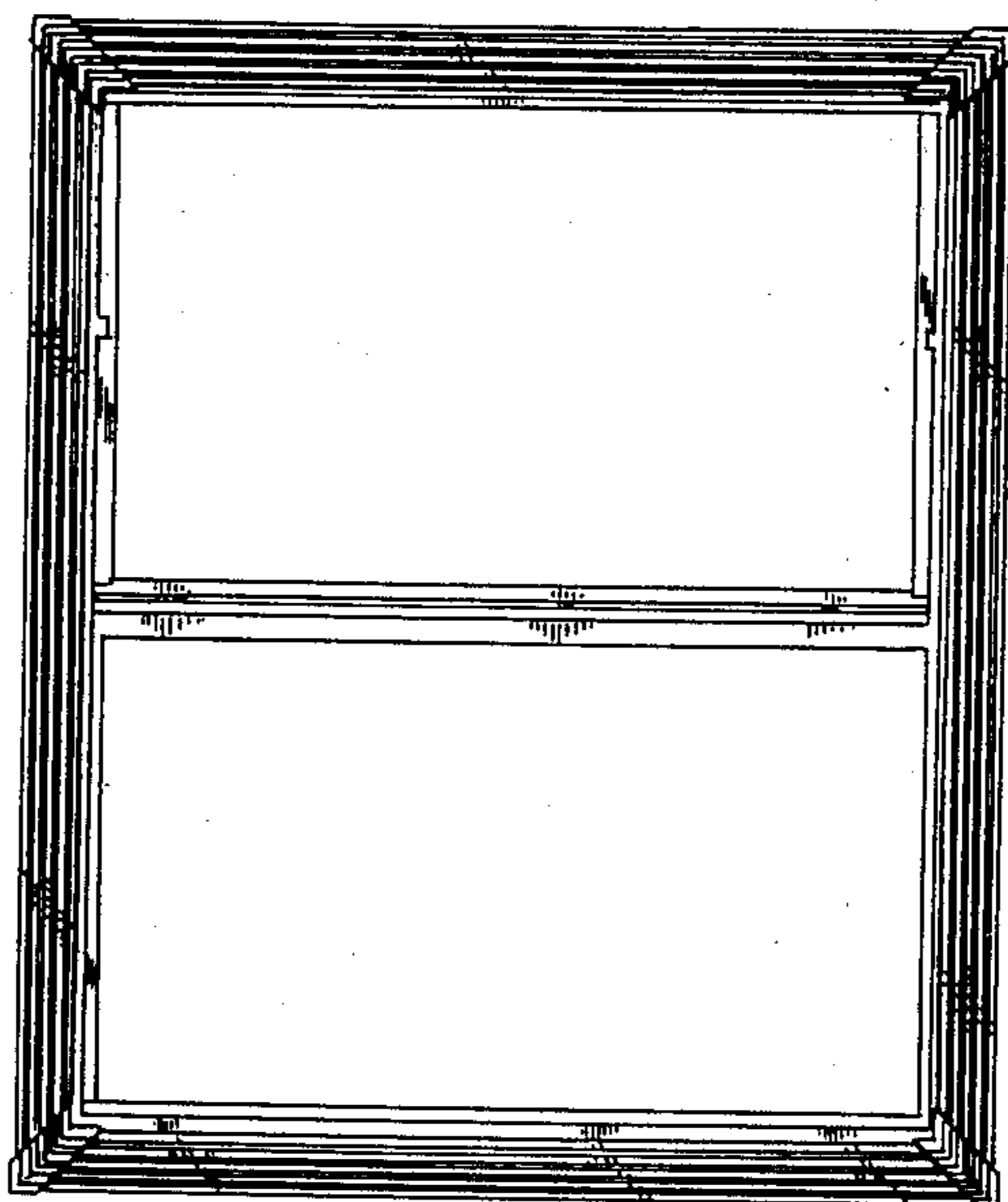

[57] CLAIM

The ornamental design for a door light frame, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a door light frame embodying our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a fragmentary perspective view of the upper left-hand corner of the frame shown in FIG. 1;
 FIG. 4 is a fragmentary elevational view of the upper left-hand corner of the frame shown in FIG. 1;
 FIG. 5 is a fragmentary top plan view of the front frame portion shown in FIG. 1;
 FIG. 6 is a fragmentary perspective view of the upper left-hand corner of the rear frame portion shown in FIG. 2;
 FIG. 7 is a fragmentary elevational view of the upper left-hand corner of the rear frame portion shown in FIG. 2;
 FIG. 8 is a fragmentary perspective view of the left center cross member shown in FIG. 2; and
 FIG. 9 is a fragmentary elevational view of the left center cross member shown in FIG. 2.



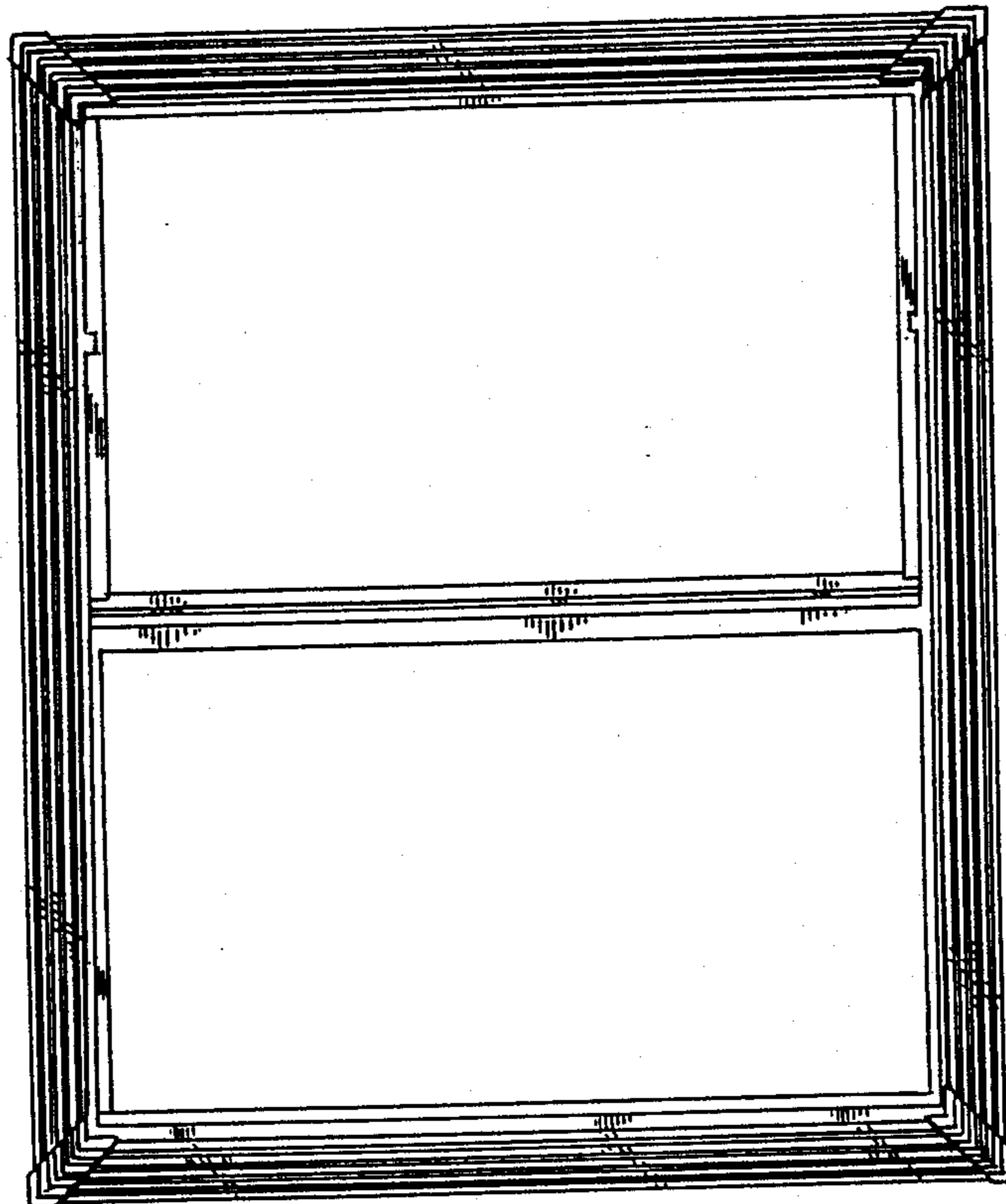

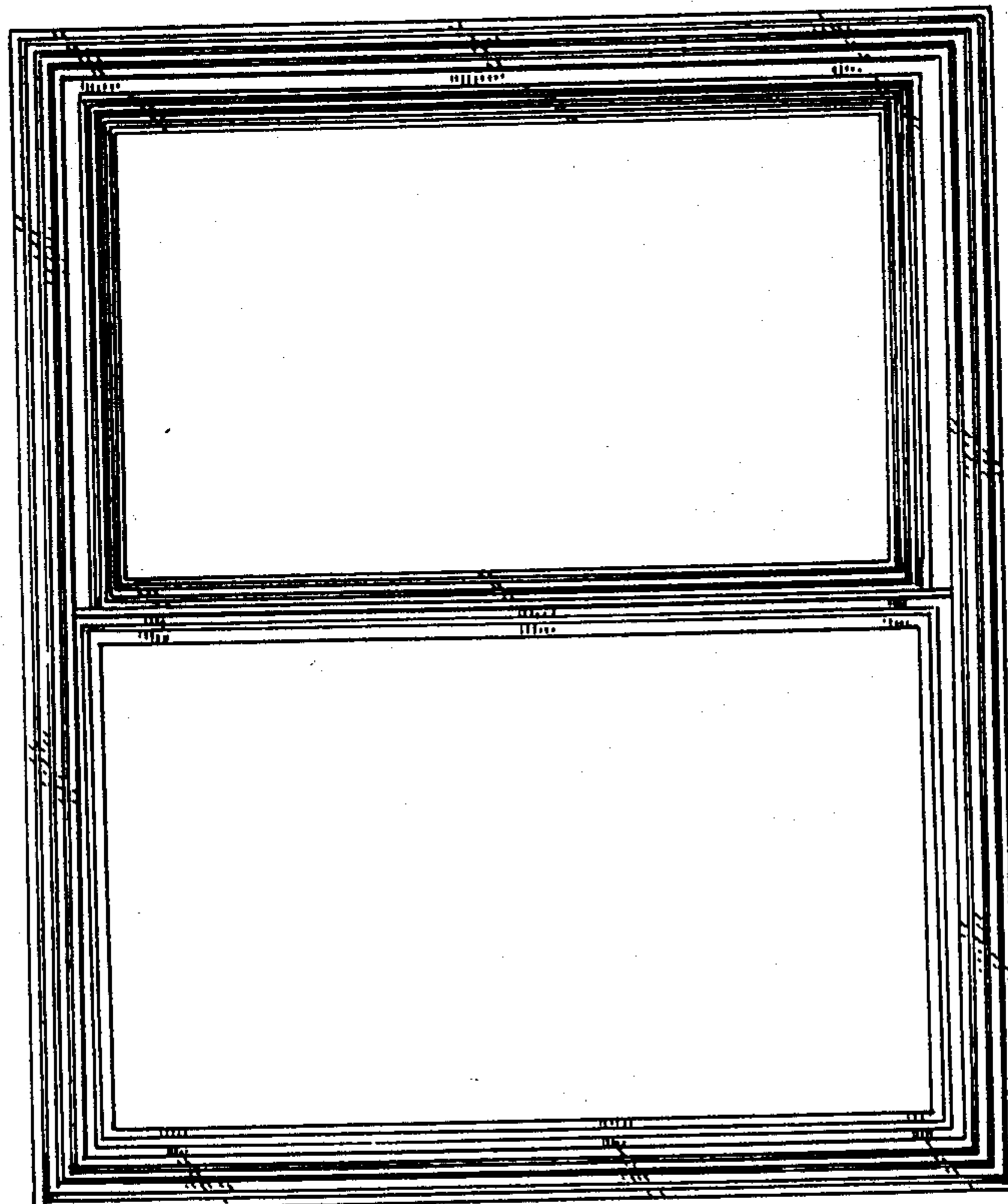

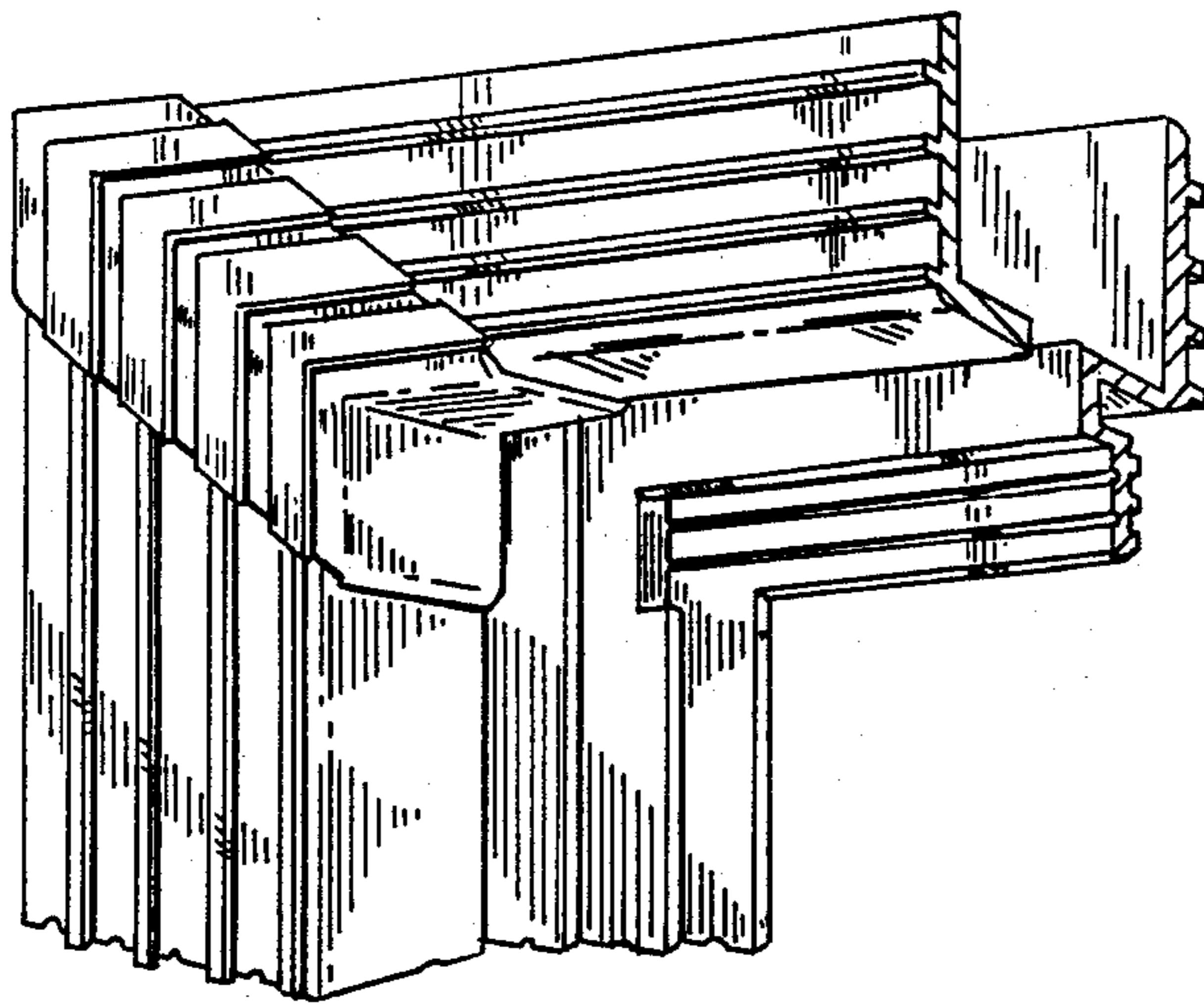

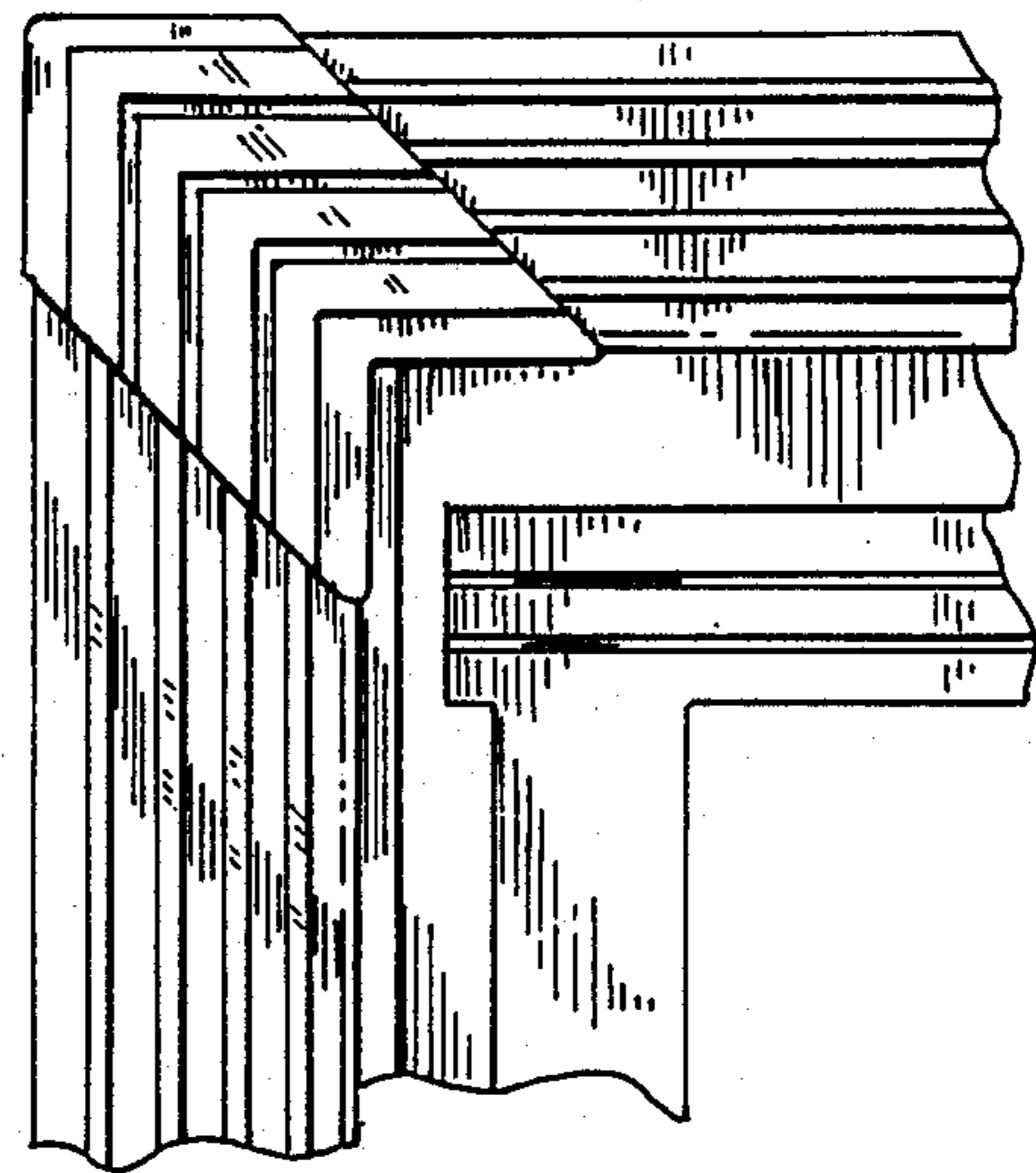

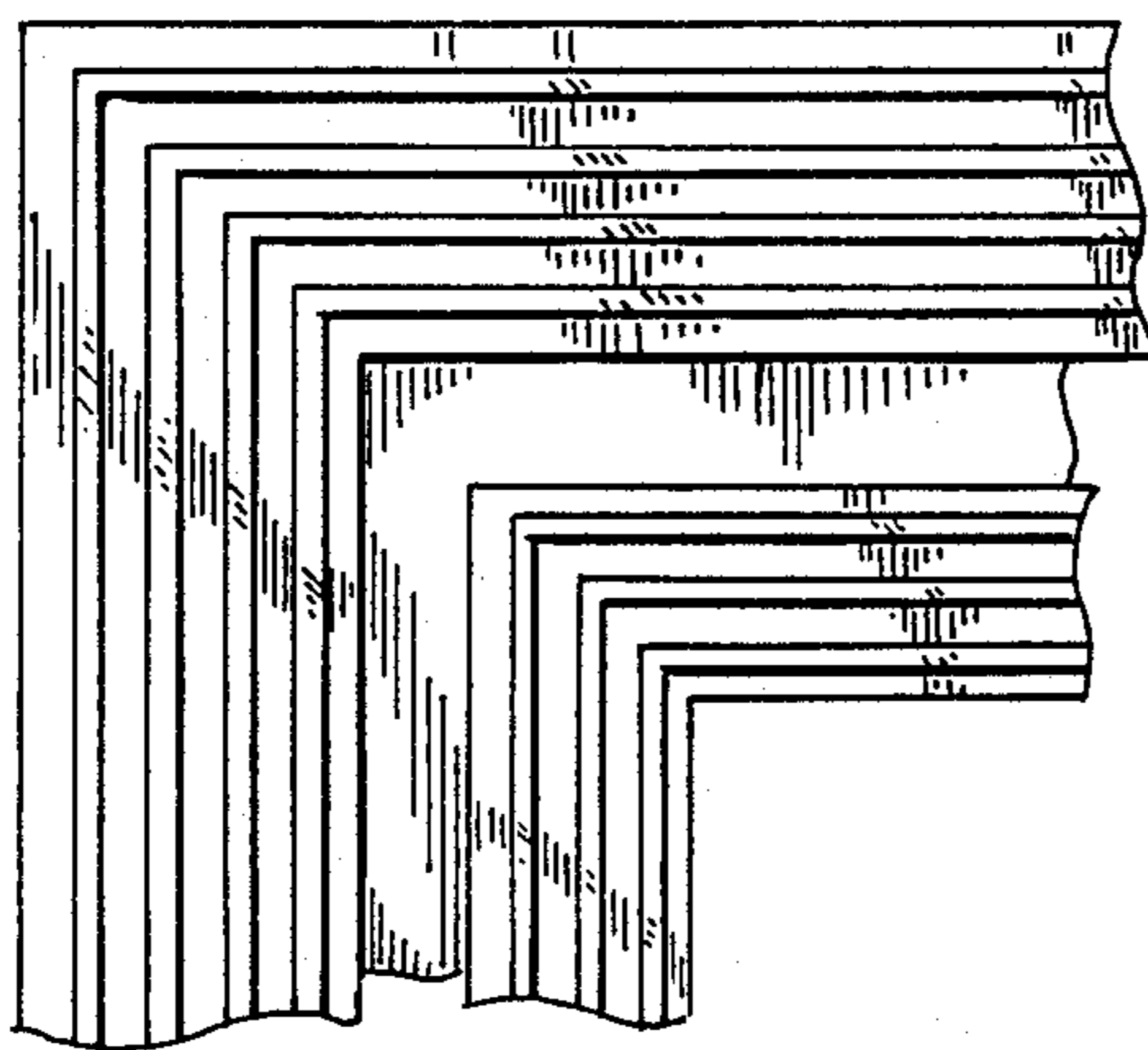

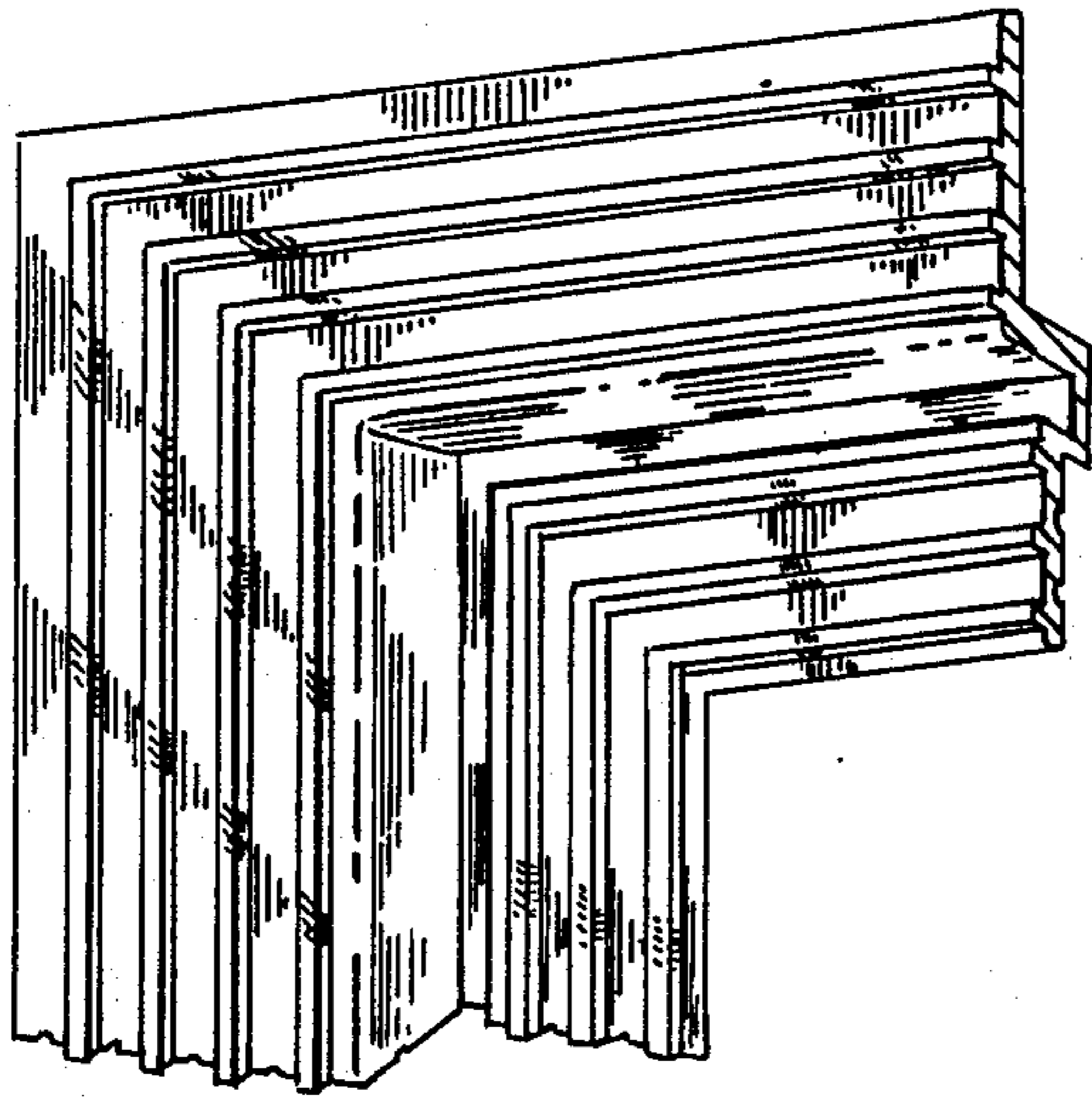

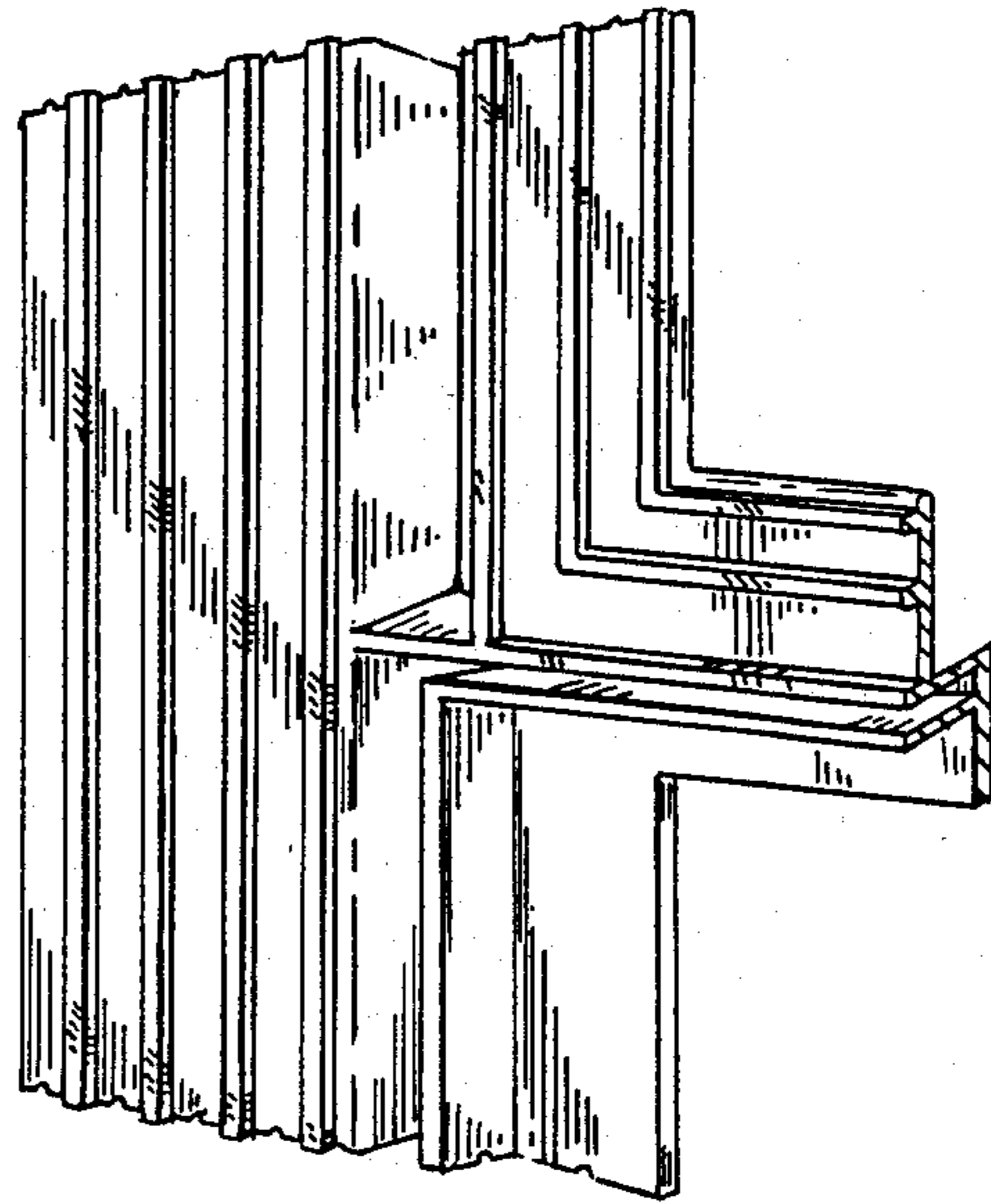

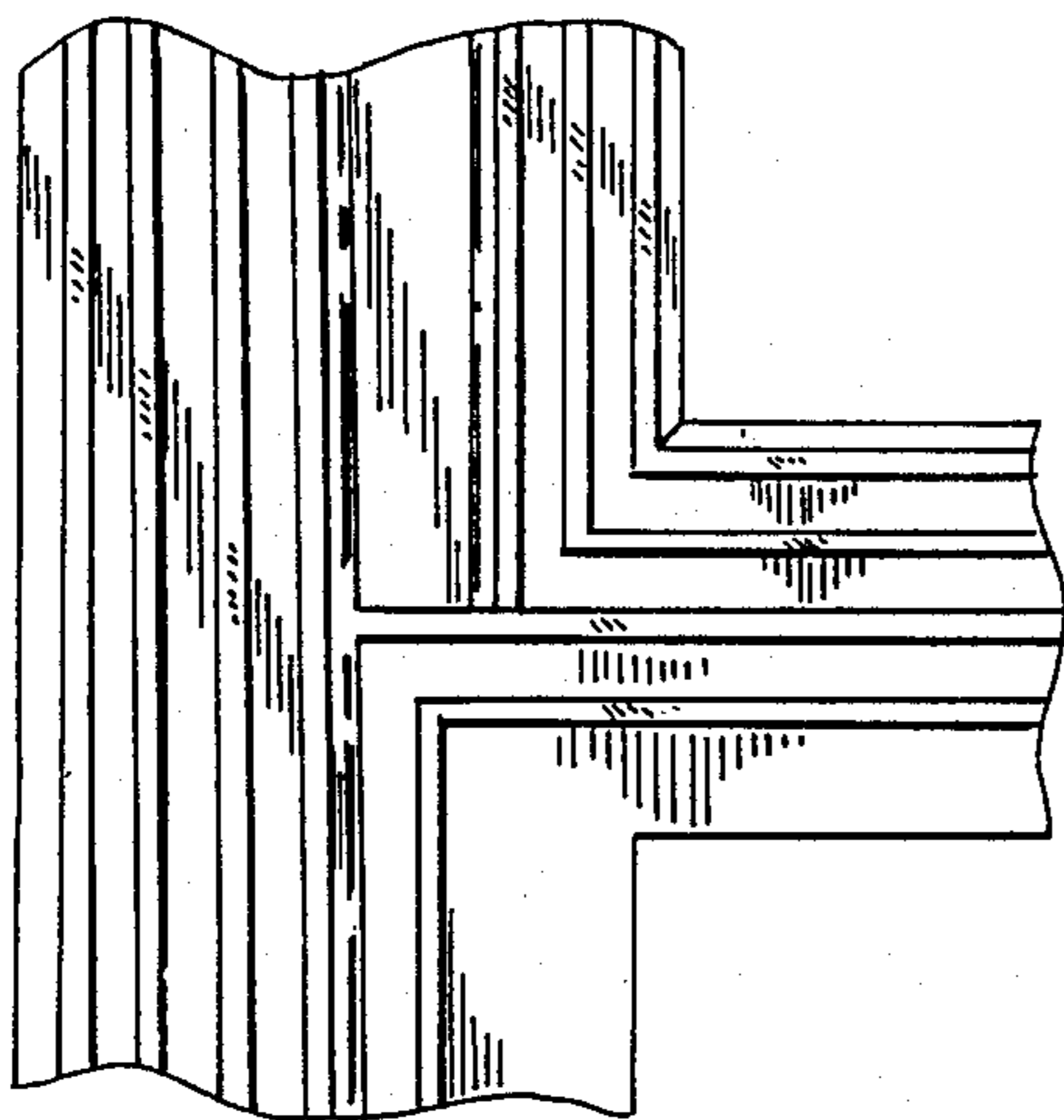
