DESCRIPTION

FIG. 1 is a front, left side and top of a combination wireless handset telephone and speaker stand therefor showing our new design in cradled relationship; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view thereof; FIGS. 4 and 5 are respectively front and rear elevational views thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a left side elevational view thereof; FIG. 8 is a front, left side and top perspective view of the stand shown separately for clarity of representation; FIG. 9 is a bottom plan view of the stand alone; FIG. 10 is a right side elevational view of the stand alone; FIGS. 11 and 12 are respectively front and rear elevational views of the stand alone; FIG. 13 is a bottom plan view of the stand alone; FIG. 14 is a left side elevational view of the stand alone; FIG. 15 is a front, bottom and left side perspective view of the handset telephone alone; FIG. 16 is a bottom plan view of the handset telephone; FIG. 17 is a right side elevational view thereof; FIG. 18 is a bottom plan view of the handset telephone; FIGS. 19 and 20 are respectively front and rear elevational views of the handset telephone alone; and FIG. 21 is a left side elevational view of the handset telephone alone.

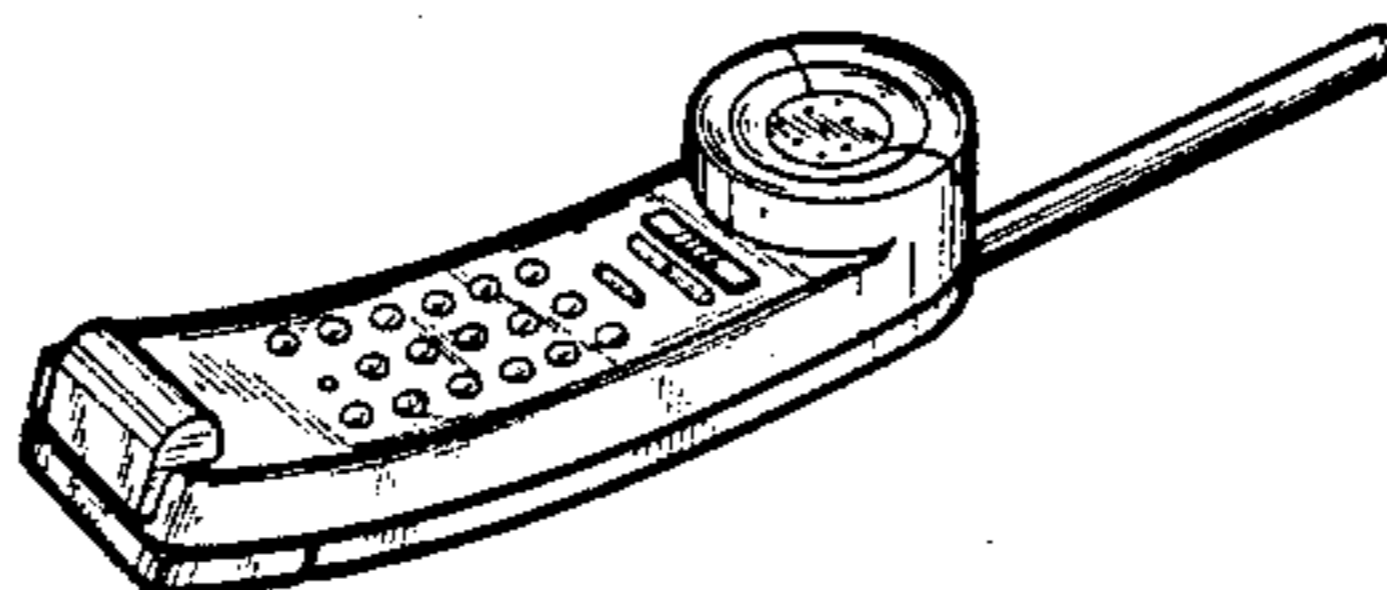
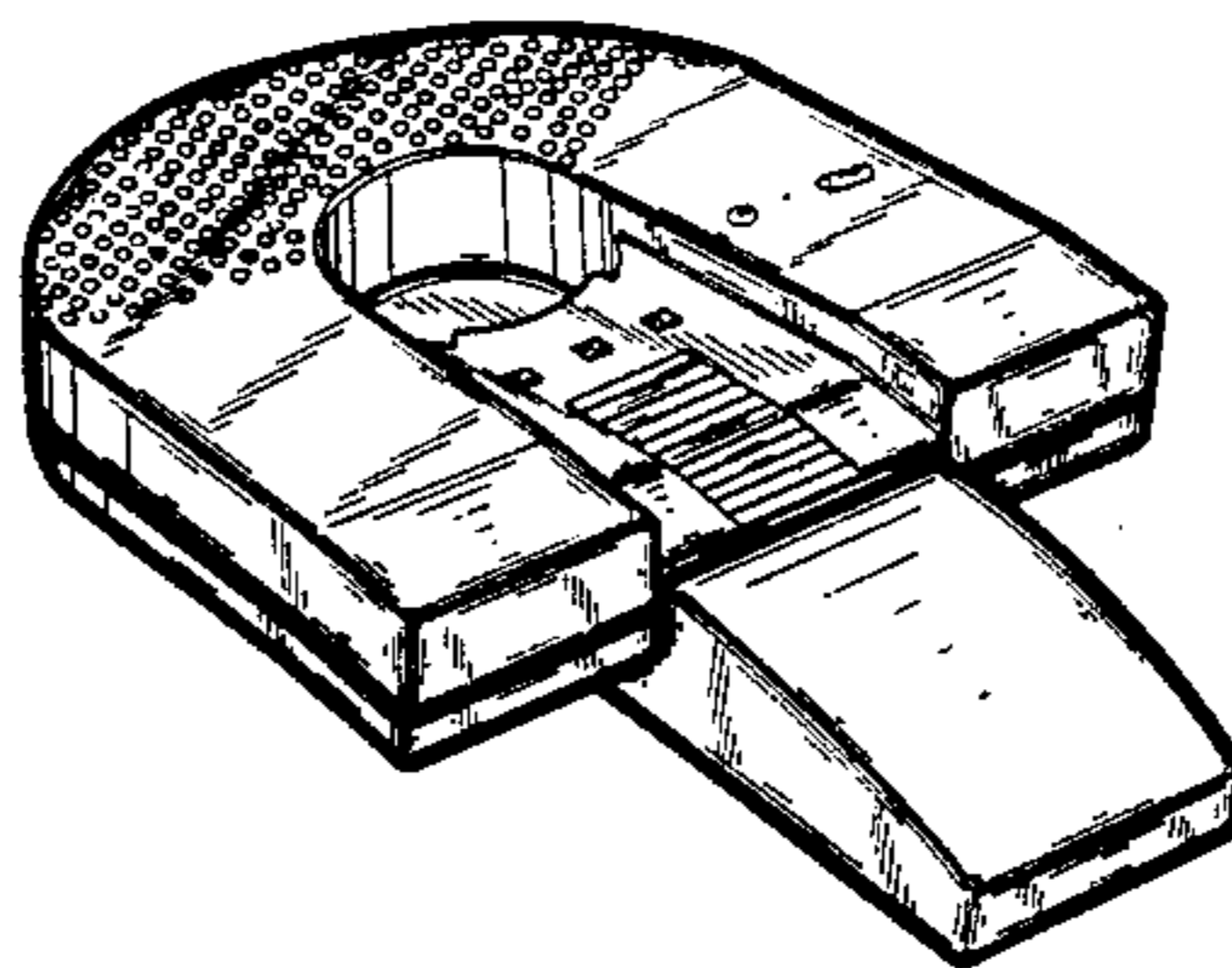

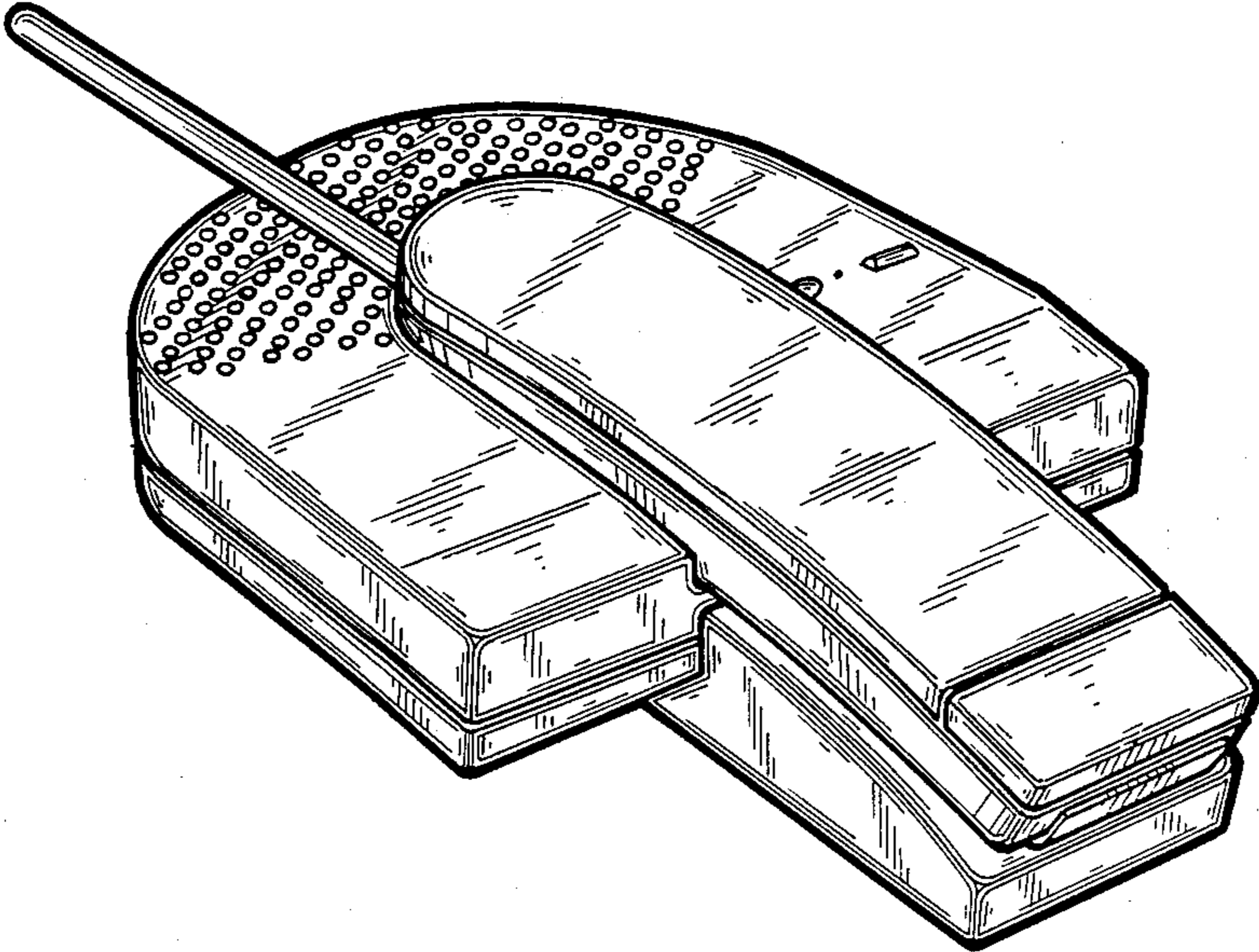

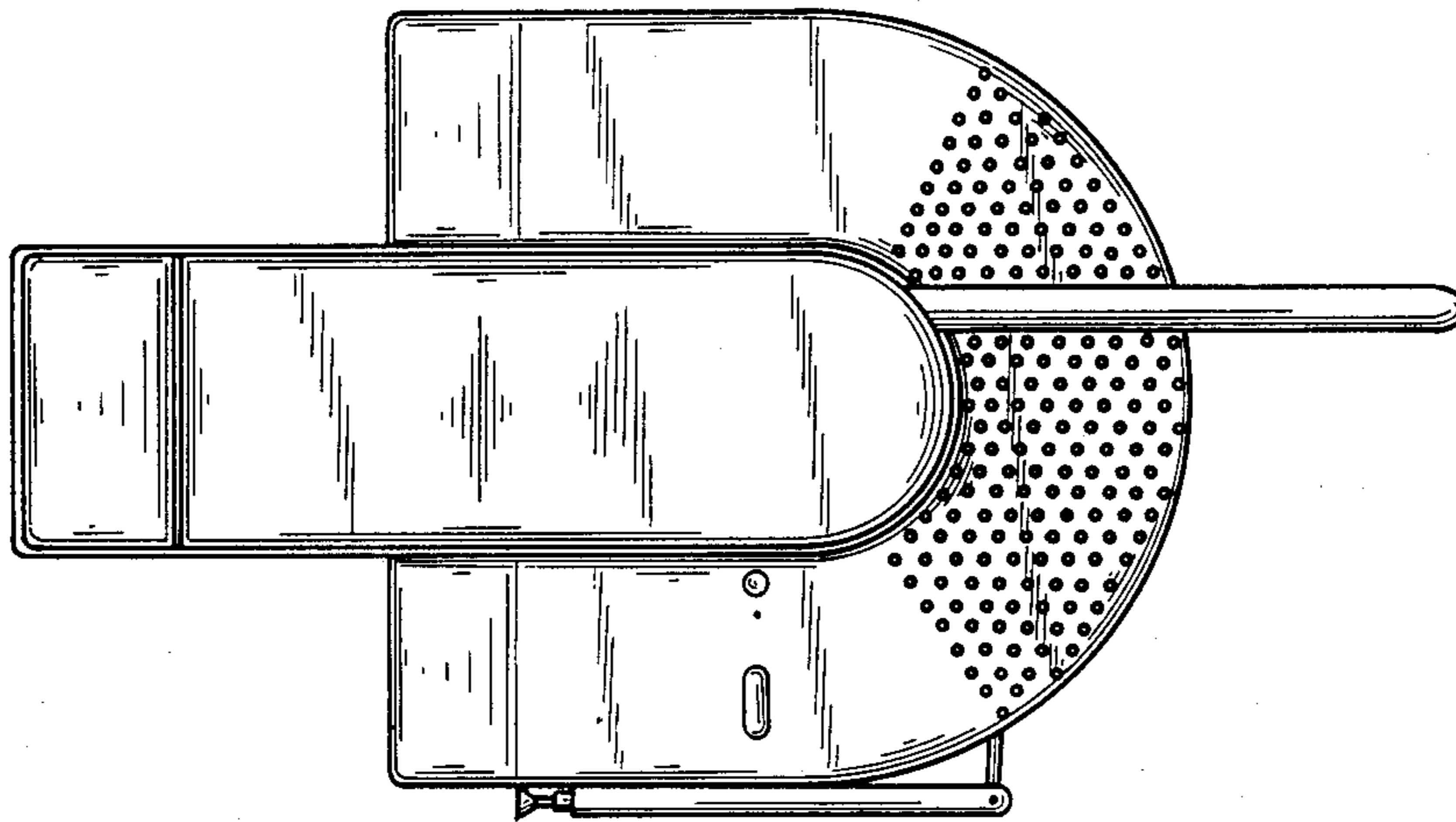

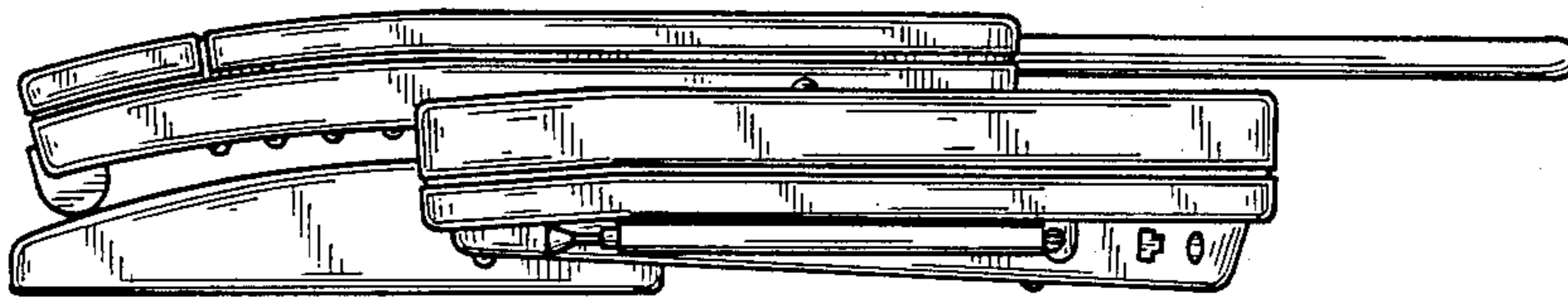

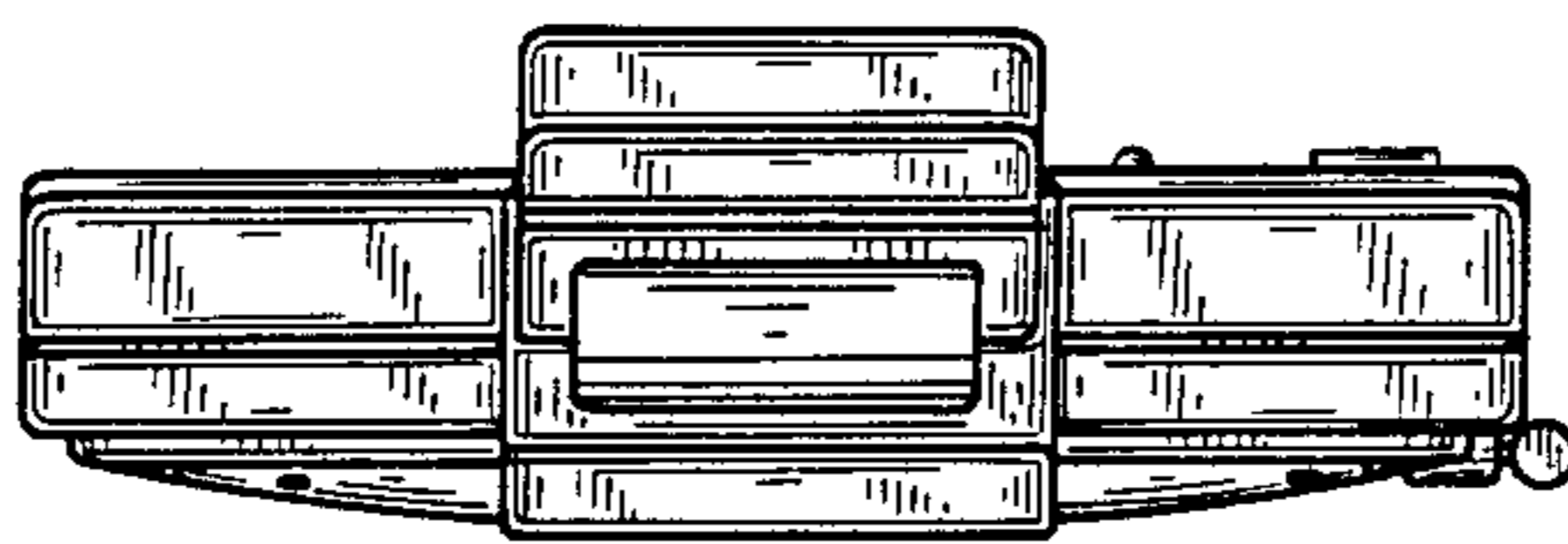

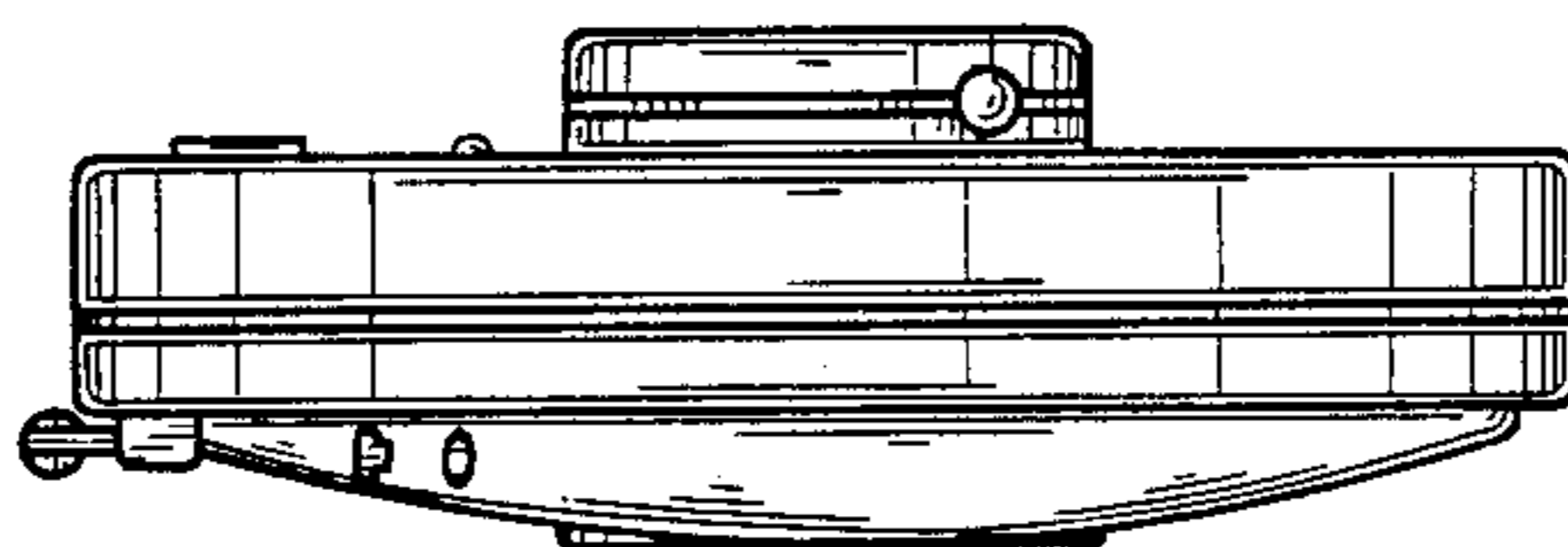

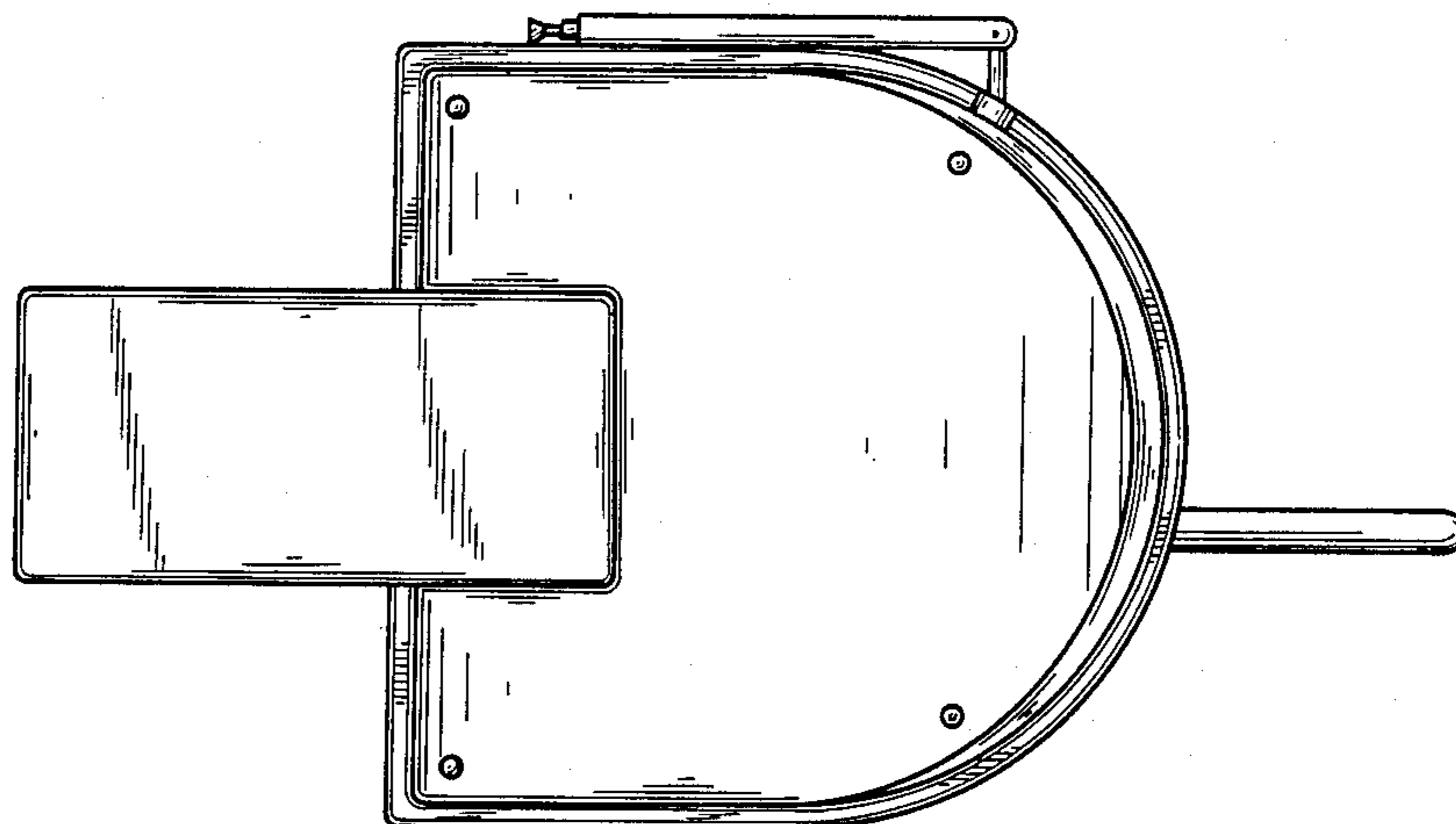

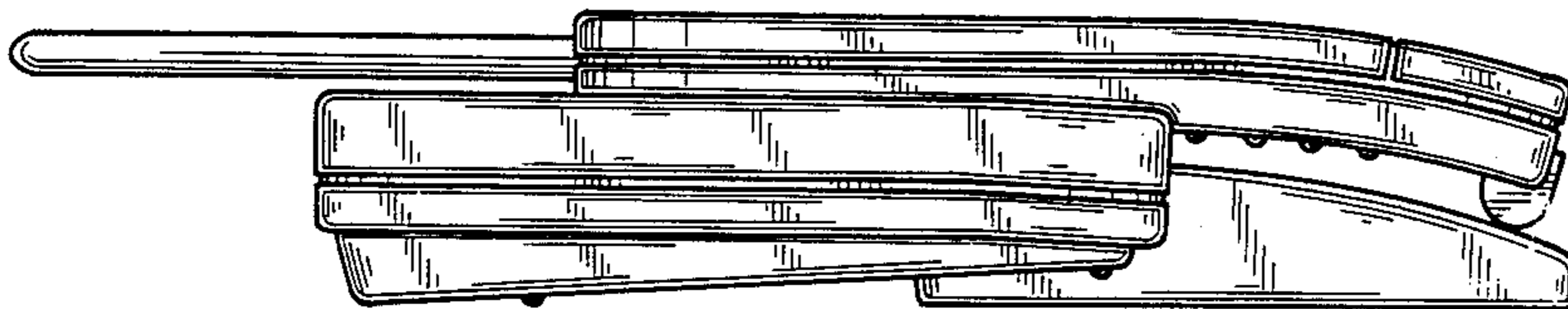

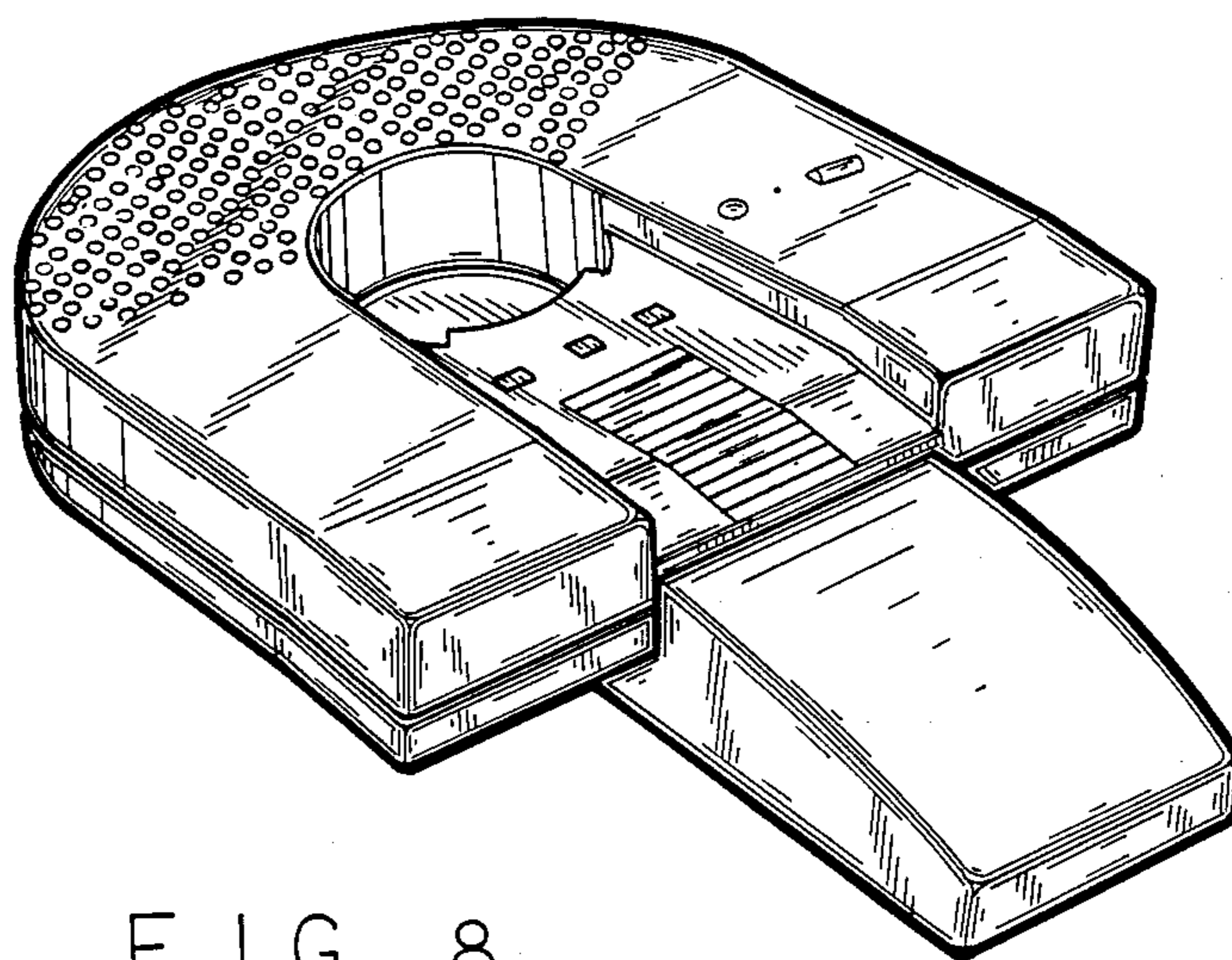

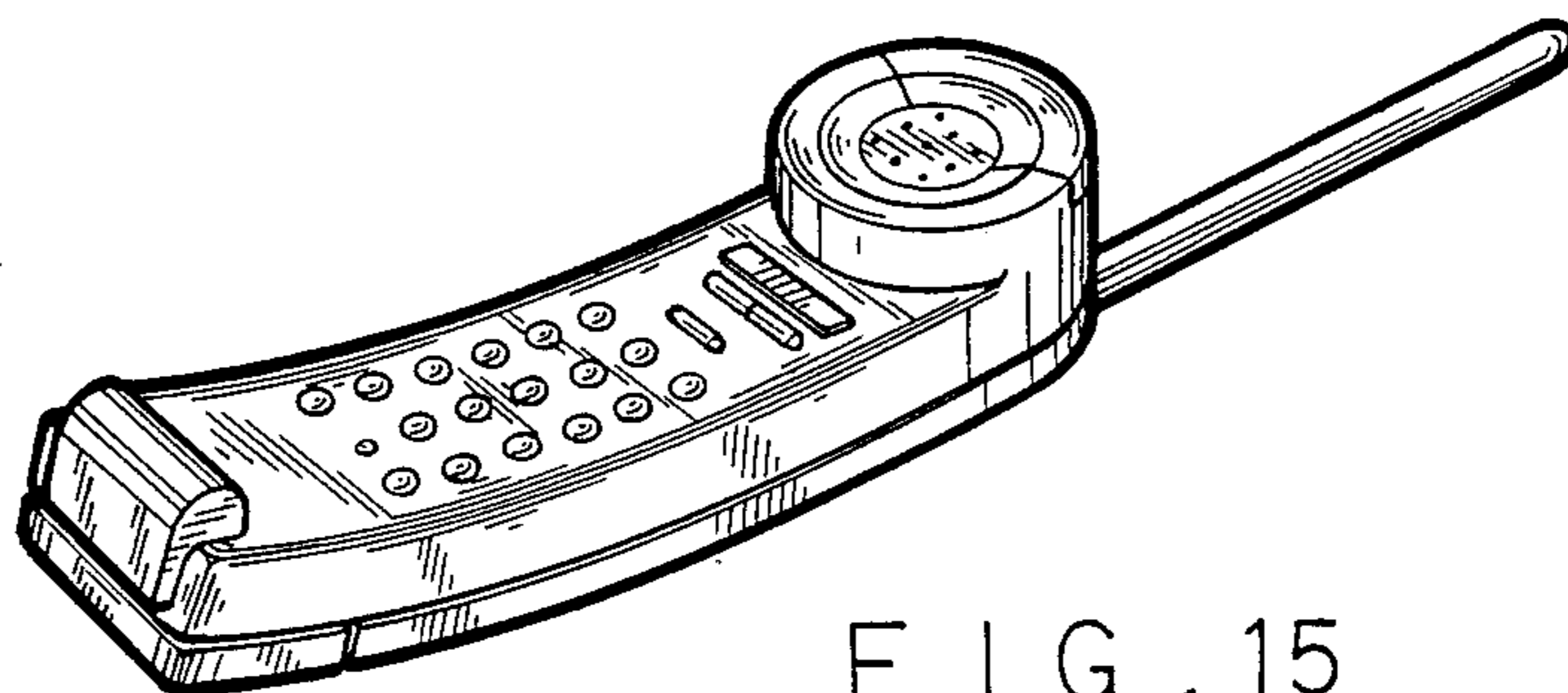

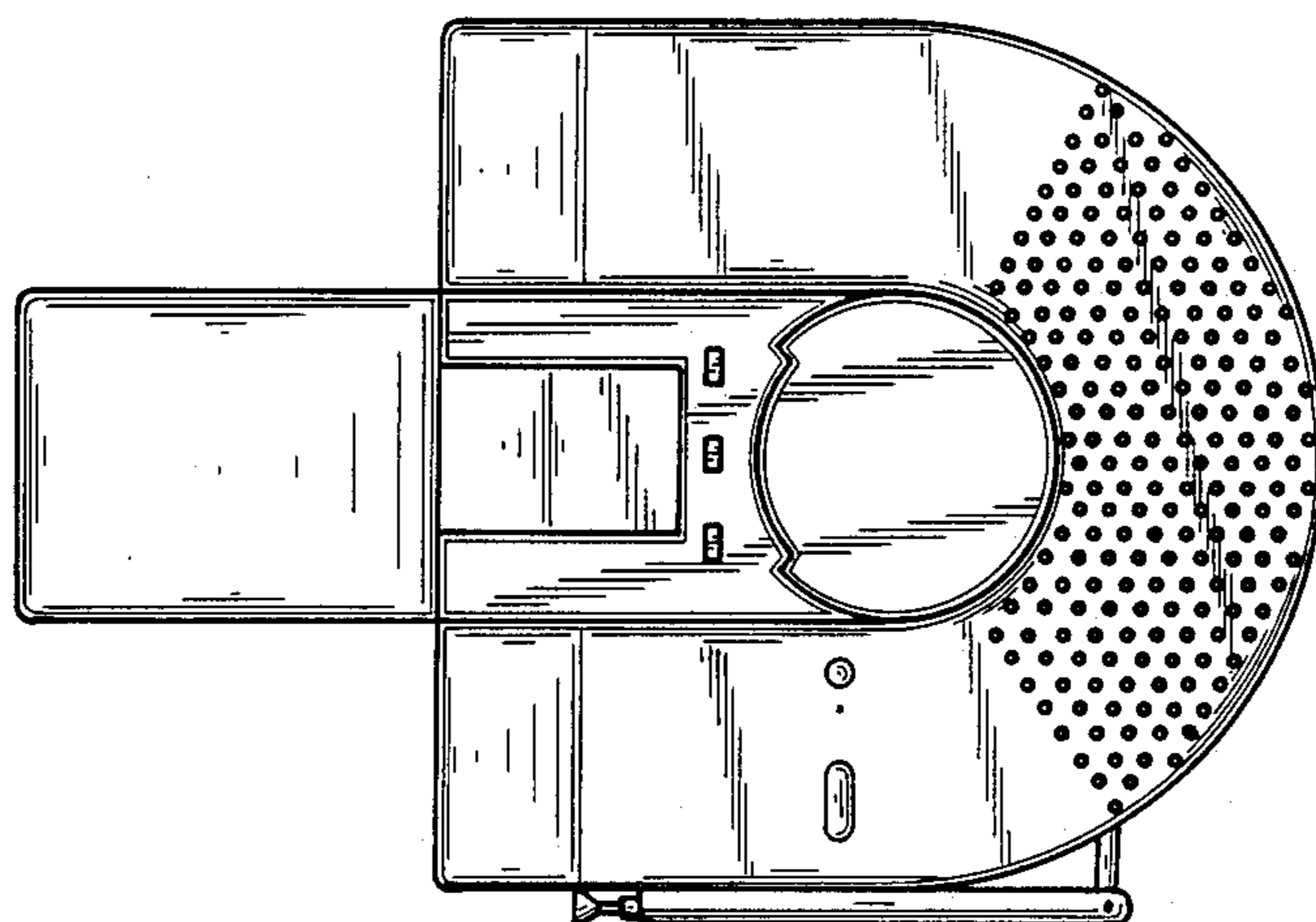

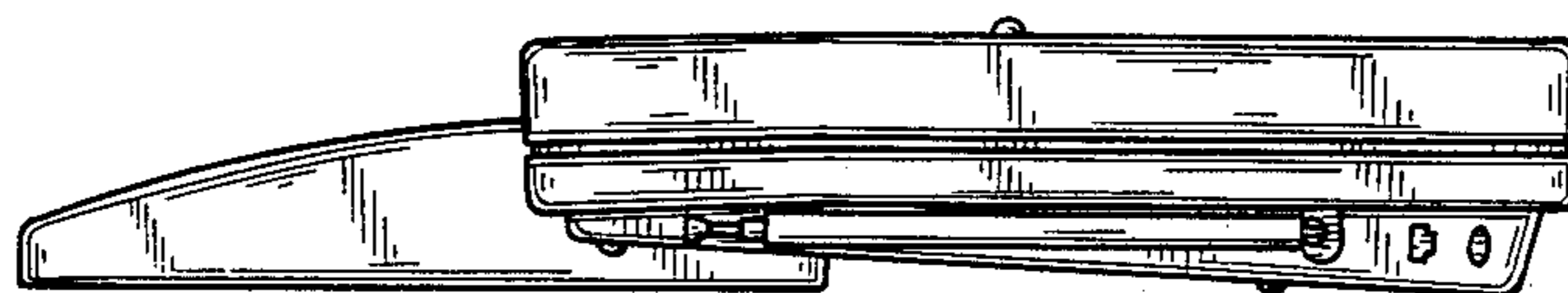

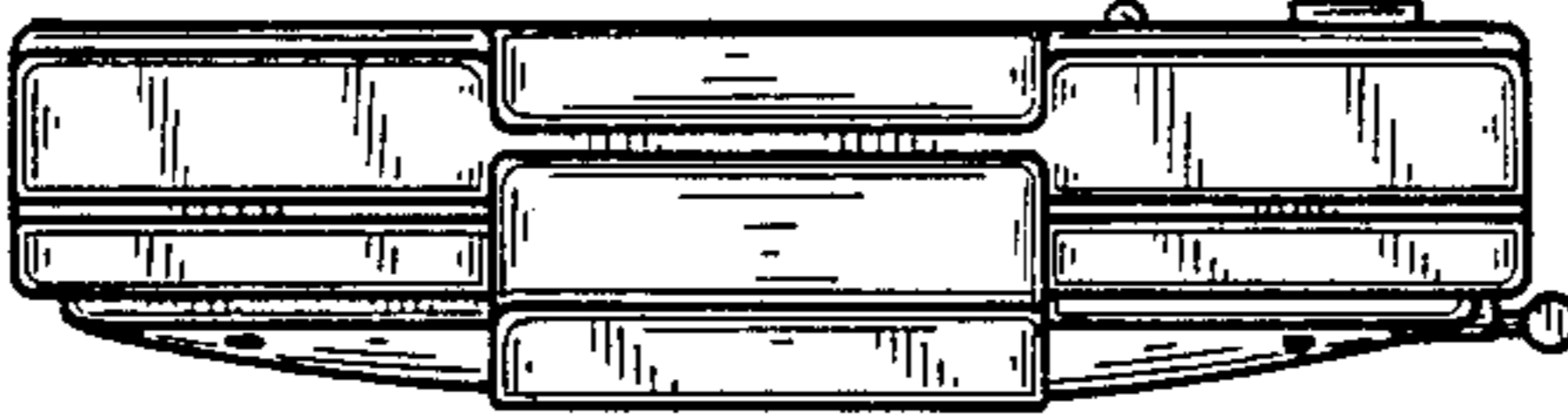

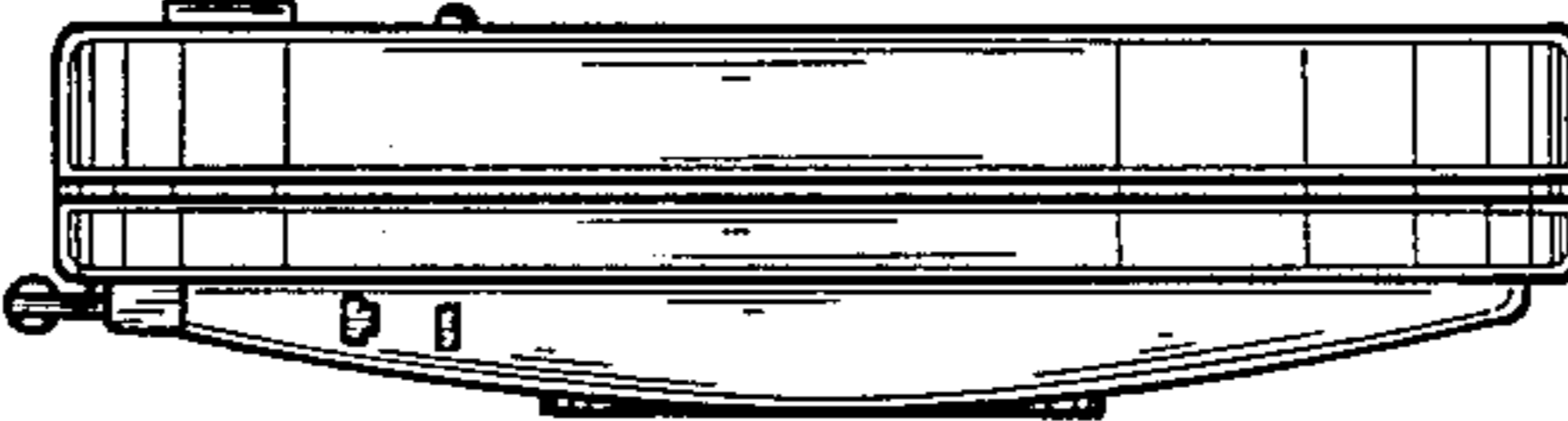

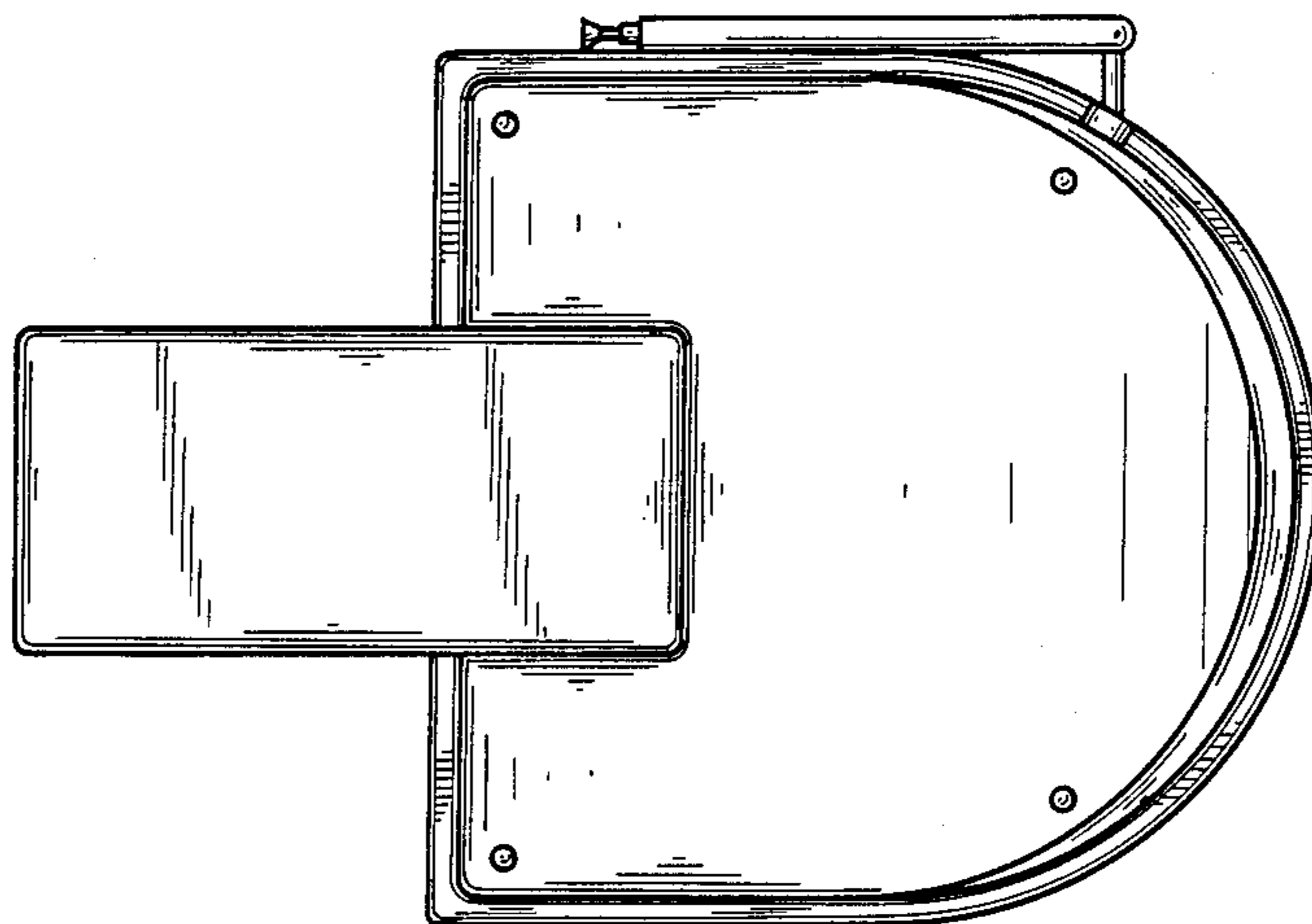

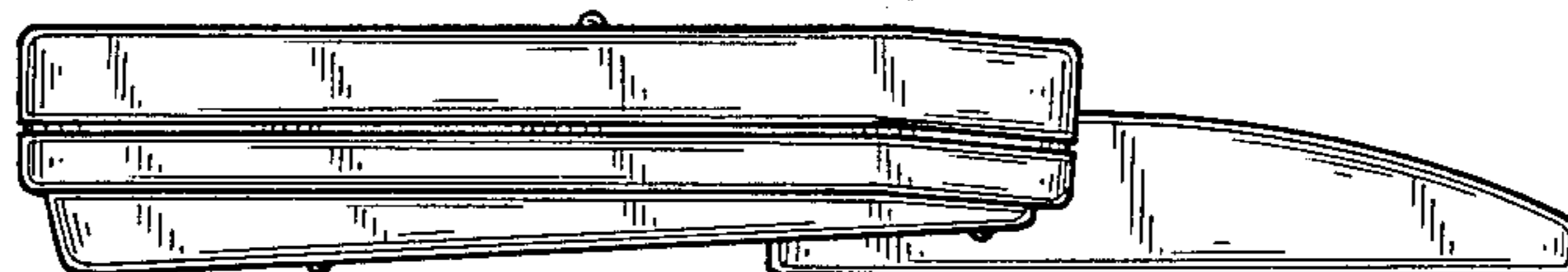

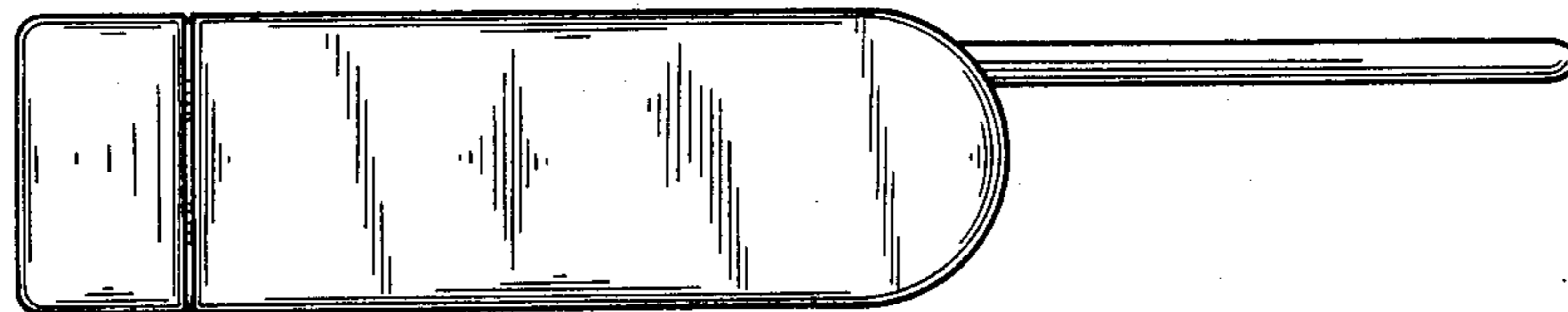

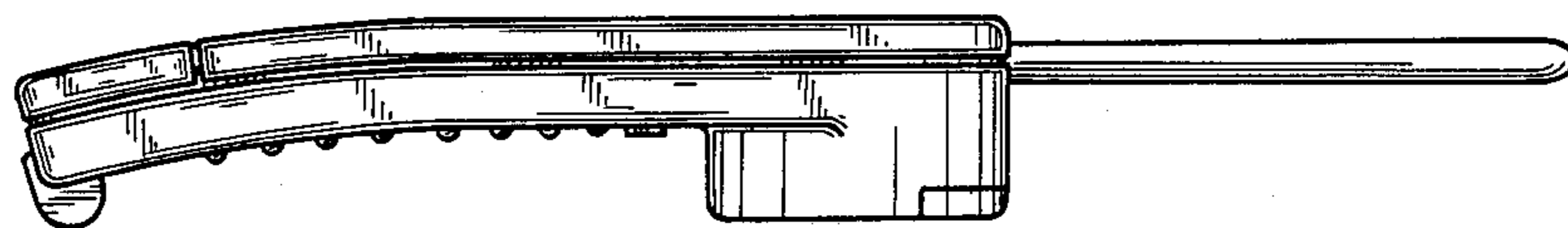

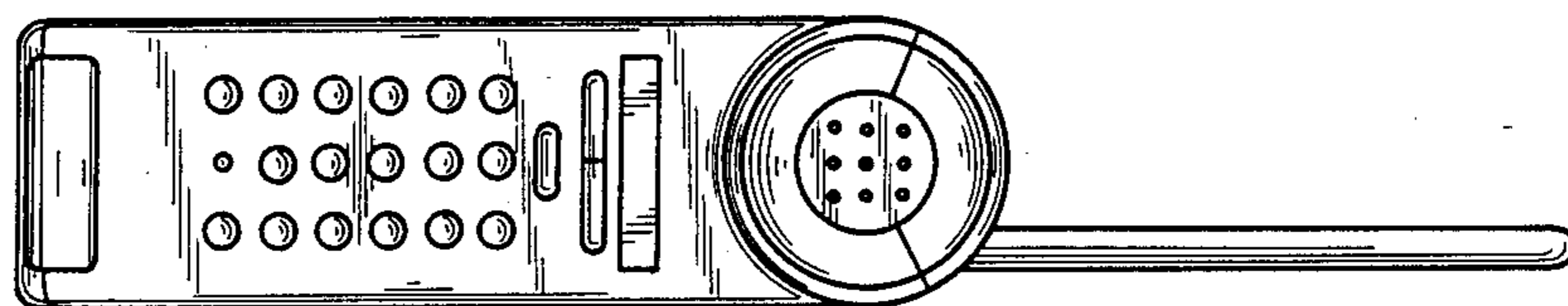

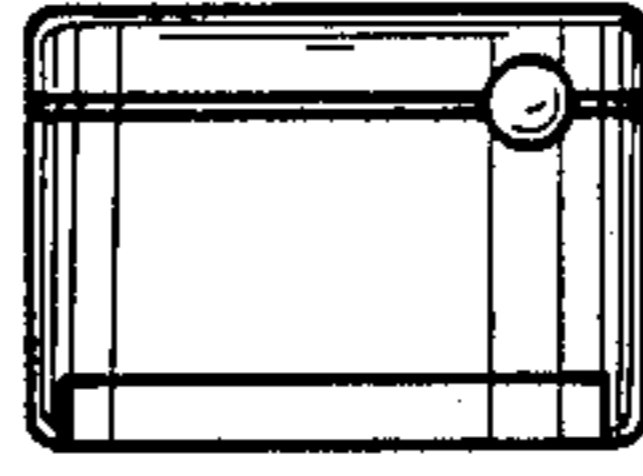

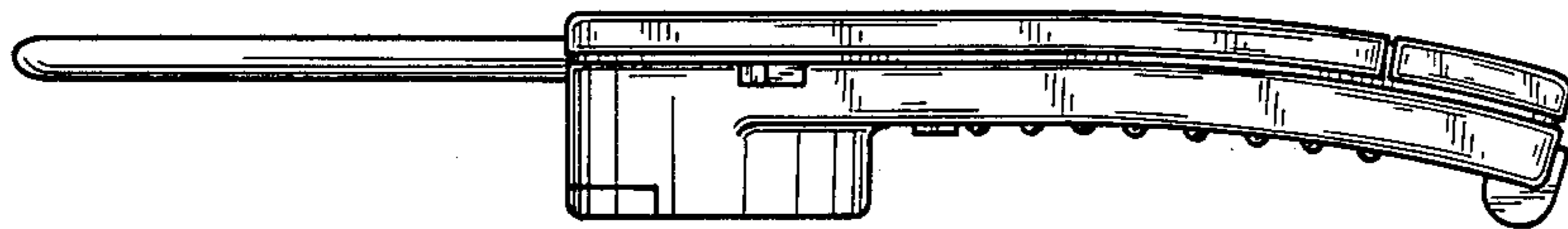
