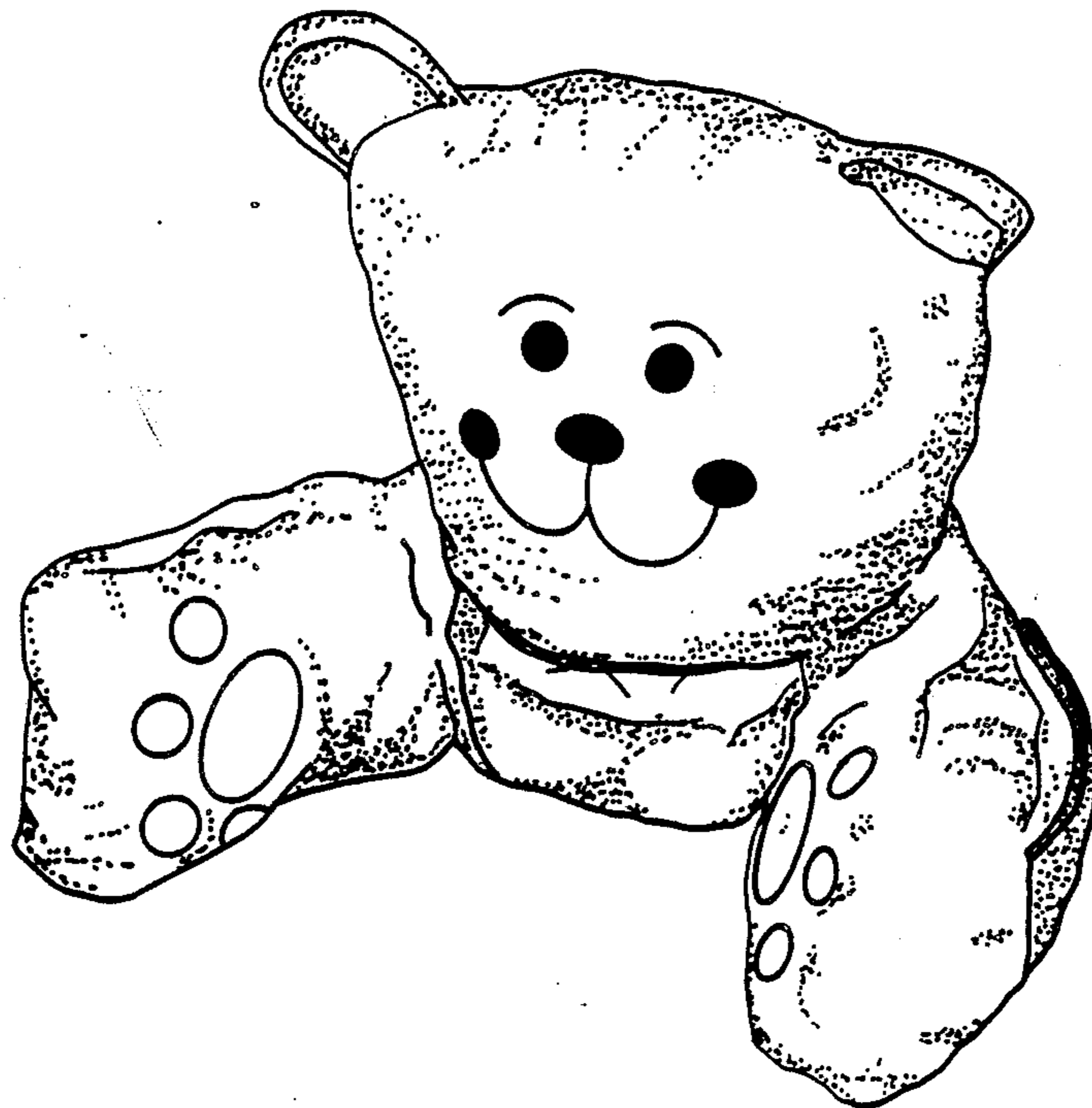

[57] **CLAIM**

The ornamental design for child's pocketed bed rest cushion, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the child's pocketed bed rest cushion showing my new design, on an enlarged scale;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a back elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof; and  
 FIG. 6 is a side elevational view thereof, the opposite side being a mirror image.



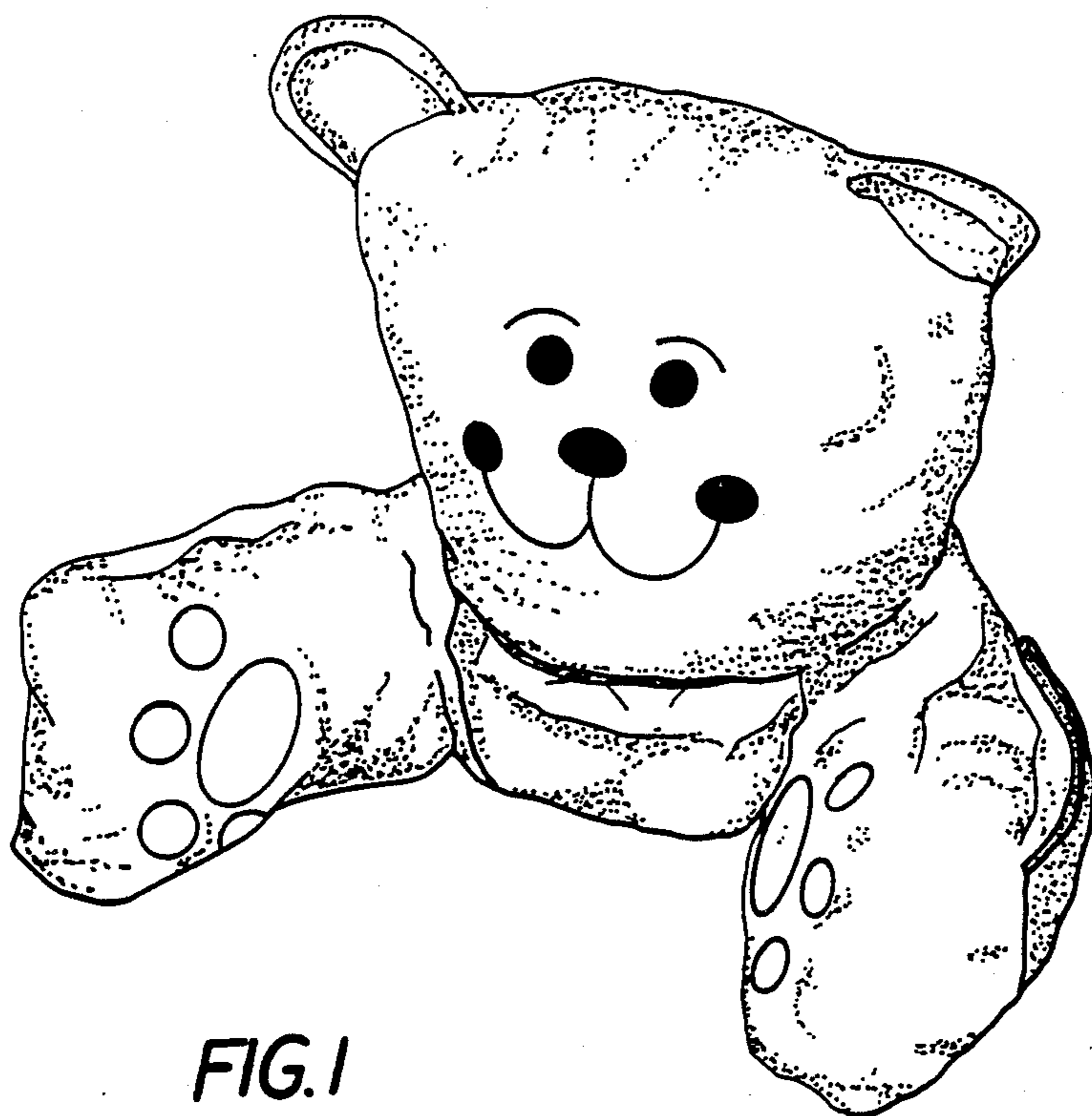

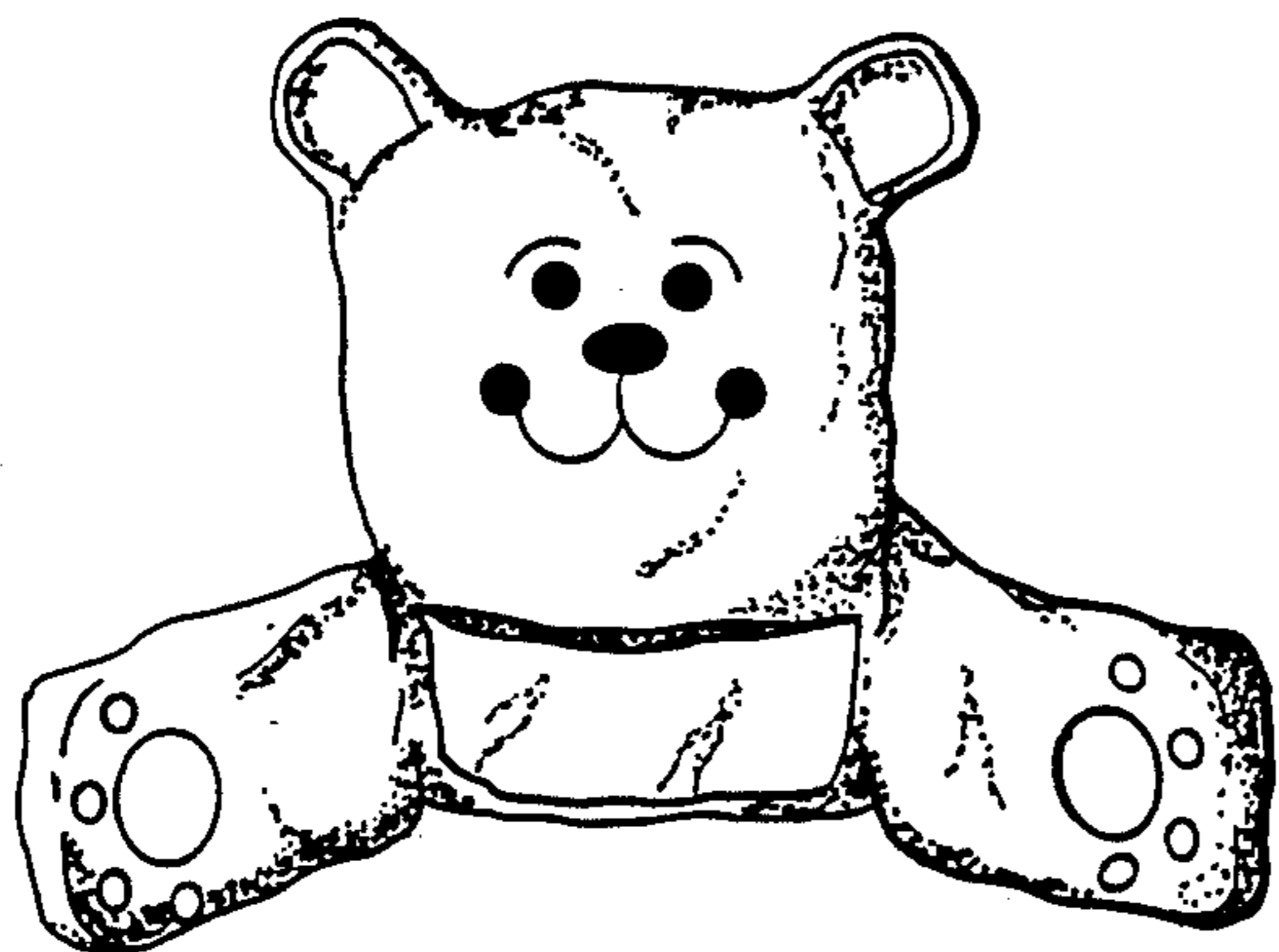

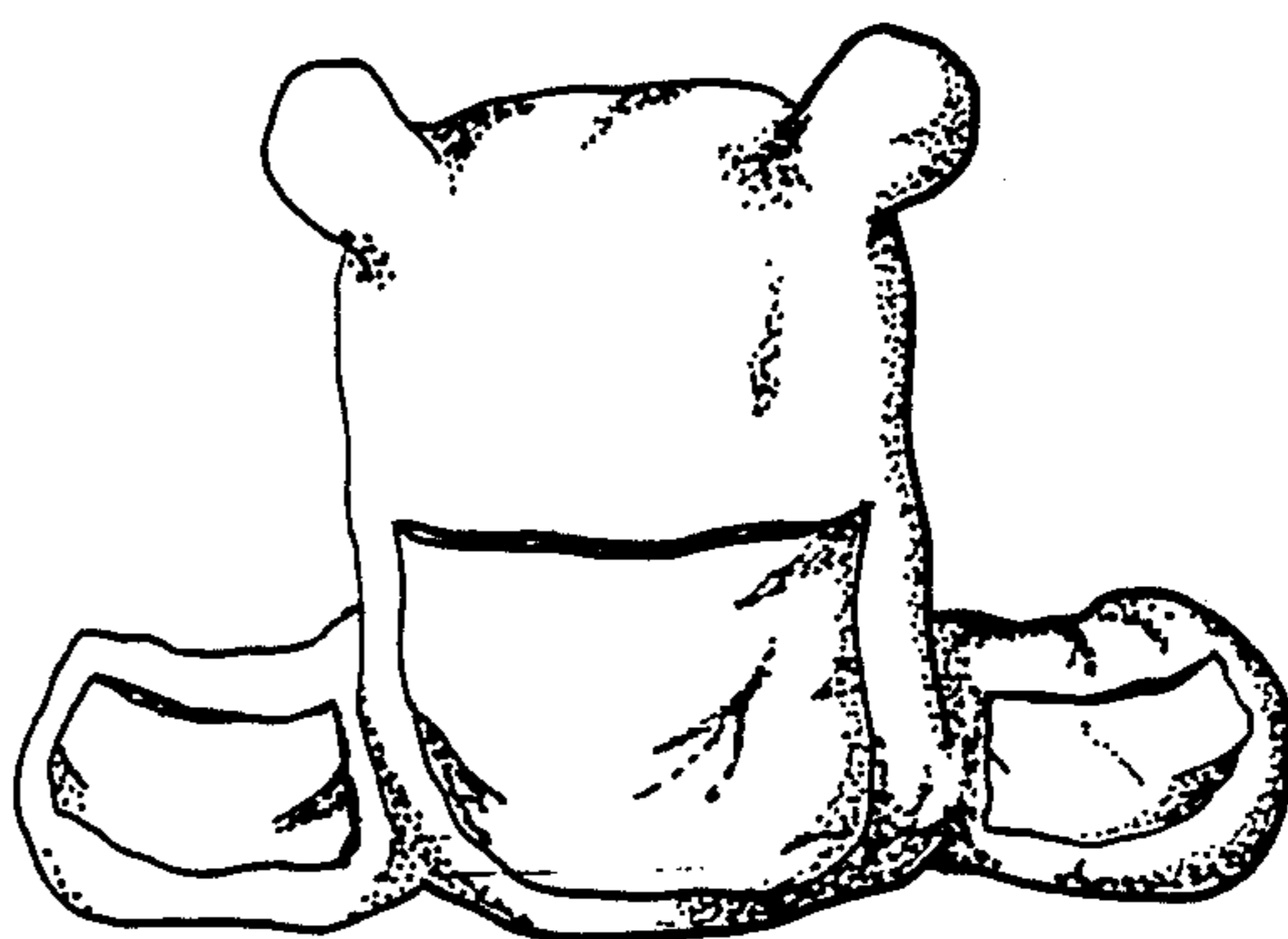

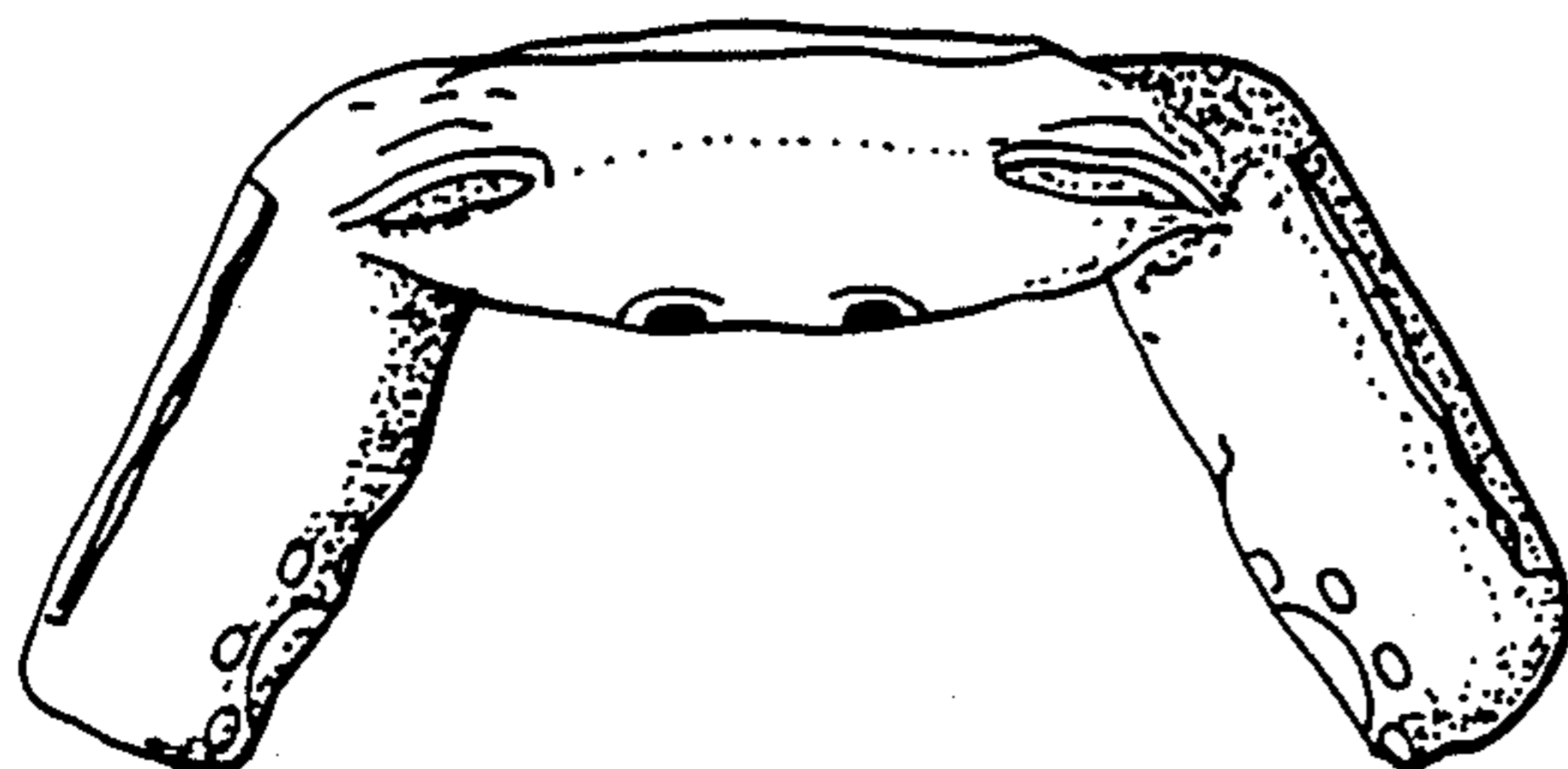

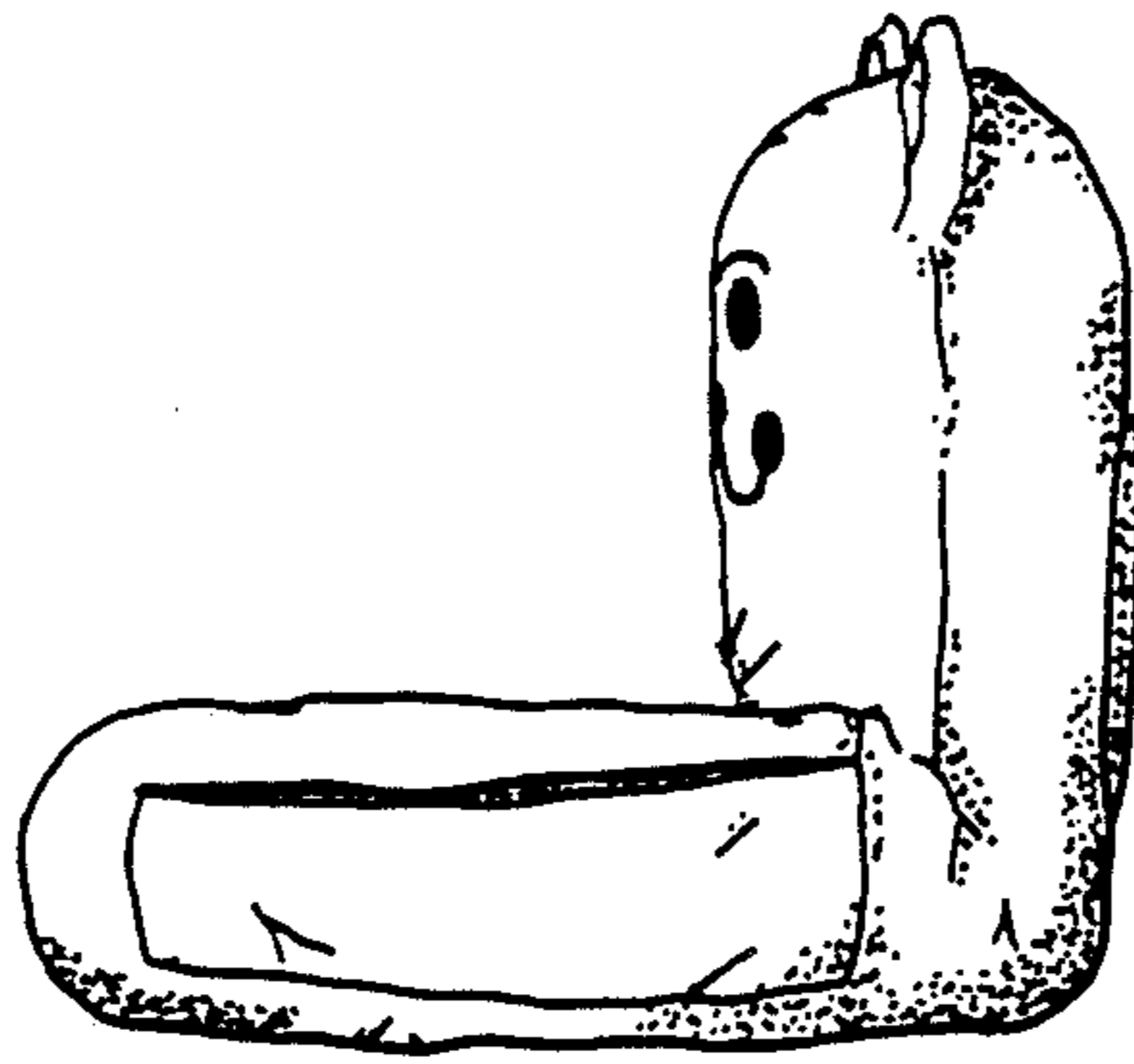
