The ornamental design for a stapling machine, as shown and described.

**DESCRIPTION**

FIG. 9 is a right side elevational view of that shown in FIG. 8;

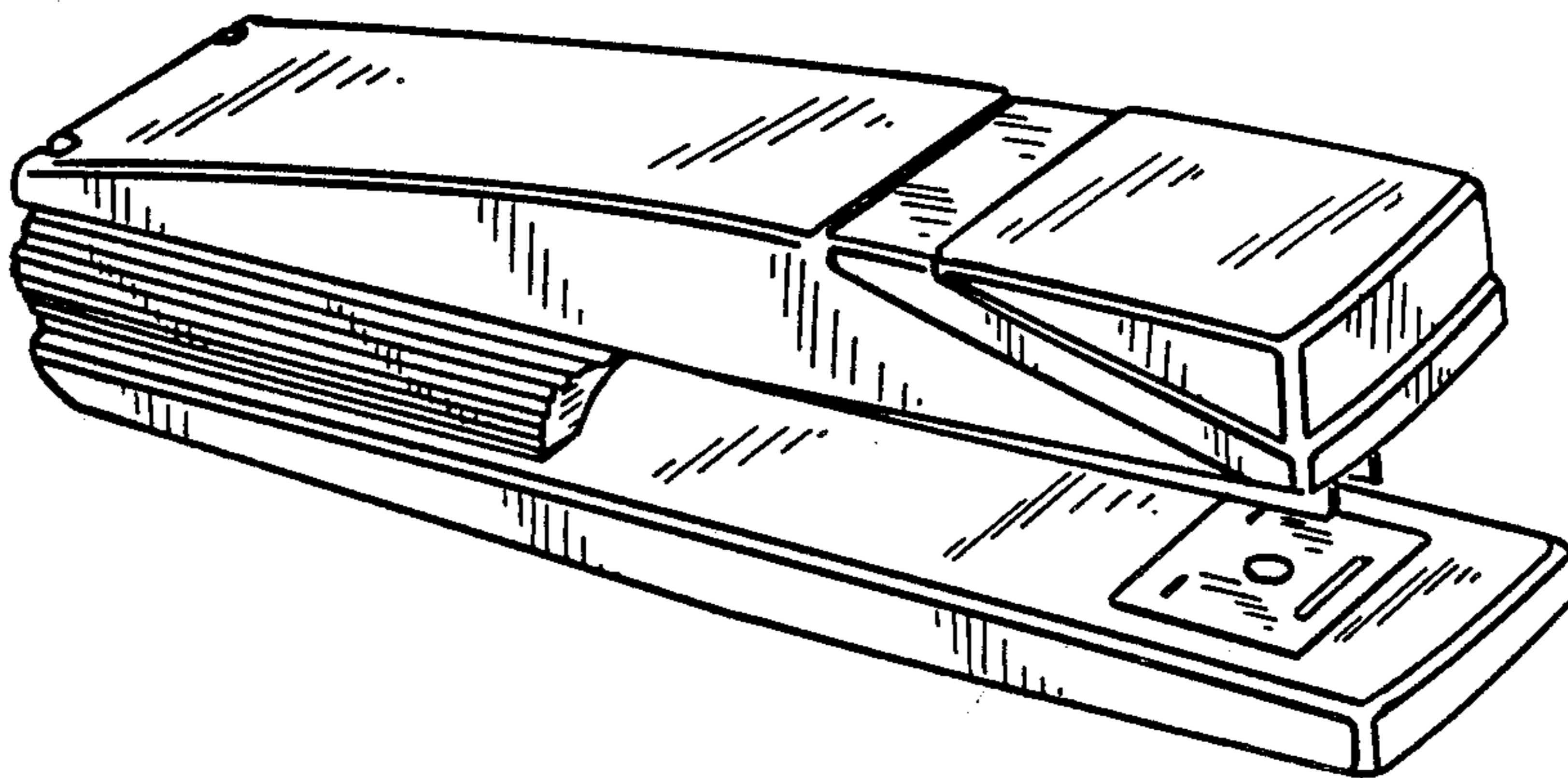
FIG. 10 is a left side elevational view of that shown in FIG. 8;

FIG. 14 is a bottom plan view of that shown in FIG. 8.



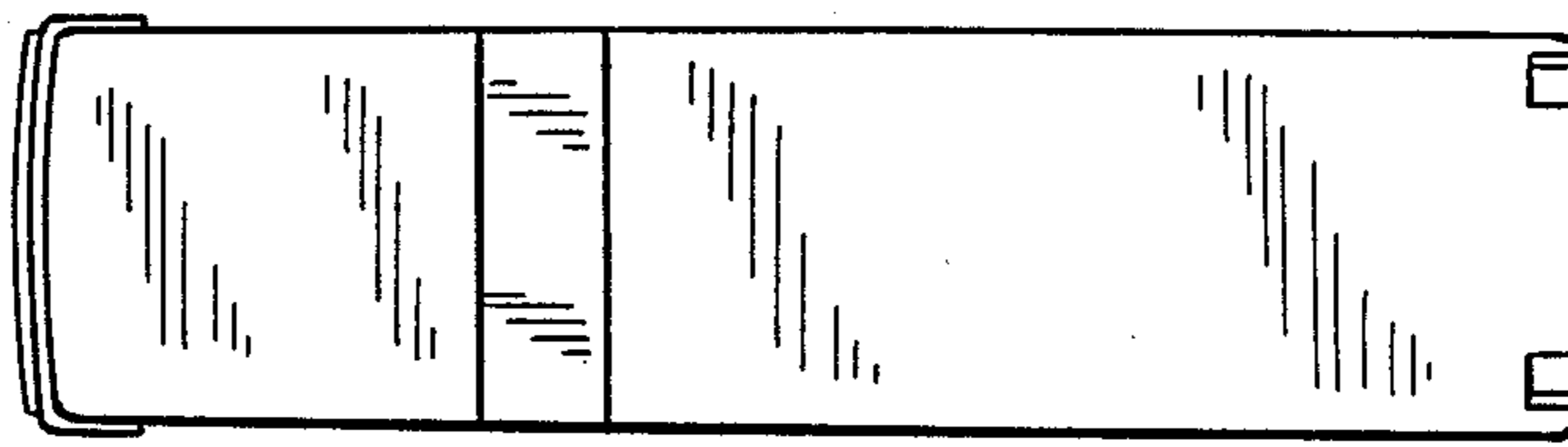

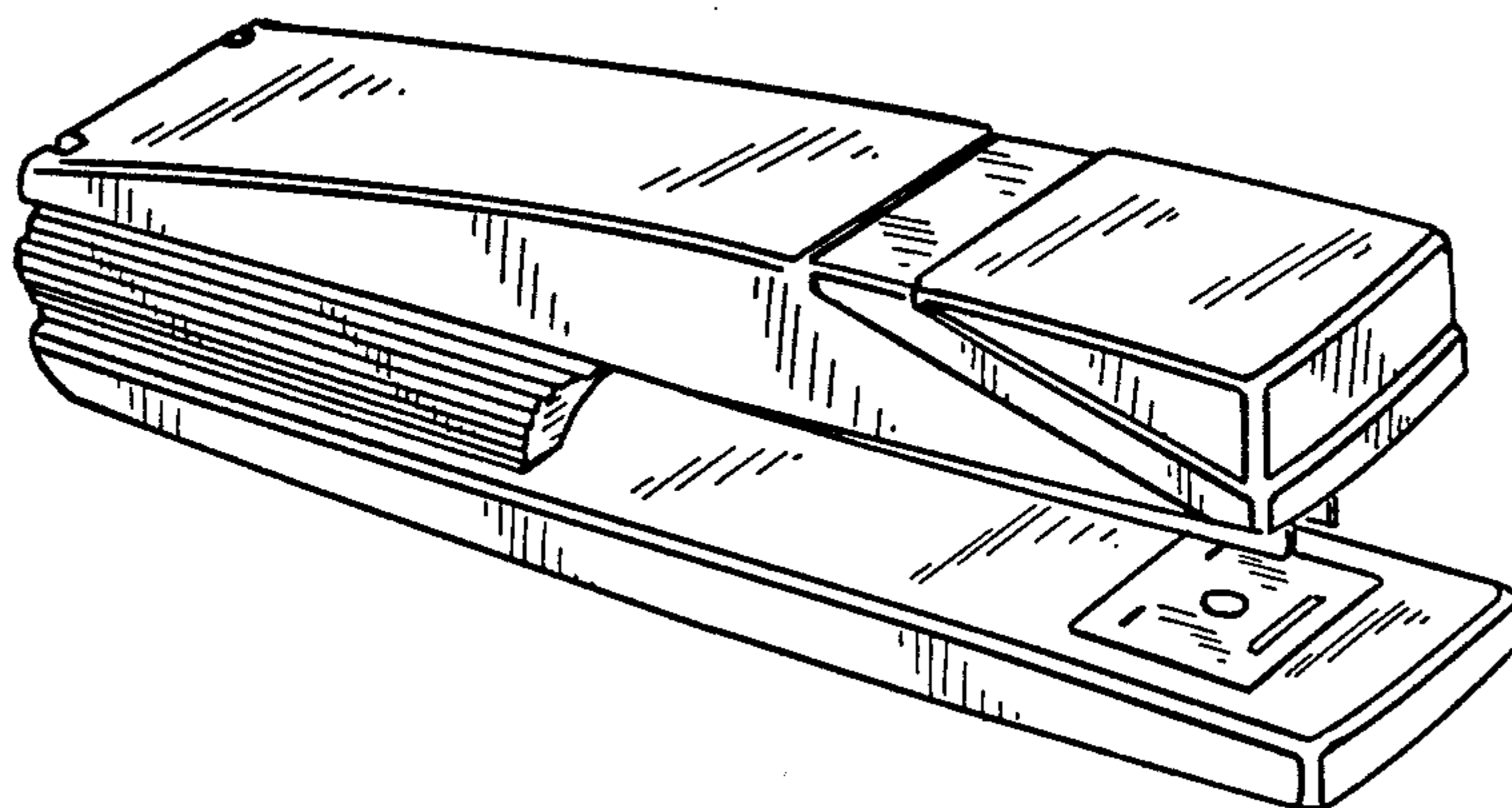

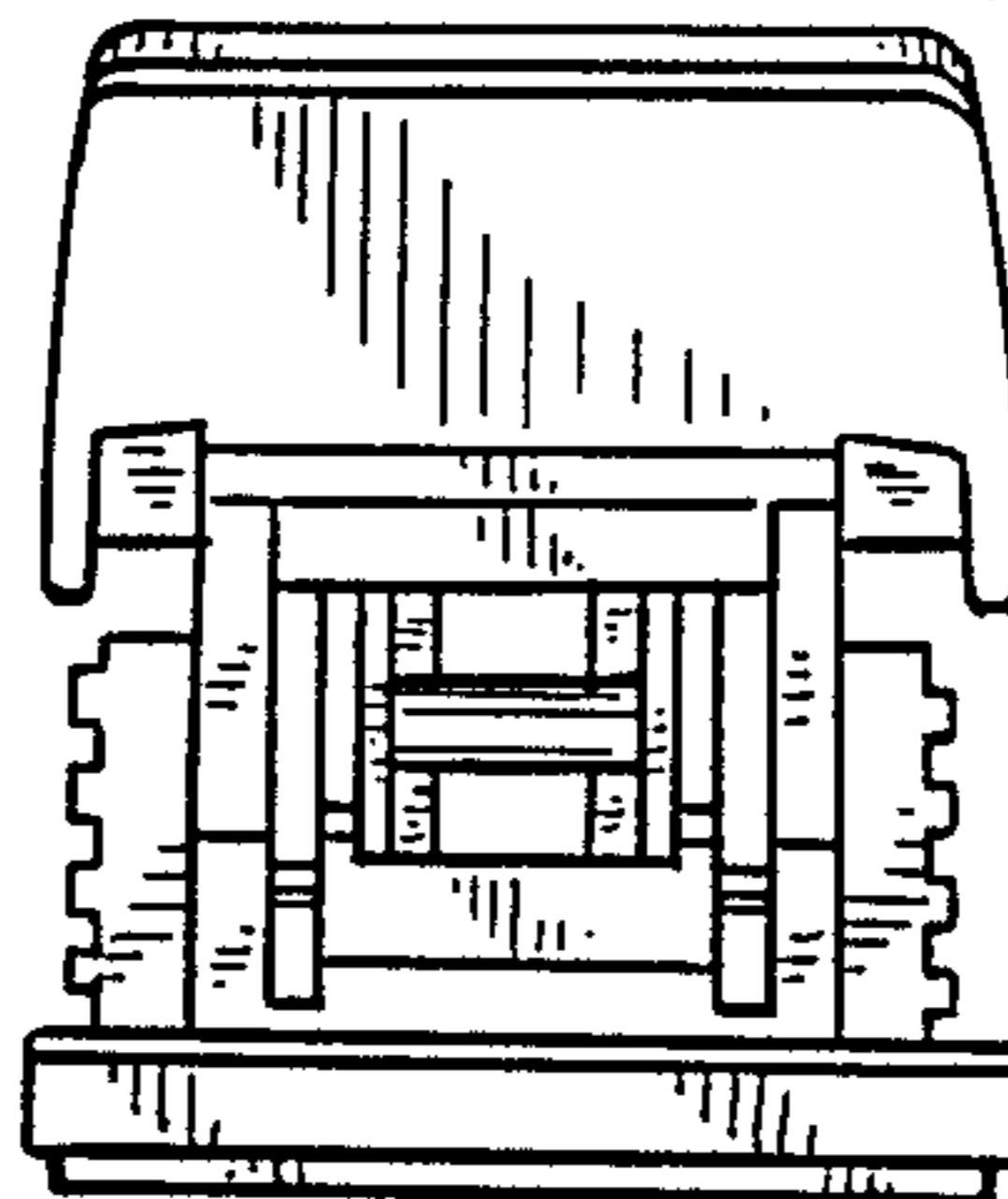

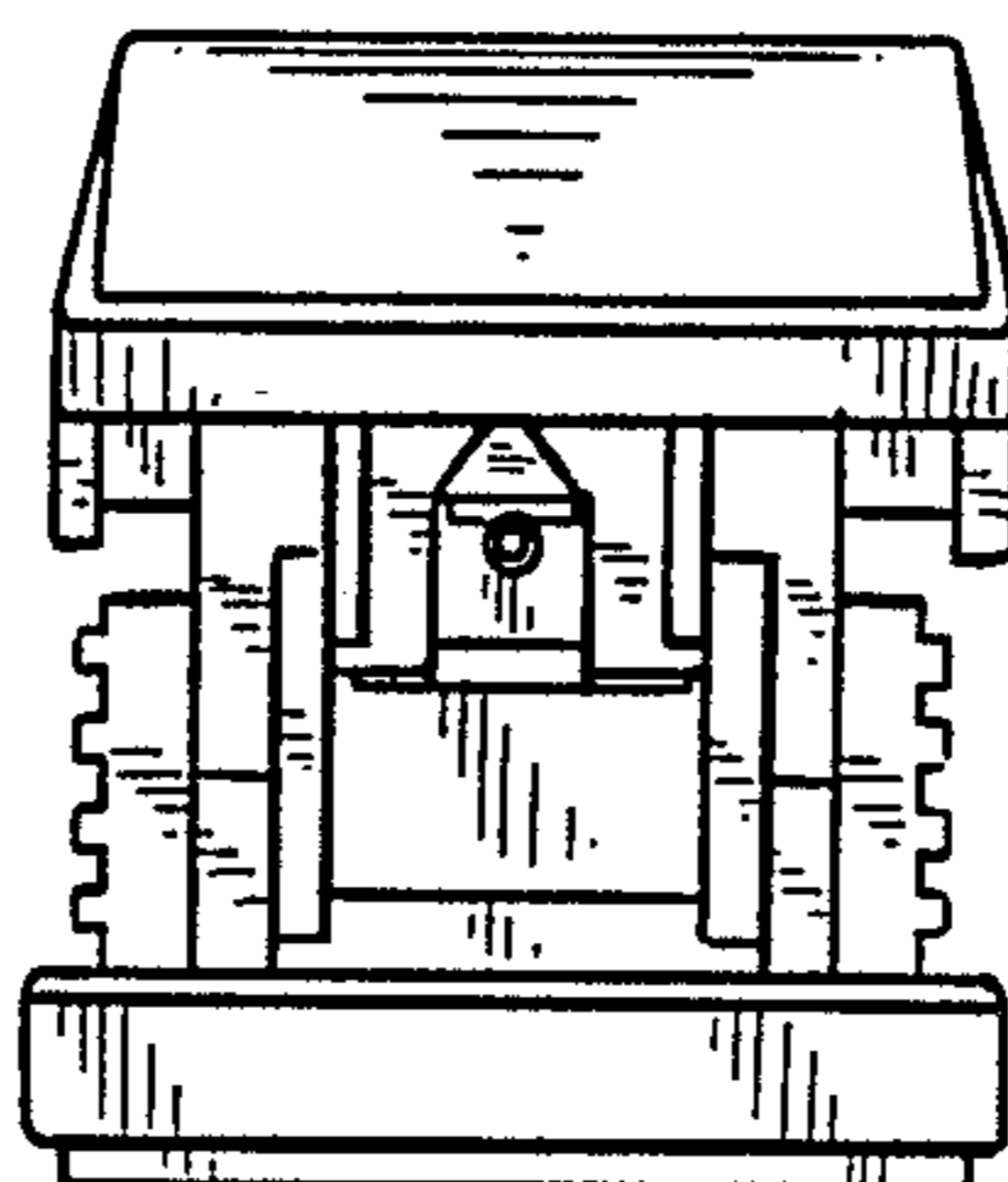

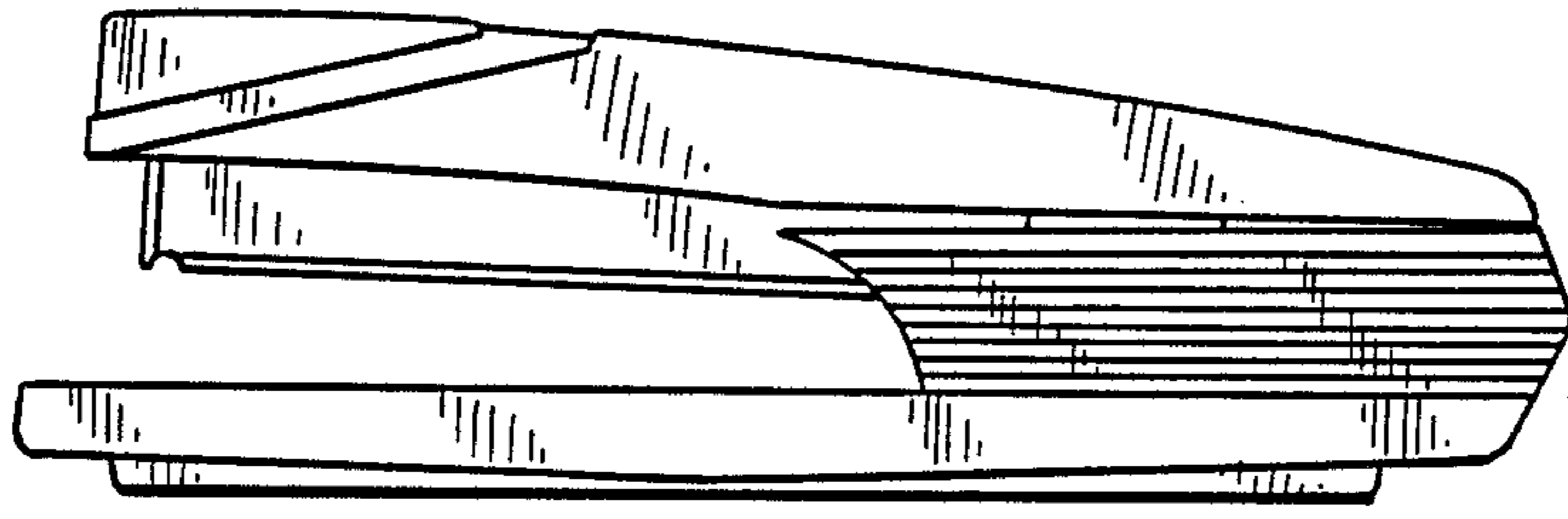

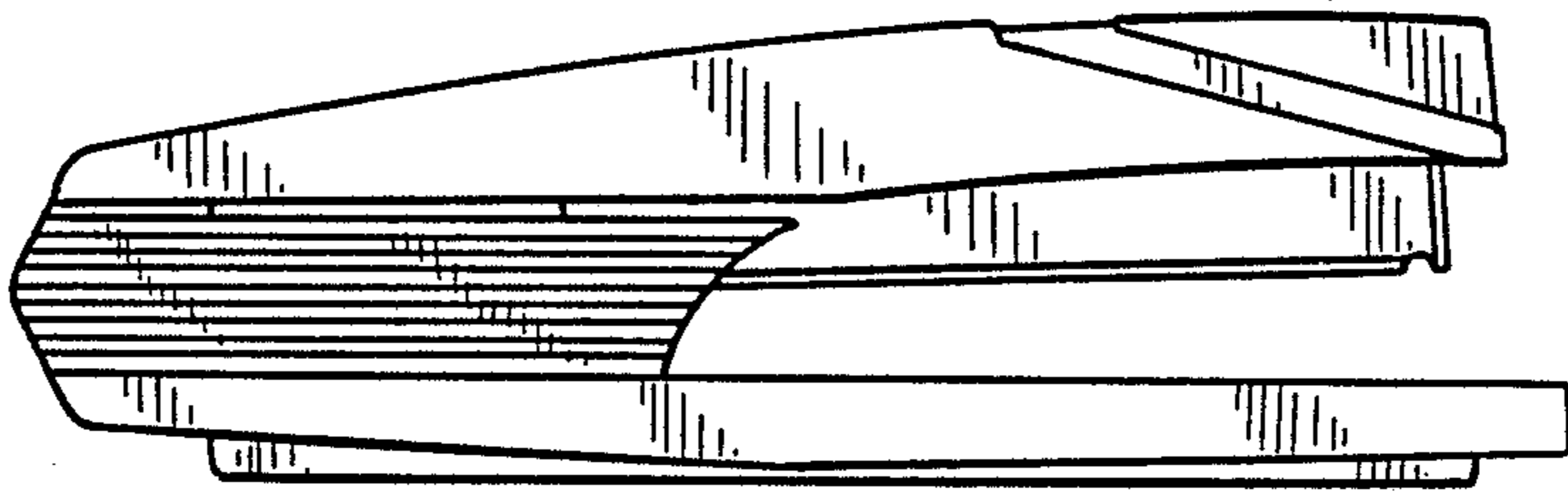

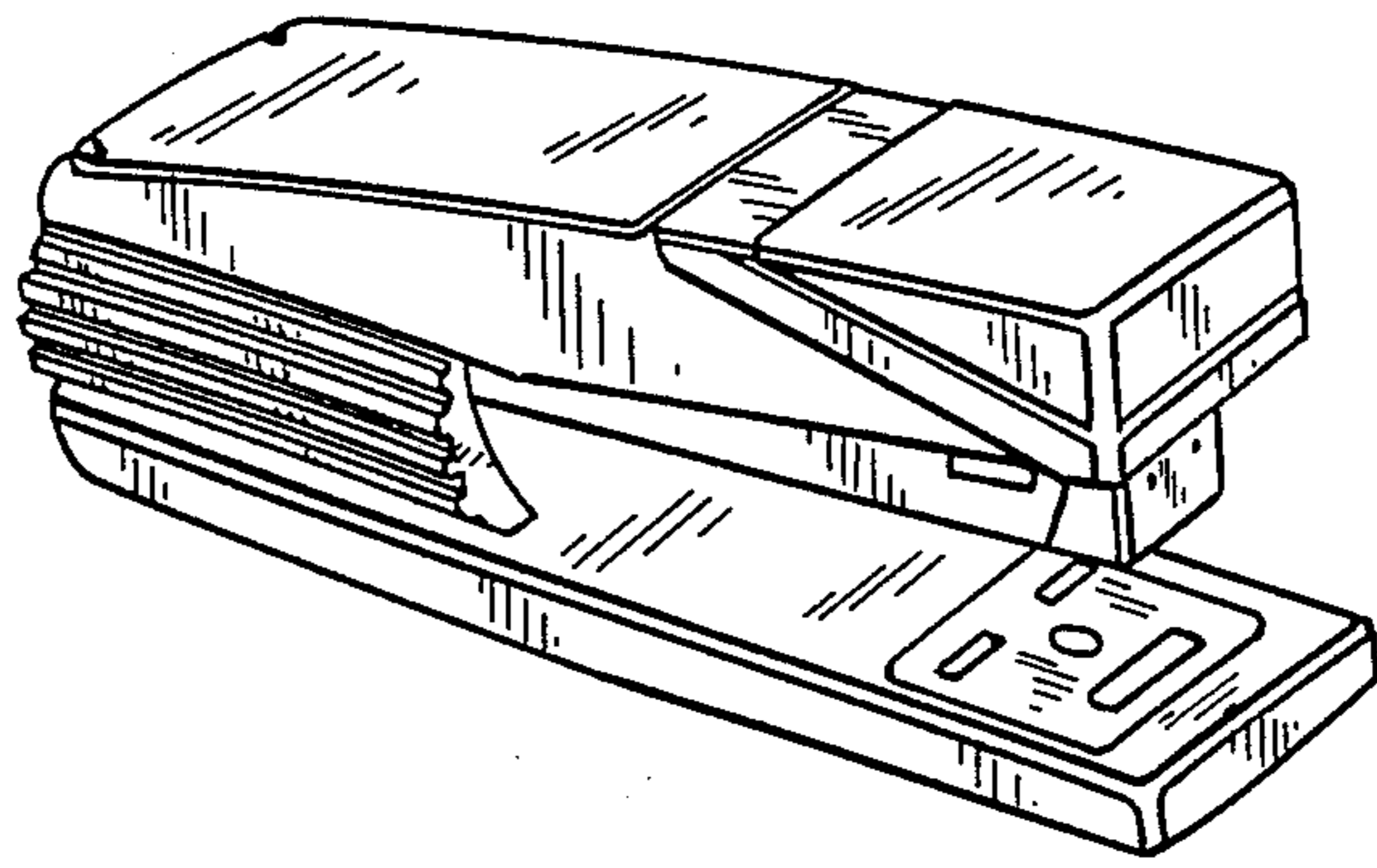

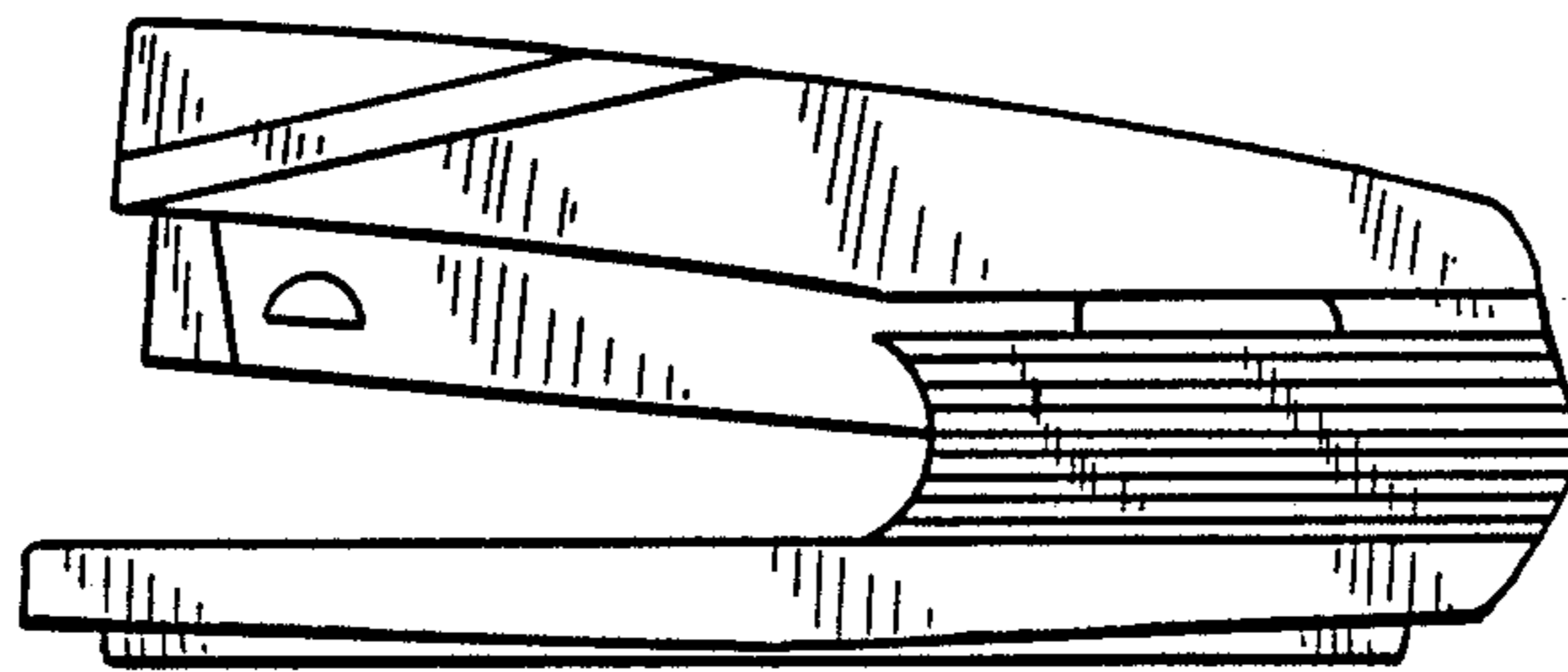

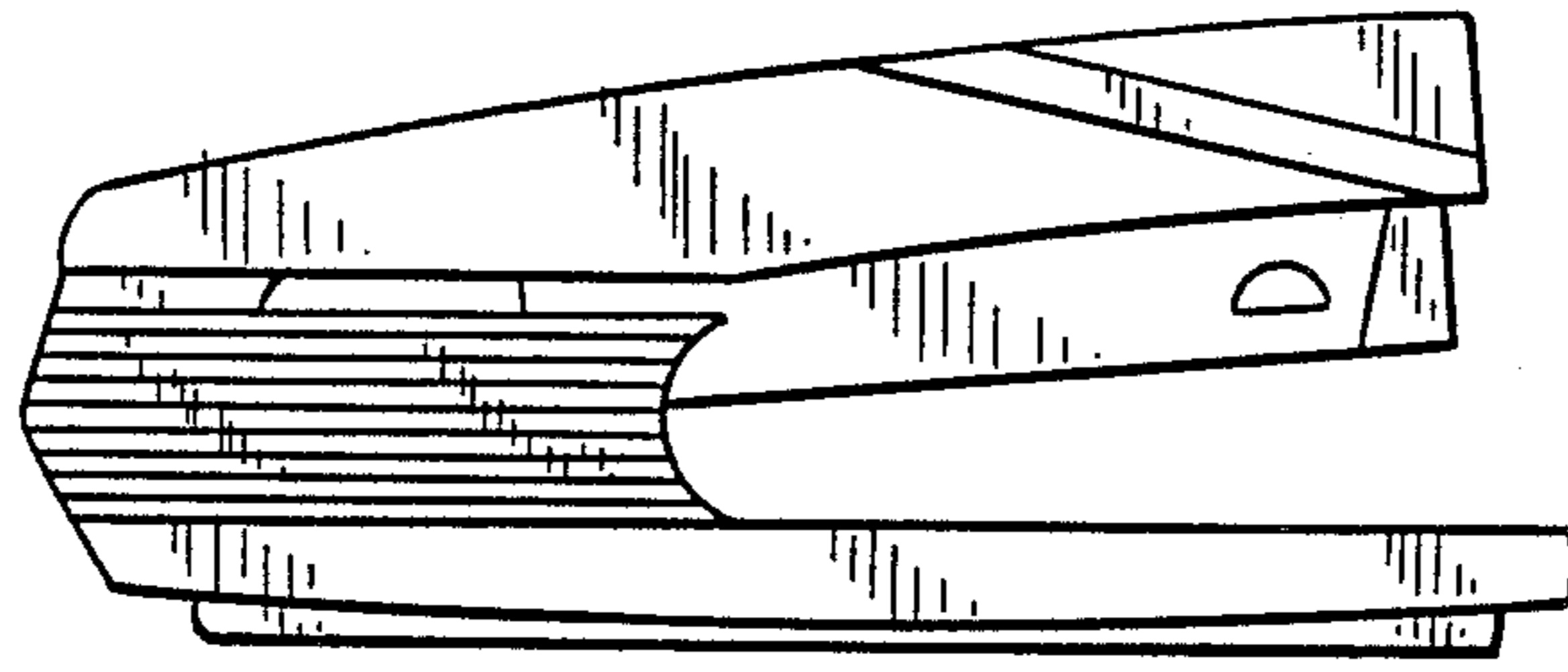

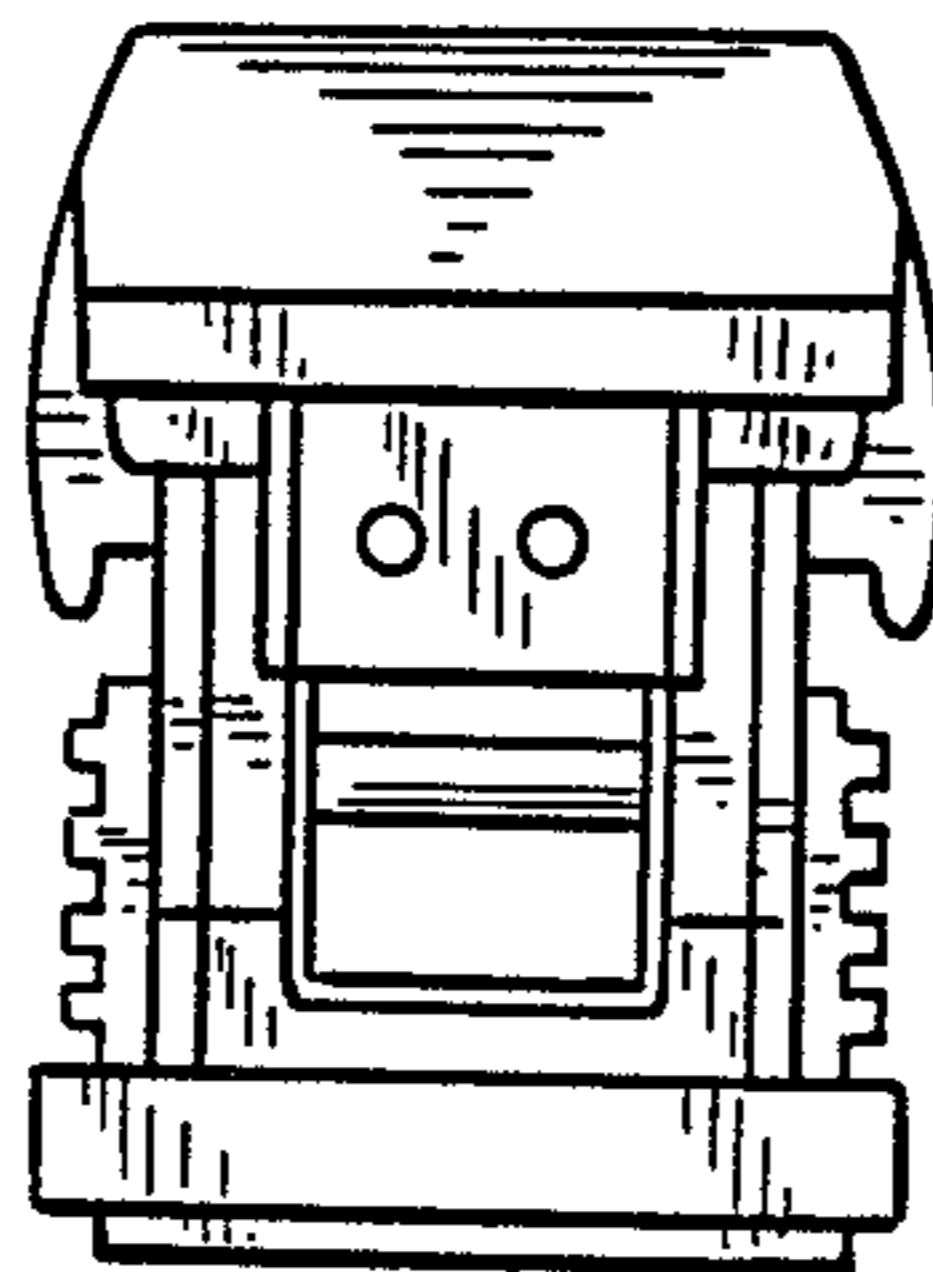

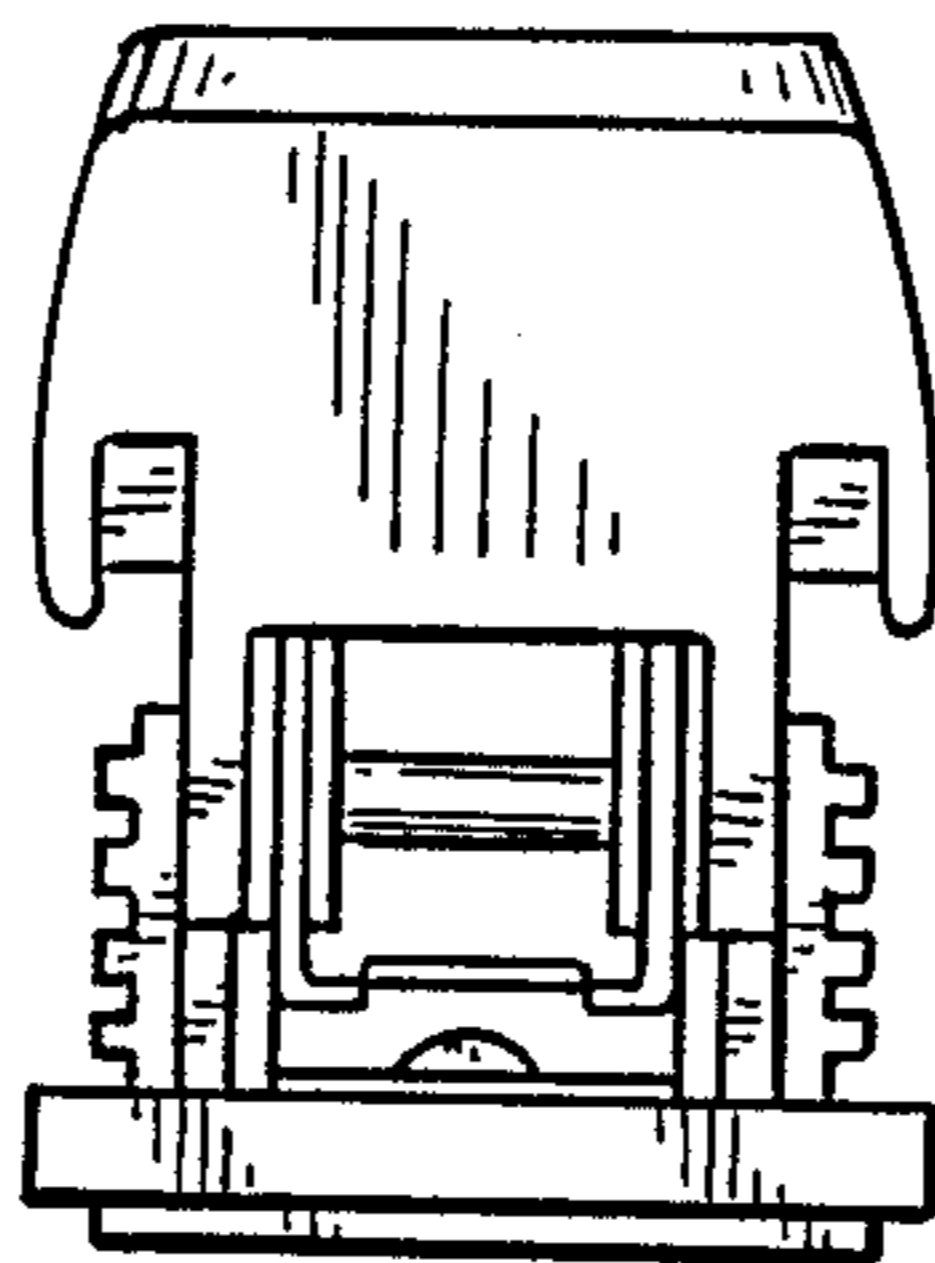

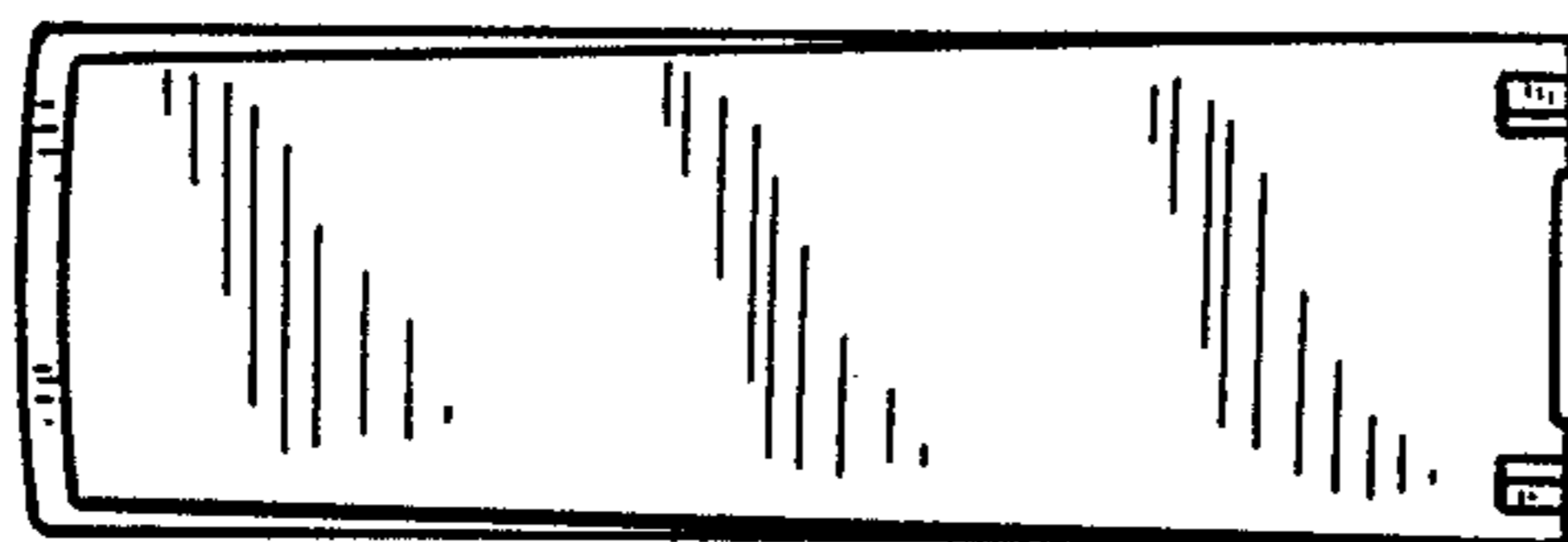

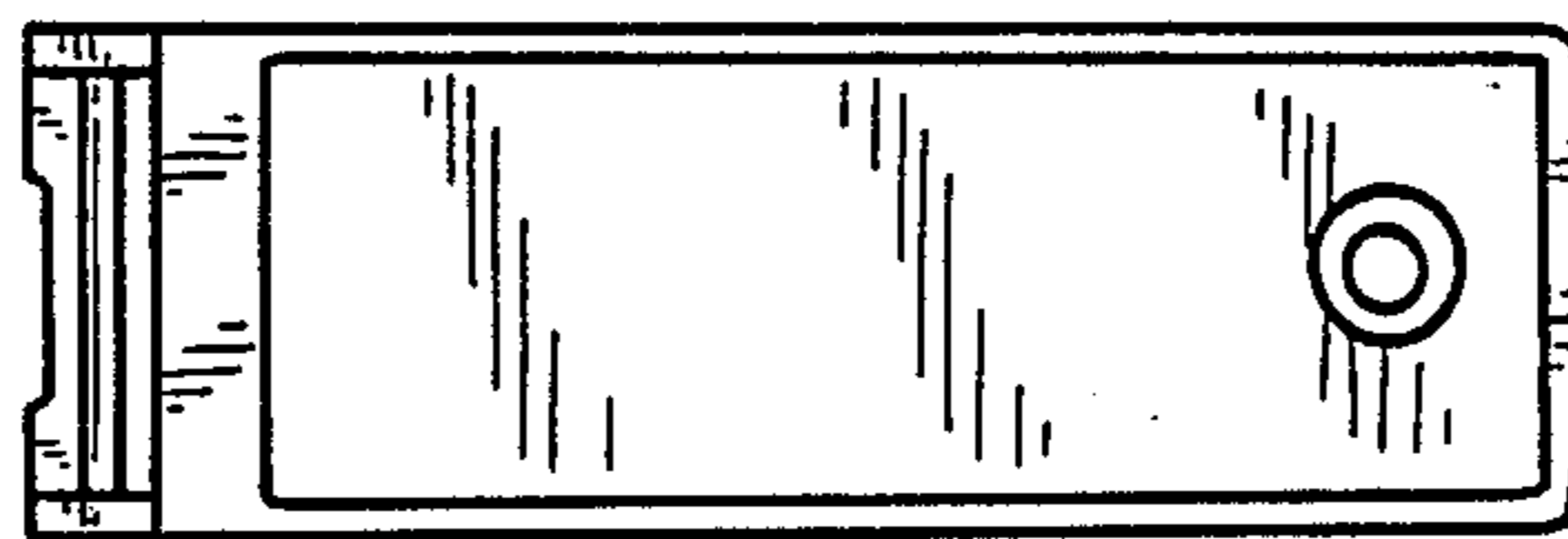
