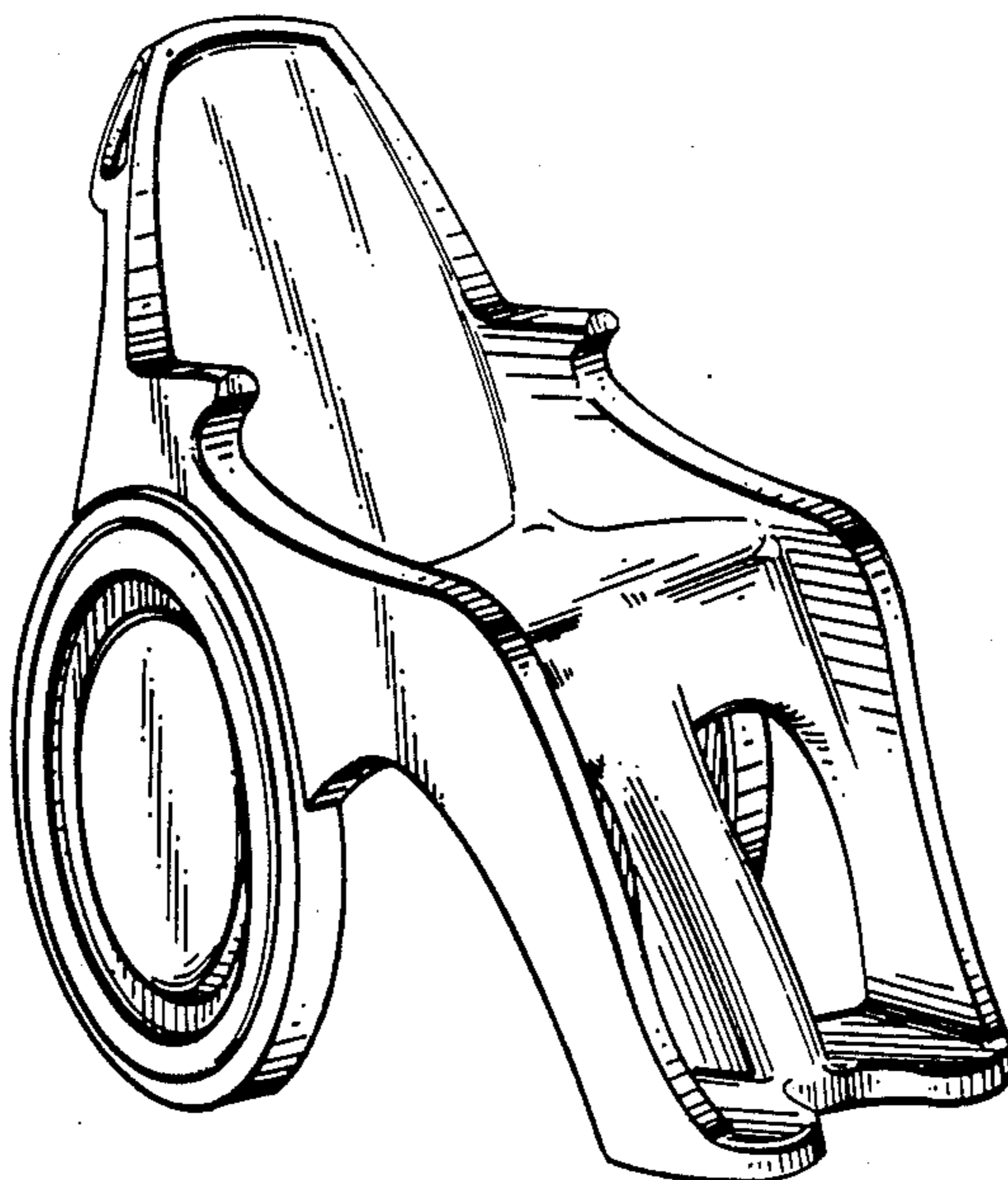

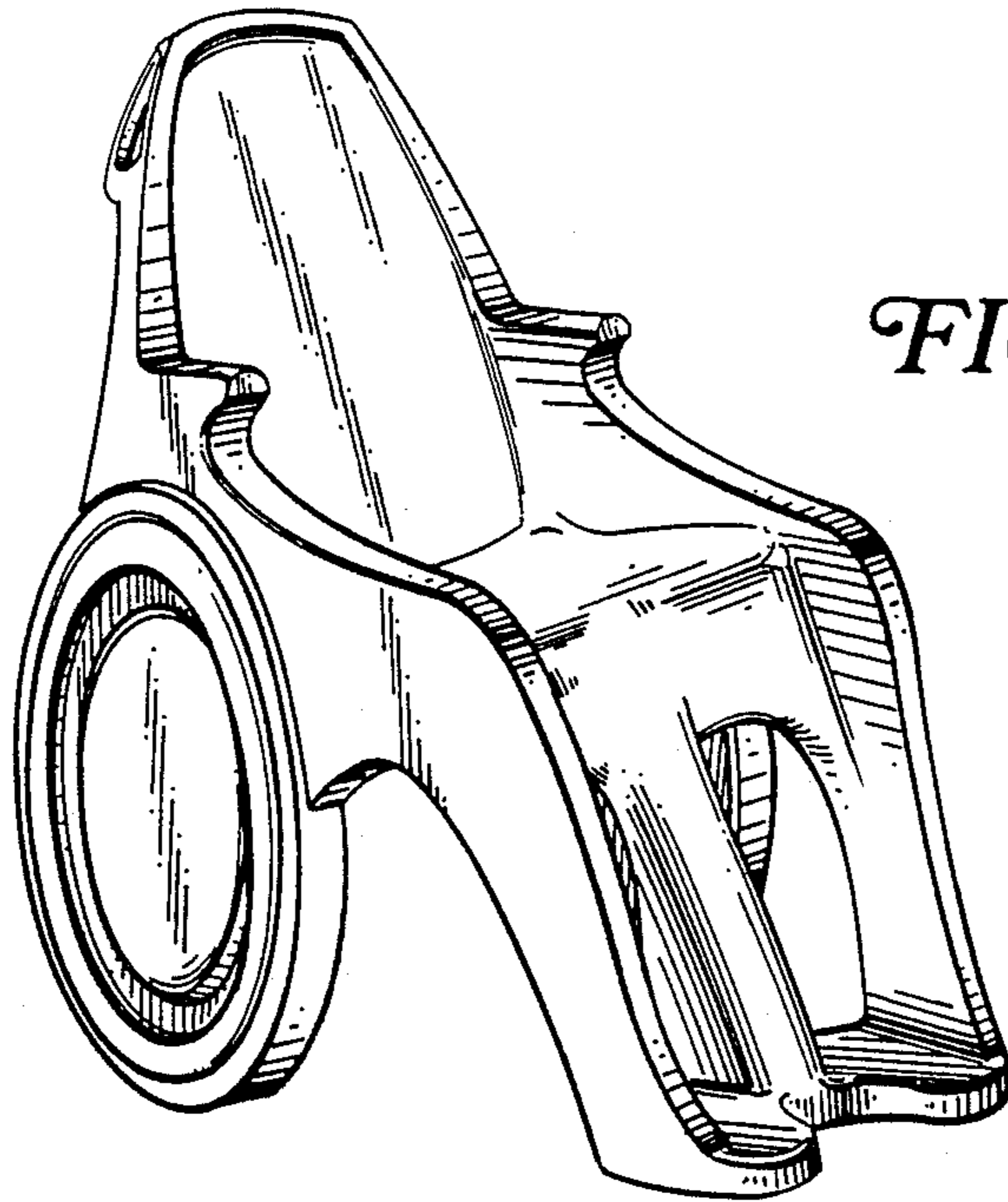
[57] CLAIM

The ornamental design for a wheel-chair, as shown and described.

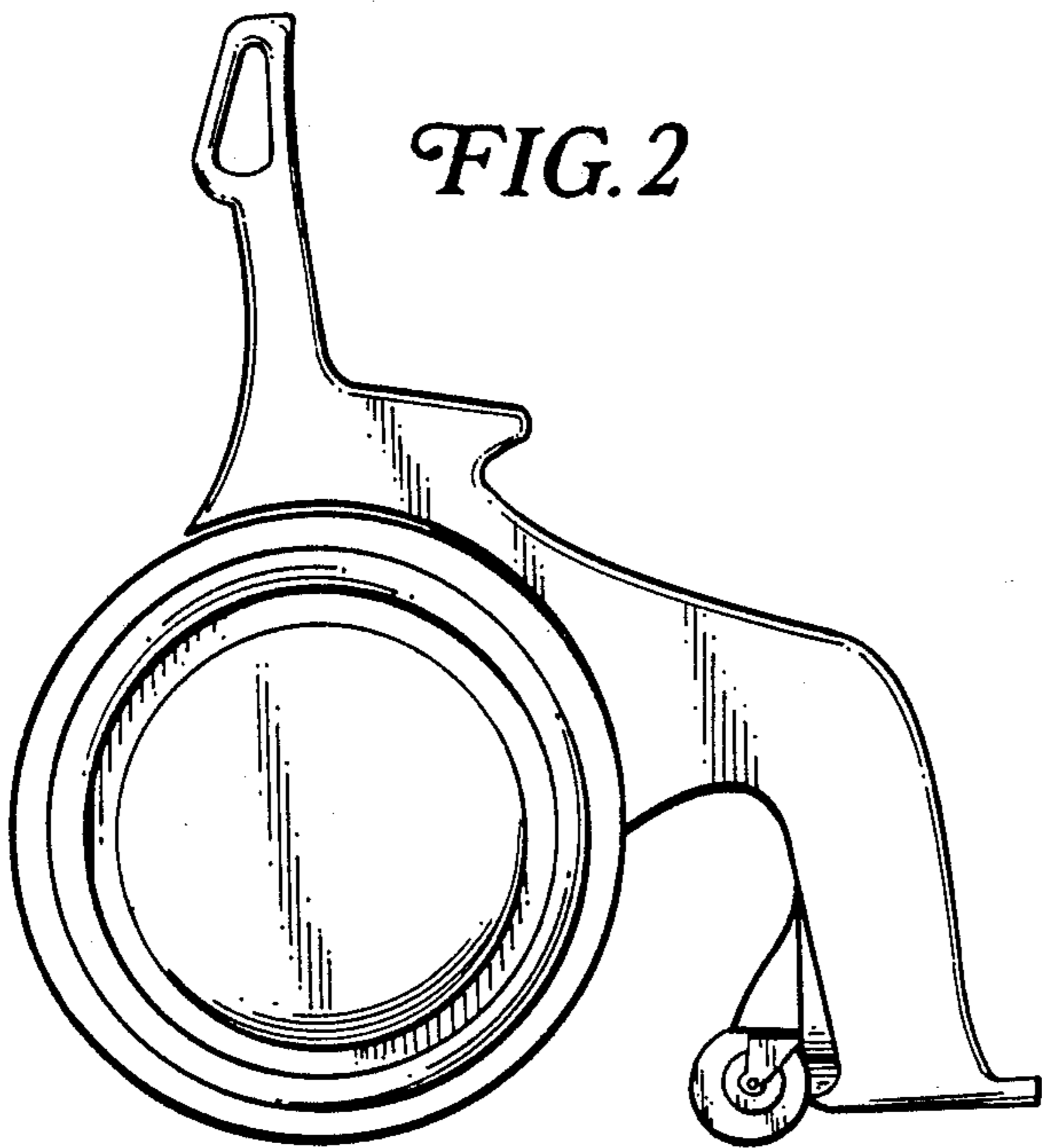
DESCRIPTION

FIG. 6 is a rear elevational view thereof.

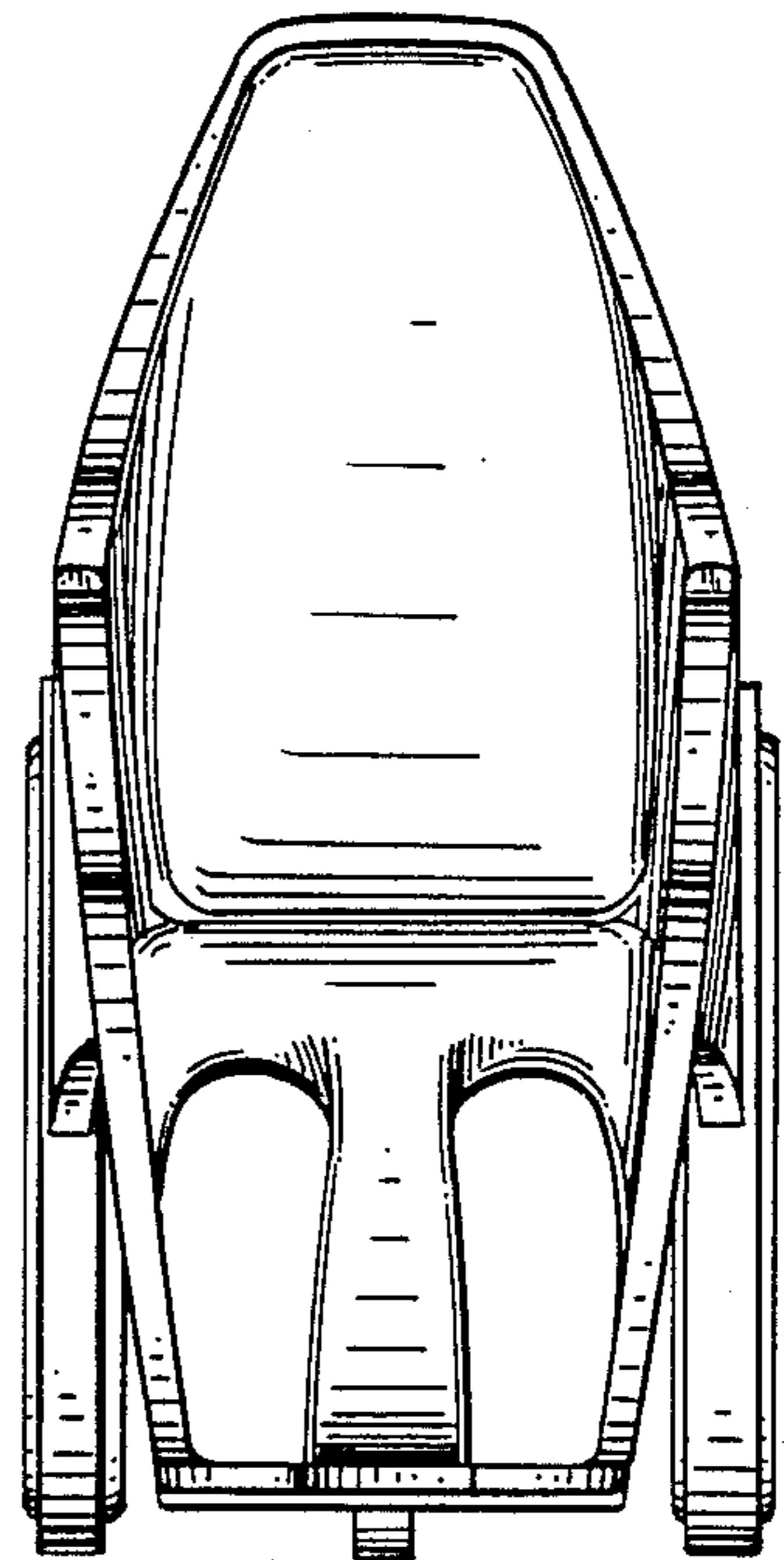




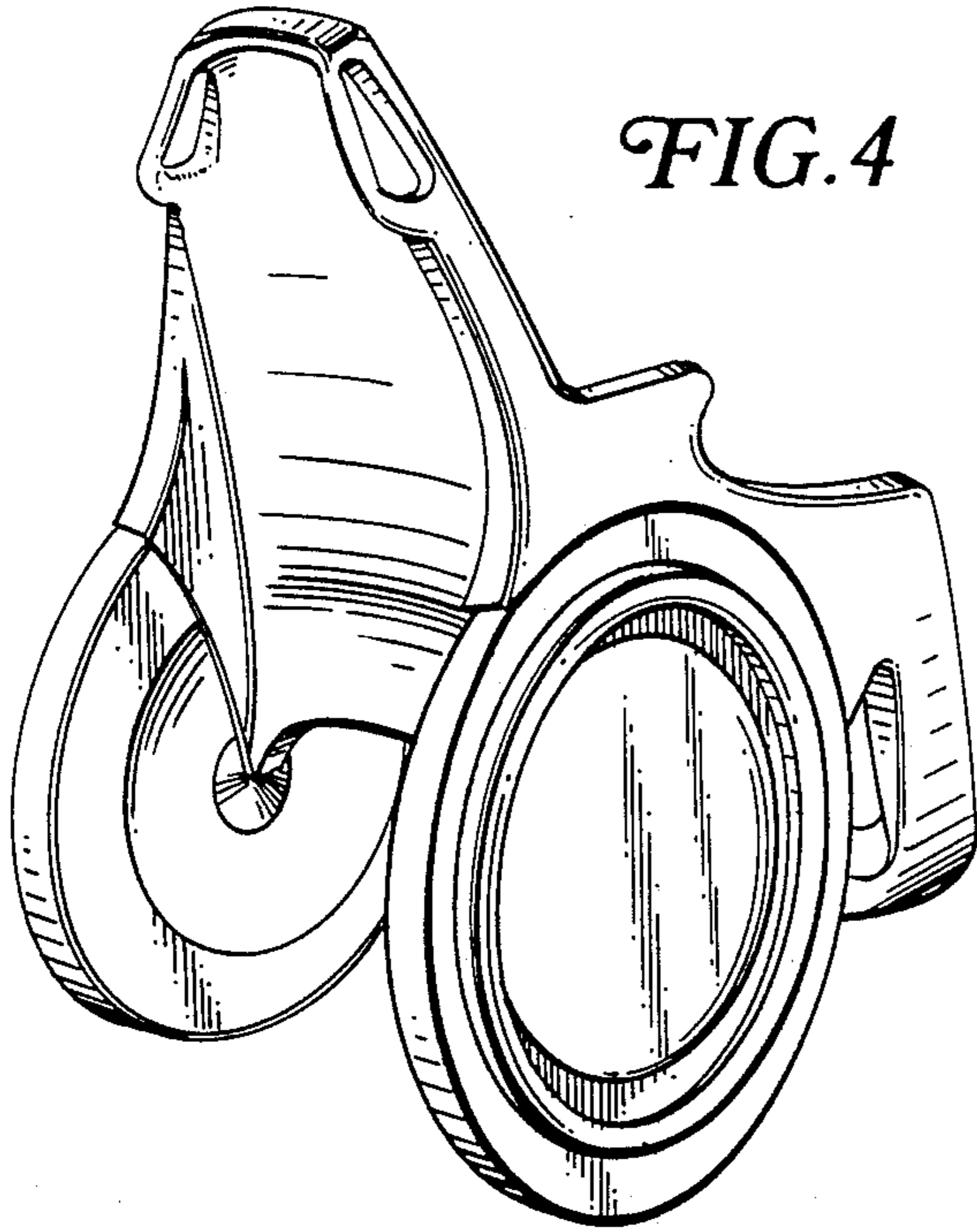

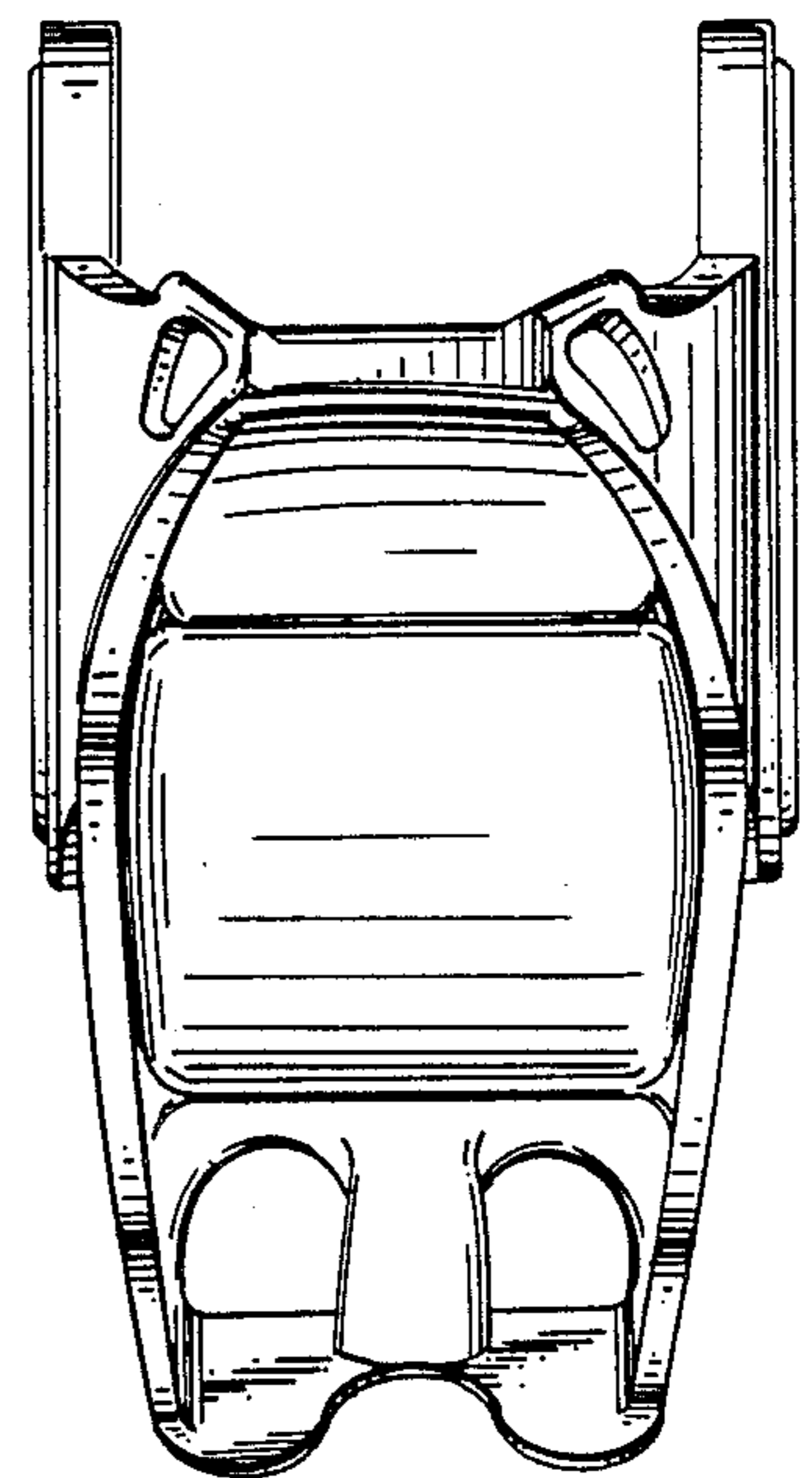

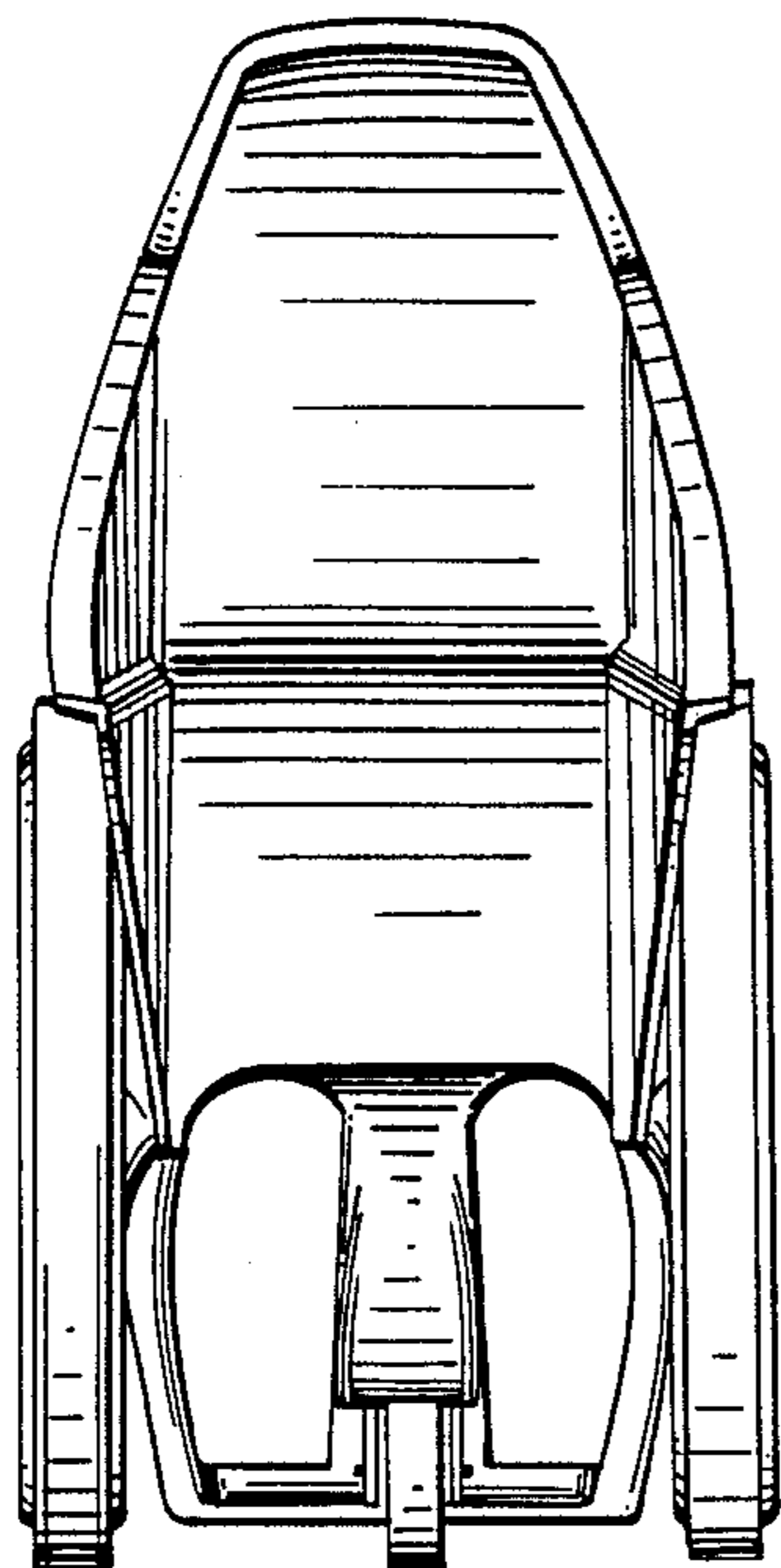
