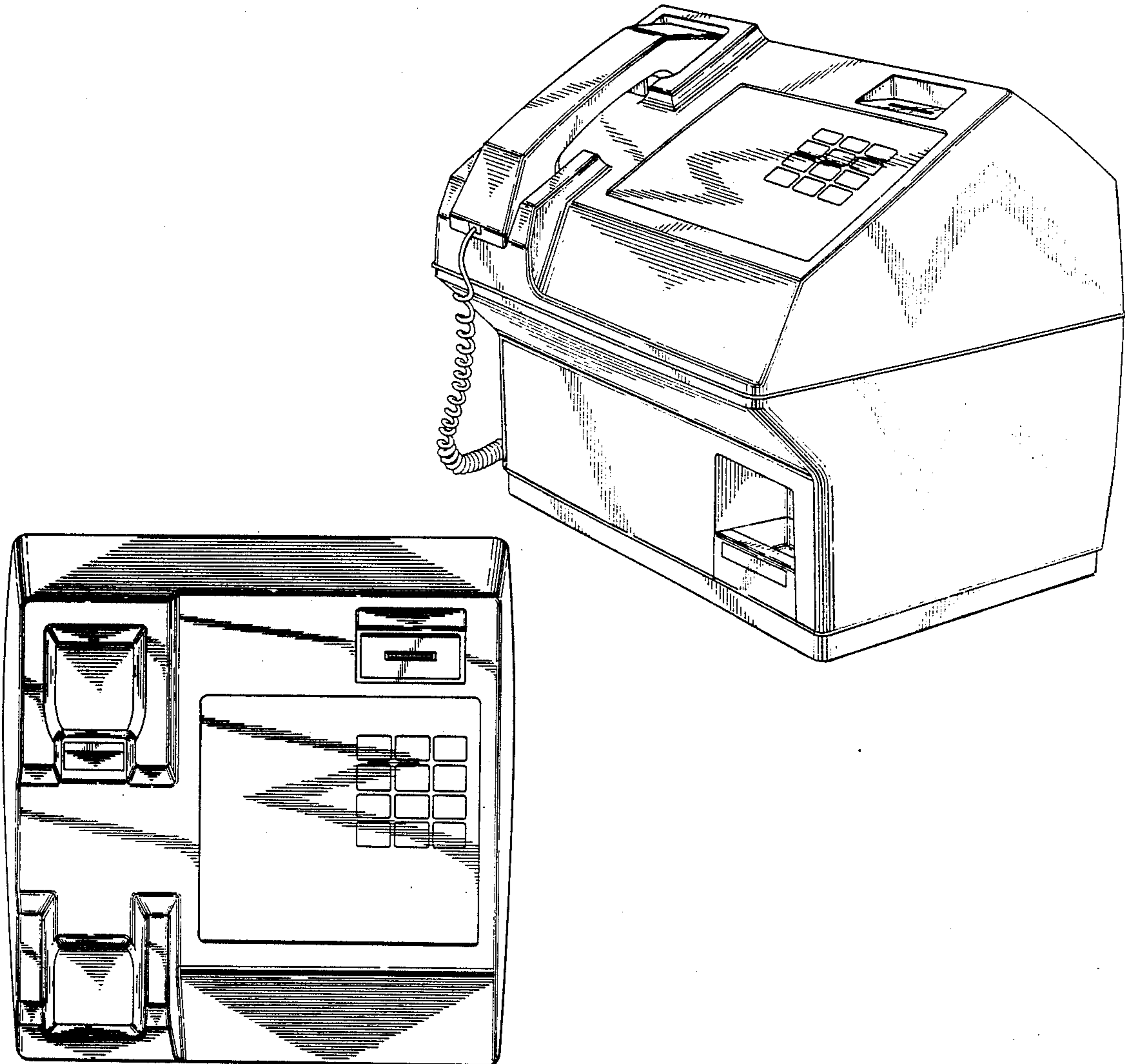

[57] **CLAIM**

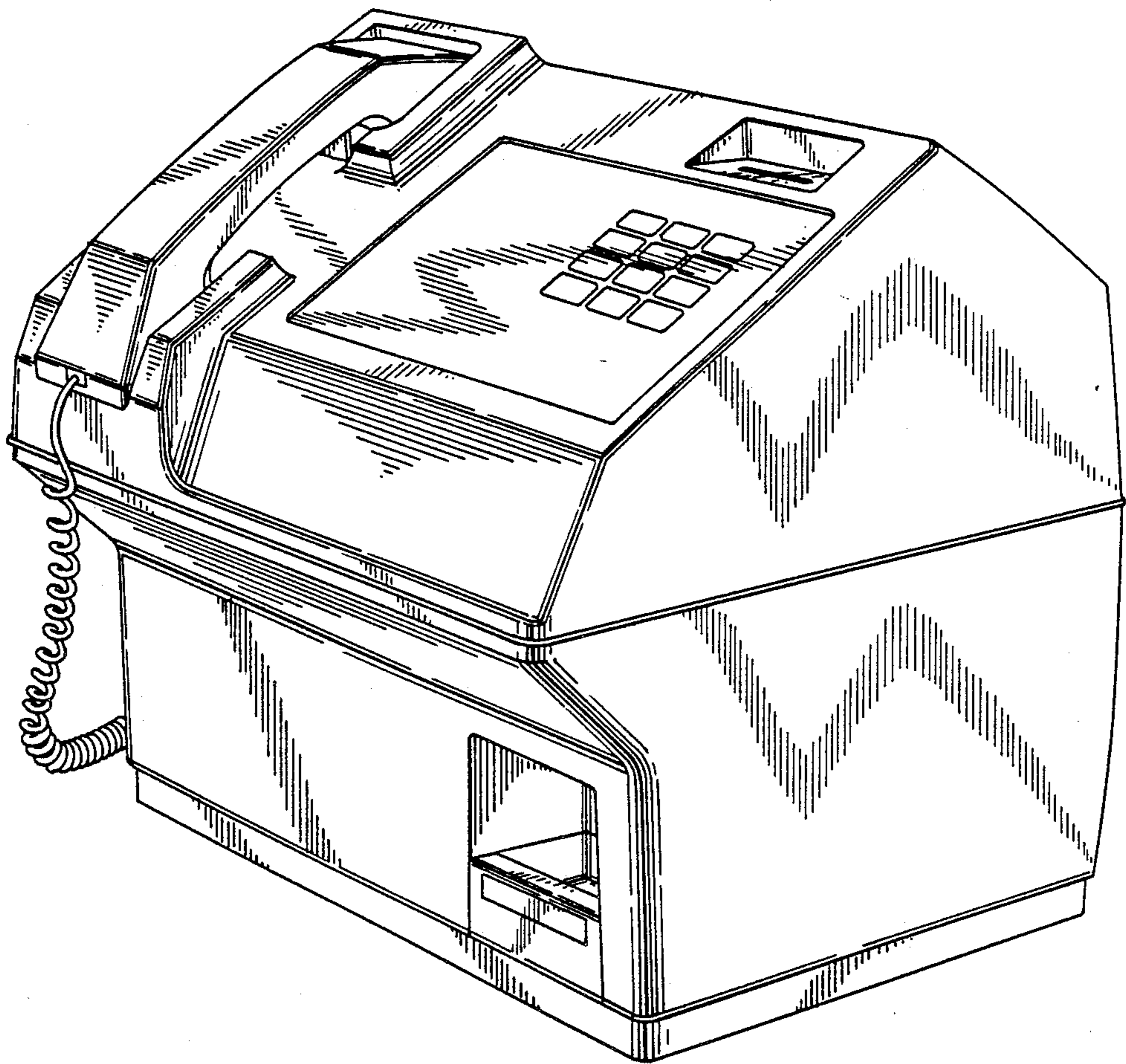
The ornamental design for a coin telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the coin telephone, showing our design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a normal view showing an instruction plate face forming a part of the design;  
 FIG. 4 is an elevational view showing one side thereof;  
 FIG. 5 is an elevational view of the side opposite to that shown in FIG. 4;  
 FIG. 6 is a rear view thereof.

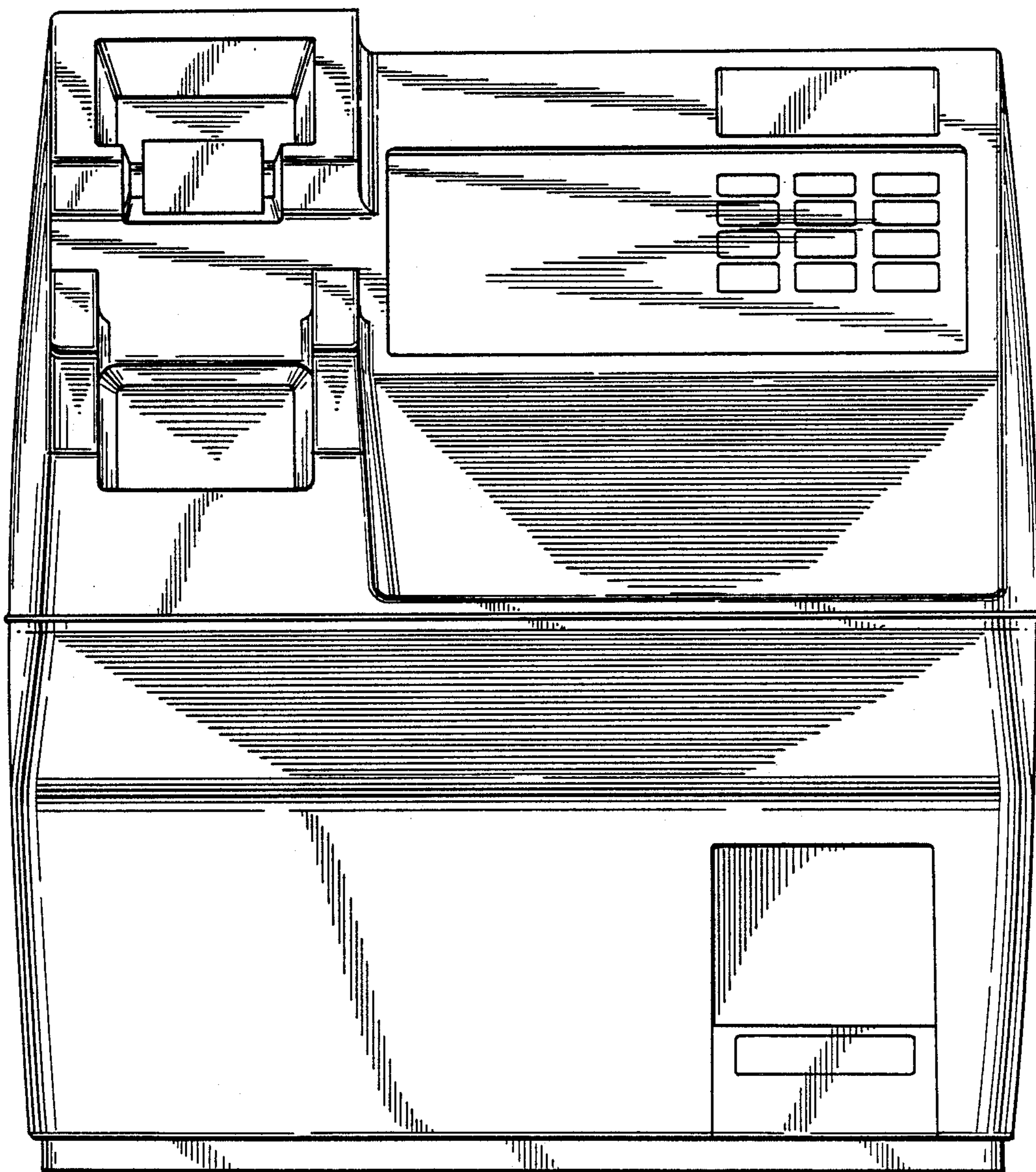

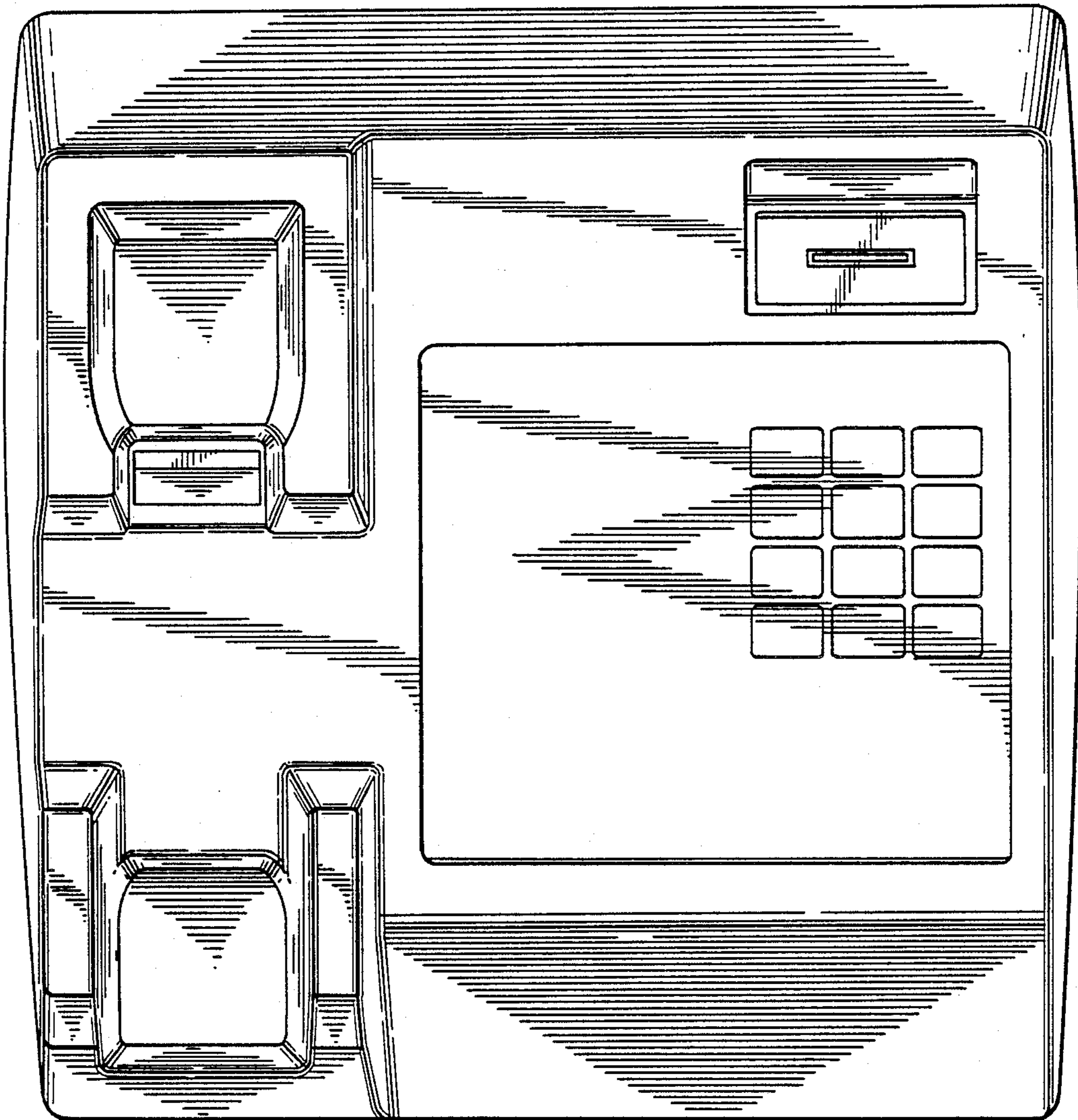




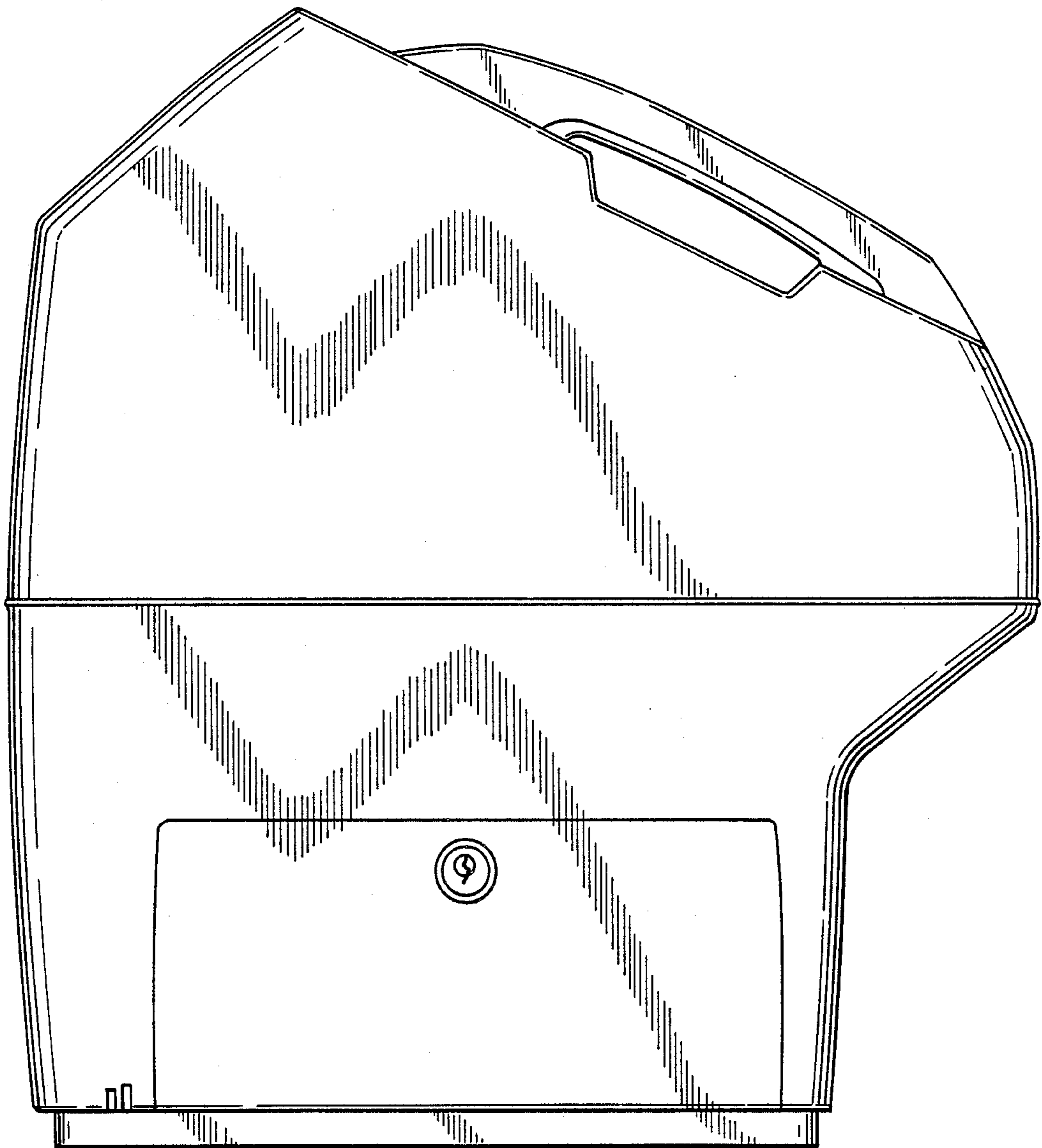

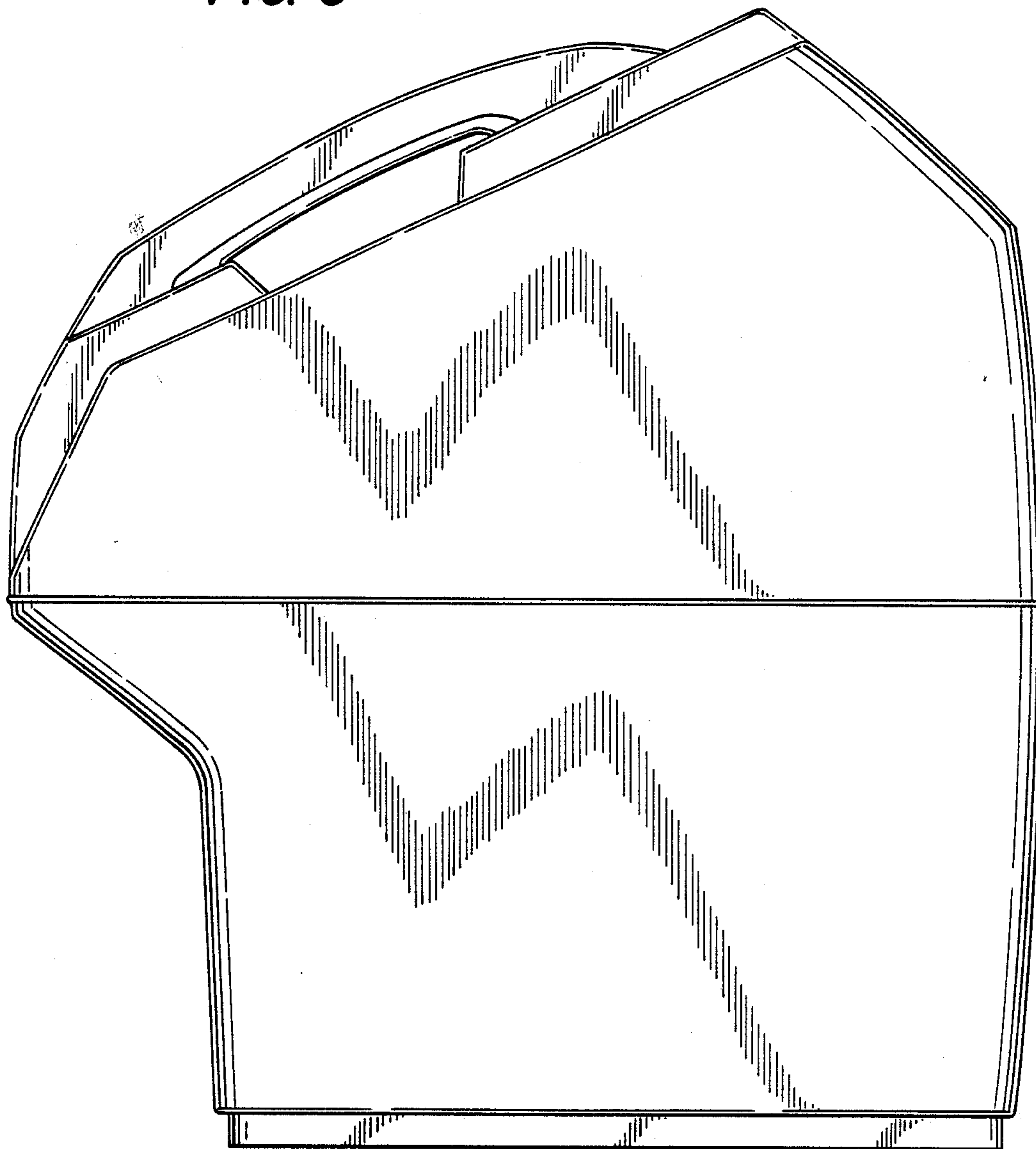
