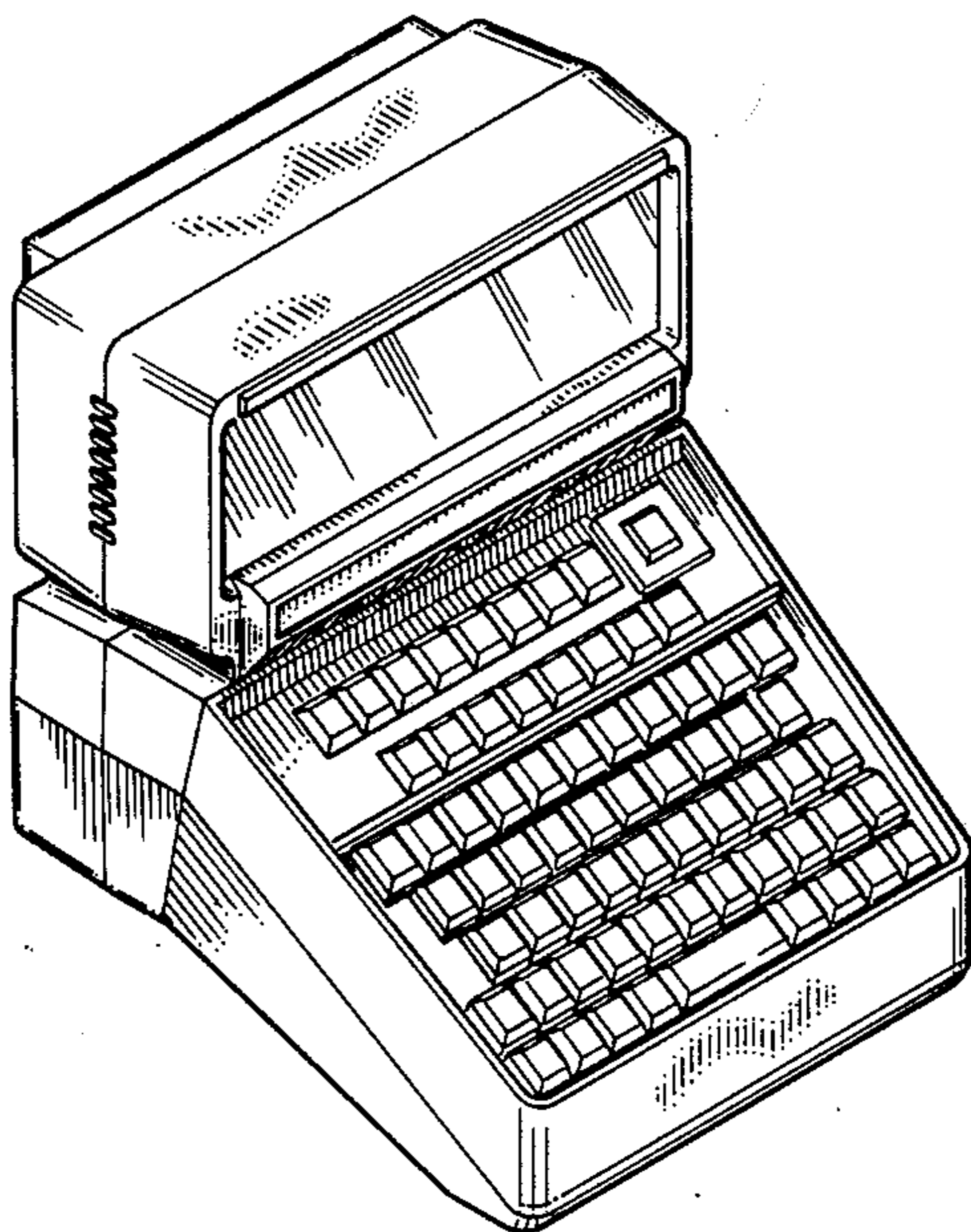

The ornamental design for a mobile input/output data terminal, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, front perspective view of a mobile input/output data terminal showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIGS. 6 and 7 are respectively right and left side elevational views thereof.



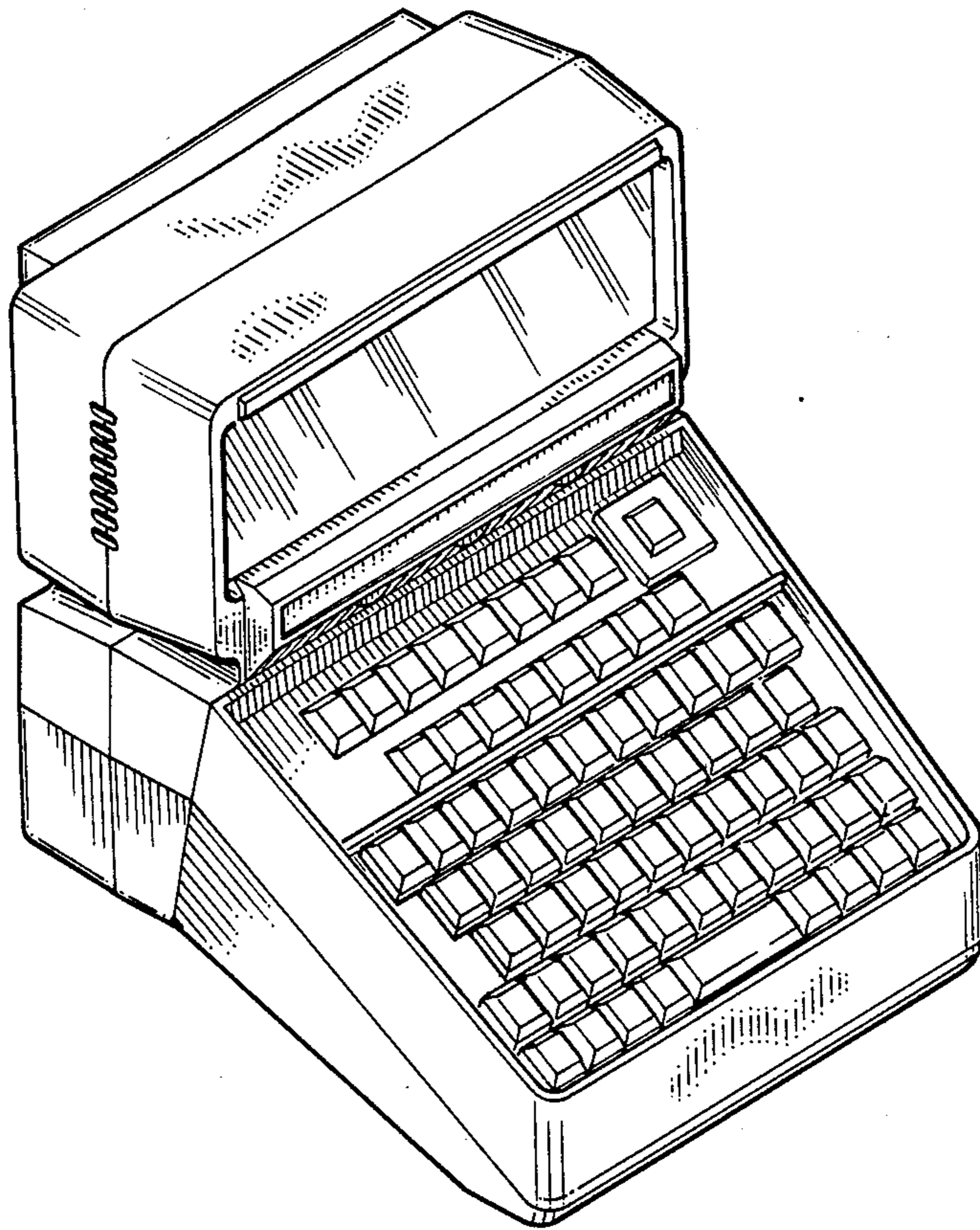

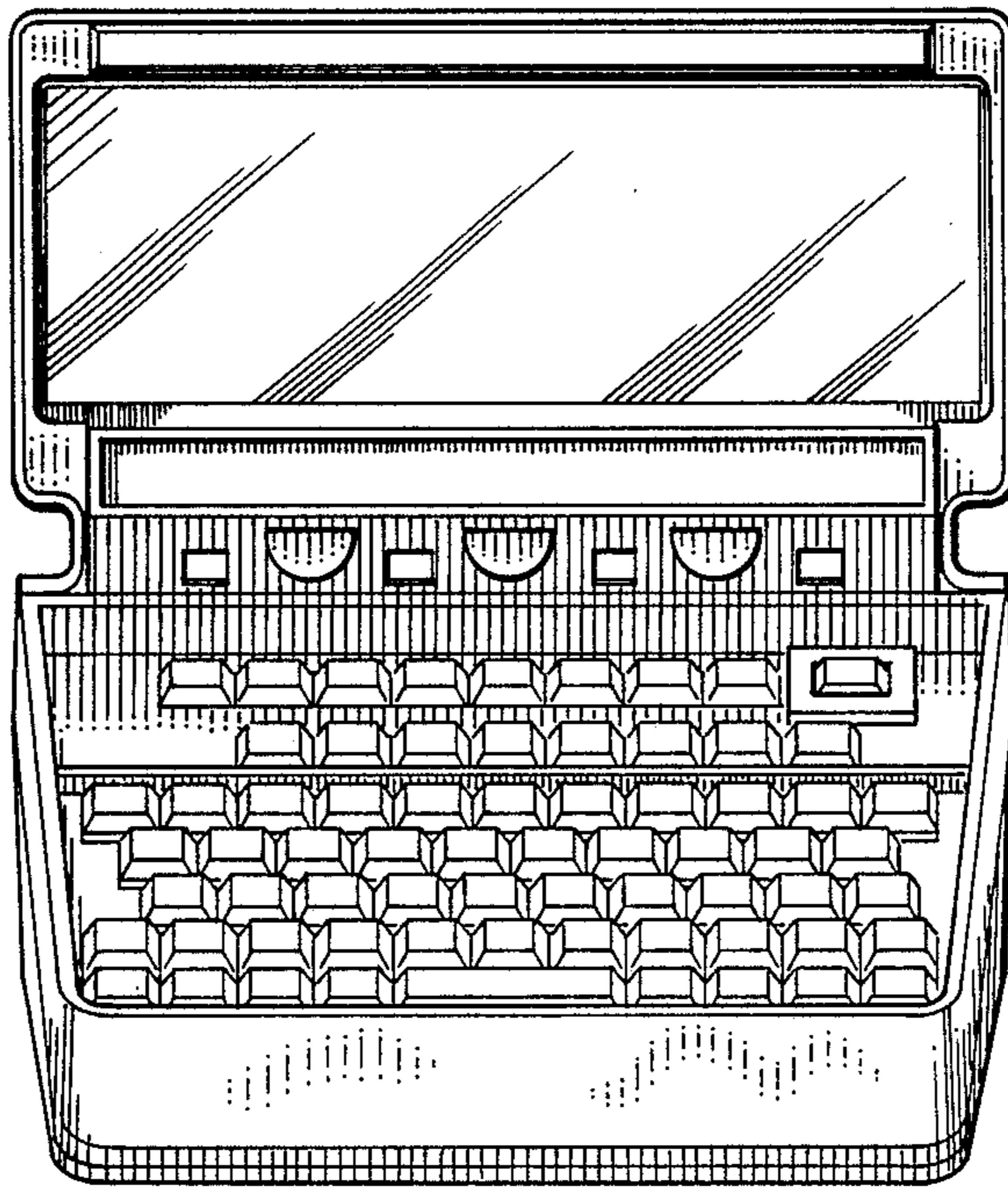

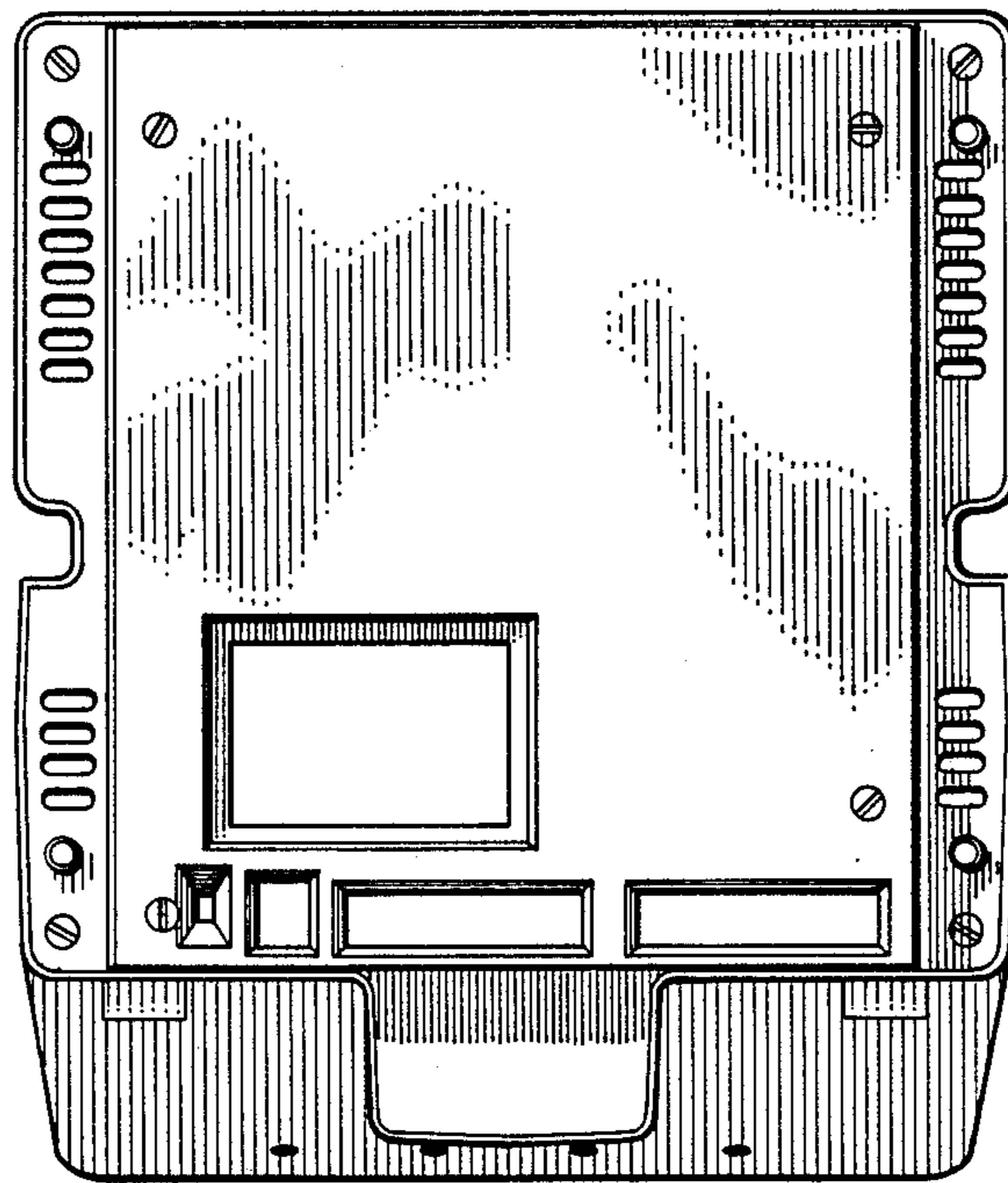

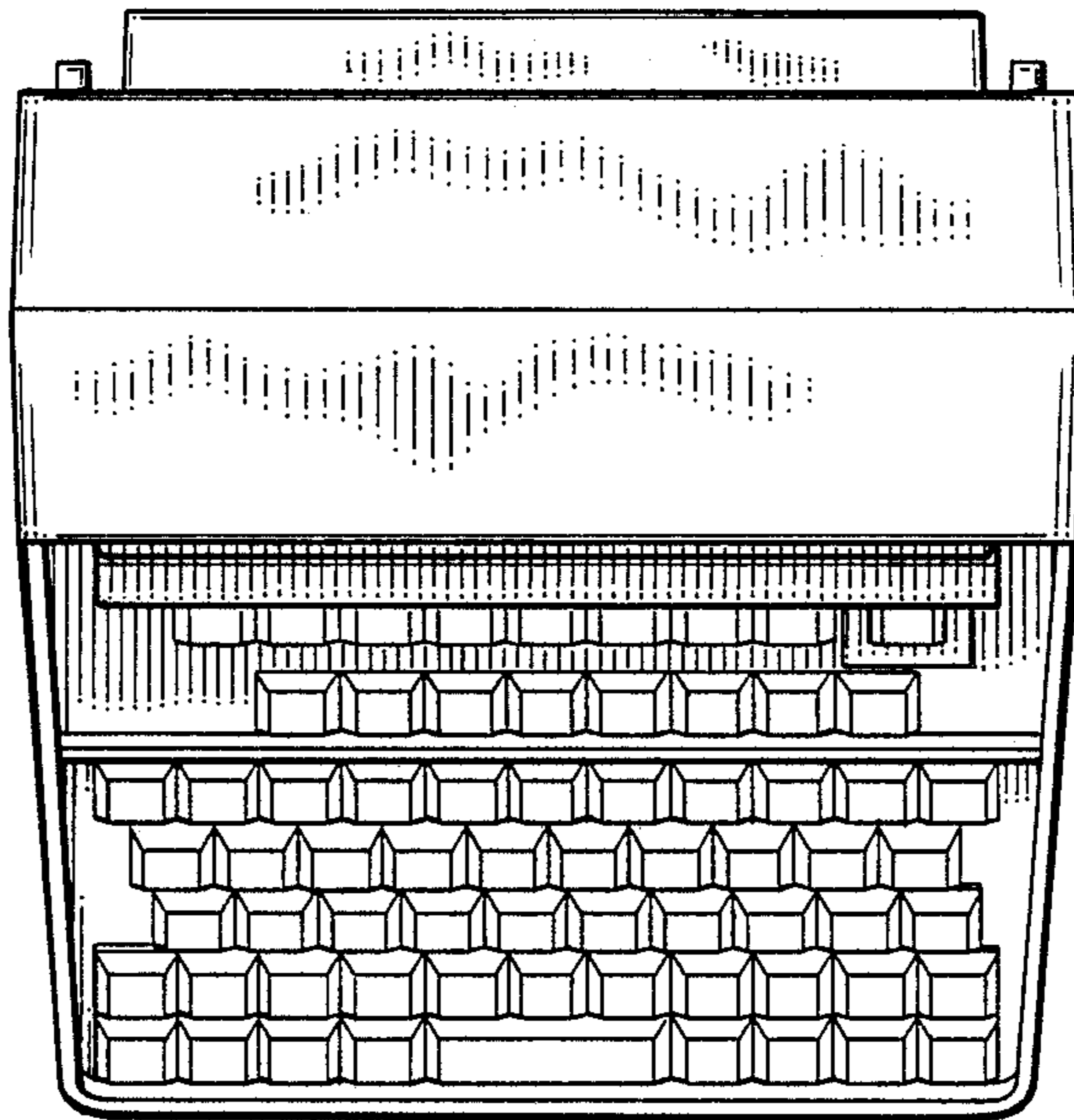

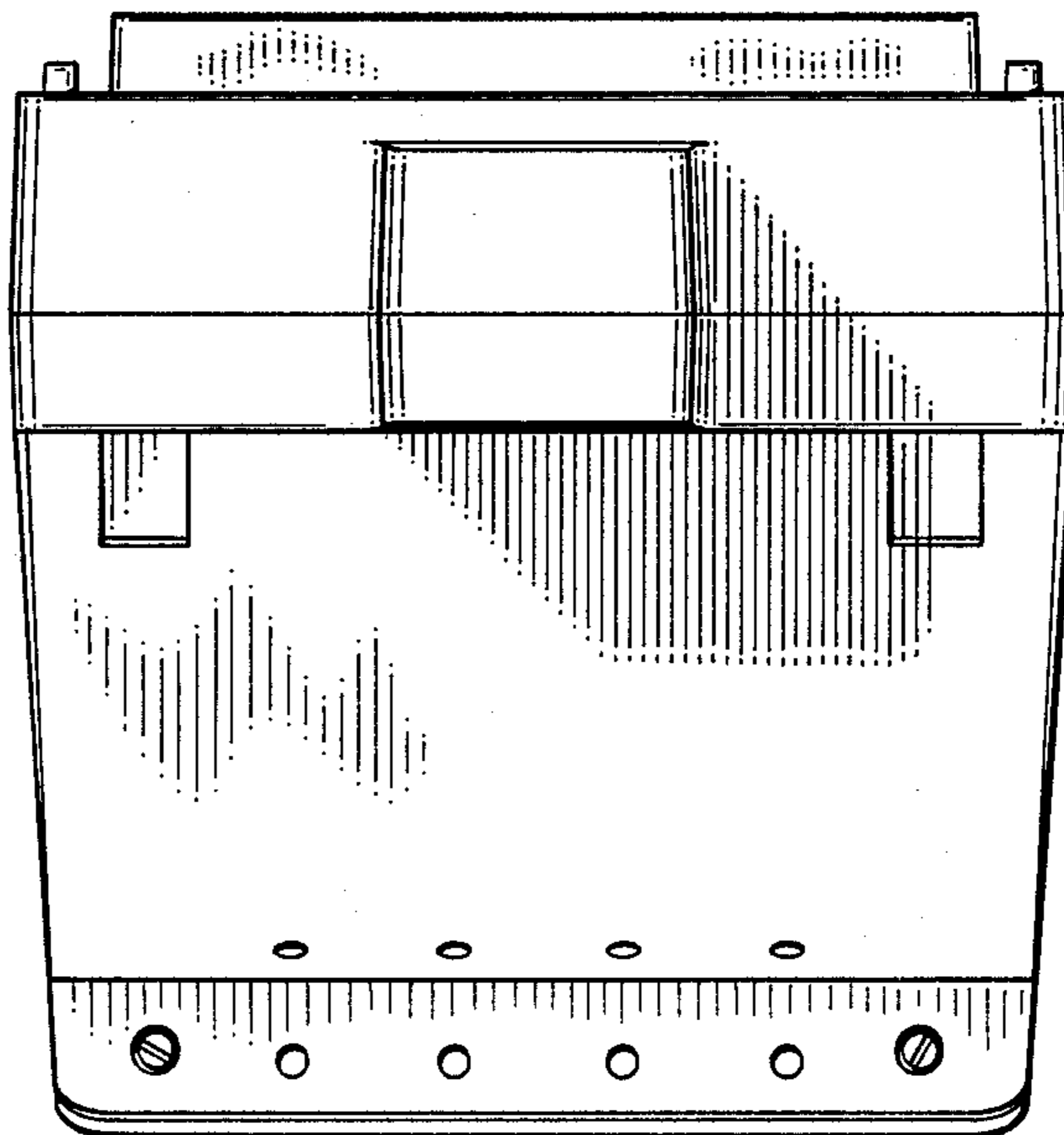

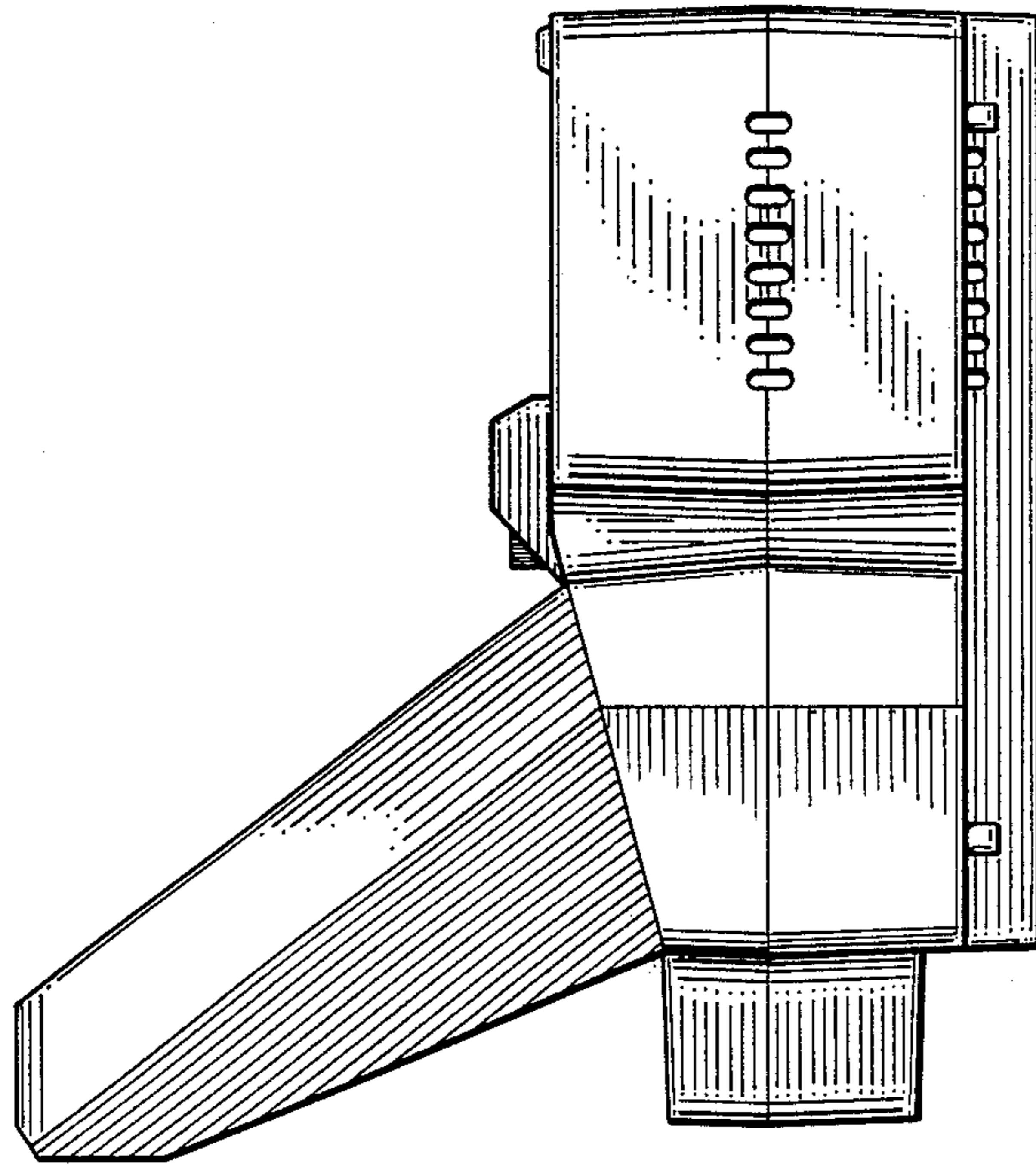

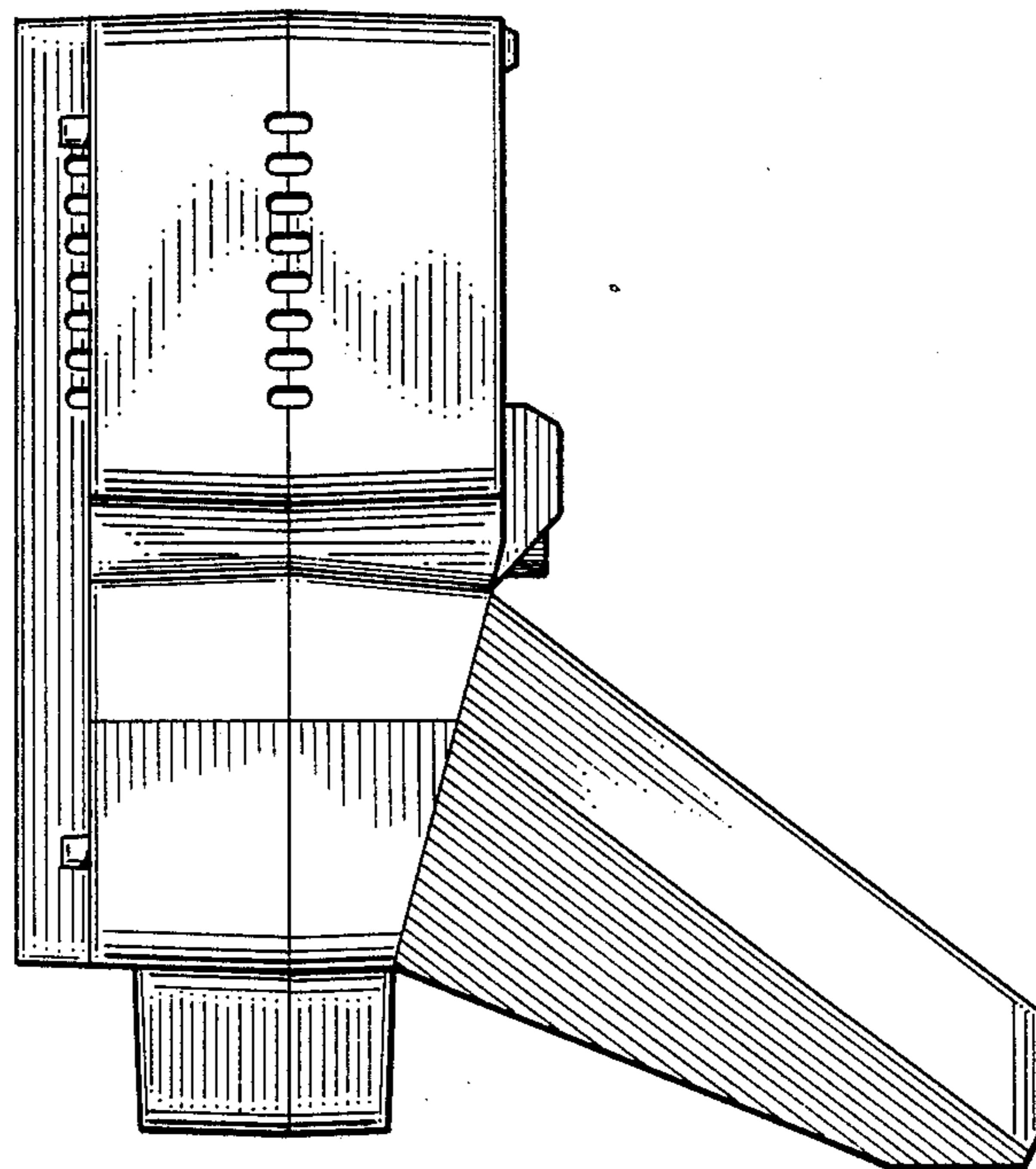
