**DESCRIPTION**

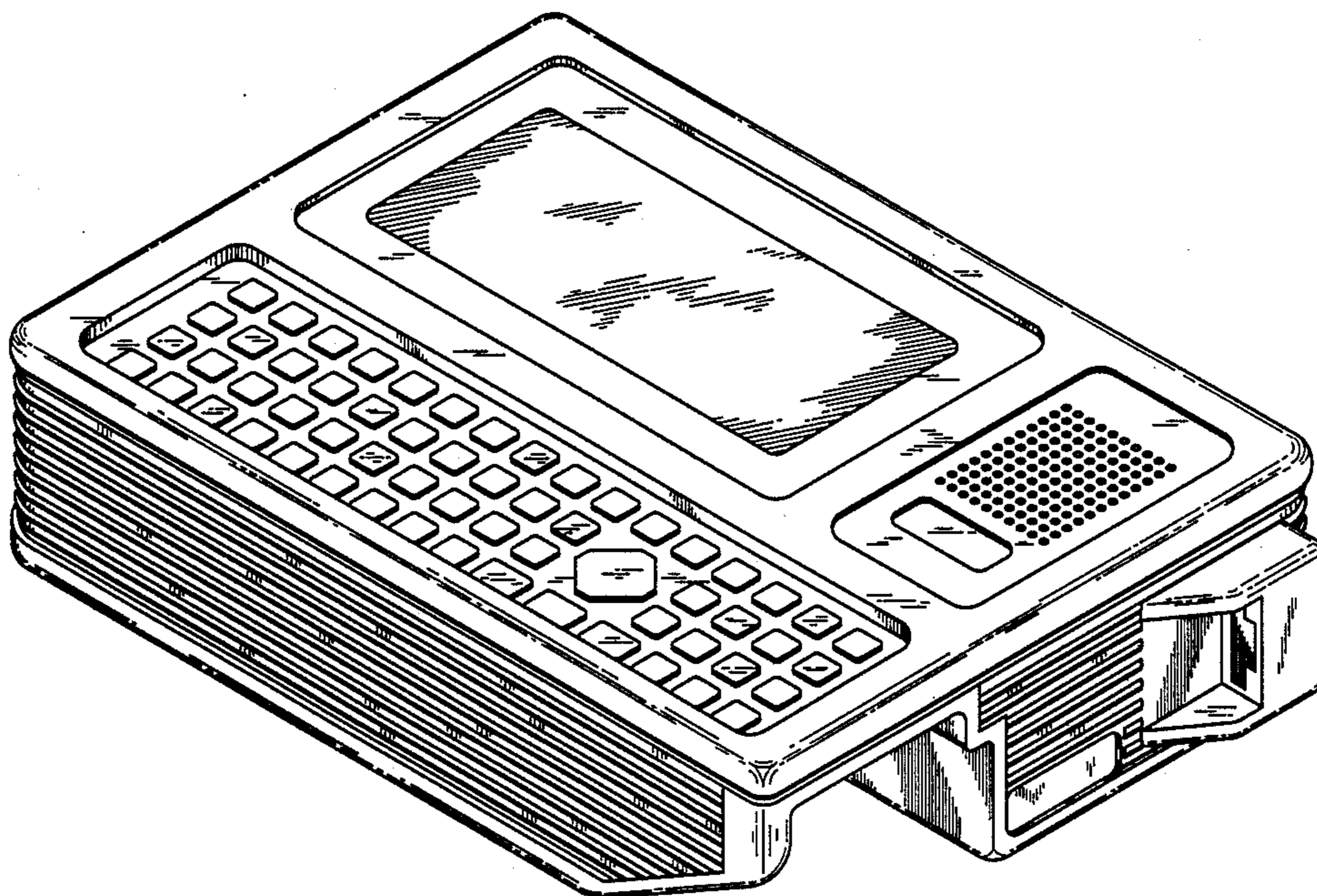
FIG. 1 is a top, front, right side perspective view of the portable terminal or similar article showing our new design;

FIG. 3 is a rear elevational view thereof; and

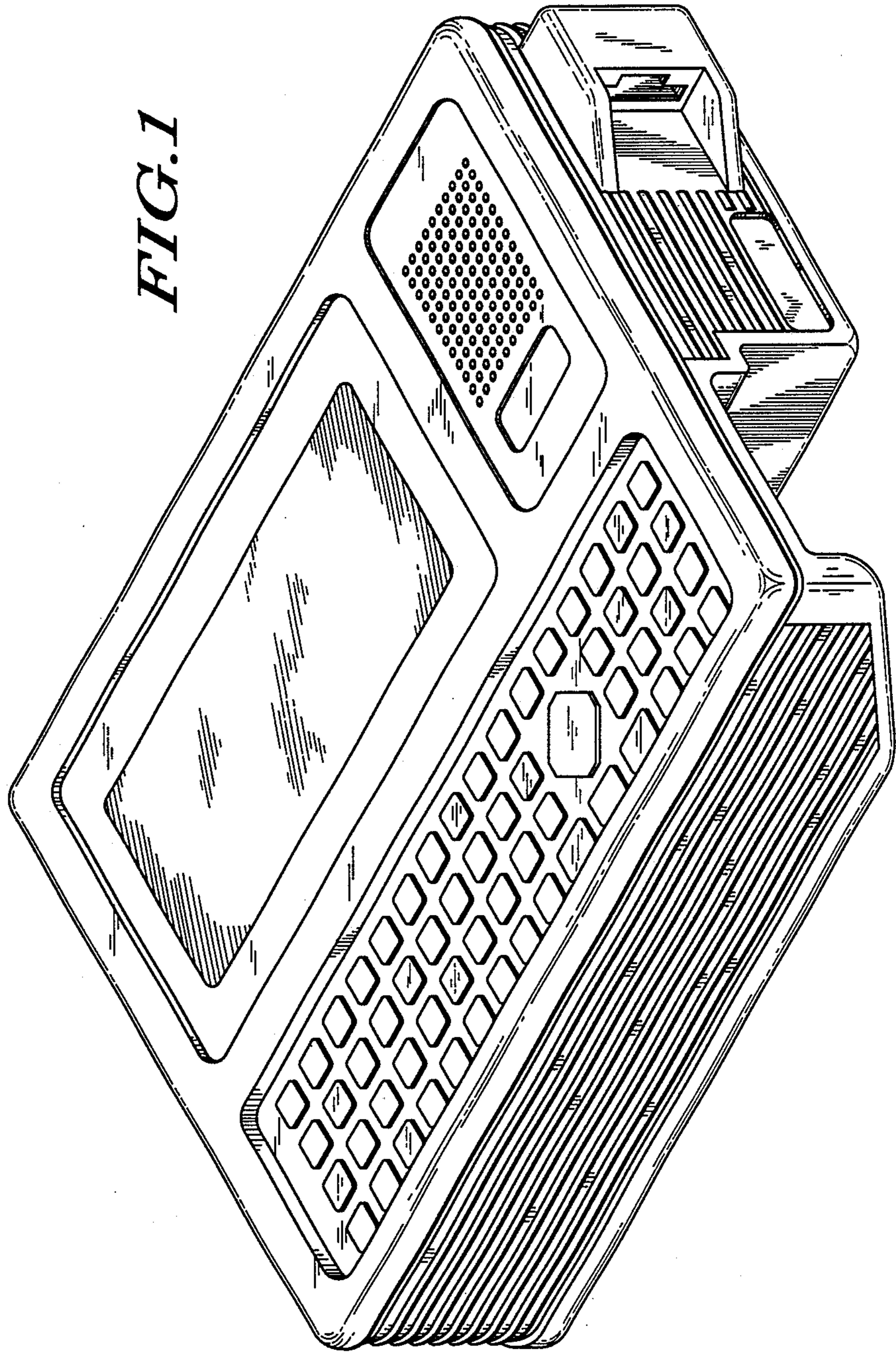
FIG. 4 is a bottom plan view thereof.

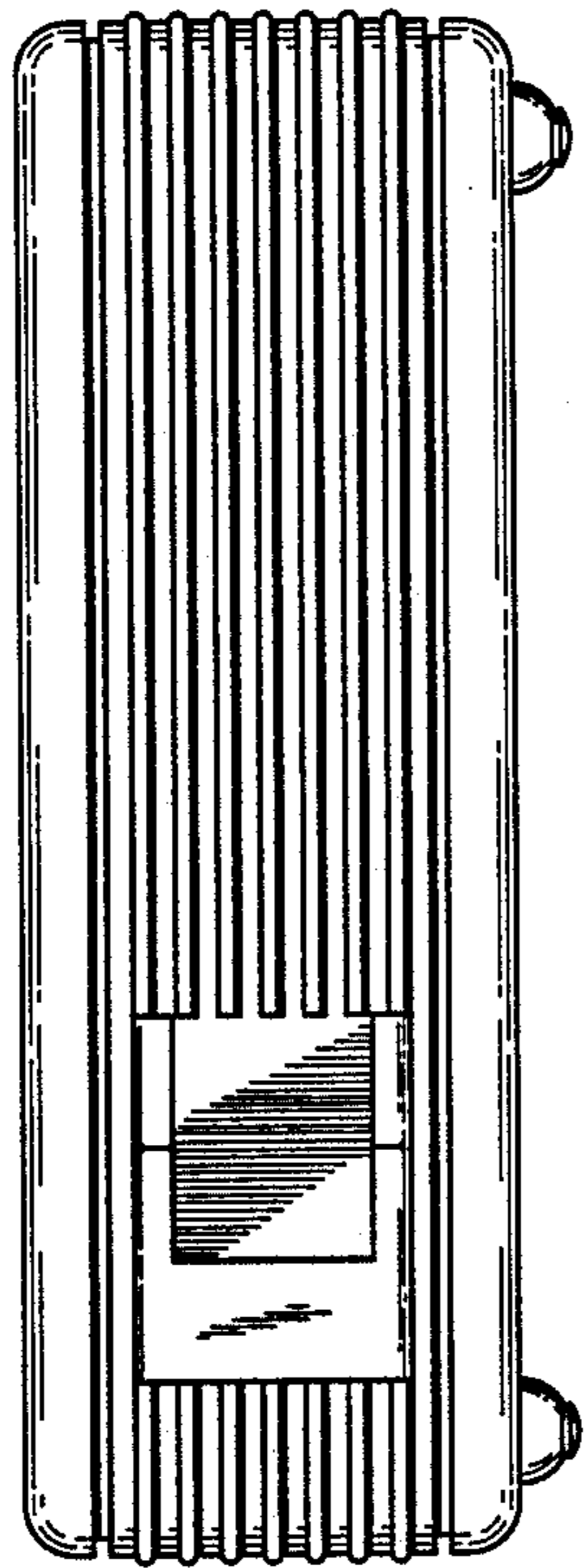
FIG. 5 is a right side elevational view thereof.



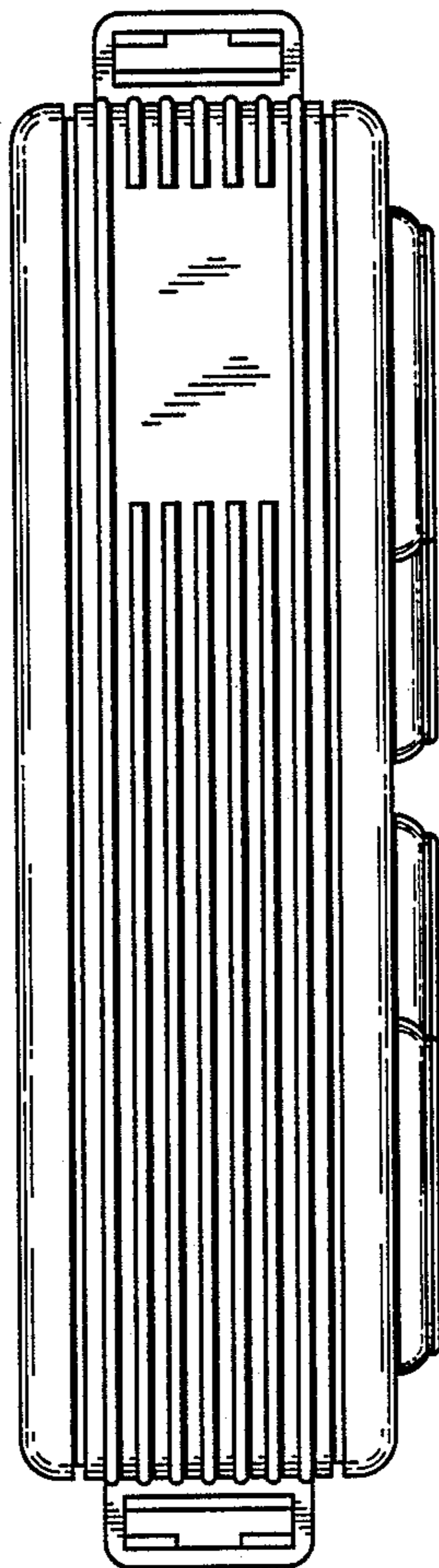

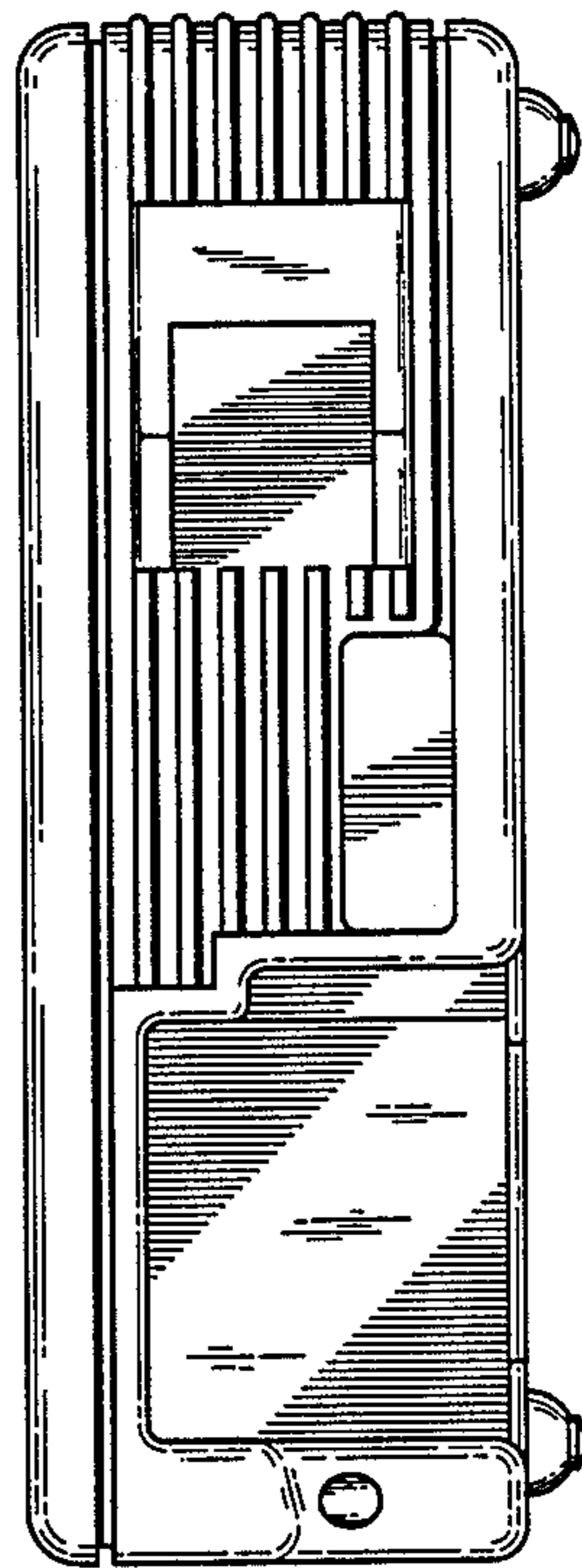




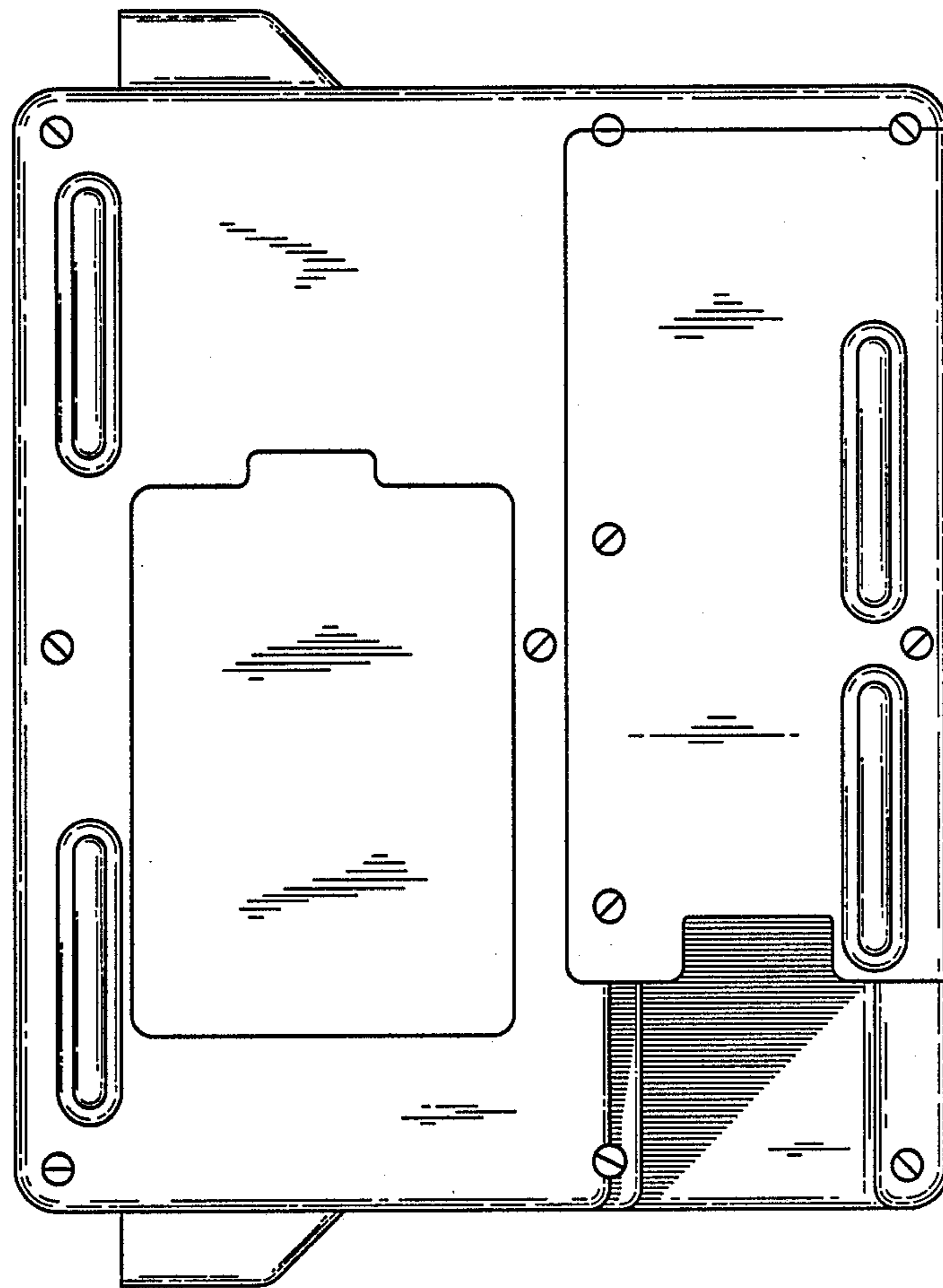
