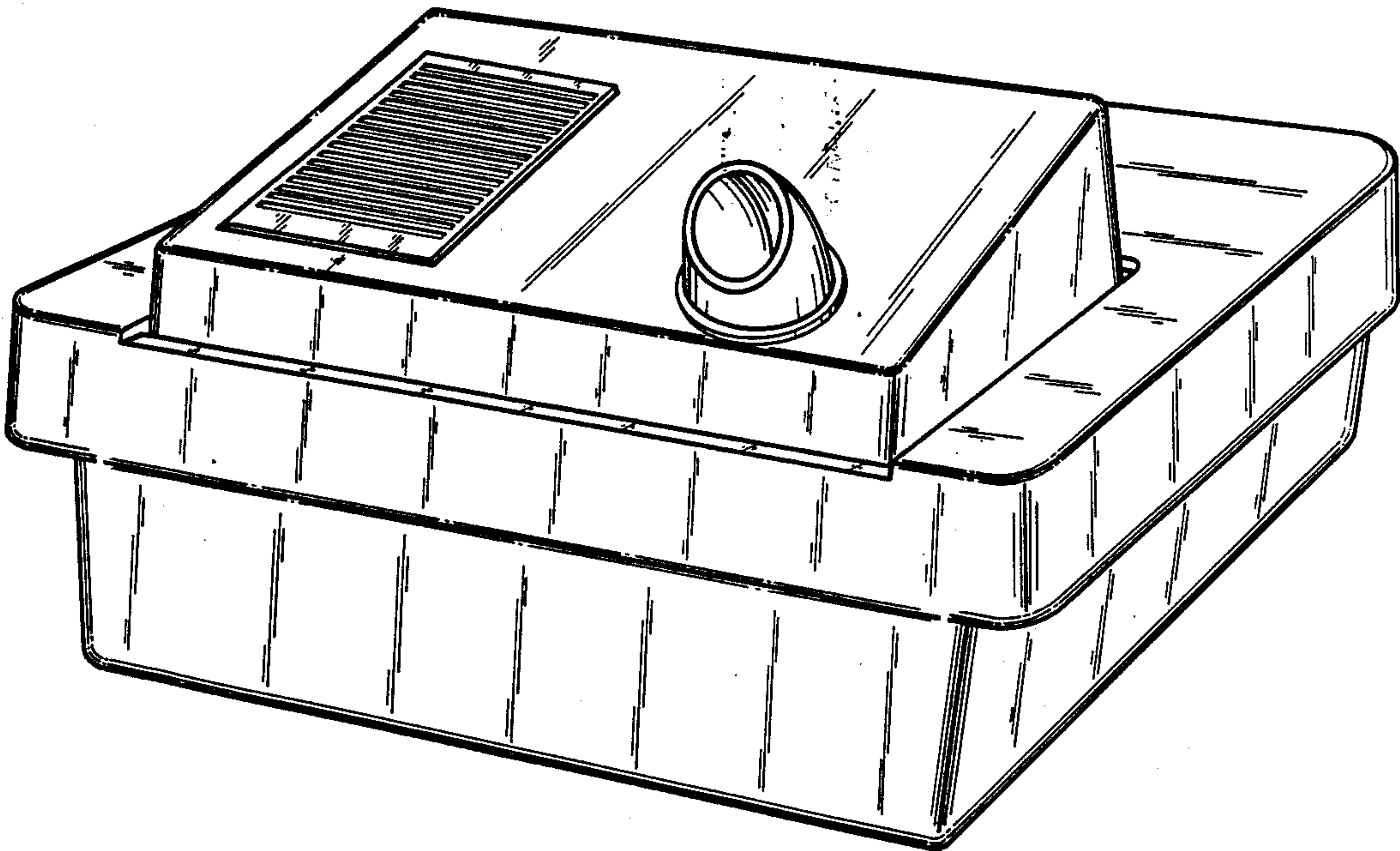

FIG. 7 is a bottom plan view thereof on a further reduced scale.



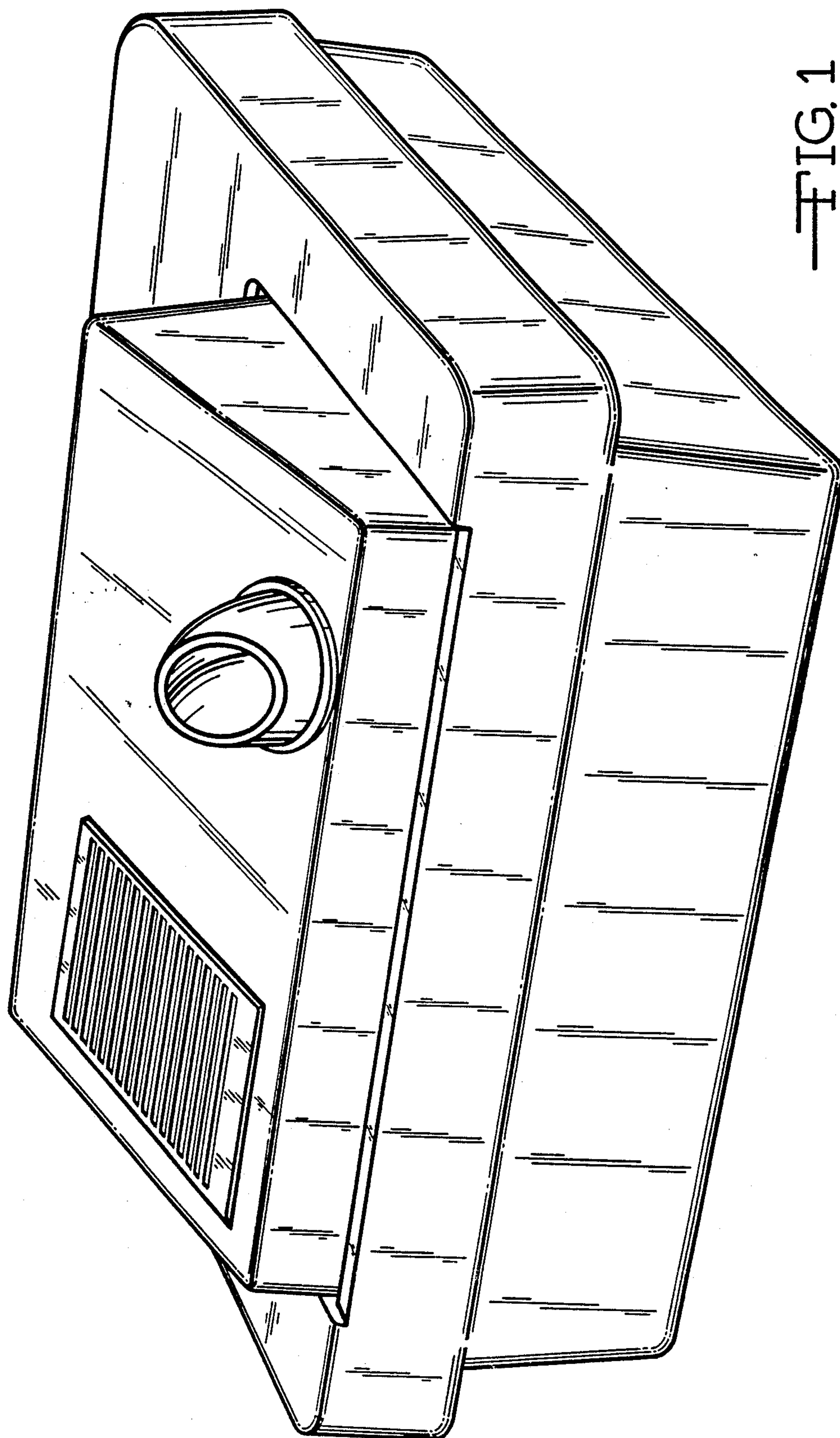

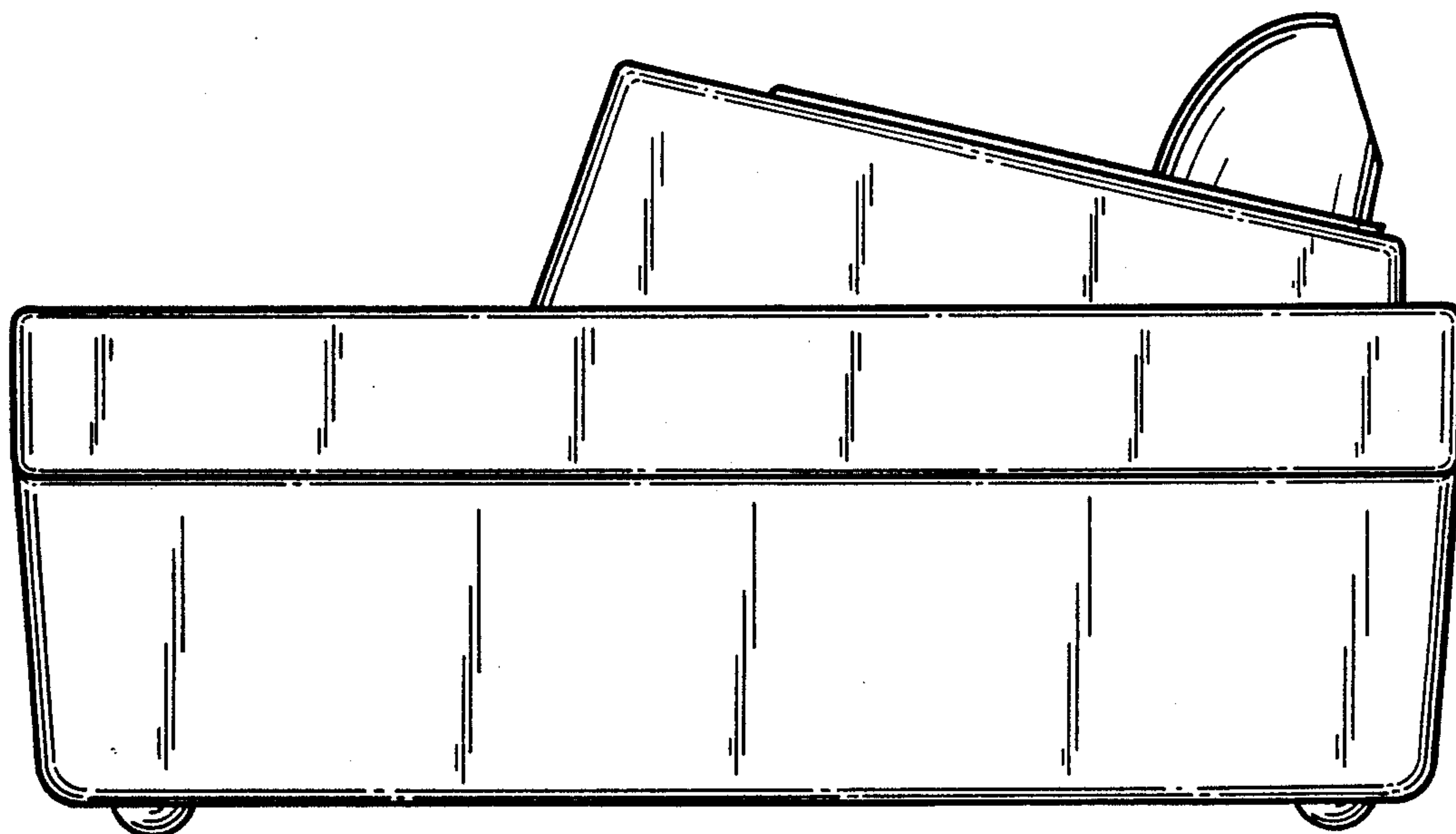

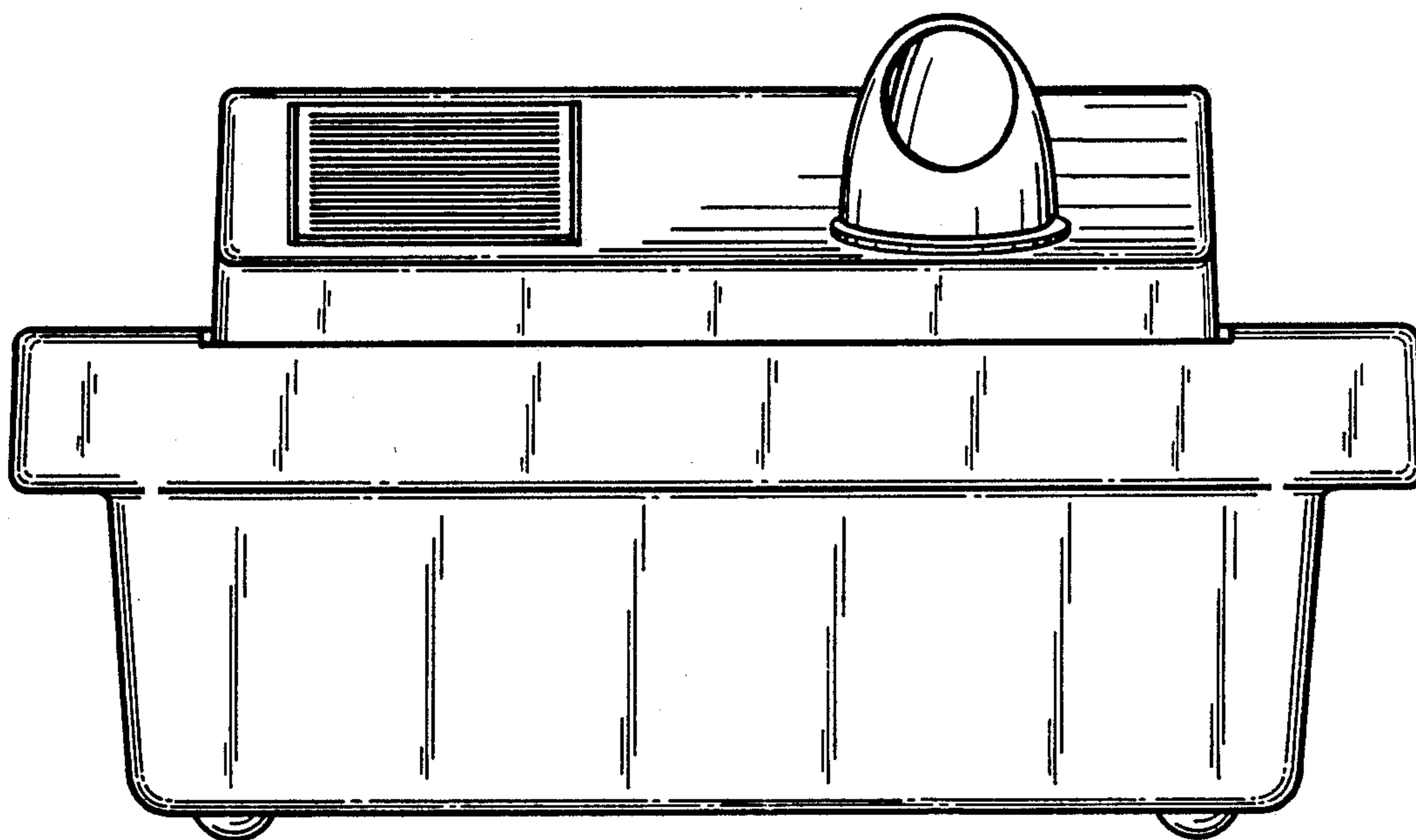

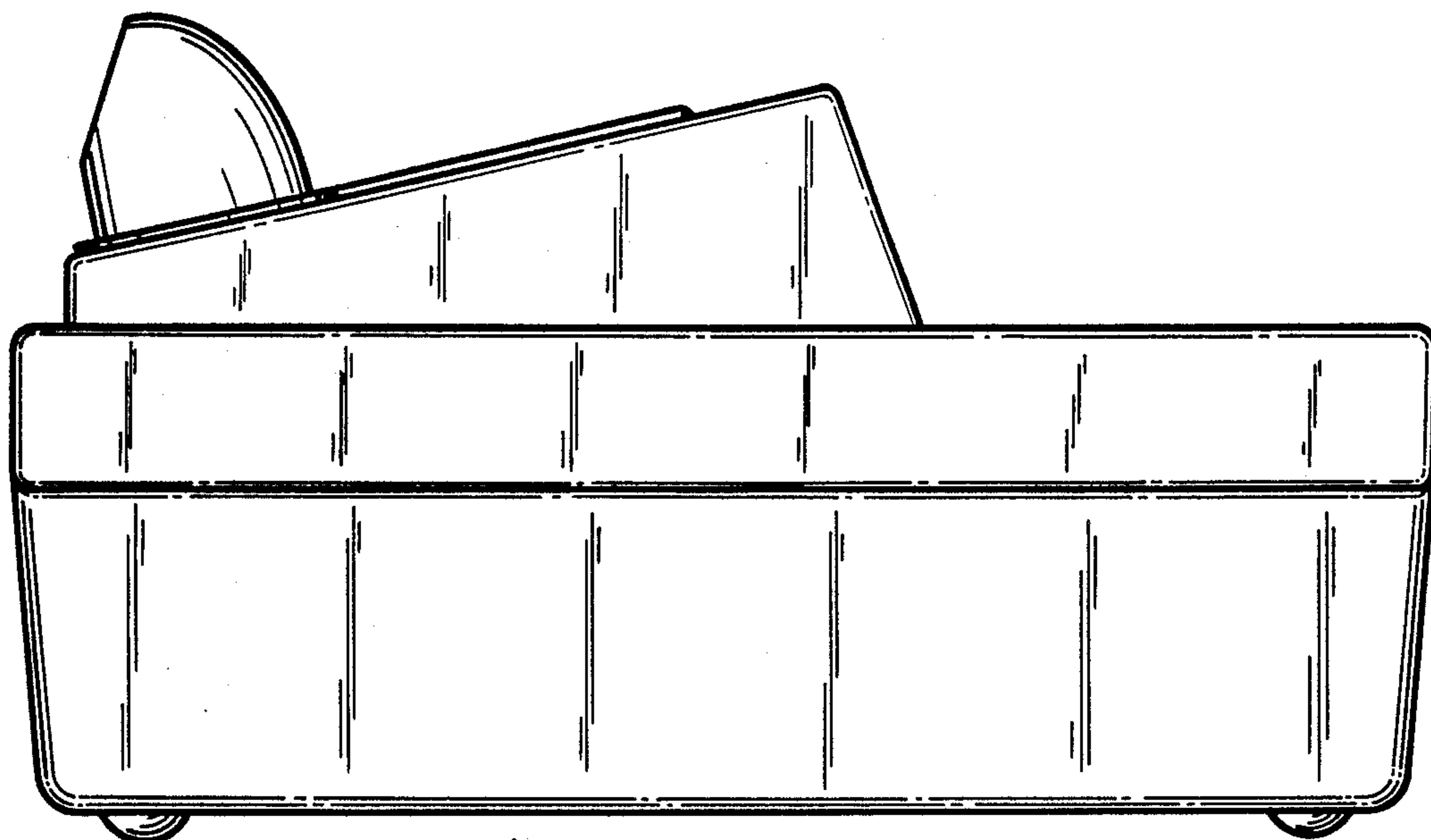

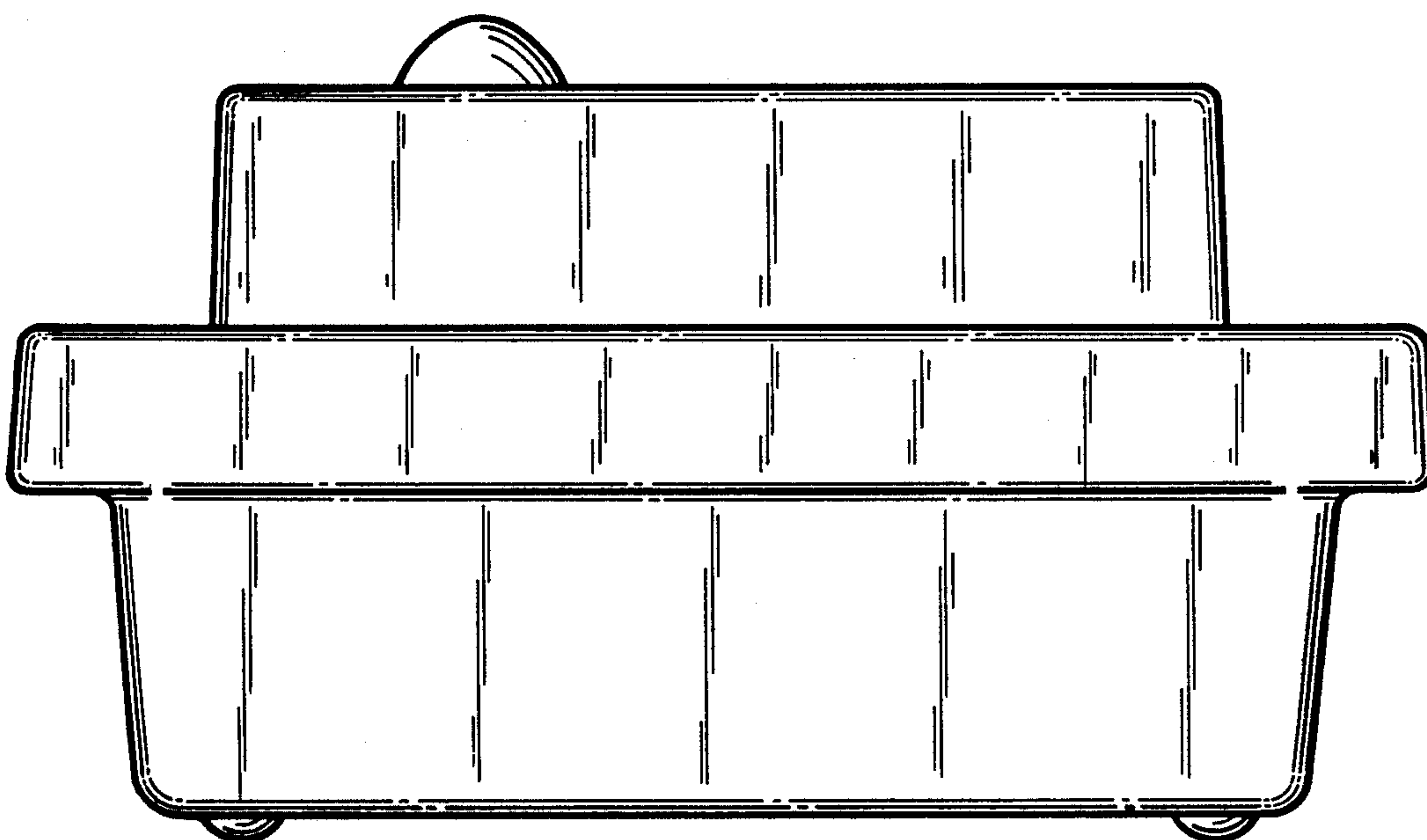

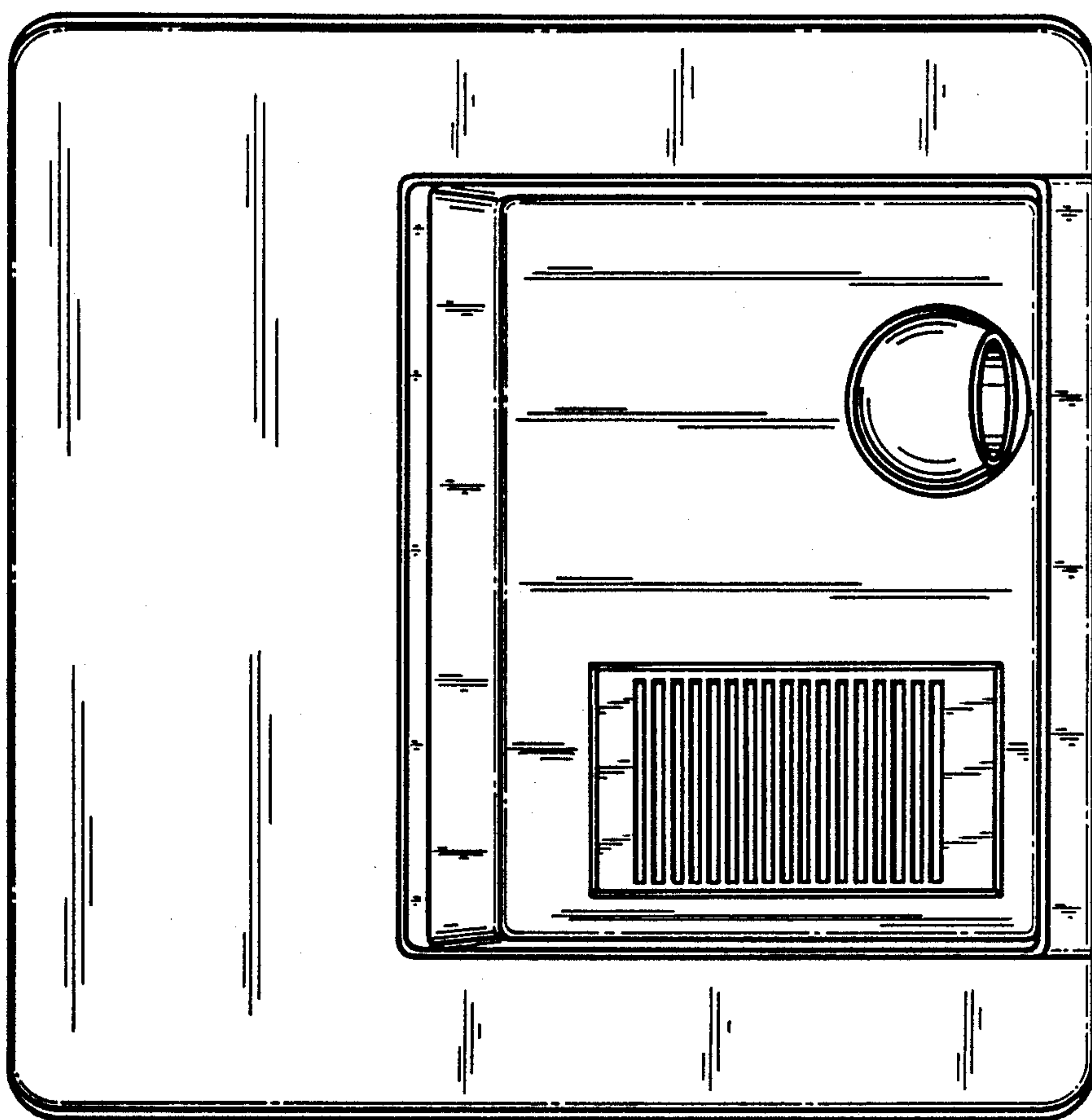

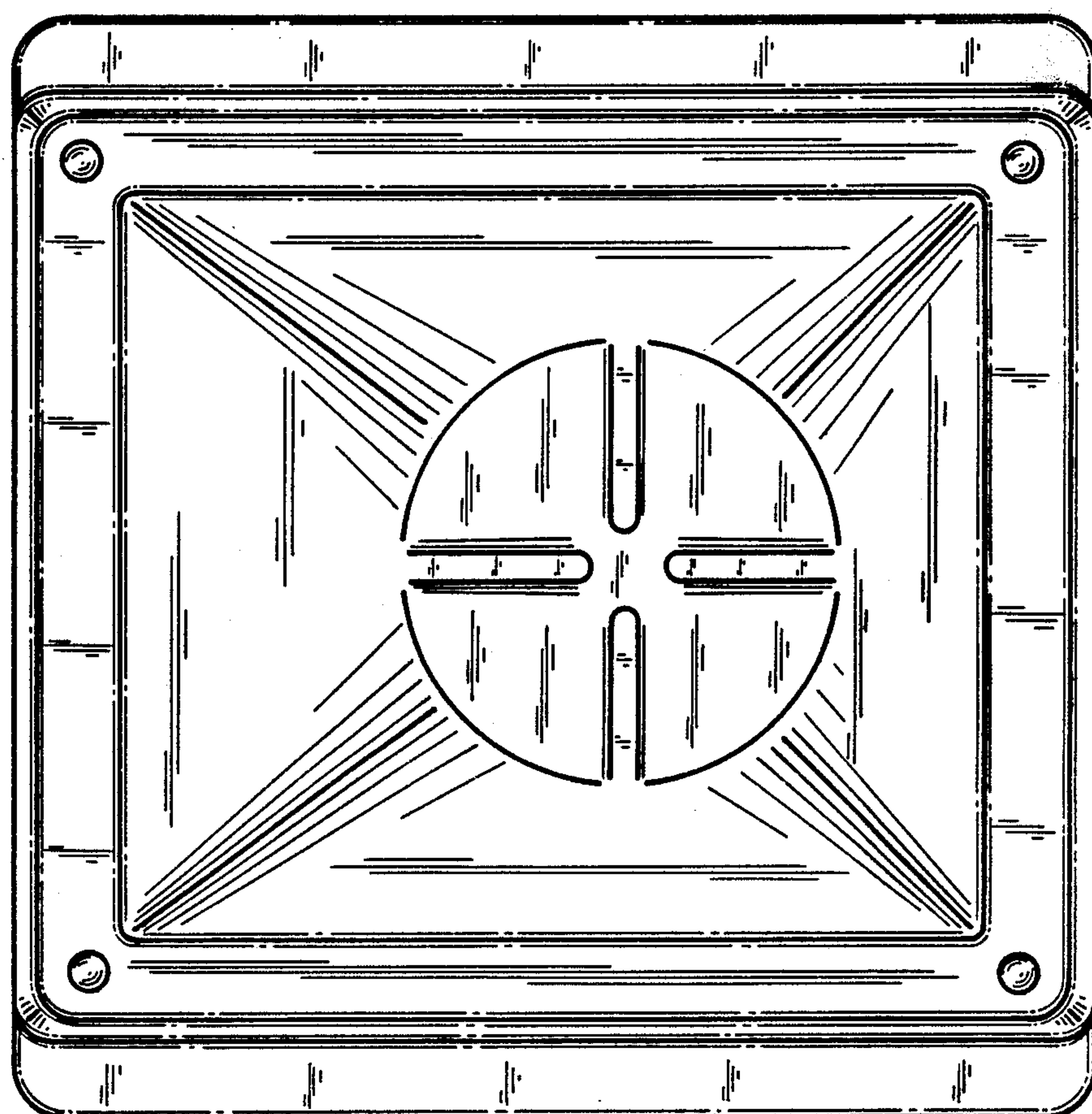
