[57] CLAIM

The ornamental design for a space-divider panel for use primarily in an office, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the space-divider

panel for use primarily in an office, showing our new design, the dotted lines depicting additional wall surface are used for illustrative purposes only;

FIG. 2 is a front elevational view,
 FIG. 3 is a right side elevational view, the left side being a mirror image thereof,
 FIG. 4 is a top plan view,
 FIG. 5 is a bottom plan view,
 FIG. 6 is an enlarged fragmentary sectional view taken along line 6—6 in FIG. 2,
 FIG. 7 is an enlarged fragmentary sectional view taken along line 7—7 in FIG. 2,
 FIG. 8 is a front elevational view of a second embodiment,
 FIG. 9 is a front elevational view of a third embodiment,
 FIG. 10 is a front elevational view of a fourth embodiment,
 FIG. 11 is a front elevational view of a fifth embodiment,
 FIG. 12 is a front elevational view of a sixth embodiment,
 FIG. 13 is a front elevational view of a seventh embodiment,
 FIG. 14 is a front elevational view of an eighth embodiment;
 FIG. 15 is a front elevational view of a ninth embodiment,
 FIG. 16 is a front elevational view of a tenth embodiment,
 FIG. 17 is a front elevational view of an eleventh embodiment,
 FIG. 18 is a front elevational view of a twelfth embodiment,
 FIG. 19 is a front elevational view of a thirteenth embodiment; and
 FIG. 20 is a front elevational view of a fourteenth embodiment thereof.
 With respect to FIGS. 8-20, the rear elevational view is a mirror image of the front elevational view, and the left side, right side, top and bottom views substantially correspond to FIGS. 3-5.

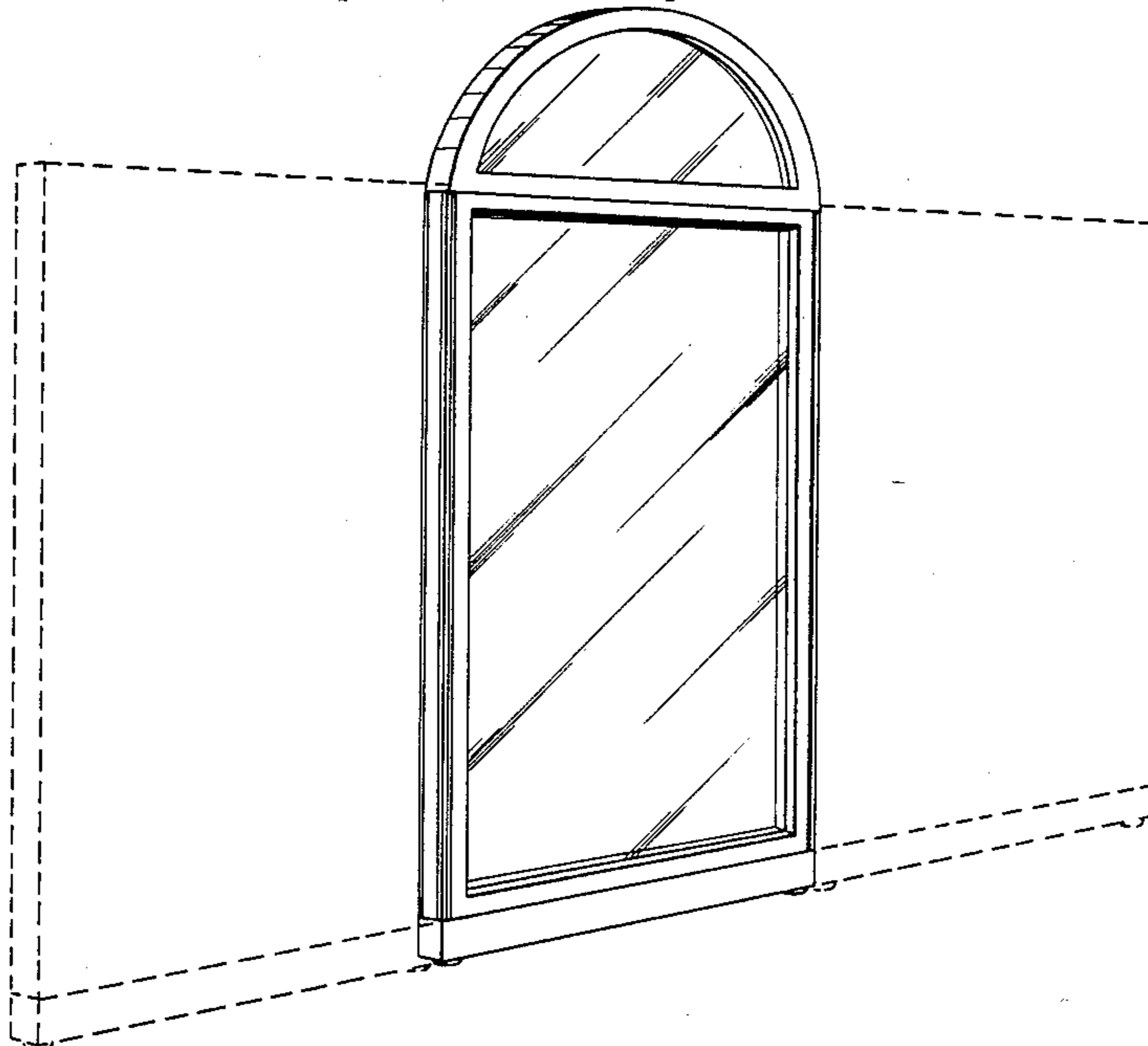

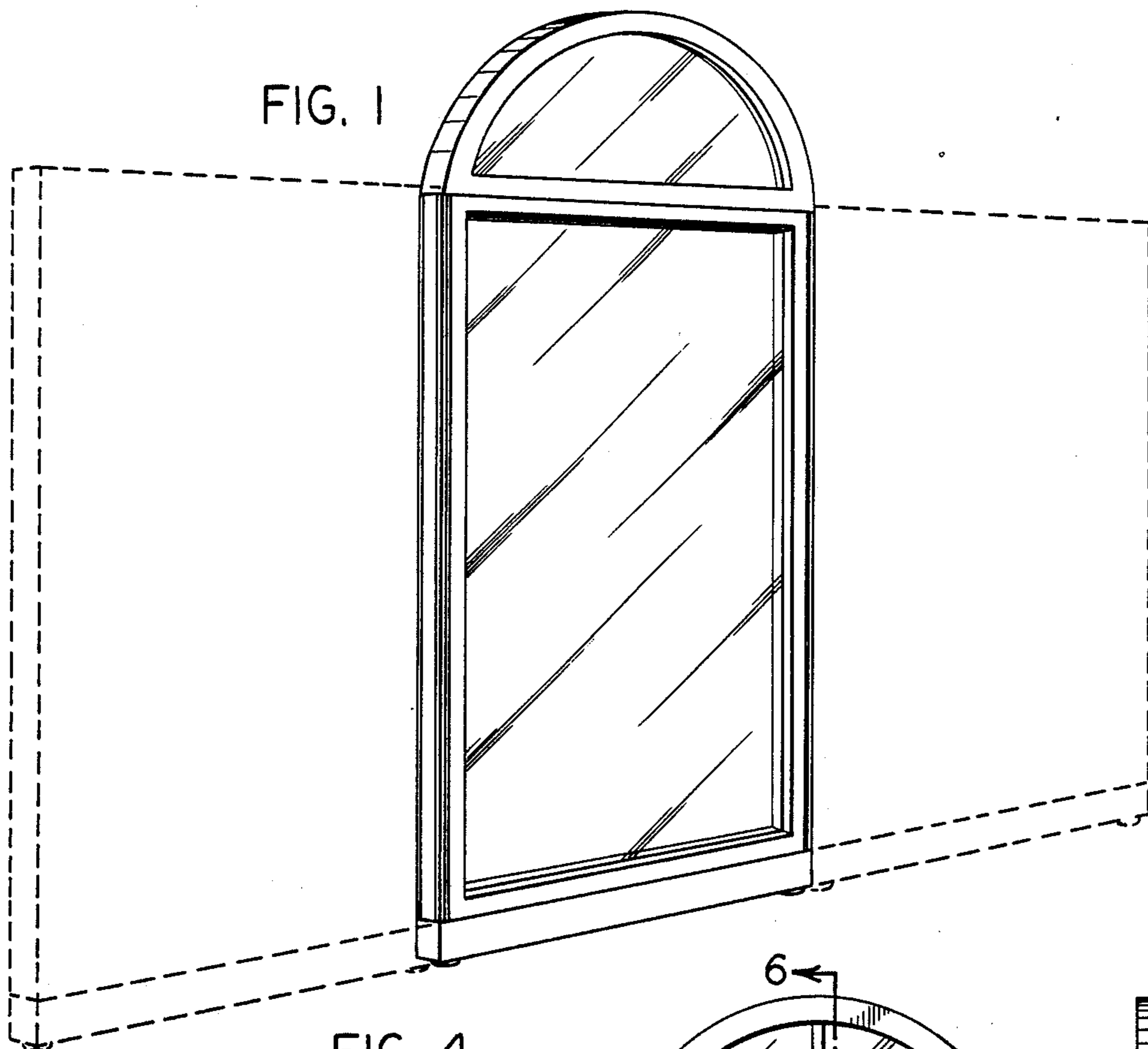

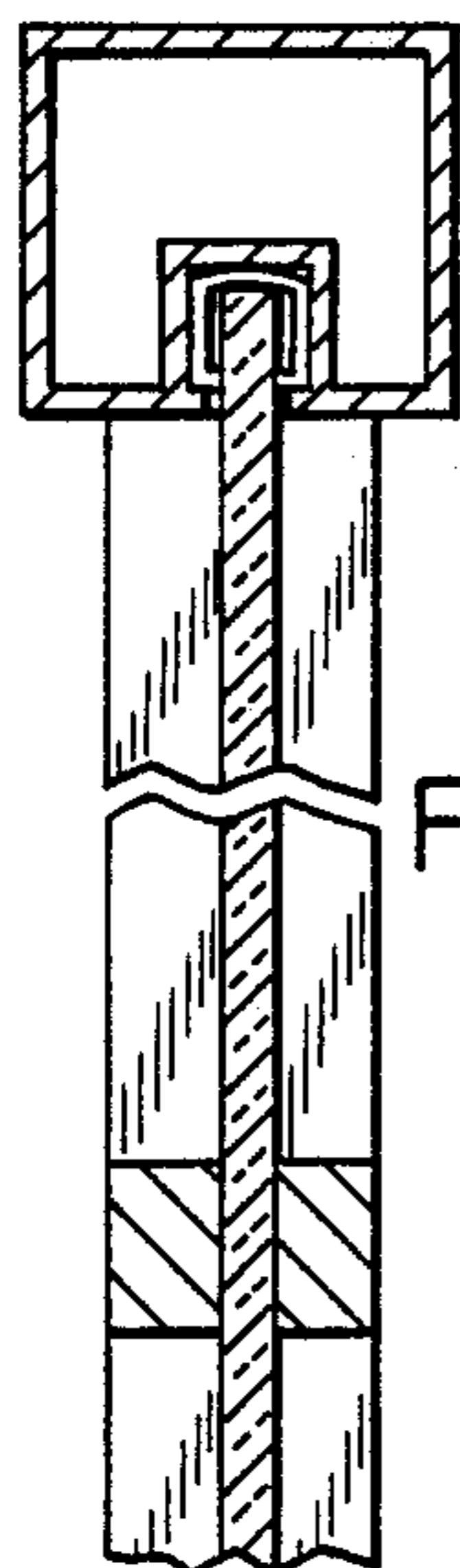

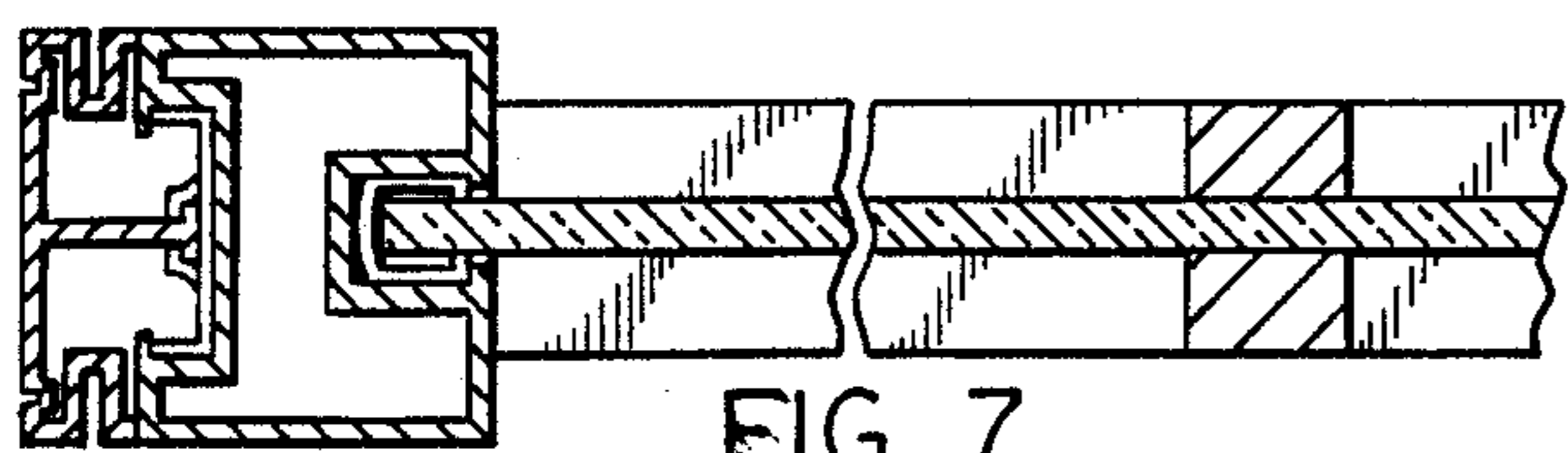

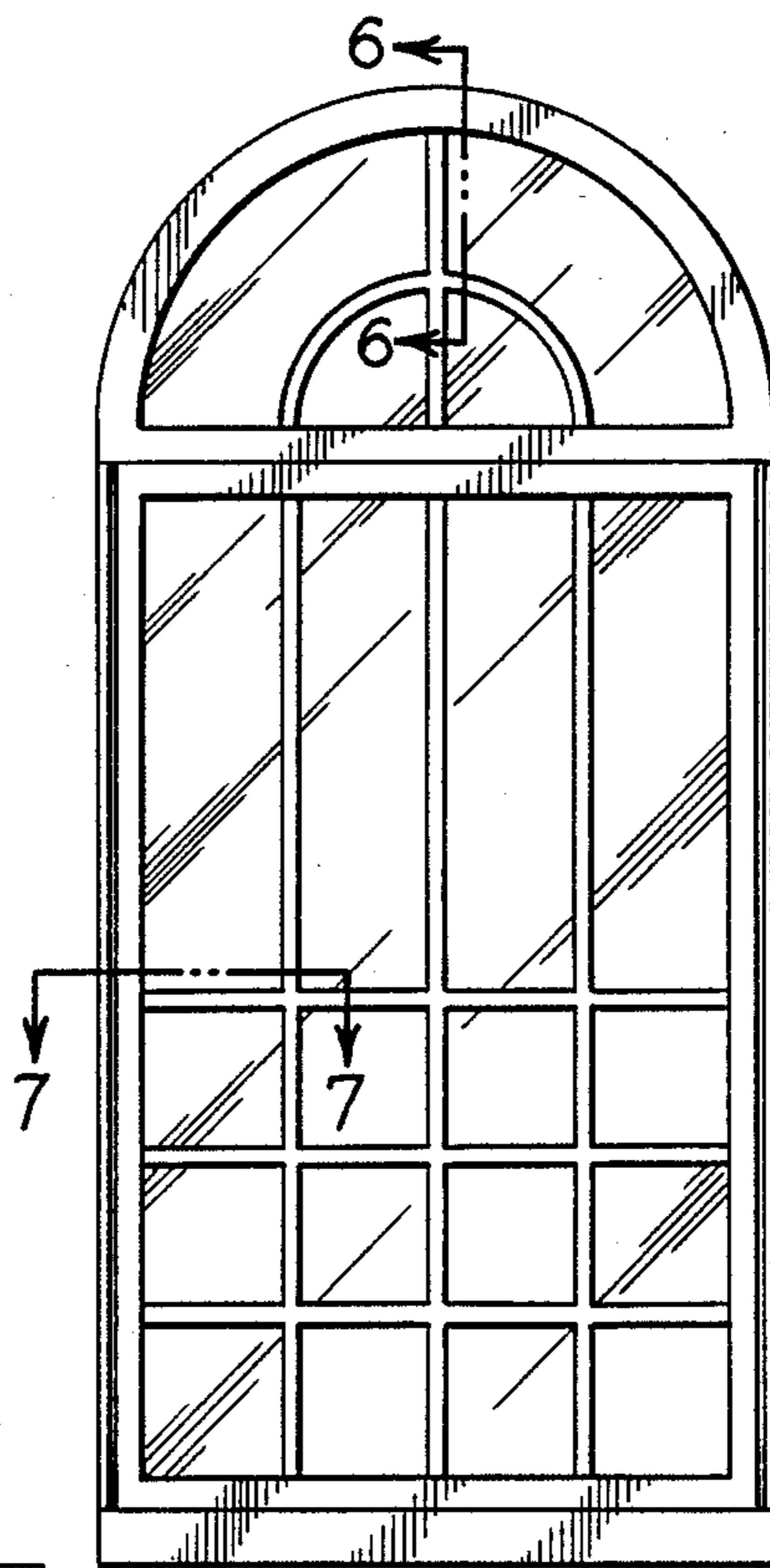

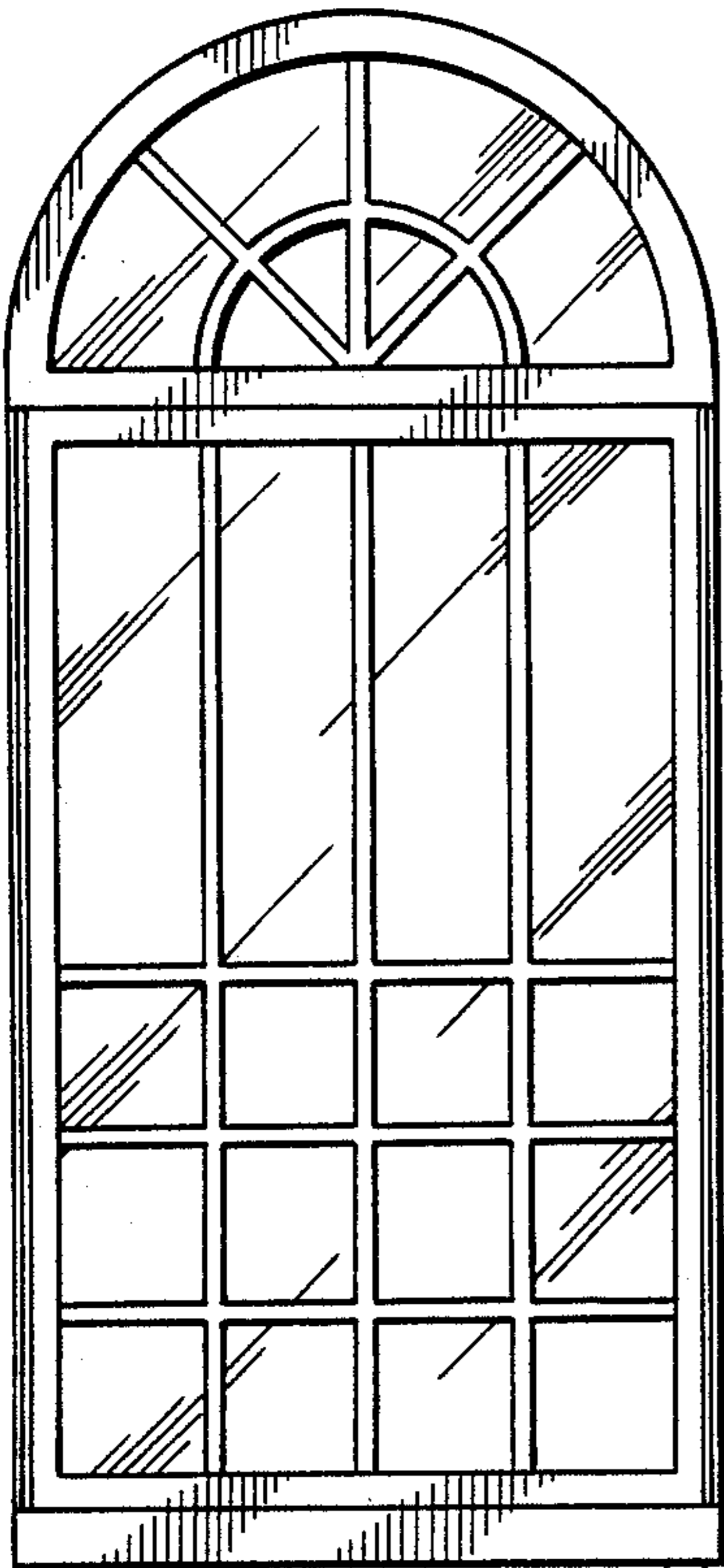

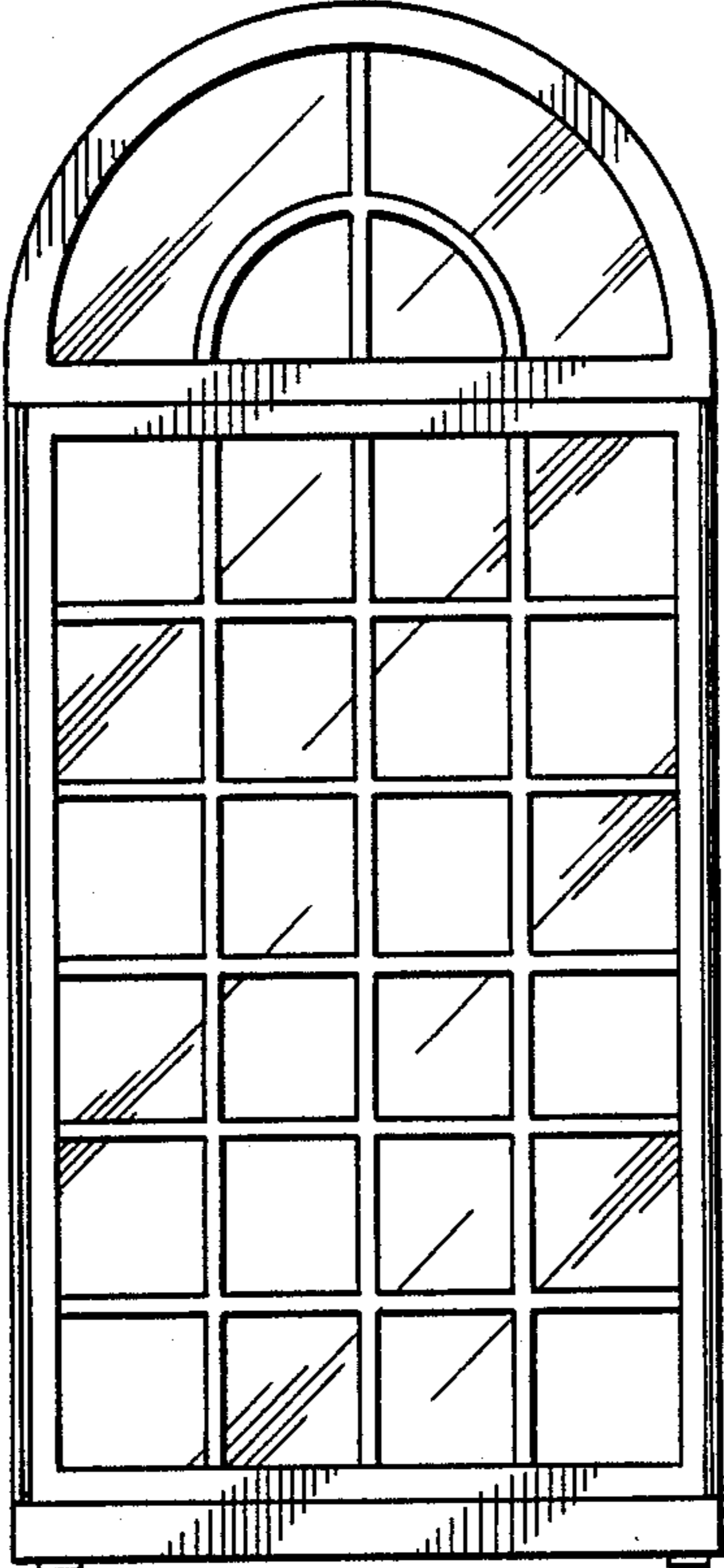

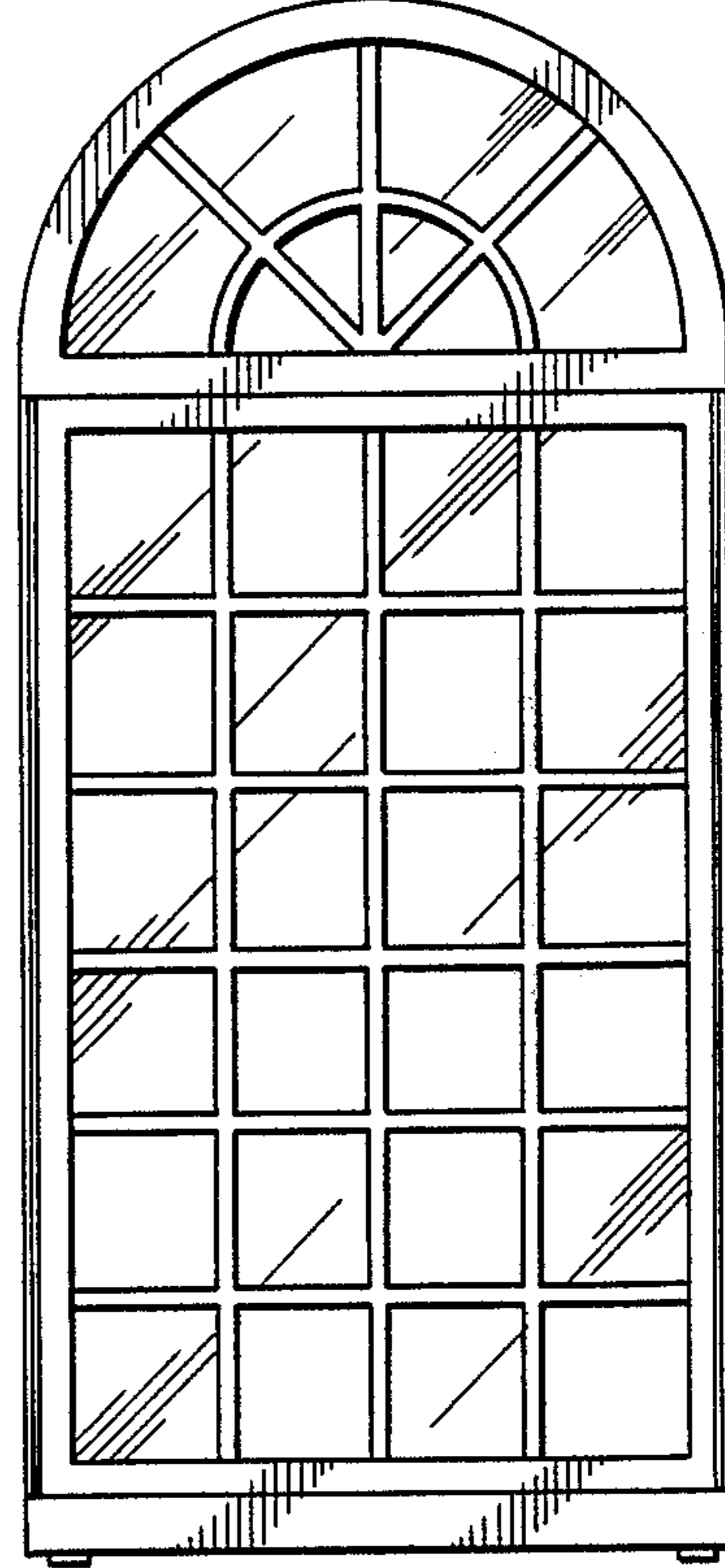

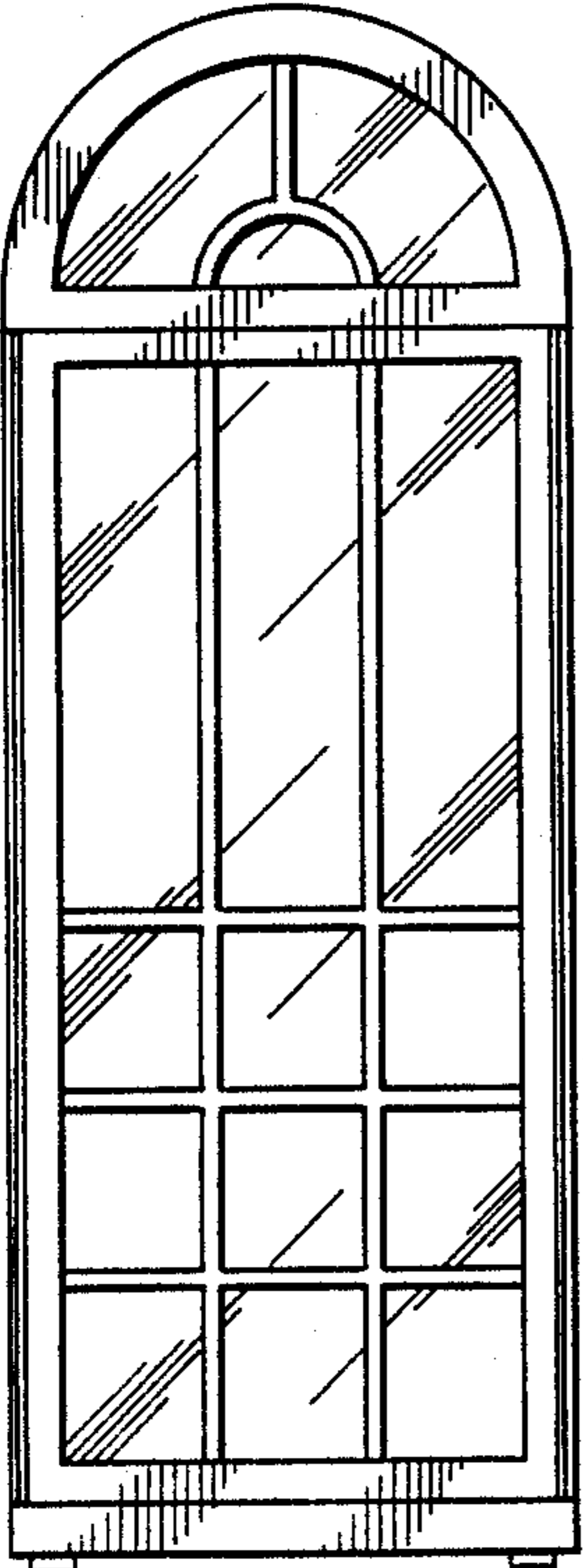

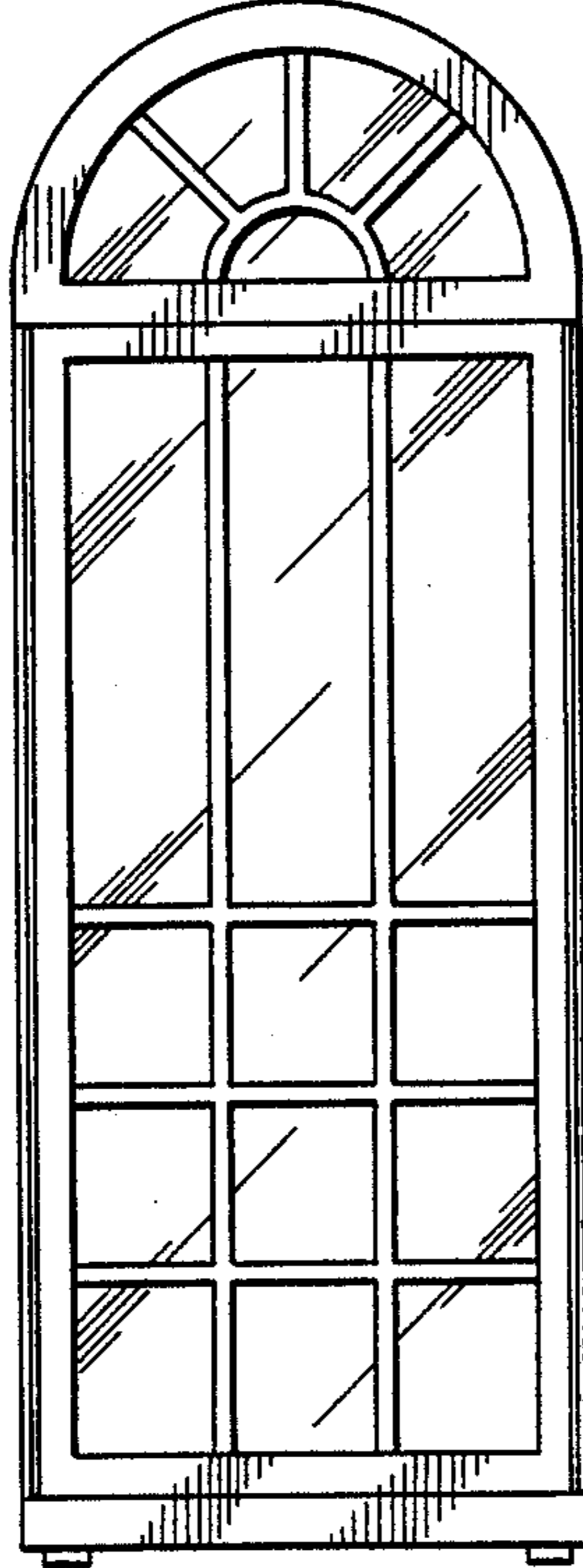

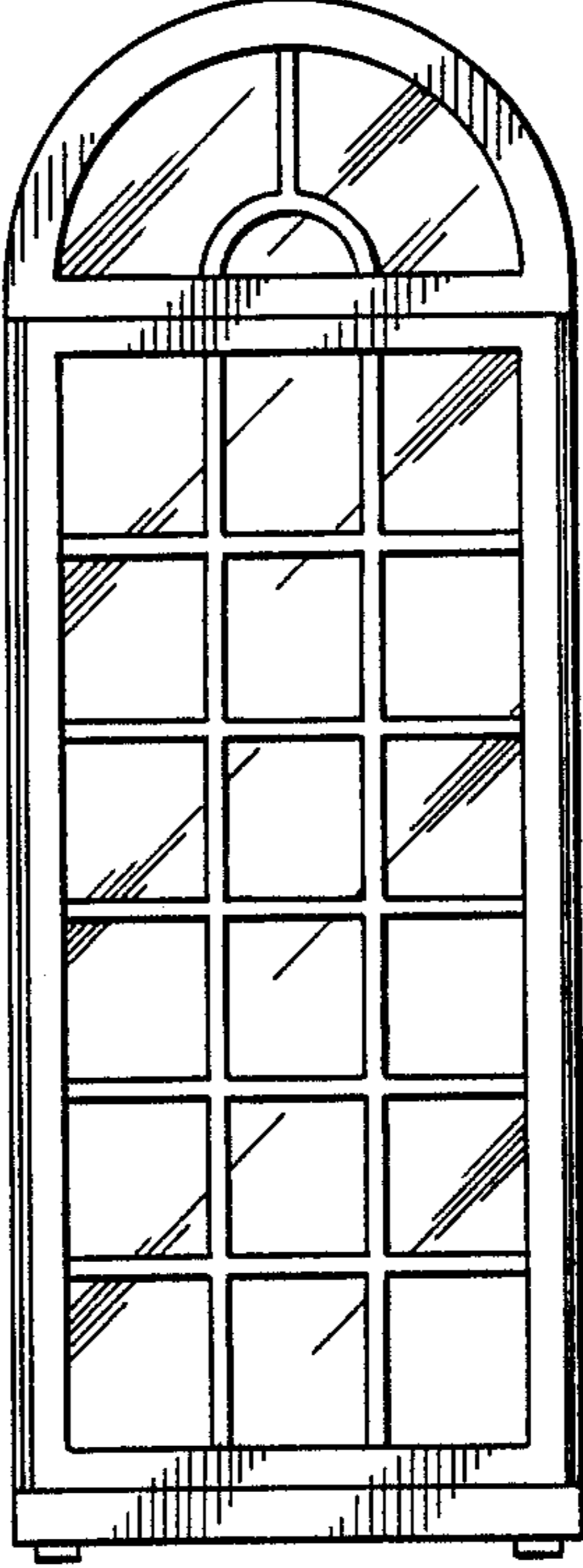

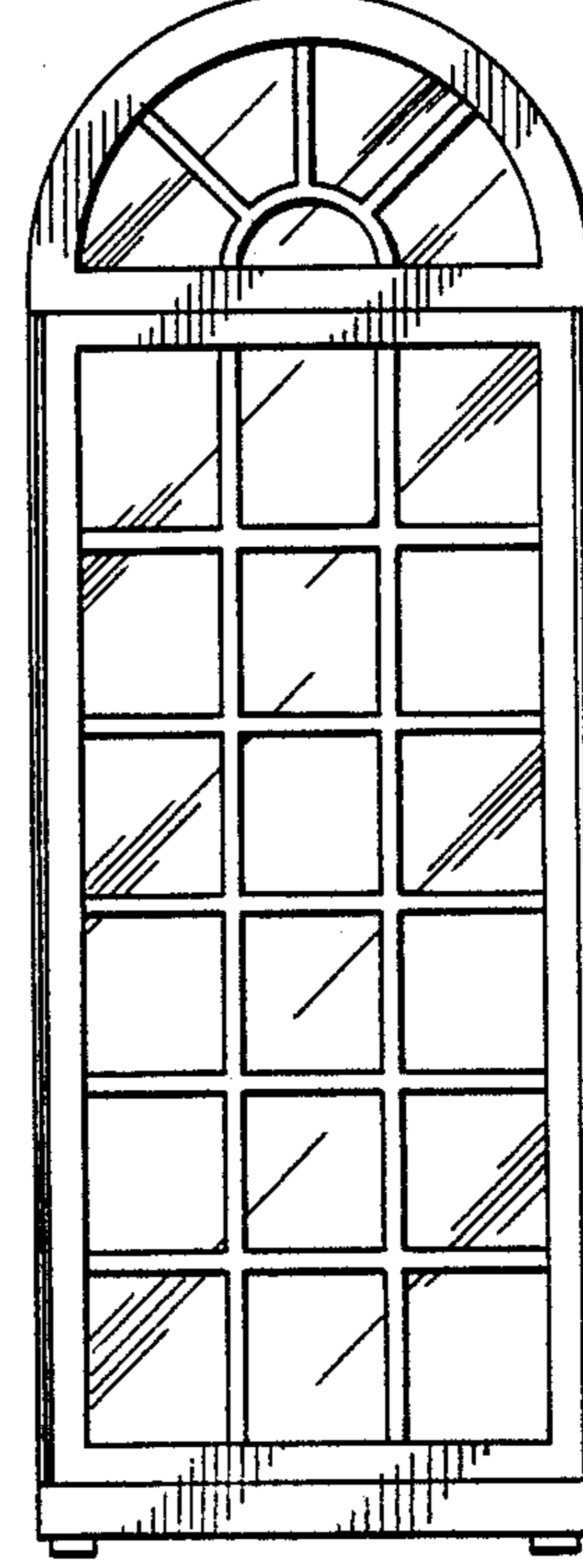

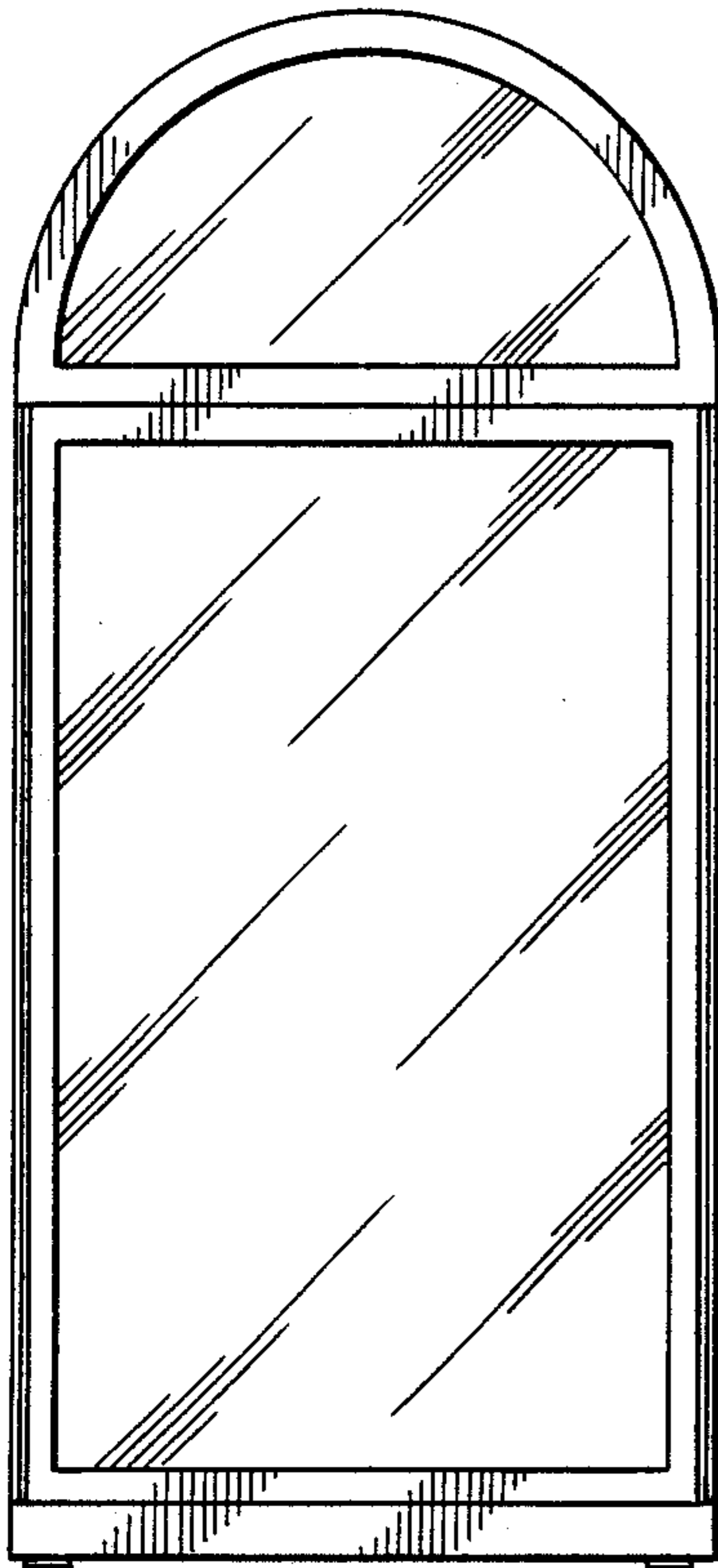

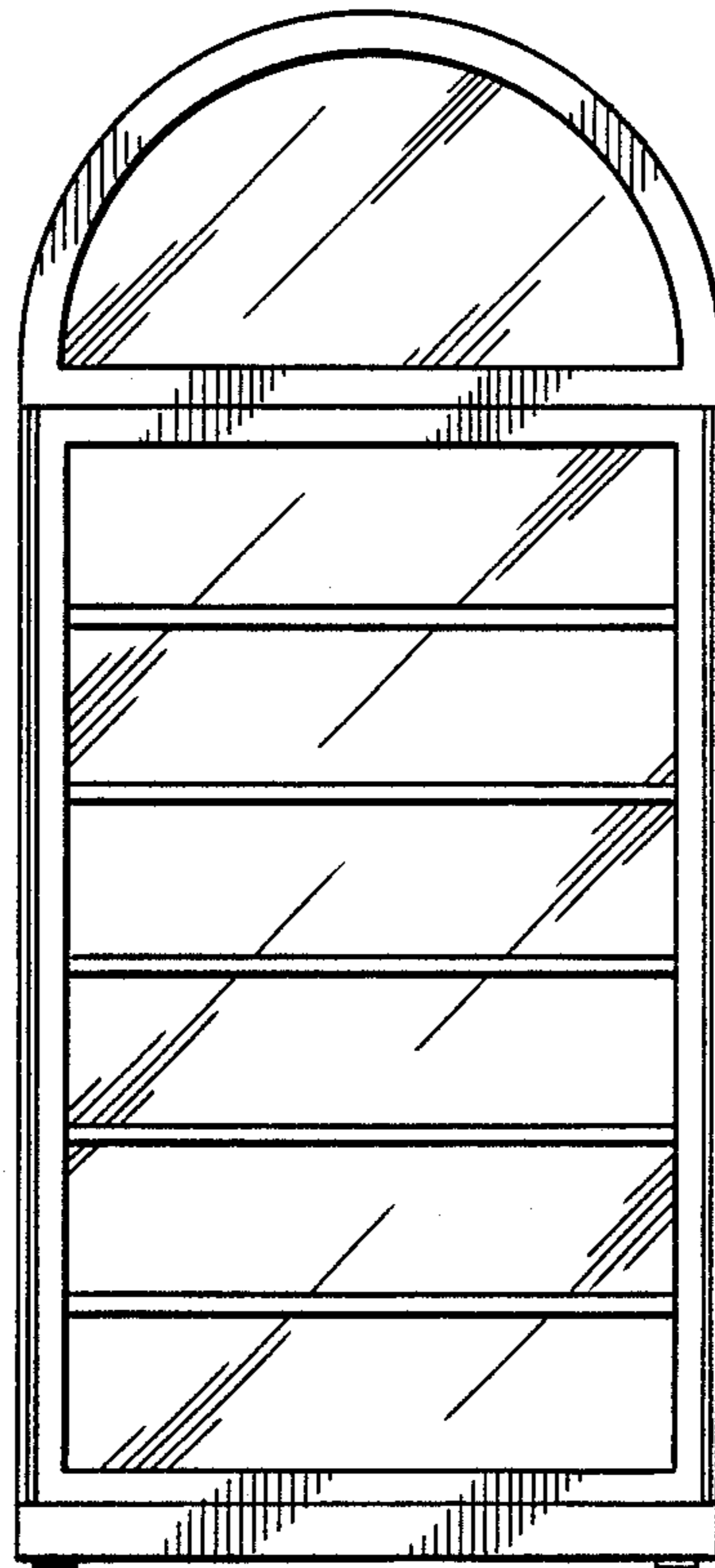

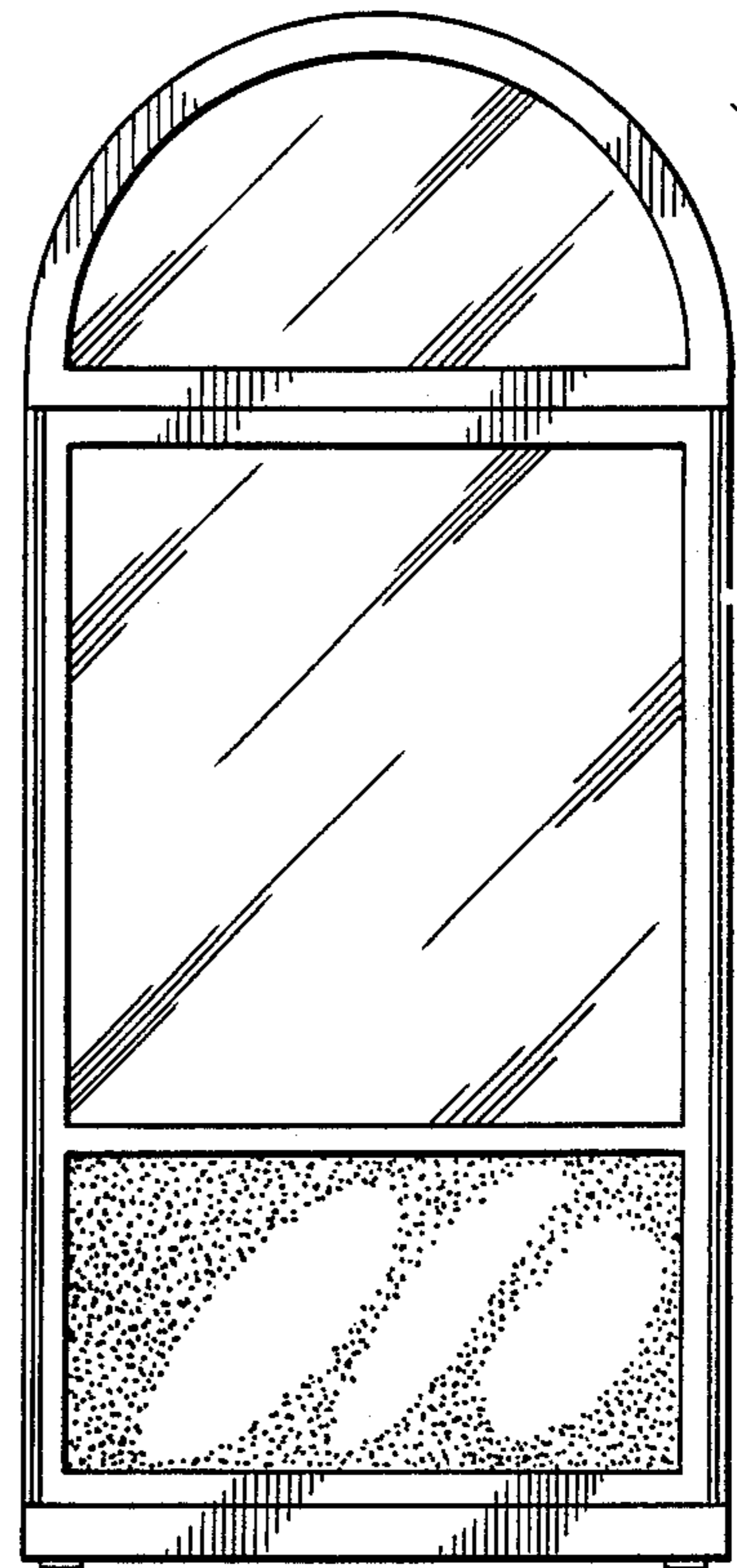

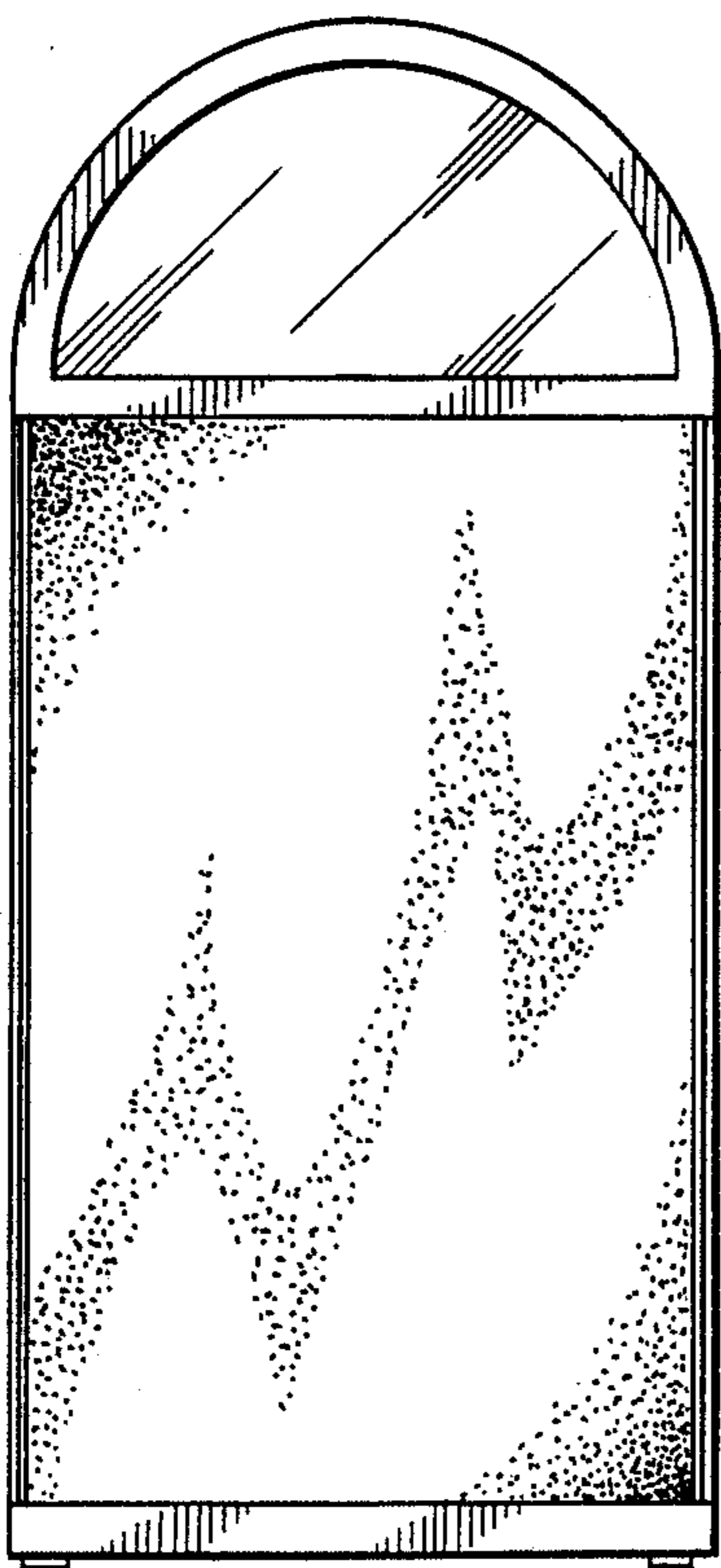

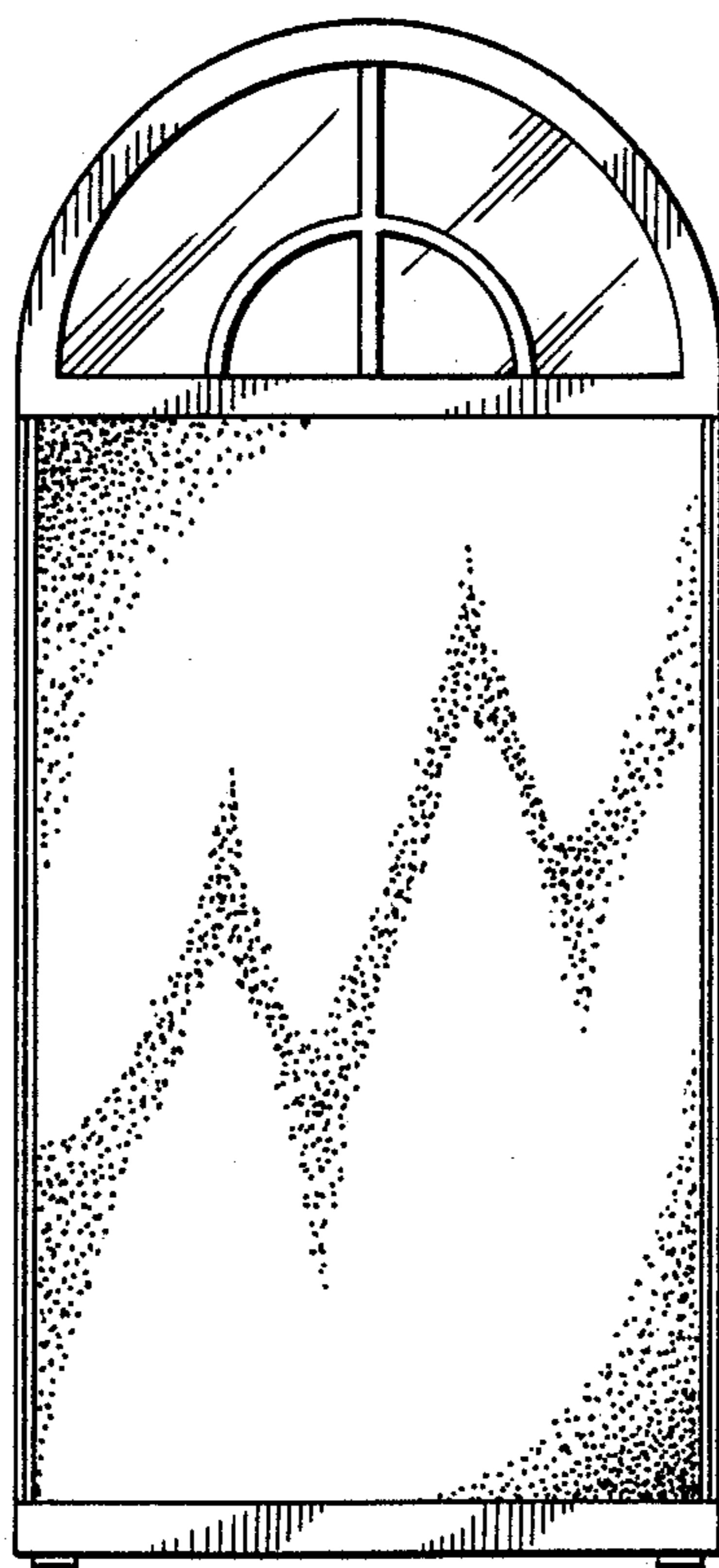

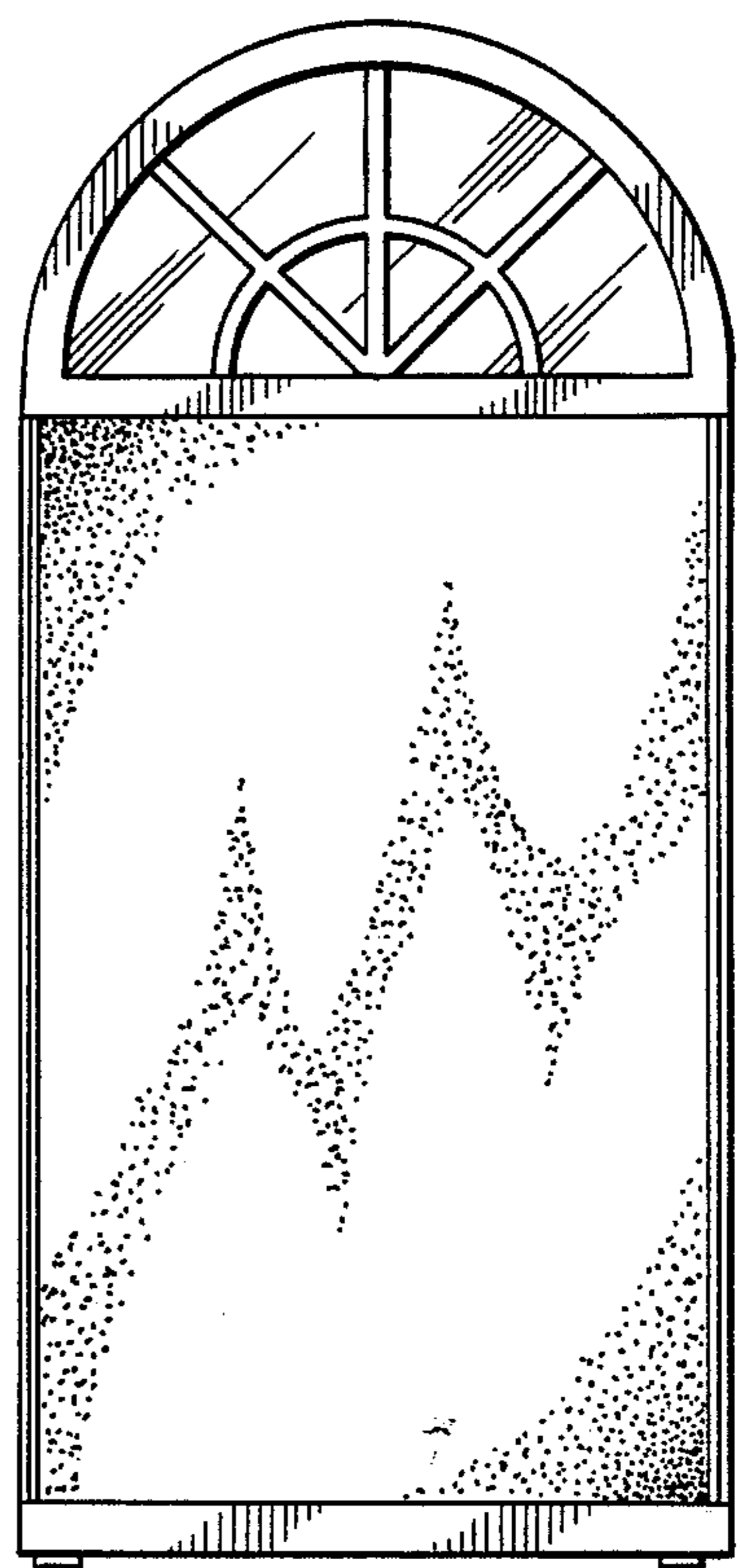
