[57] CLAIM

The ornamental design for a strap for a wristwatch, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a strap for a wristwatch showing my new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a perspective view thereof;
FIG. 8 is a front elevational view of a first modified embodiment of the strap for wristwatch shown in FIG. 1;
FIG. 9 is a right side elevational view thereof;

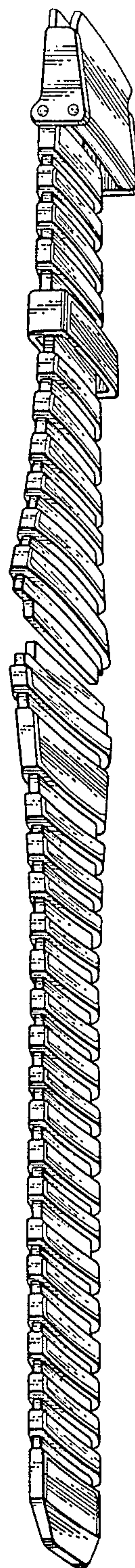


FIG. 10 FIG. 8

FIG. 10 is a left side elevational view thereof;
FIG. 11 is a top plan view thereof;
FIG. 12 is a bottom plan view thereof;
FIG. 13 is a rear elevational view thereof;
FIG. 14 is a perspective view thereof;
FIG. 15 is a front elevational view of a second modified embodiment of the strap for wrist watch shown in FIG. 1;
FIG. 16 is a right side elevational view thereof;
FIG. 17 is a left side elevational view;
FIG. 18 is a top plan view thereof;
FIG. 19 is a bottom plan elevational view thereof;
FIG. 20 is a rear elevational view thereof; and
FIG. 21 is a perspective view thereof.

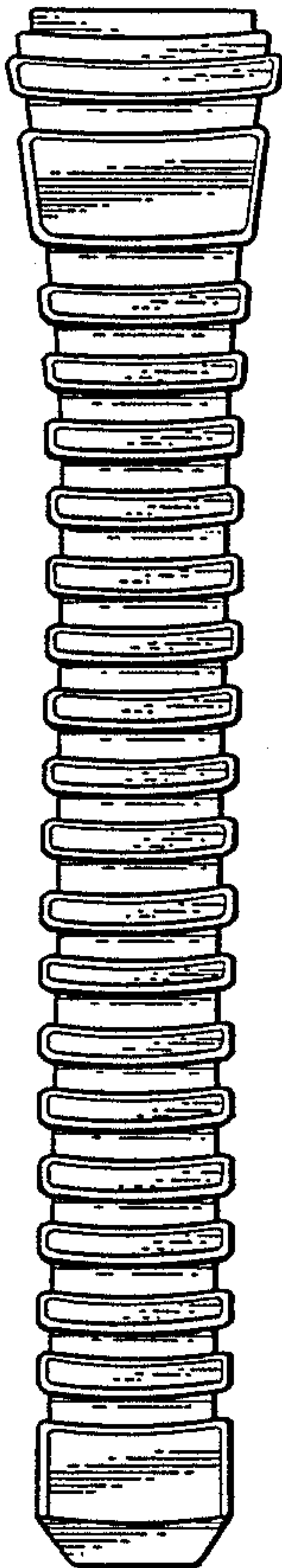
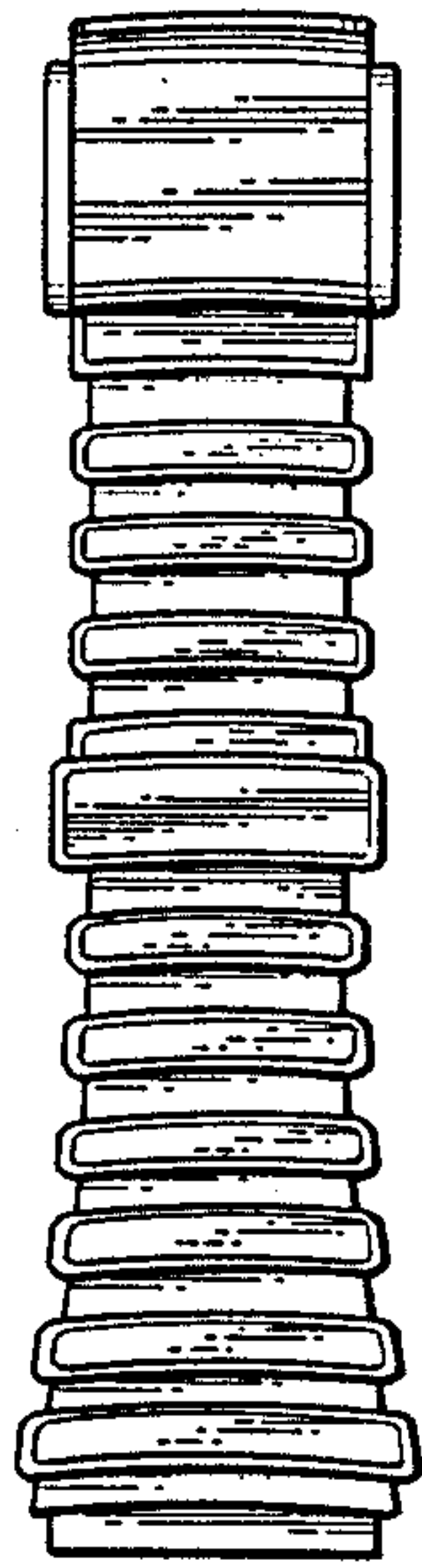

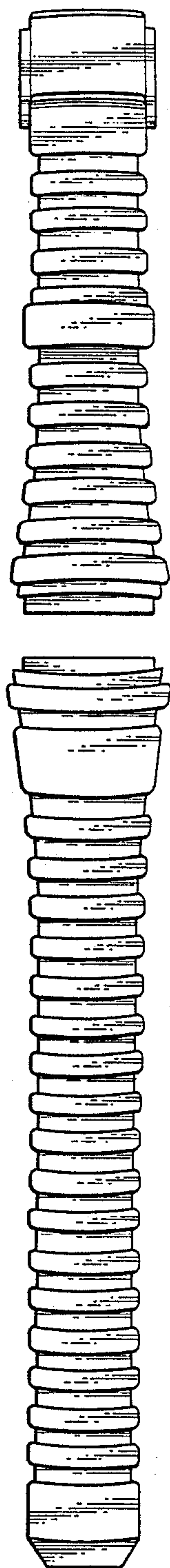

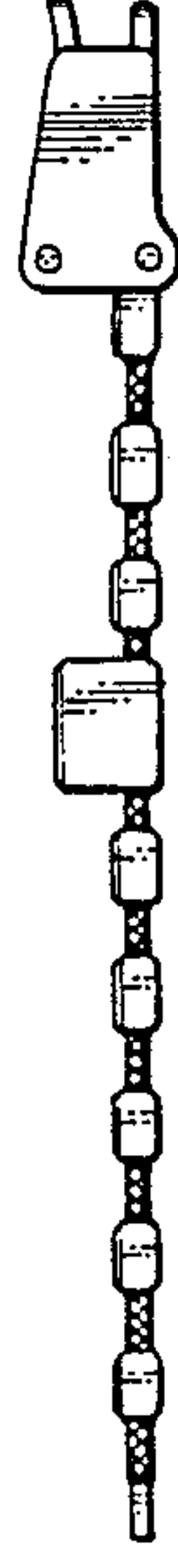
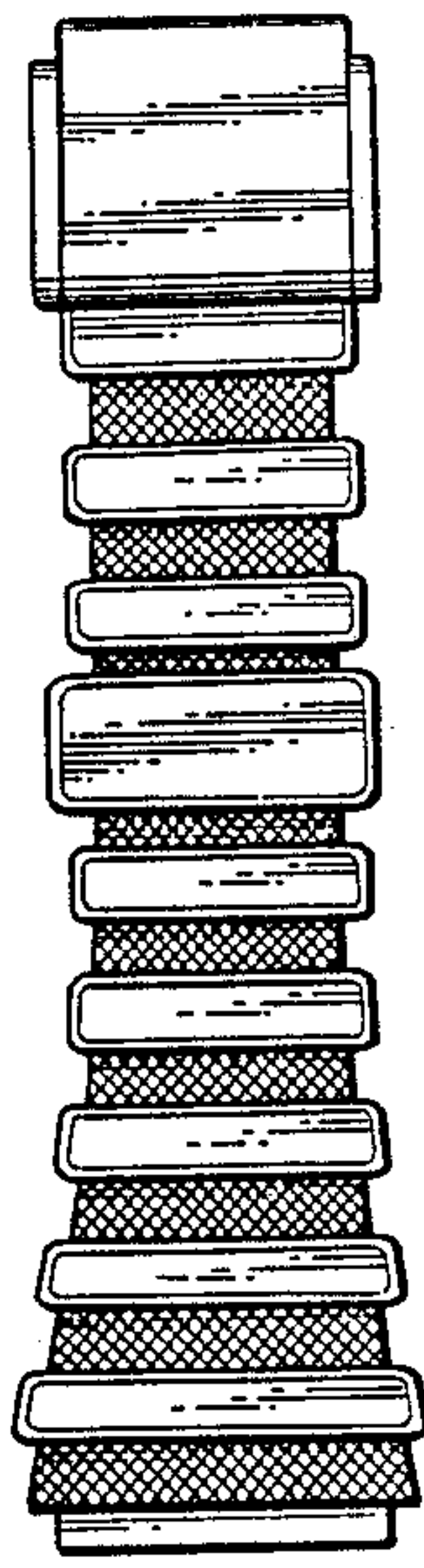
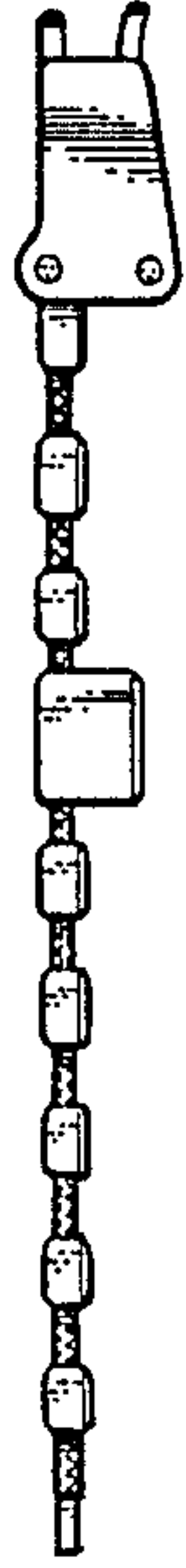

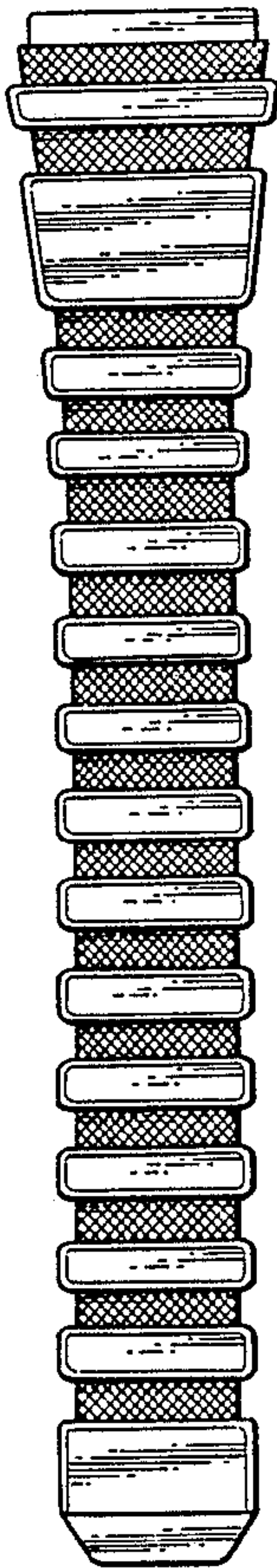

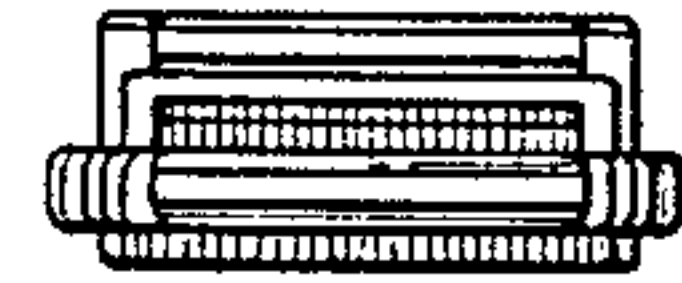

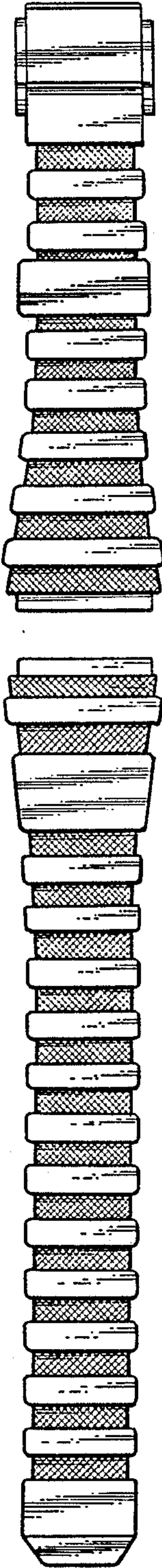
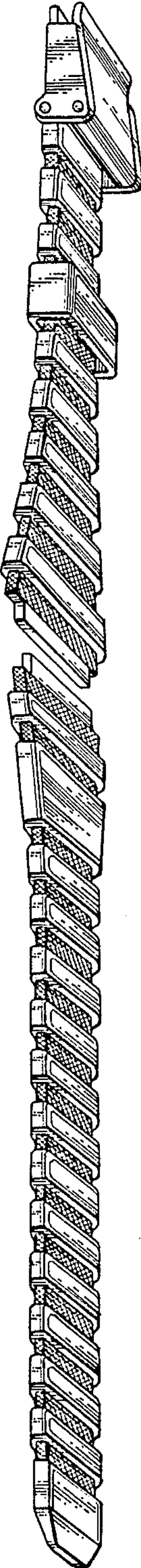
