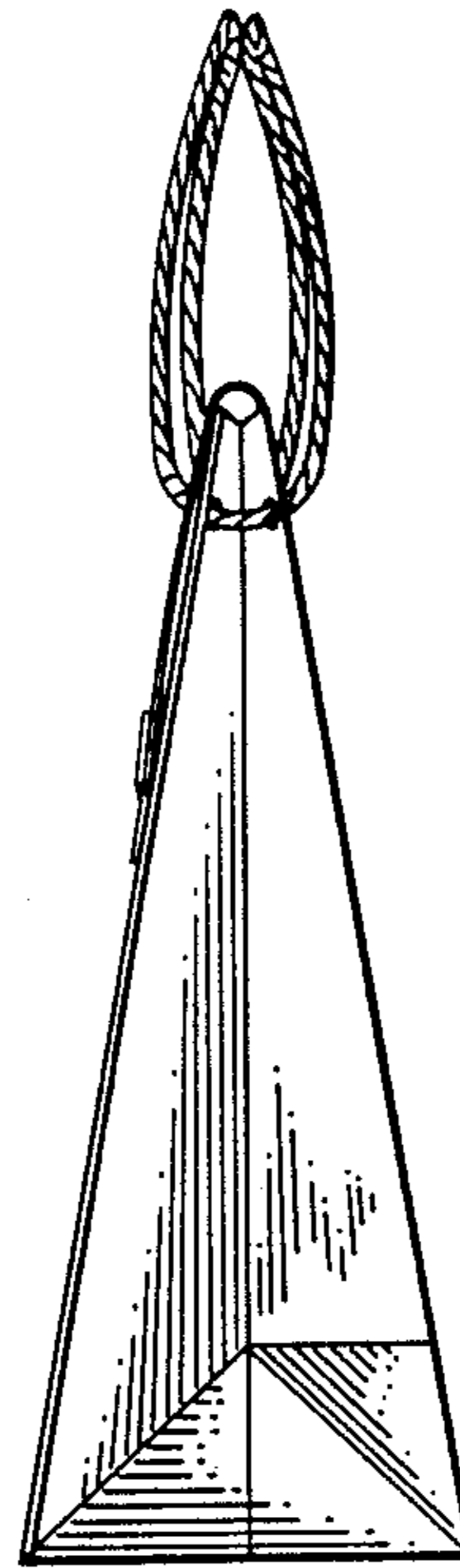
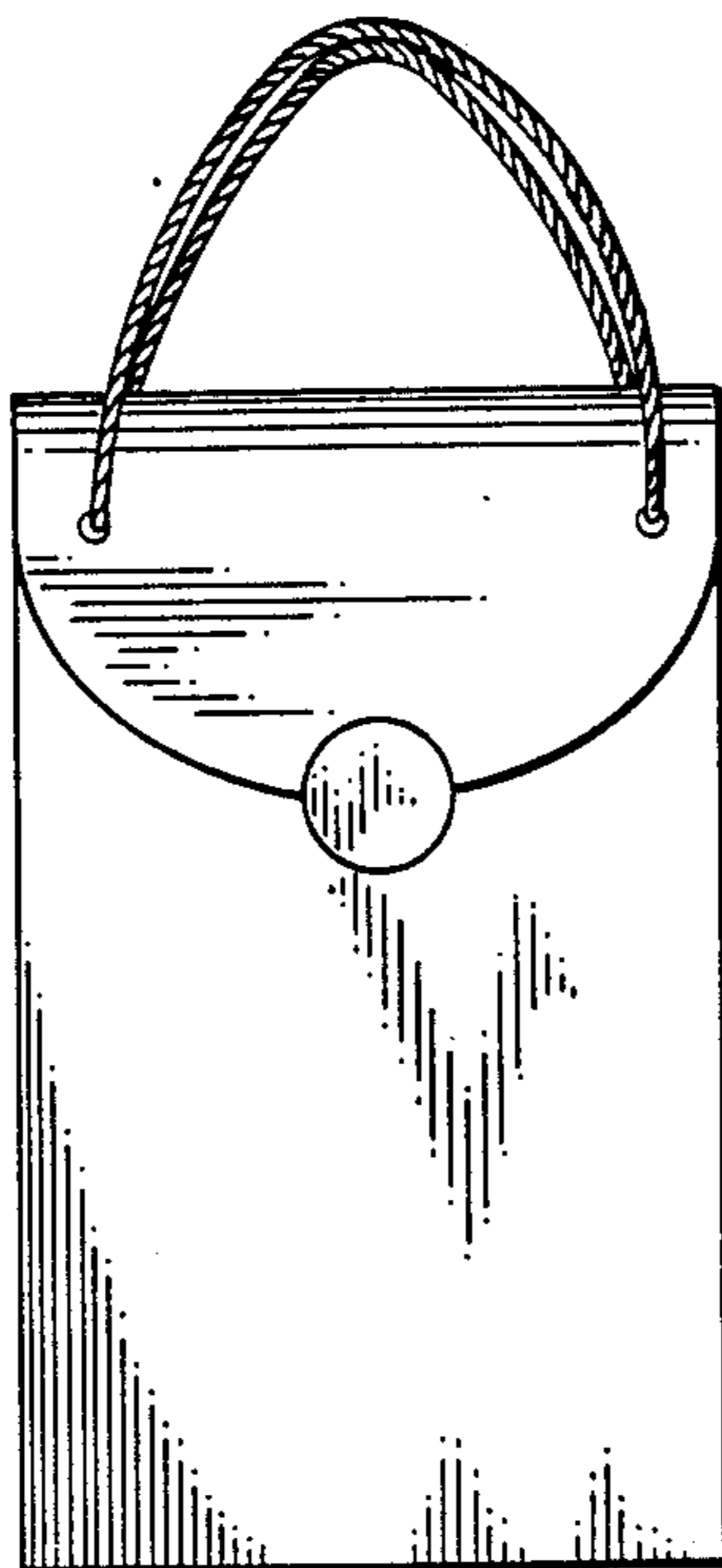

[57] CLAIM

The ornamental design for a combined greeting card and gift bag, as shown and described.

DESCRIPTION

- FIG. 1 is a front elevational view of a combined greeting card and gift bag, in a closed position, showing my new design;
- FIG. 2 is a right side elevational view thereof;
- FIG. 3 is a left side elevational view thereof;
- FIG. 4 is a rear elevational view thereof;
- FIG. 5 is a bottom plan view thereof.
- FIG. 6 is a top plan view thereof.
- FIG. 7 is a front elevational view of the bag in an open position and the indicia shown in broken lines for illustrative purposes only;
- FIG. 8 is a right side elevational view of FIG. 7;
- FIG. 9 is a left side elevational view of FIG. 7;
- FIG. 10 is a sectional view taken along line 10—10 in FIG. 7.
- FIG. 11 is a sectional view taken along line 11—11 in FIG. 8.
- FIG. 12 is a rear elevational view of FIG. 1 in a folded position;
- FIG. 13 is a left side elevational view of FIG. 12;
- FIG. 14 is a right side elevational view of FIG. 12.



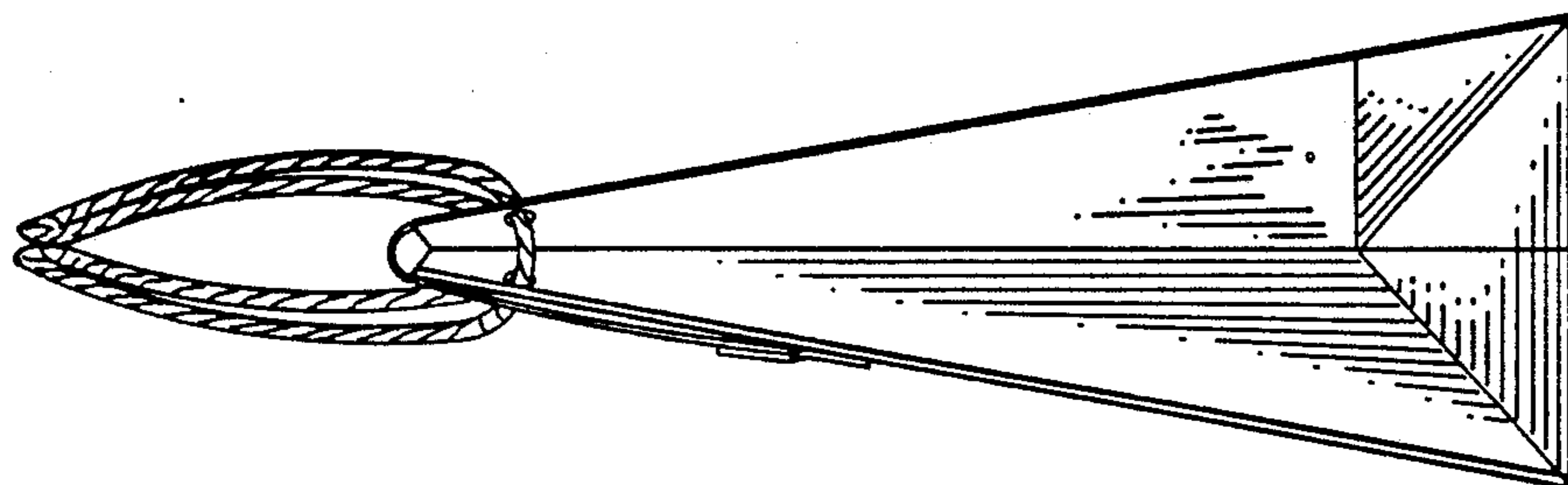

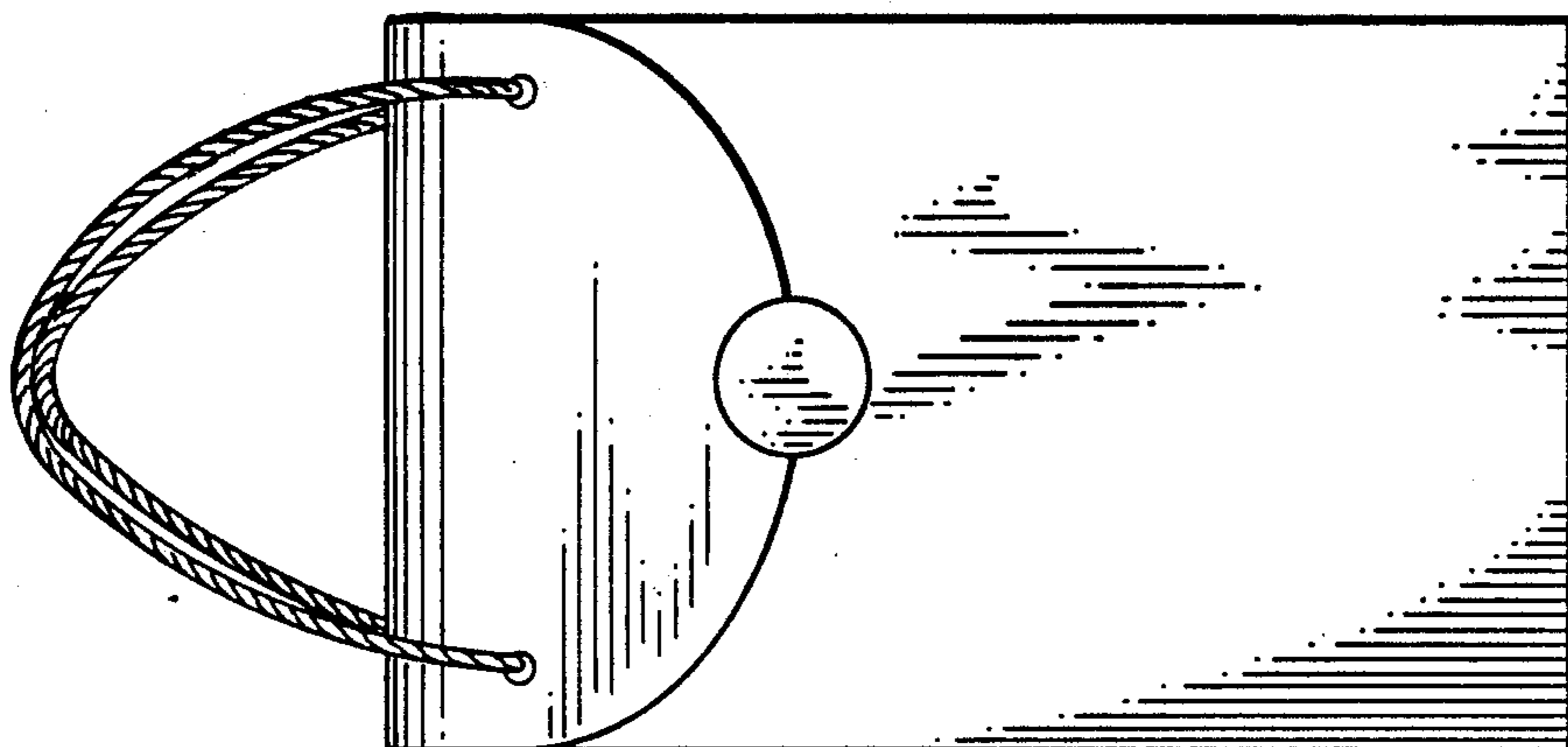

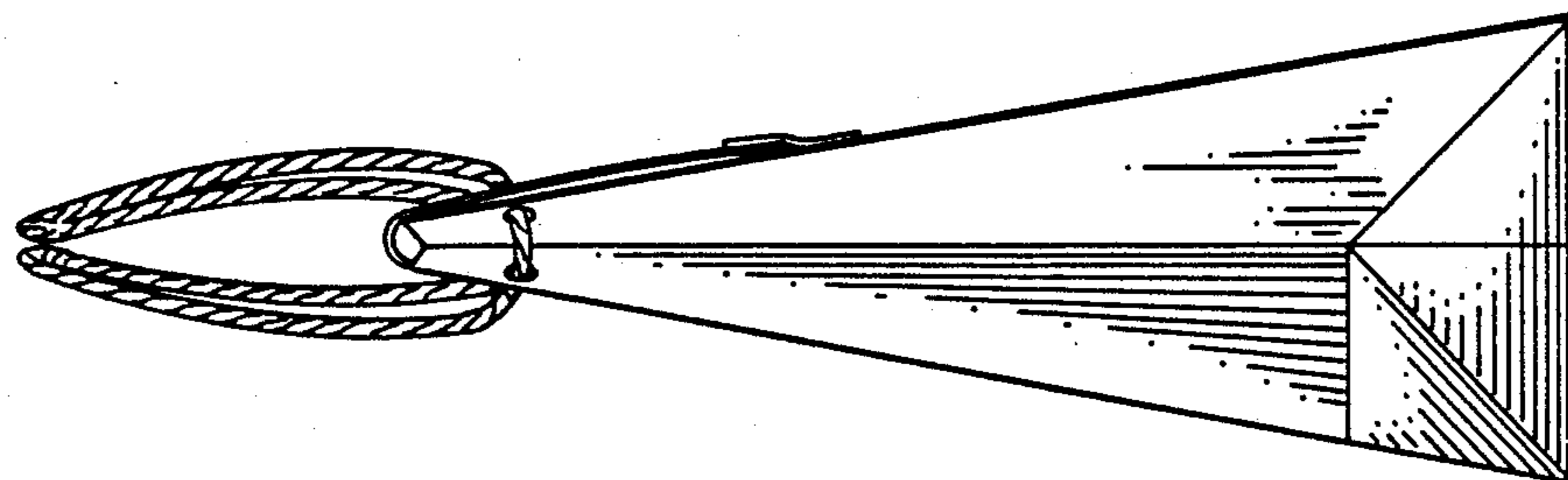

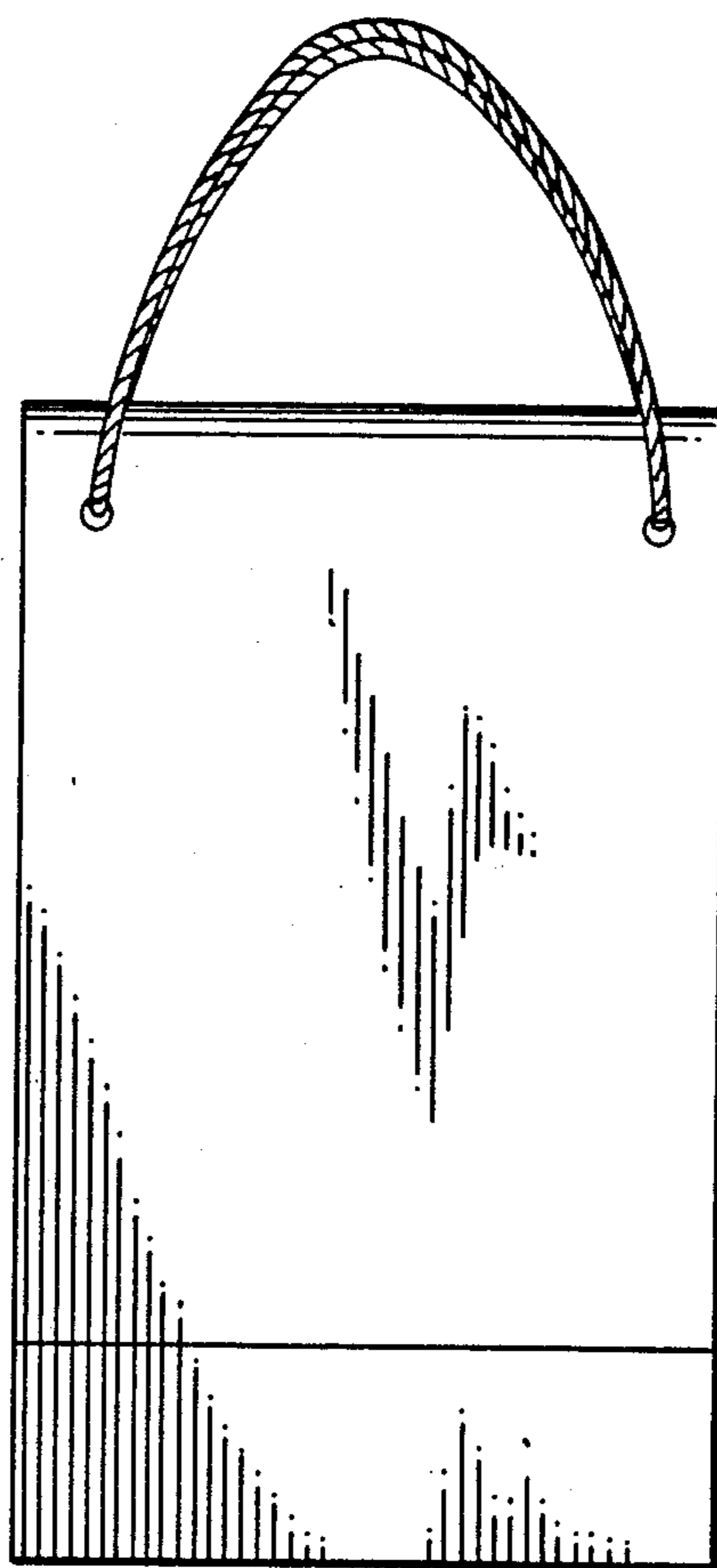

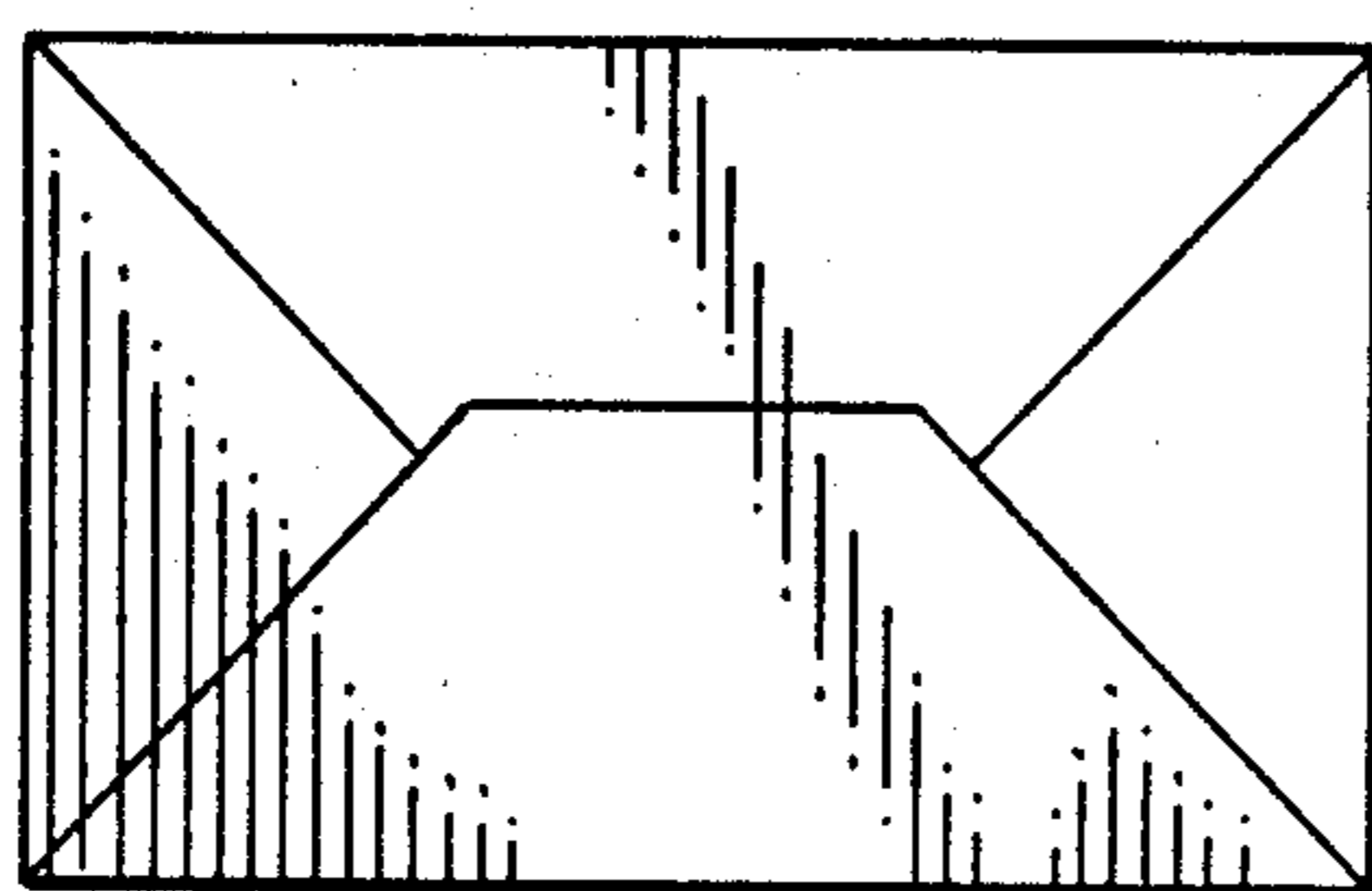

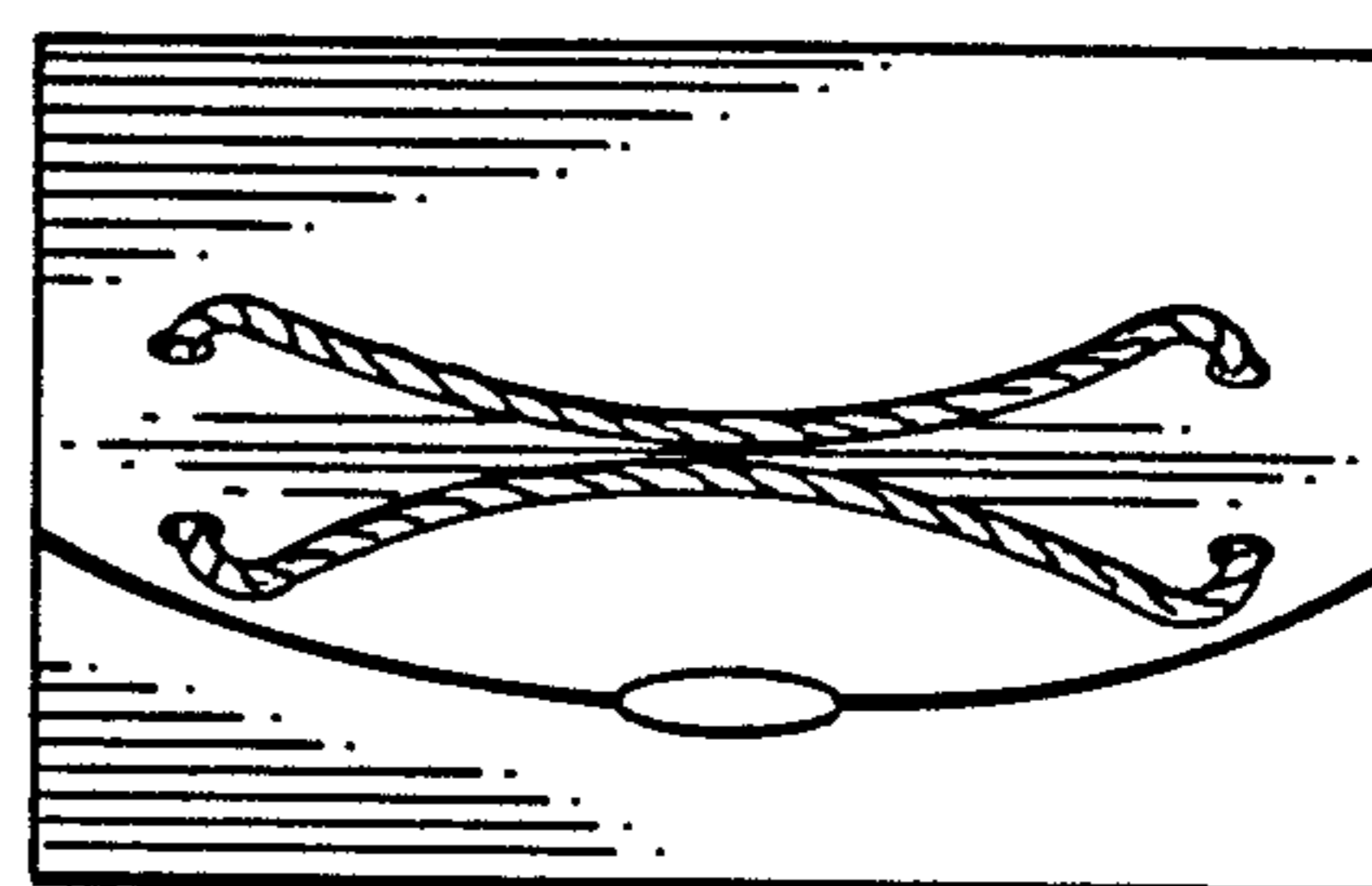
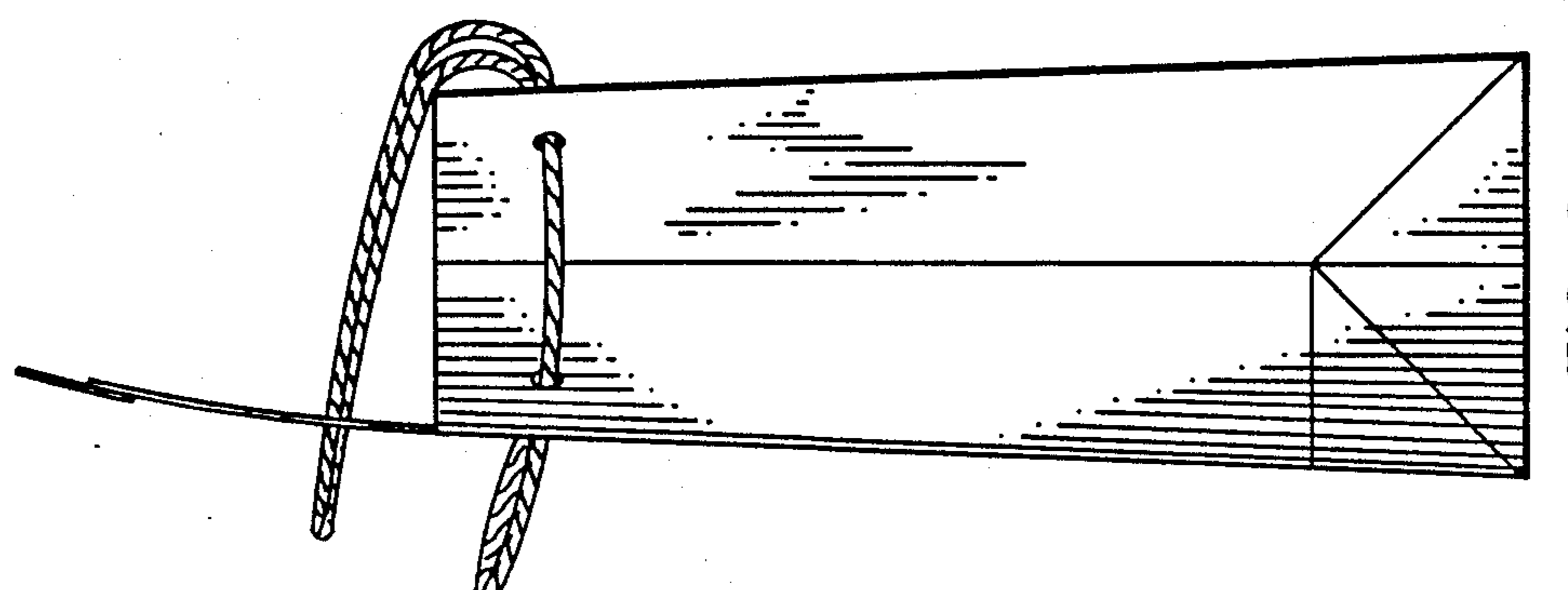
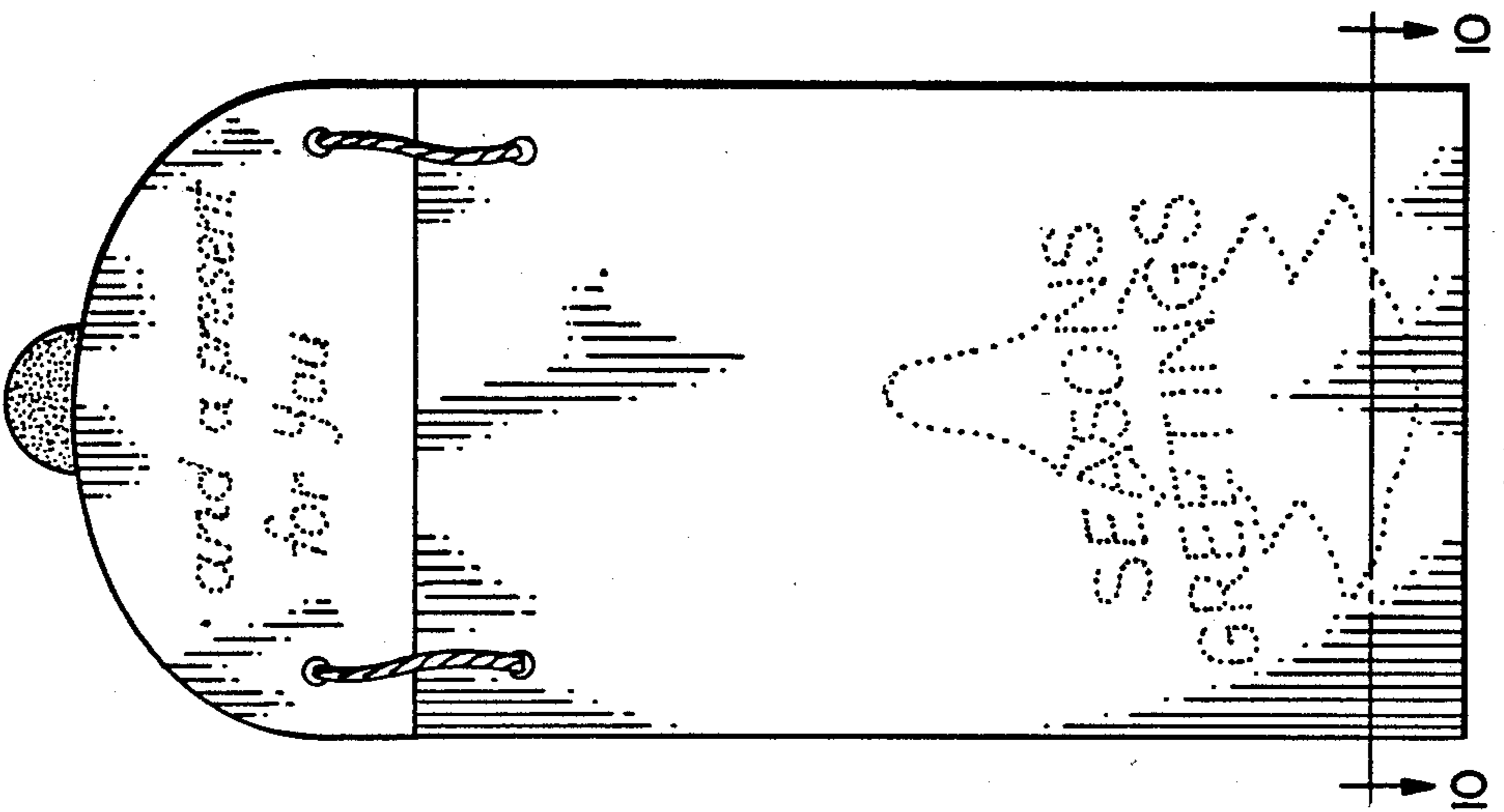
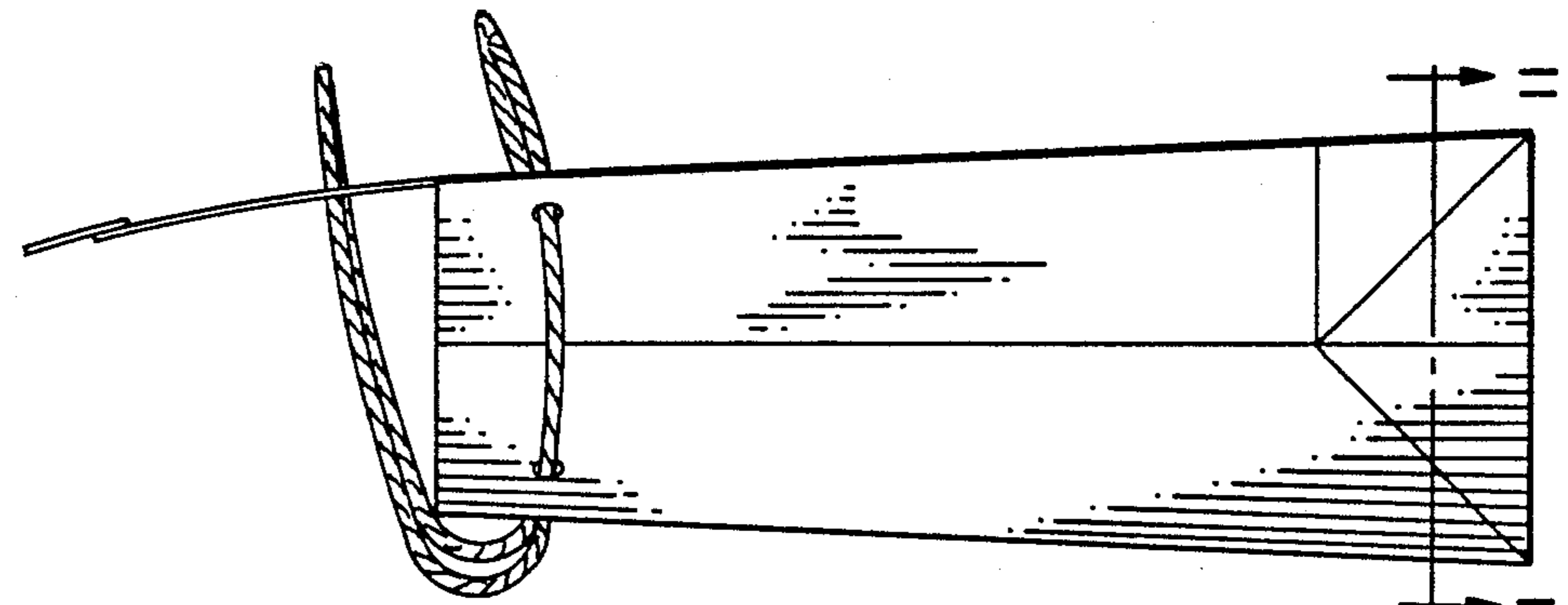

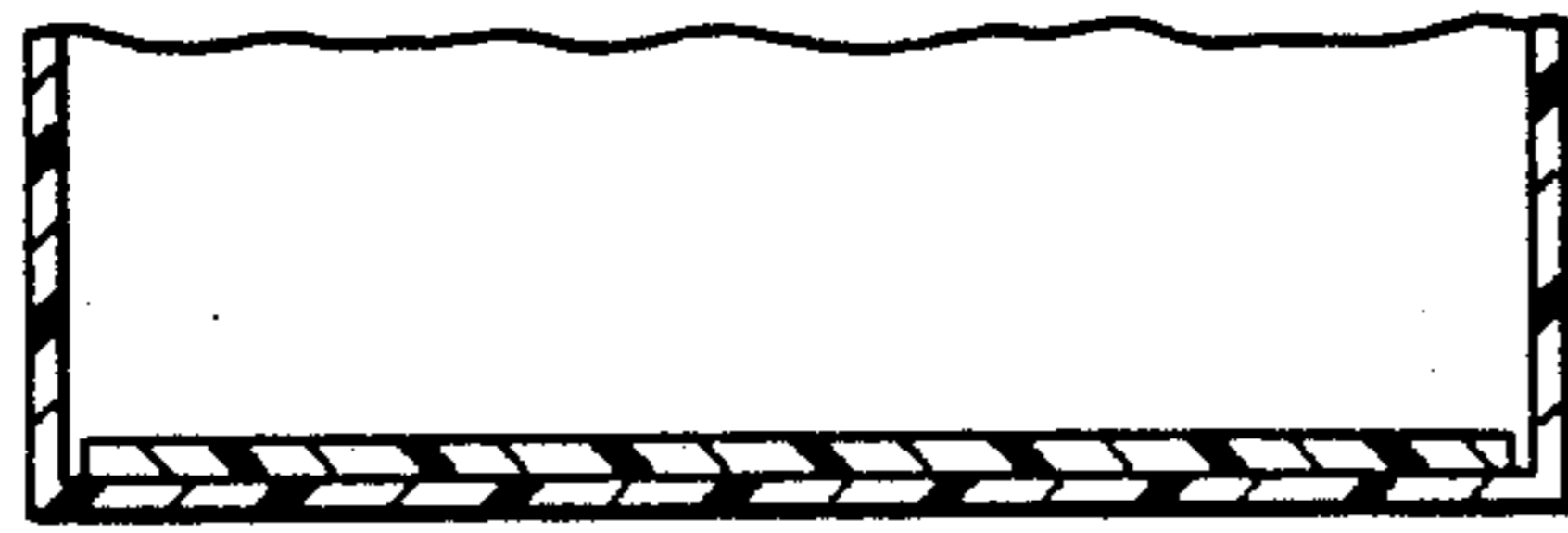

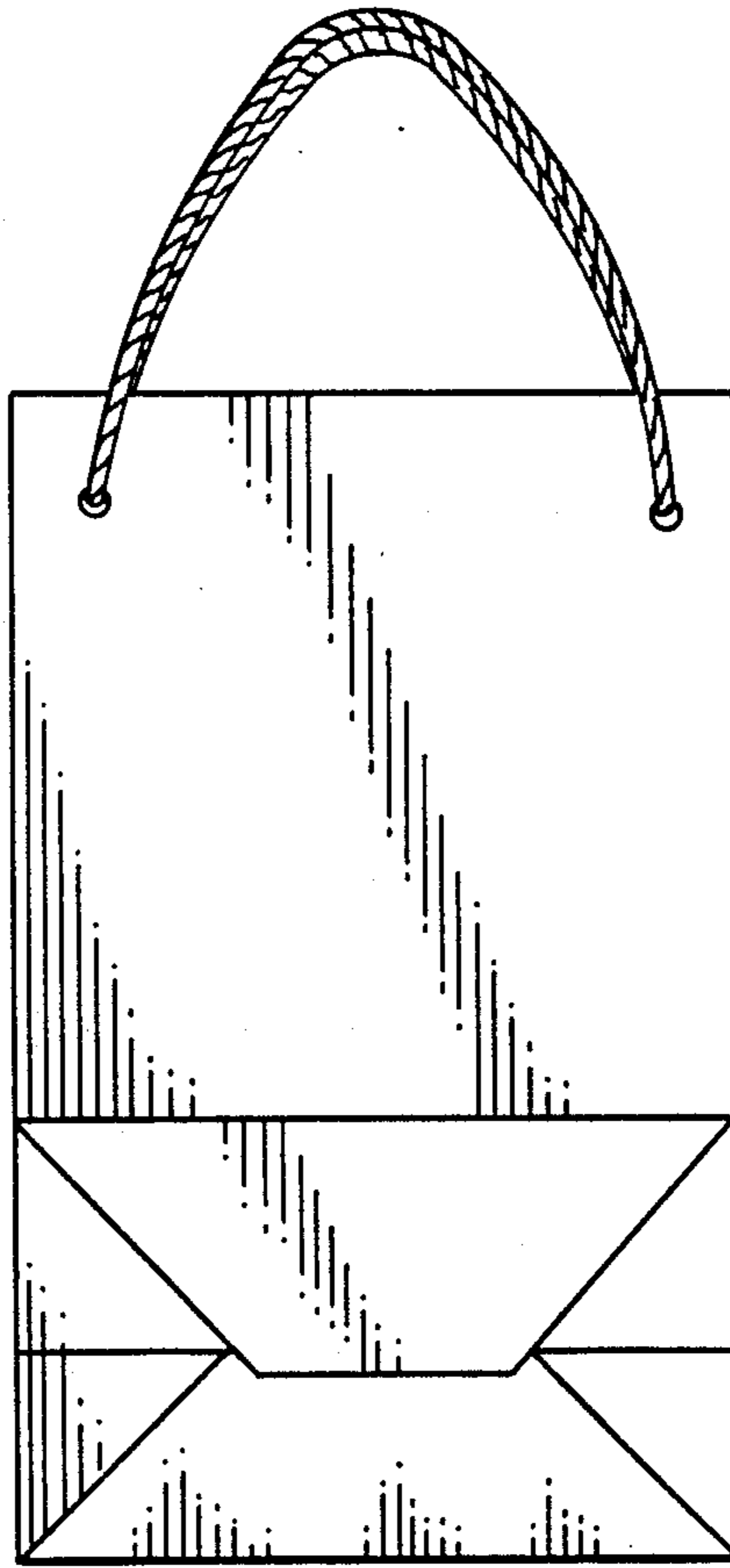
