[57] CLAIM

The ornamental design for a combined tape recorder and radio receiver, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a combined tape recorder and radio receiver showing our new design;

FIG. 2 is a top, front and right side perspective view thereof, shown with the handle removed and the cassette holder in an open position;

FIG. 3 is a top, front and right side perspective view thereof, shown with the handle removed and the antenna in an extended position;

FIG. 4 is a top, front and right side perspective view thereof, shown with the handle removed;

FIG. 5 is a top, front and right side perspective view thereof, shown with the handle attached at the top;

FIG. 6 is a front elevational view thereof;

FIG. 7 is a rear elevational view thereof;

FIG. 8 is a left-side elevational view thereof;

FIG. 9 is a right-side elevational view thereof;

FIG. 10 is a top plan view thereof; and

FIG. 11 is a bottom plan view thereof.

The handle is omitted from FIGS. 6 thru 10 for ease of illustration.

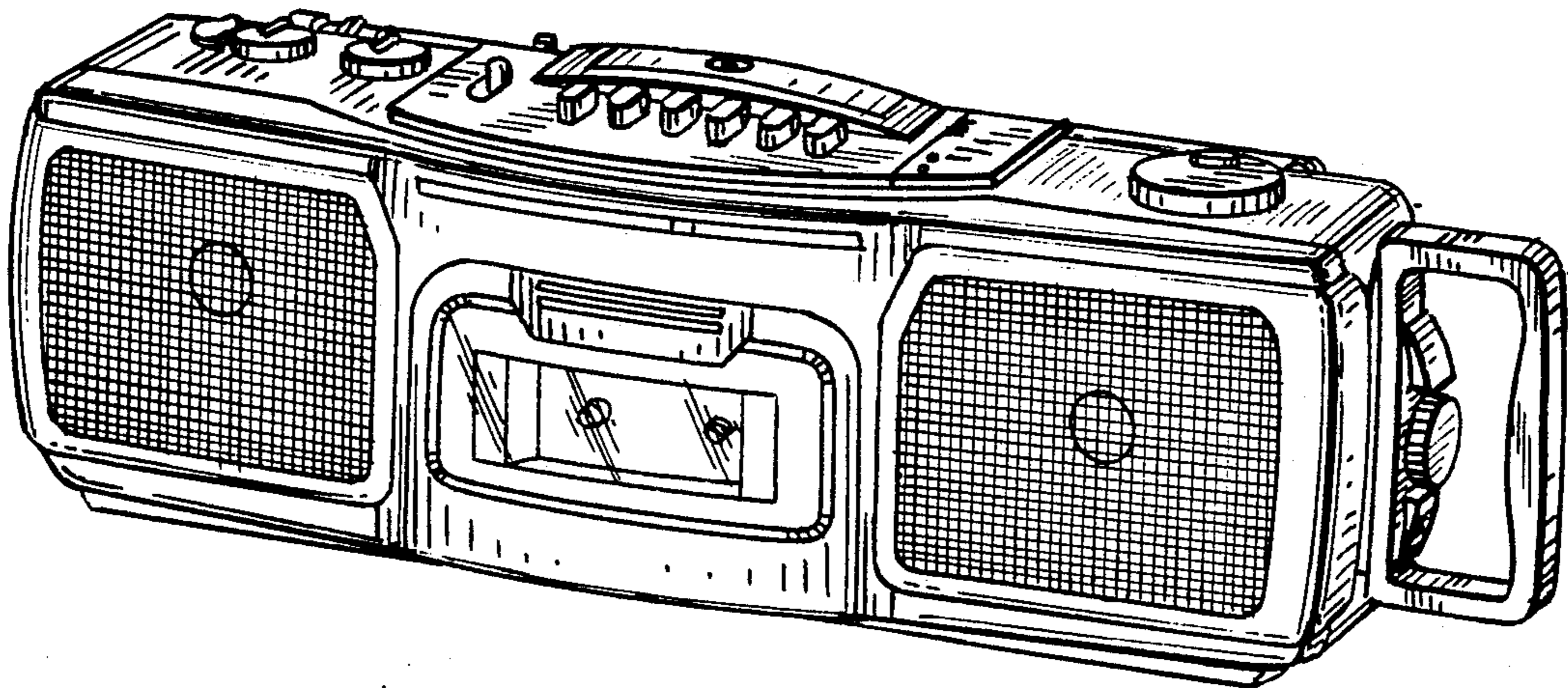

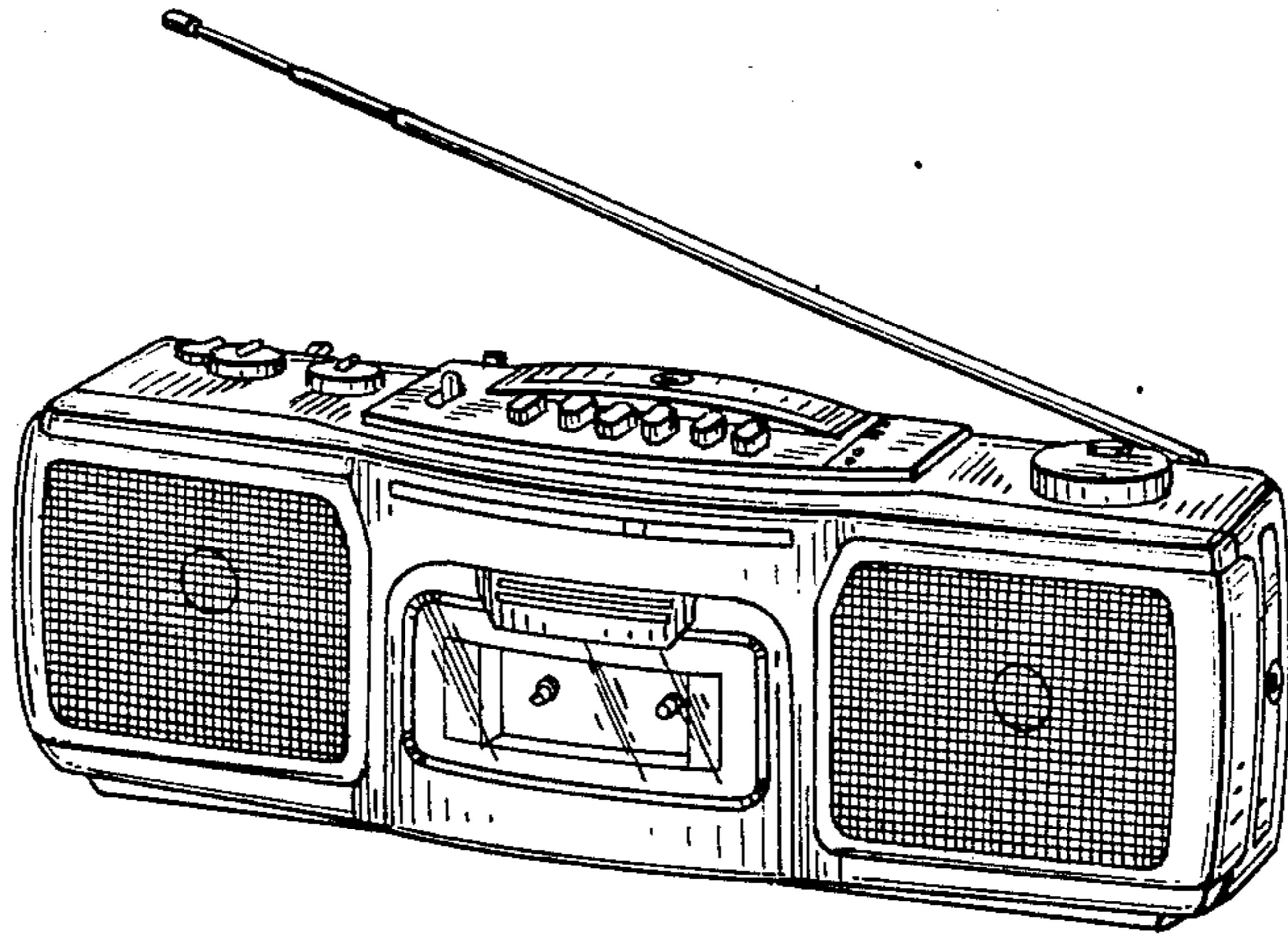

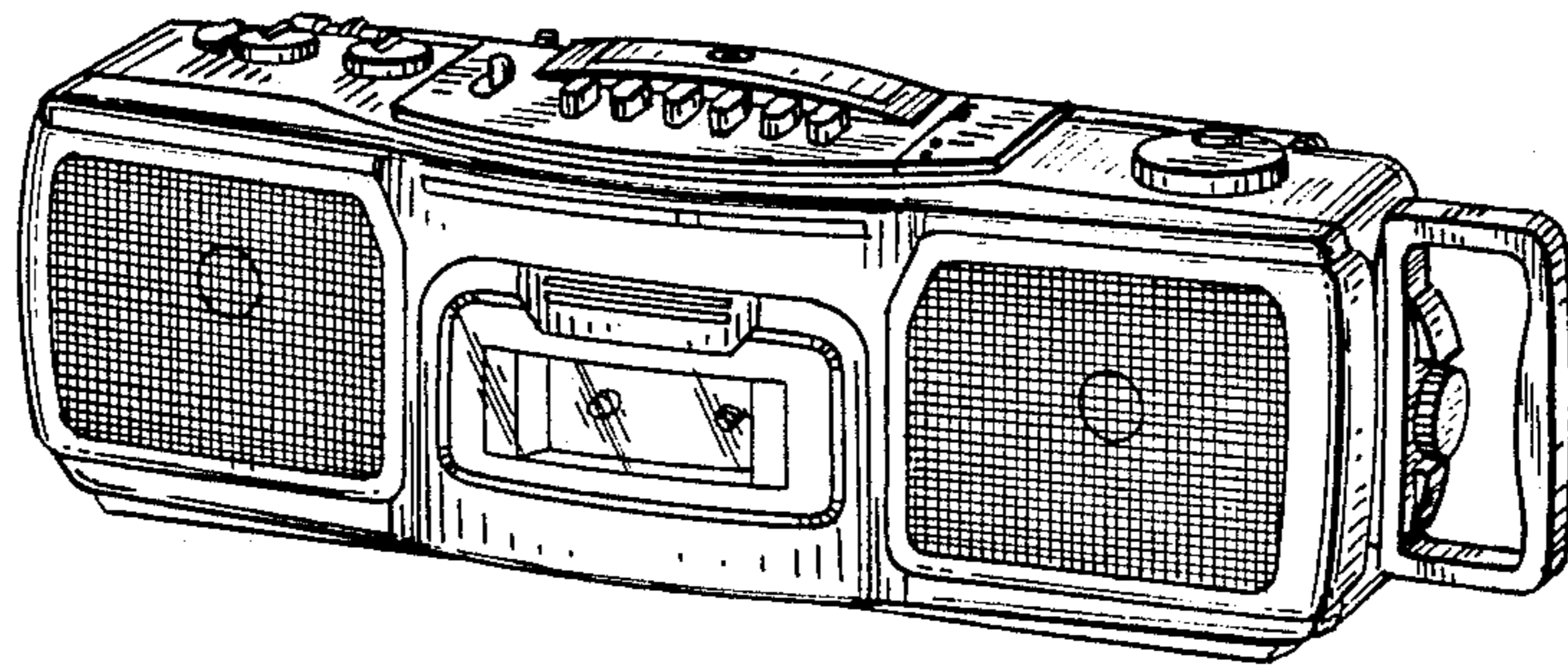

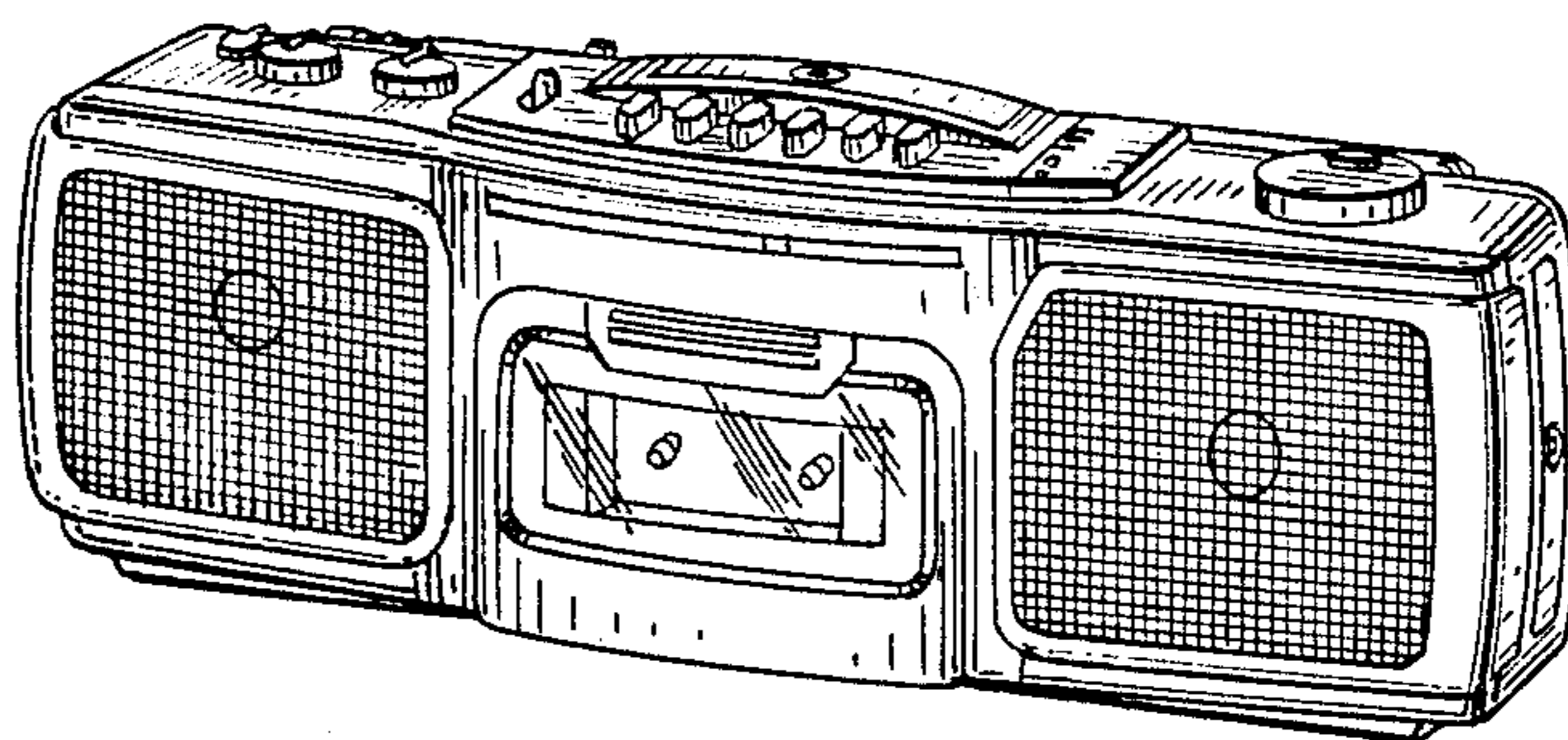

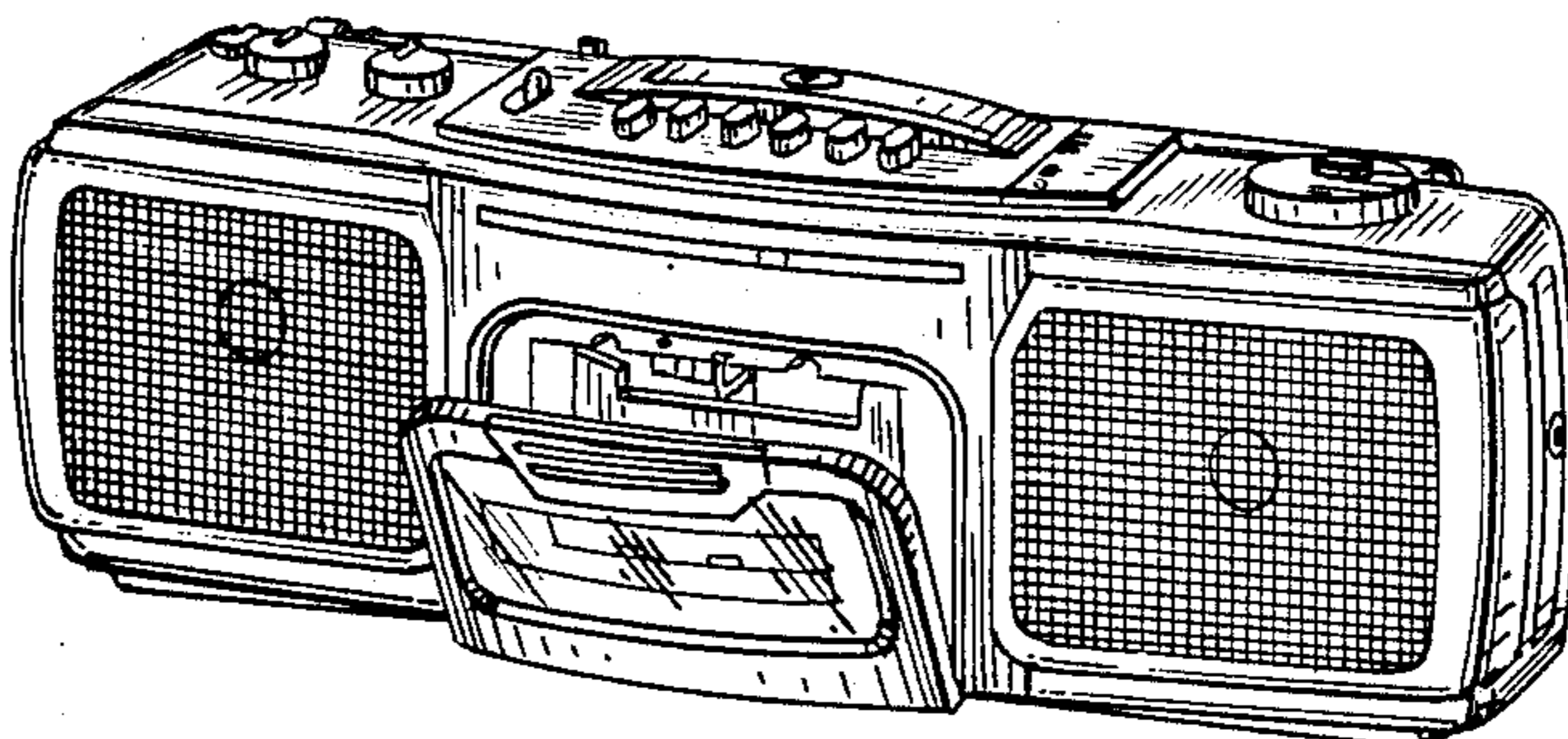

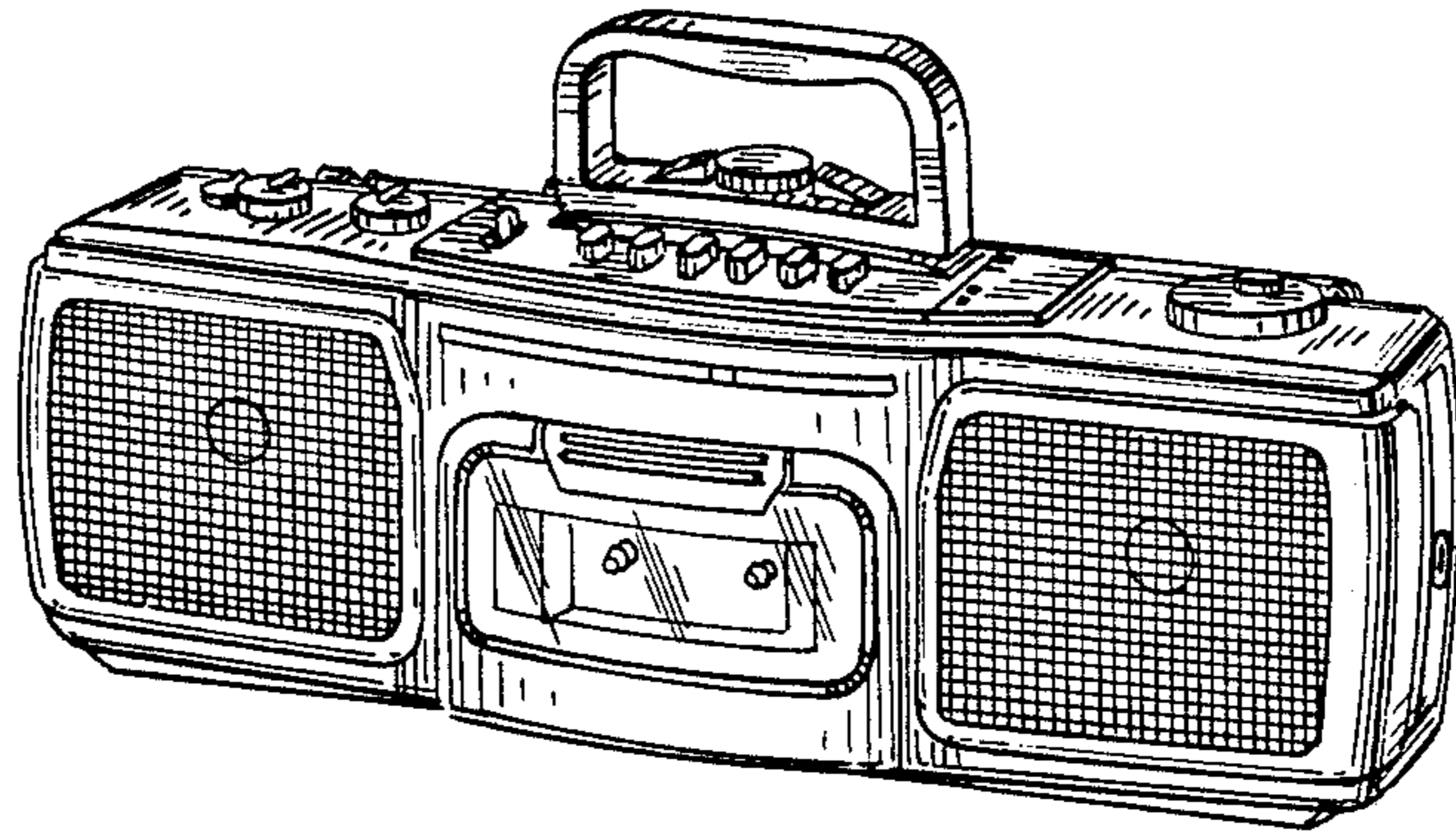

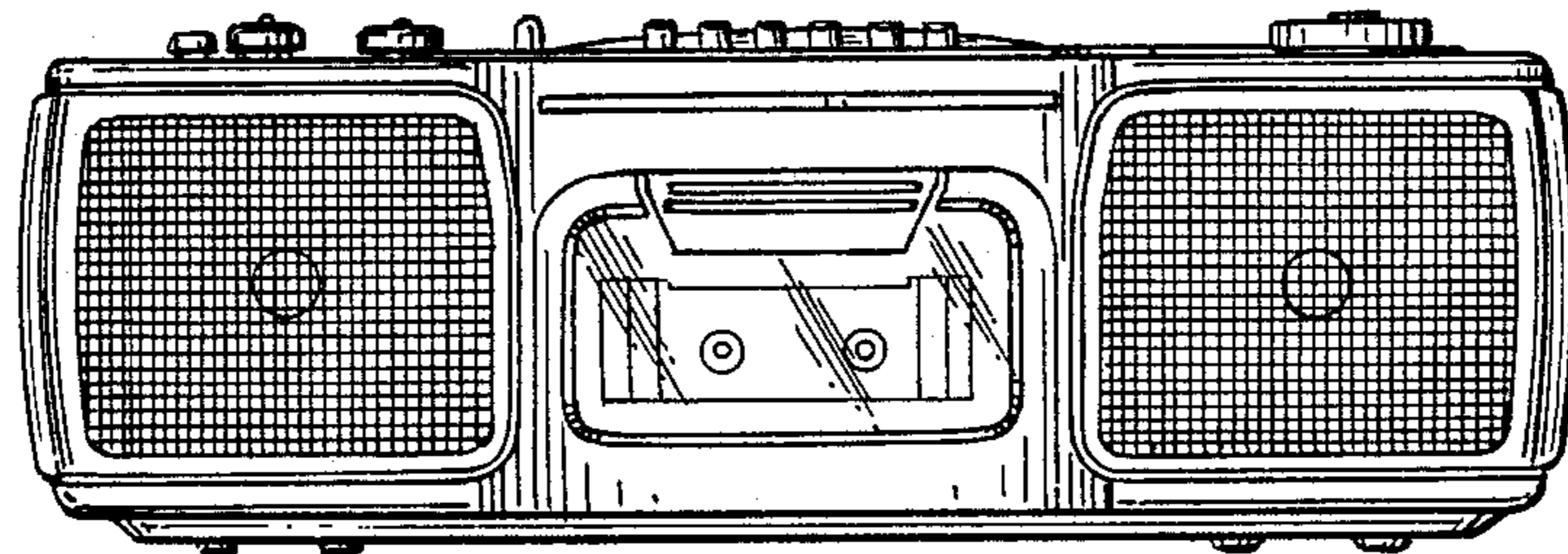

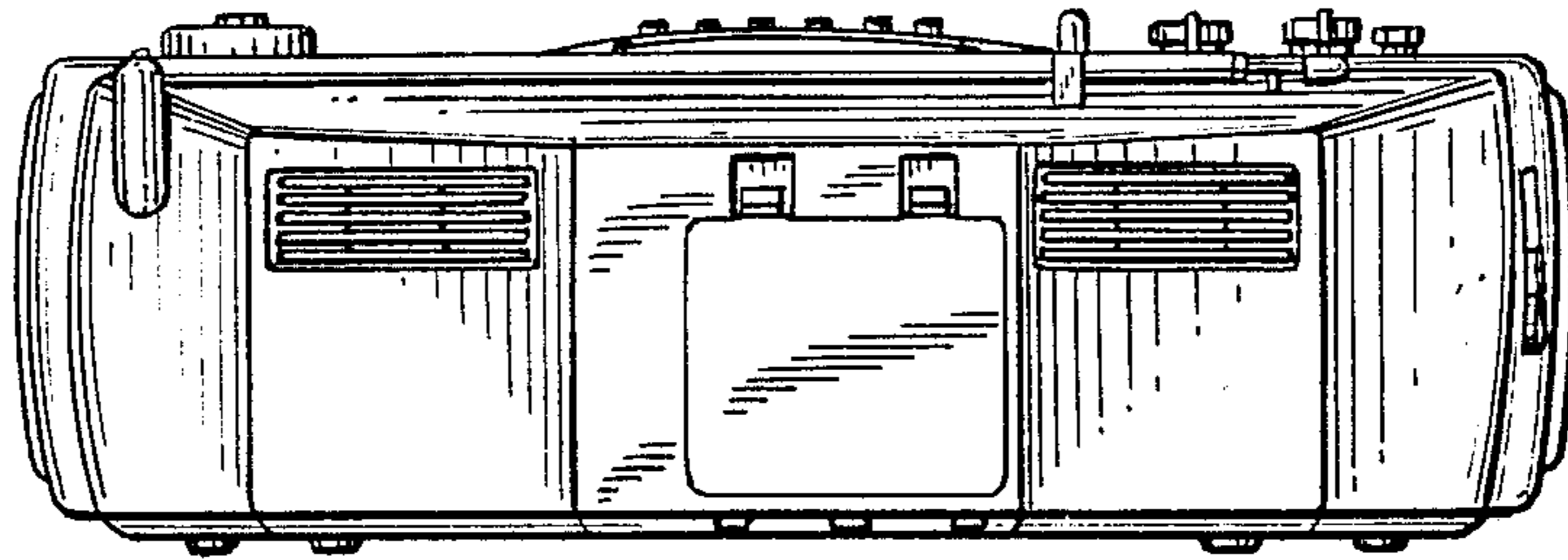

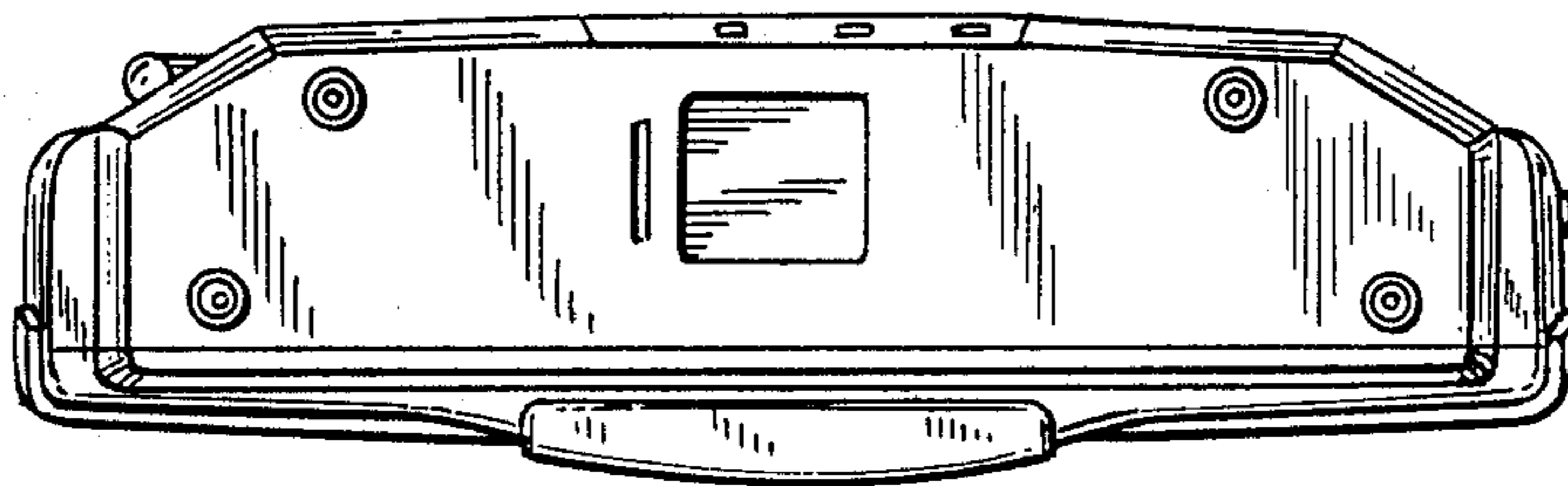

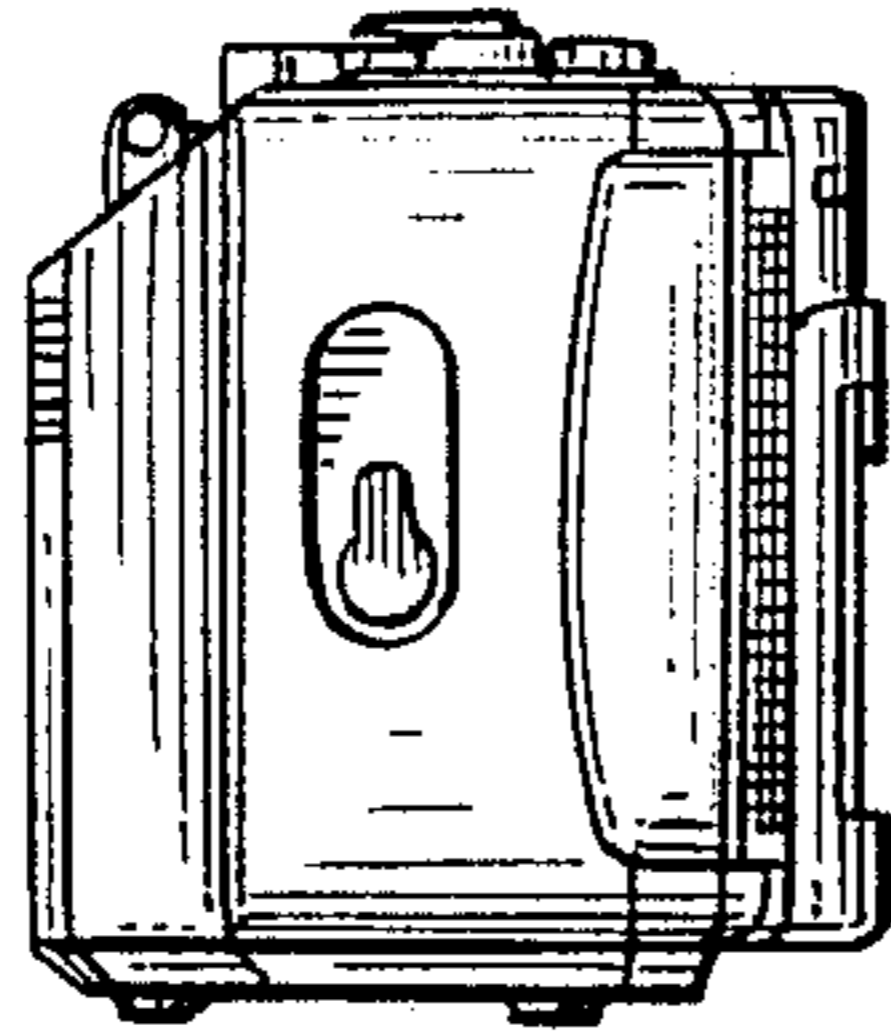

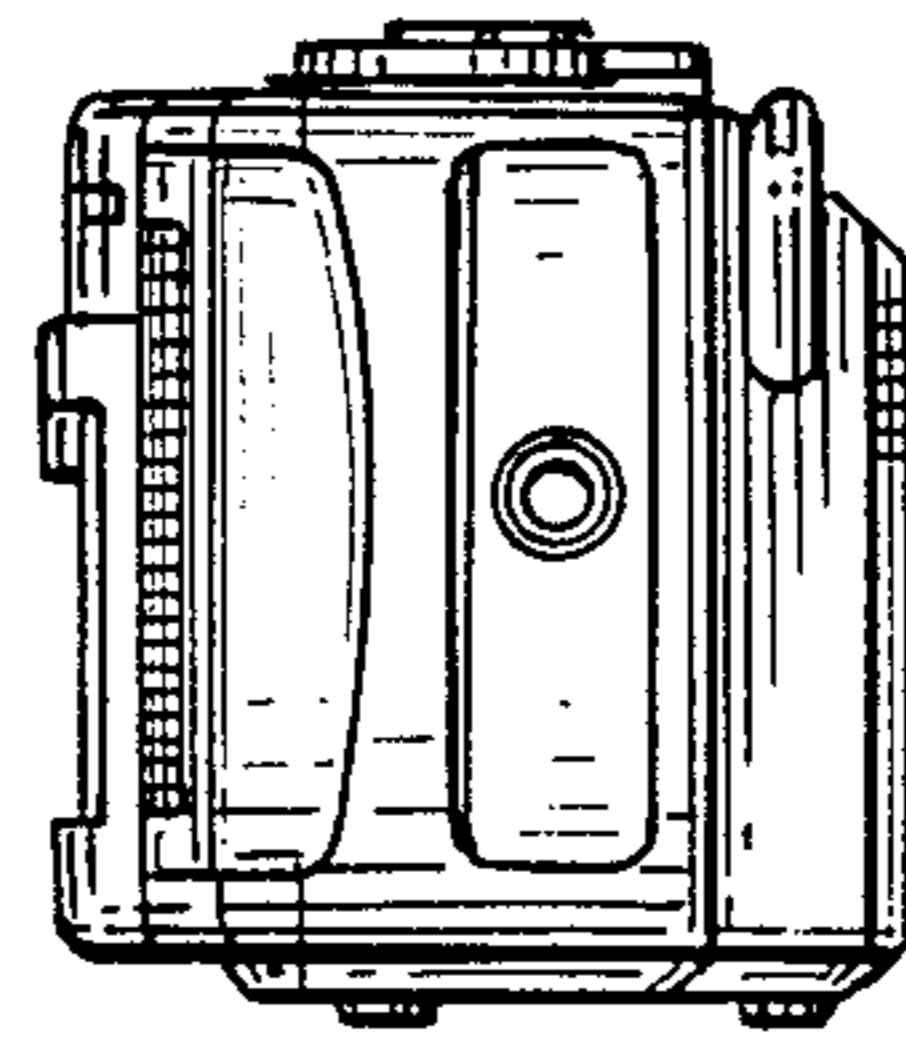
