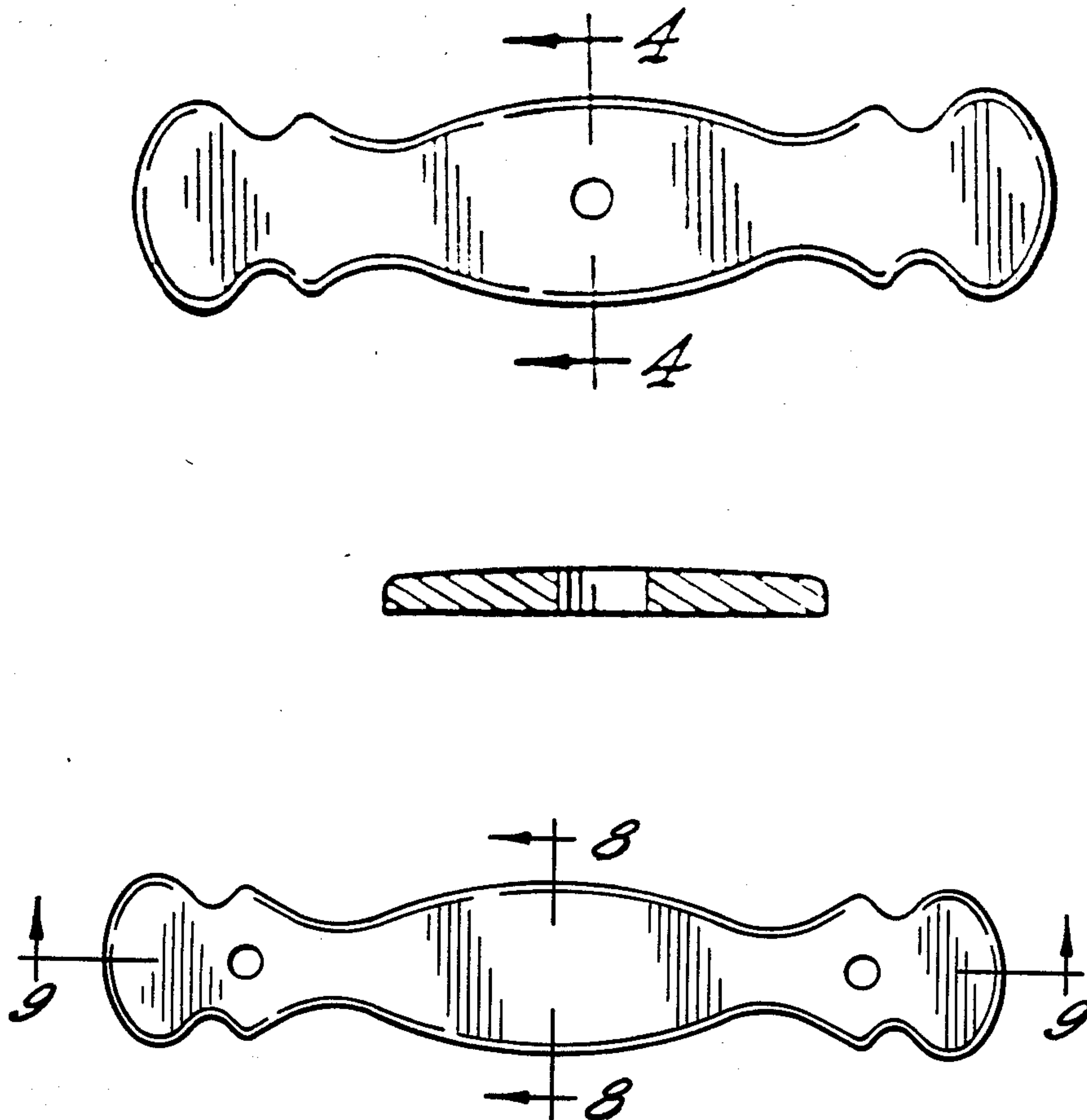

[57] CLAIM

The ornamental design for an escutcheon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an escutcheon, showing my new design as embodied for a knob, the rear being unornamented;  
FIG. 2 is a bottom view thereof, the top being a mirror image;  
FIG. 3 is a side view thereof, both sides being identical;  
FIG. 4 is an enlarged sectional view taken in the direction of the arrows on line 4—4 of FIG. 1;  
FIG. 5 is a front view of a second embodiment of the design of FIG. 1, as embodied for a pull;  
FIG. 6 is a bottom view of FIG. 5, the top being a mirror image;  
FIG. 7 is a side view of FIG. 5, both sides being identical;  
FIG. 8 is an enlarged sectional view taken in the direction of the arrows on line 8—8 of FIG. 5;  
FIG. 9 is a sectional view taken in the direction of the arrows on line 9—9 of FIG. 5.



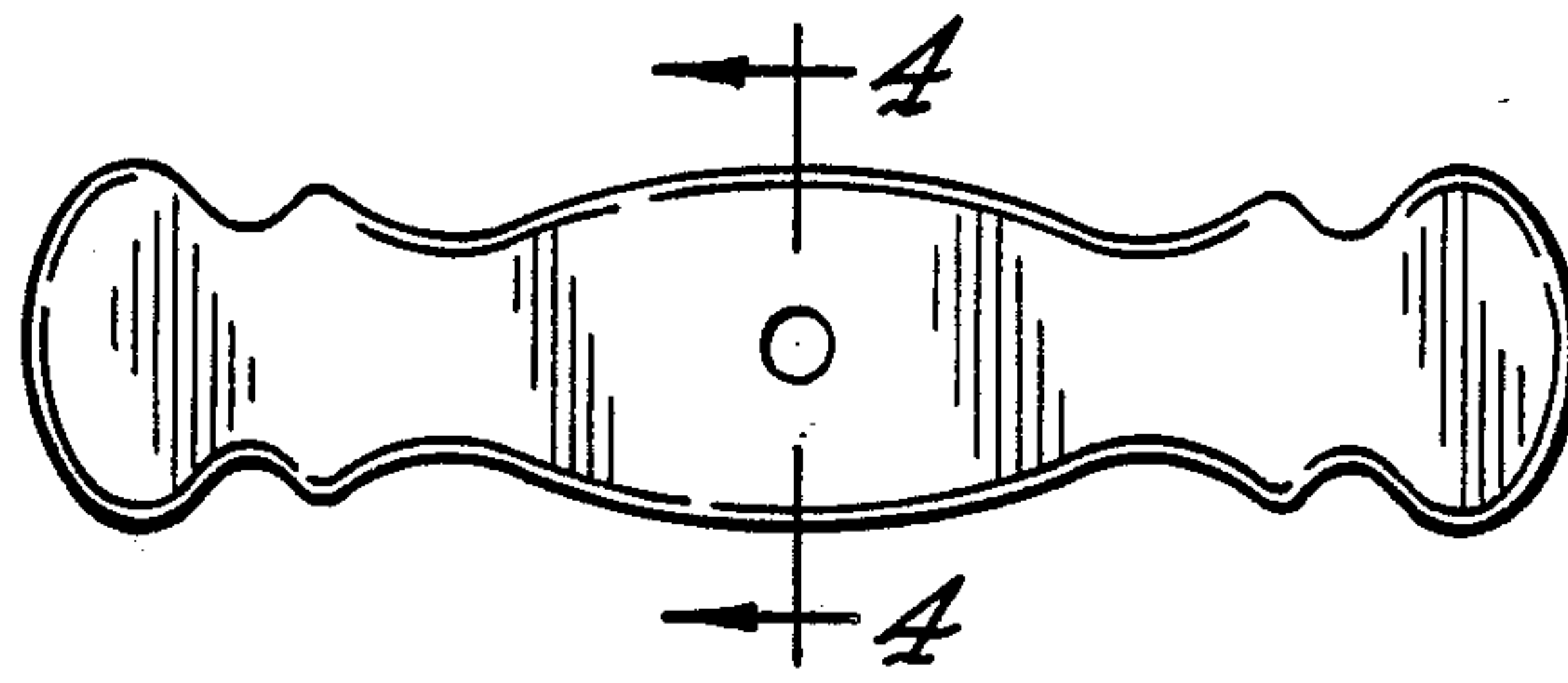

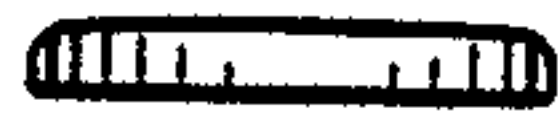

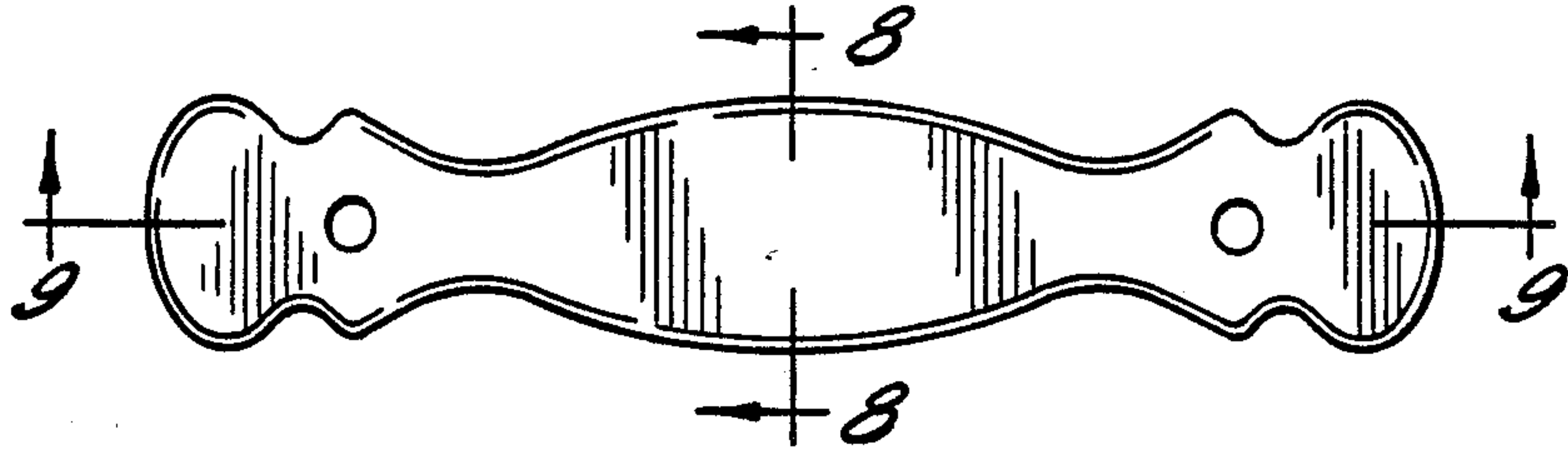
