The ornamental design for a portable radiotelephone unit, as shown.

**DESCRIPTION**

FIG. 1 is a top plan view of a portable radiotelephone unit showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a rear elevational view thereof; and FIG. 7 is front right bottom perspective view thereof.

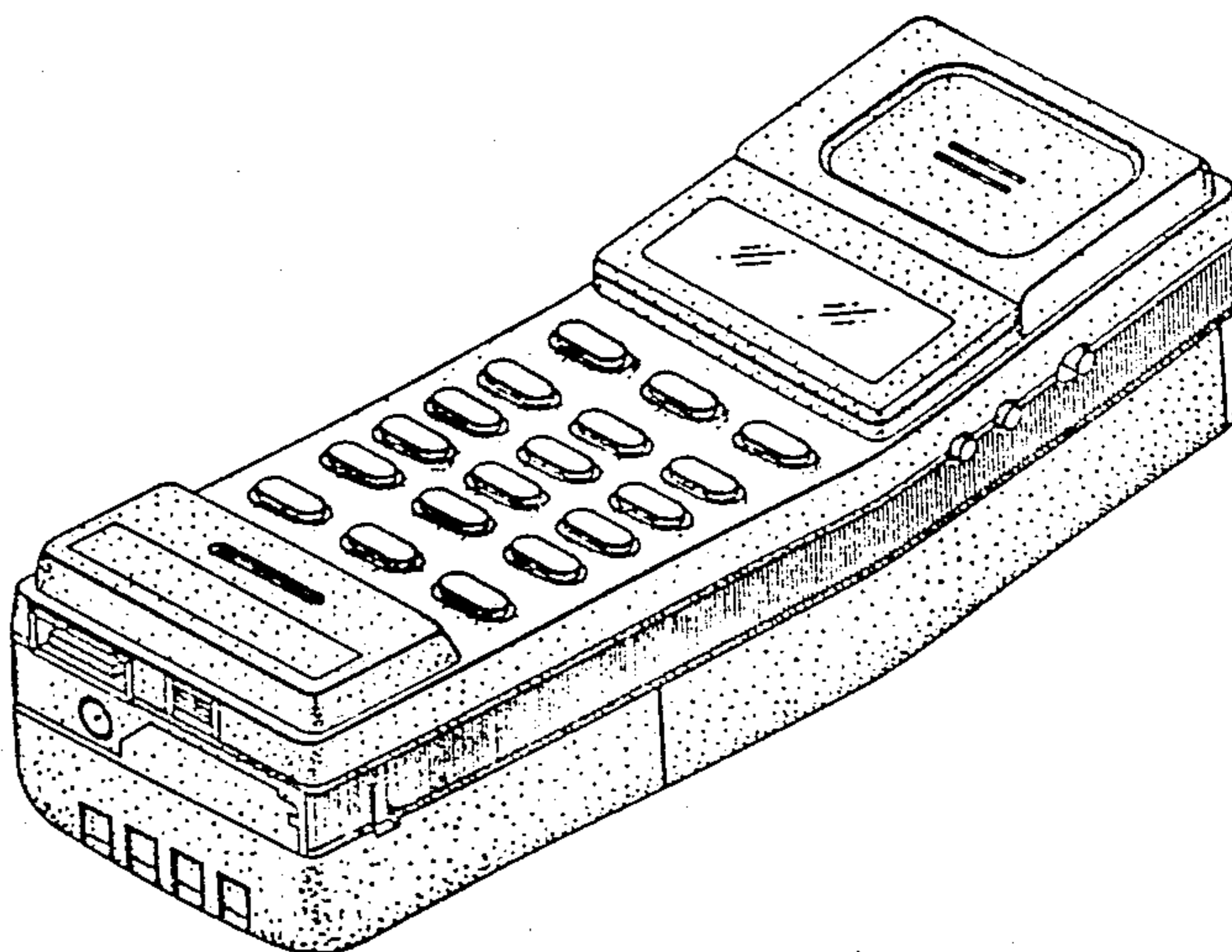
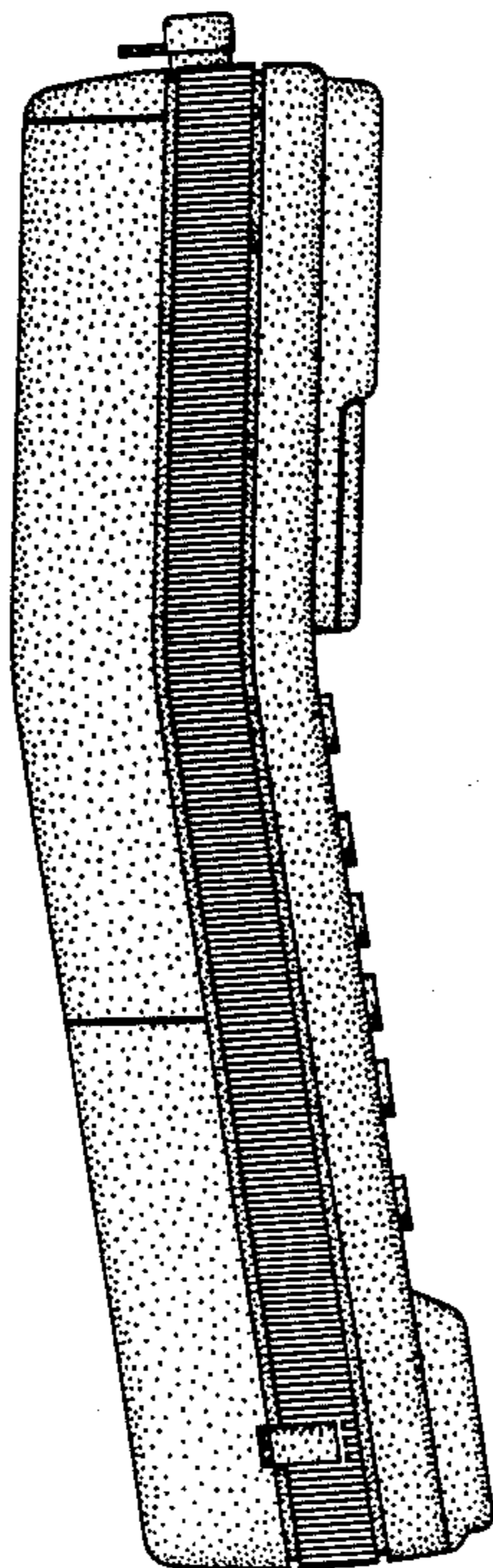

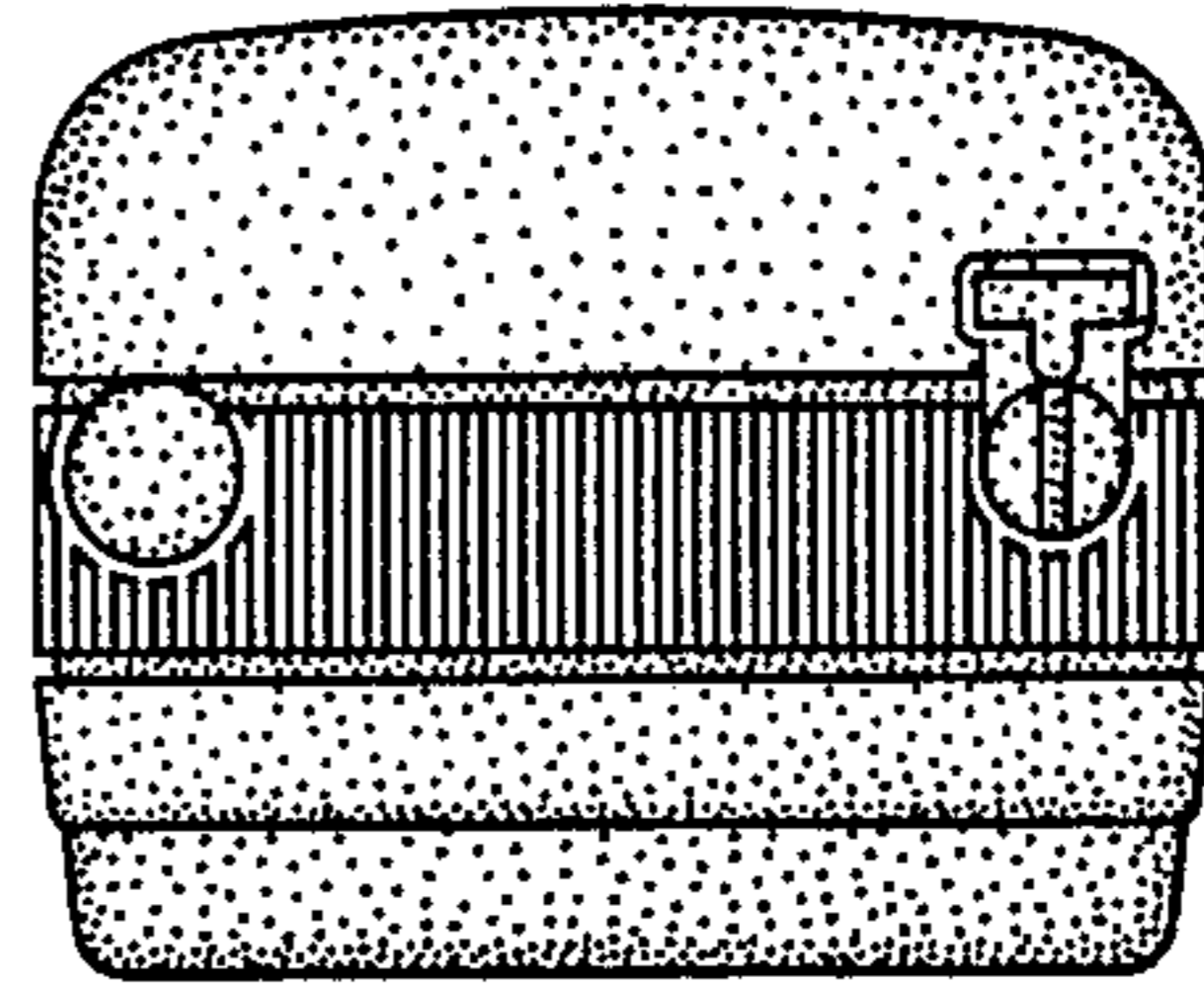

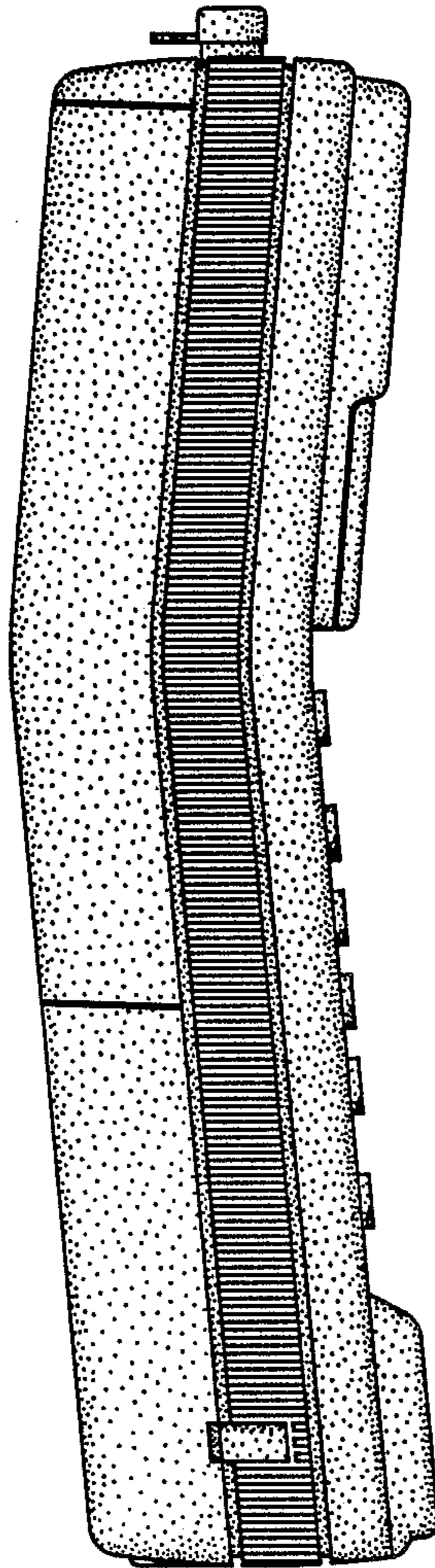

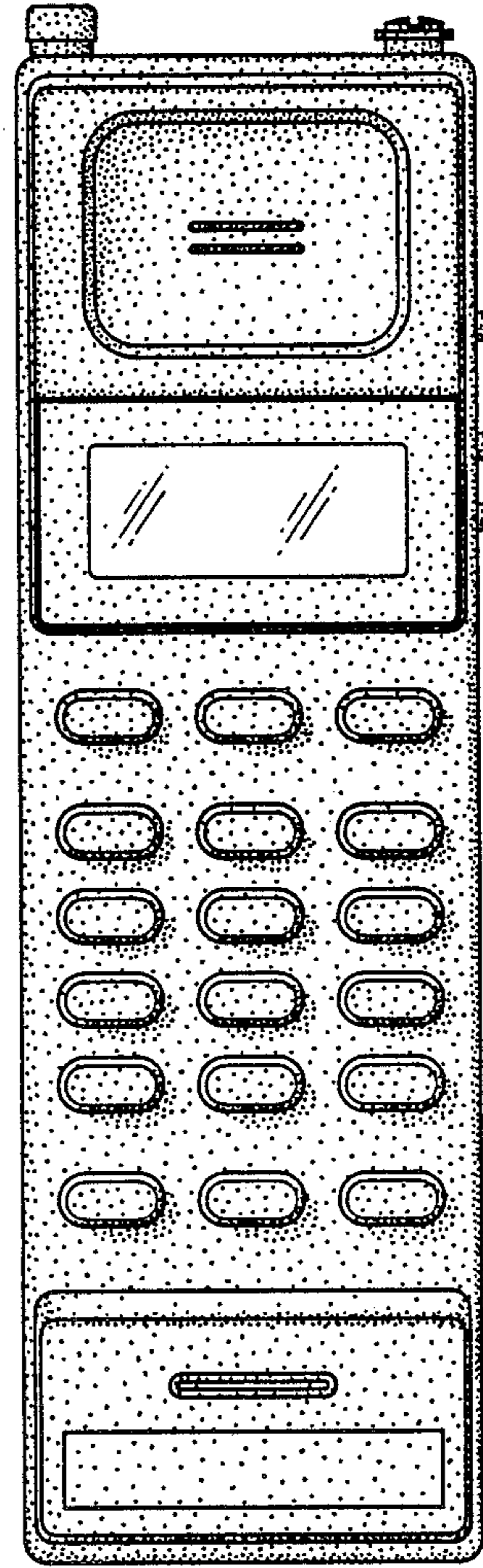

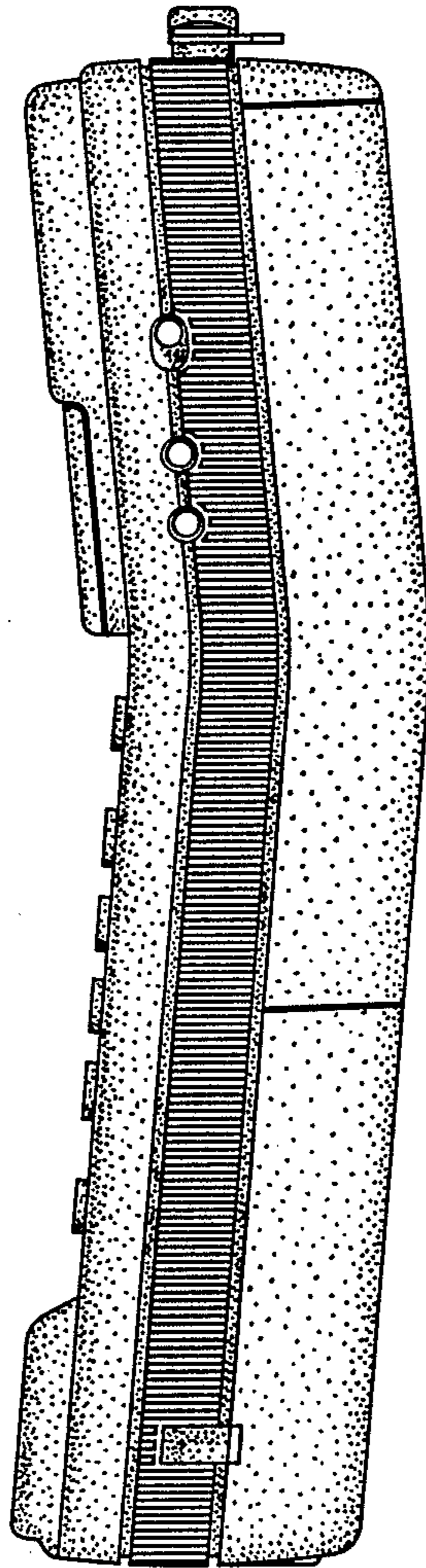

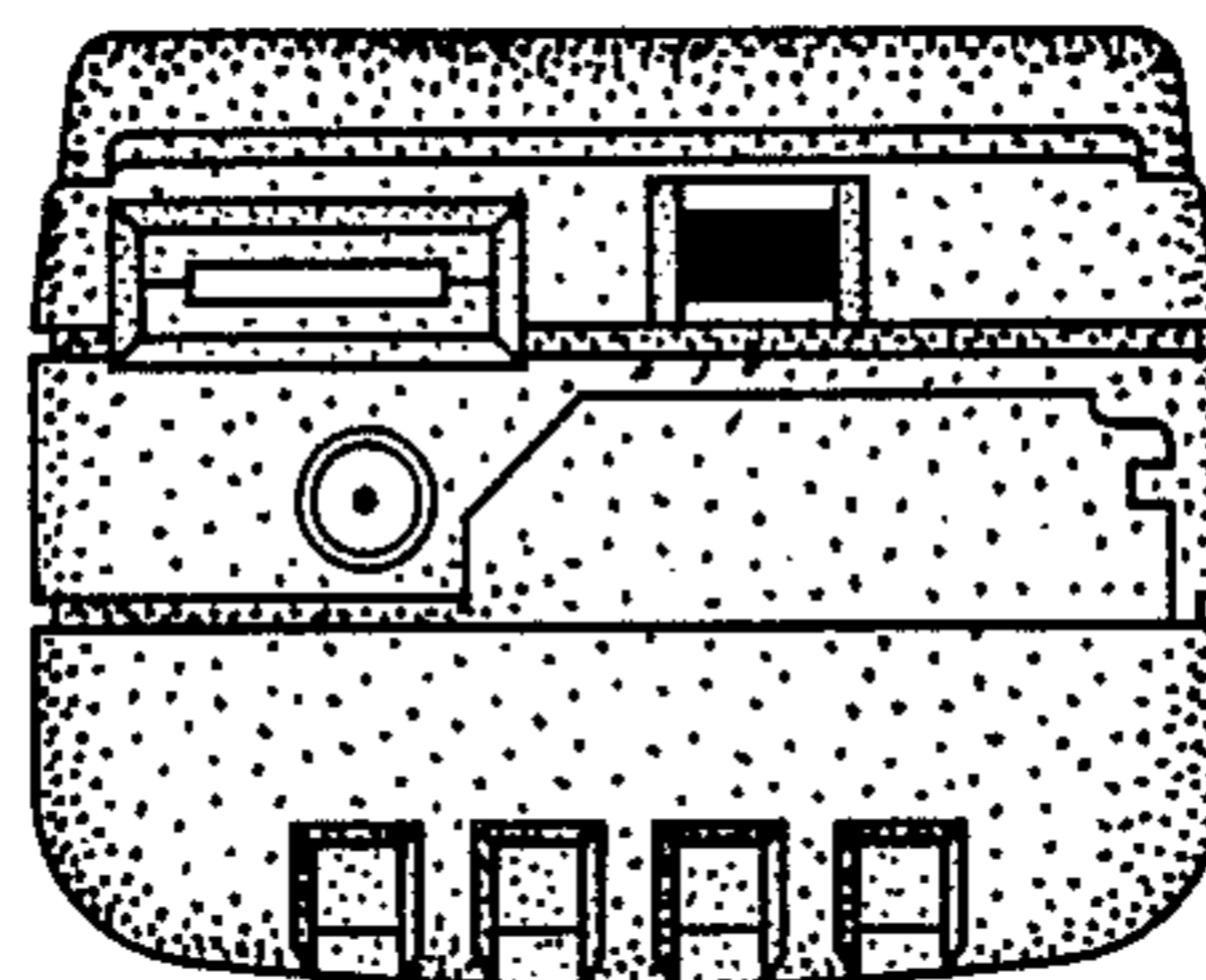

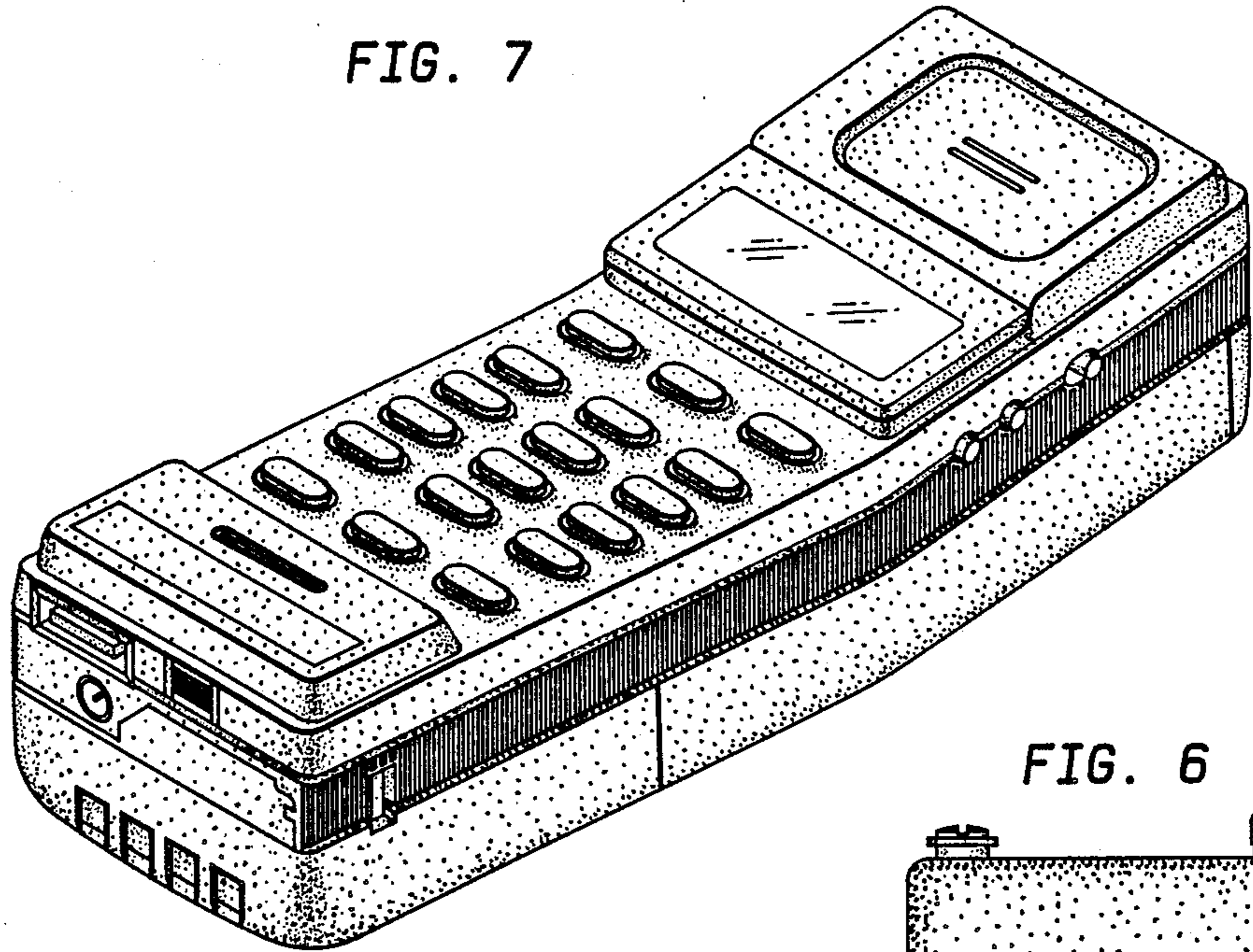
