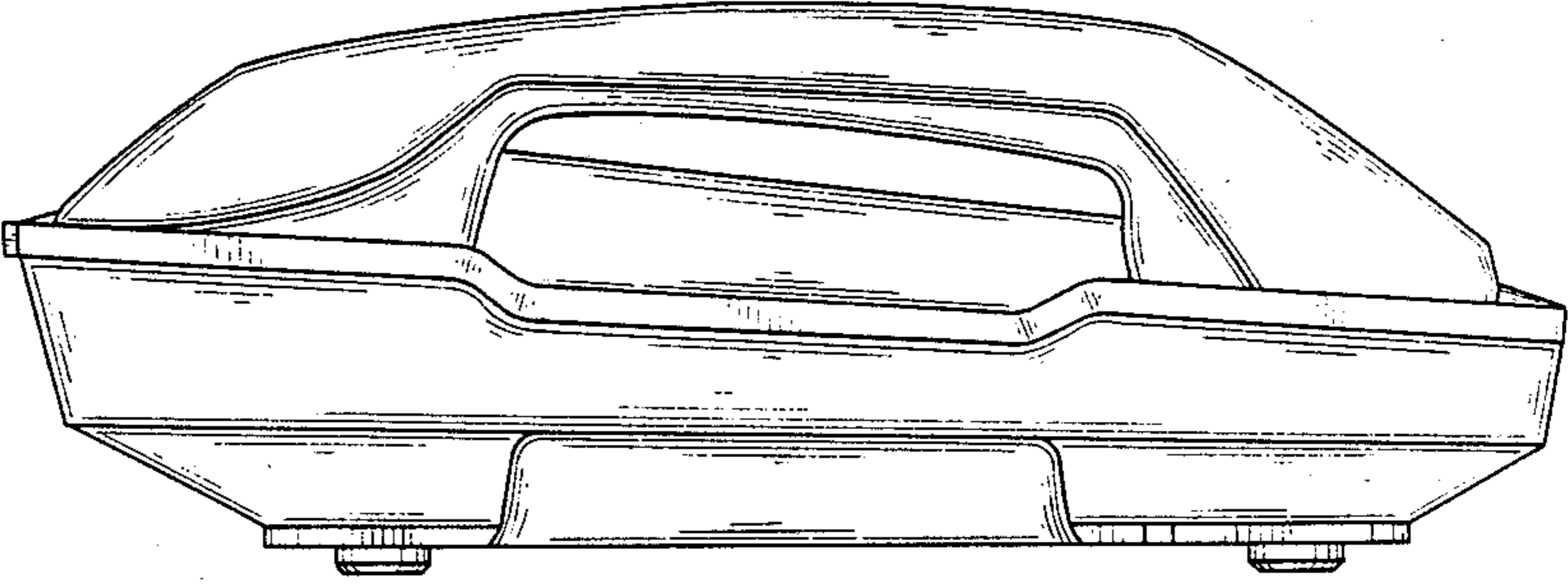
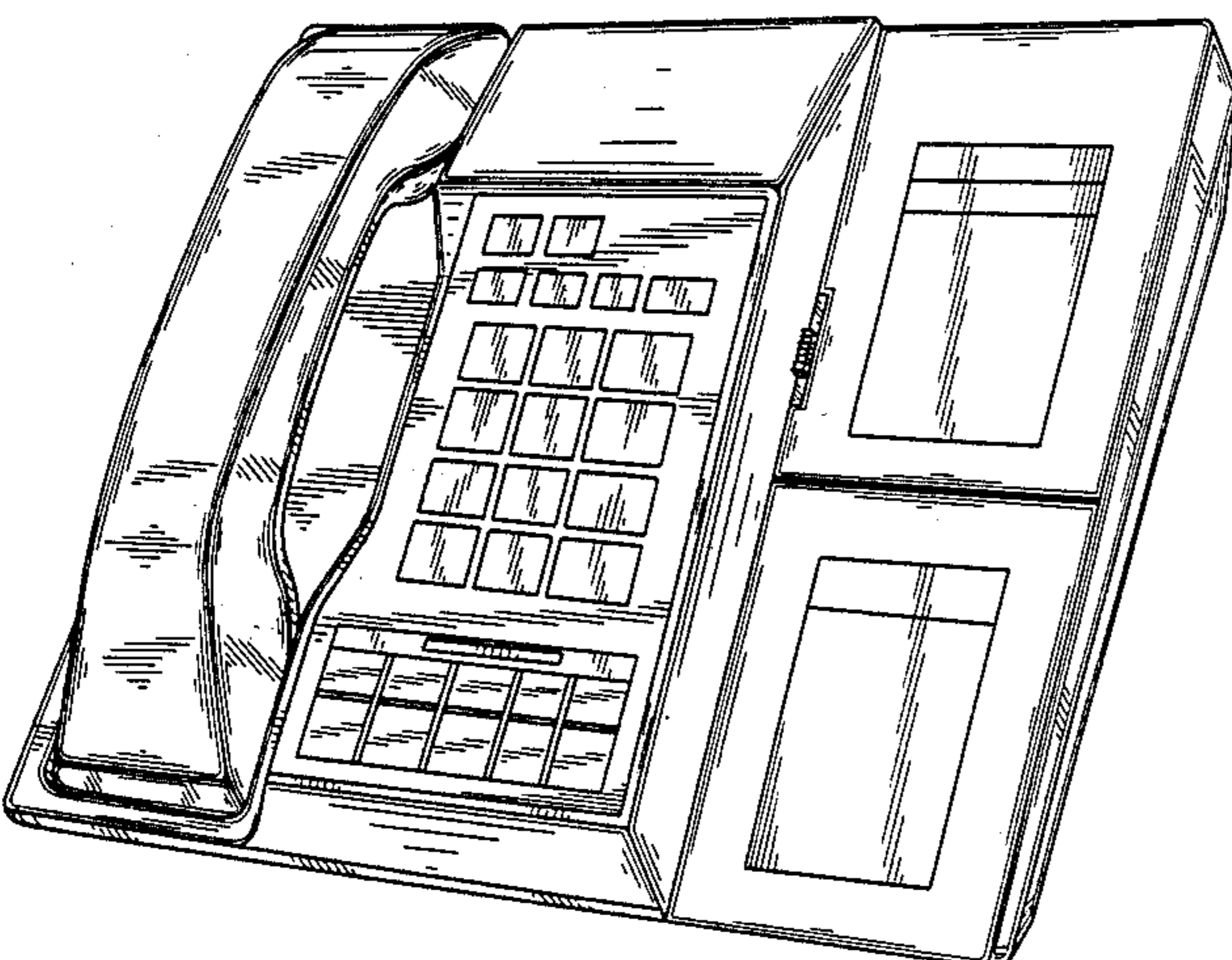

The ornamental design for telephone set, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and right side perspective view of a telephone set showing my new design in cradled relationship;  
 FIGS. 2 and 3 are respectively front and rear elevational views thereof;  
 FIGS. 4 and 5 are respectively right and left side elevational views thereof; and  
 FIGS. 6 and 7 are respectively top and bottom plan views thereof.



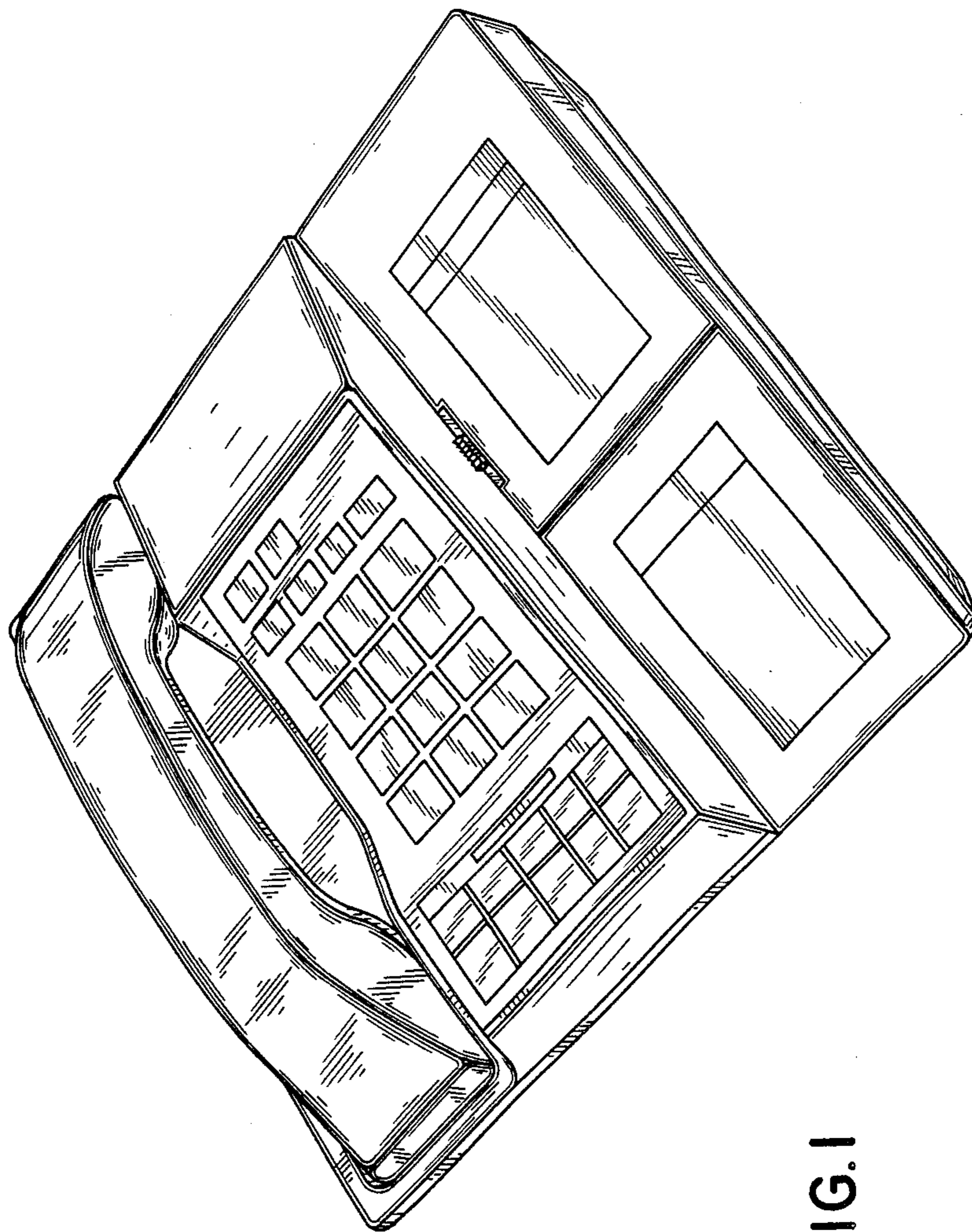

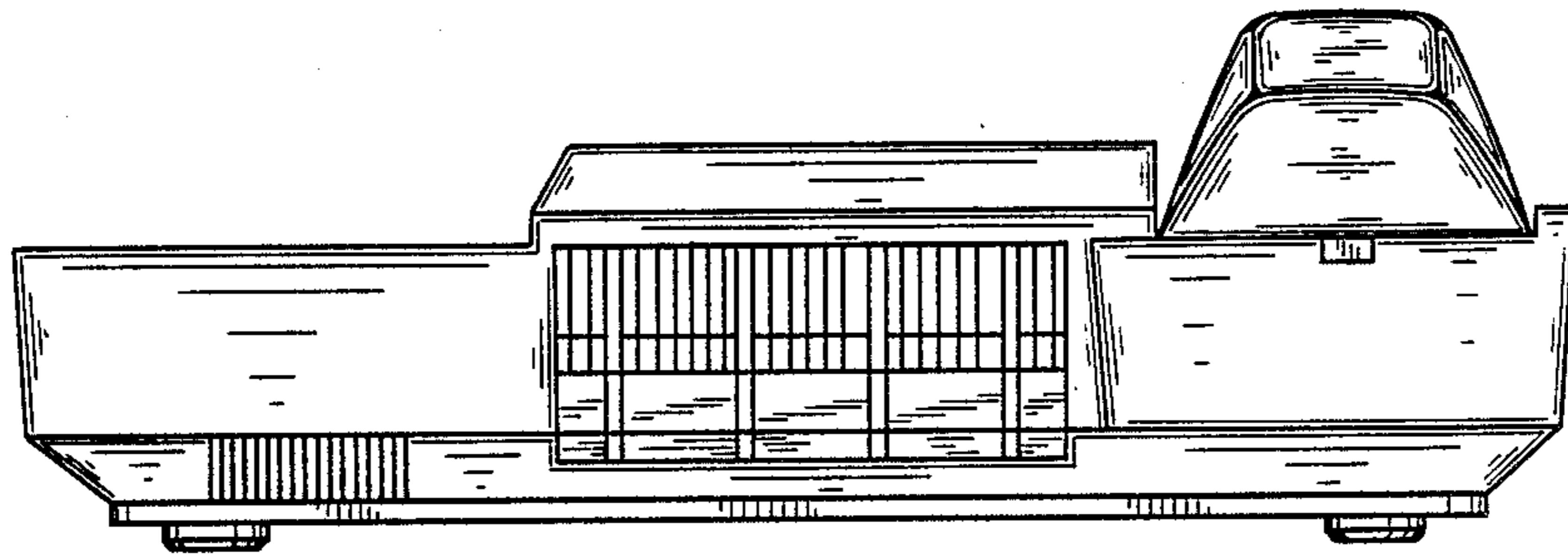
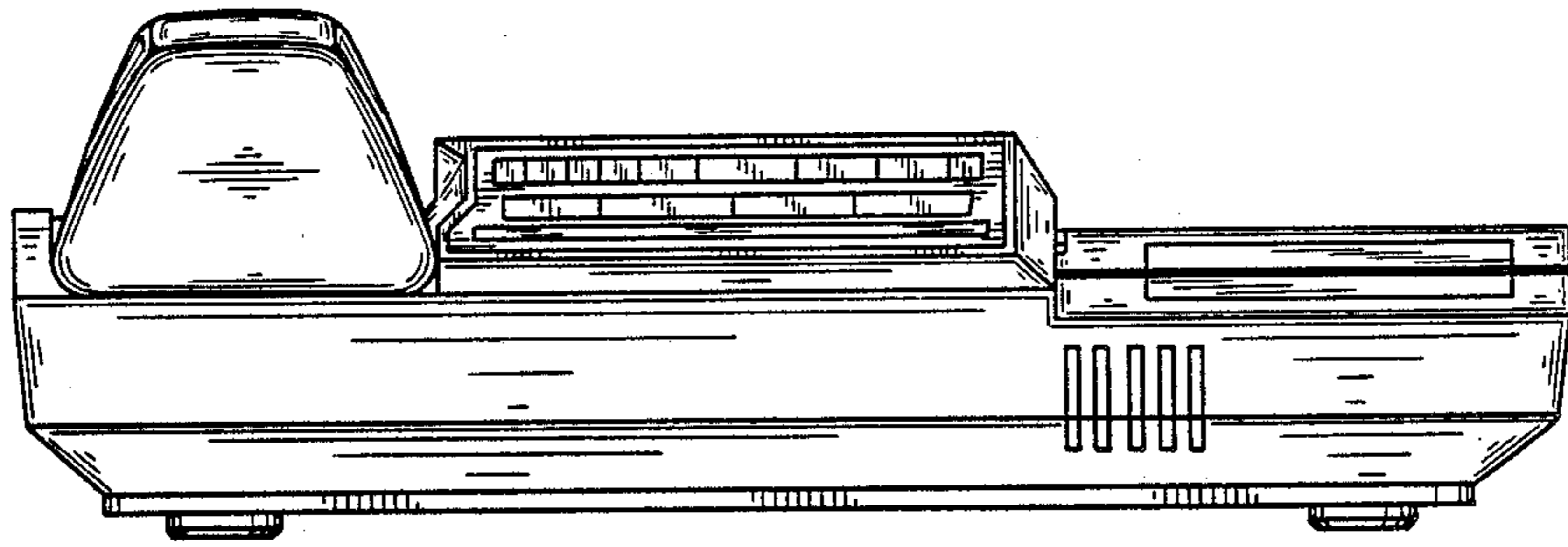

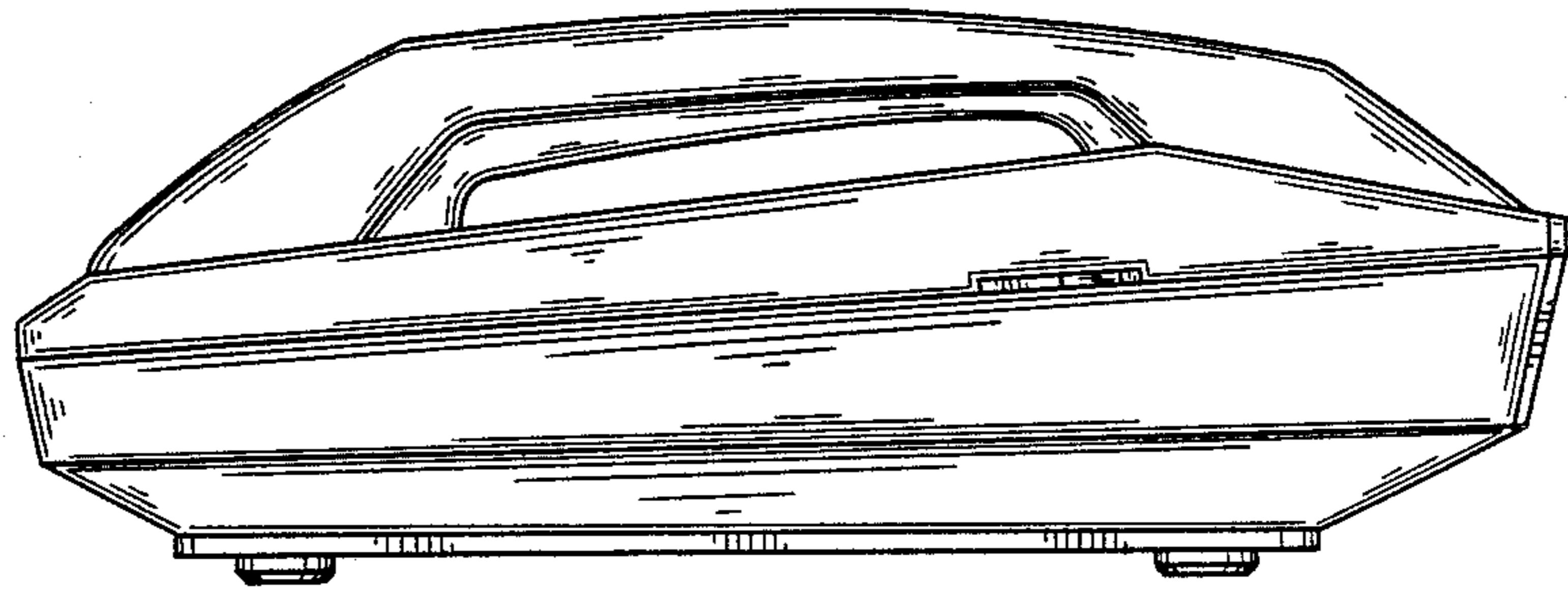

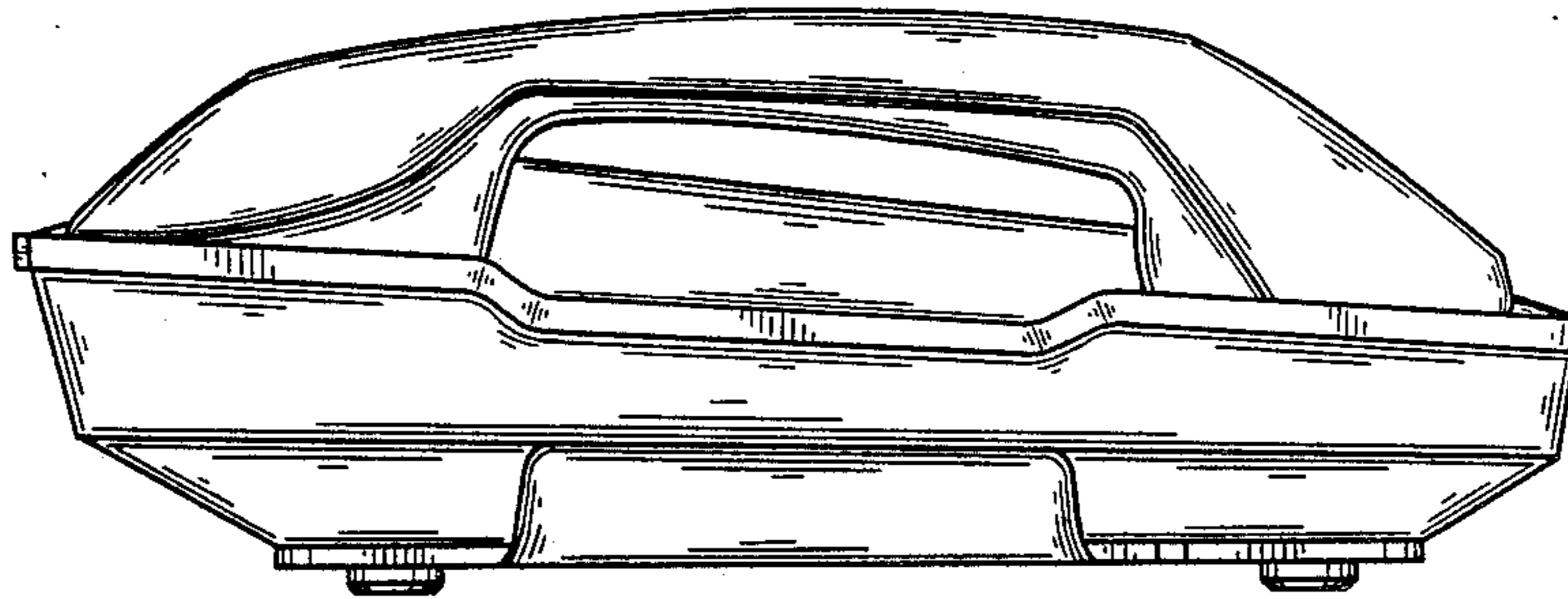

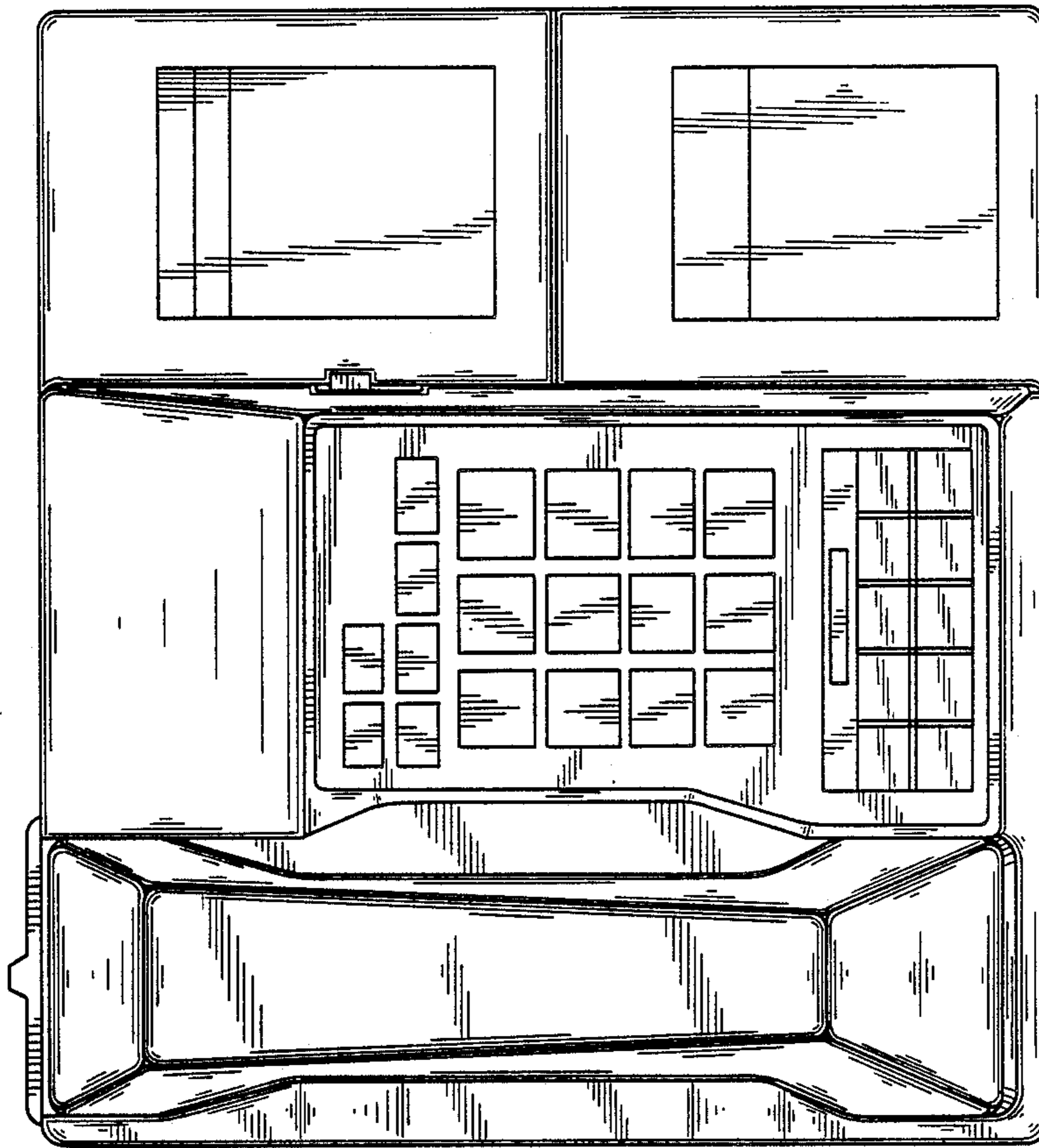
