[57] CLAIM

The ornamental design for a dental implant cleaning tool, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a dental implant cleaning tool showing our new design, the left side being the mirror image of that shown;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a front elevational view thereof; and  
 FIG. 5 is a rear elevational view thereof.

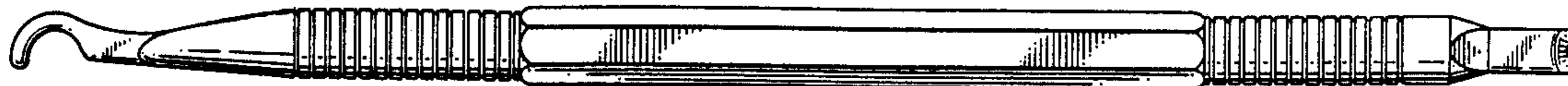
