The ornamental design for a blocker sole with tap insert, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a blocker sole with tap insert showing my new design;

FIG. 2 is an elevational view thereof;

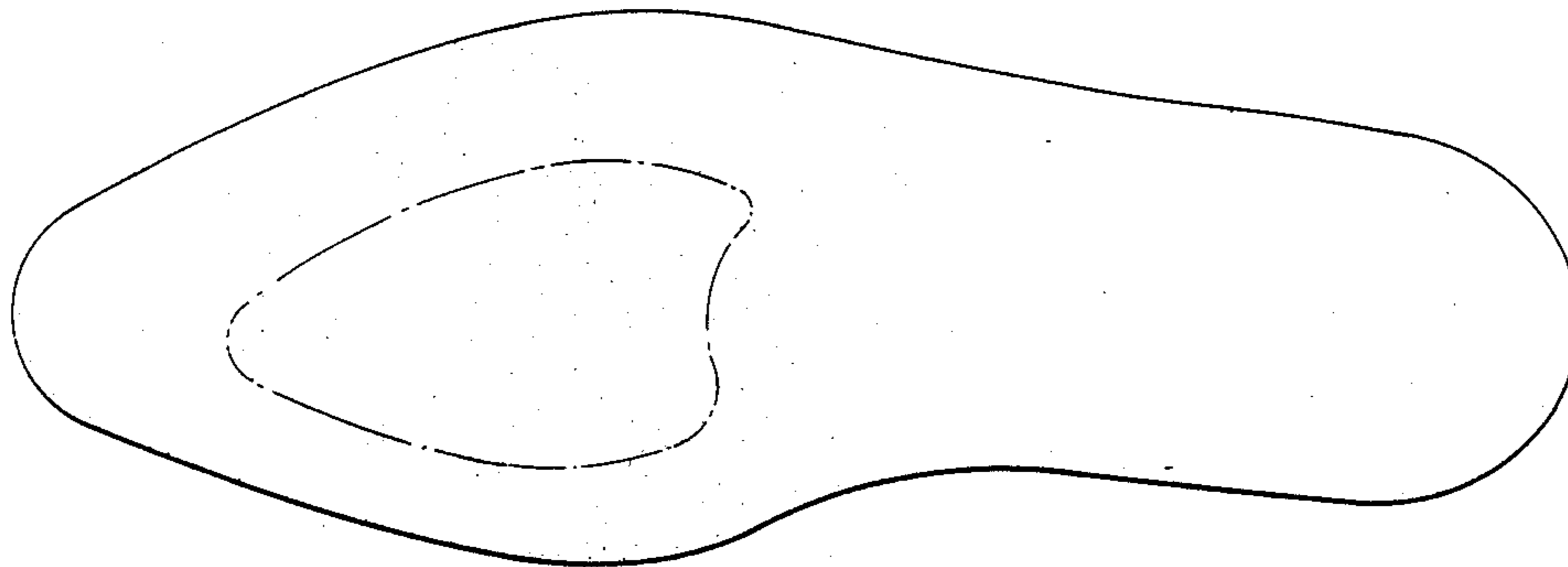
FIG. 3 is a bottom plan view thereof;

FIG. 4 is a side elevational view opposite to that of FIG. 2;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof.

The broken line showing of a domed bridge on the top in FIGS. 1, 2 and 4-6 is for illustrative purposes only and forms no part of the claimed design.



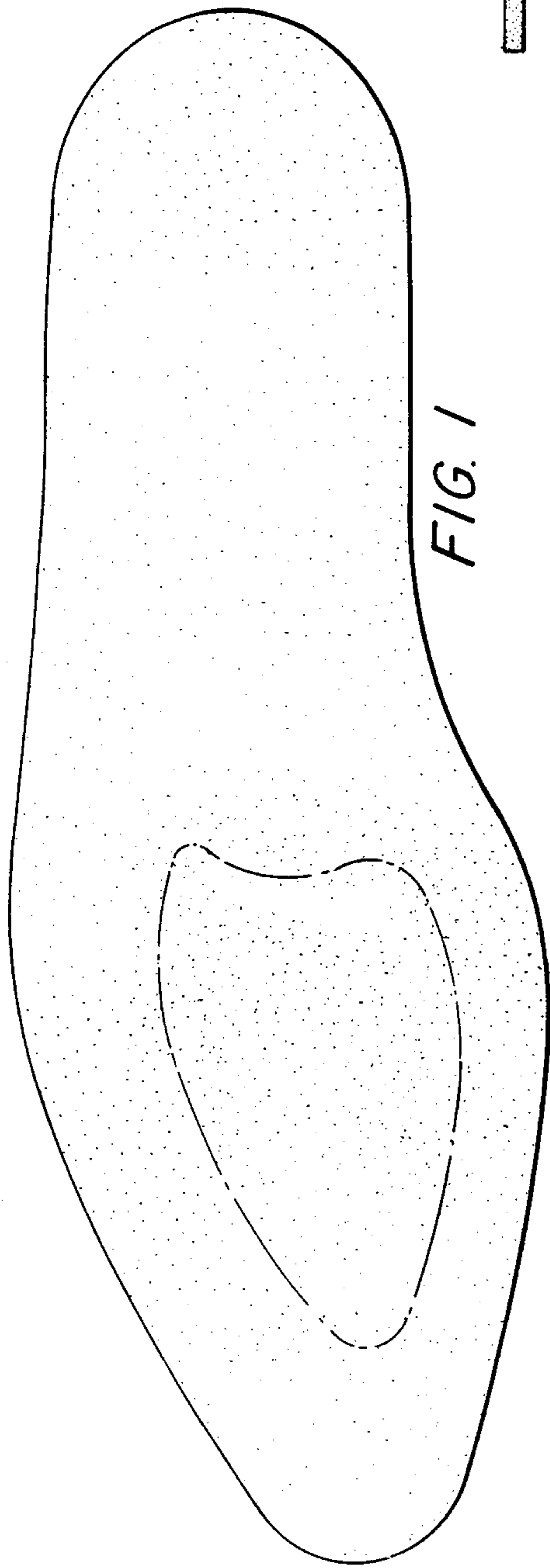

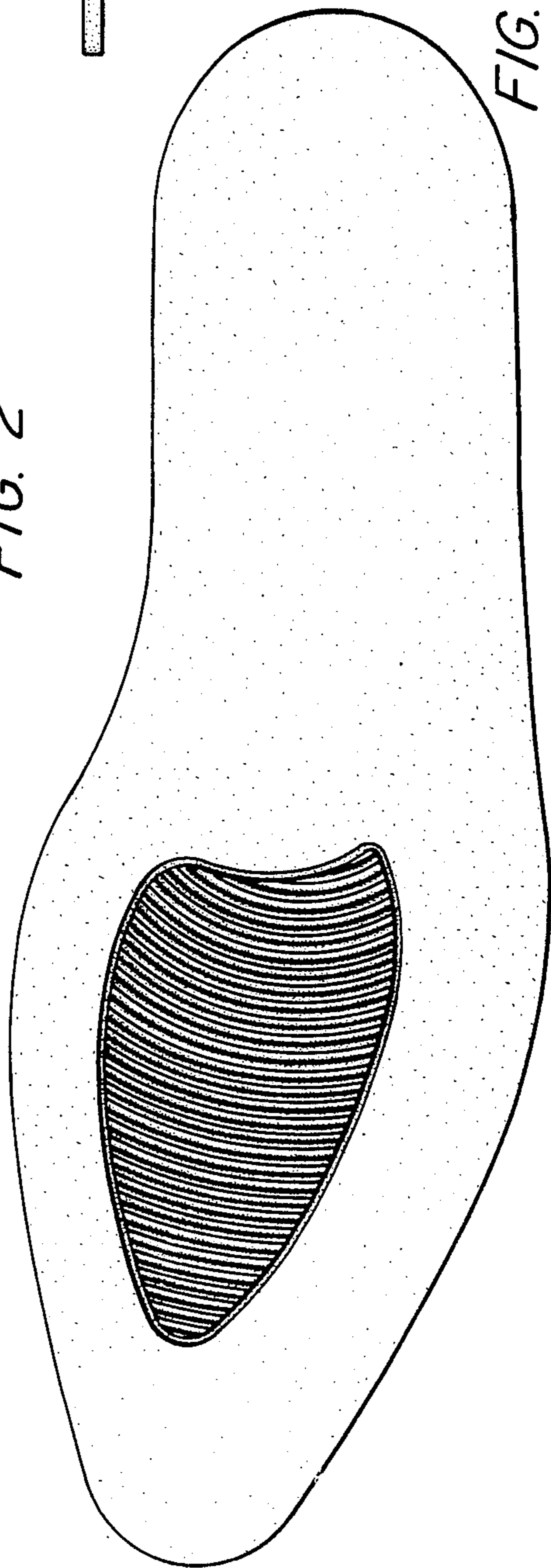
