The ornamental design for writing case, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a writing case showing my new design;
 FIG. 2 is a rear elevational view;
 FIG. 3 is a top plan view, the bottom plan view being identical;
 FIG. 4 is a right side elevational view, the left side view being identical;
 FIG. 5 is a top plan view of the cap portion of the writing case, the body portion having been omitted for ease of illustration;
 FIG. 6 is a bottom plan view;
 FIG. 7 is a front elevational view, the rear elevational view being identical;
 FIG. 8 is a right side elevational view, the left side view being identical;
 FIG. 9 is a top plan view of the main body portion of the writing case, the cap portion having been omitted for ease of illustration;
 FIG. 10 is a bottom plan view;
 FIG. 11 is a front elevational view;
 FIG. 12 is a rear elevational view;
 FIG. 13 is a right side elevational view, the left side view being identical; and
 FIG. 14 is a rear perspective view thereof.

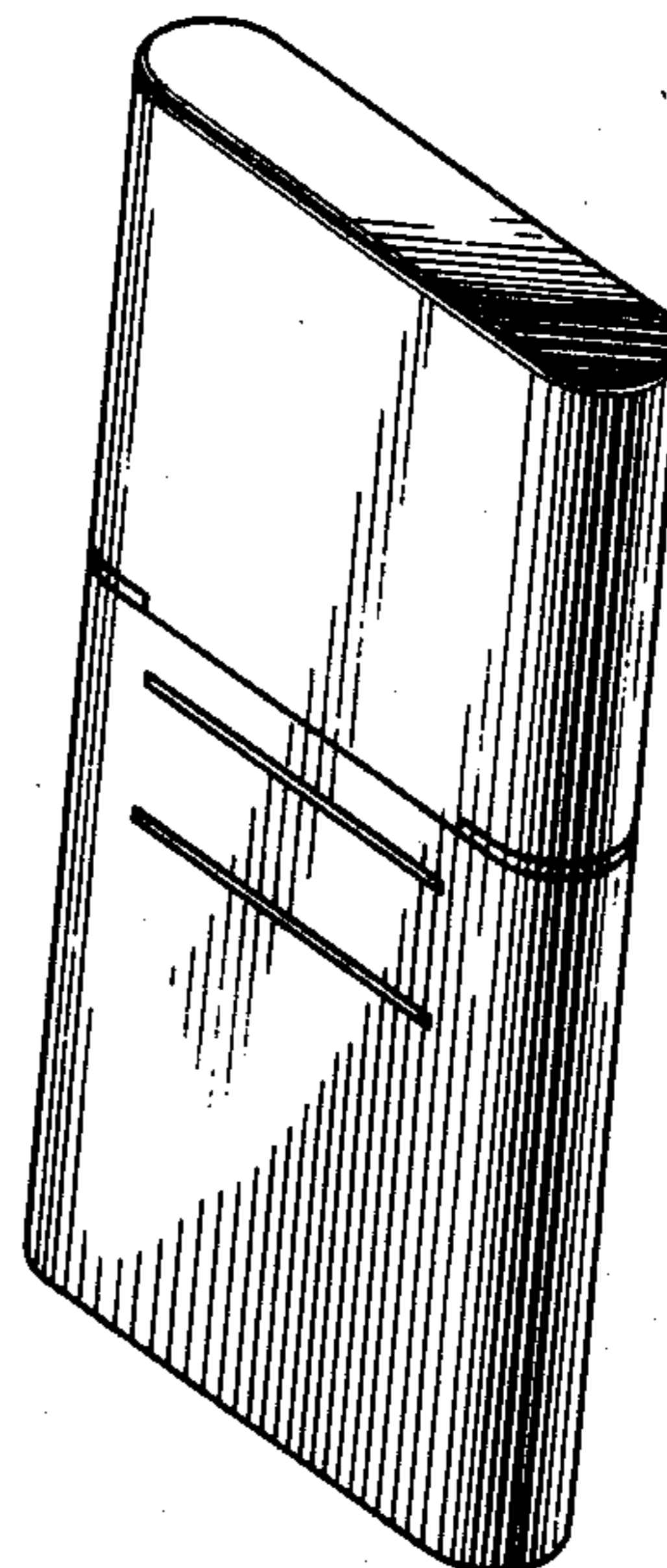
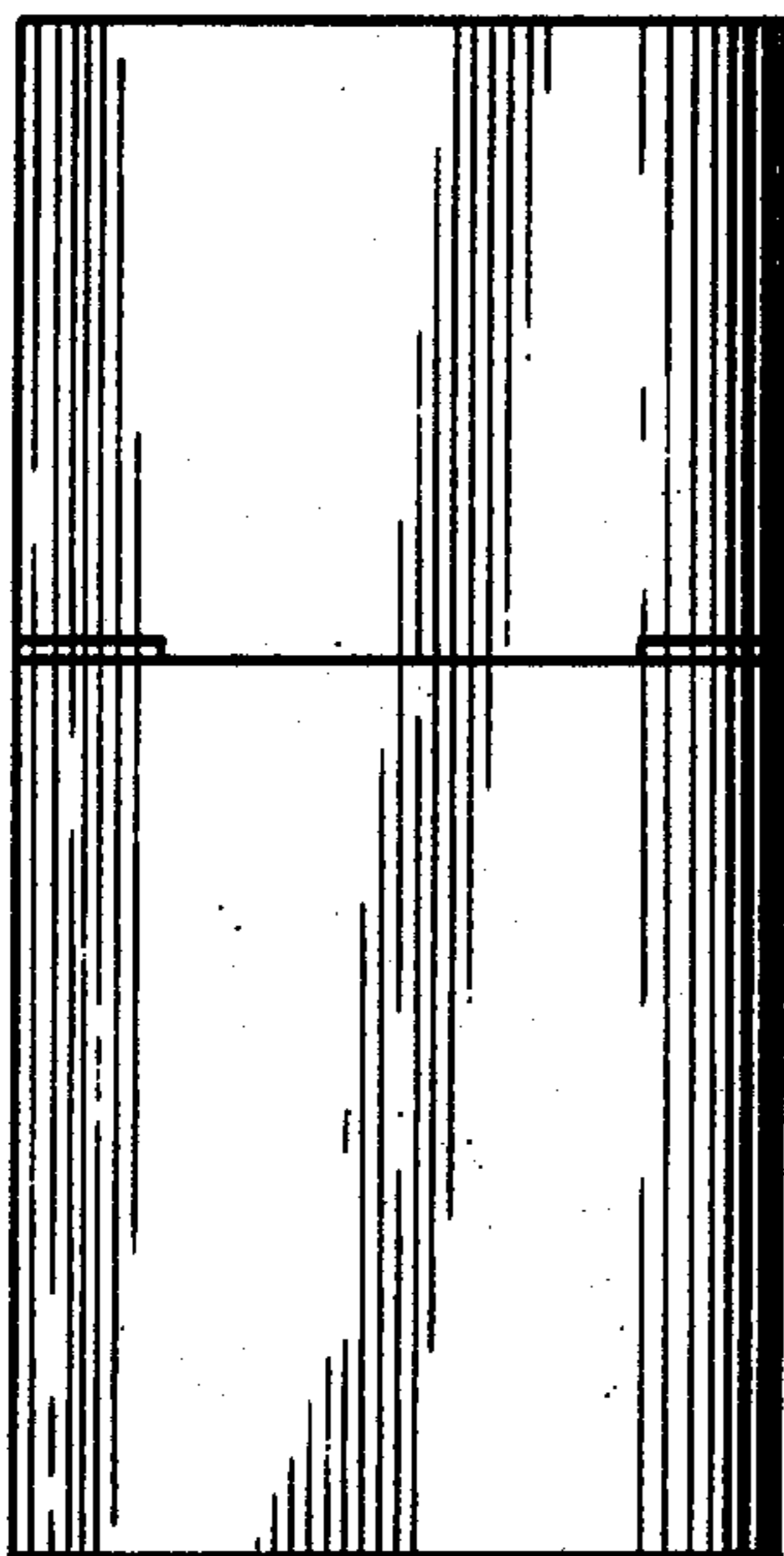

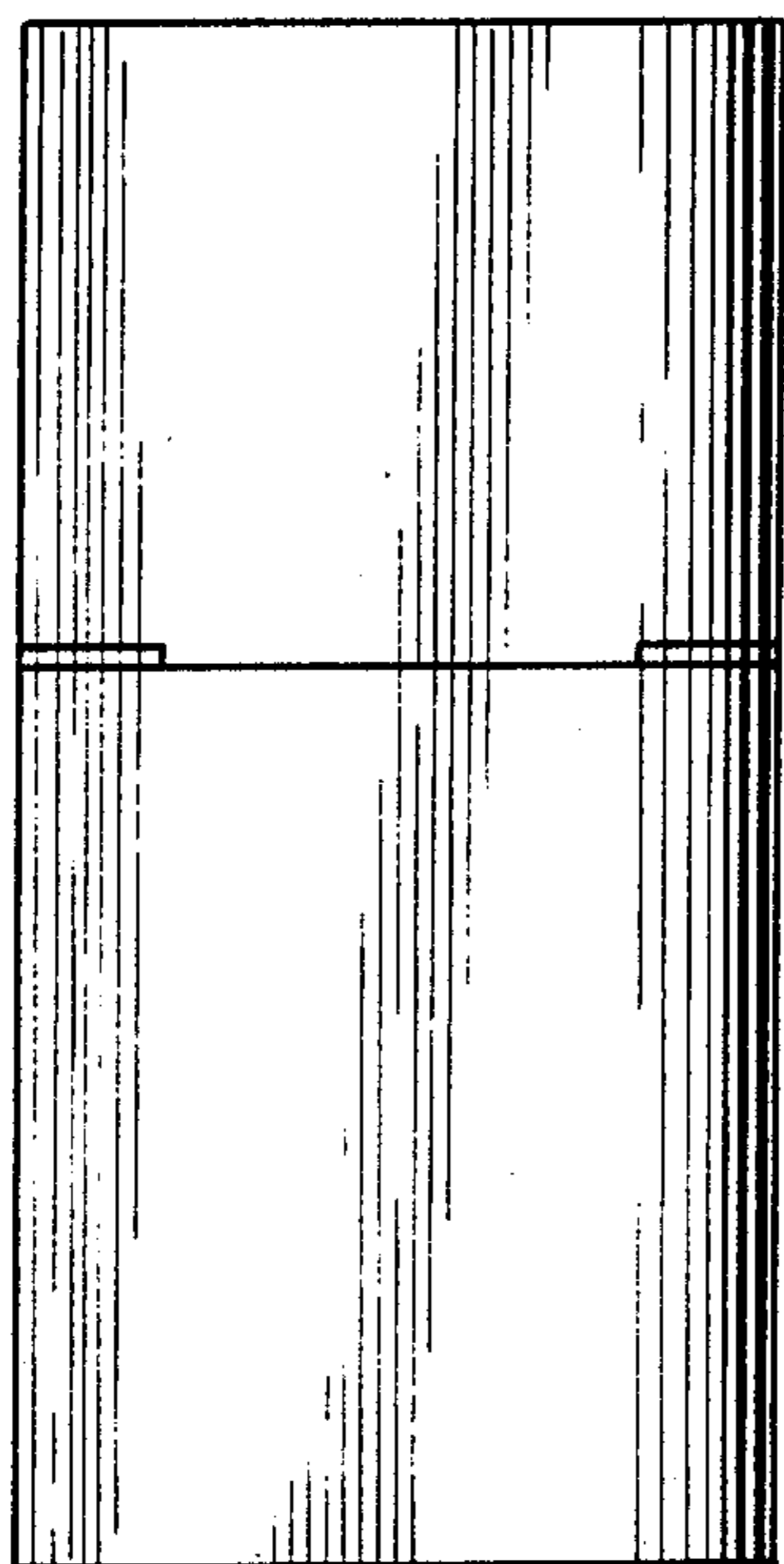

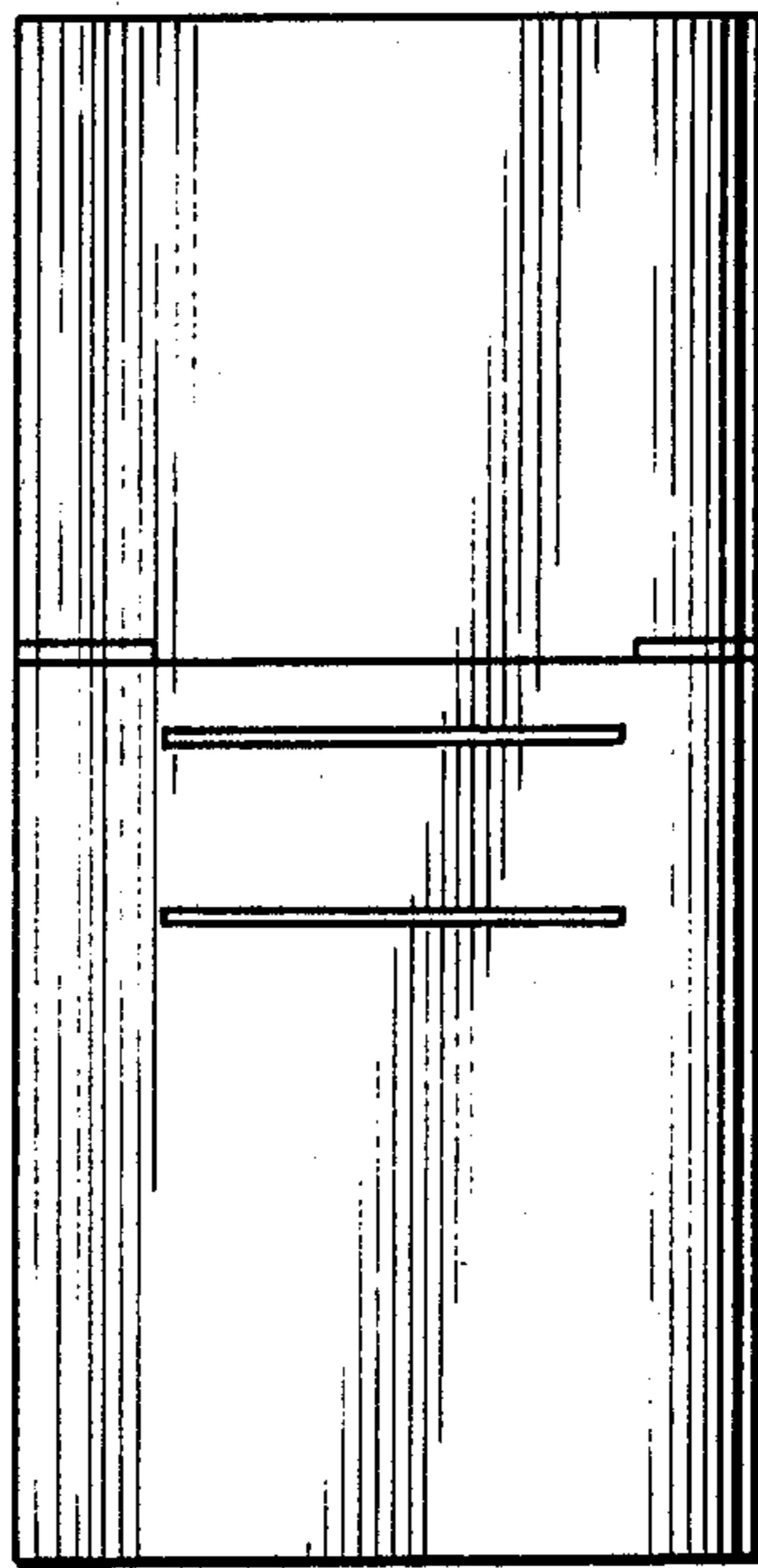

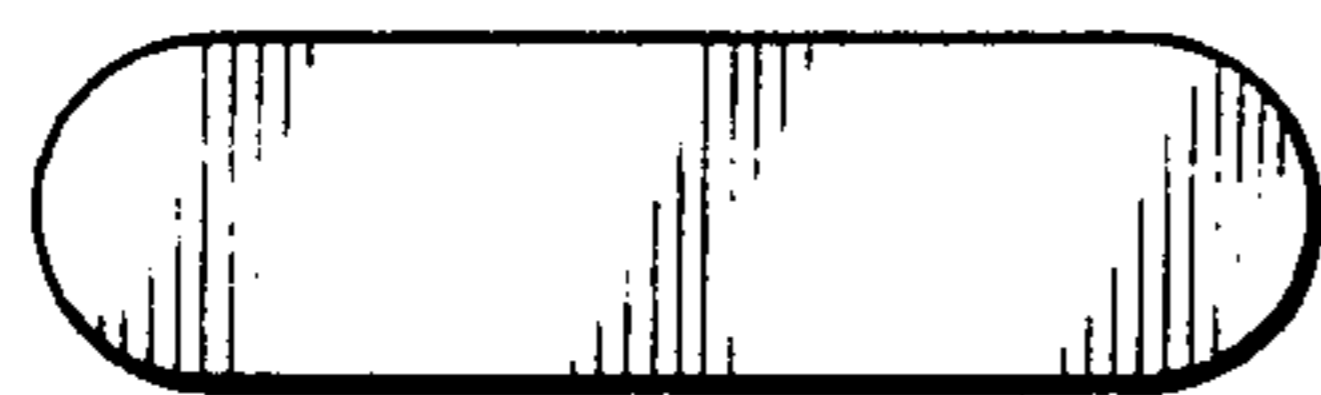

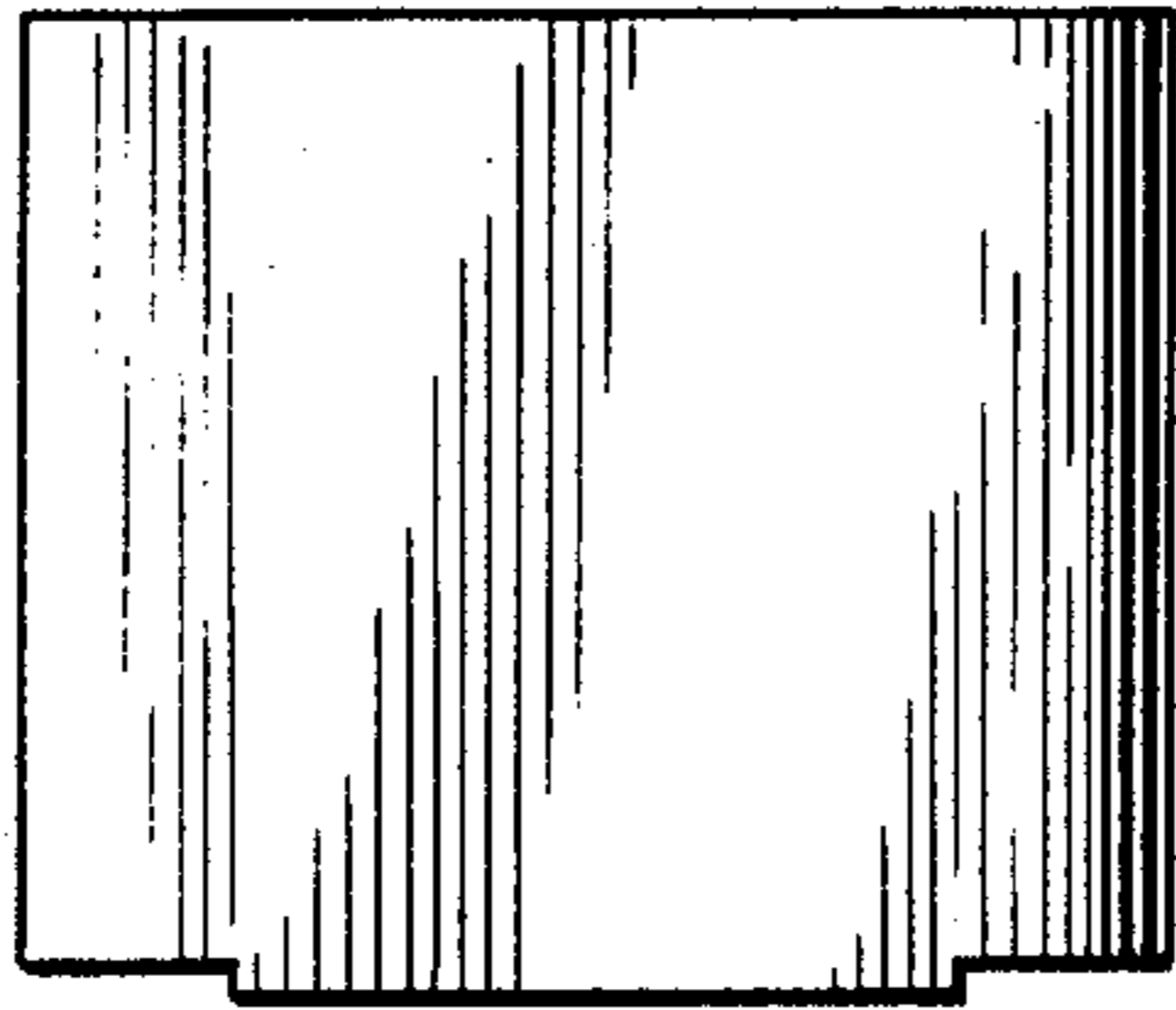

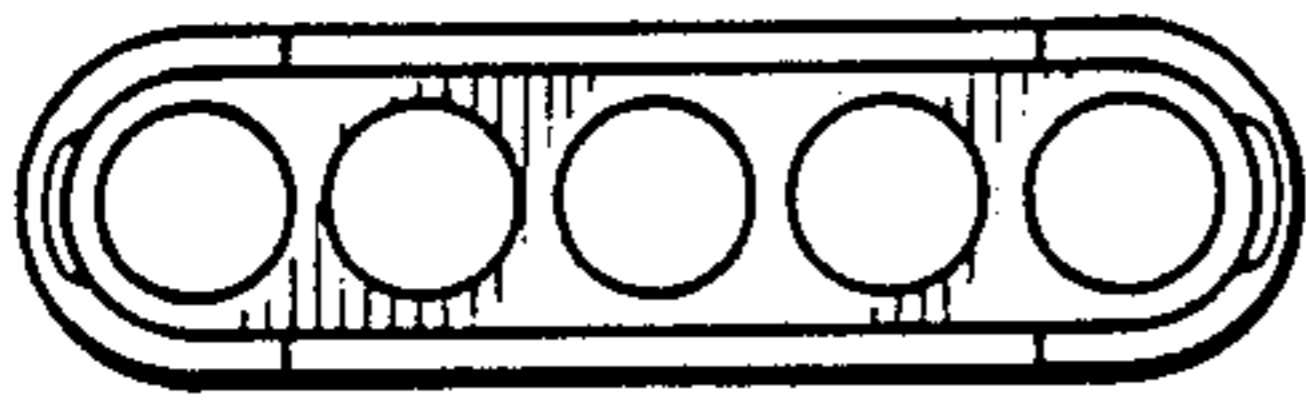

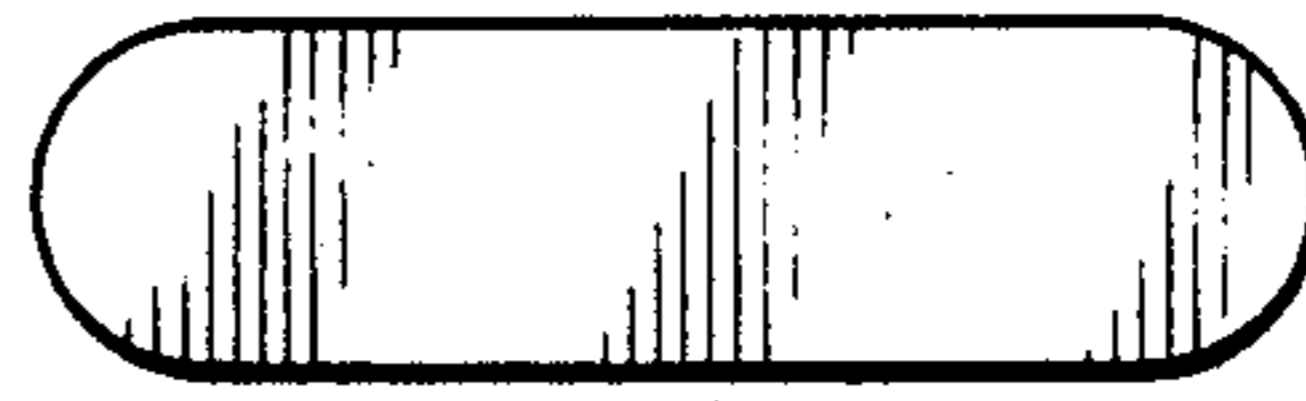

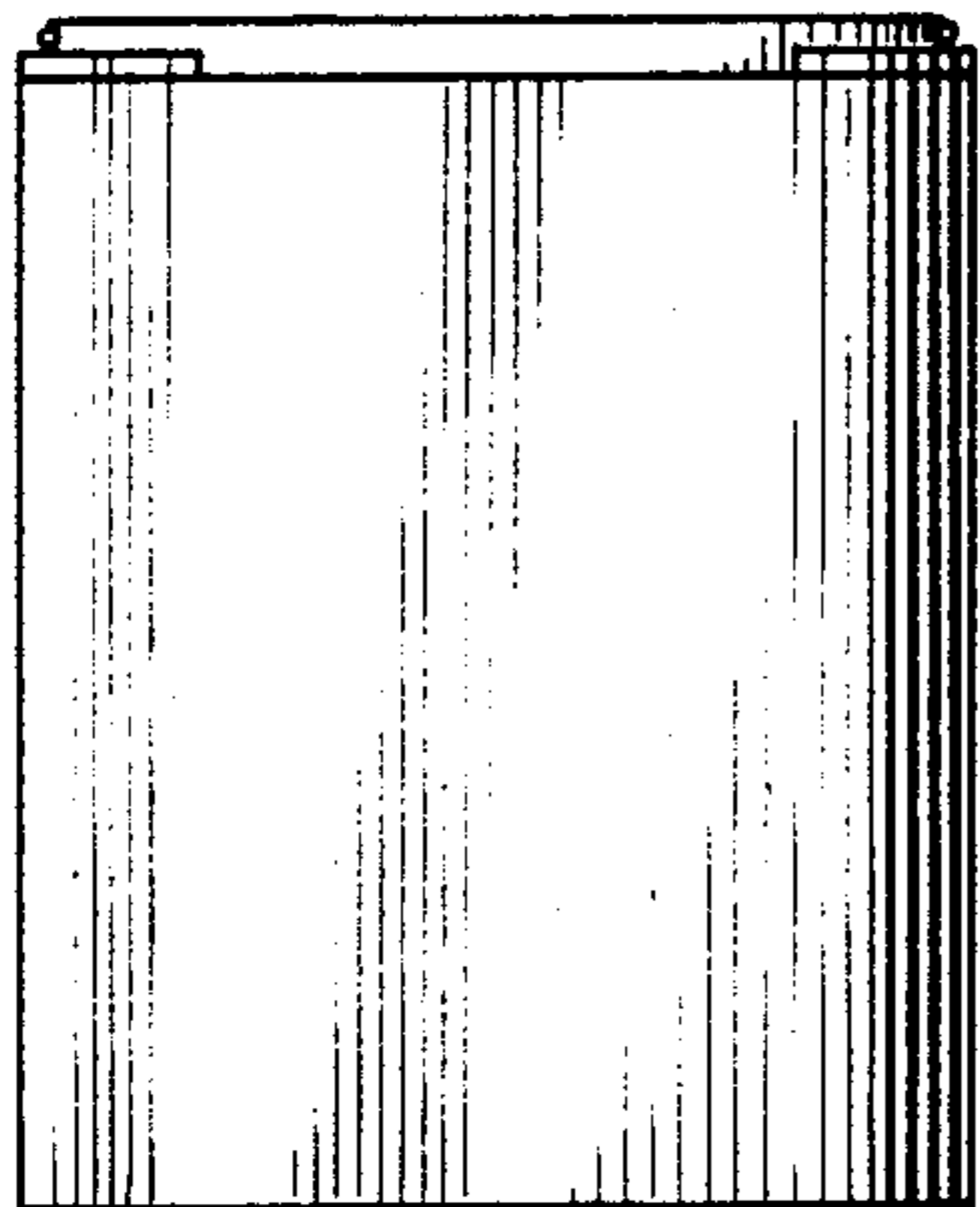

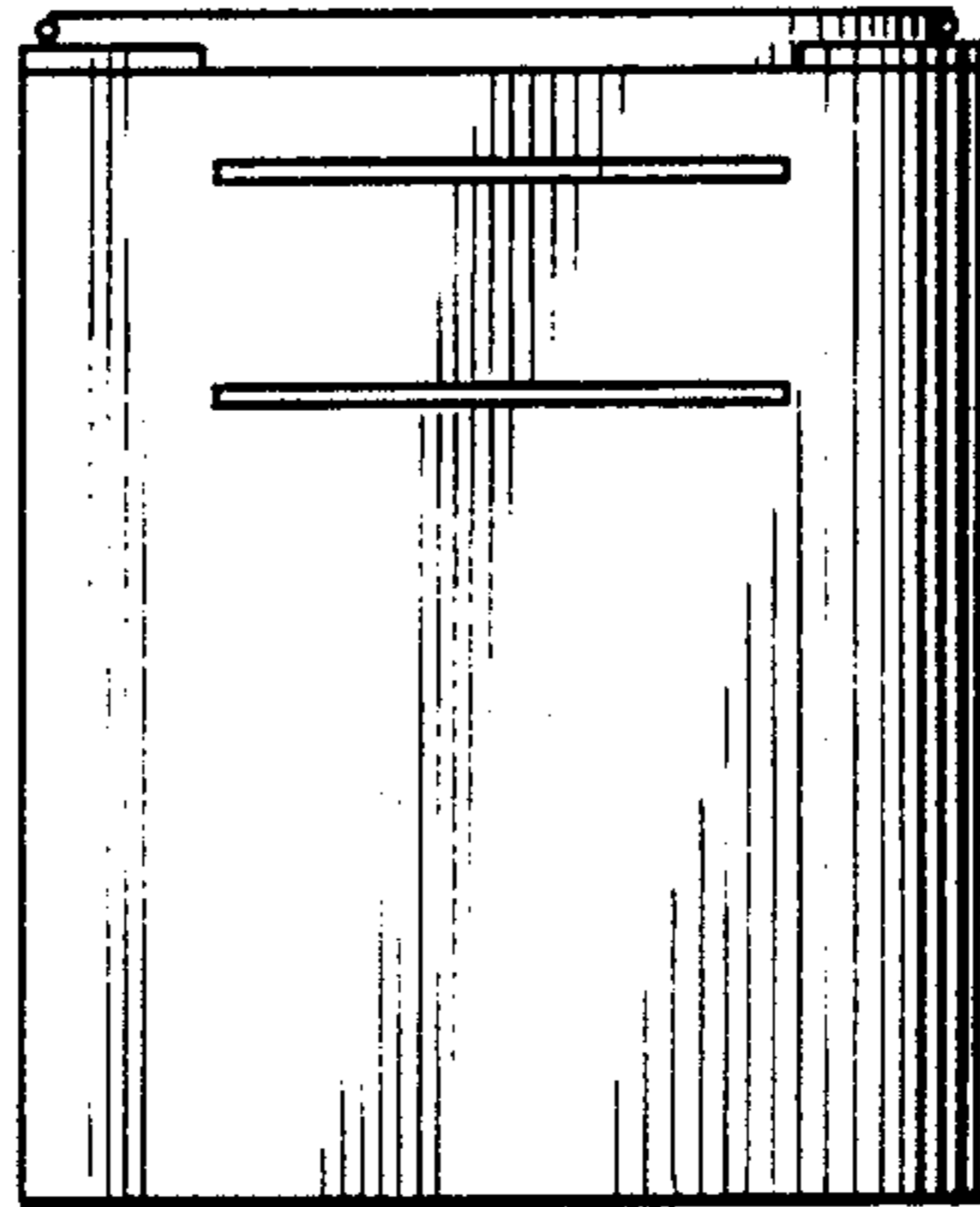

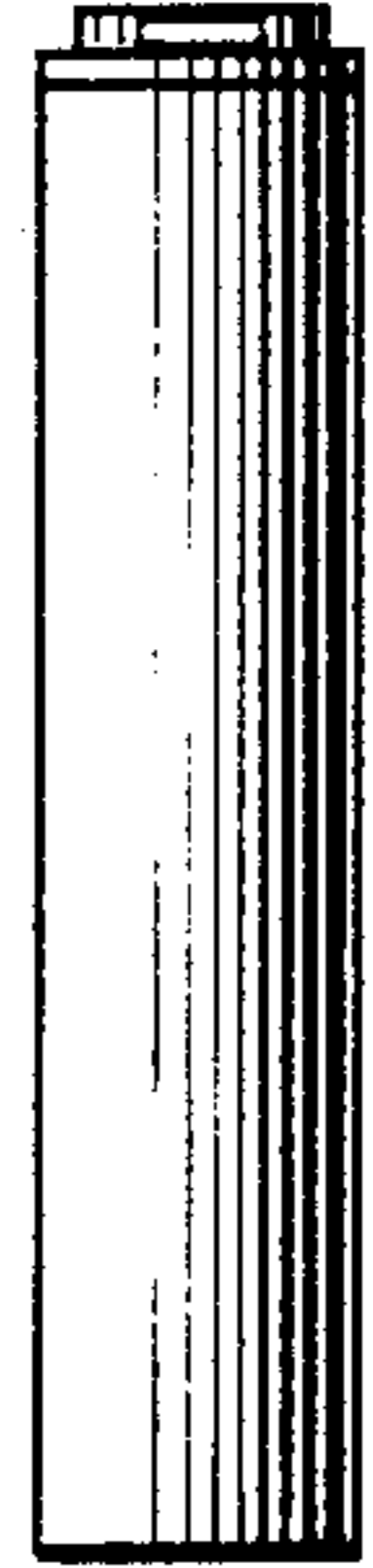
