[57] CLAIM

The ornamental design for a point-of-sale terminal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the front and left side of a point-of-sale terminal showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side being a mirror image of the left side shown;

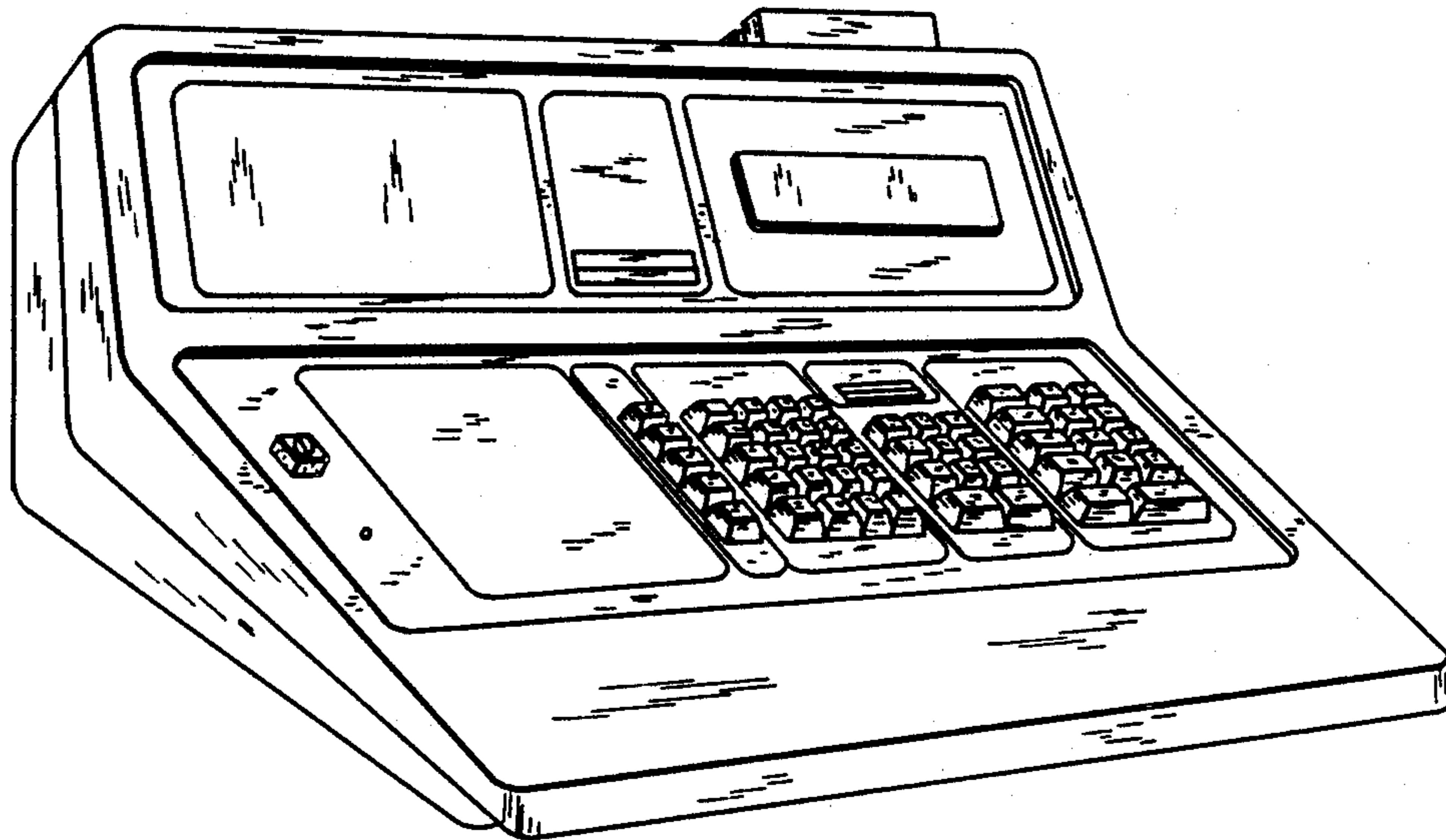
FIG. 5 is a perspective view taken from the front and left side of a modified form of the point-of-sale terminal shown in FIG. 1;

FIG. 6 is a top plan view of FIG. 5;

FIG. 7 is a rear elevational view of FIG. 5;

FIG. 8 is a left side elevational view of FIG. 5, the right side being a mirror image of the left side shown; and,

FIG. 9 is a perspective view taken from the front and left side of a second modified form of the point-of-sale terminal shown in FIG. 1.



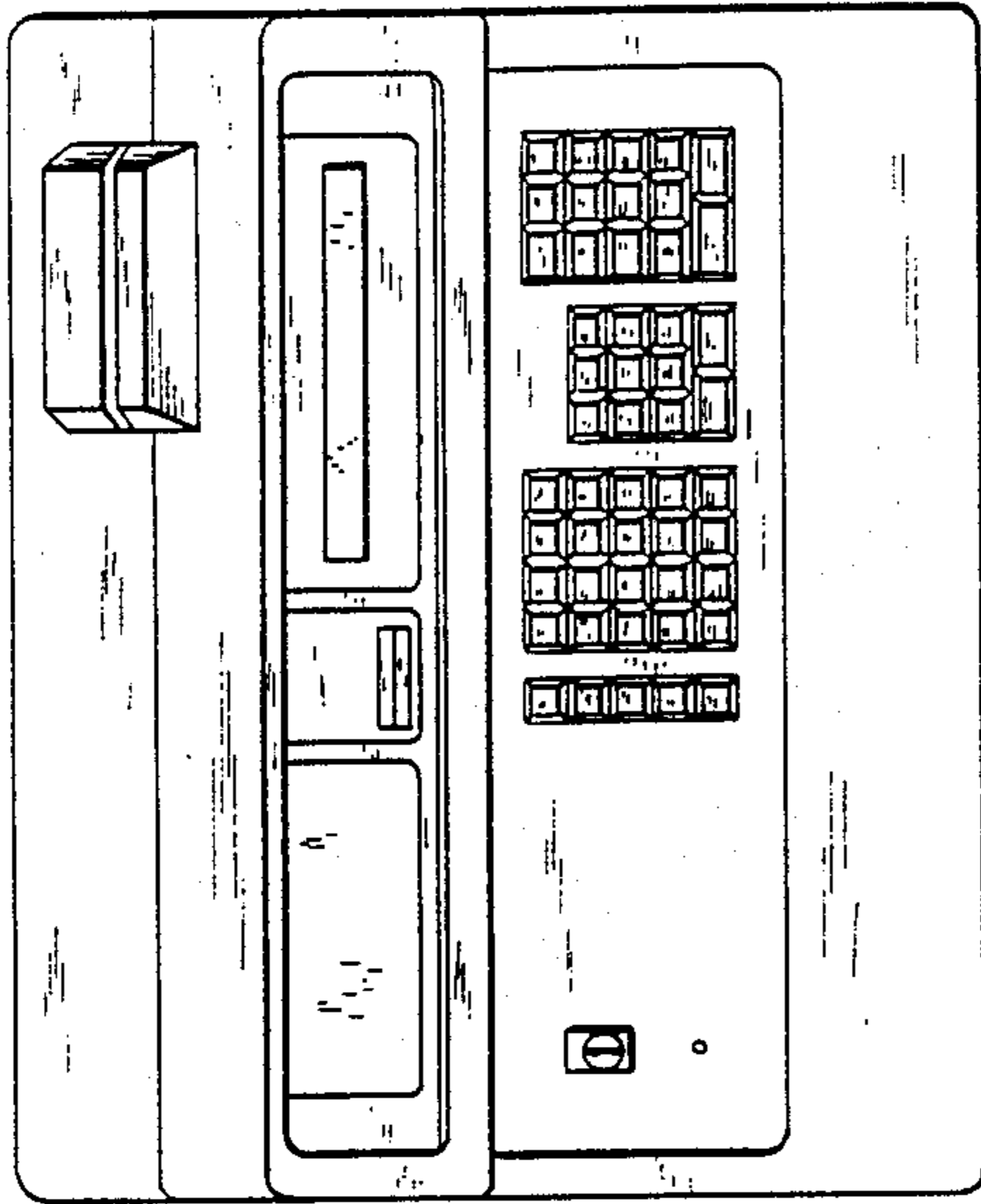

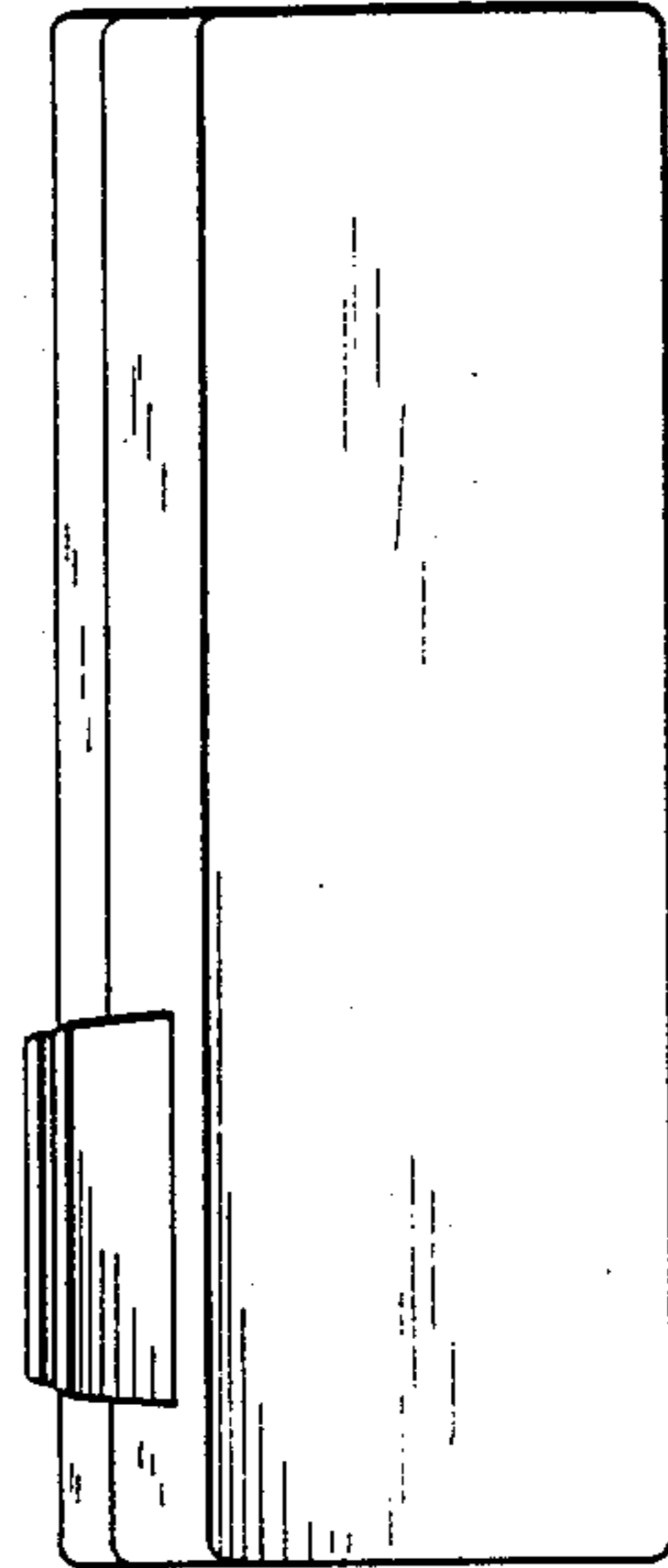

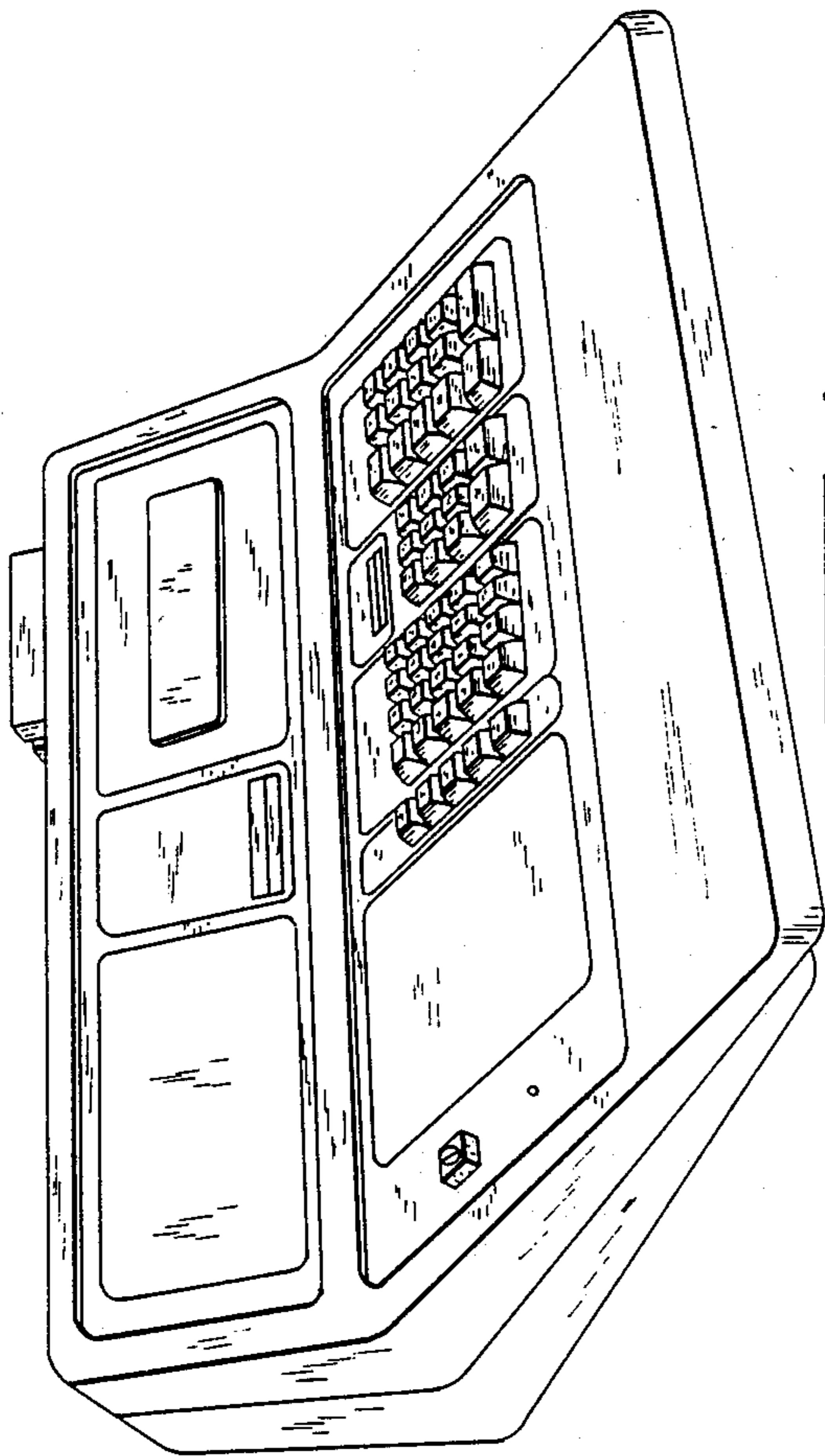

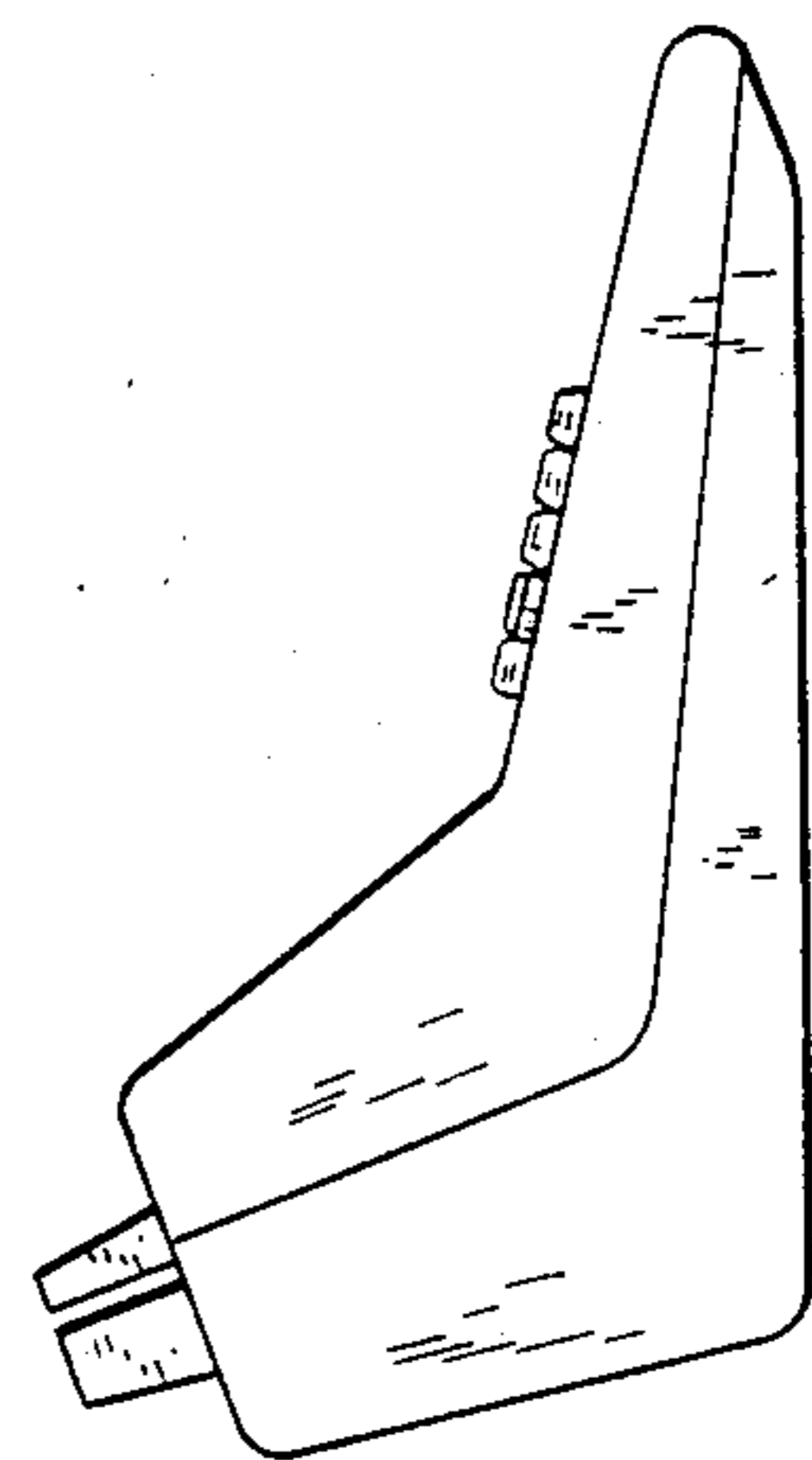

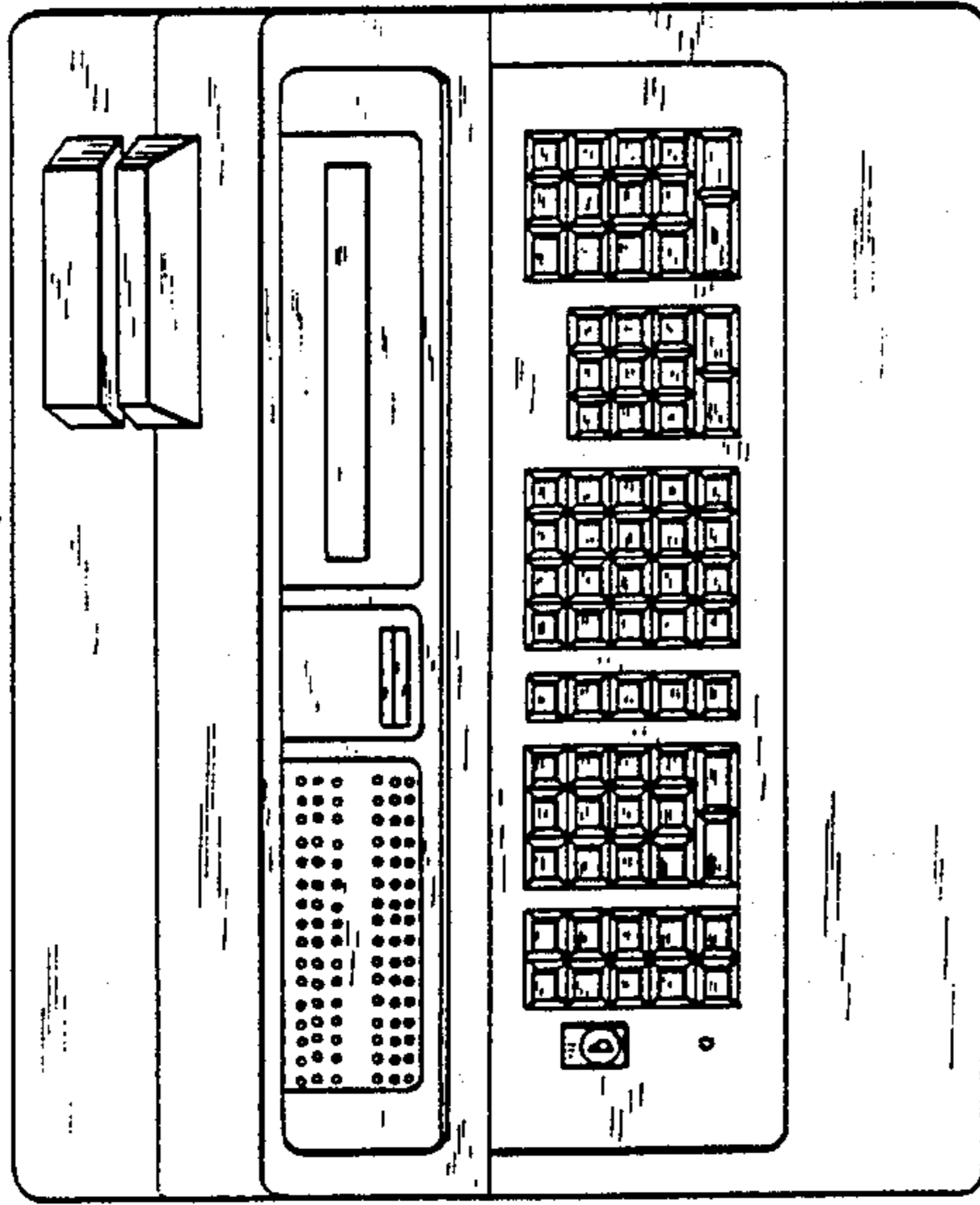

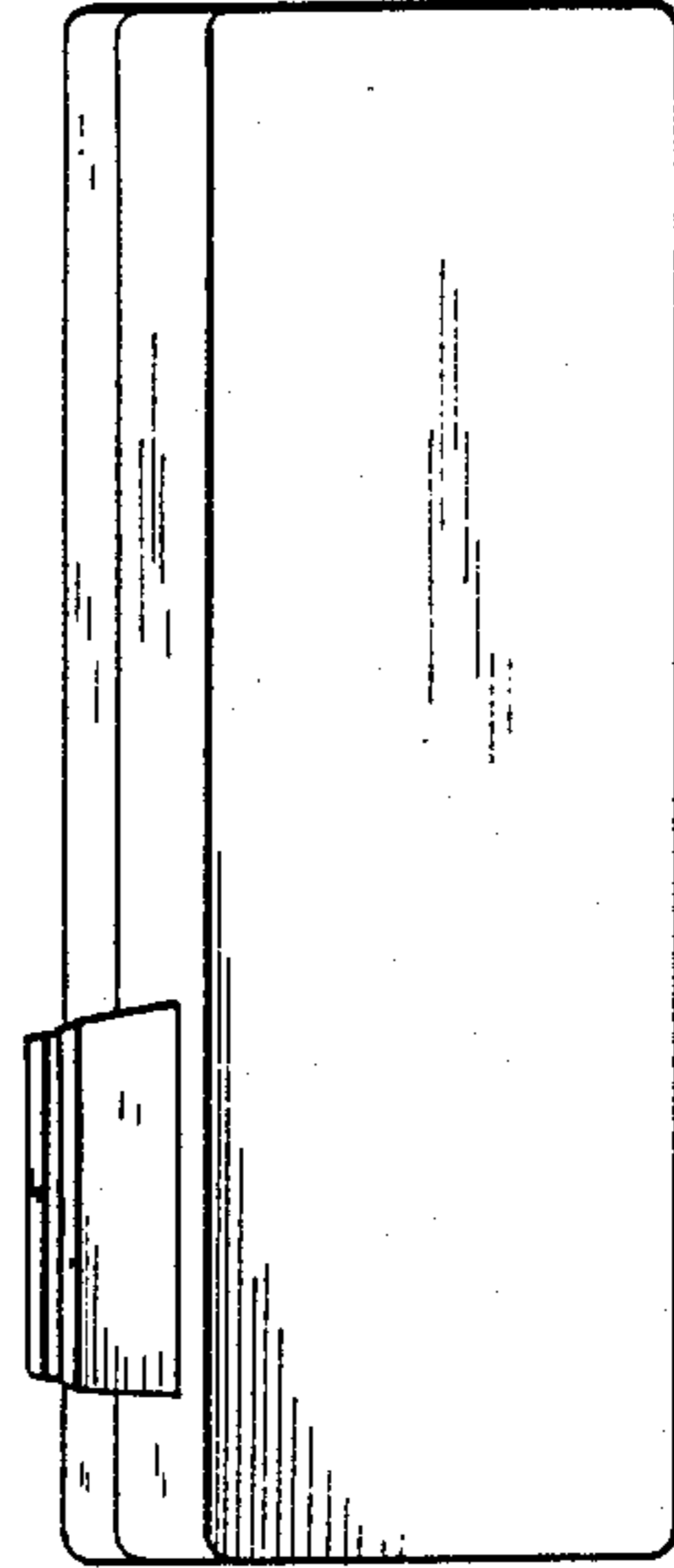

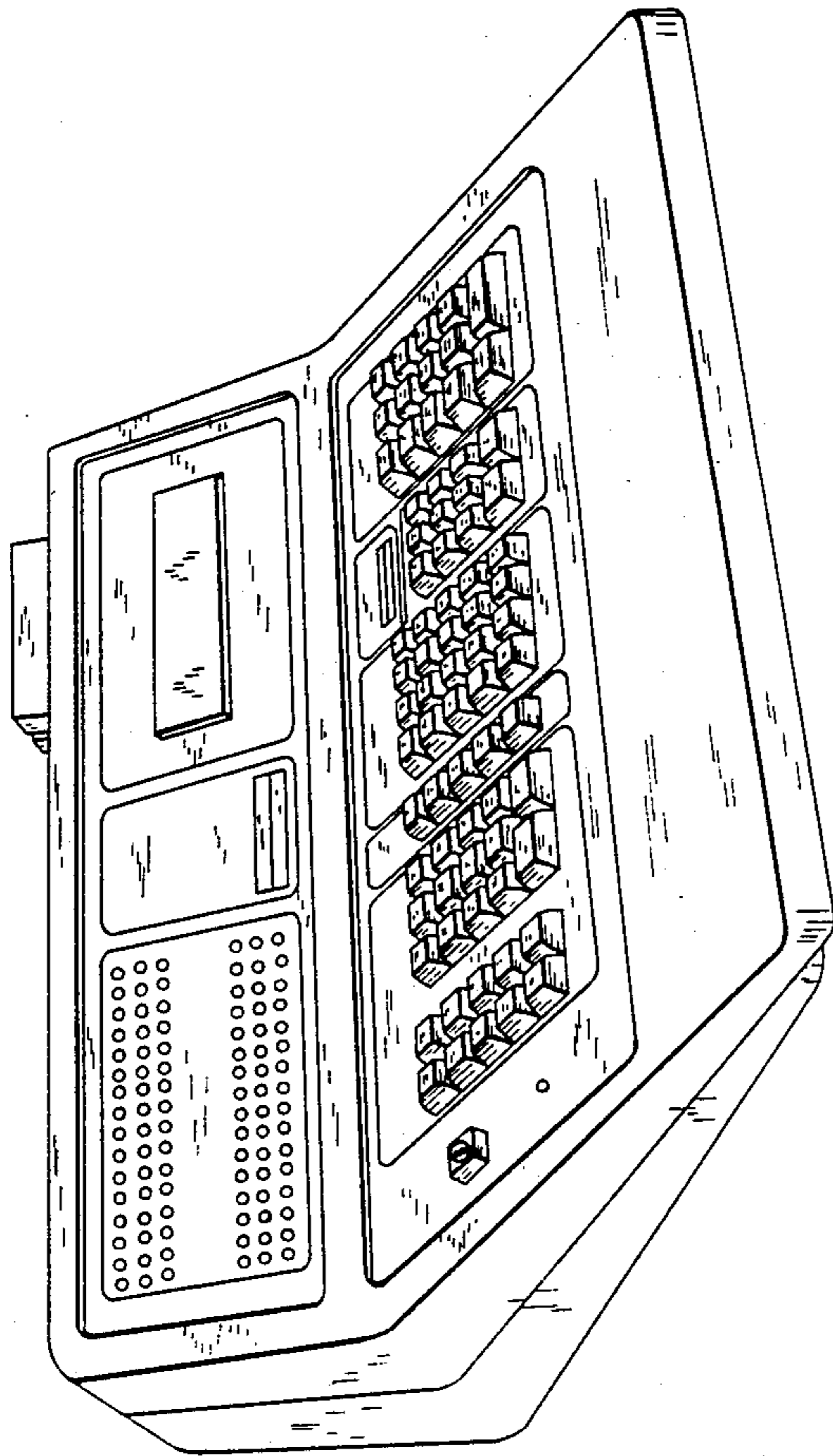

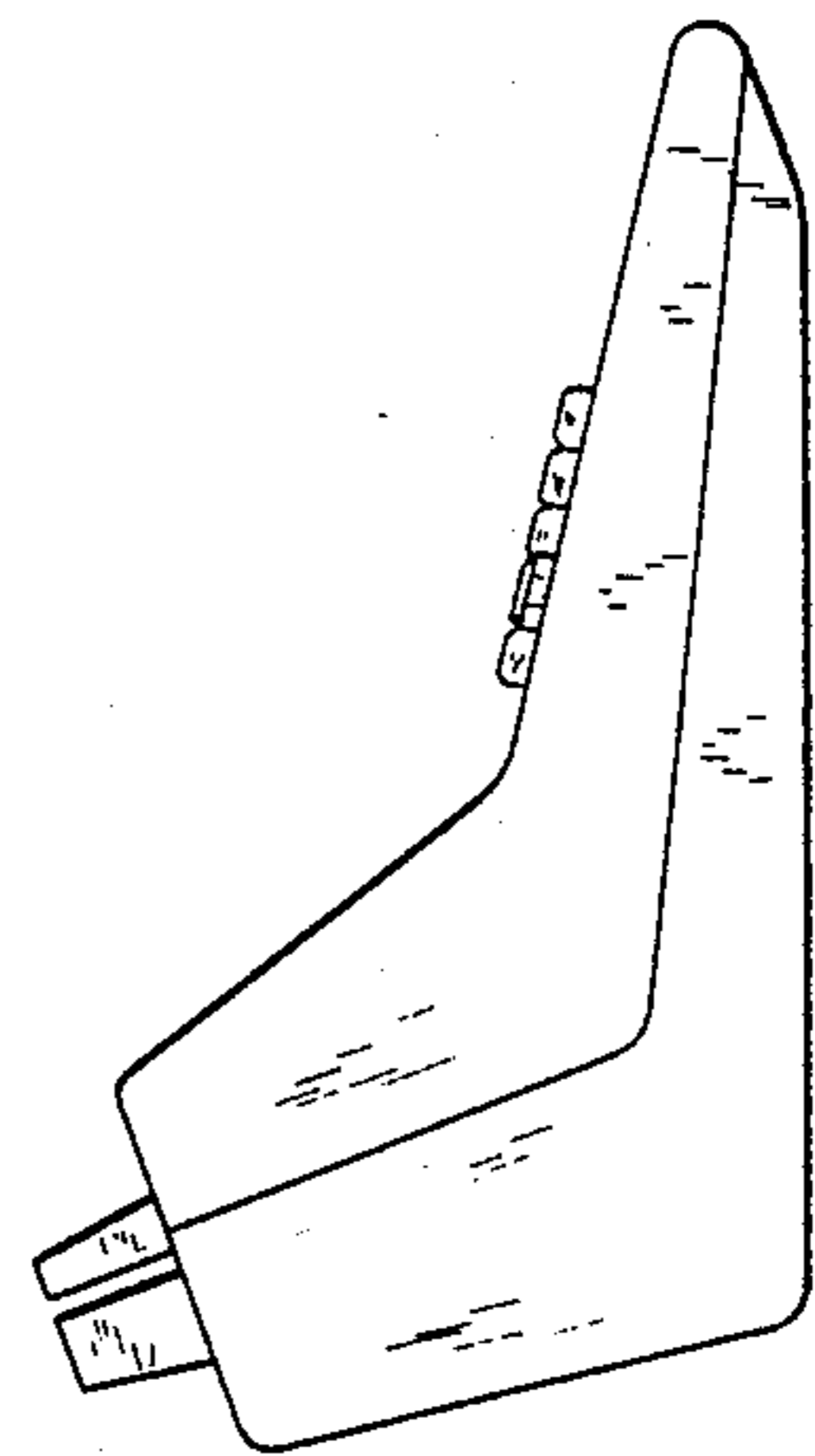

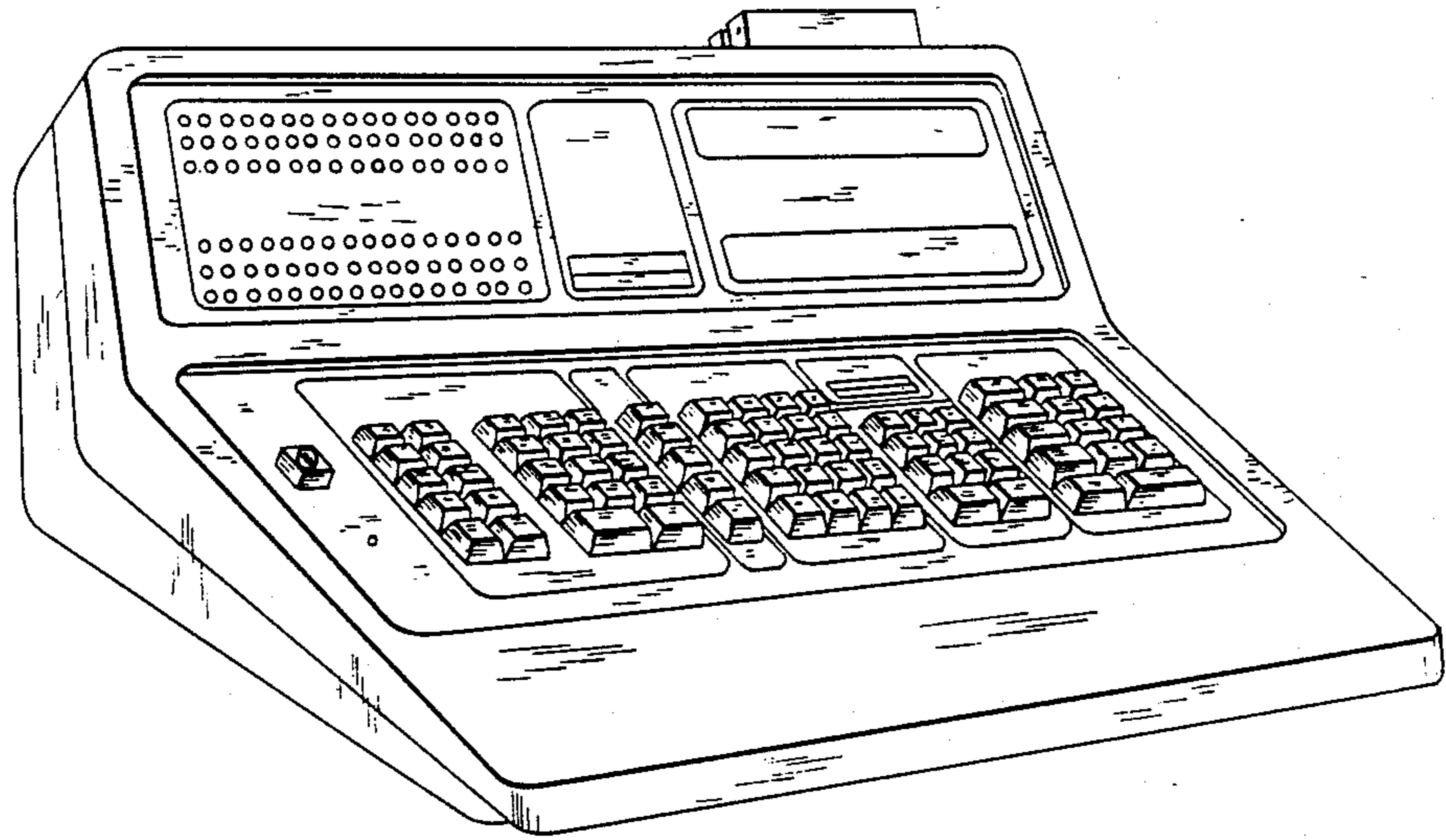
