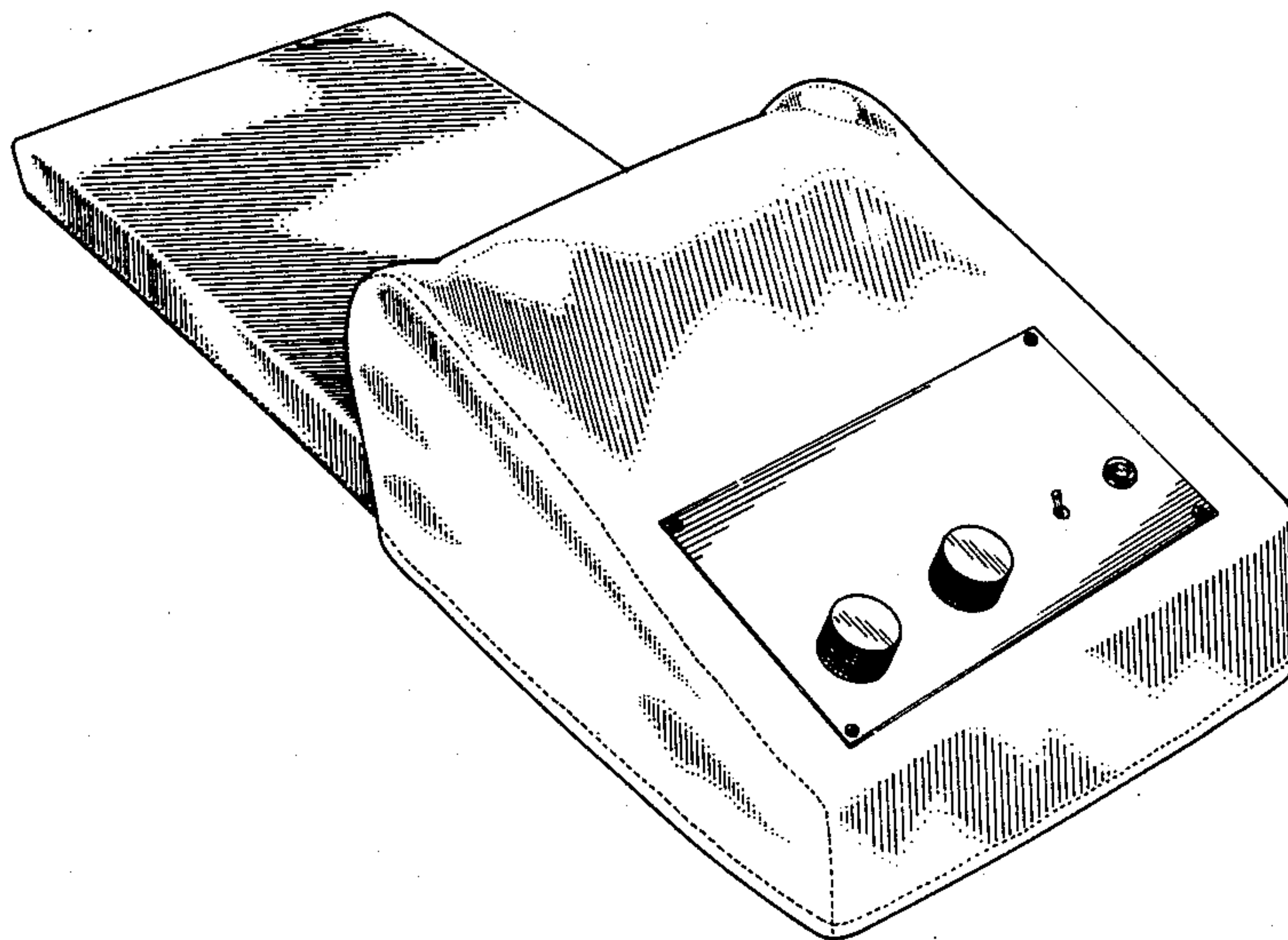

The ornamental design for a massager or similar article, as shown and described herein.

DESCRIPTION

FIG. 1 is a perspective view of a massager or similar article showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a back elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a top plan view thereof.  
The broken lines appearing in FIGS. 1-7 is conventional topstitching.



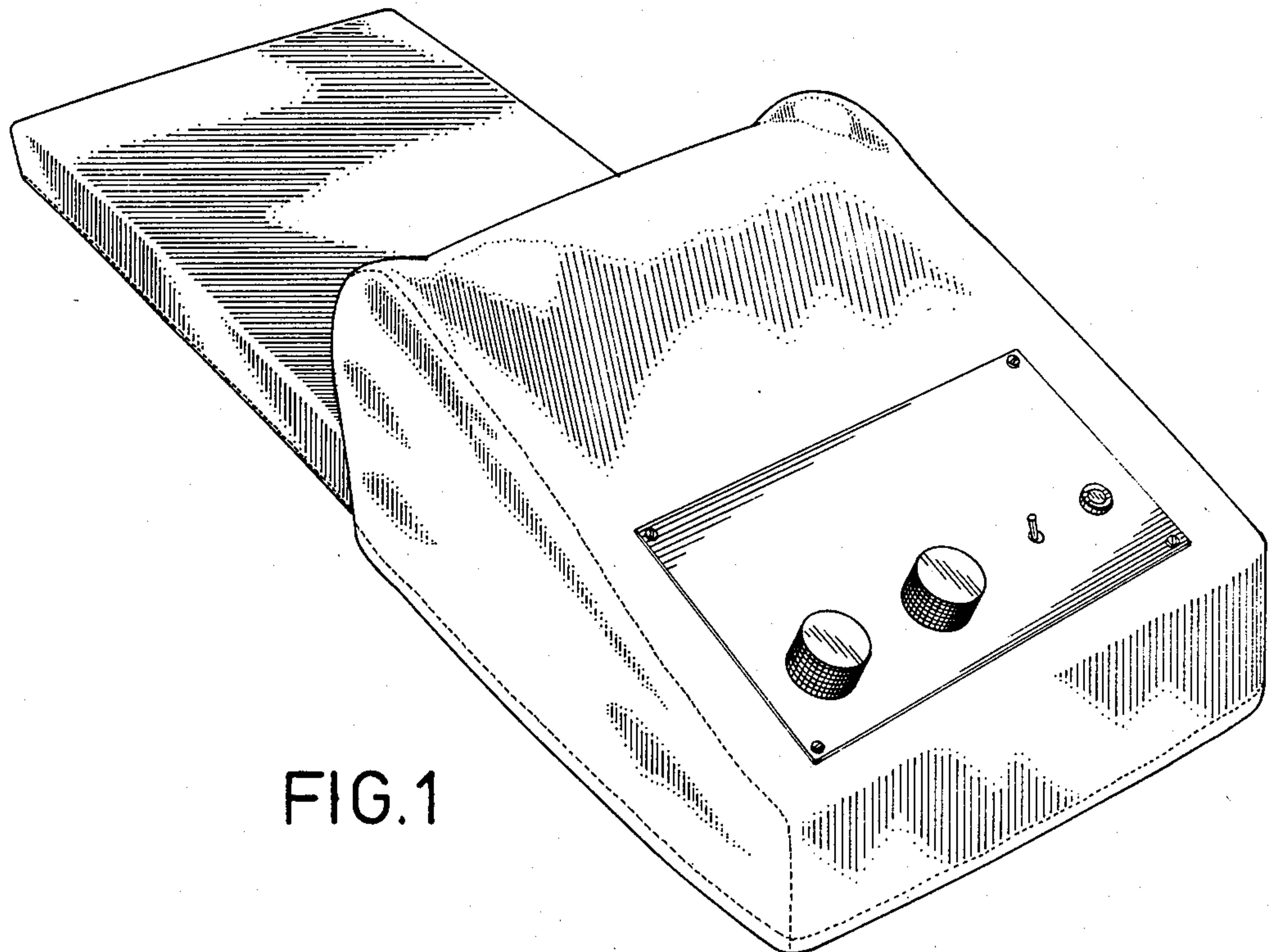

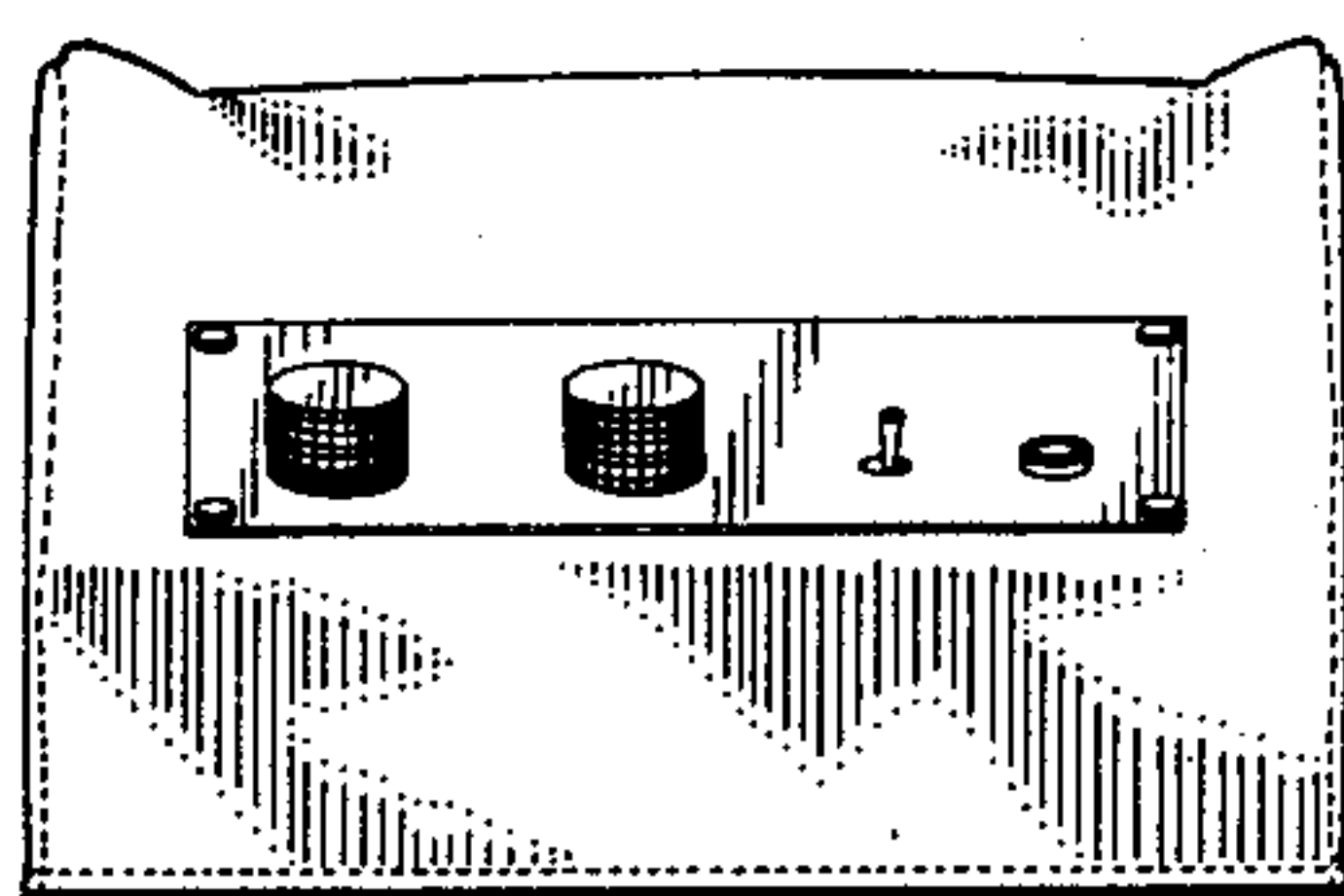

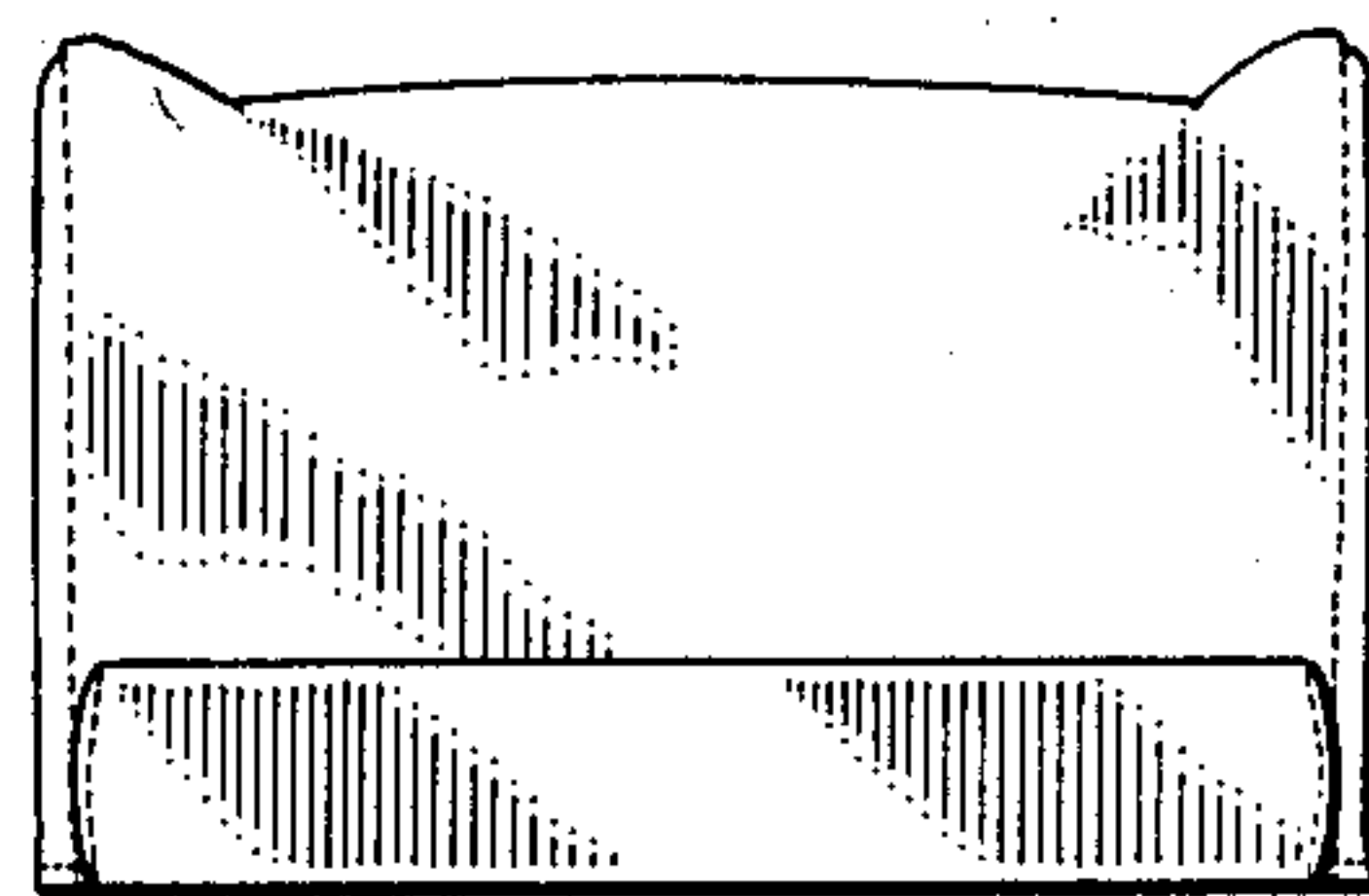

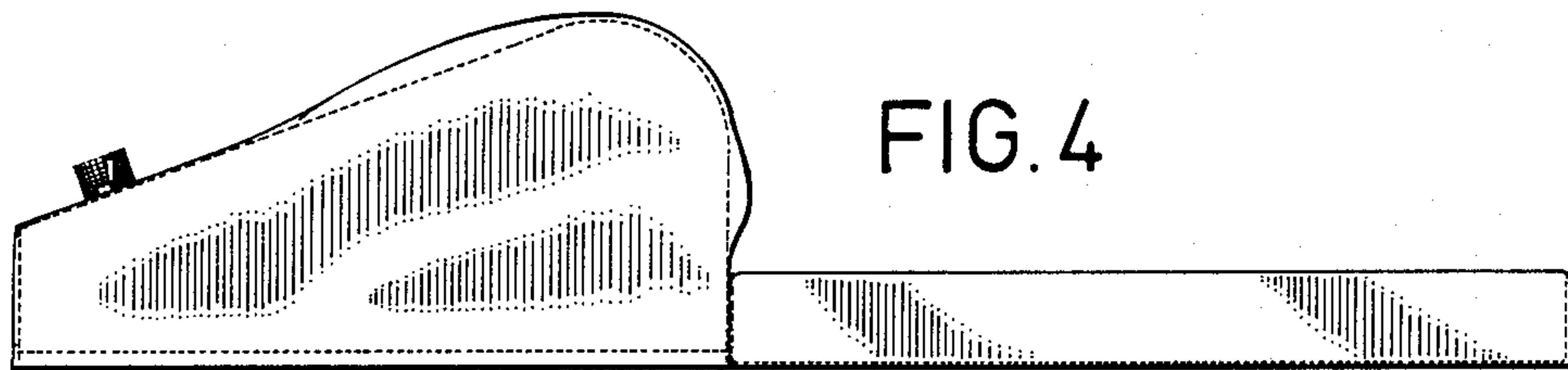

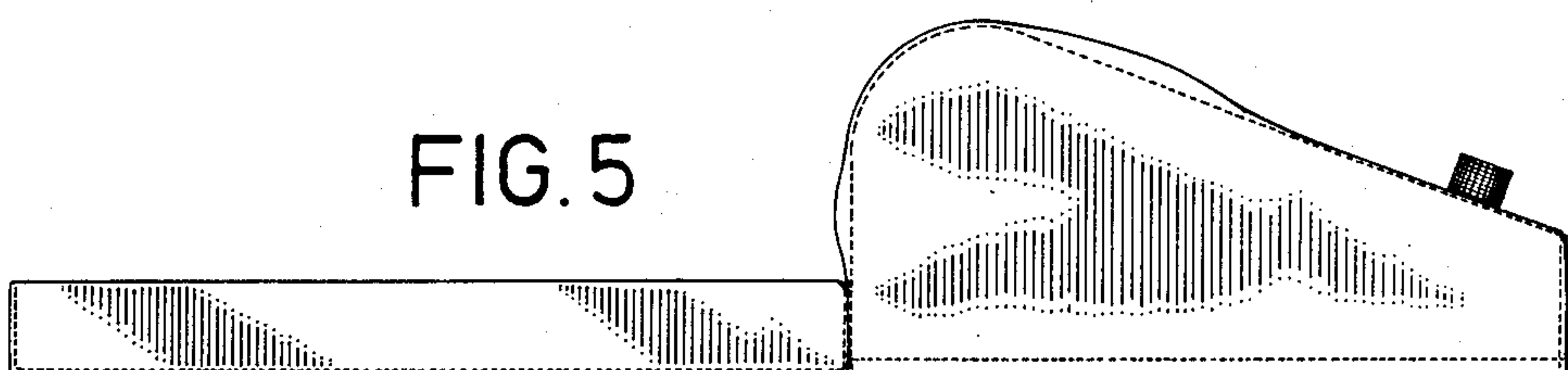

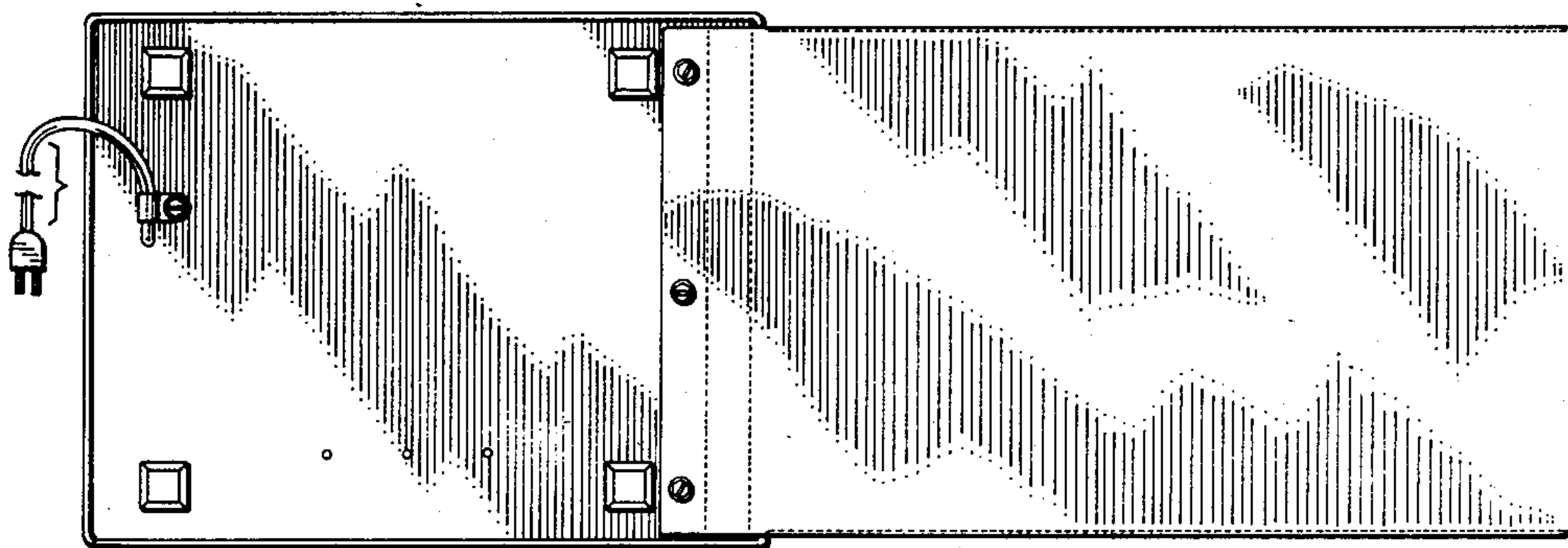

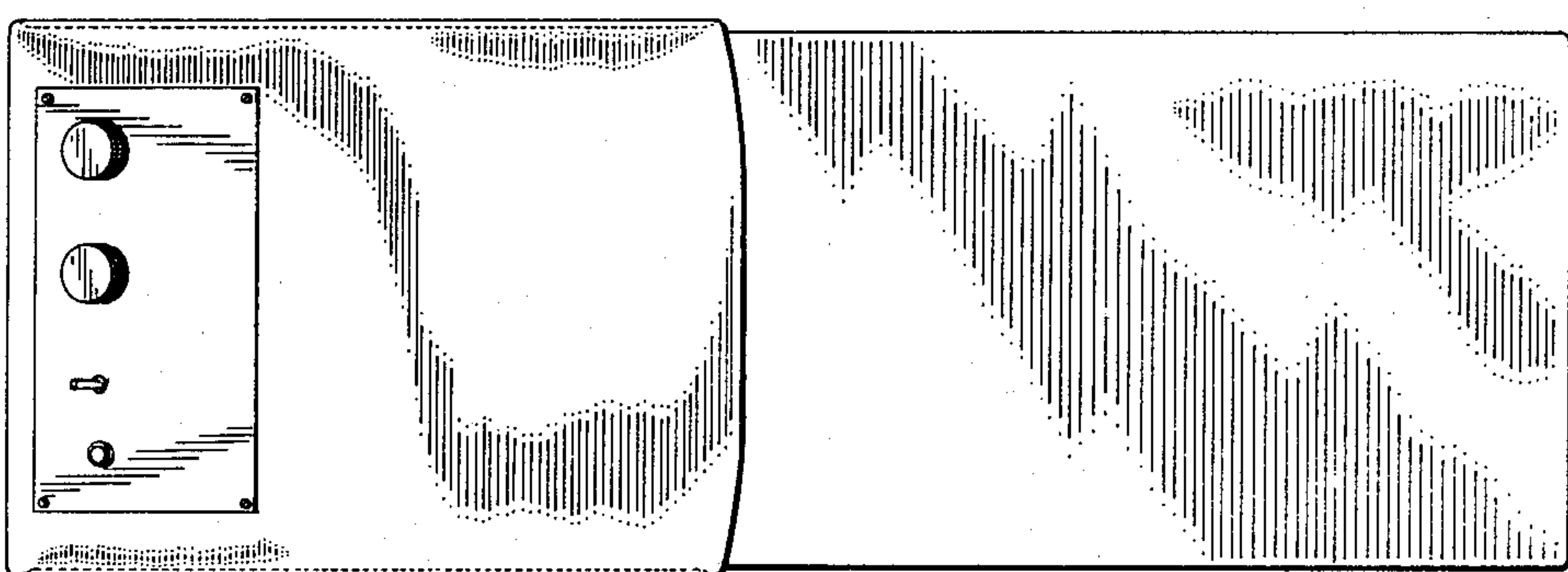
