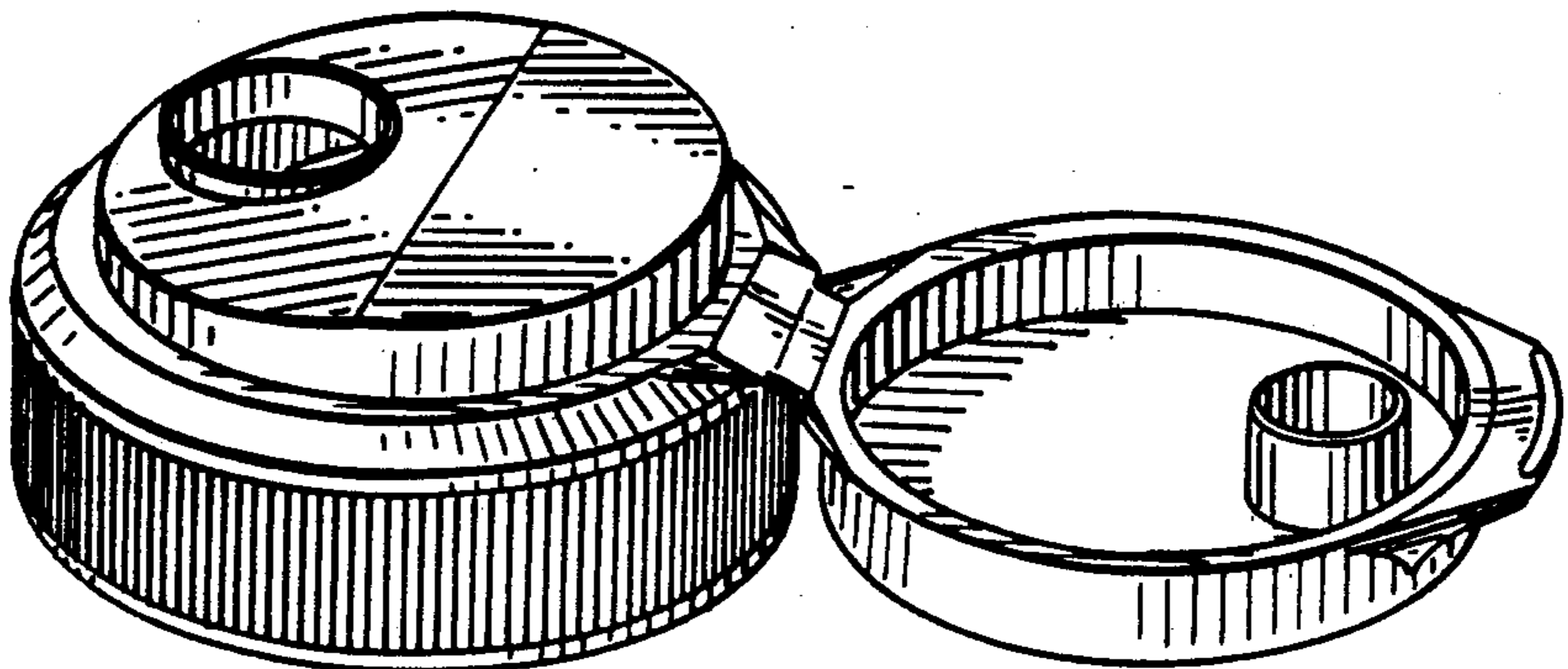
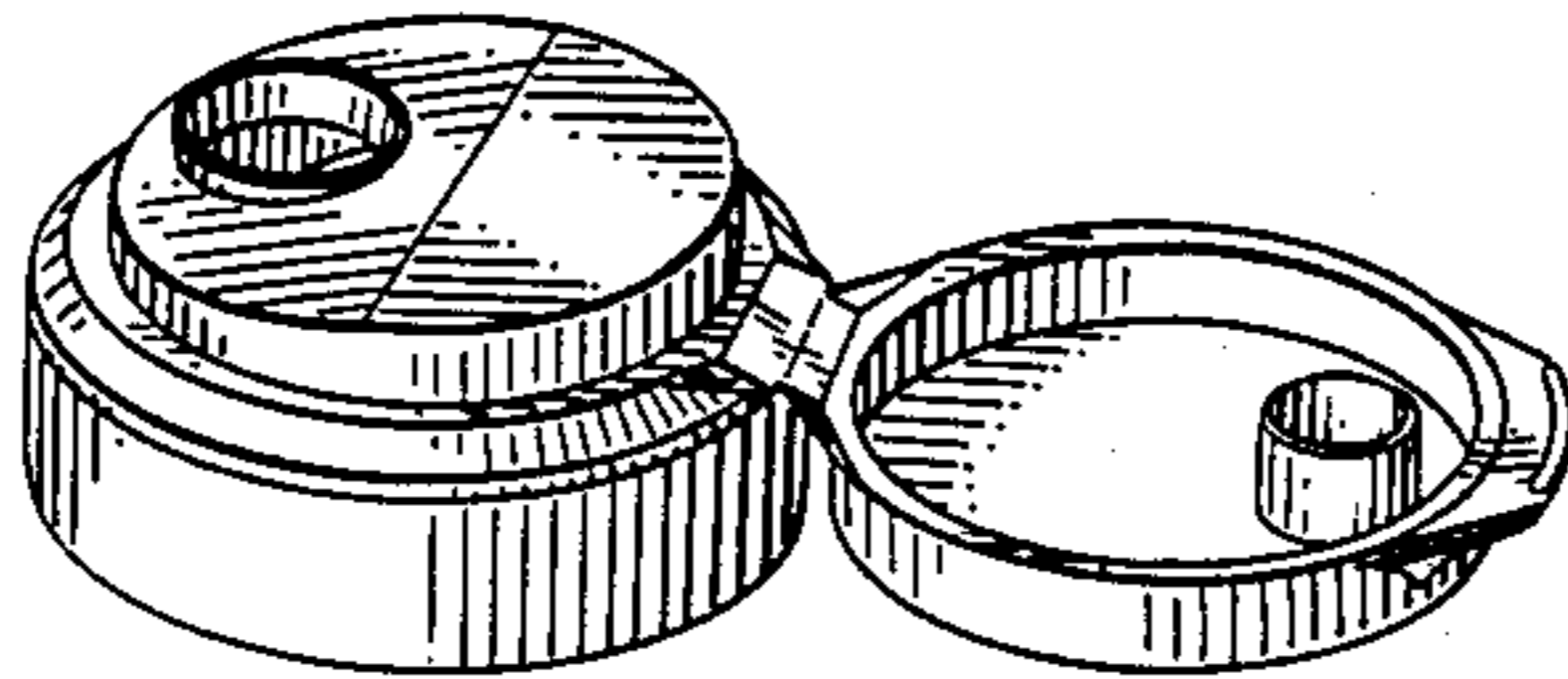

The ornamental design for a tethered dispensing closure, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective of a tethered dispensing closure showing my new design;
 FIG. 2 is an enlarged top plan view thereof;
 FIG. 3 is an enlarged front elevational view thereof;
 FIG. 4 is an enlarged right side elevational view thereof, the left side being a mirror image;
 FIG. 5 is an enlarged rear elevational view thereof;
 FIG. 6 is an enlarged bottom plan view thereof;
 FIG. 7 is a rear perspective view thereof, the closure in a position for use;
 FIG. 8 is a rear perspective view of a second embodiment of FIG. 1;
 FIG. 9 is an enlarged top plan view of FIG. 8;
 FIG. 10 is an enlarged front elevational view of FIG. 8;
 FIG. 11 is an enlarged right side elevational view of FIG. 8, the left side being a mirror image;
 FIG. 12 is an enlarged rear elevational view of FIG. 8;
 FIG. 13 is an enlarged bottom plan view of FIG. 8;
 FIG. 14 is a rear perspective view of FIG. 8, the closure in a position for use.



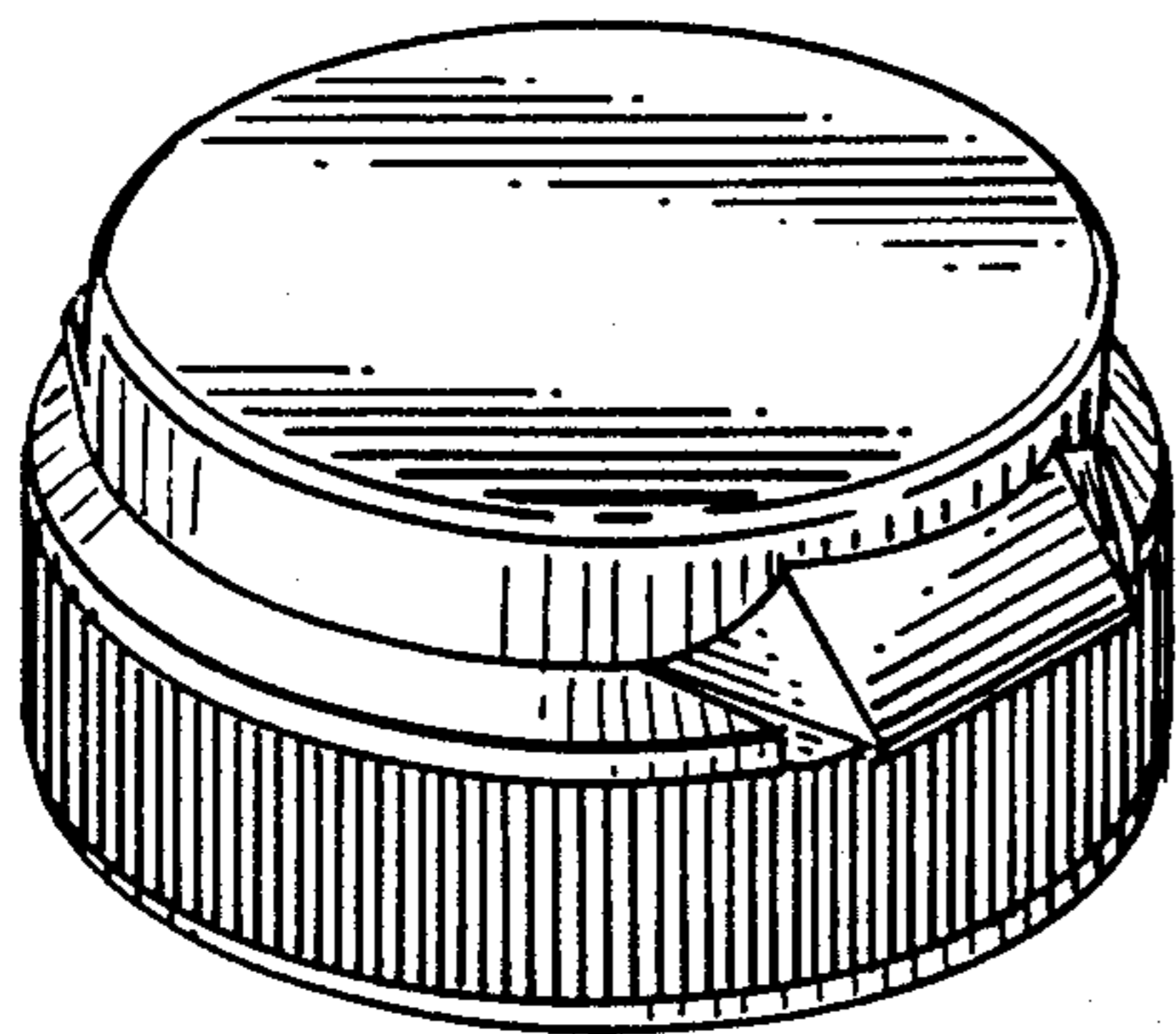

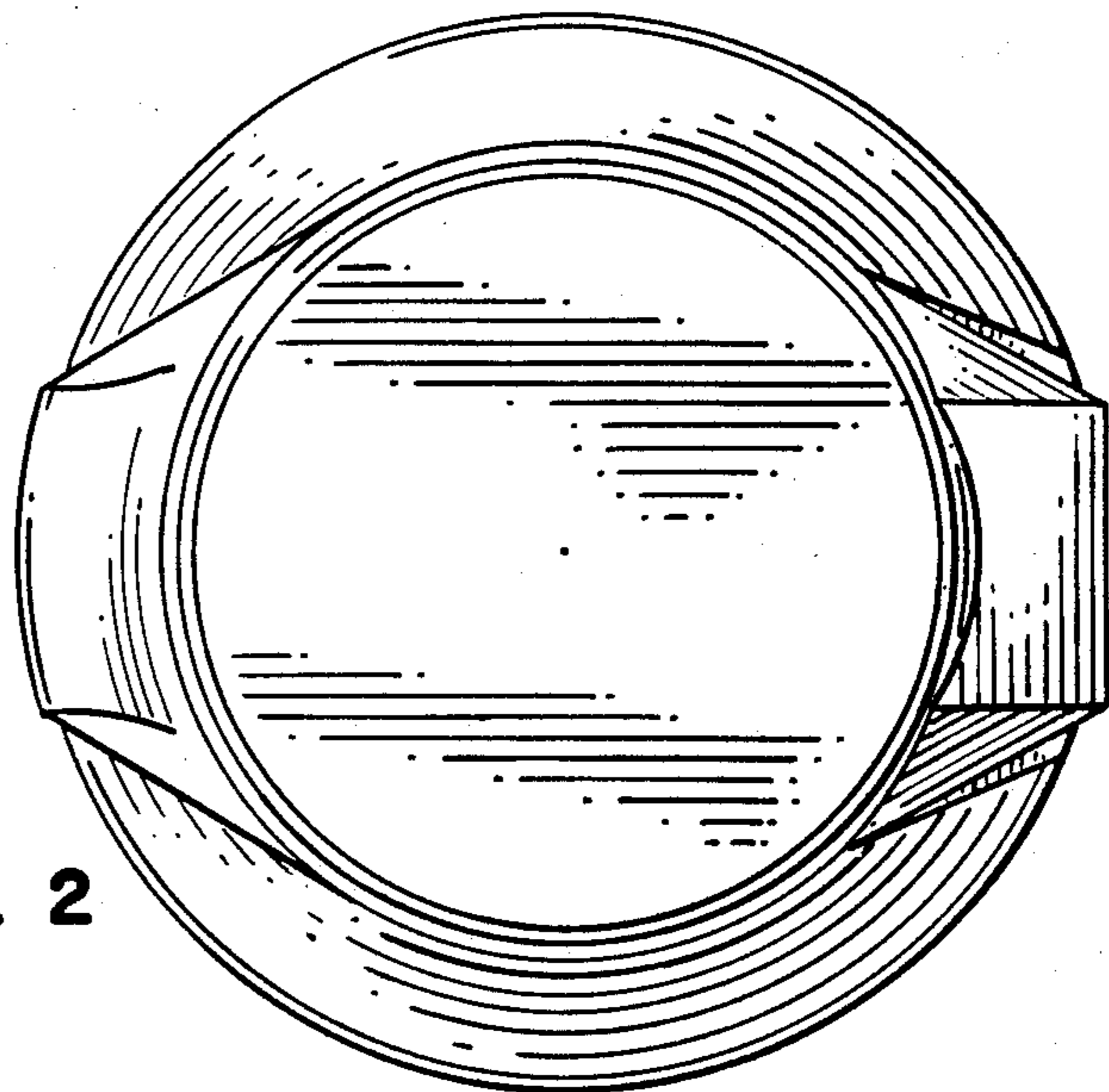

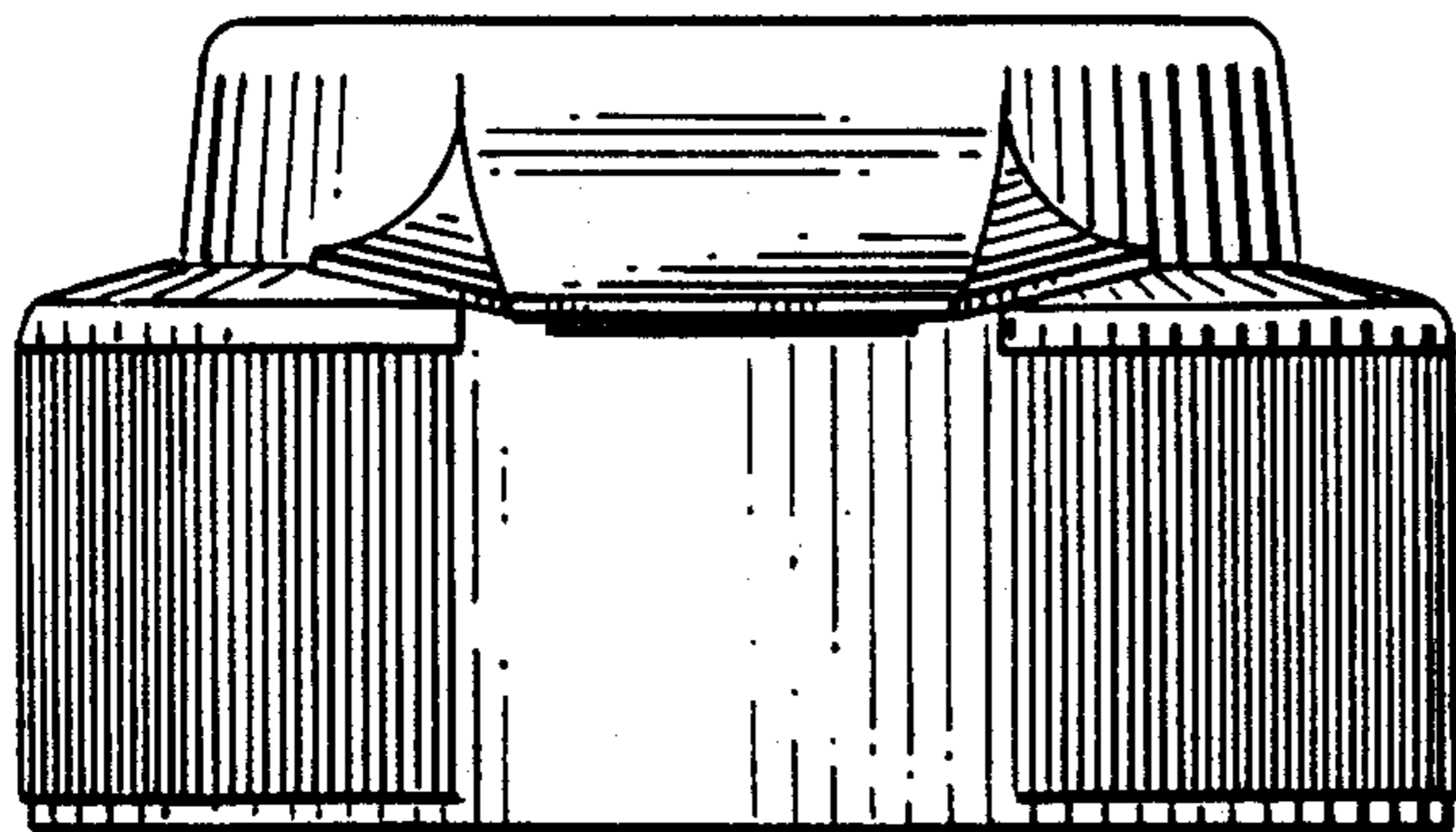

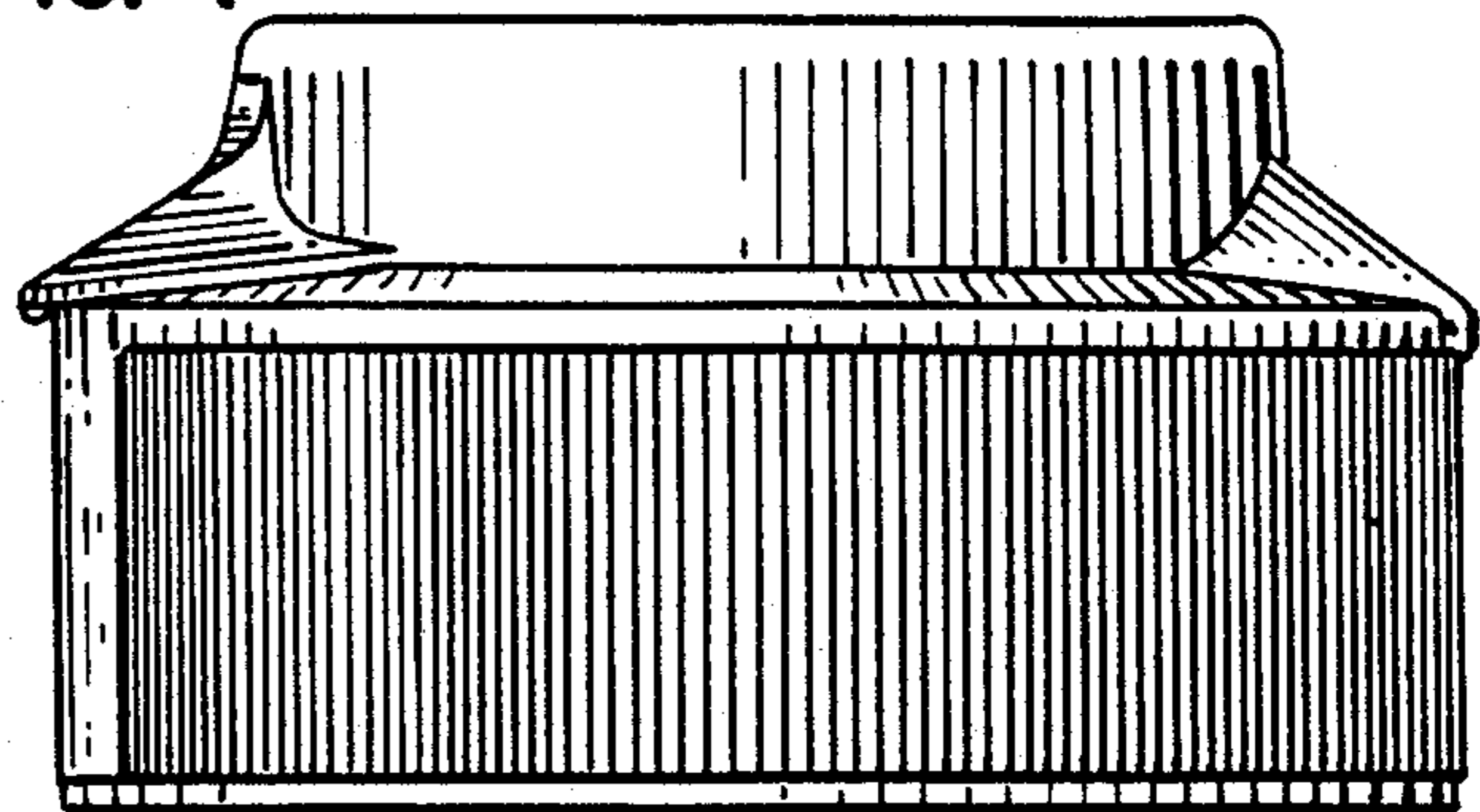

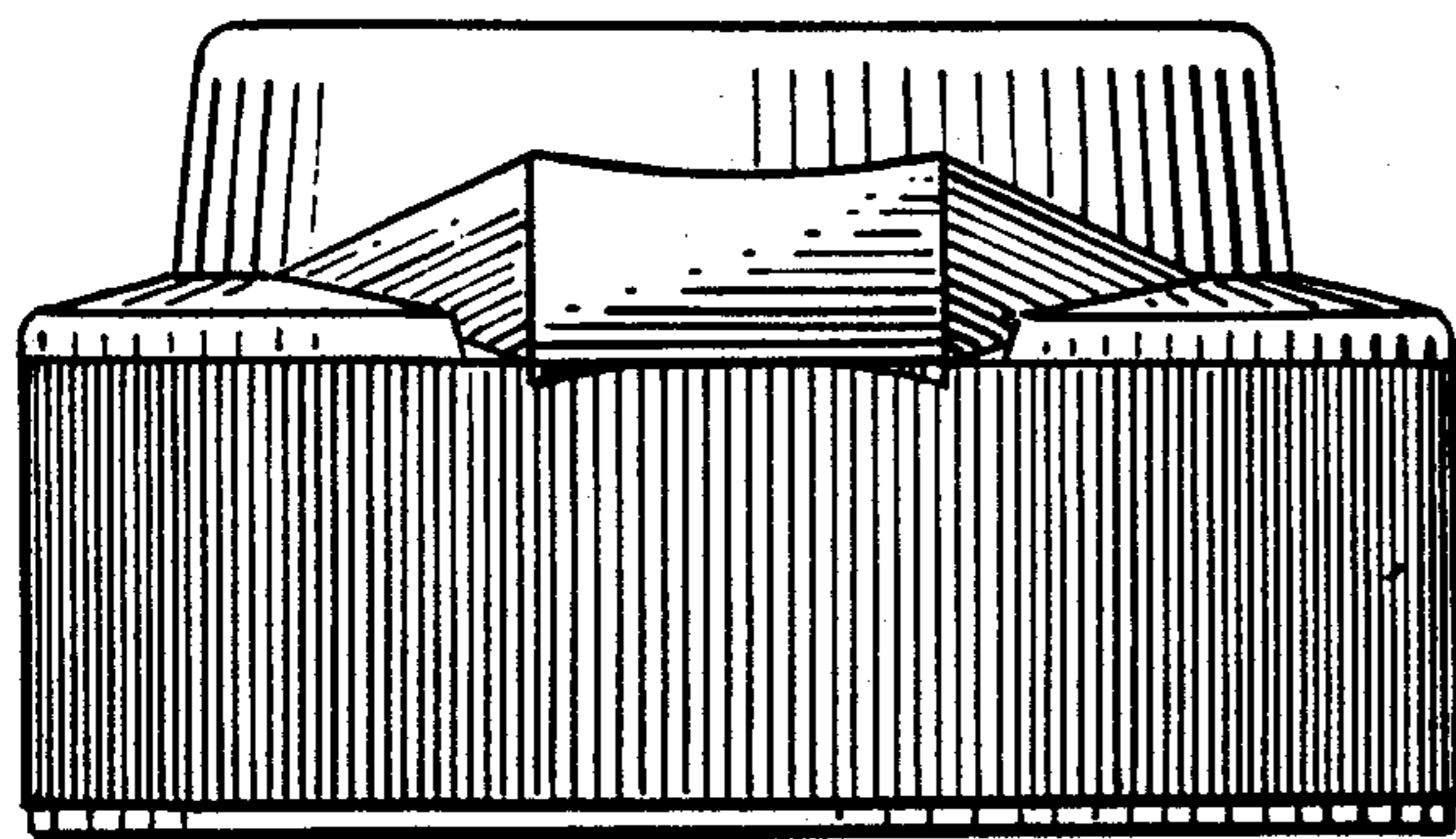

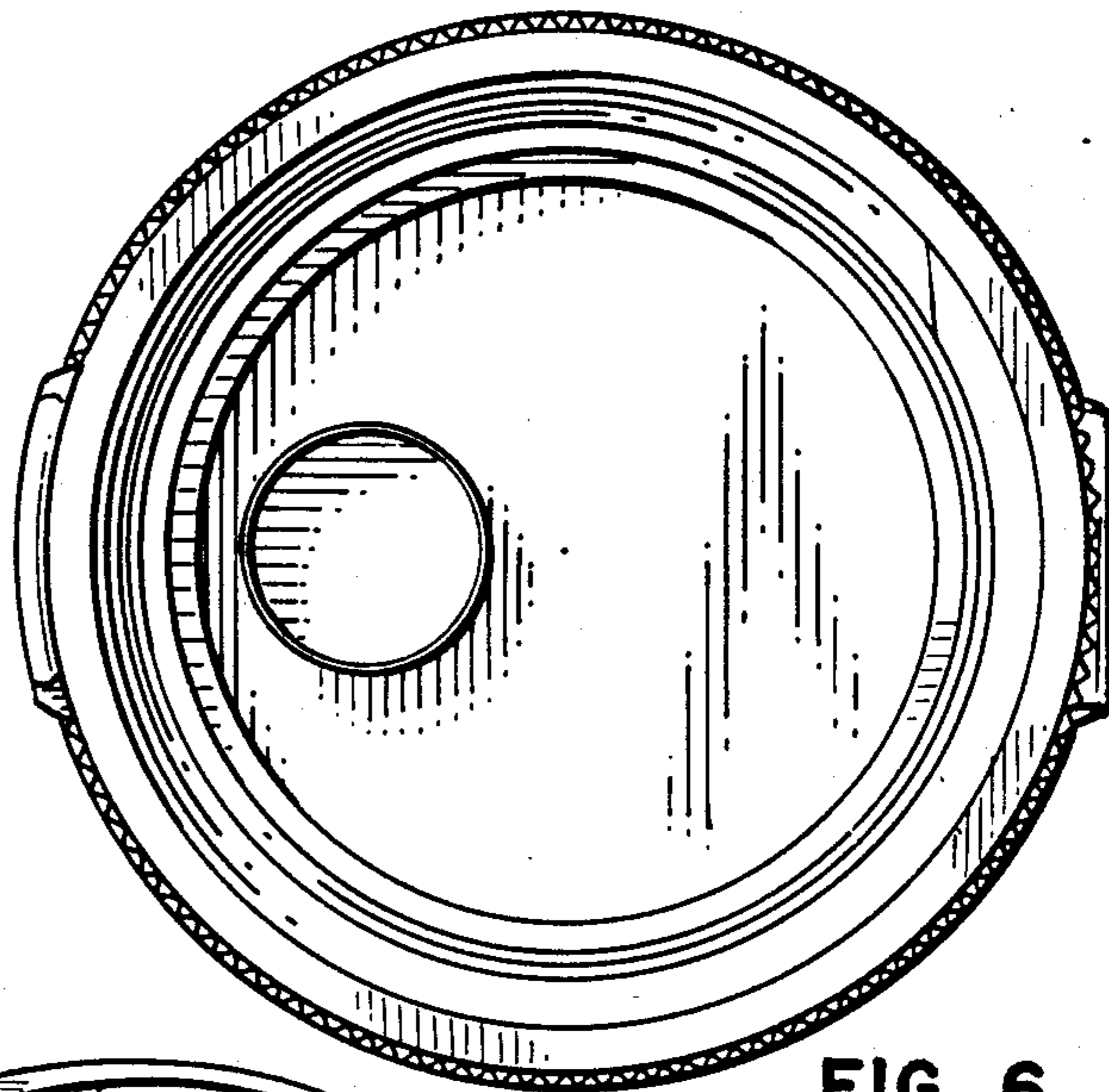

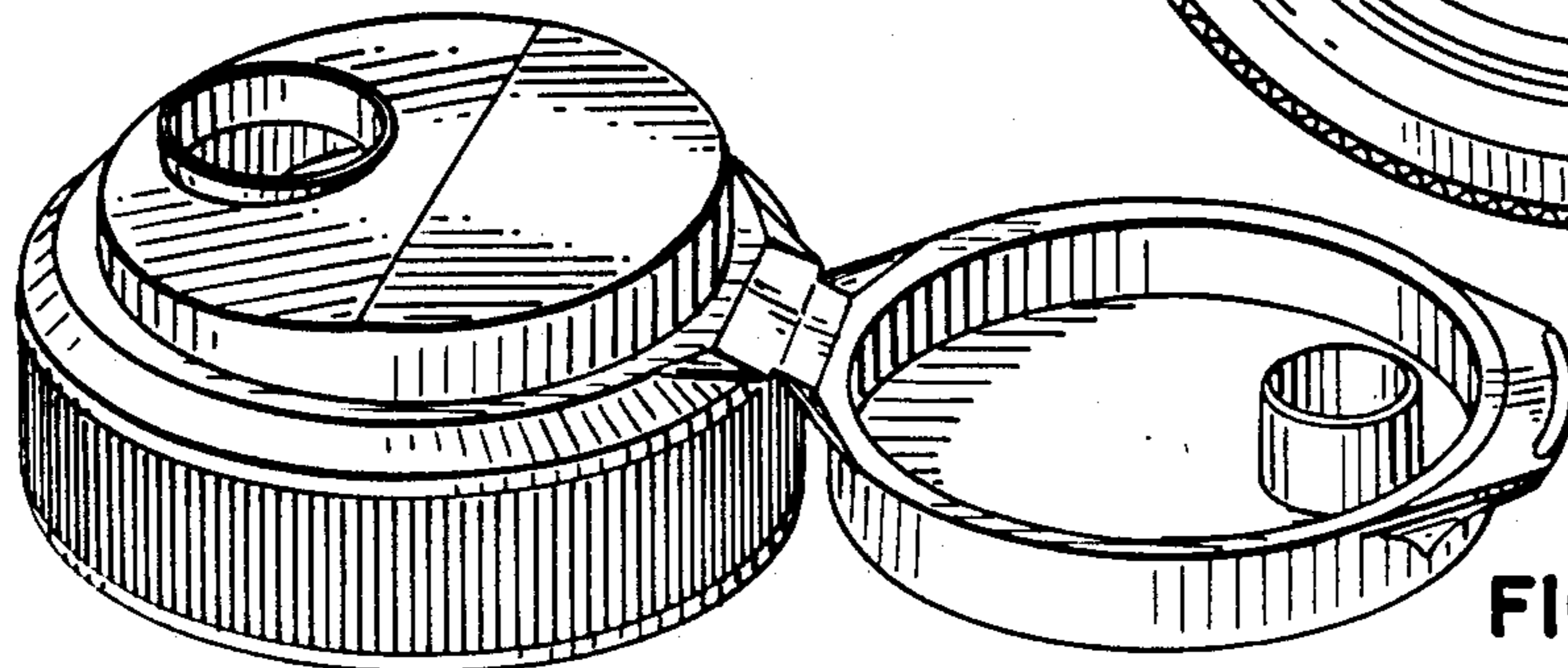

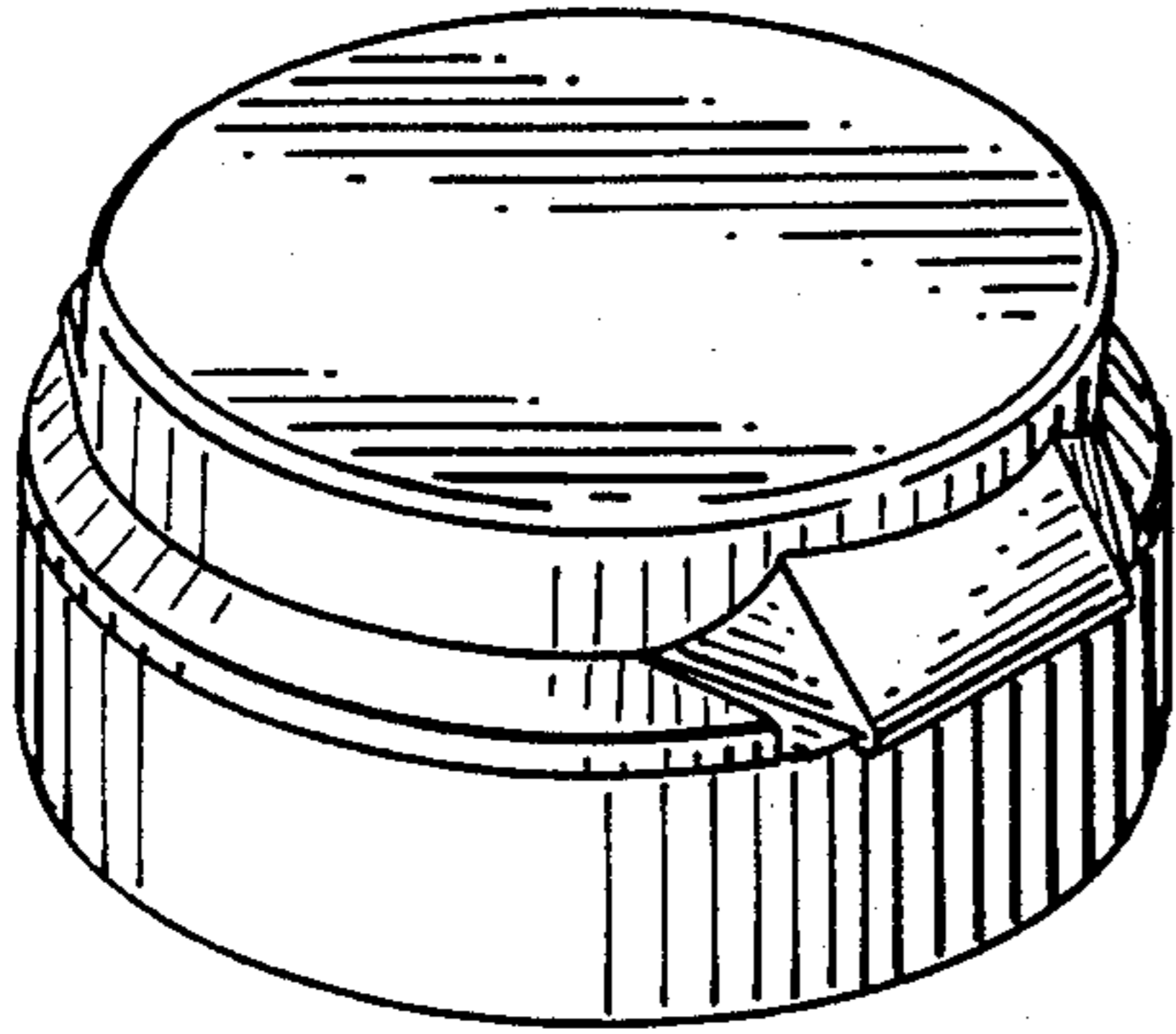

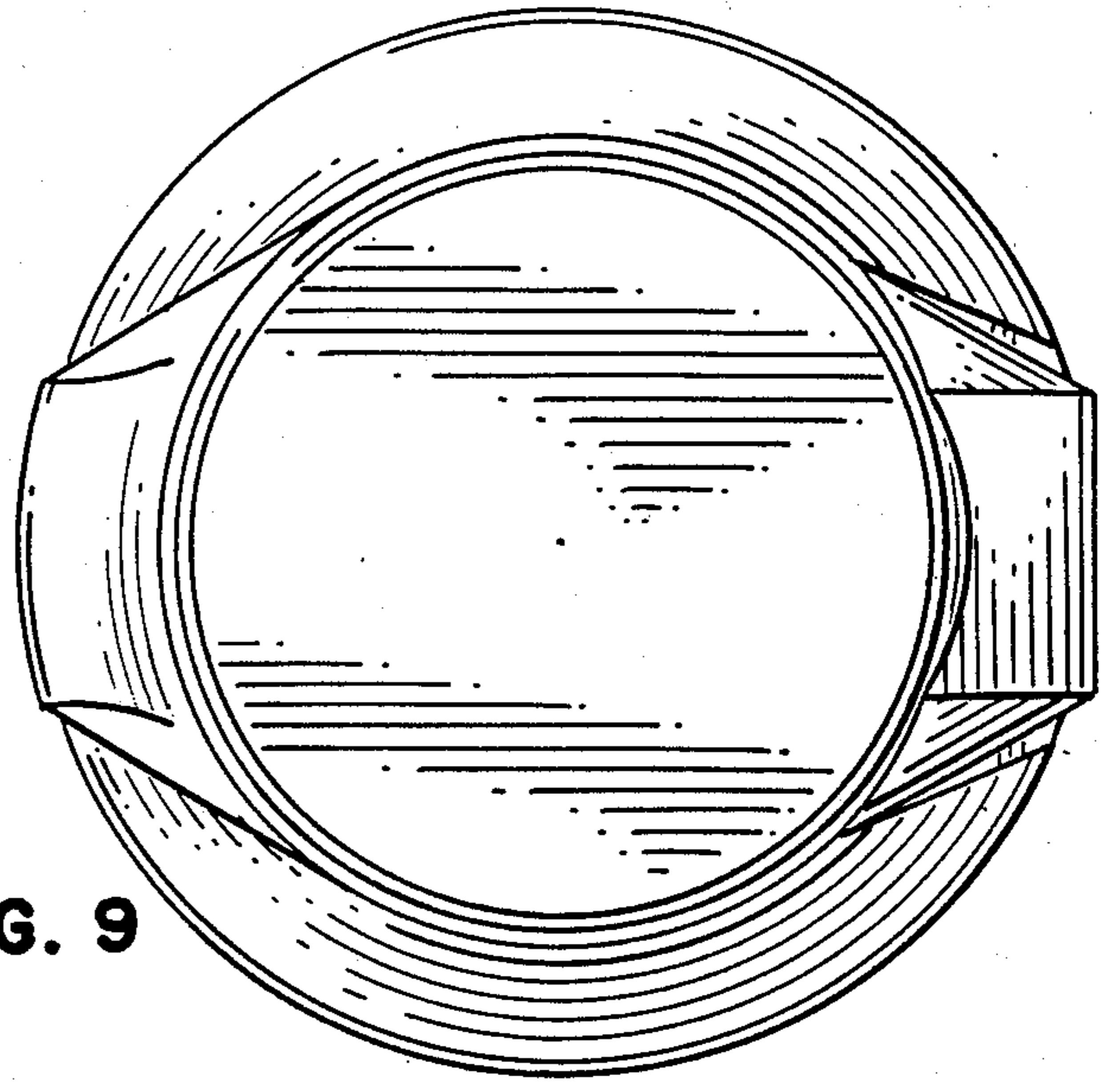

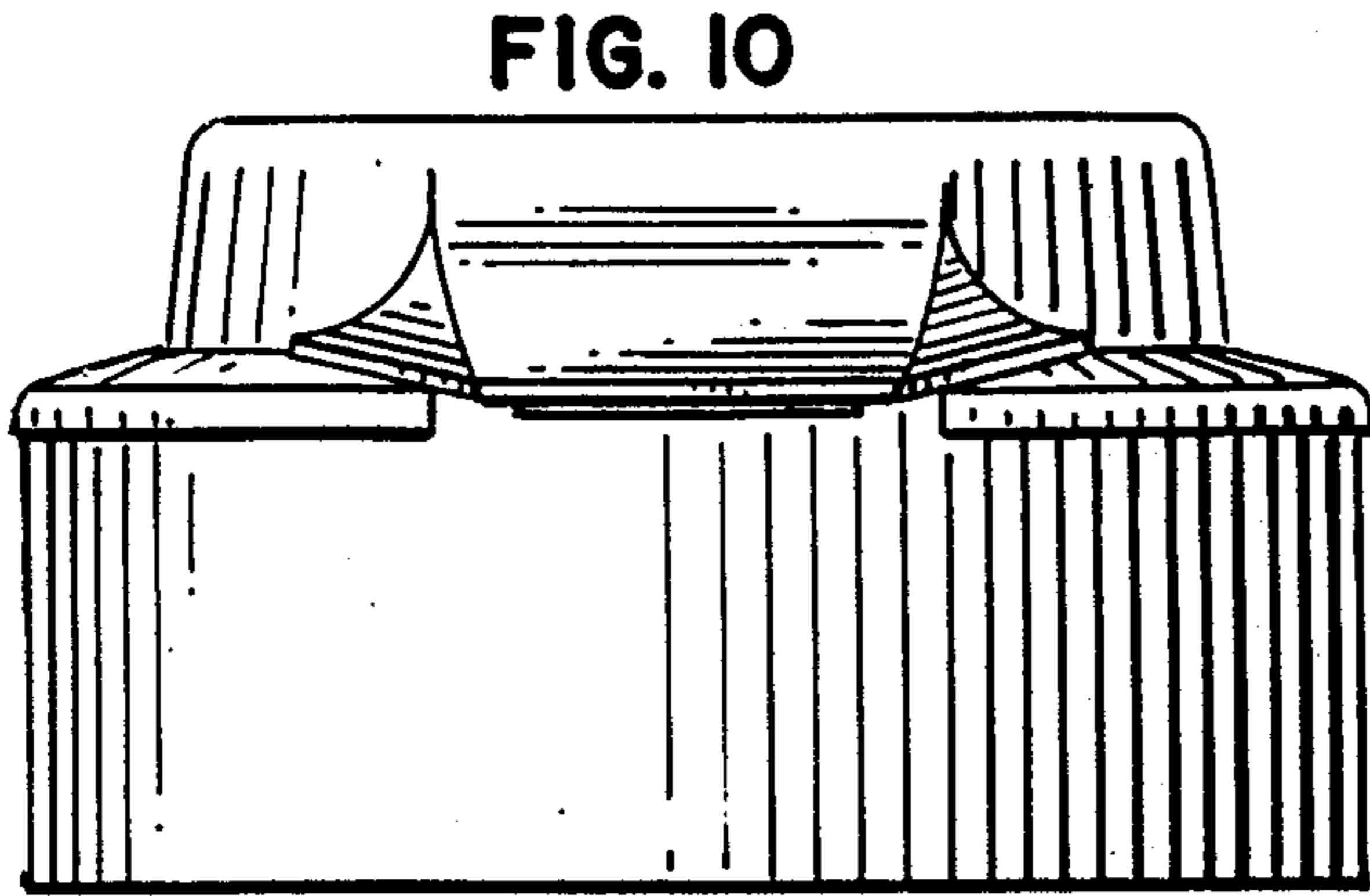

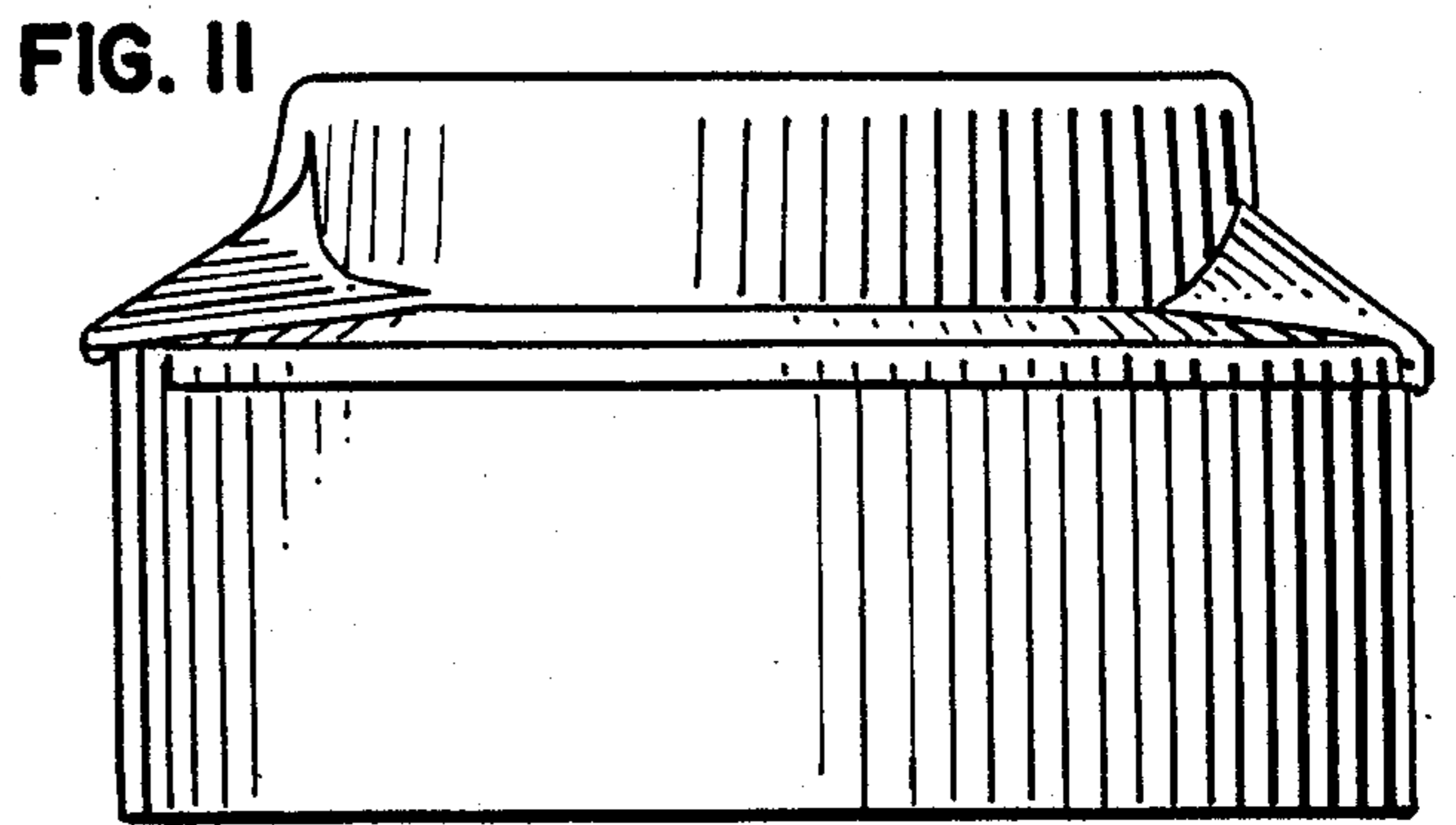

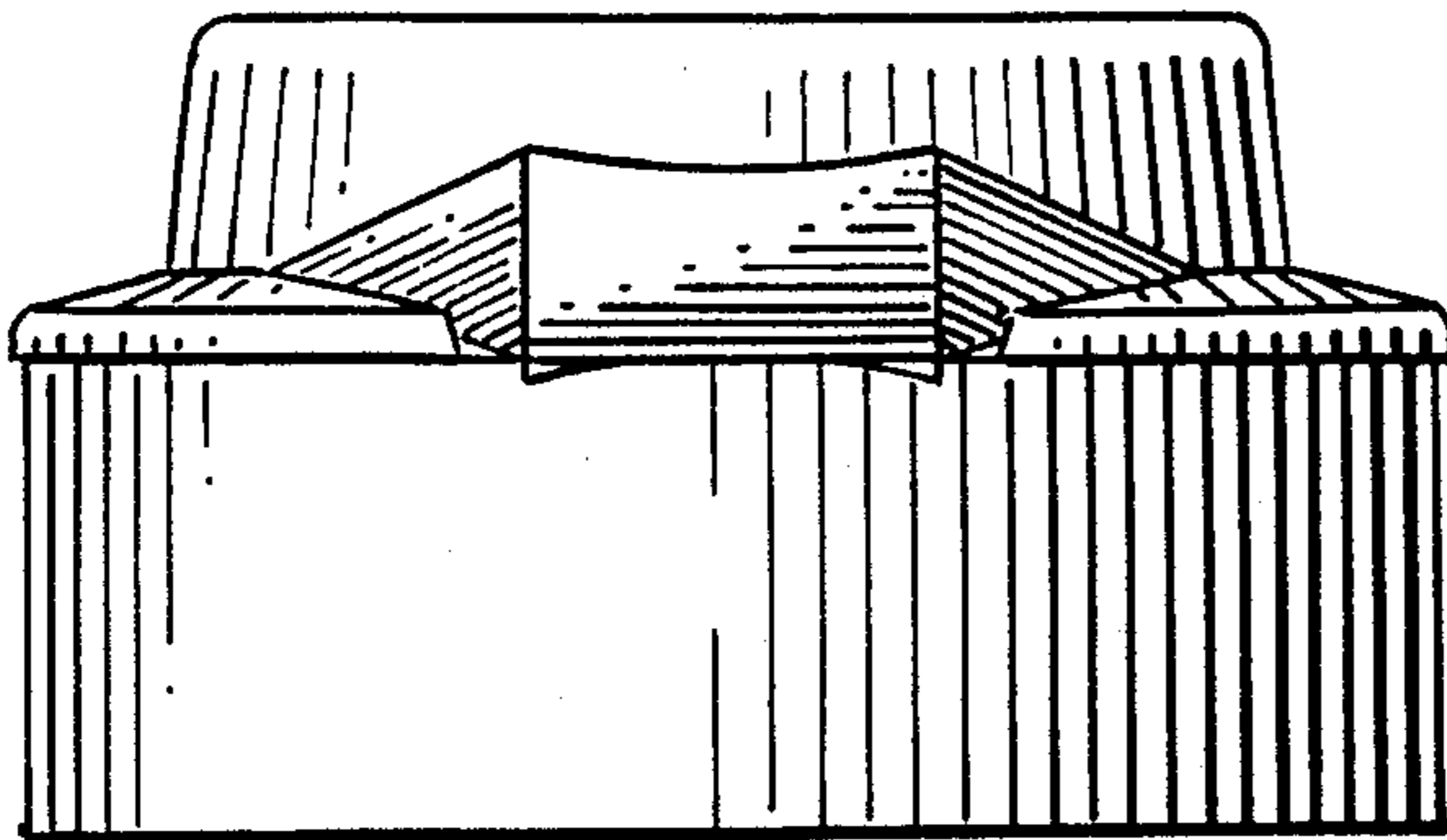

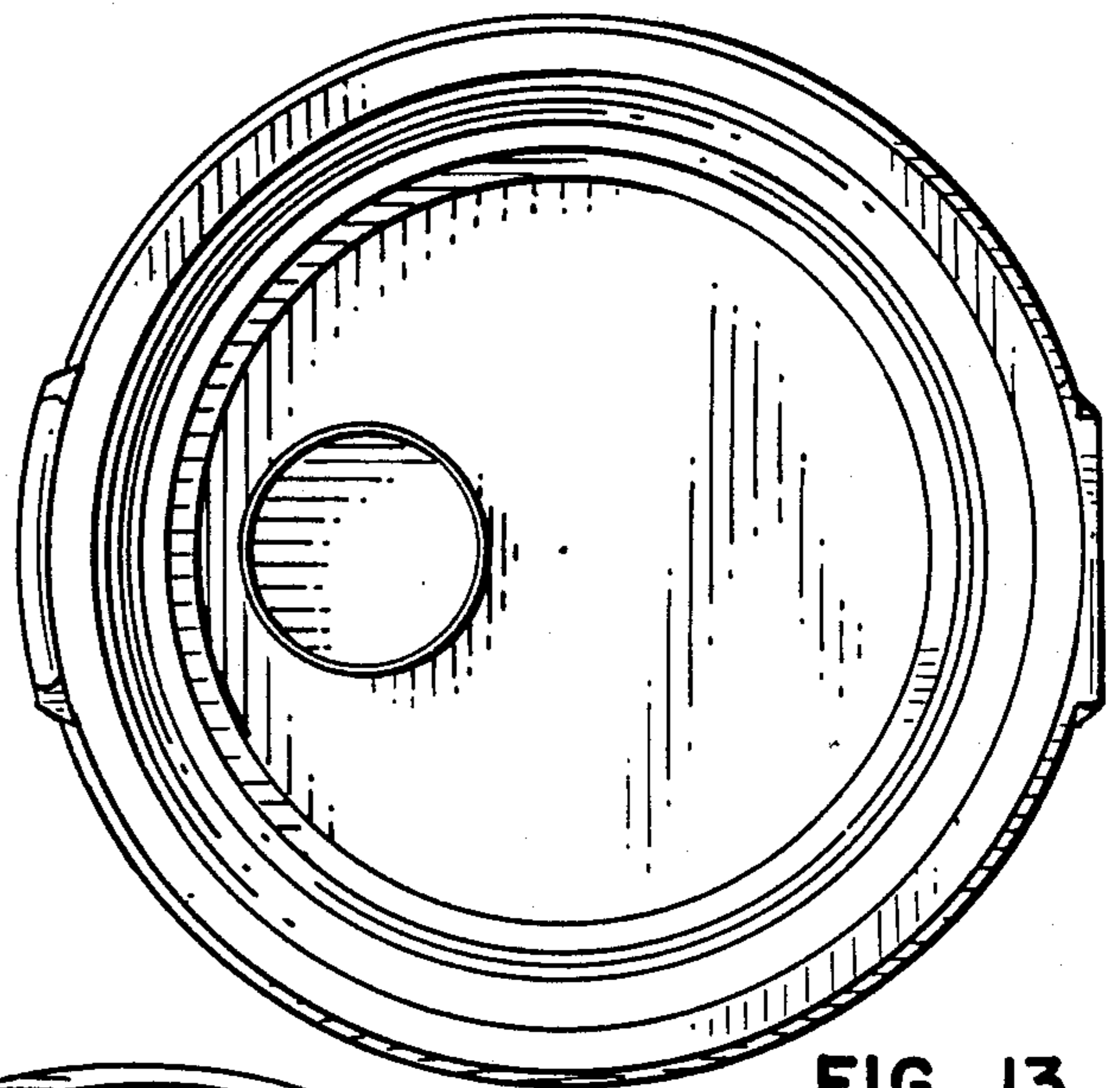

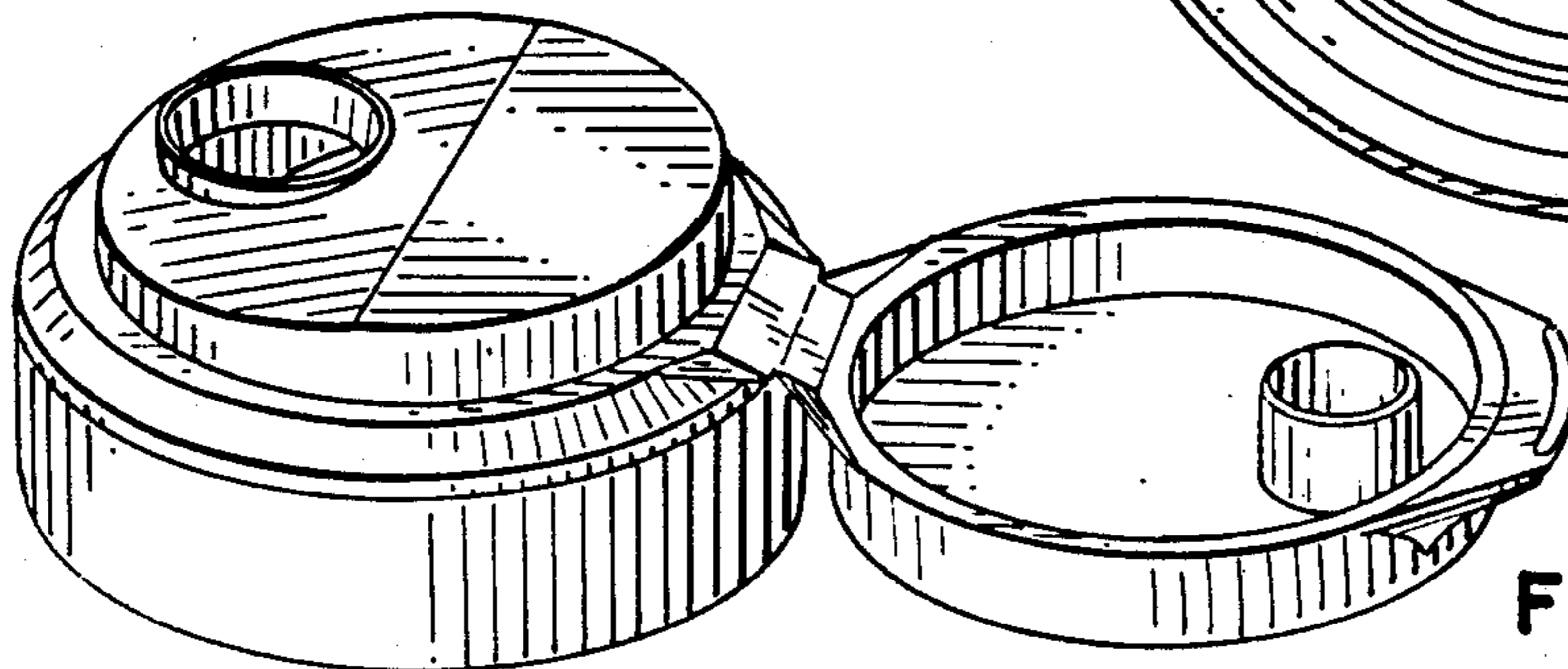
