An ornamental design for a combined telephone and data entry terminal, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a data entry terminal showing our new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof with the electrical connector receptacles being shown in broken lines for illustrative purposes only;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top plan view of a second embodiment of our design;
FIG. 8 is a left side elevational view thereof;
FIG. 9 is a right side elevational view thereof;
FIG. 10 is a front elevational view thereof;
FIG. 11 is a rear elevational view thereof, with the electrical connector receptacles being shown in broken lines for illustrative purposes only;
FIG. 12 is a bottom plan view thereof.

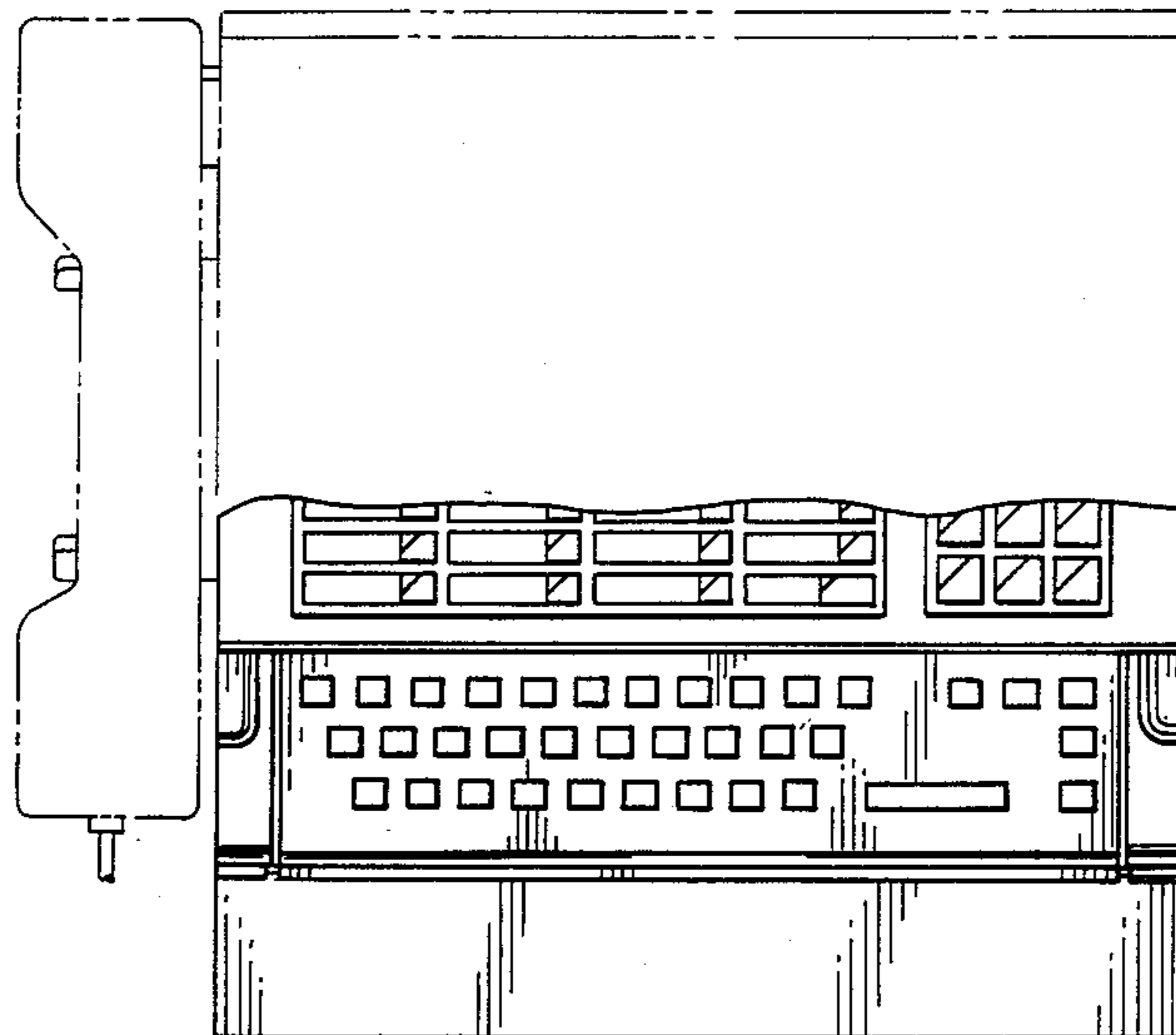

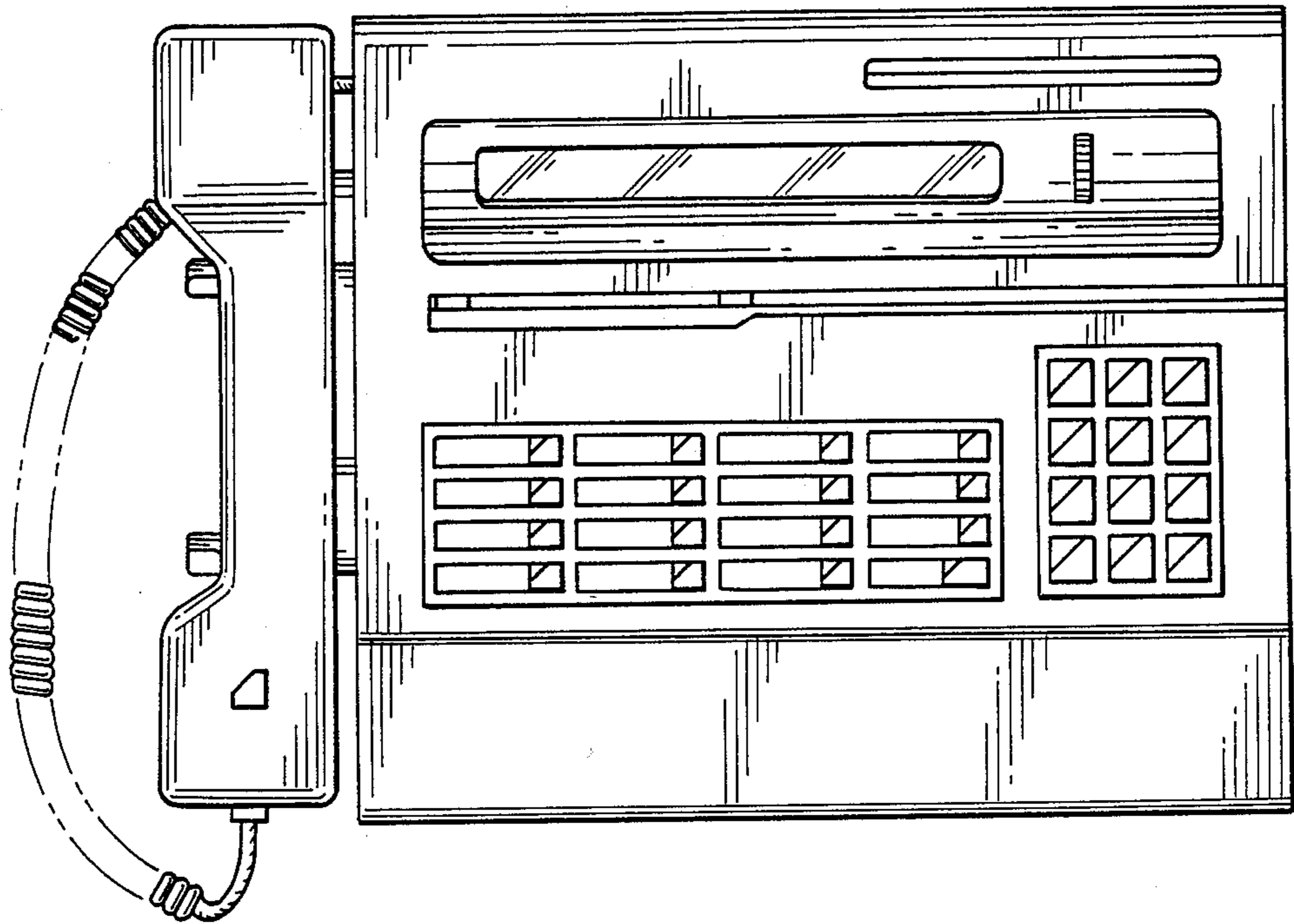

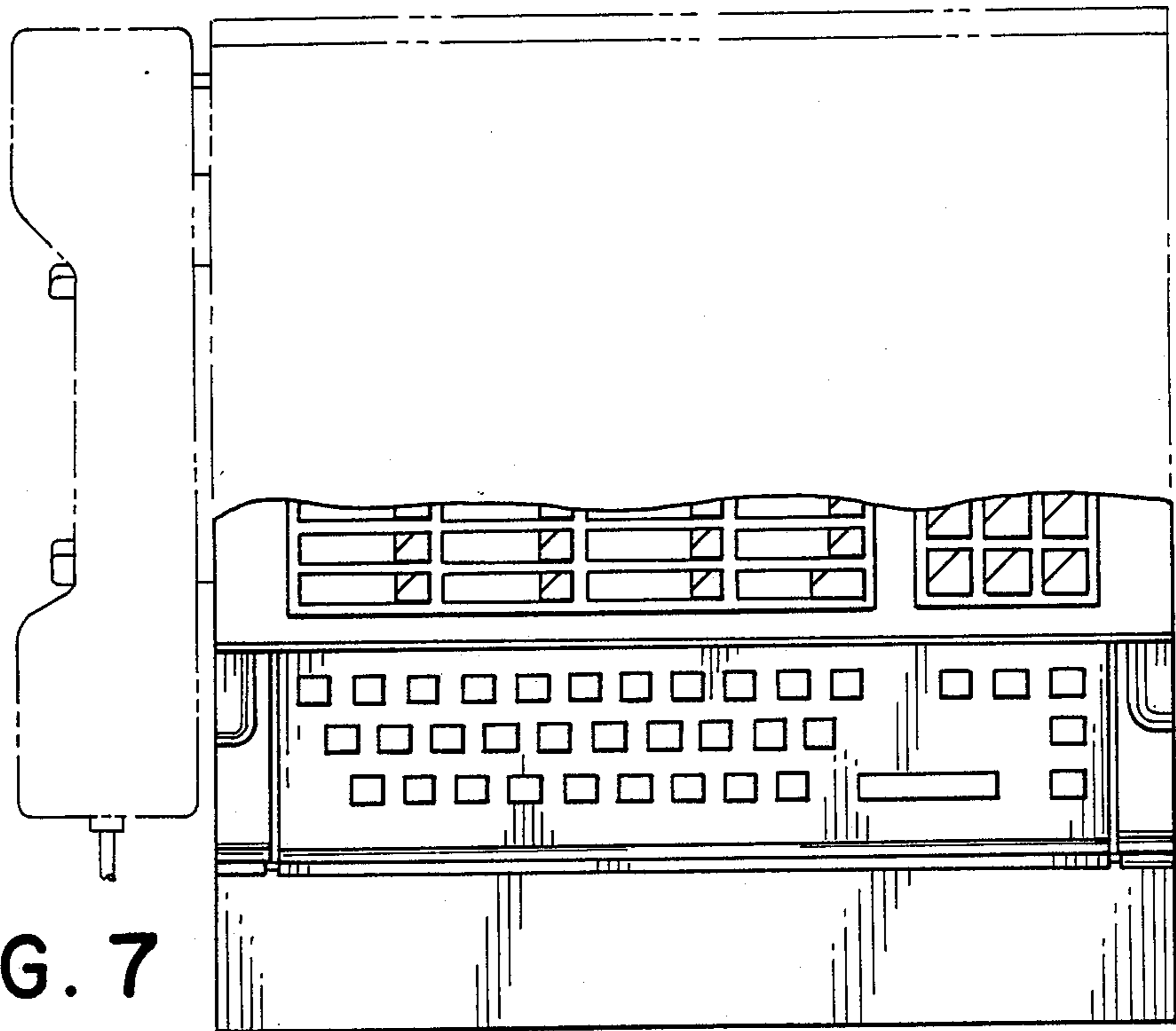

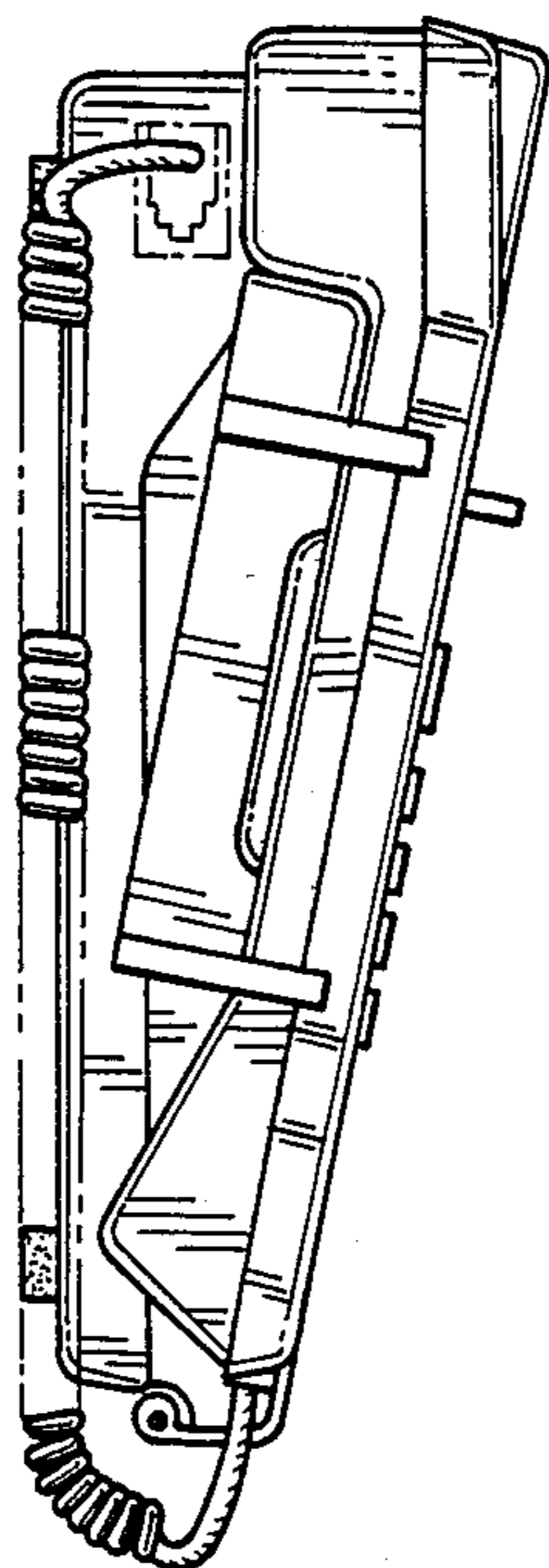

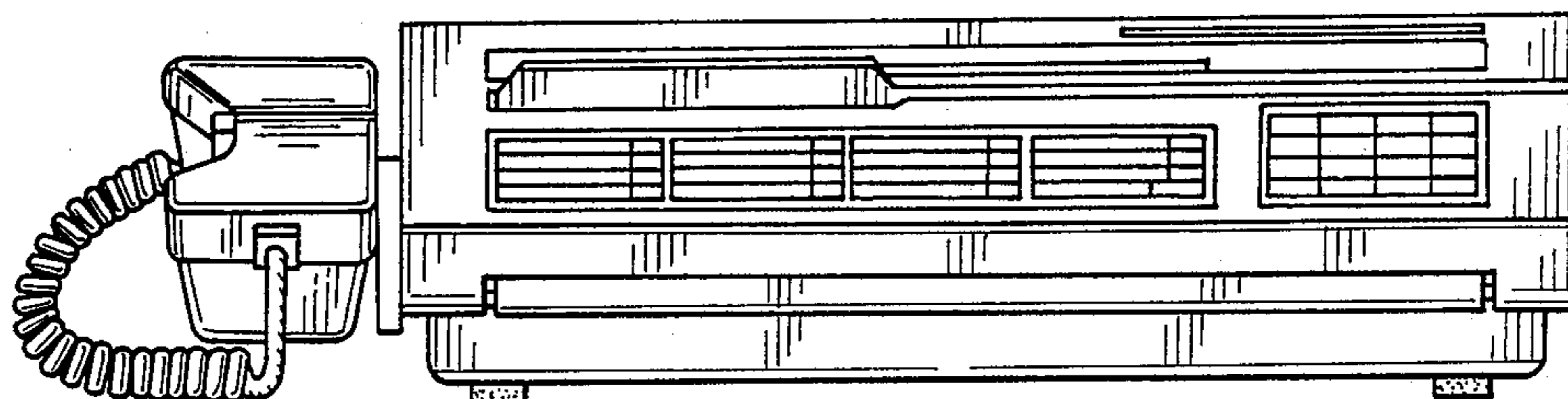
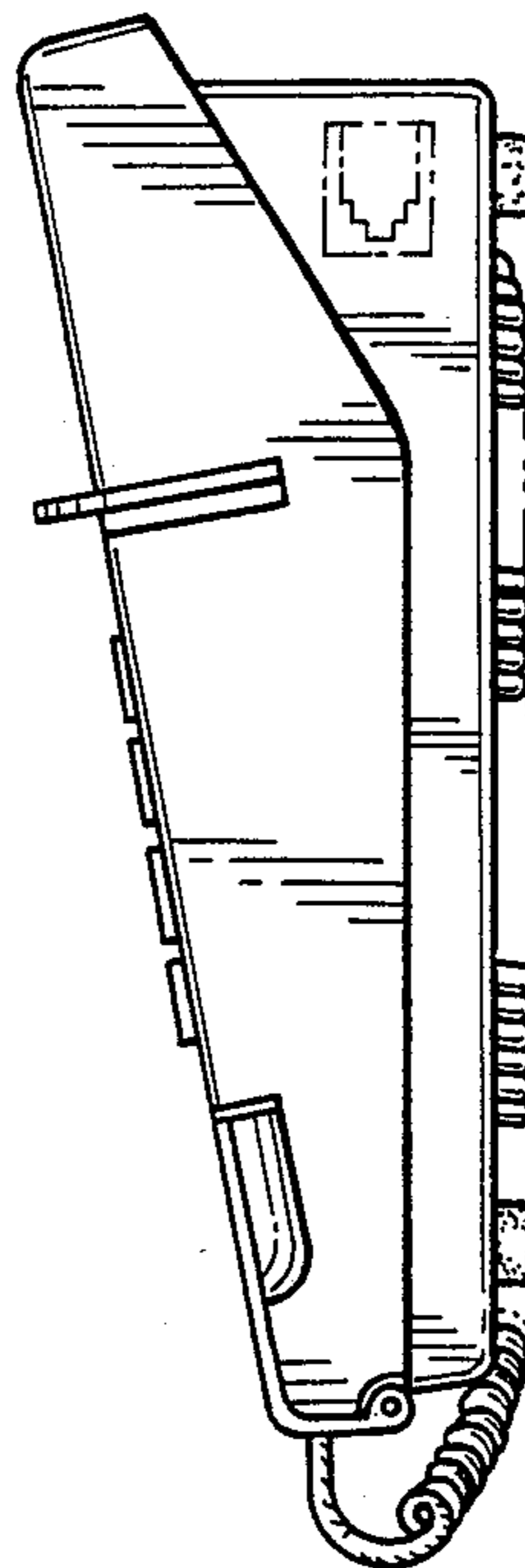

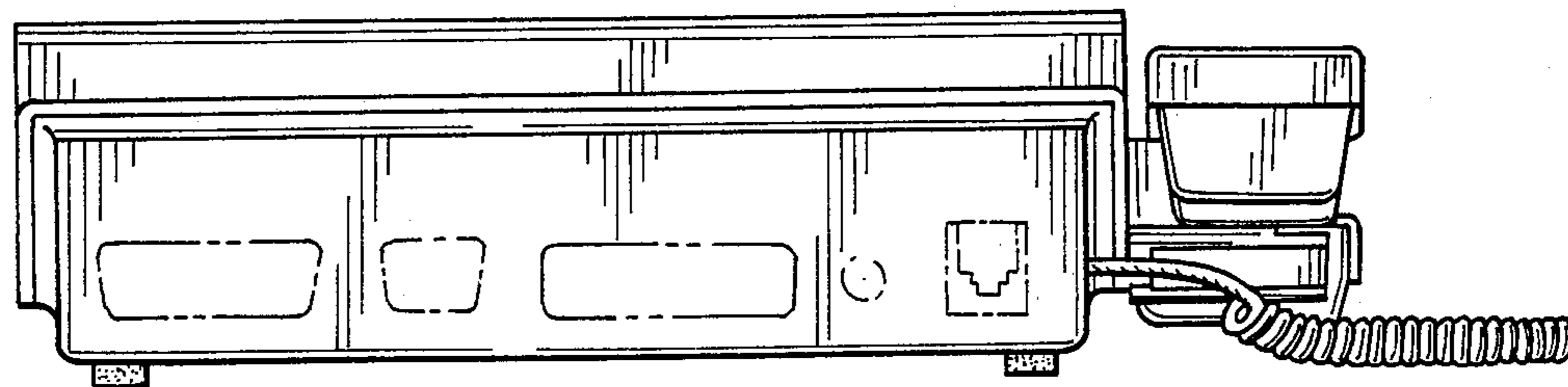

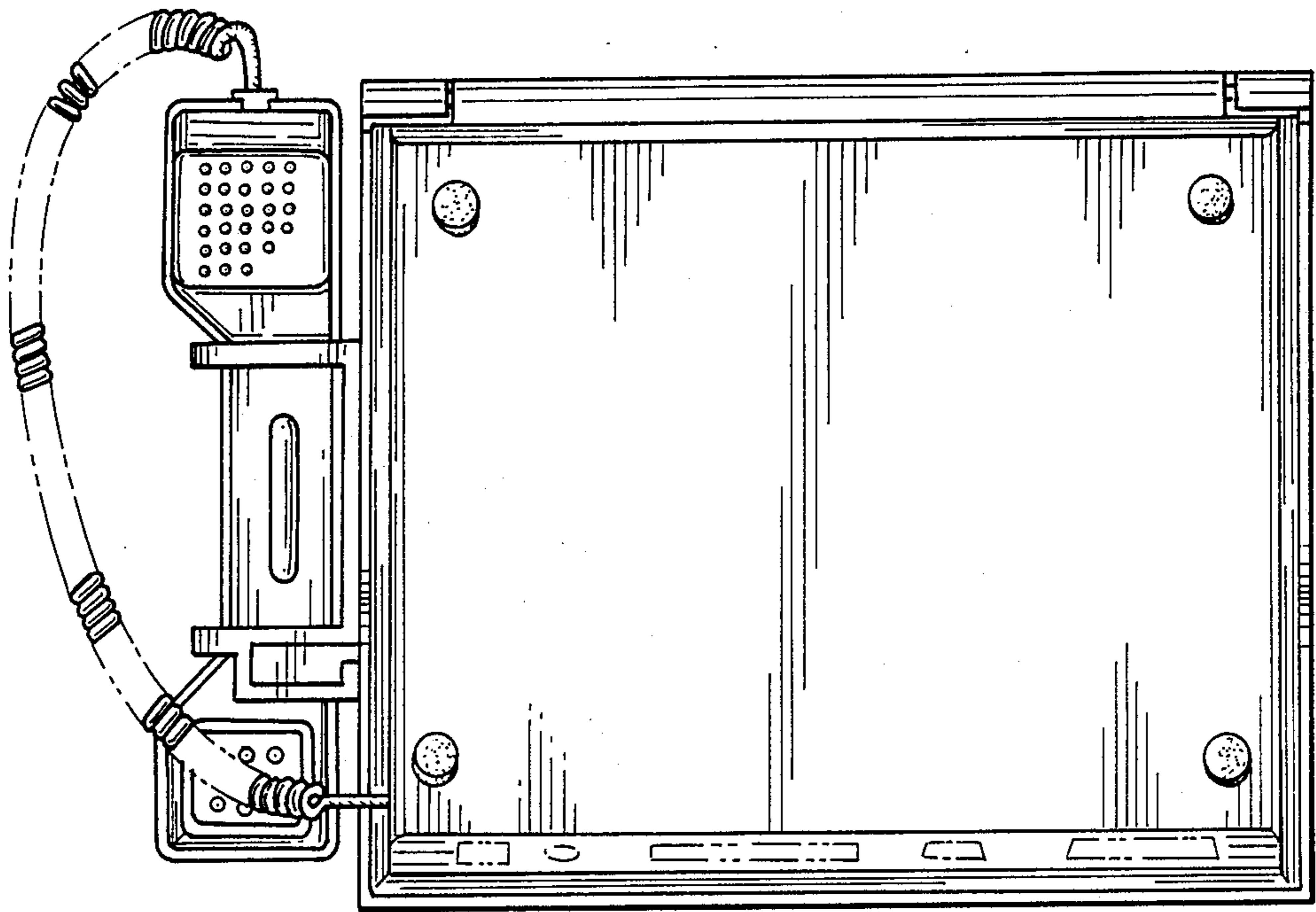

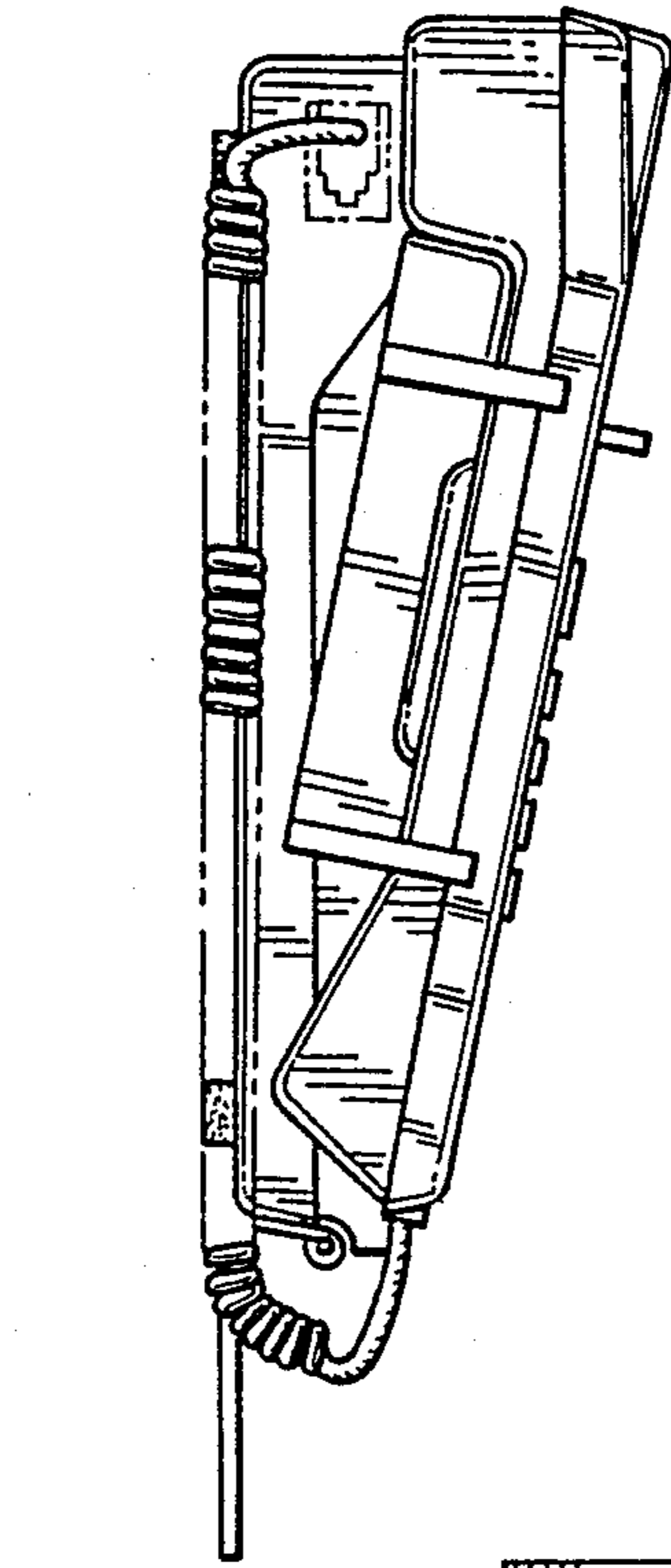

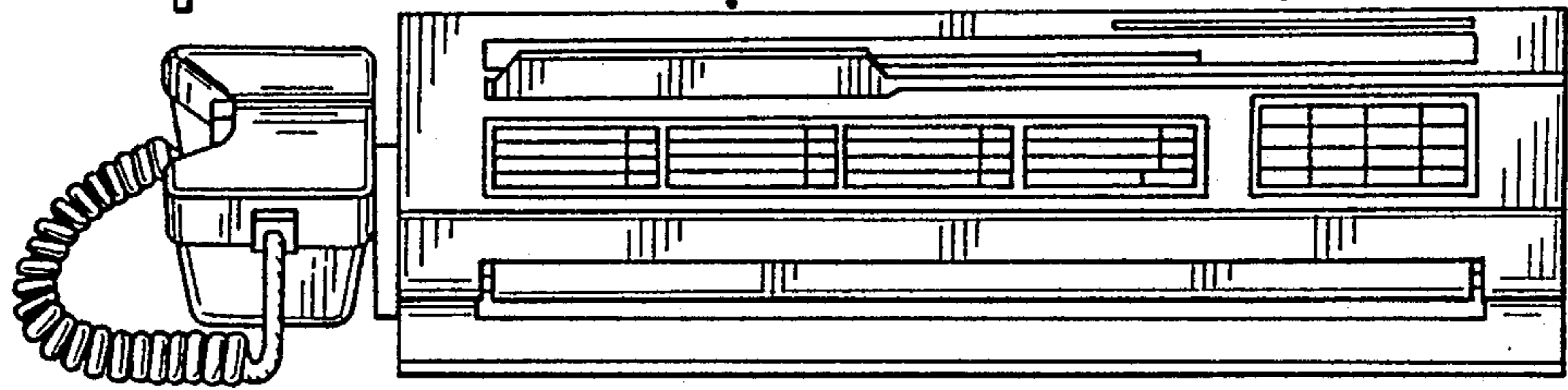
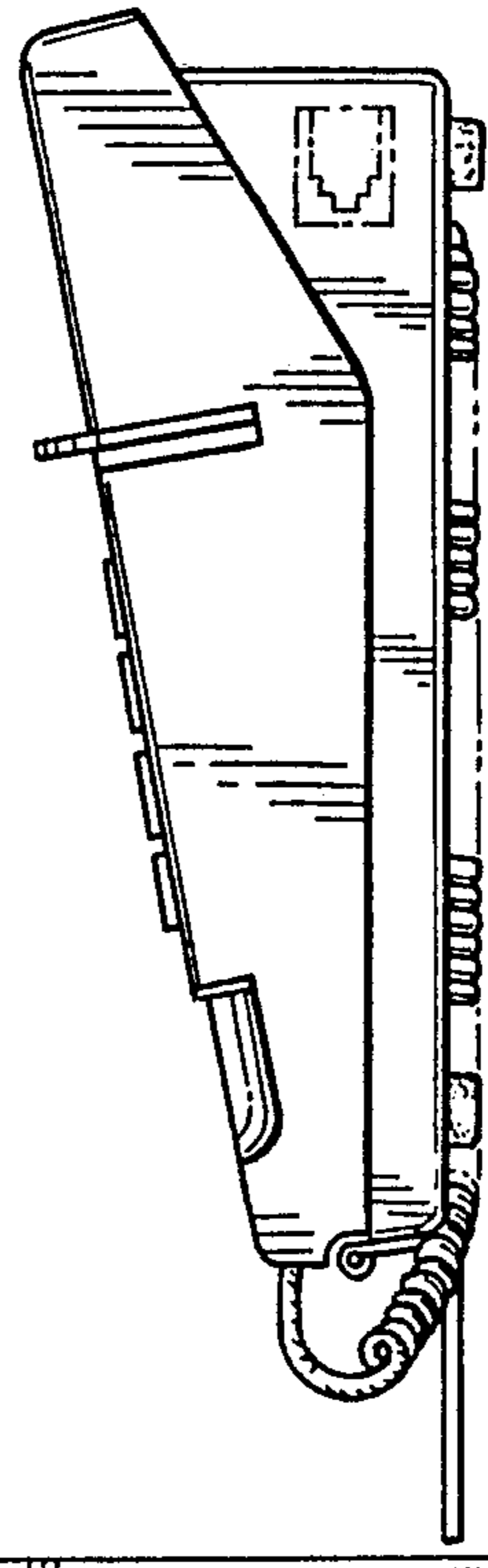

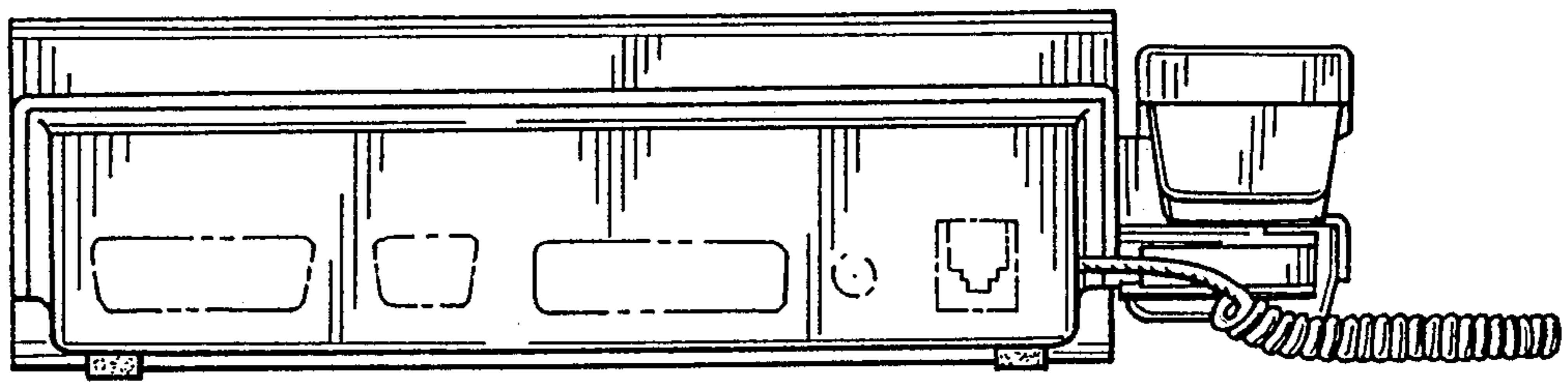

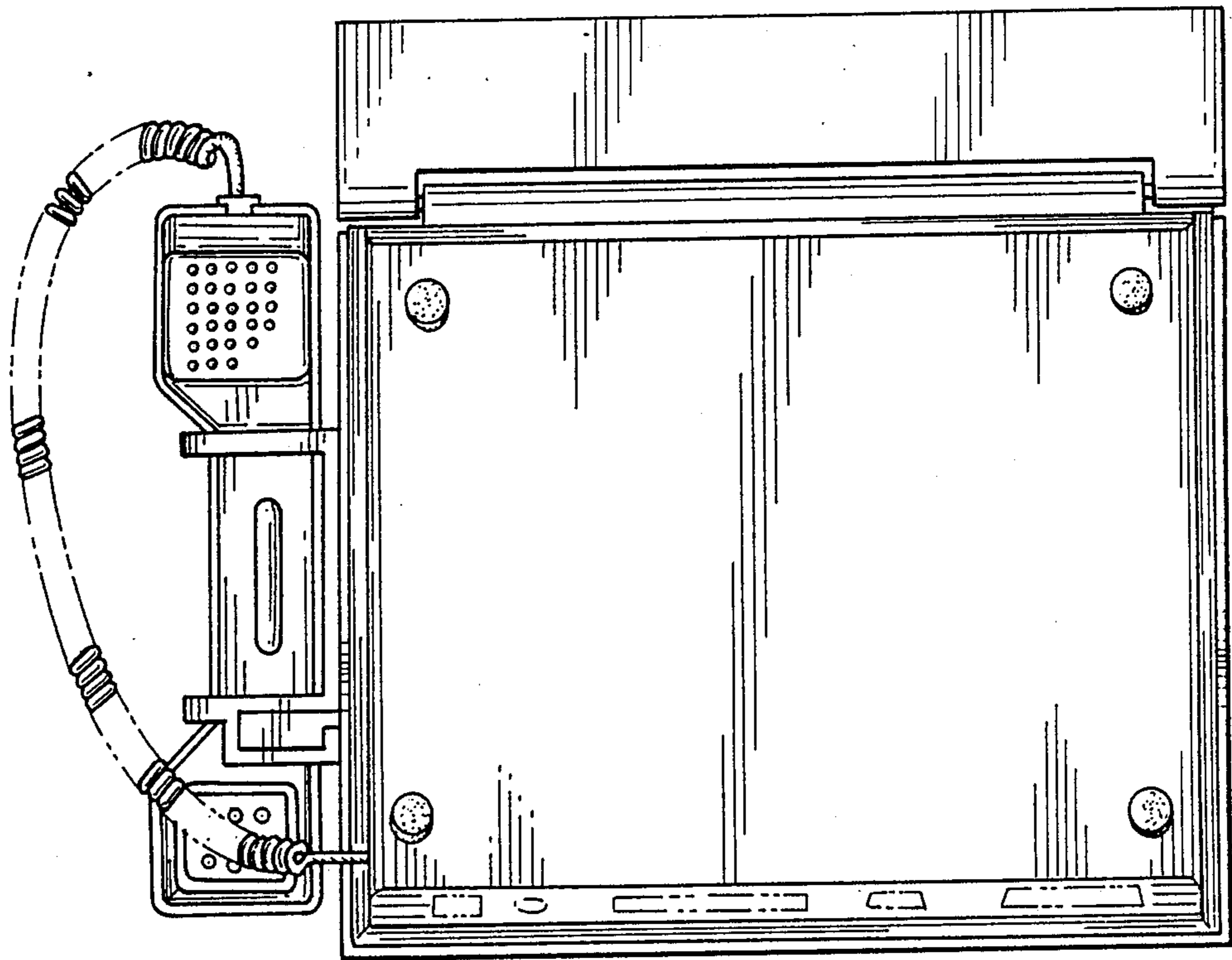
