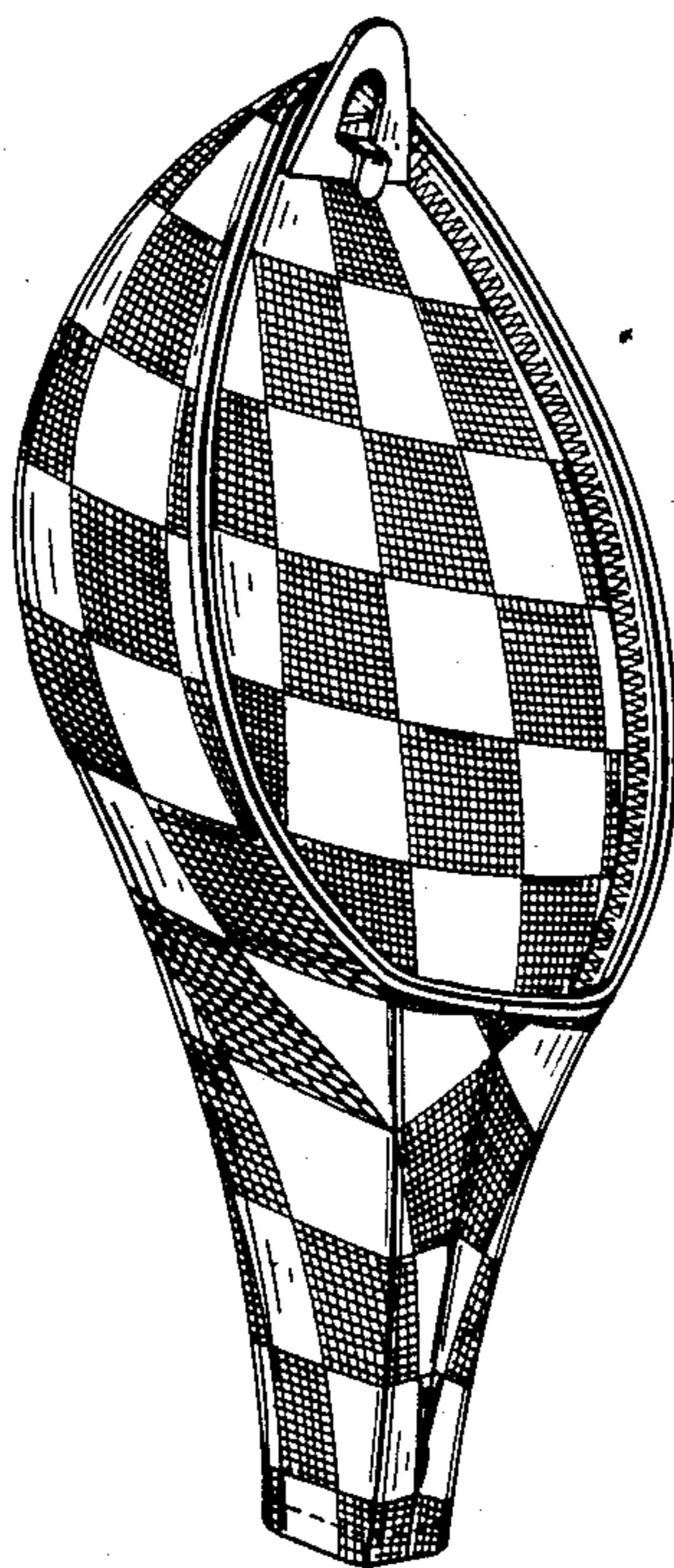

[57] CLAIM

The ornamental design for a shoe heel and counter protector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe heel and counter protector showing our new design; FIG. 2 is a rear elevational view of FIG. 1; FIG. 3 is a side elevational view of FIG. 1, the opposite side being a mirror image thereof; FIG. 4 is a front elevational view of FIG. 1; FIG. 5 is a top plan view of FIG. 1; and FIG. 6 is a bottom plan view of FIG. 1.



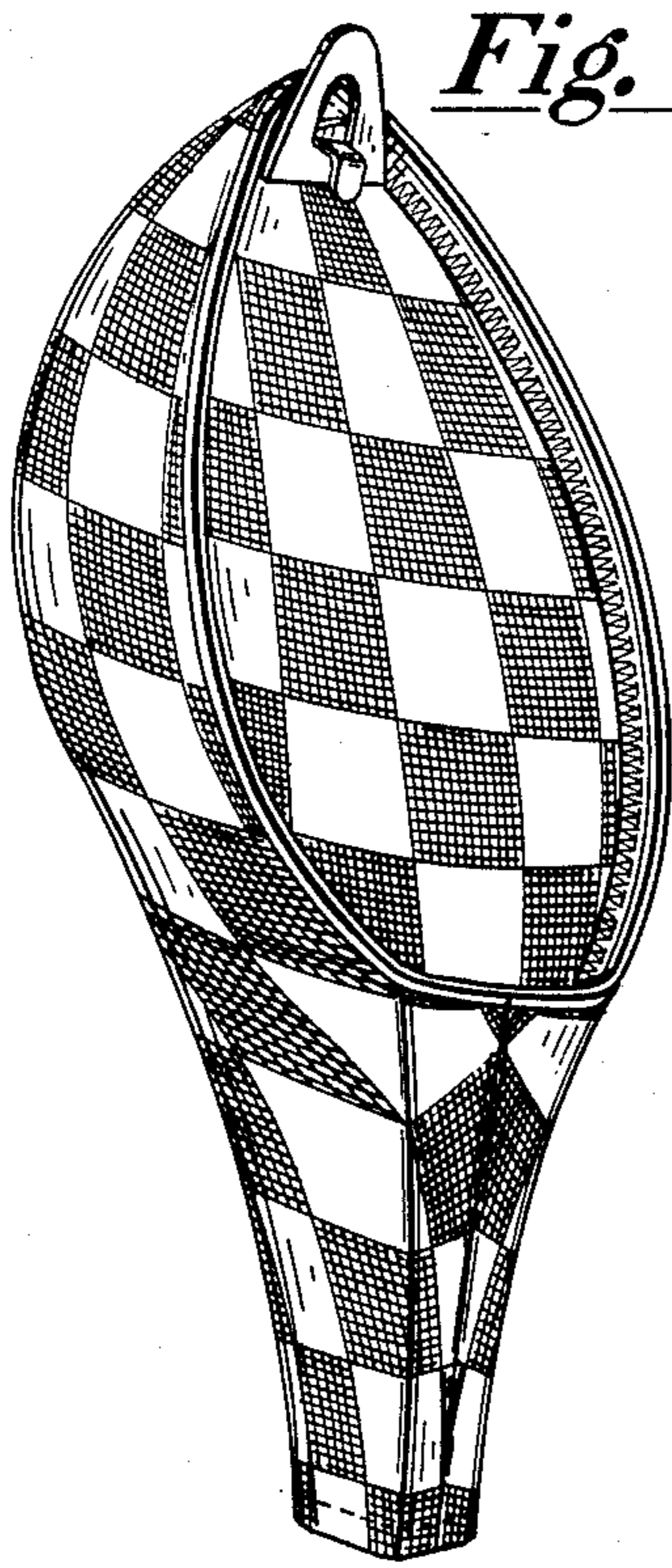

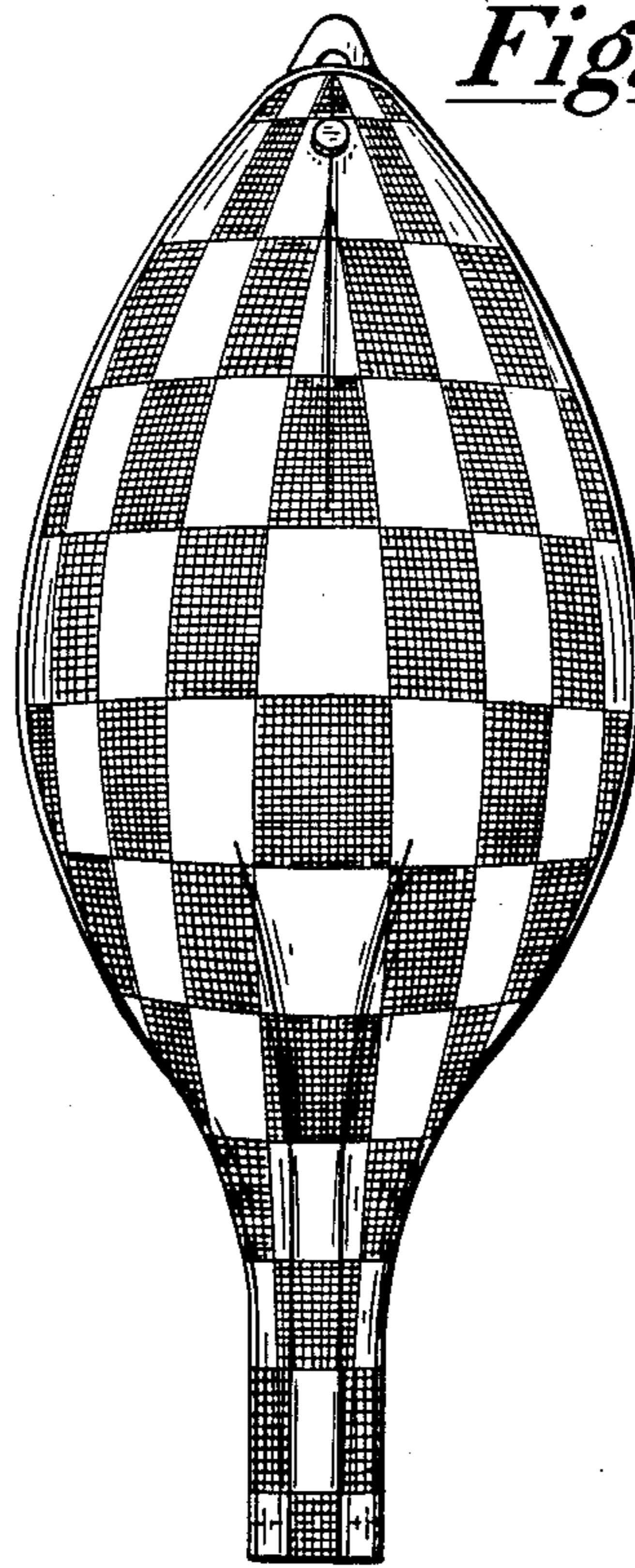

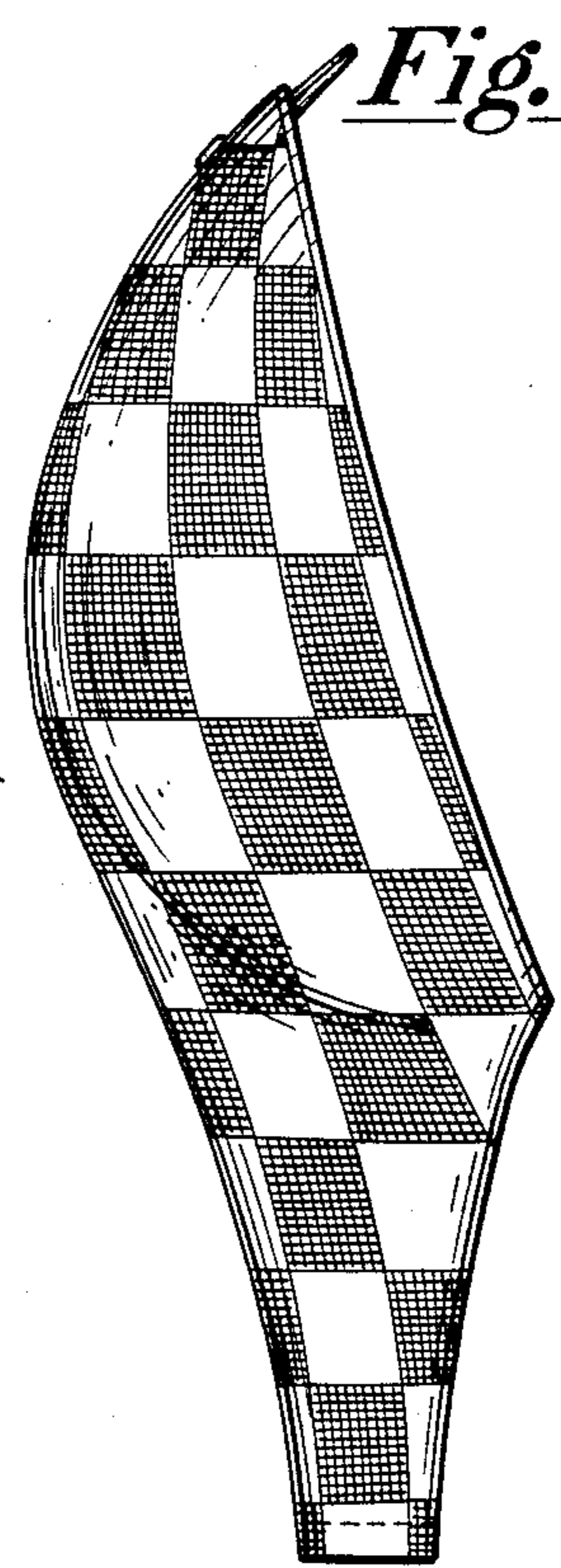

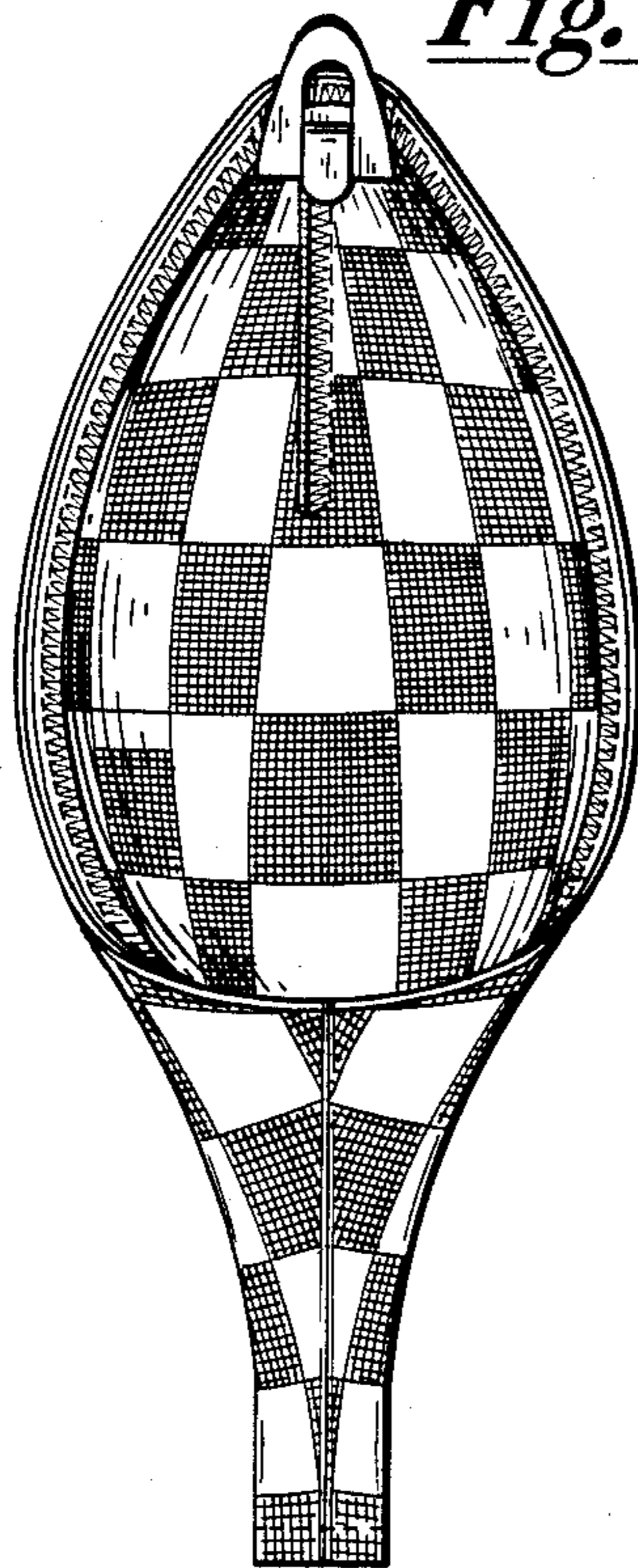

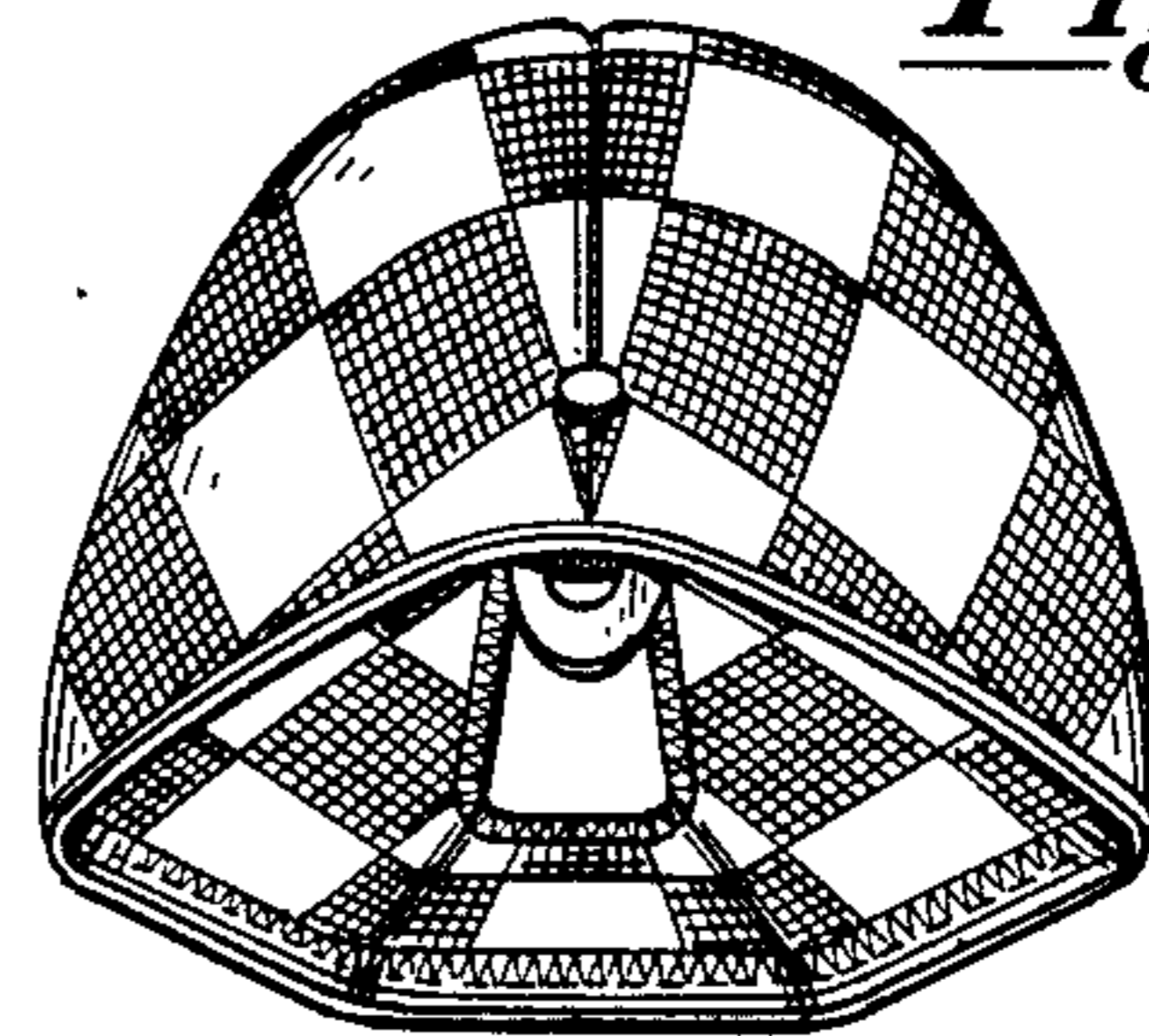

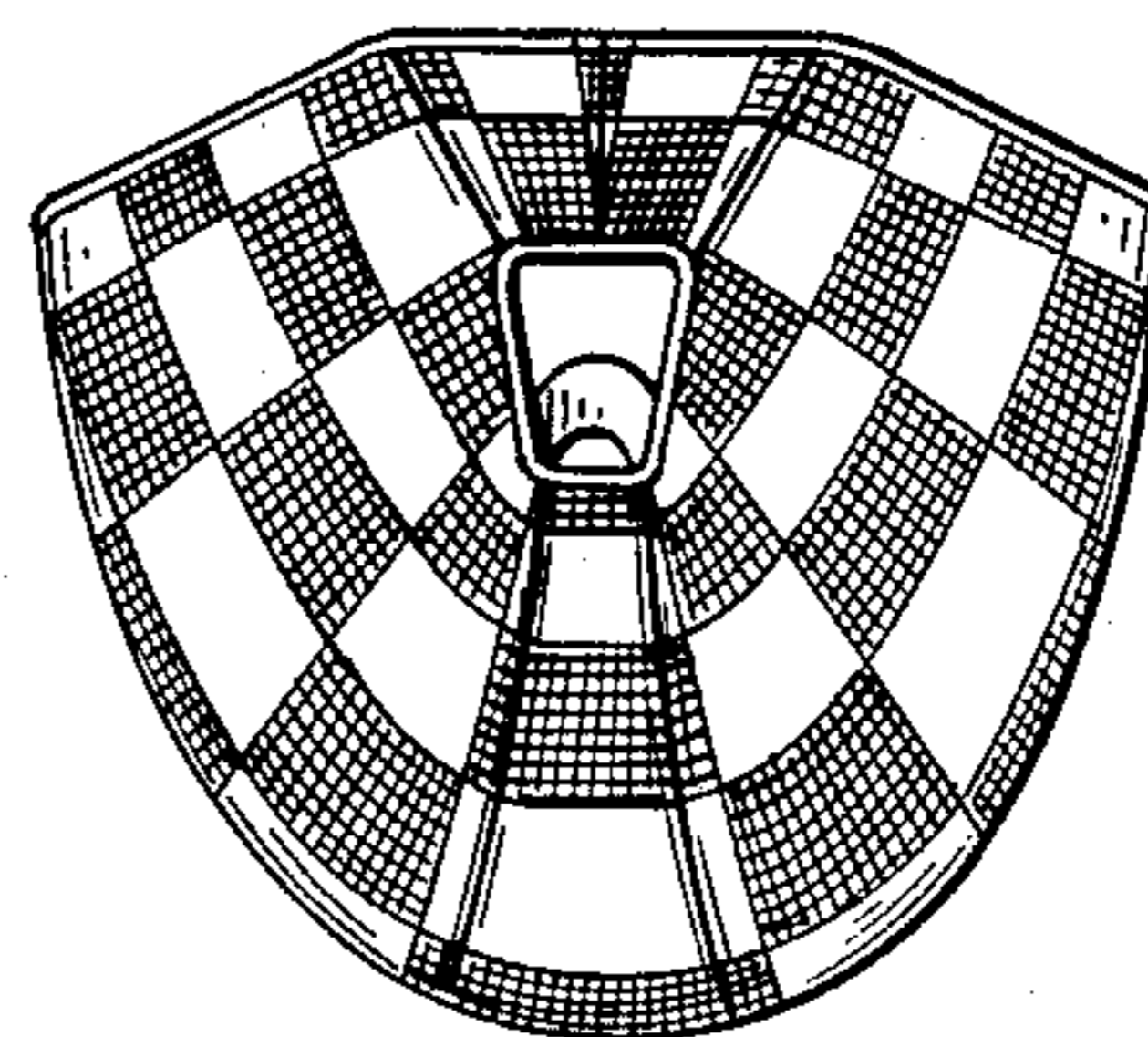

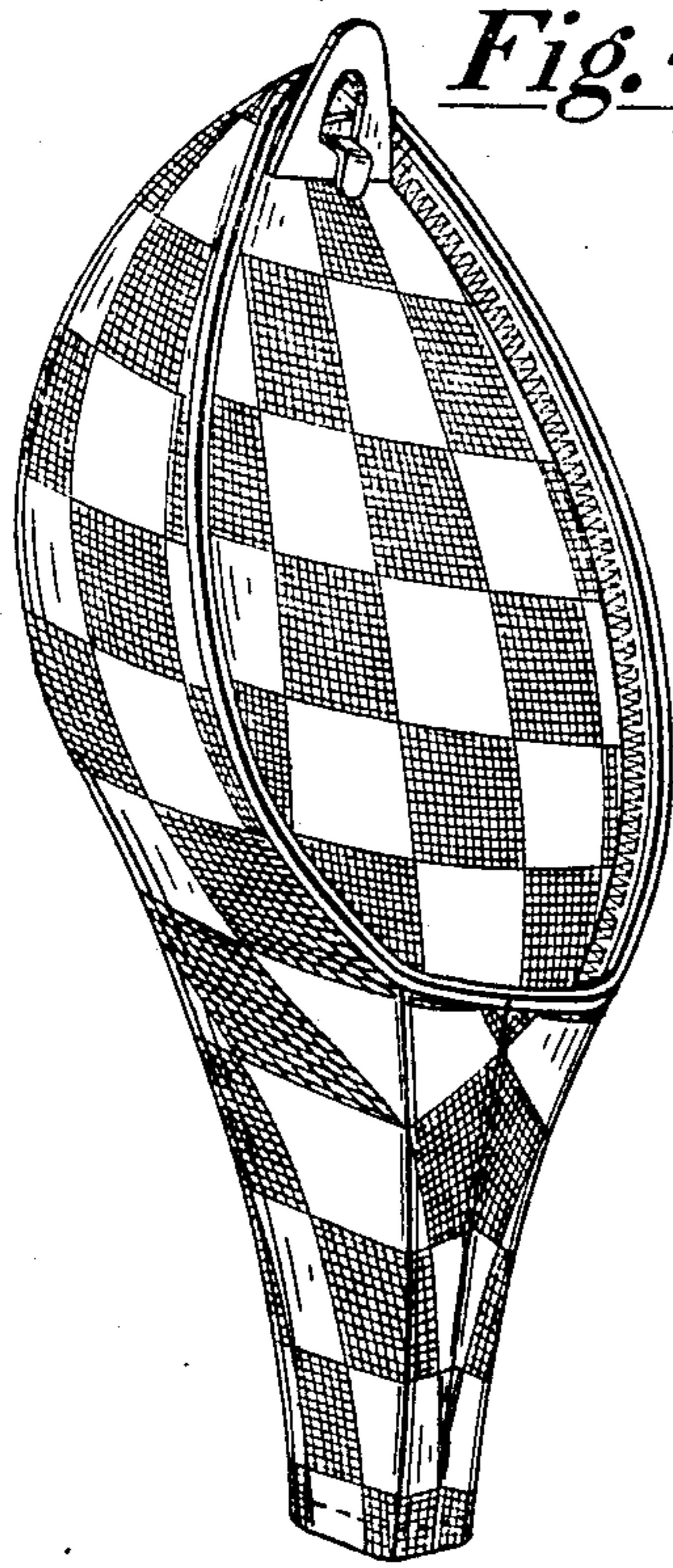

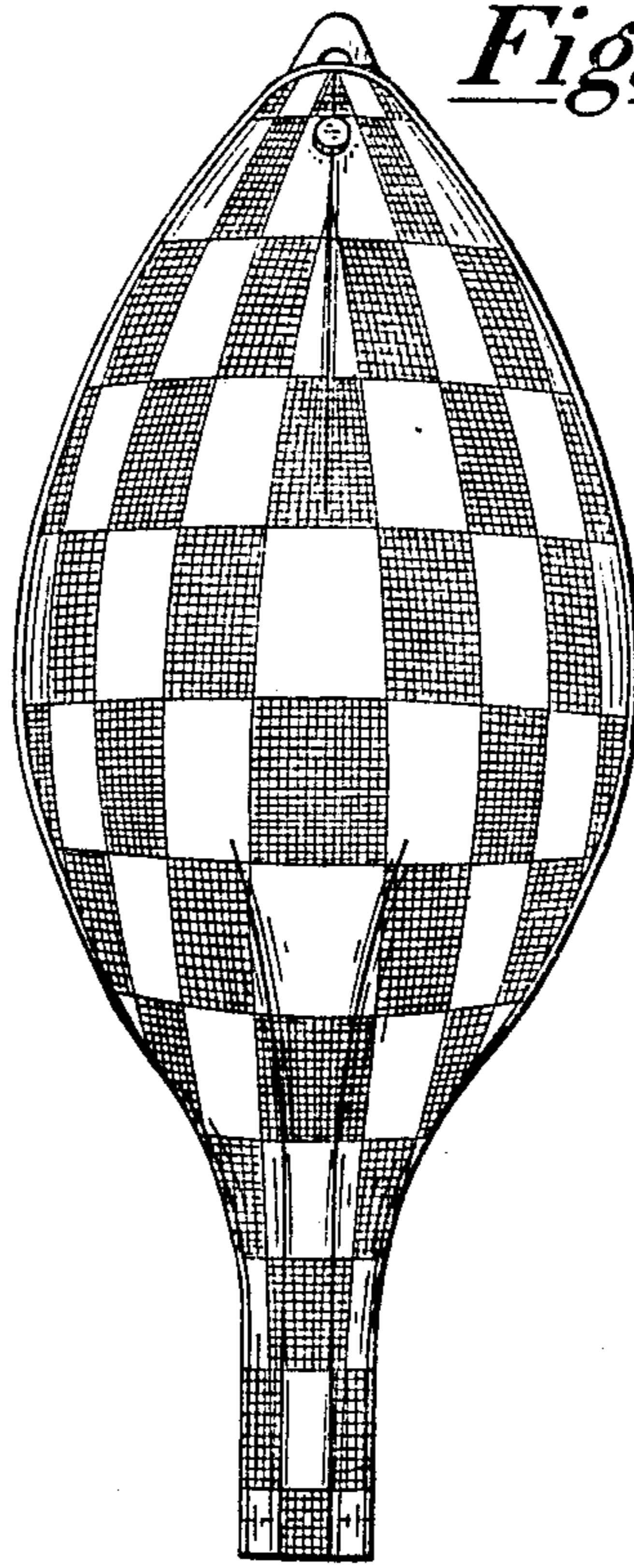

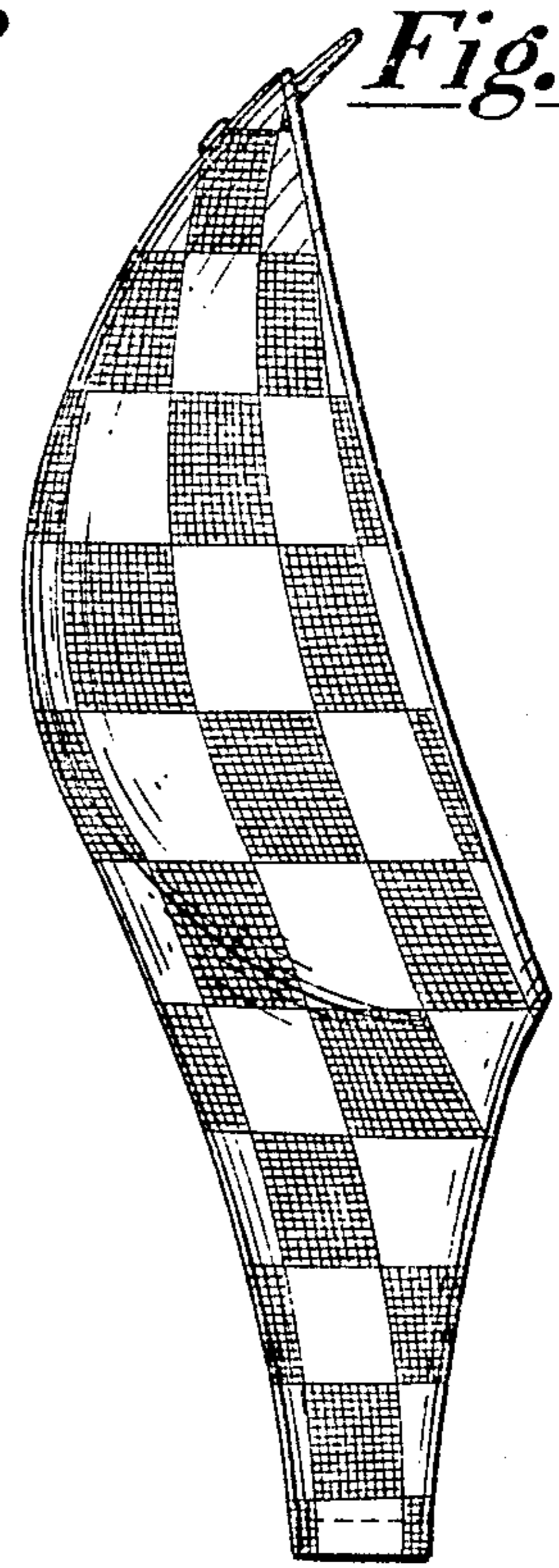

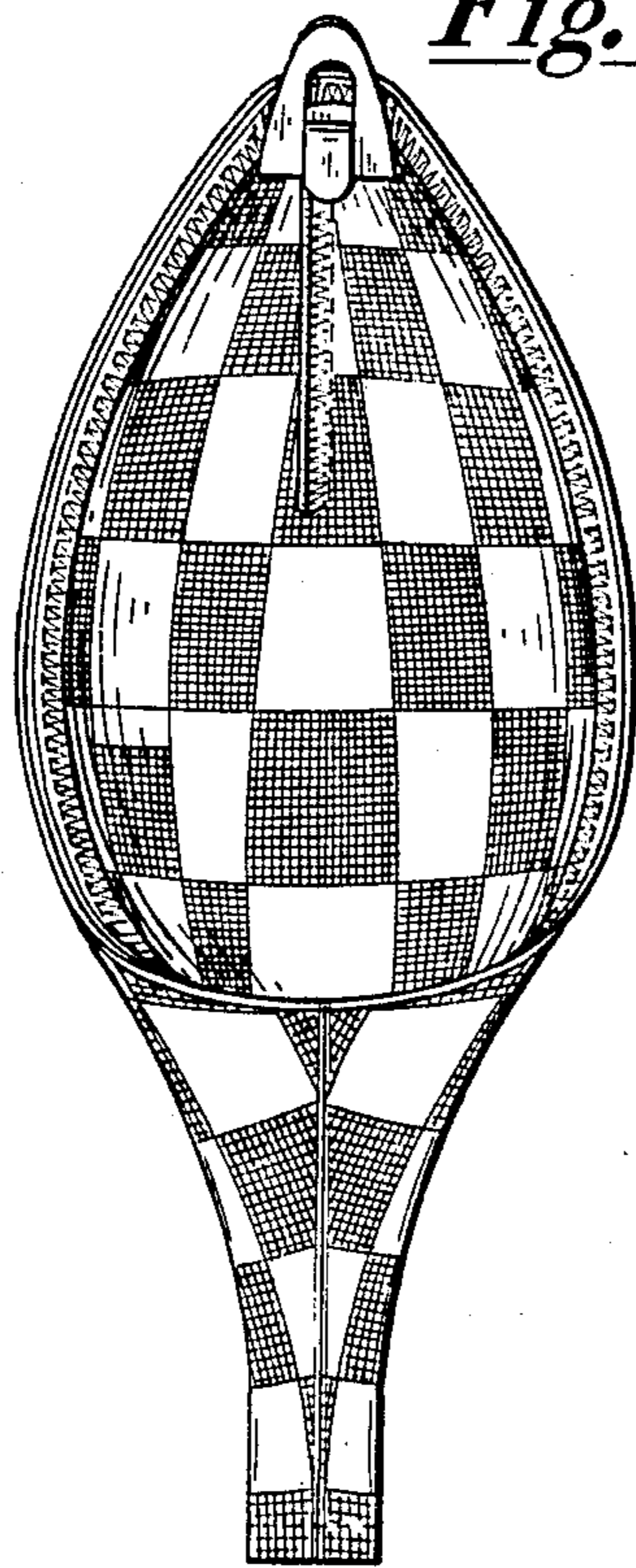

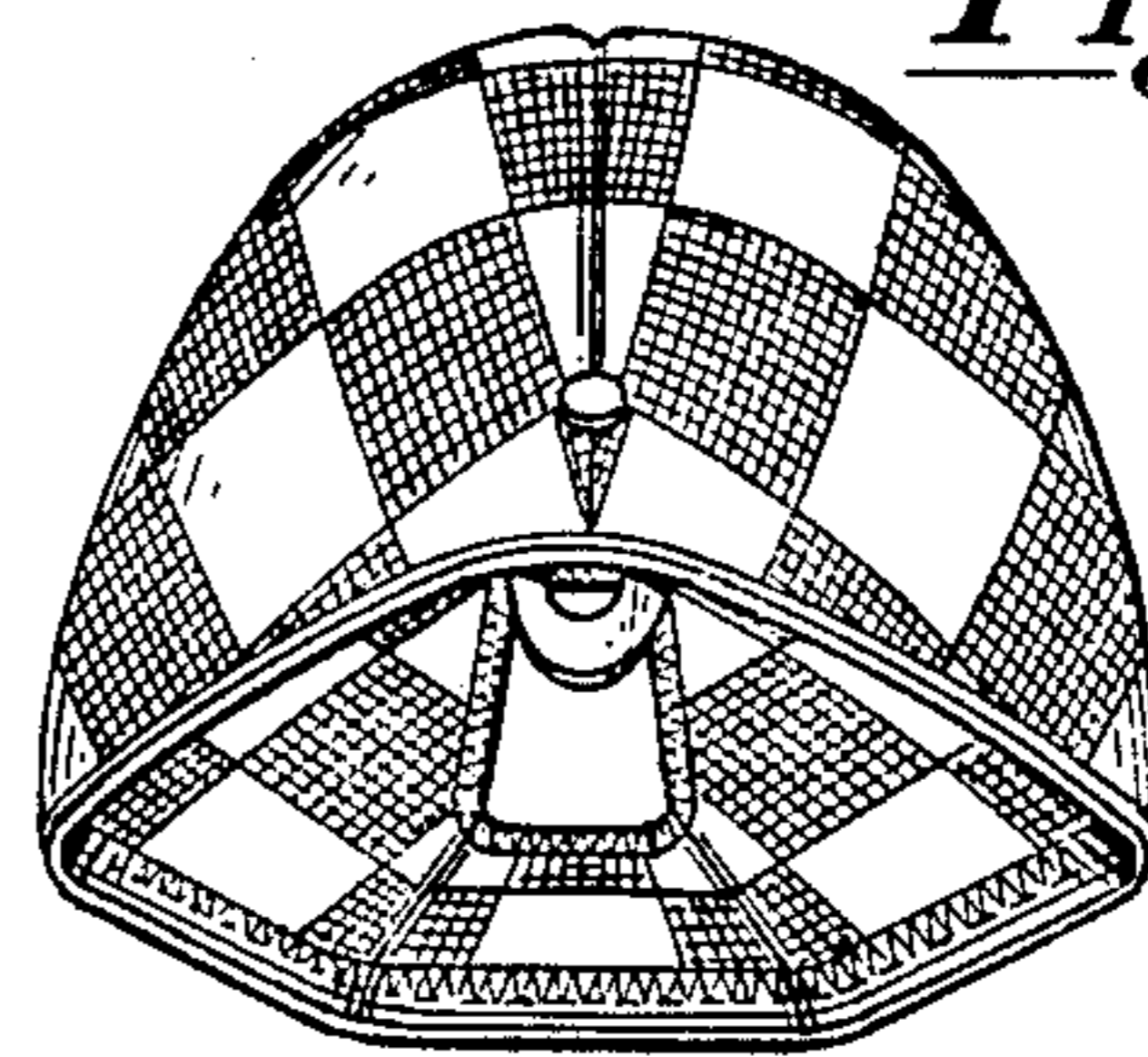

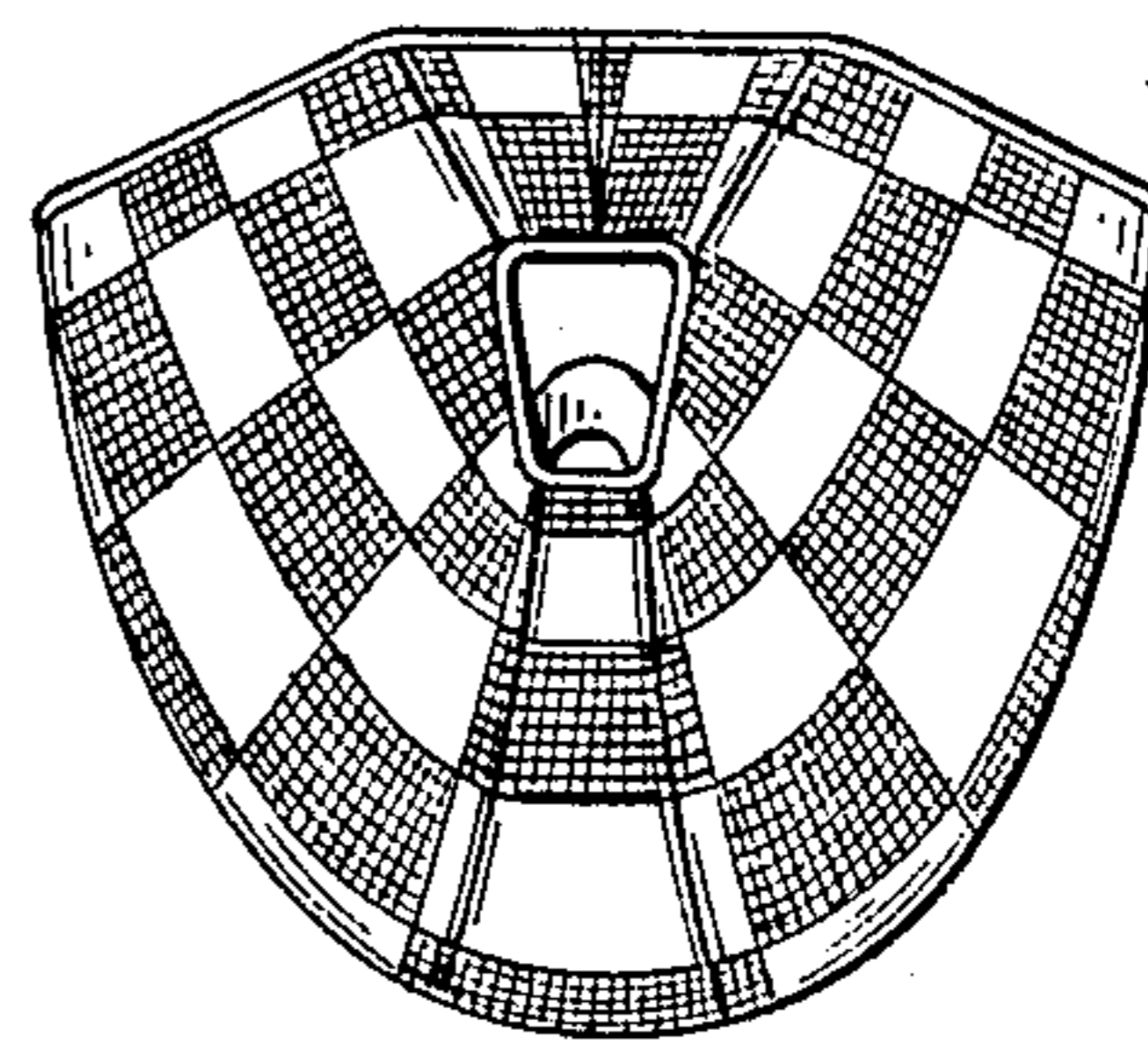
