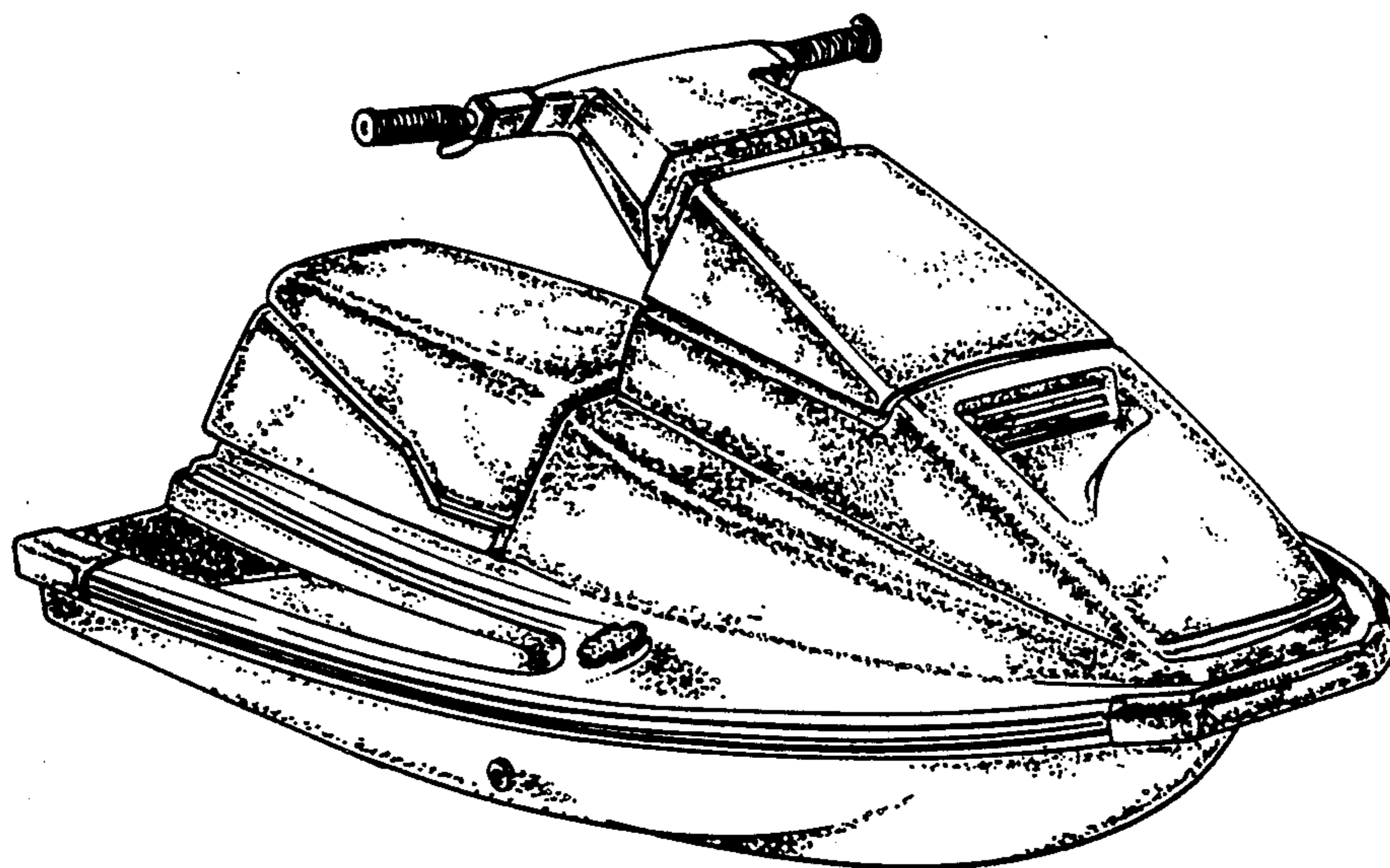

DESCRIPTION

FIG. 1 is an enlarged front perspective view of a watercraft showing my new design;
 FIG. 2 is a rear perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof; and
 FIG. 7 is a side elevational view thereof, the opposite side elevational view being a mirror image of that shown.



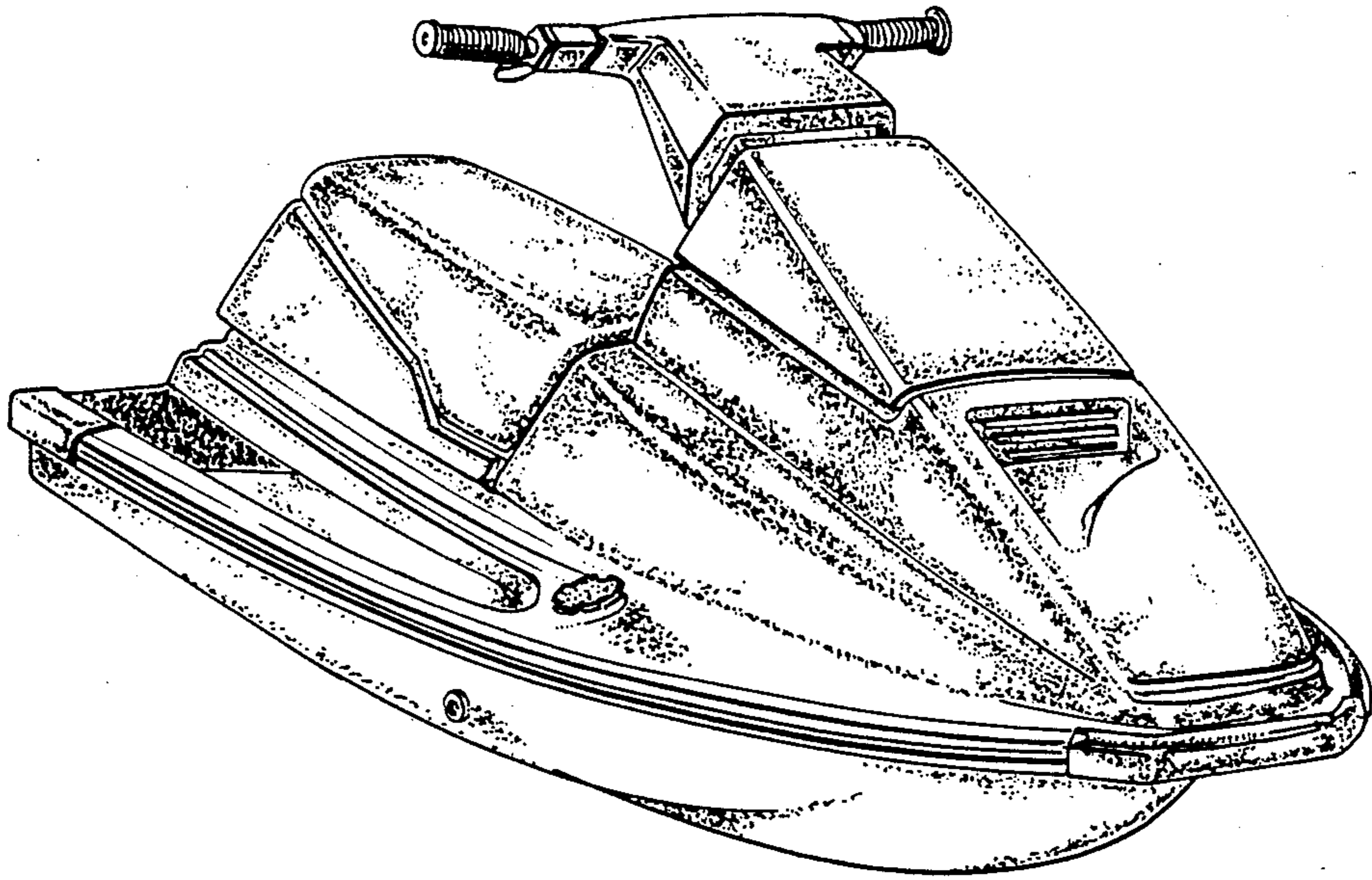

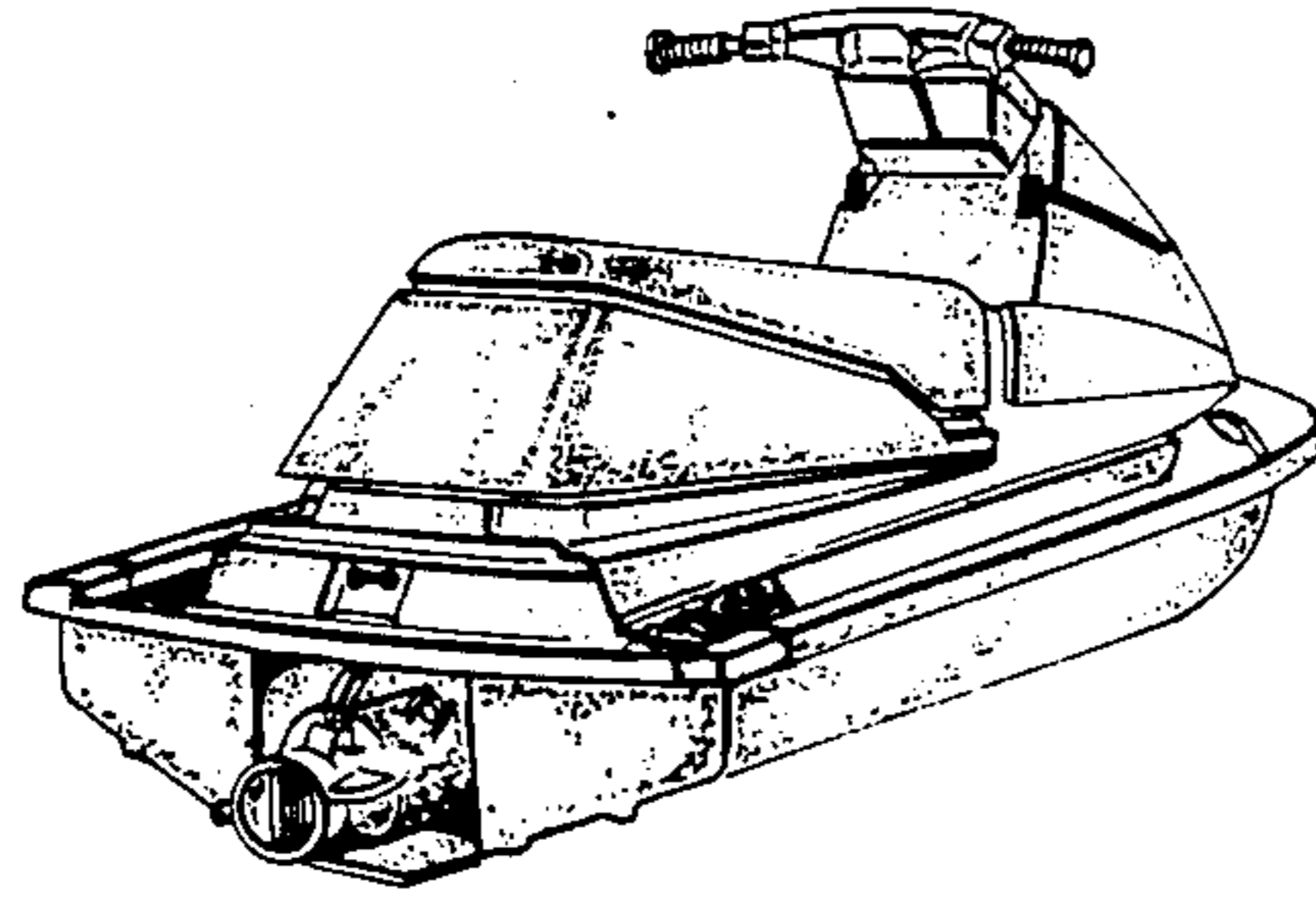

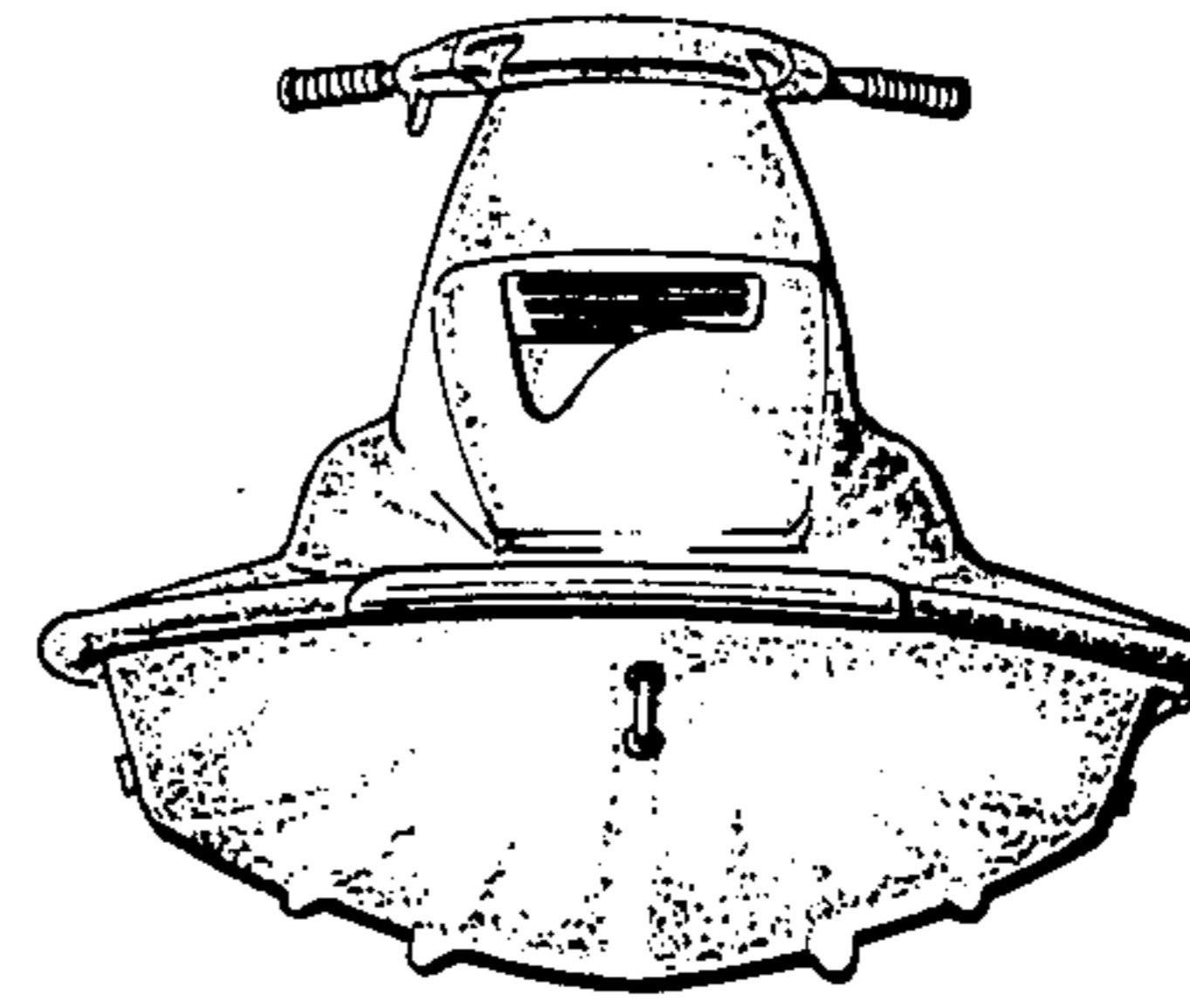

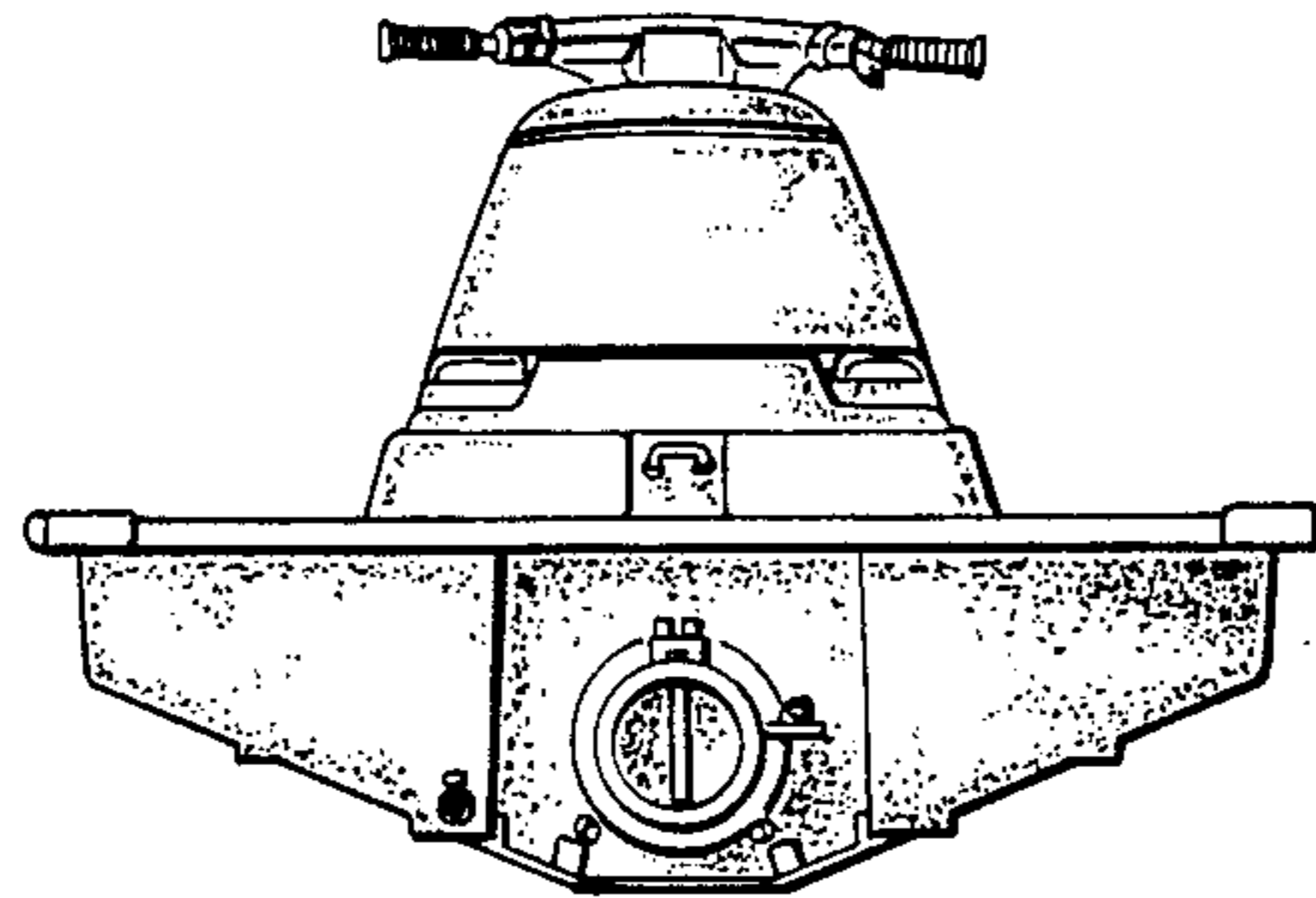

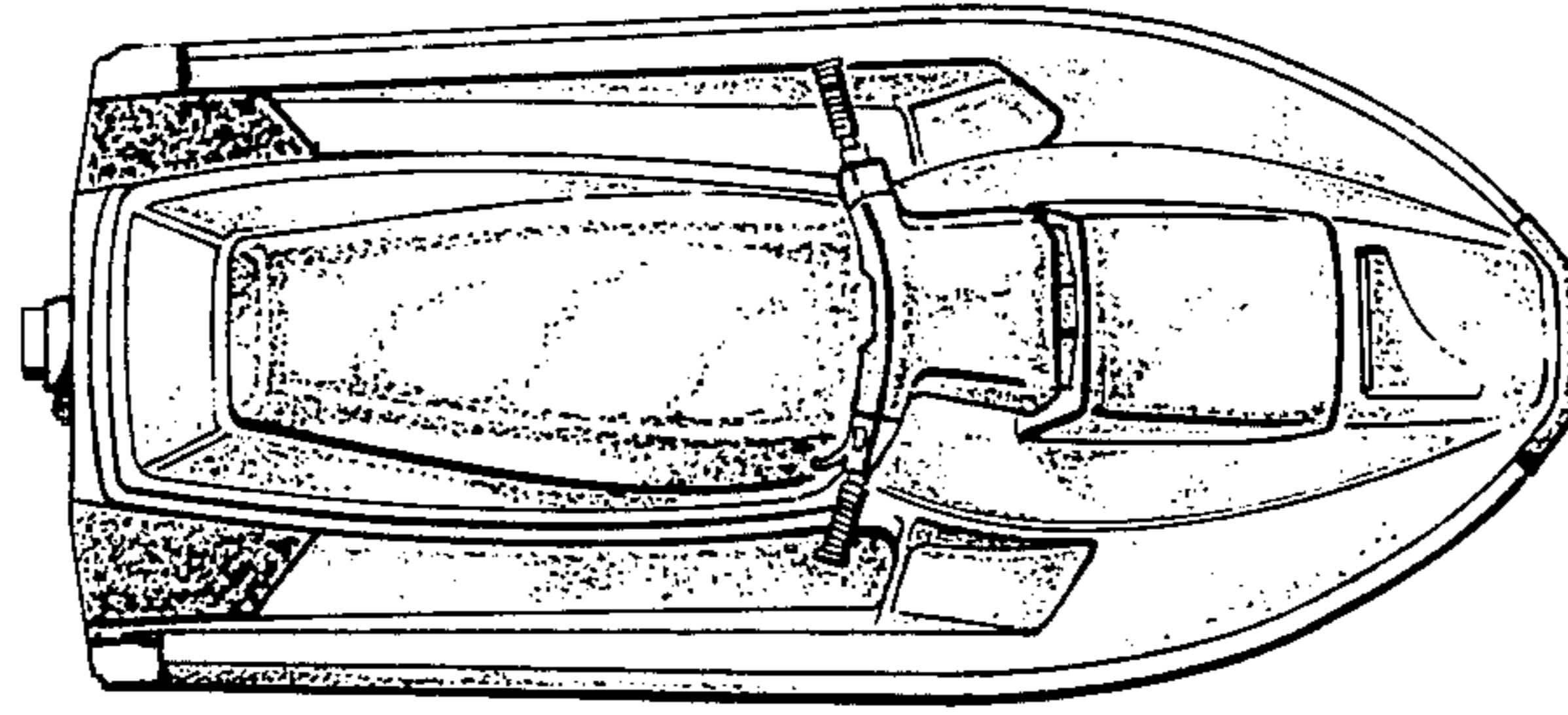

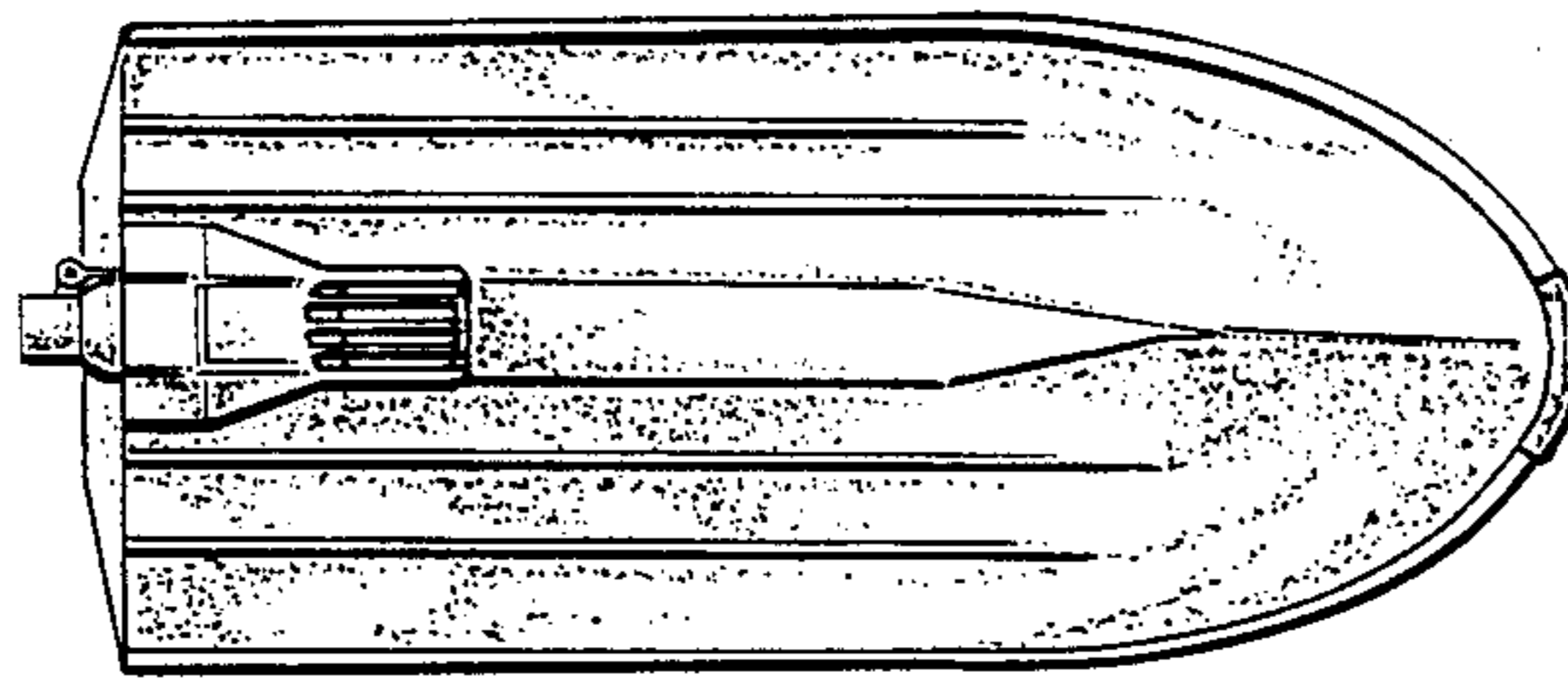

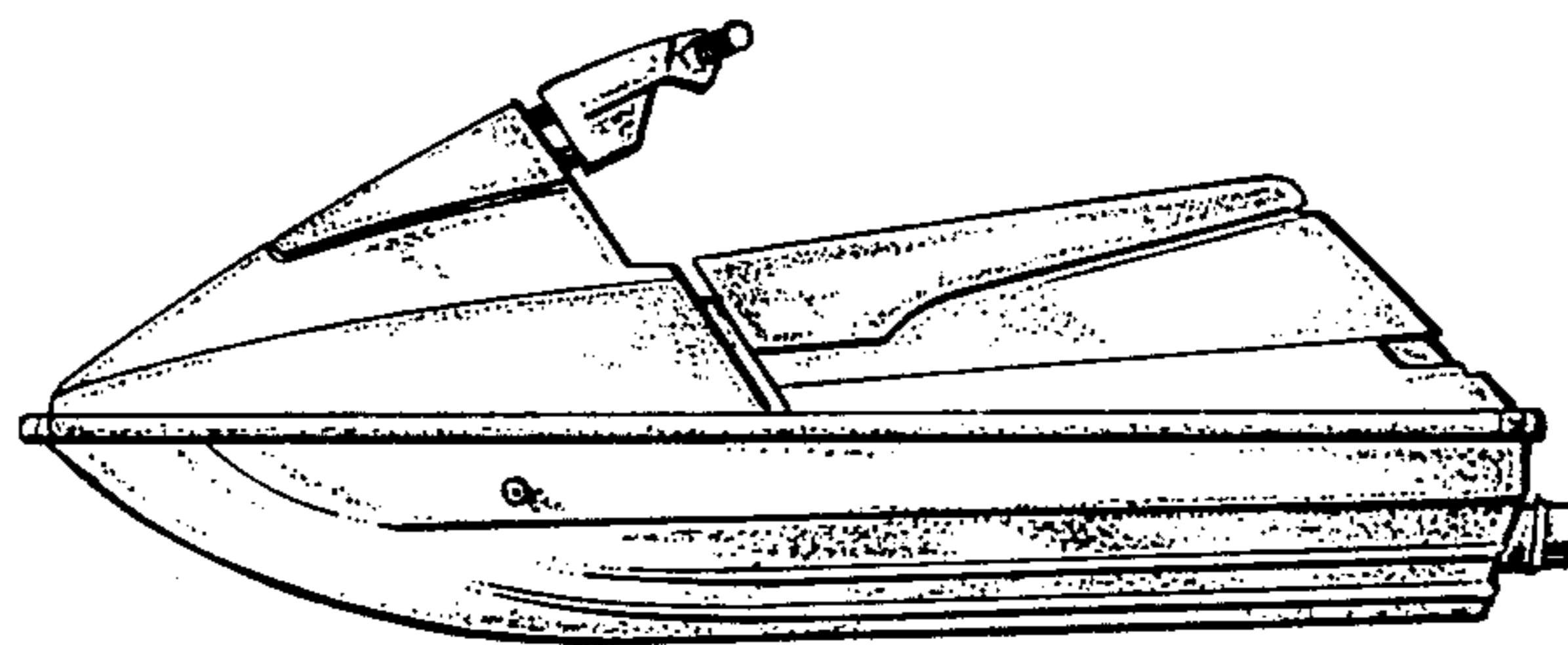
