FIG. 9 is a top plan view thereof;

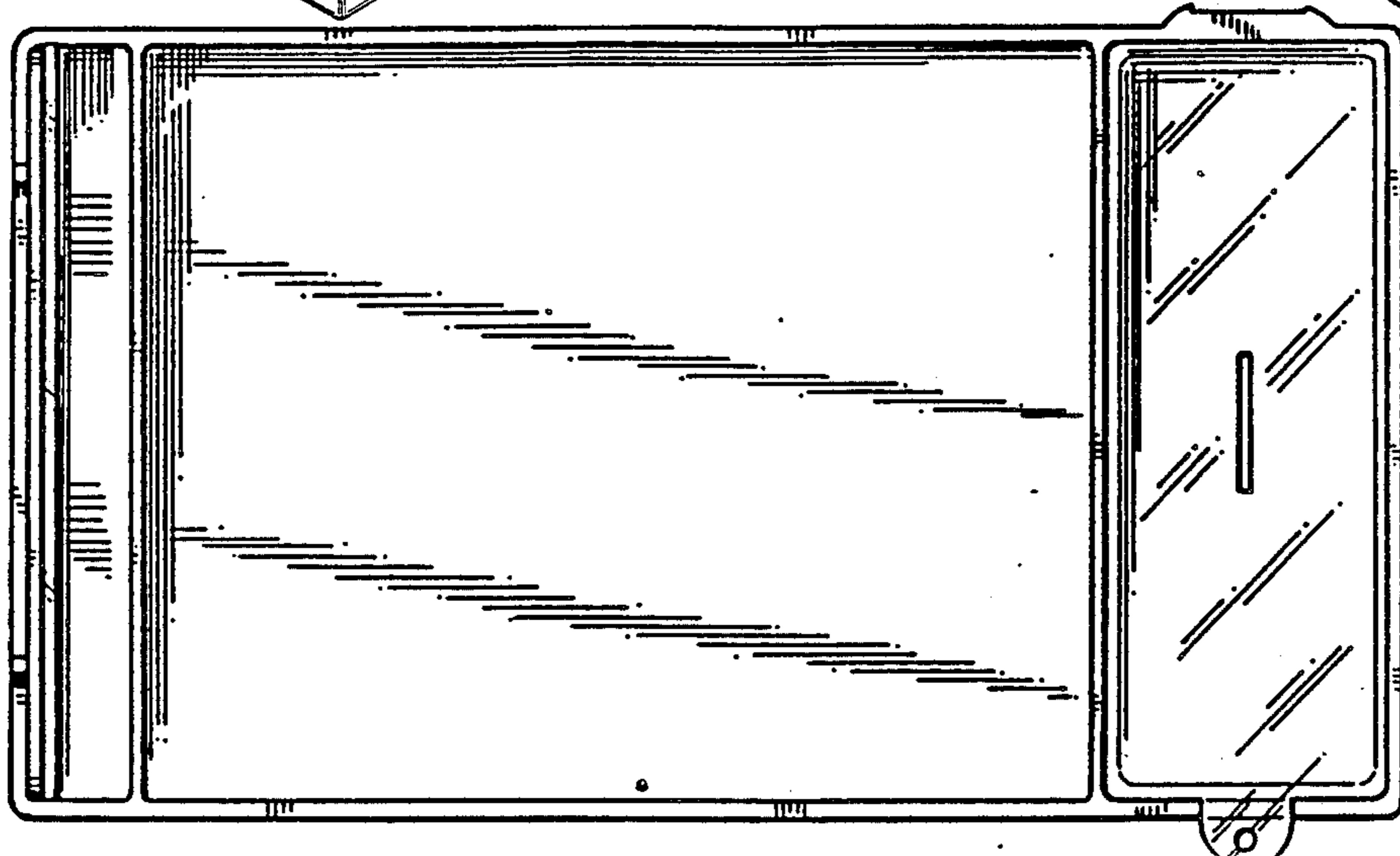
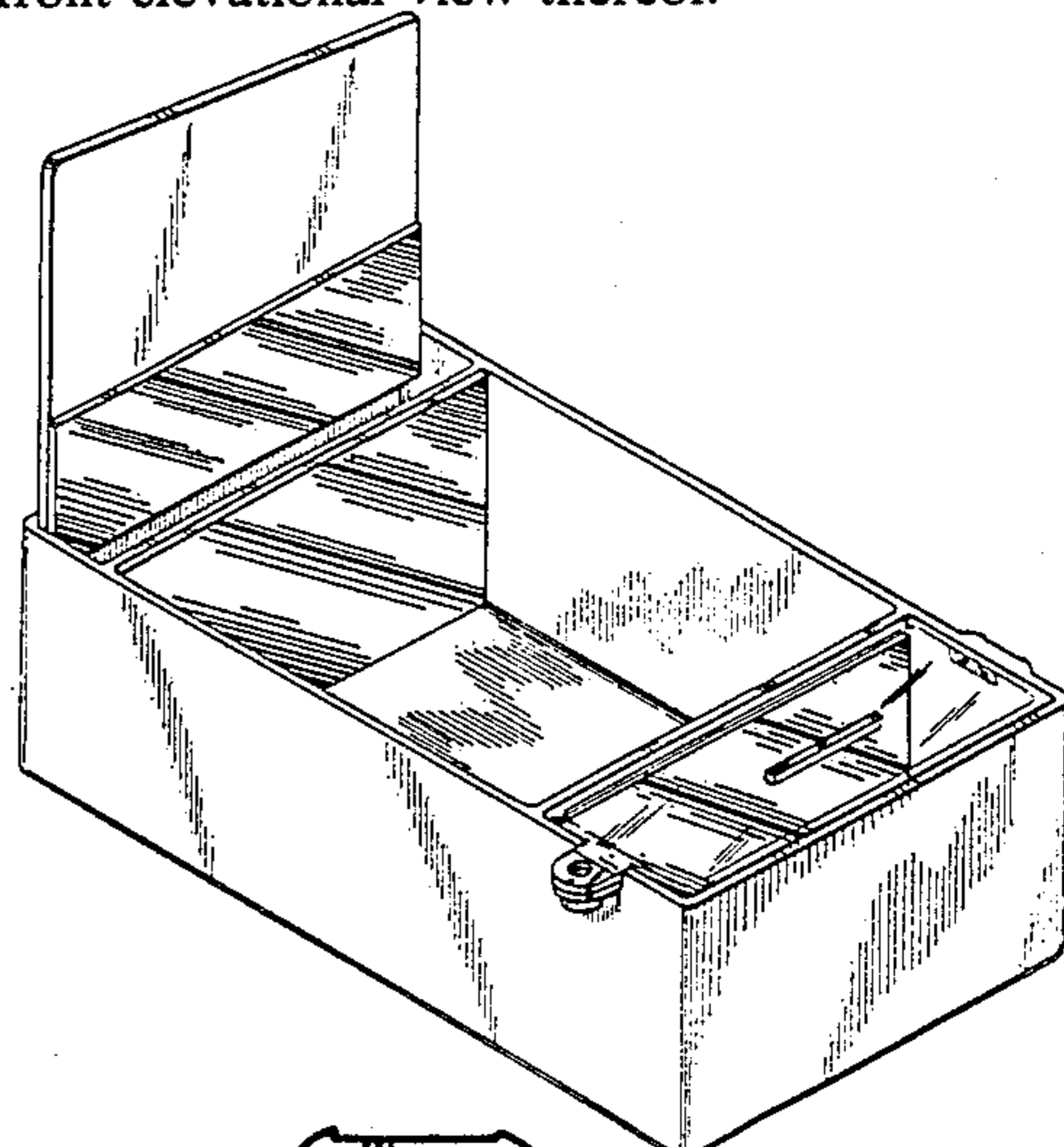
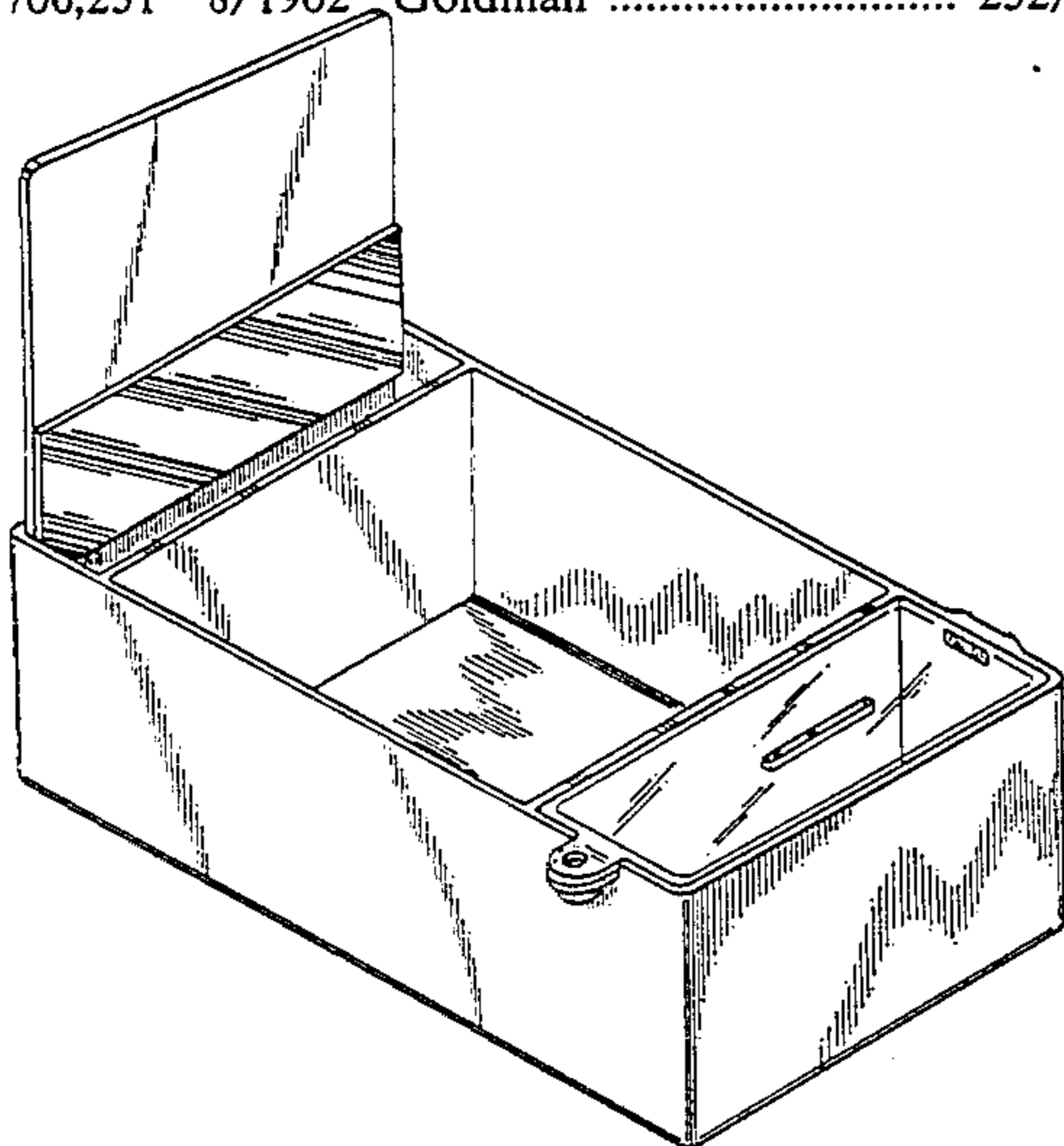
FIG. 10 is a left side elevational view thereof;

FIG. 14 is a front elevational view thereof.



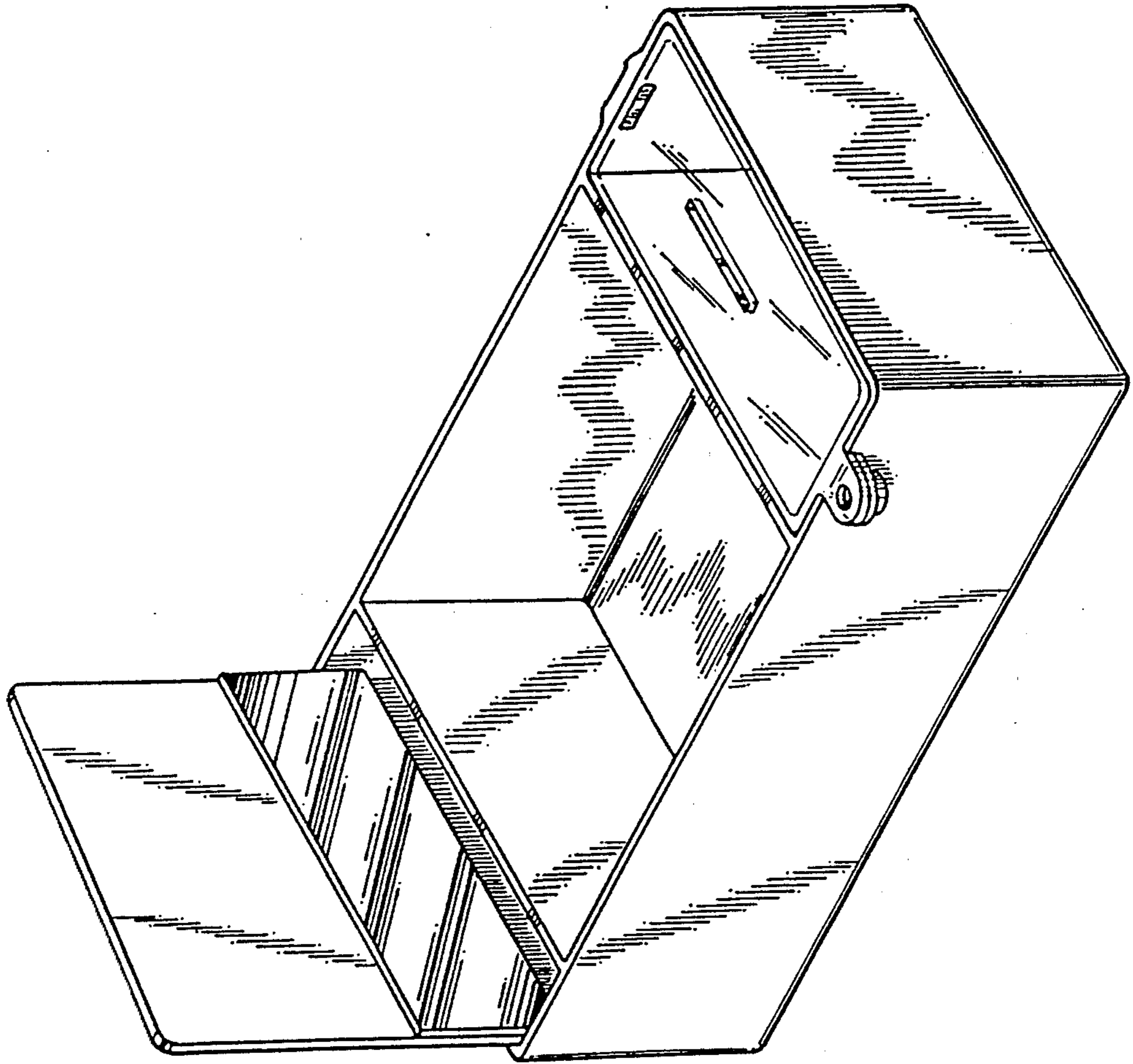

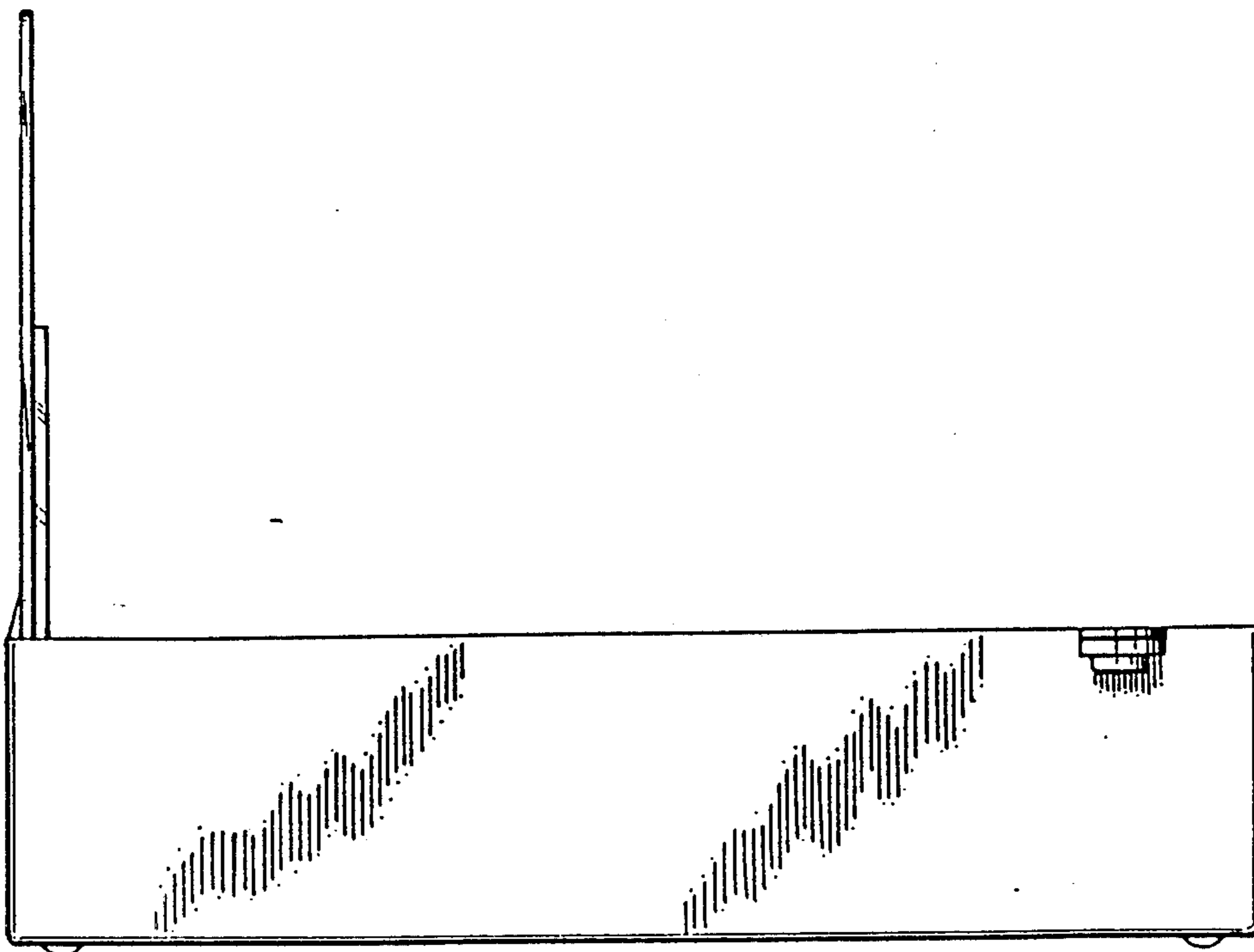
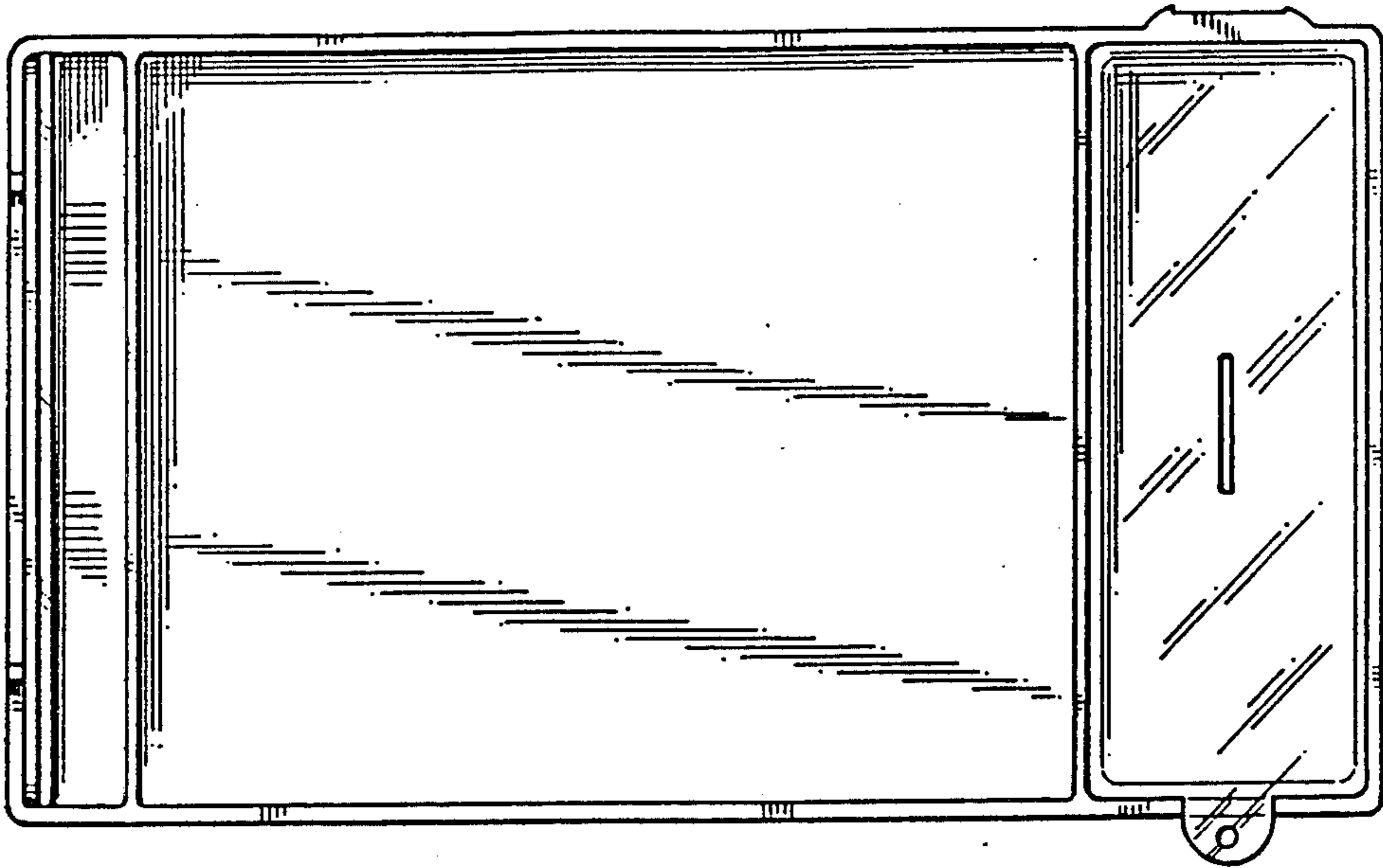

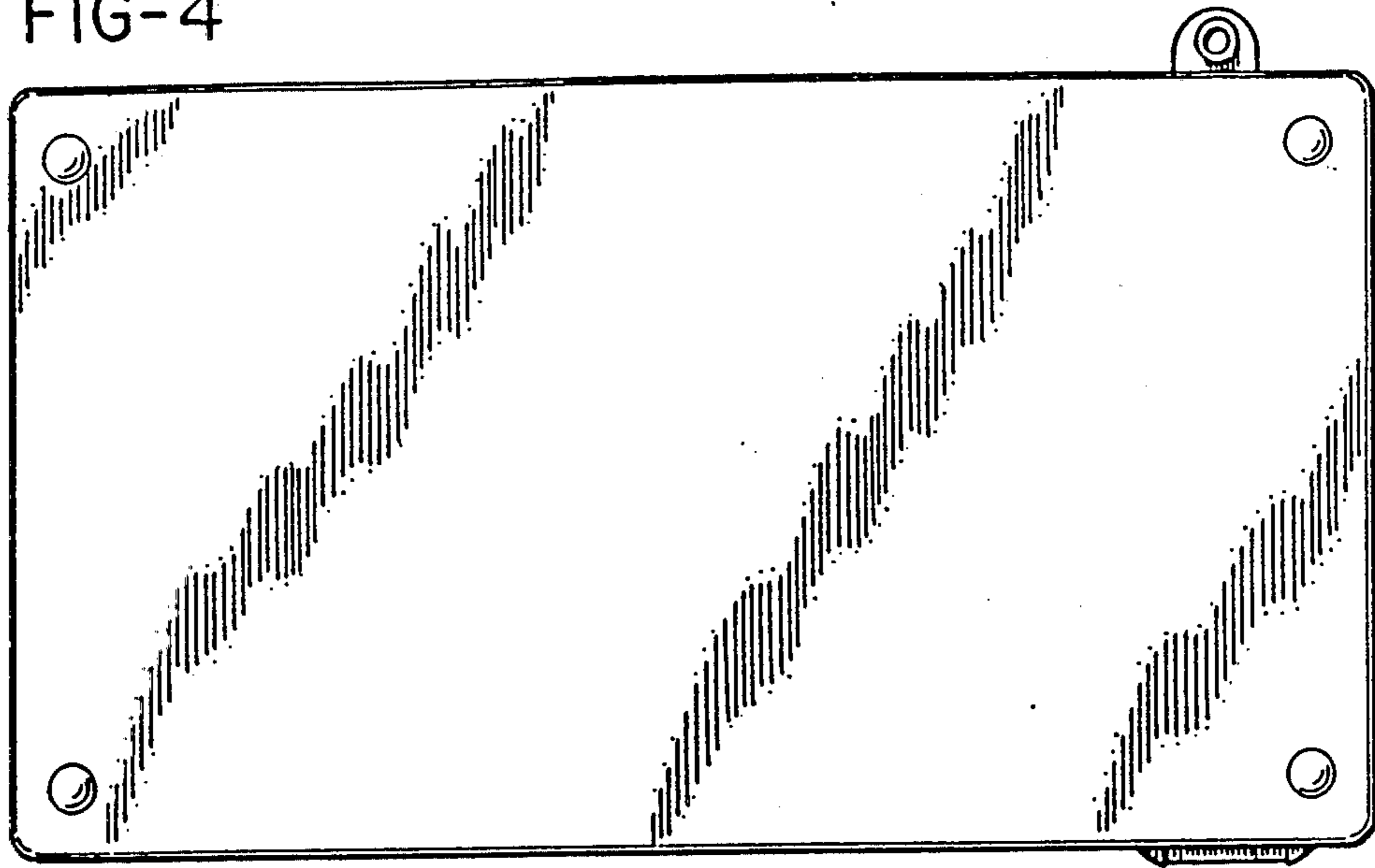

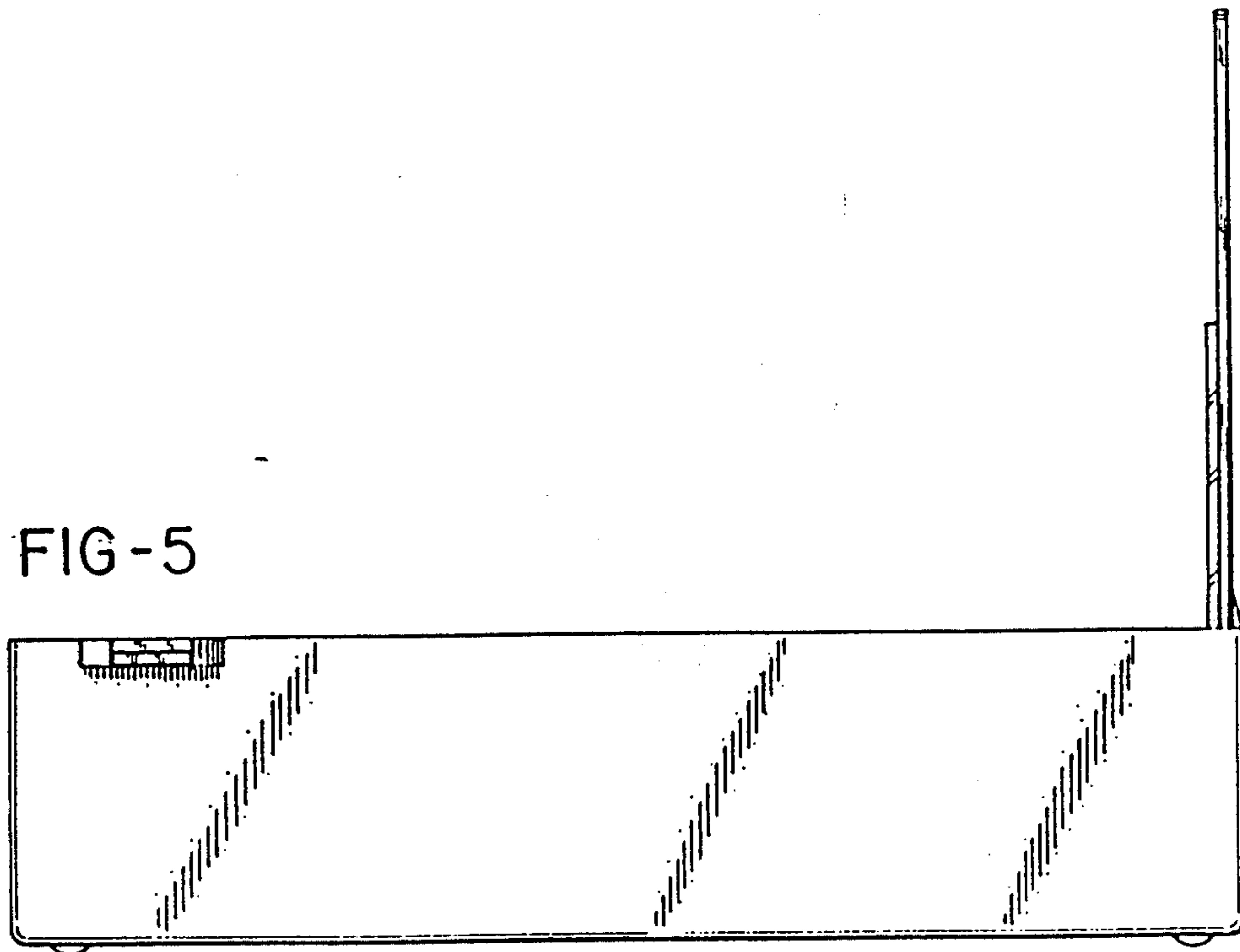

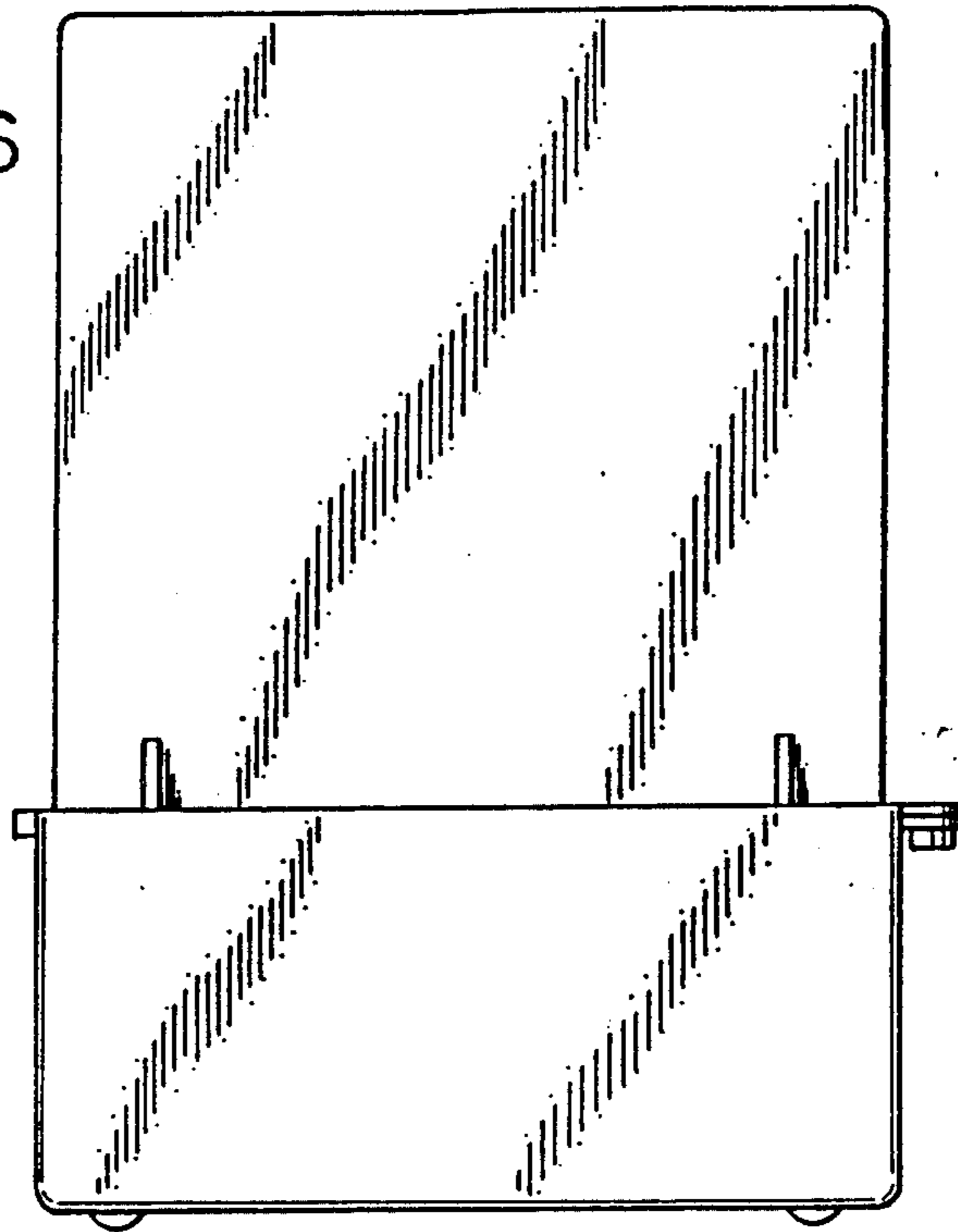
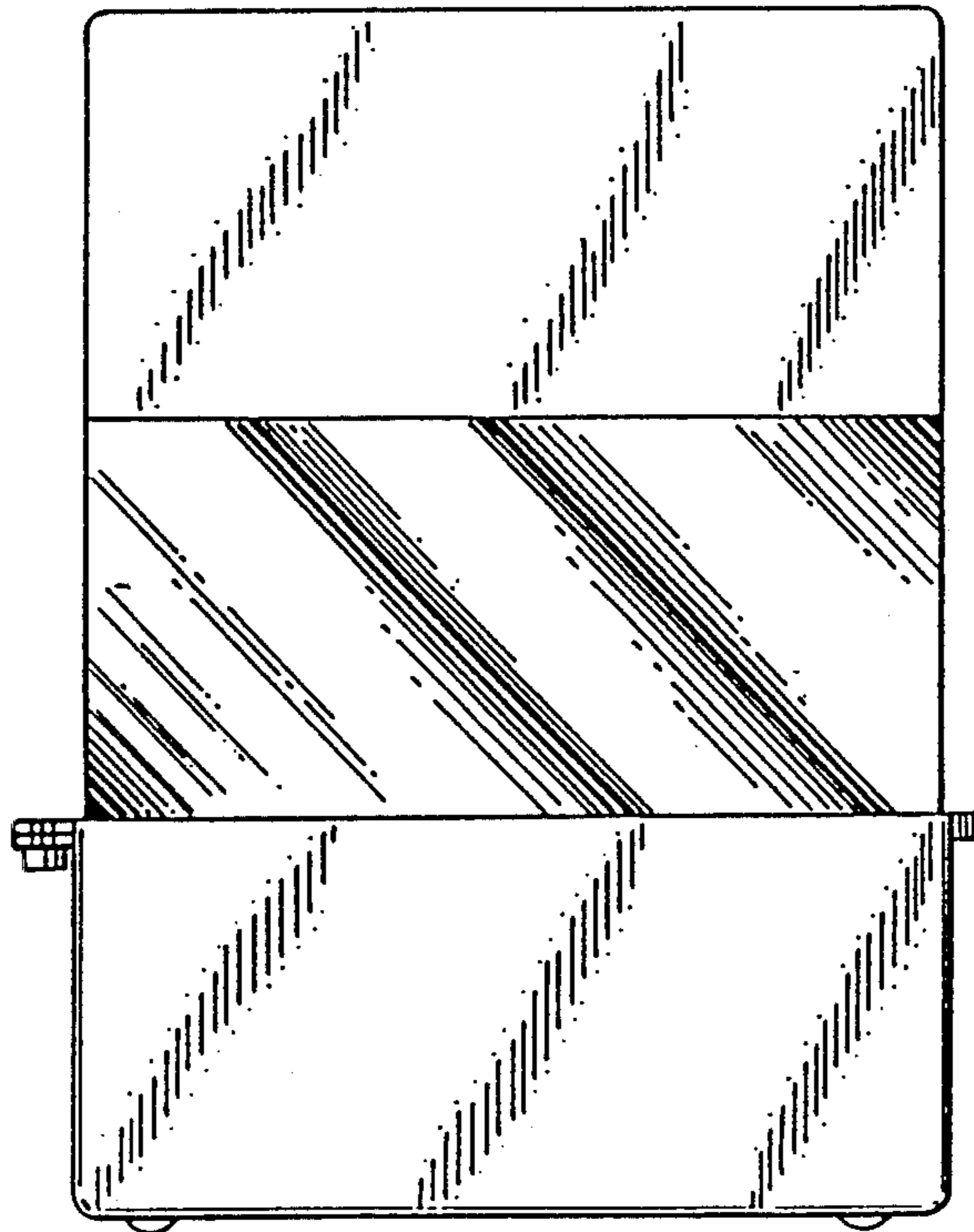

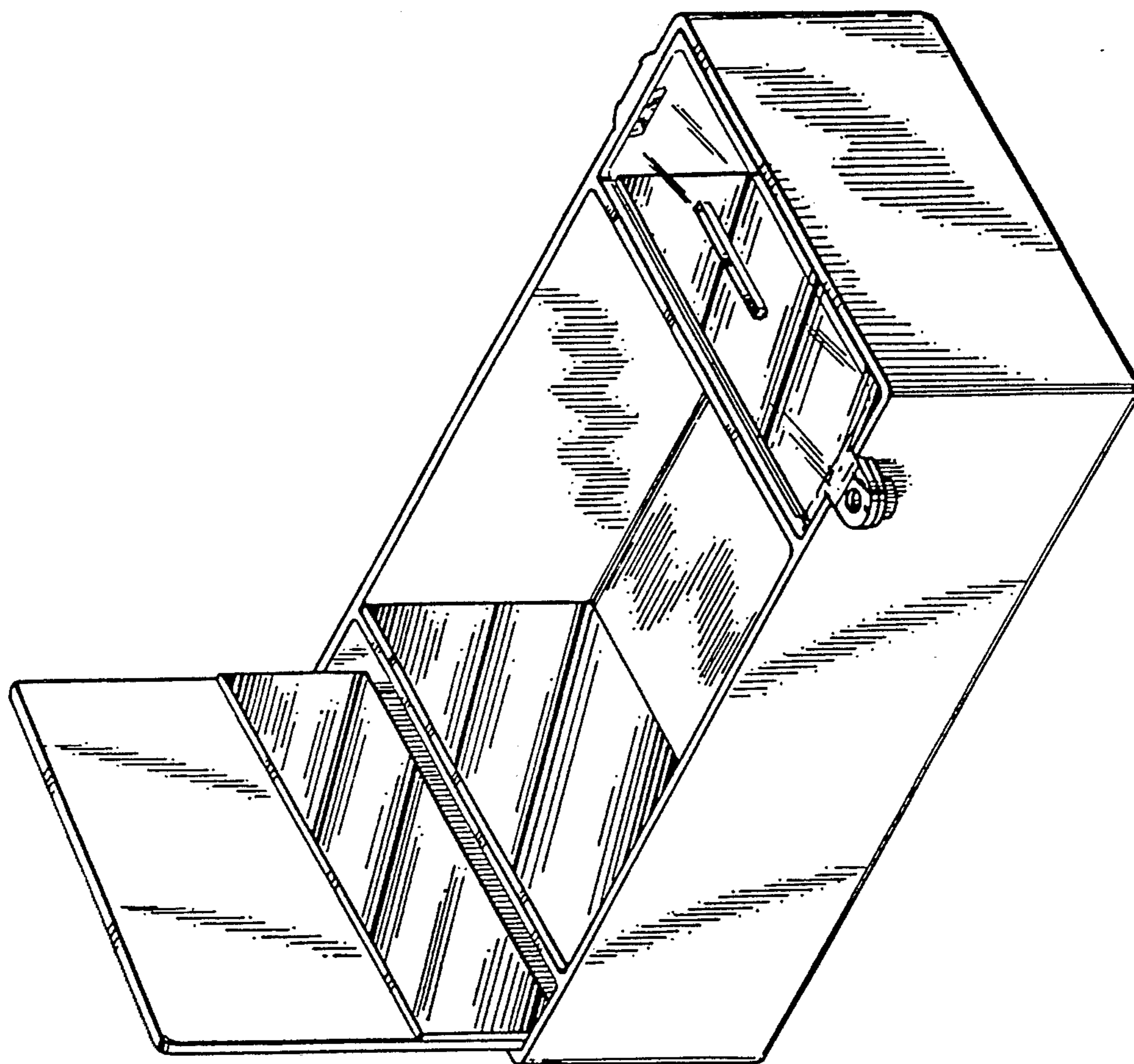

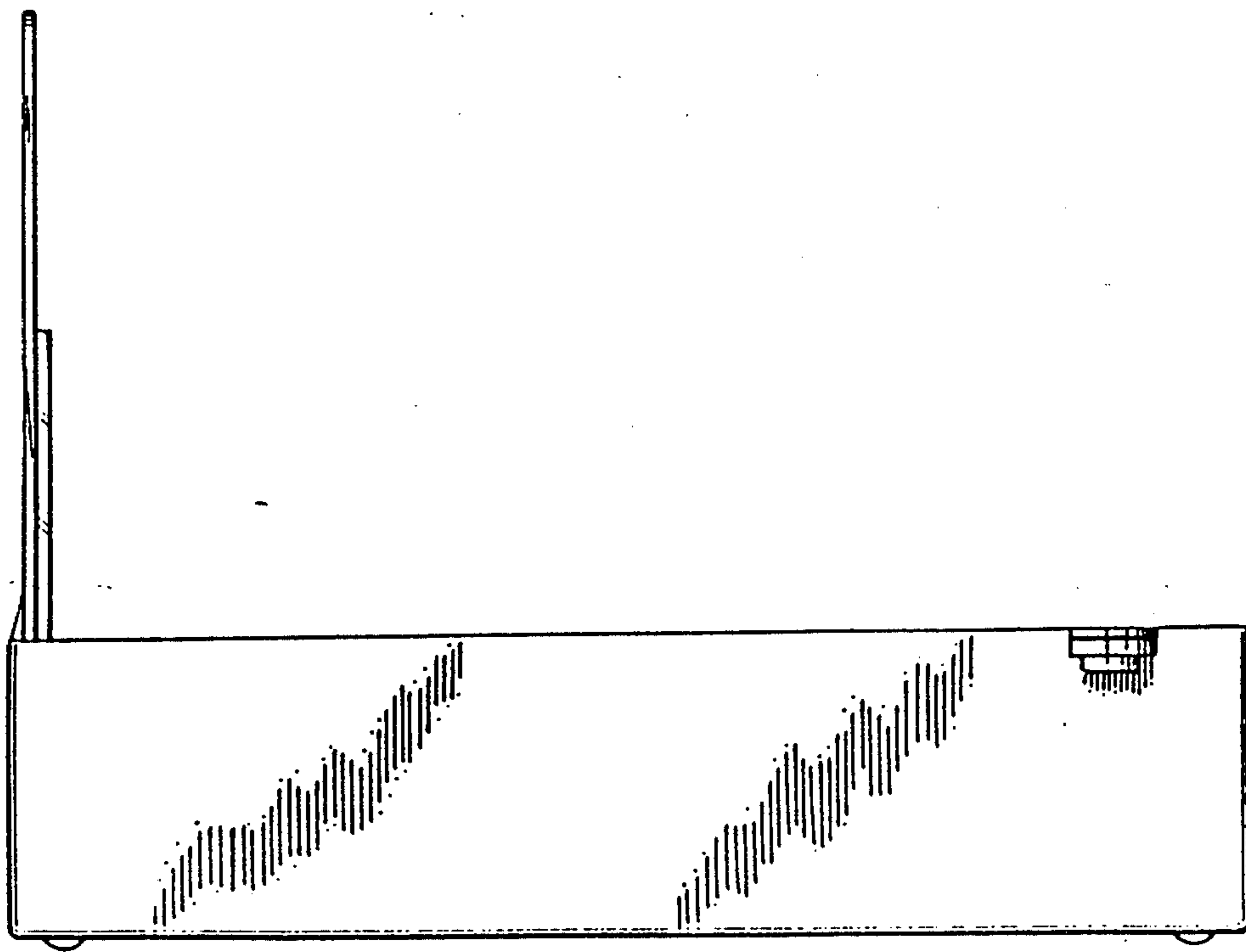
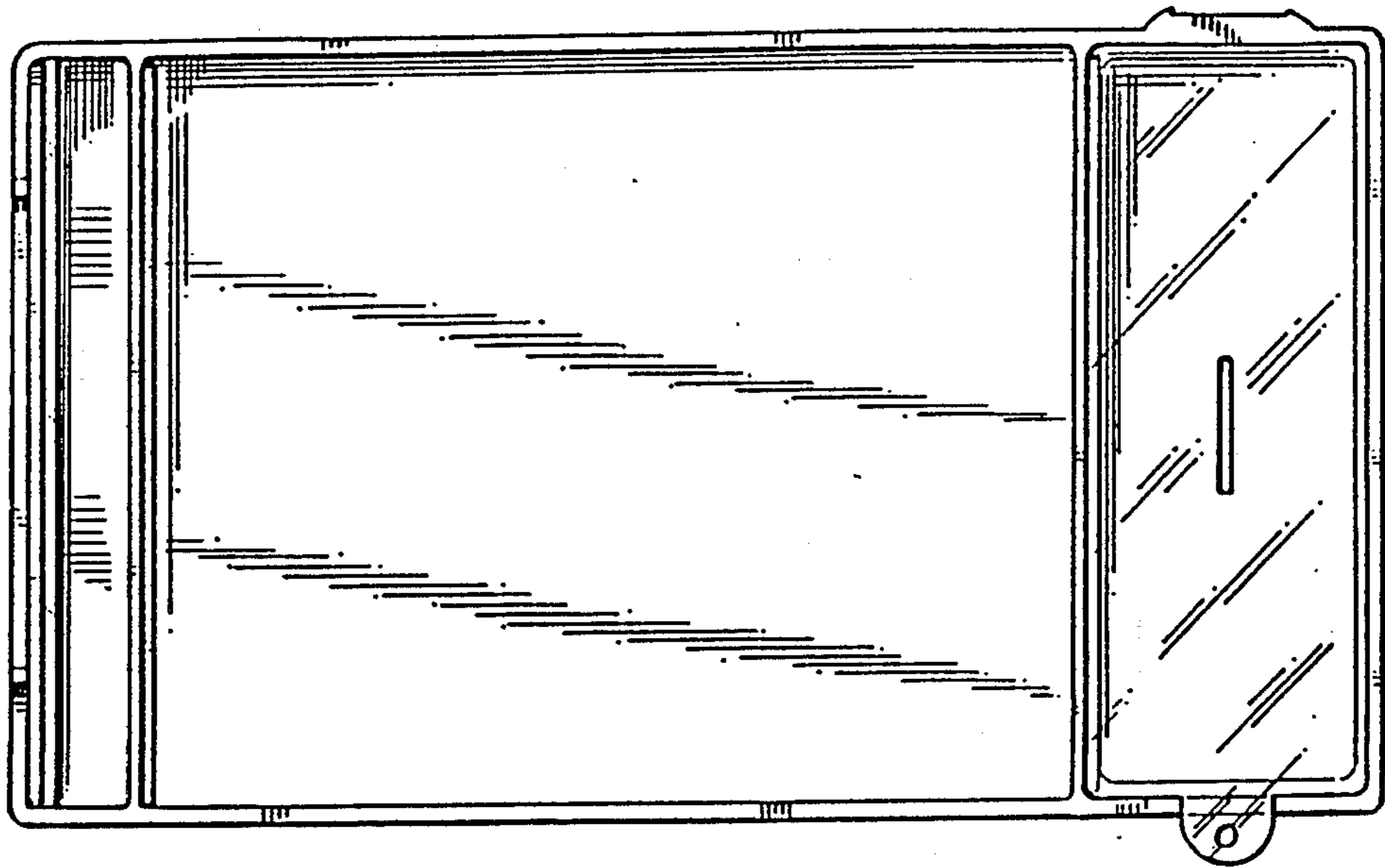

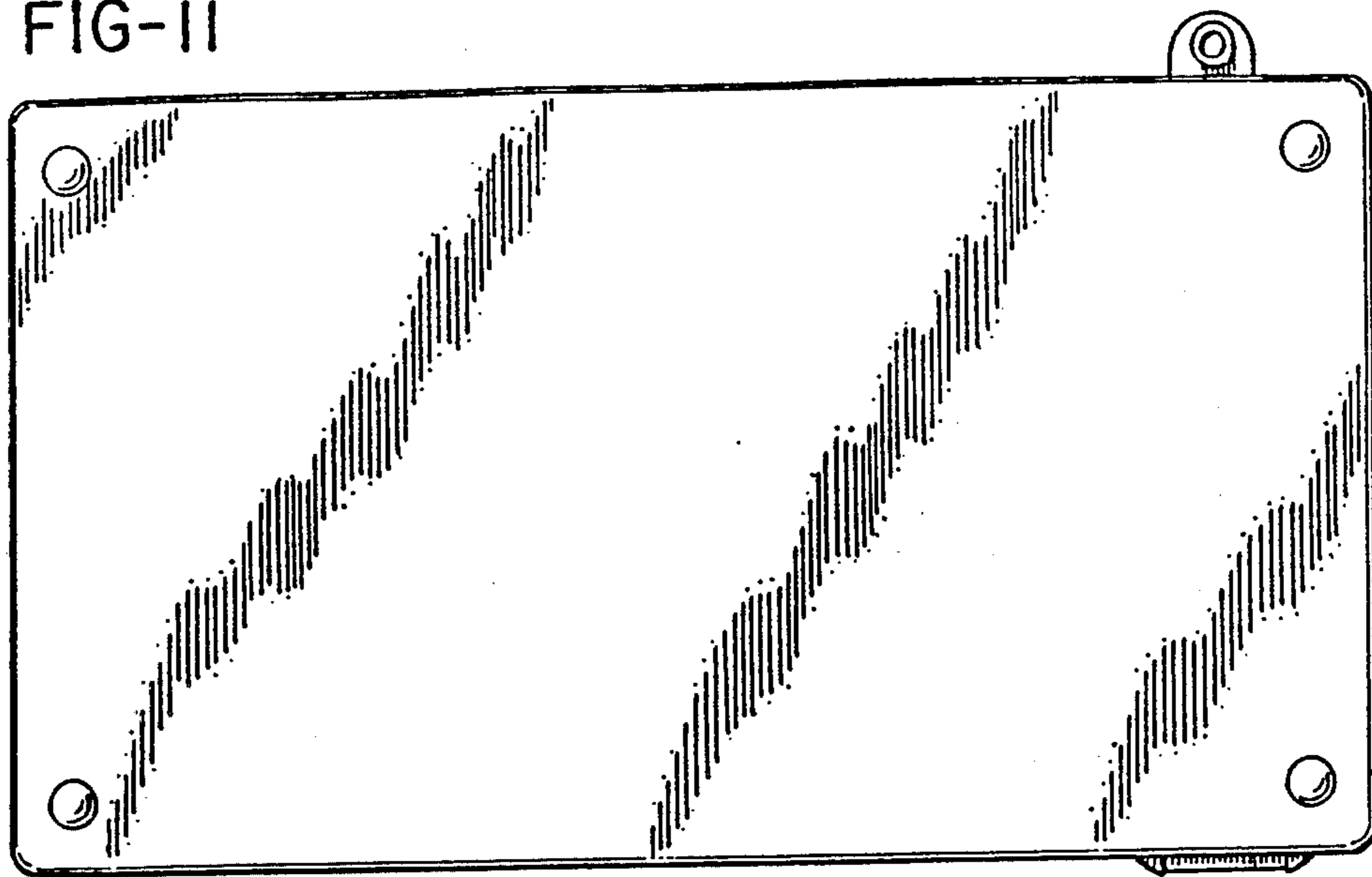

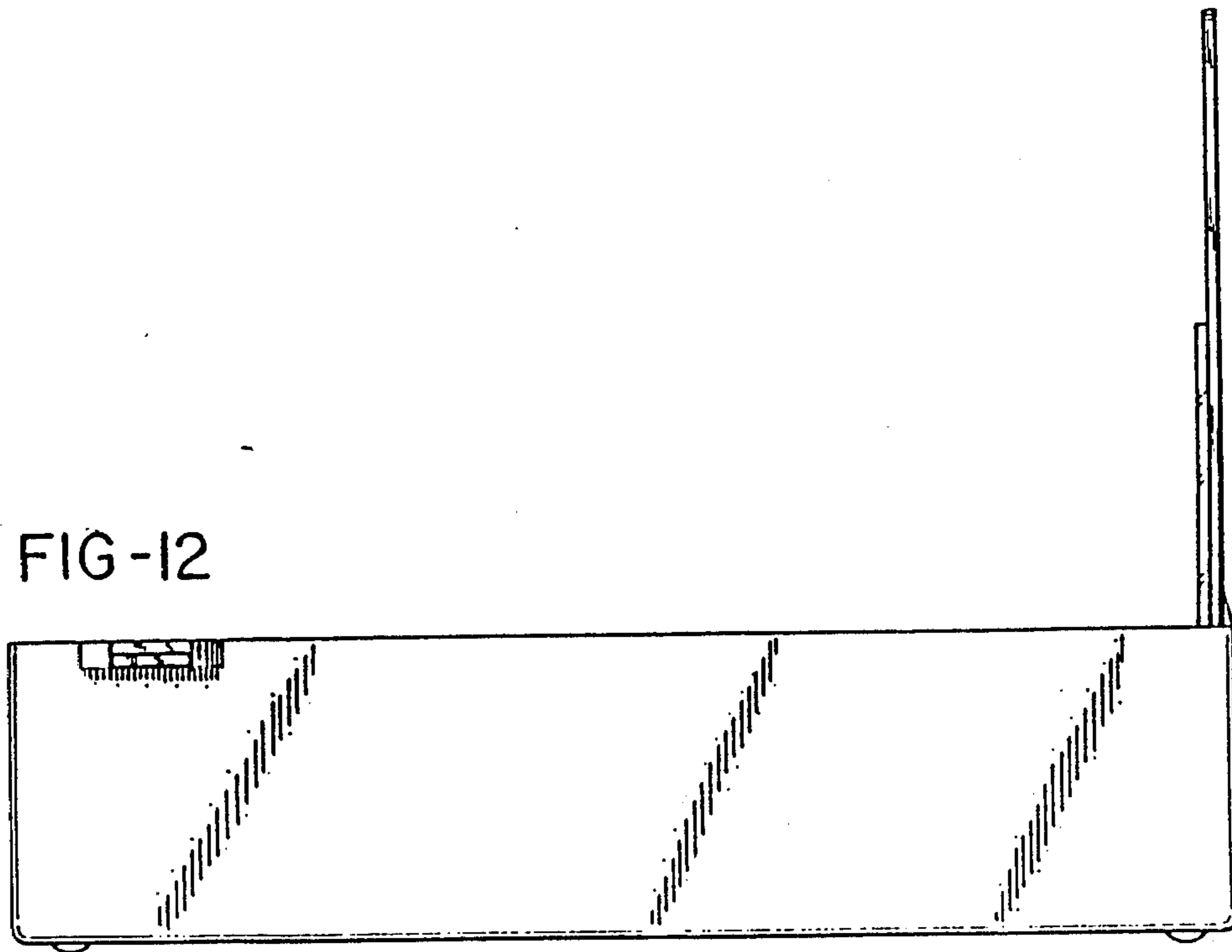

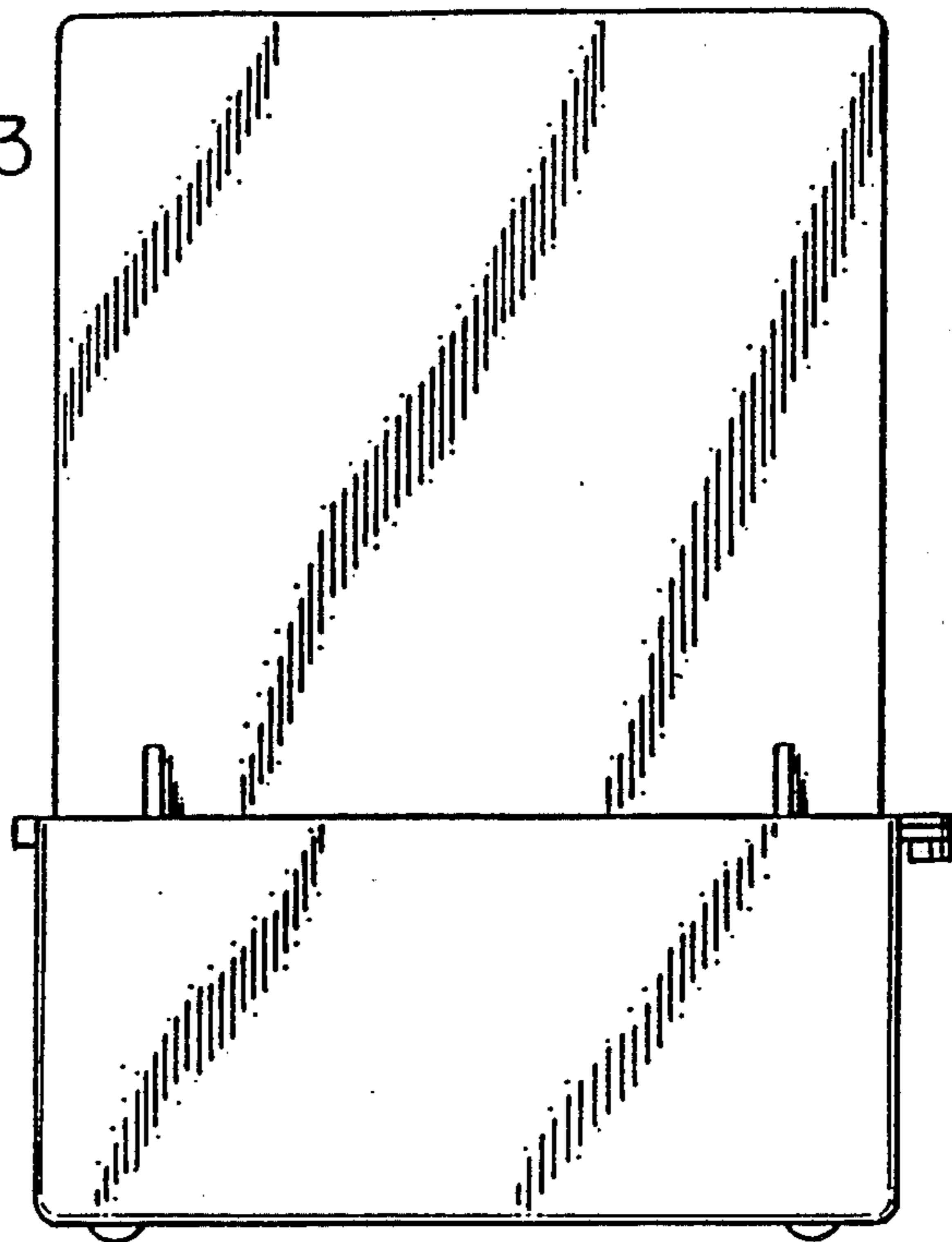
