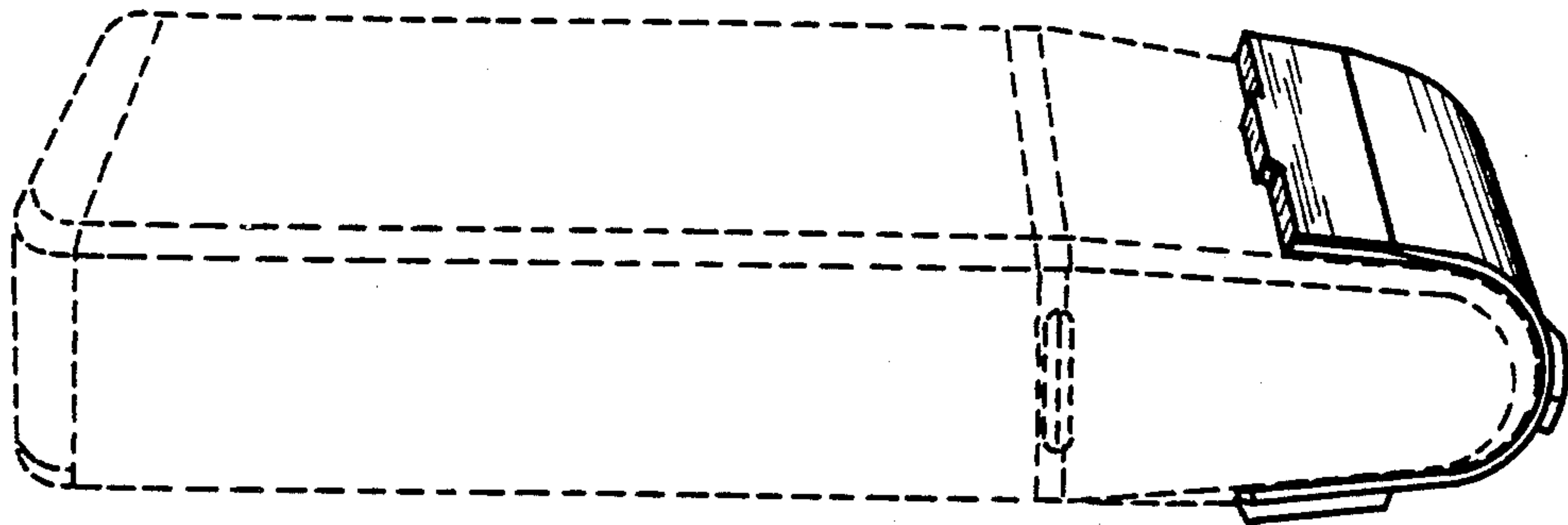

[57] CLAIM

The ornamental design of a cartridge and foil for a dry shaver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cartridge and foil for a dry shaver showing my new design in a position of use;
FIG. 2 is a bottom plan view of the cartridge and foil;
FIG. 3 is a front elevational view of the cartridge and foil;
FIG. 4 is a first side elevational view of the cartridge and foil;
FIG. 5 is a rear elevational view of the cartridge and foil;
FIG. 6 is a second side elevational view of the cartridge and foil; and
FIG. 7 is a top plan view of the cartridge and foil.
The broken-line showing of shaver and shaver head in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.



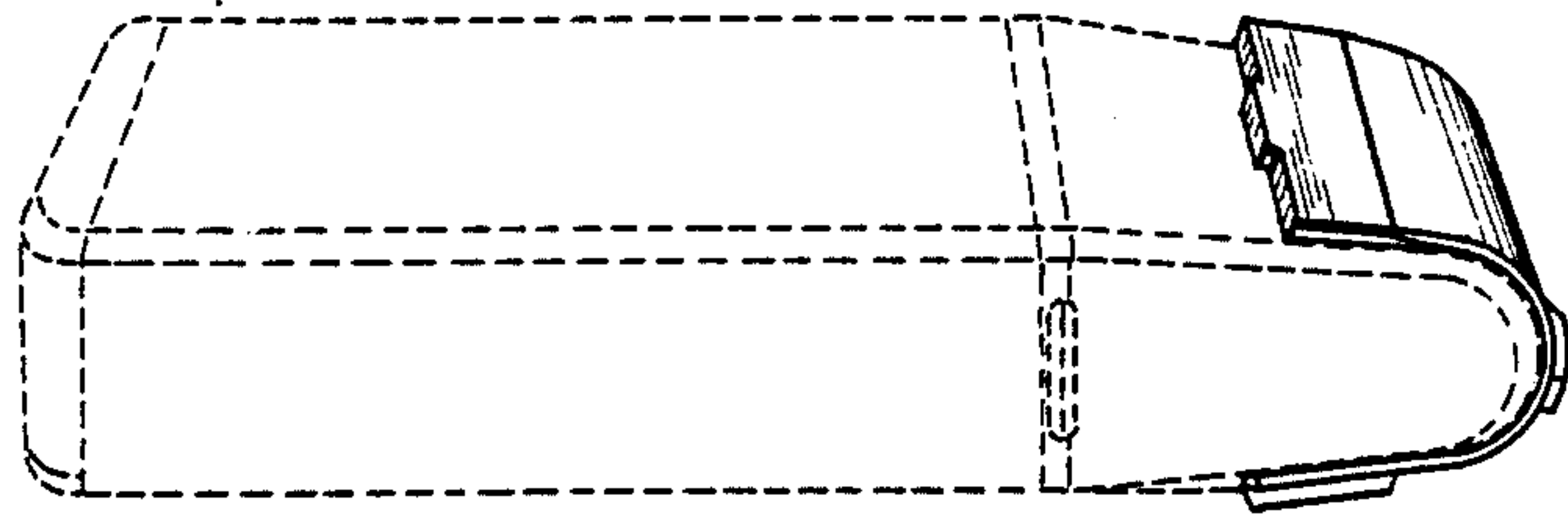

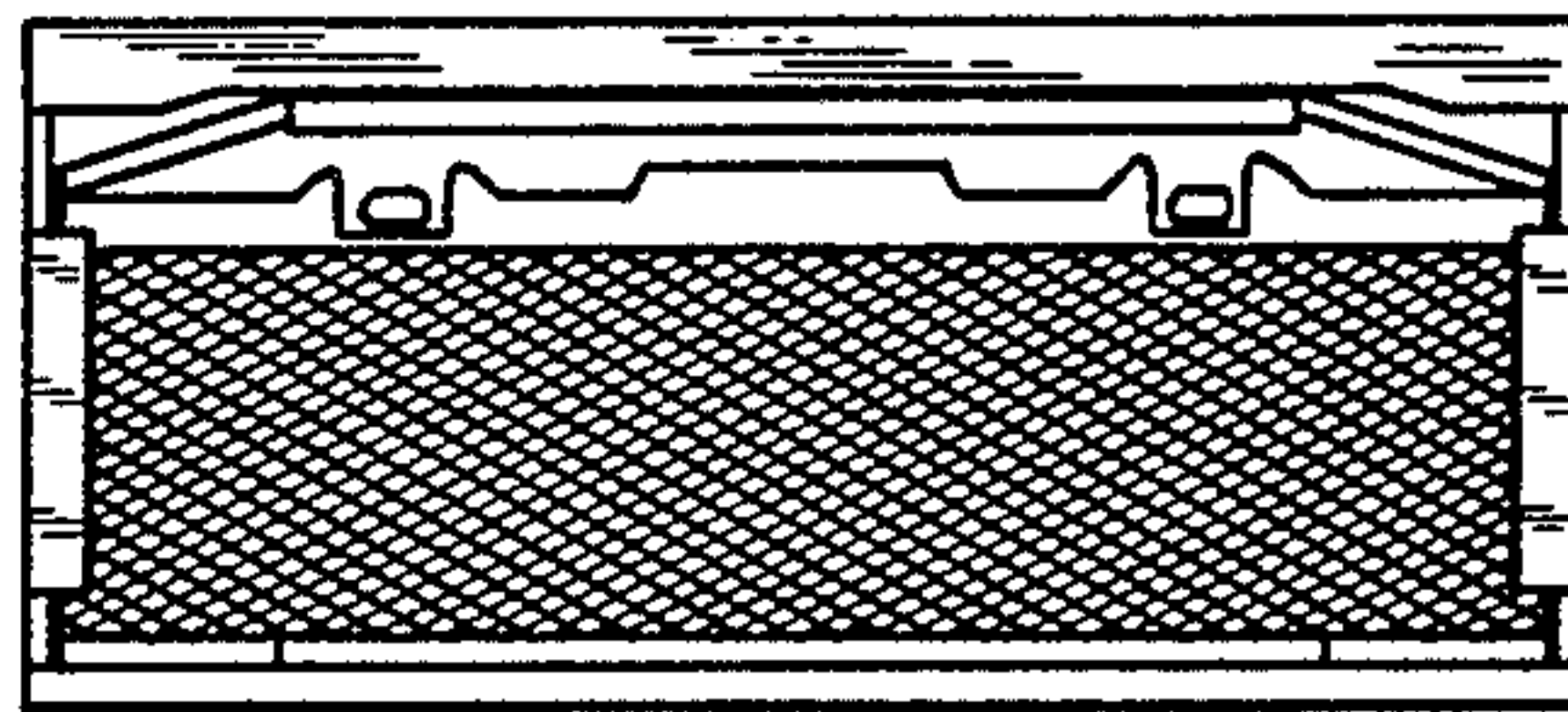

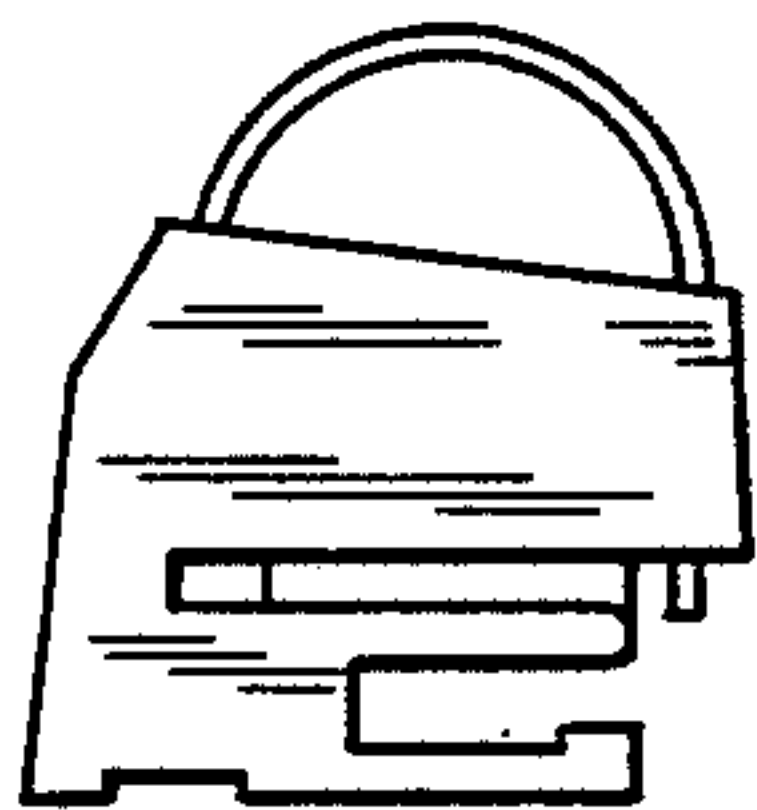

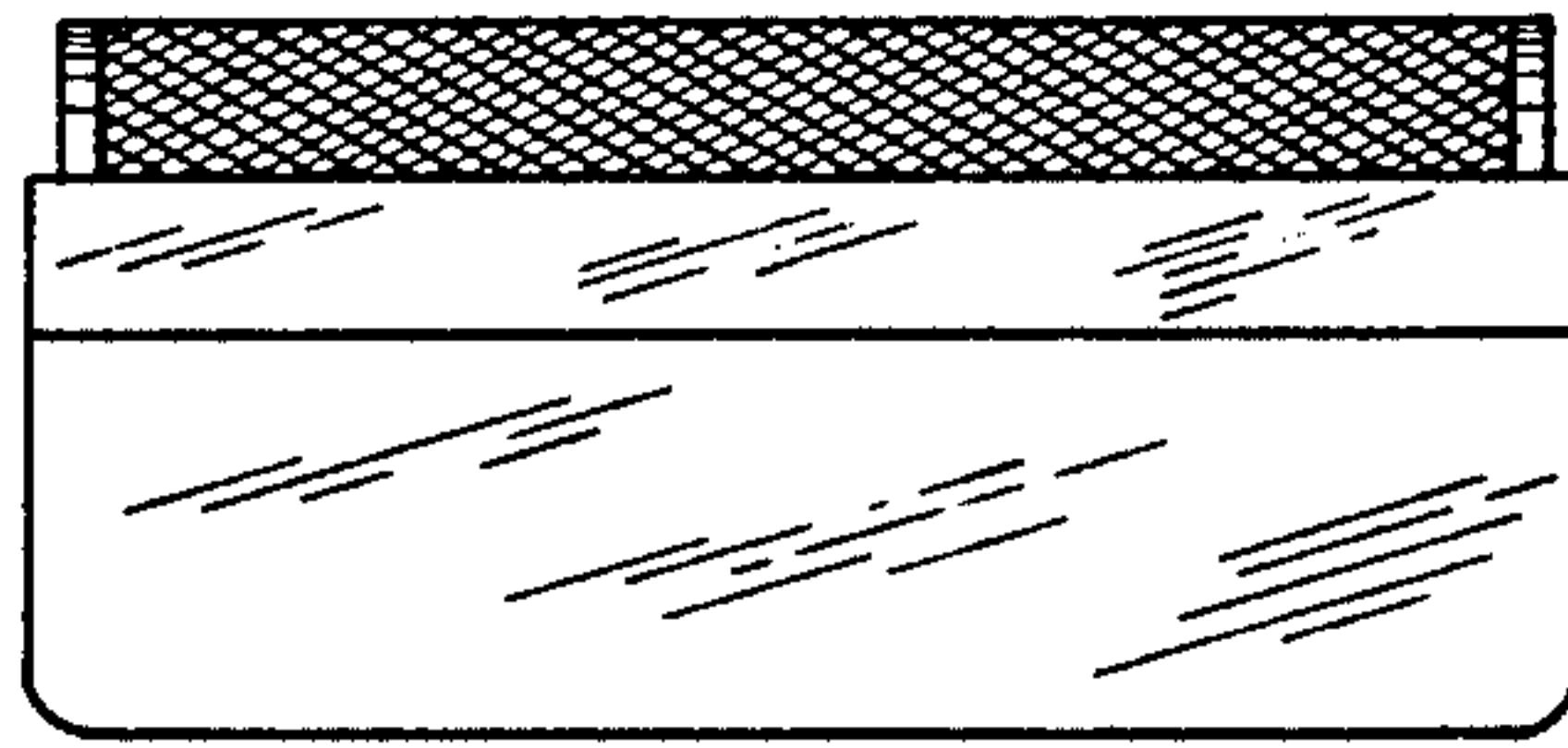

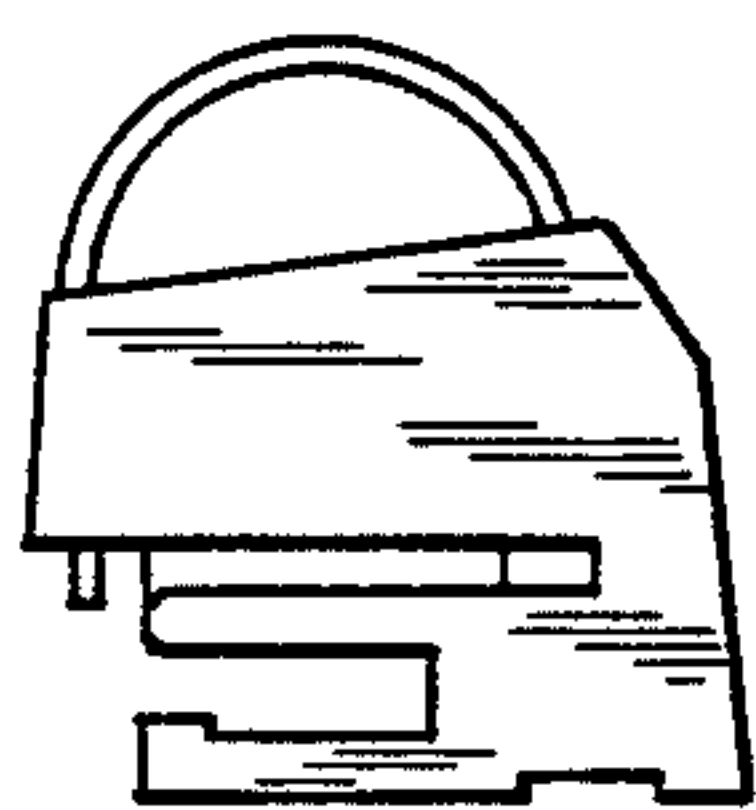

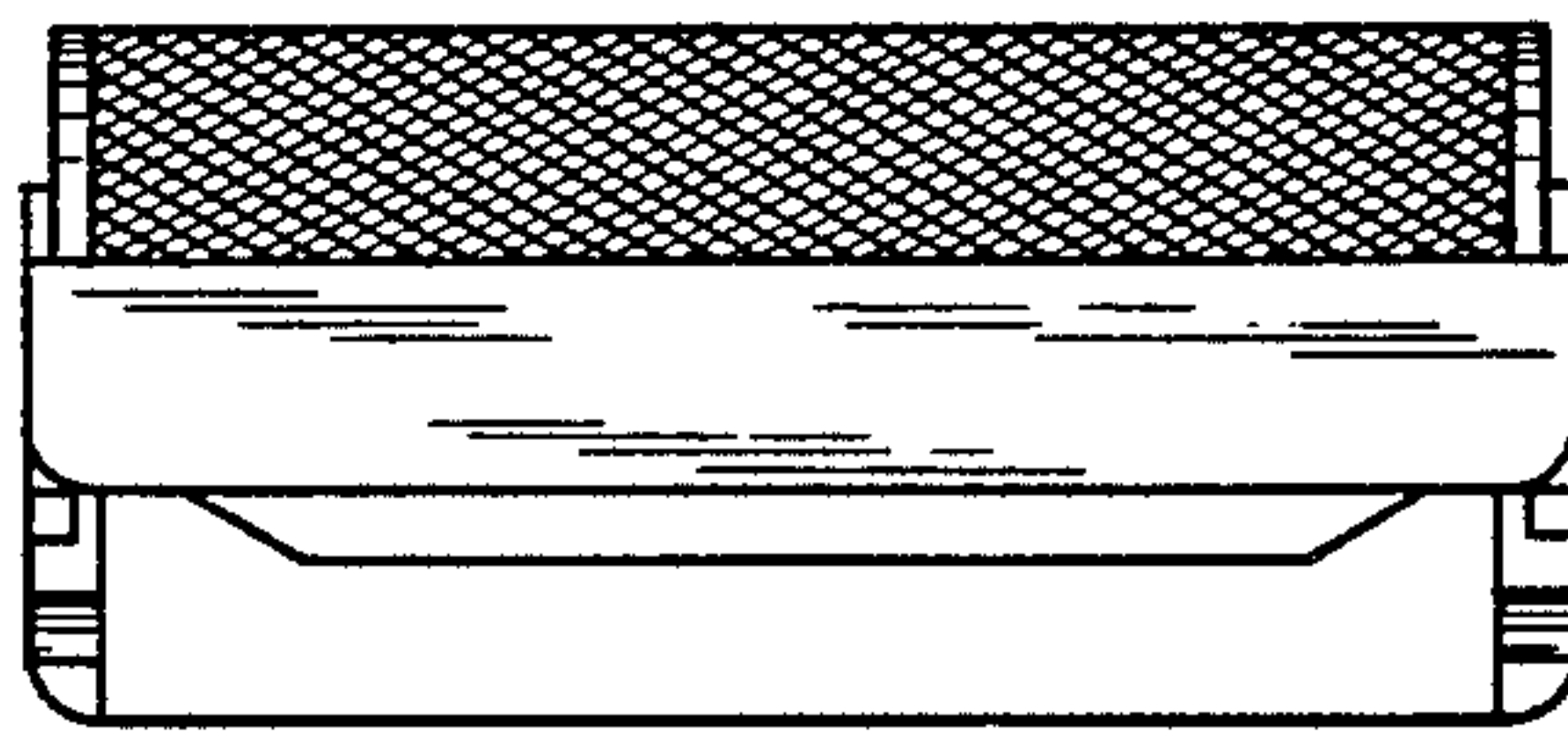

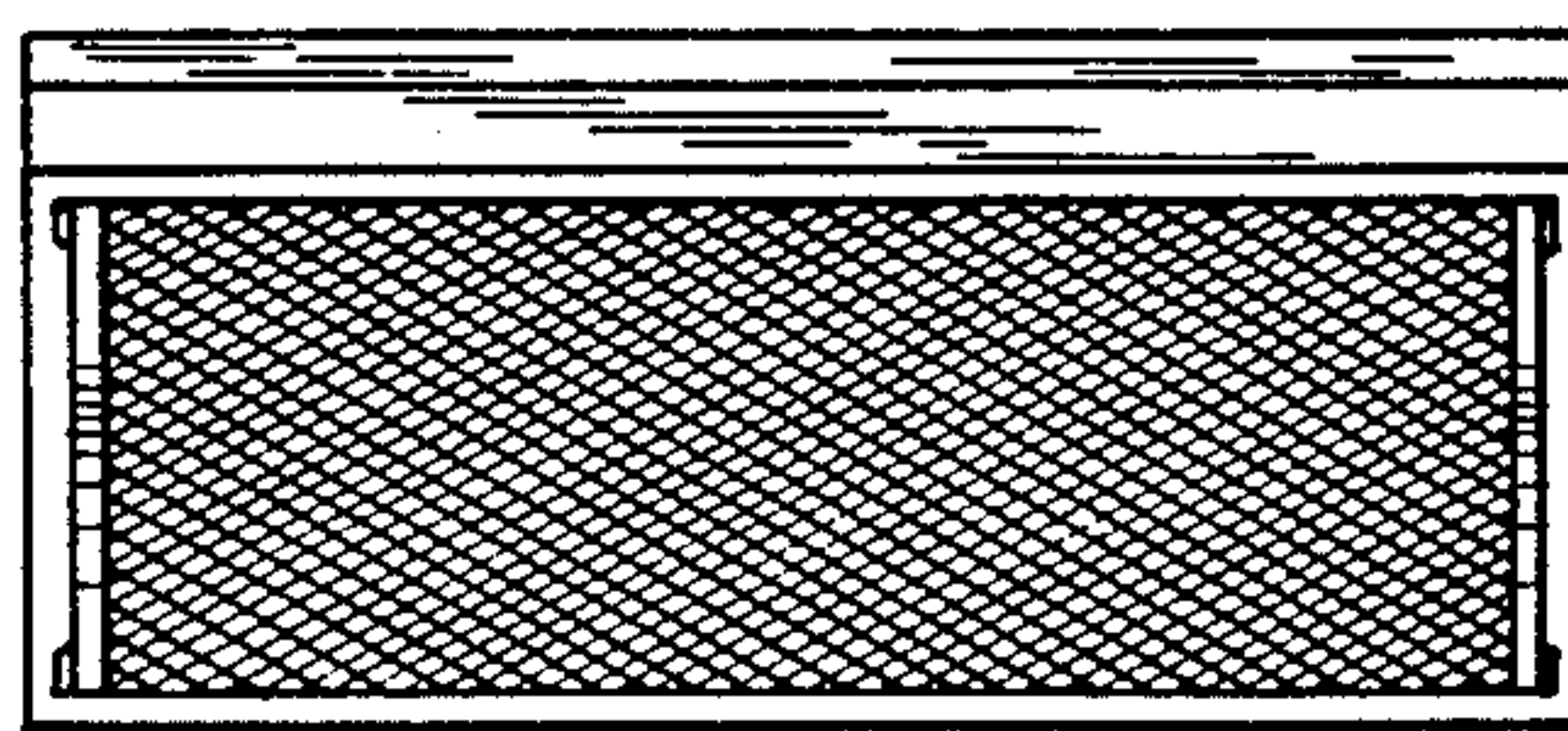
