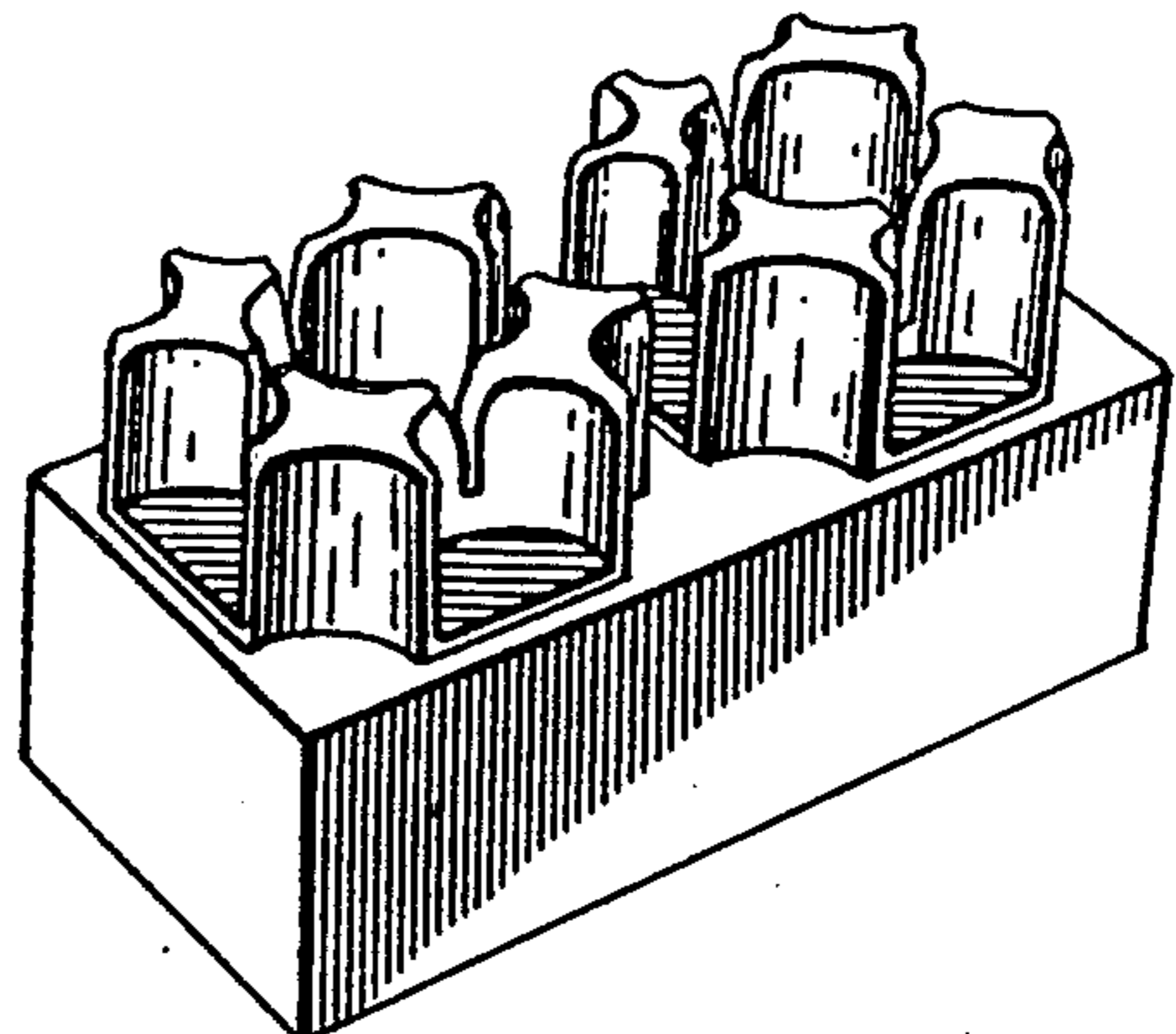
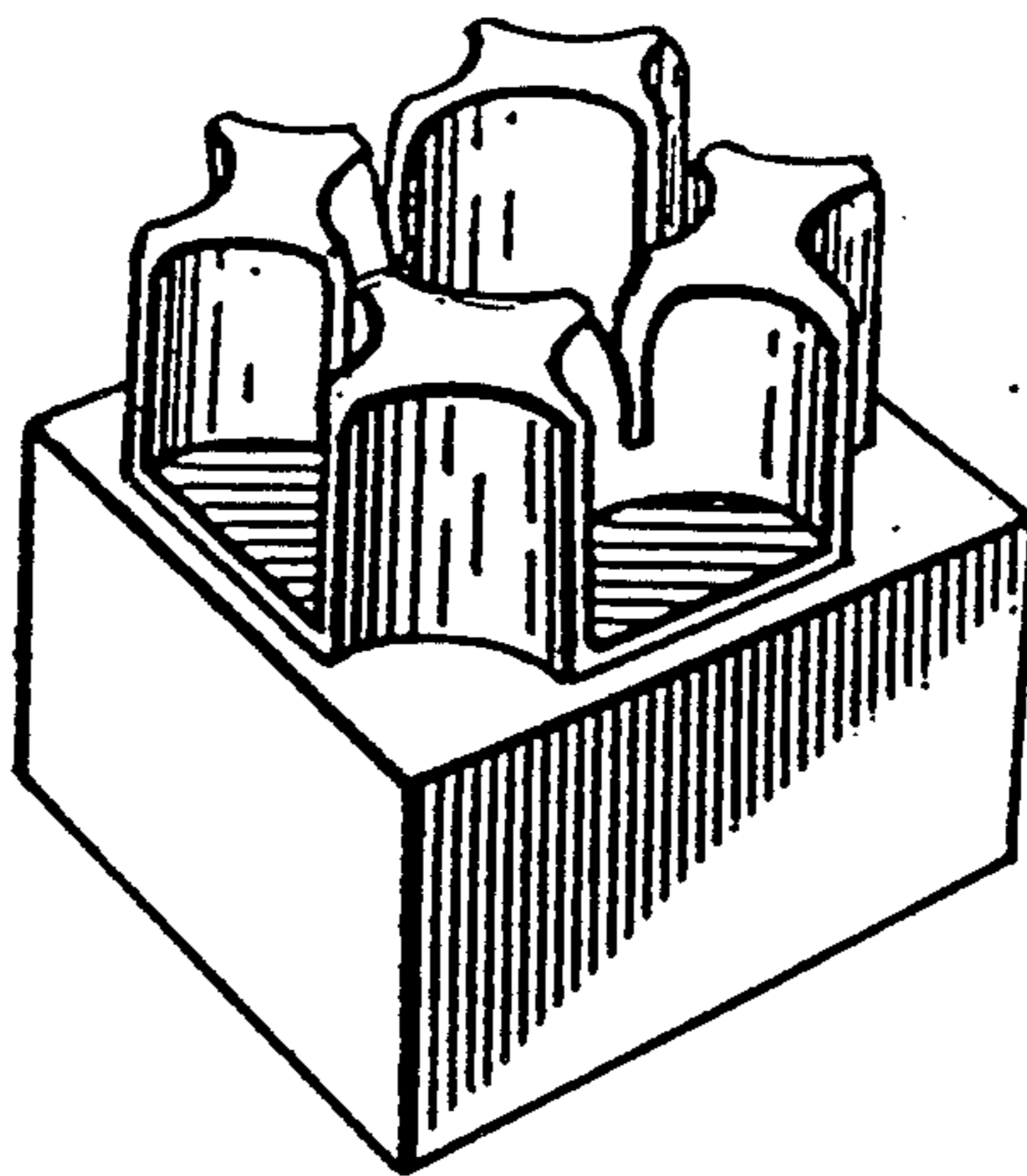
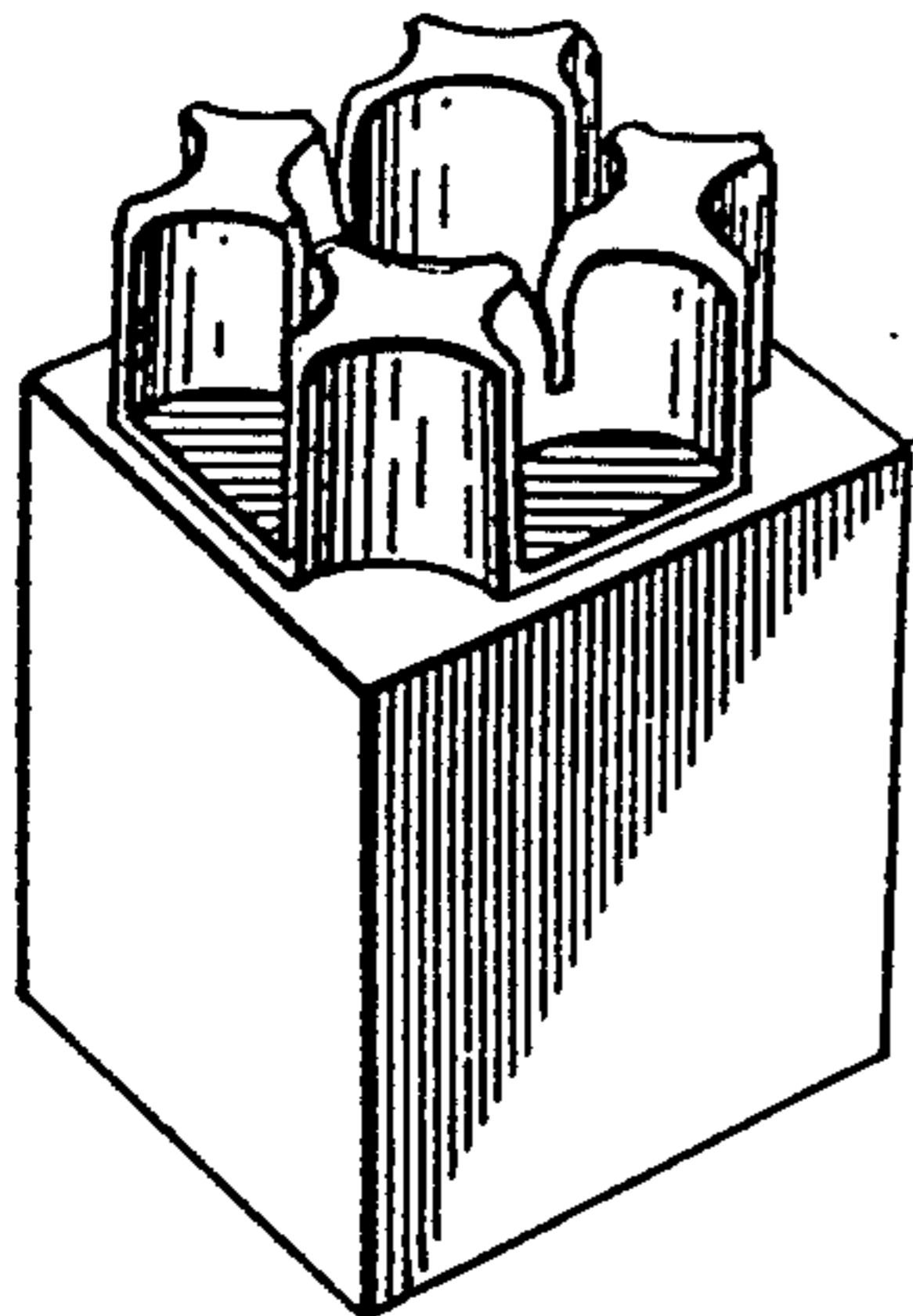

 The ornamental design for a construction toy block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a construction toy block showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a side elevational view thereof; all sides being identical;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a perspective view of a modified embodiment of the design shown in FIGS. 1 through 4;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a side elevational view thereof; all sides being identical;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is a perspective view of a second embodiment of the design shown in FIGS. 1 through 4;
 FIG. 10 is a top plan view thereof;
 FIG. 11 is a side elevational view thereof; the side opposite being identical;
 FIG. 12 is a front elevational view thereof; the side opposite being identical;
 FIG. 13 is a bottom plan view thereof;

 FIG. 18 is a bottom plan view thereof.



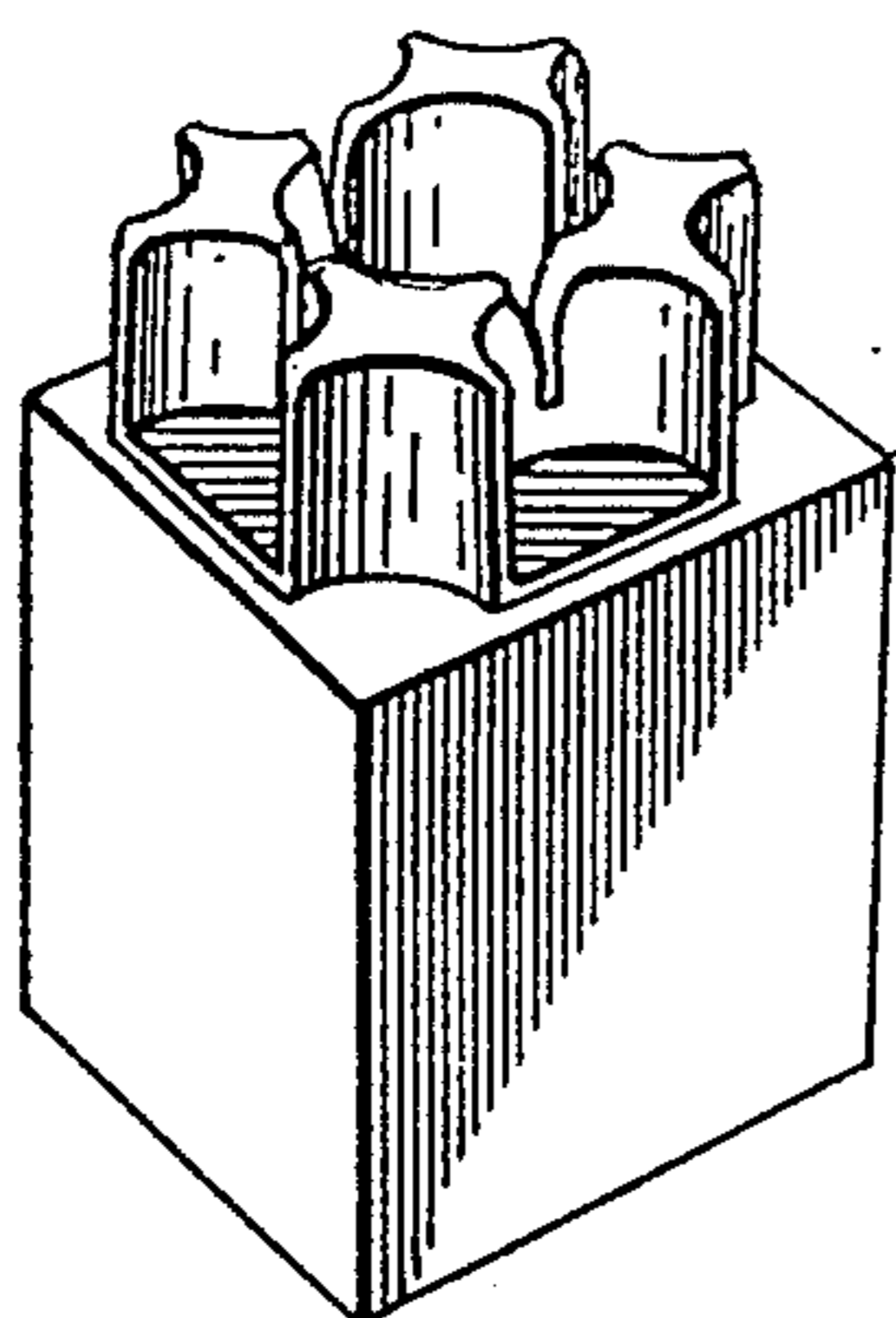

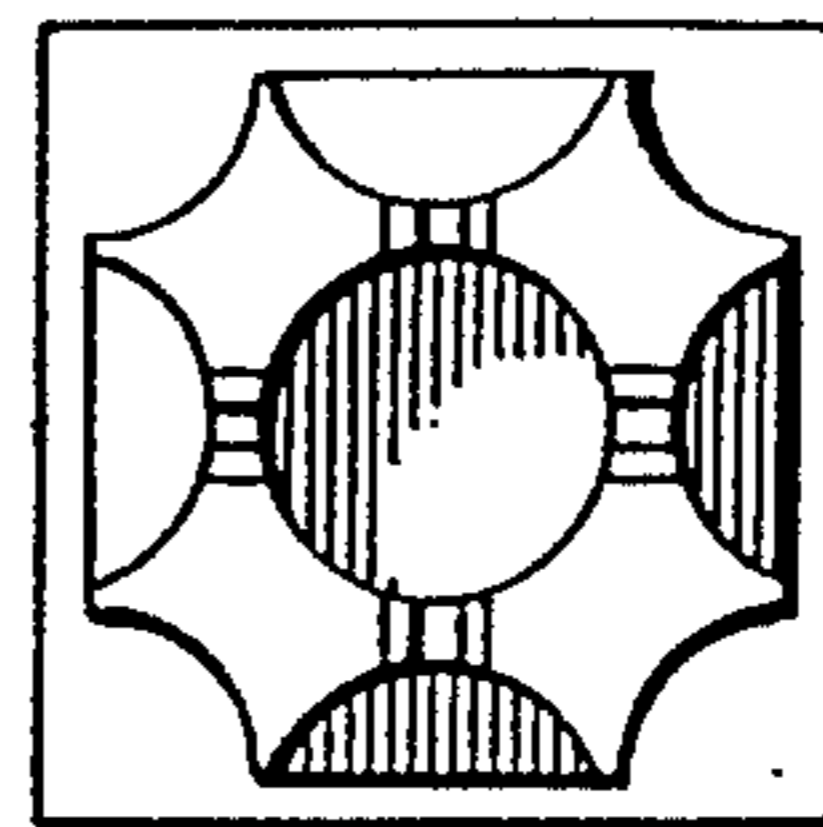

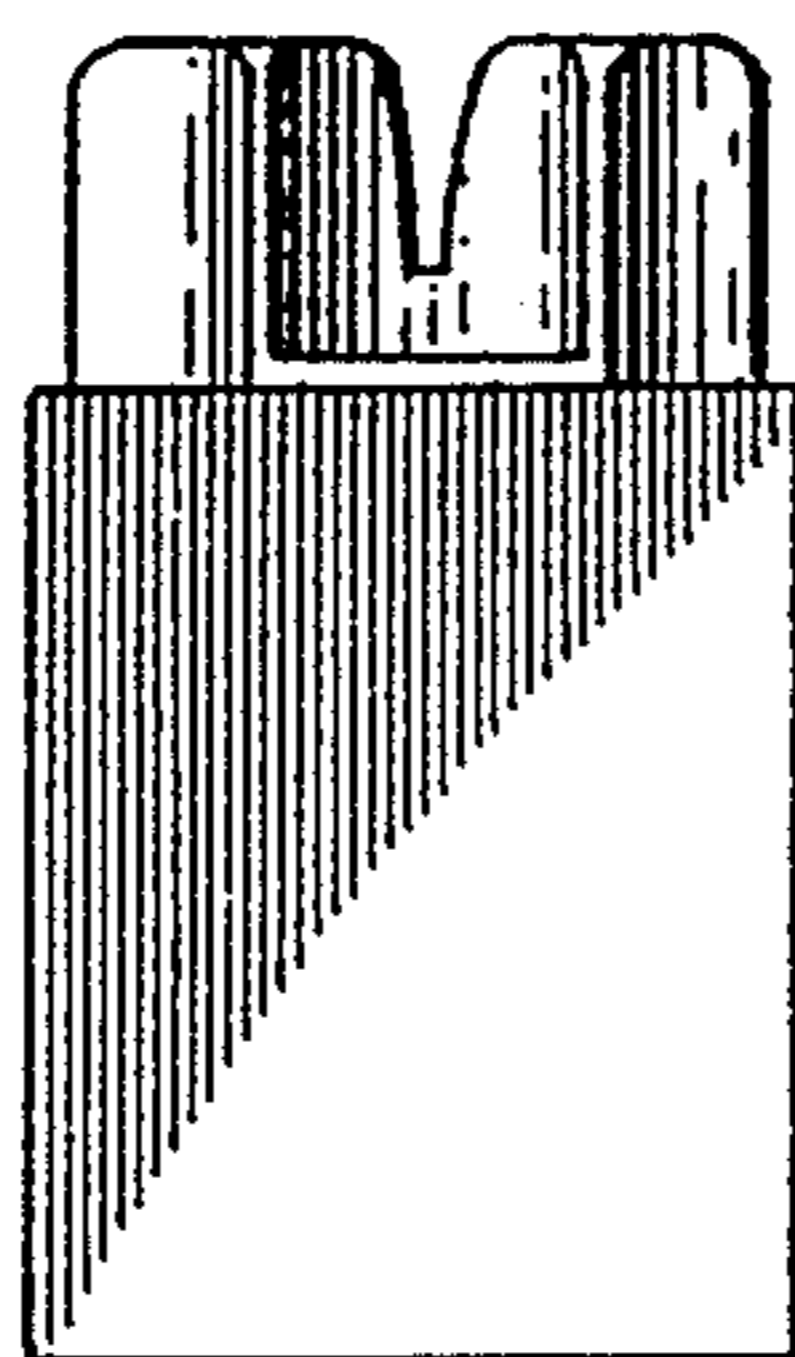

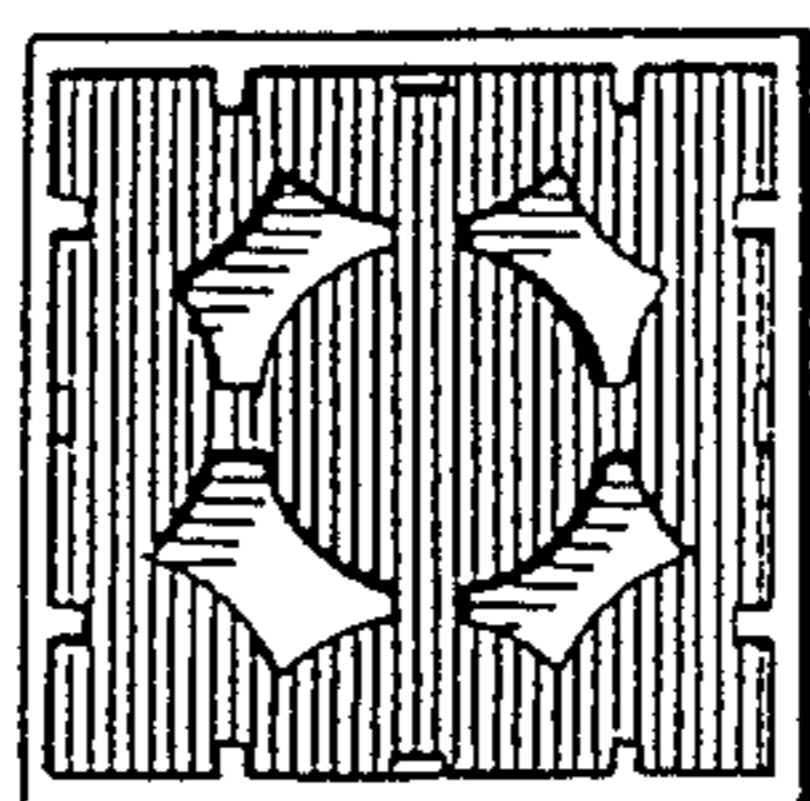

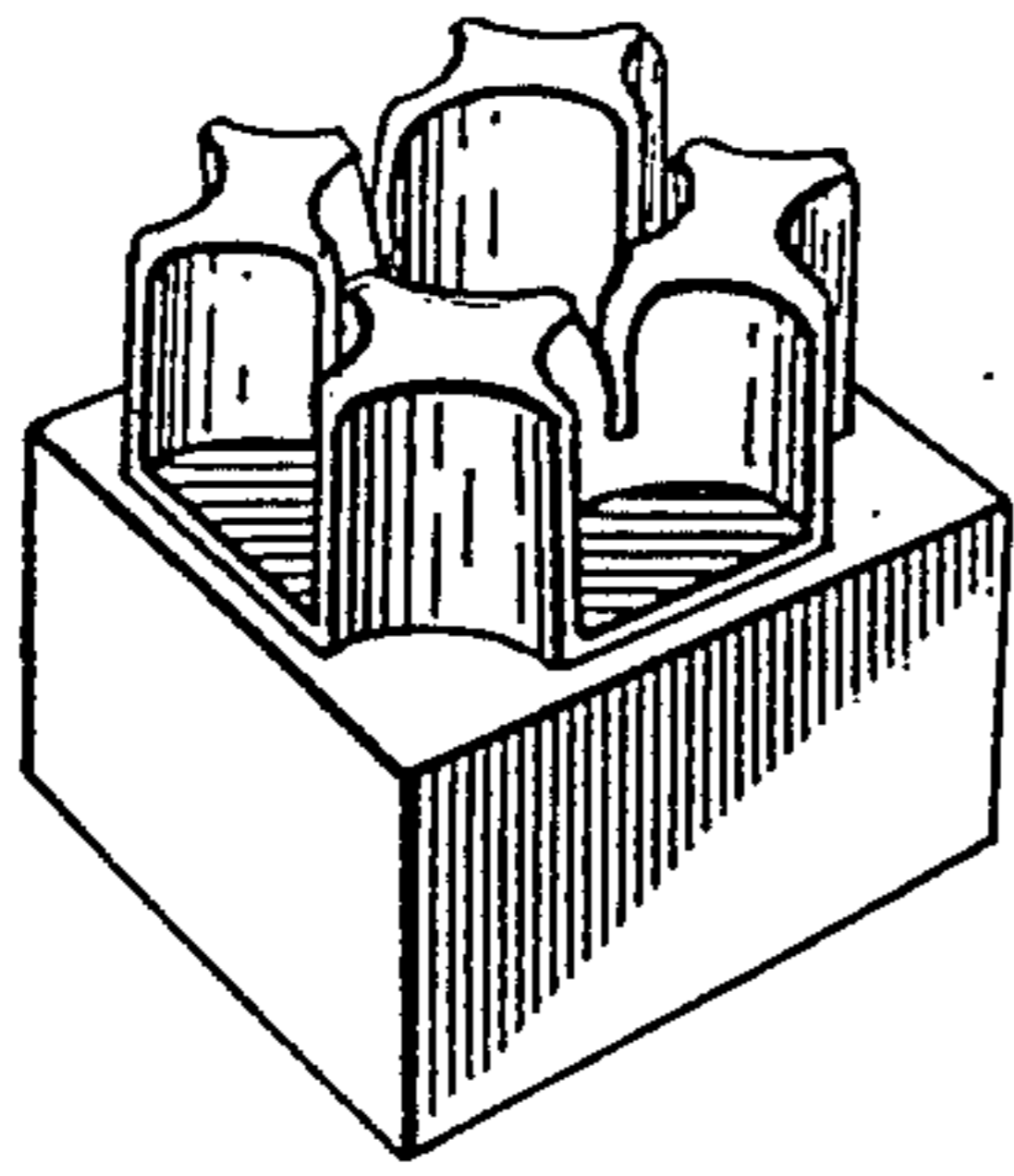

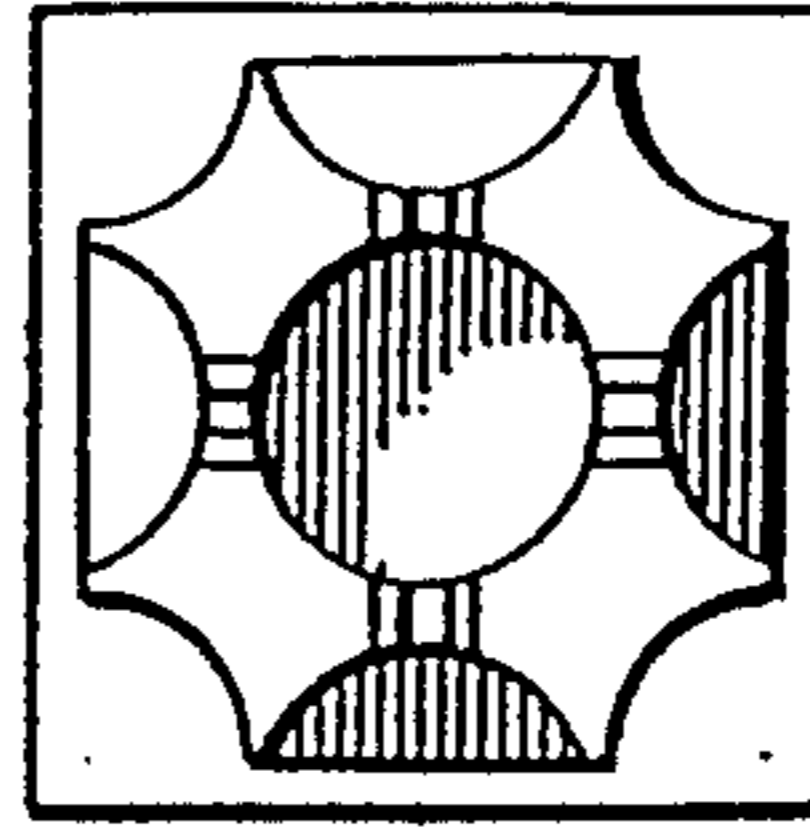

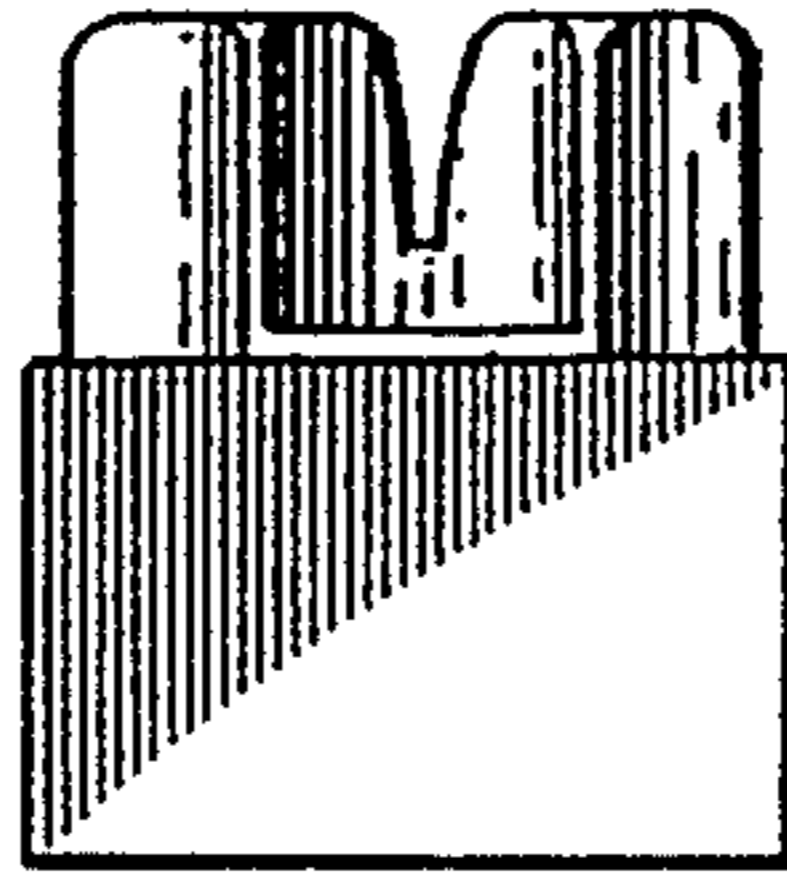

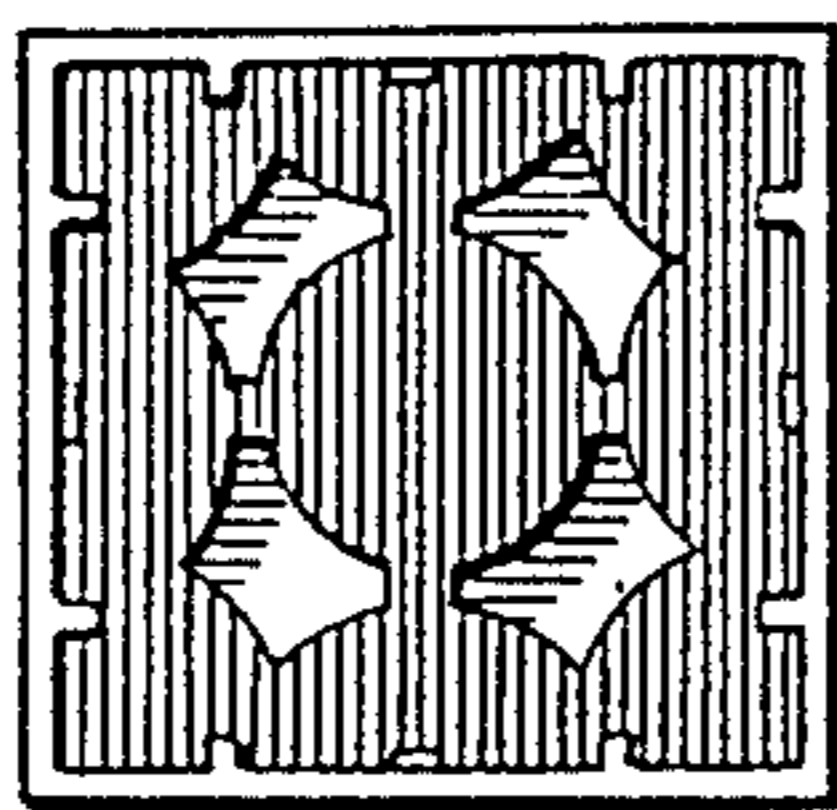

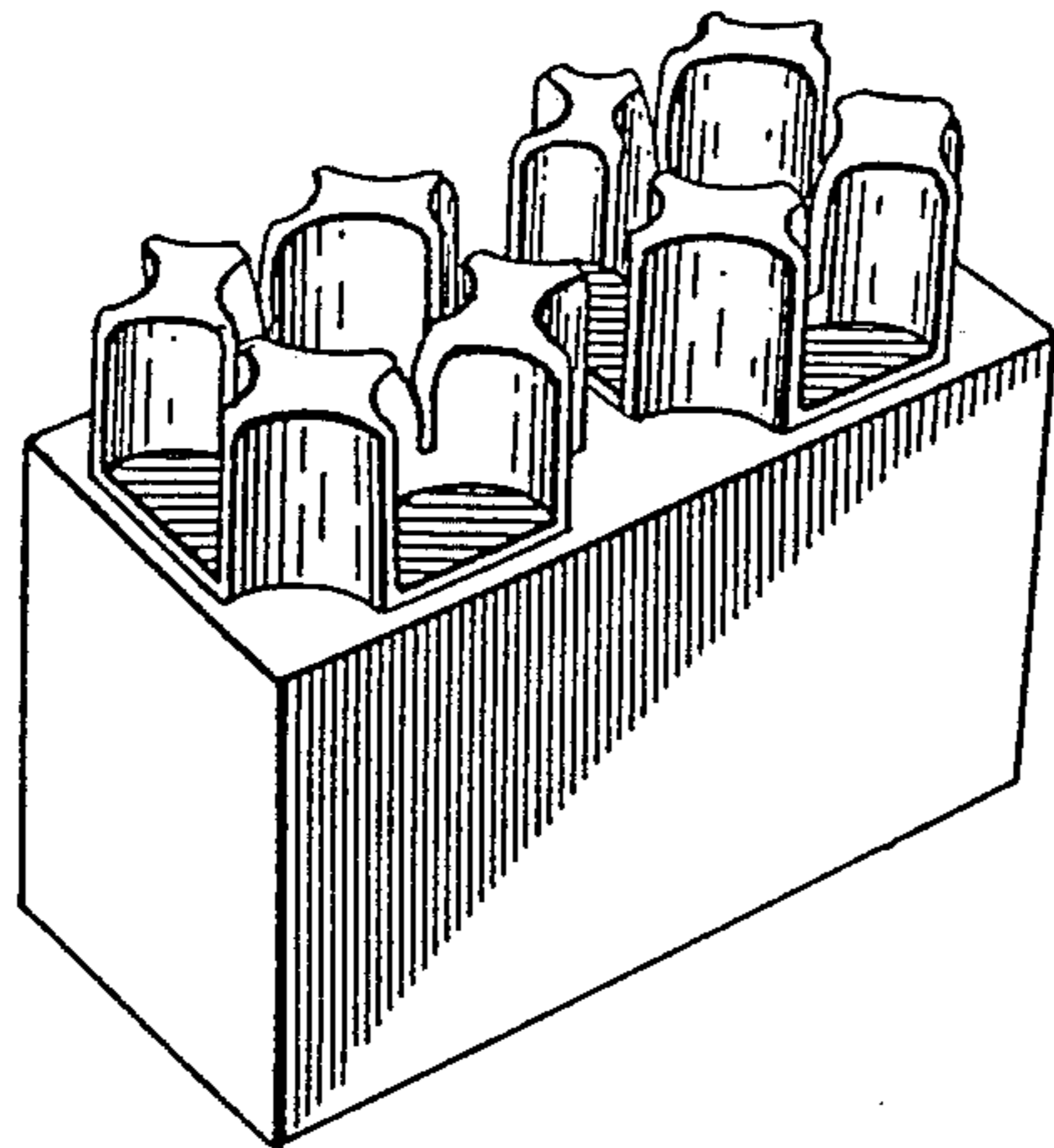

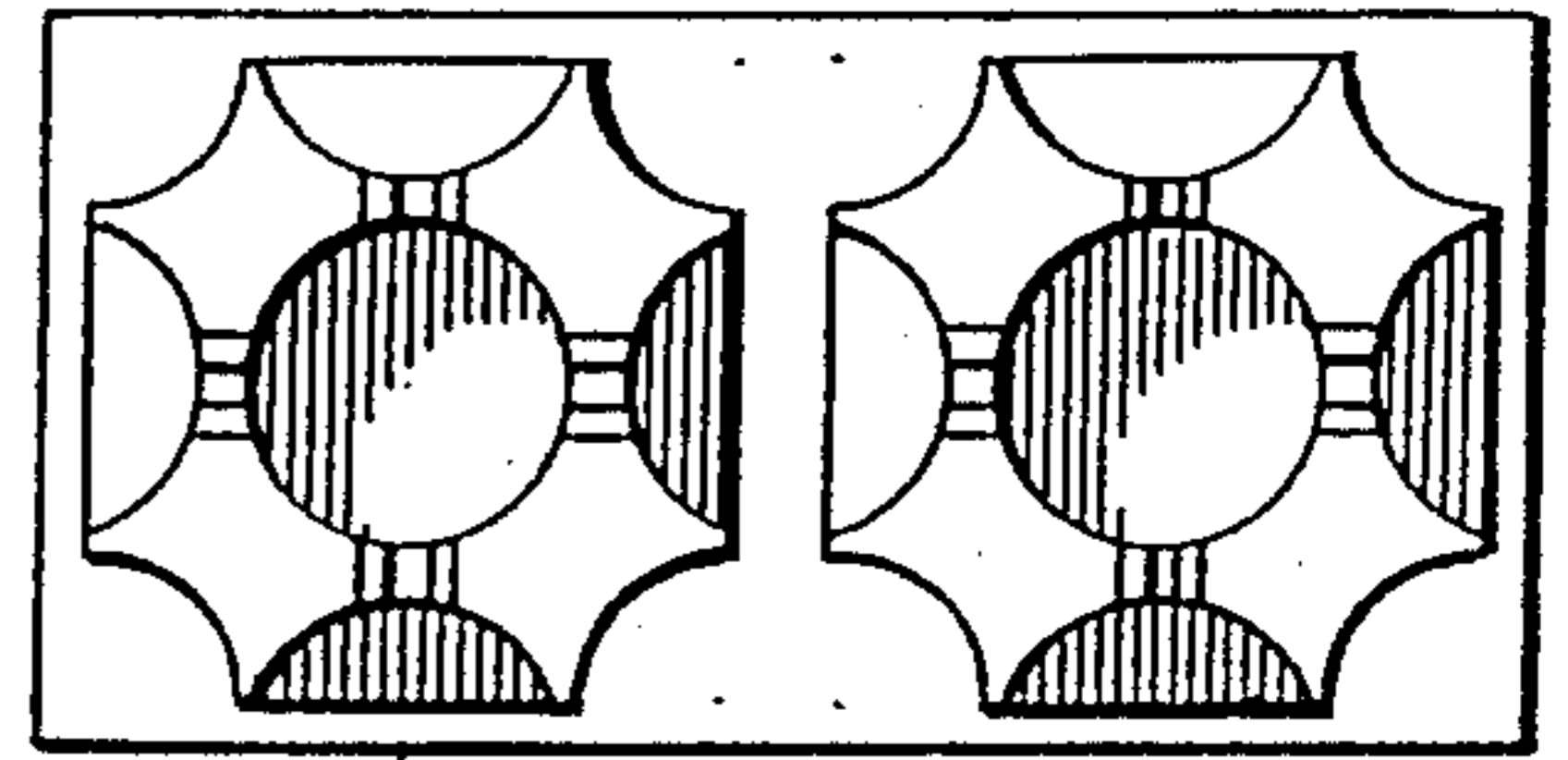

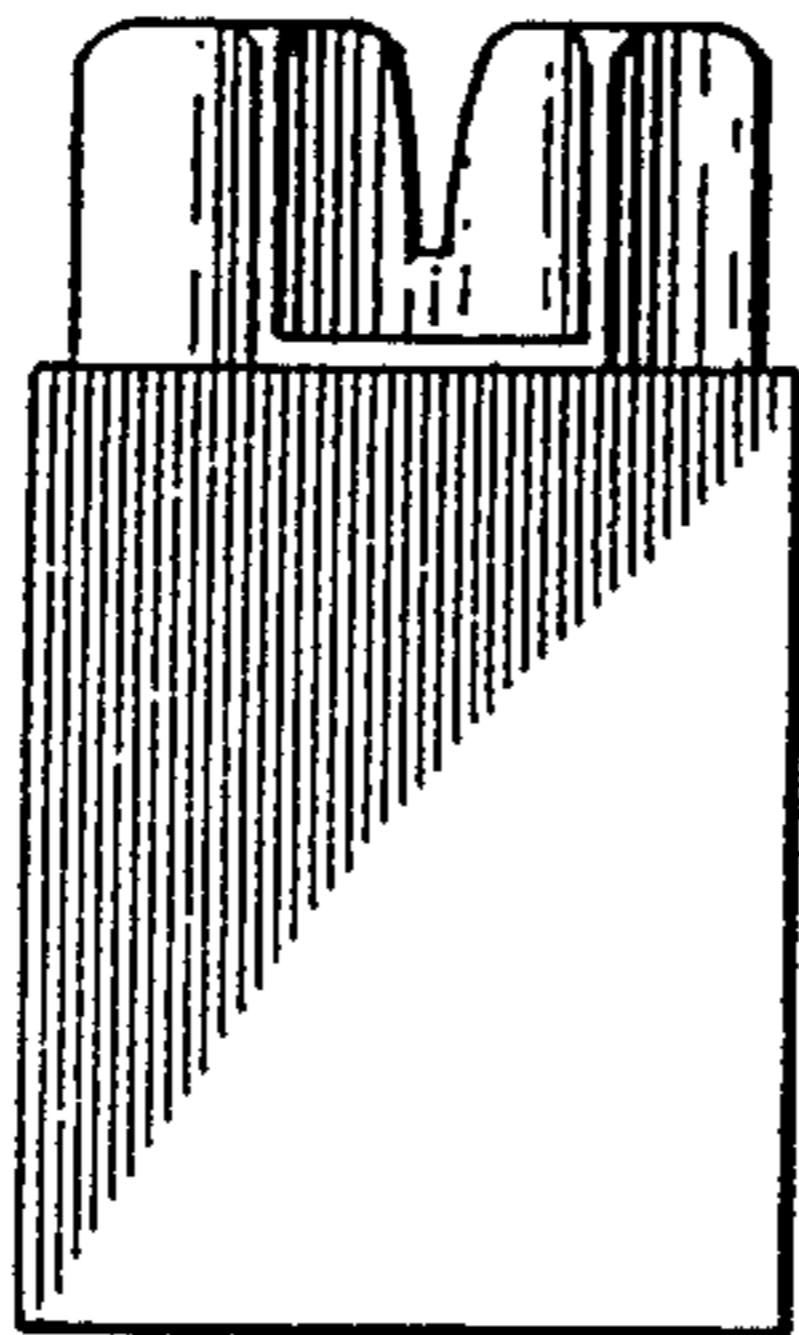

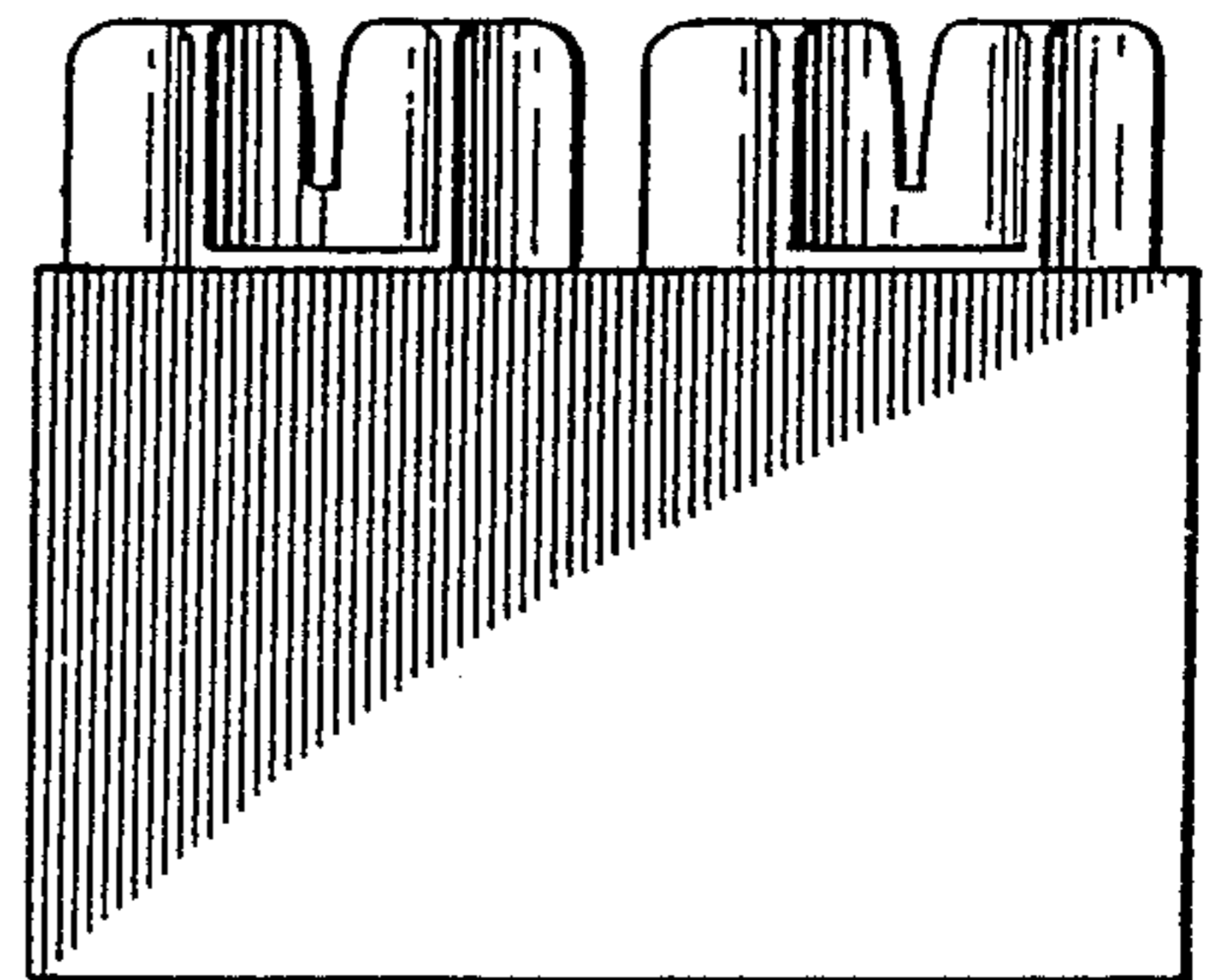

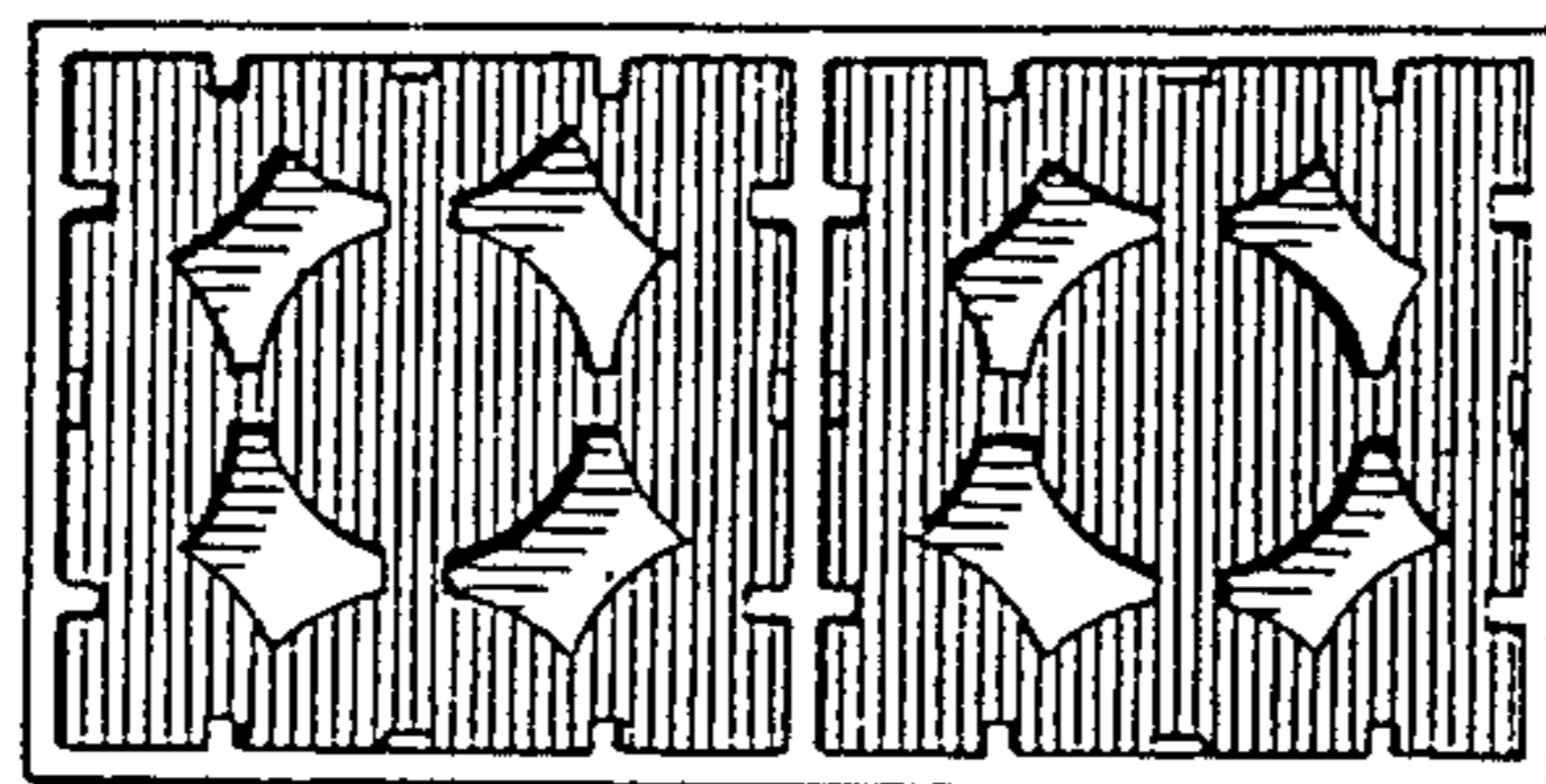

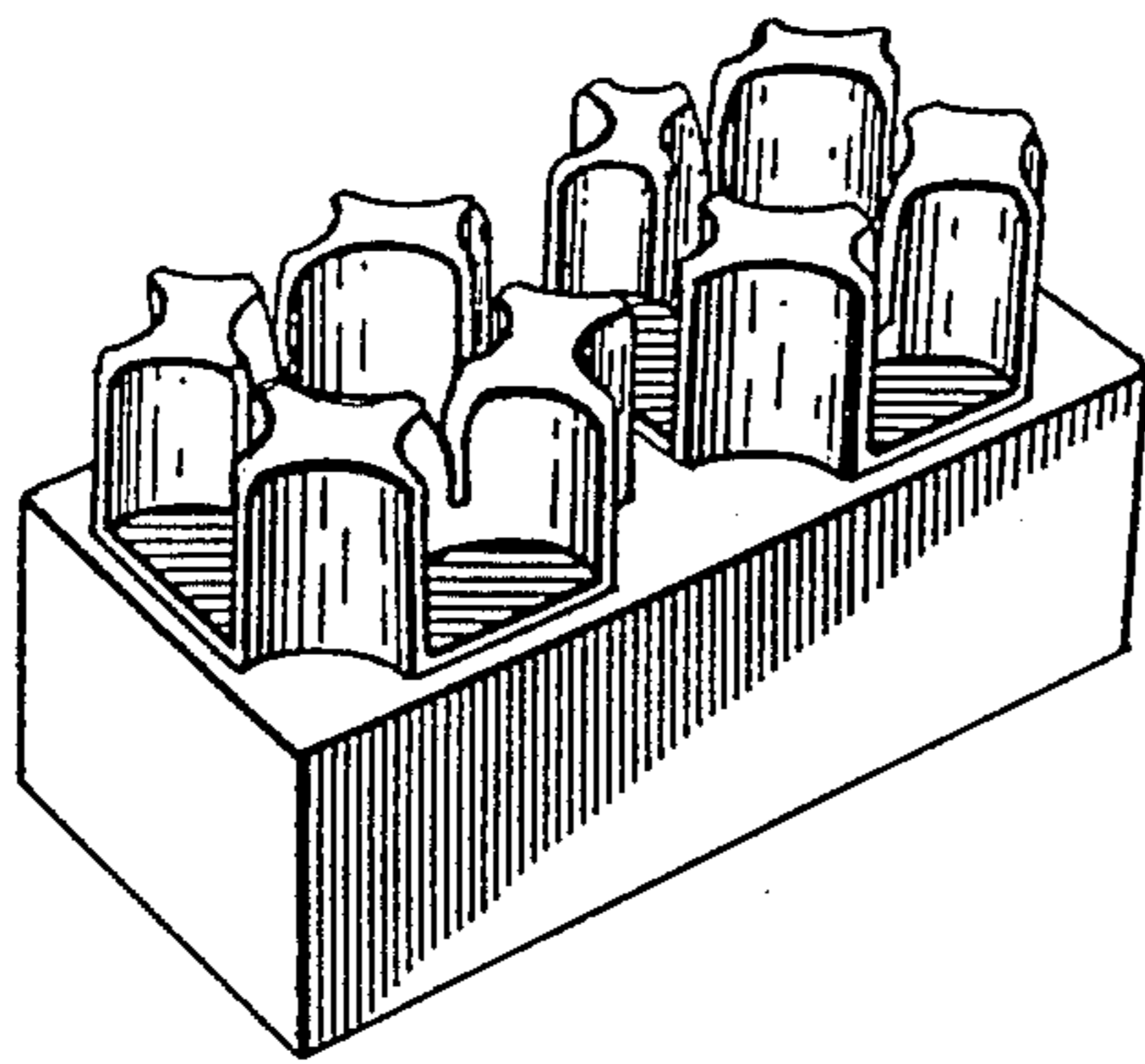

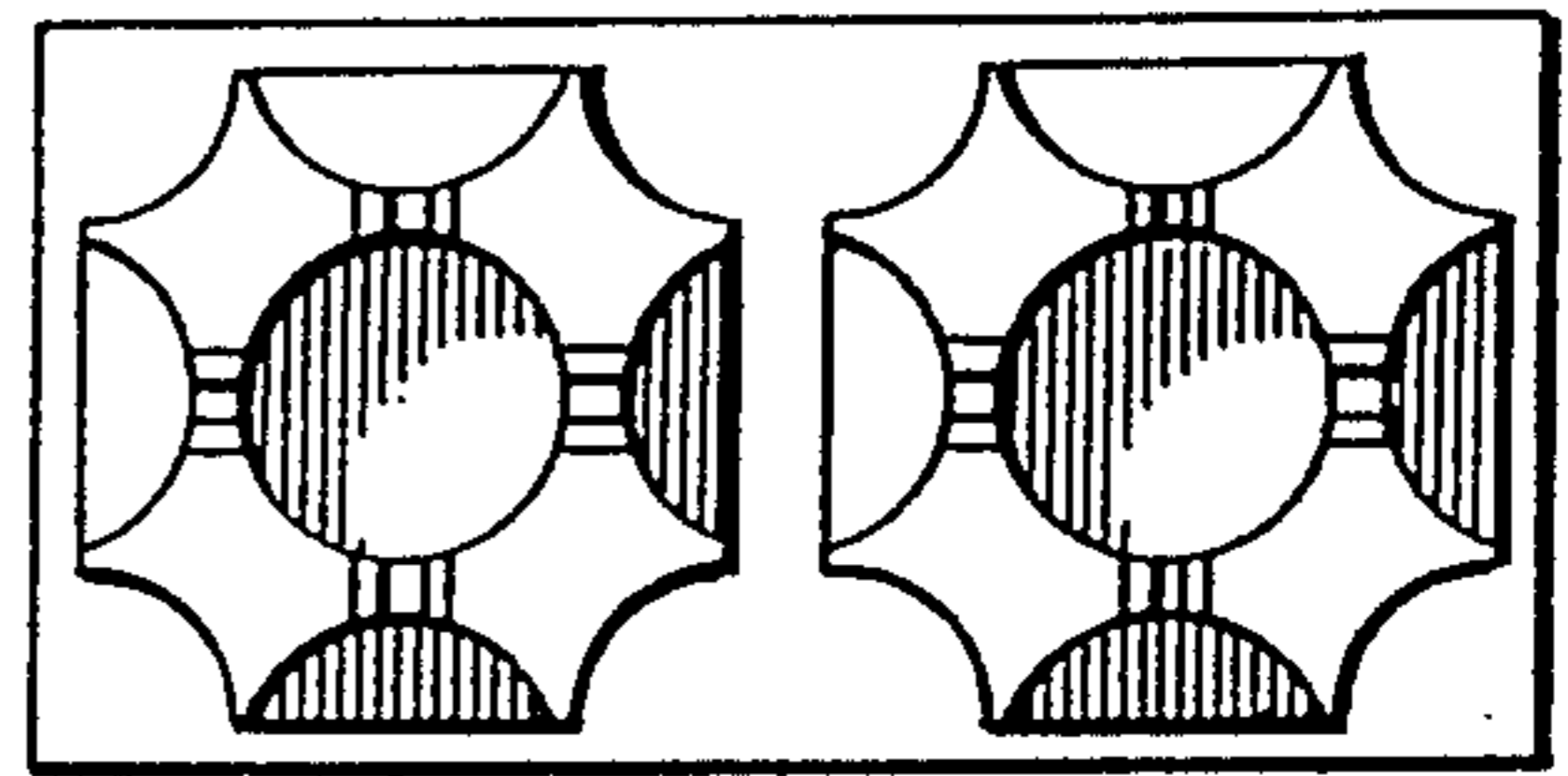

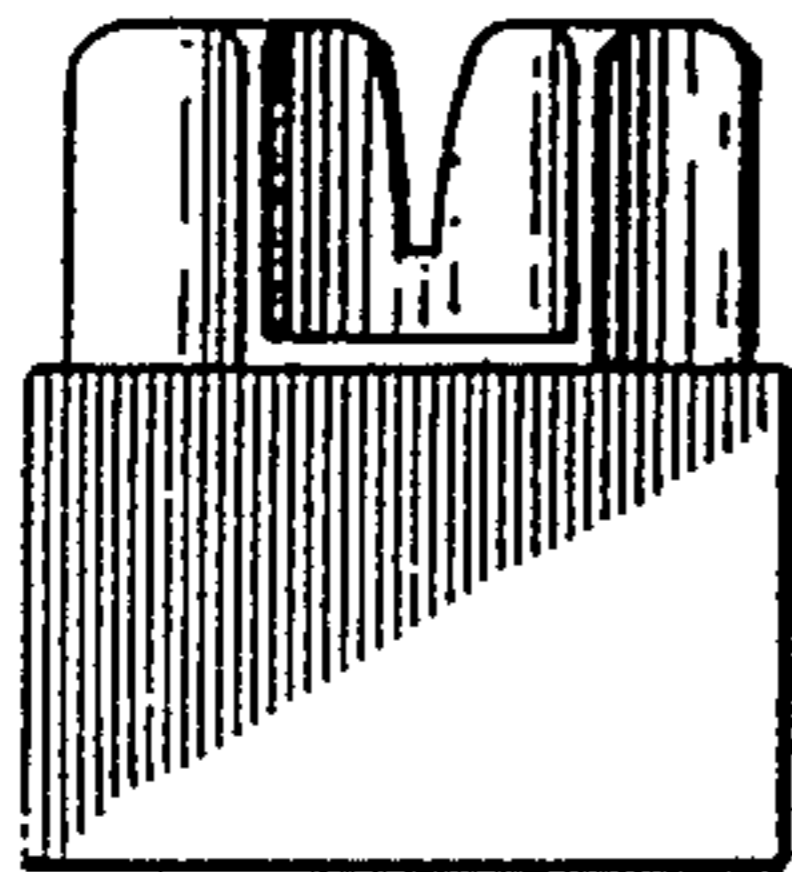

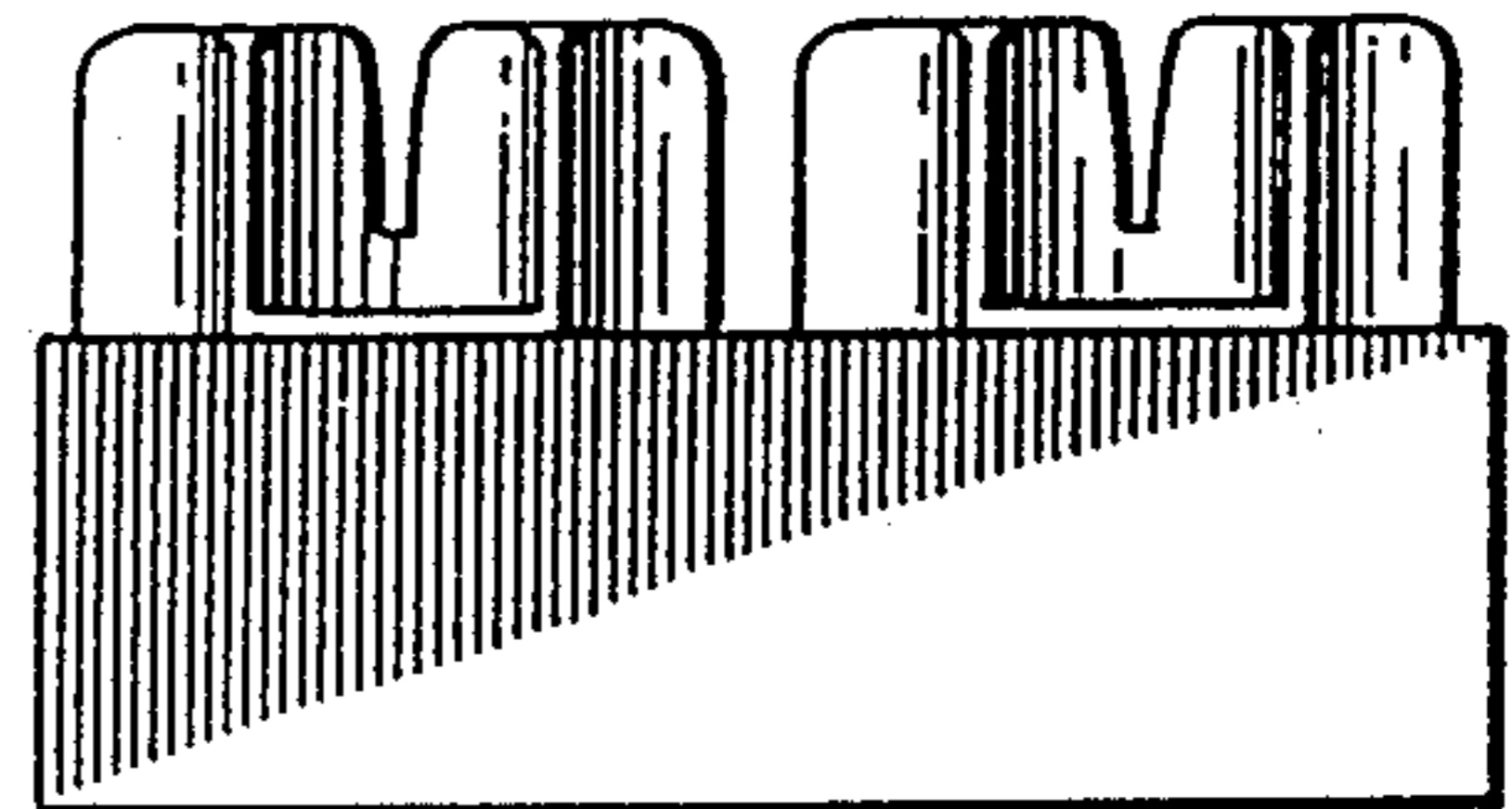

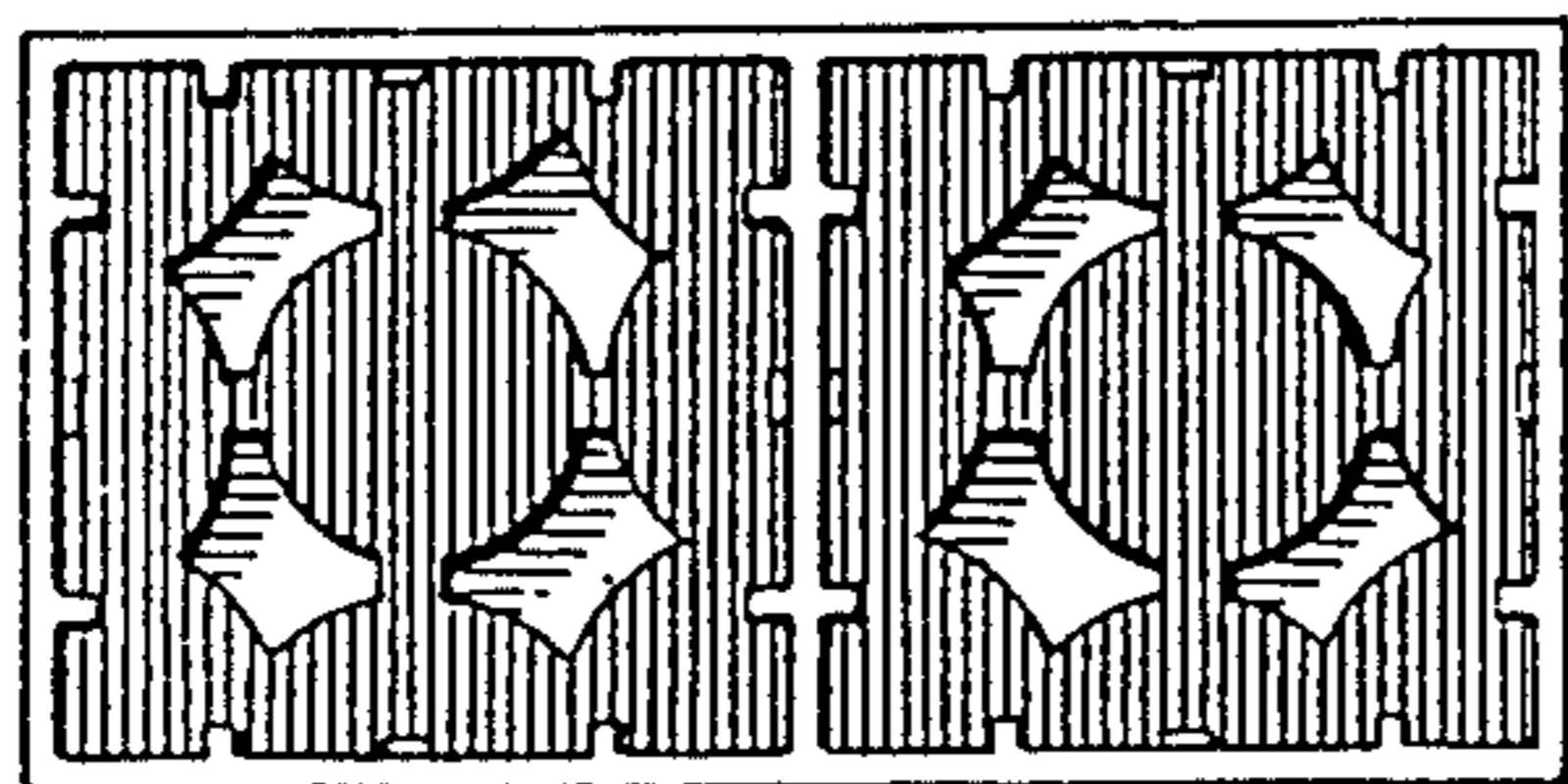
