DESCRIPTION

 FIG. 21 is a bottom plan view of FIG. 15.

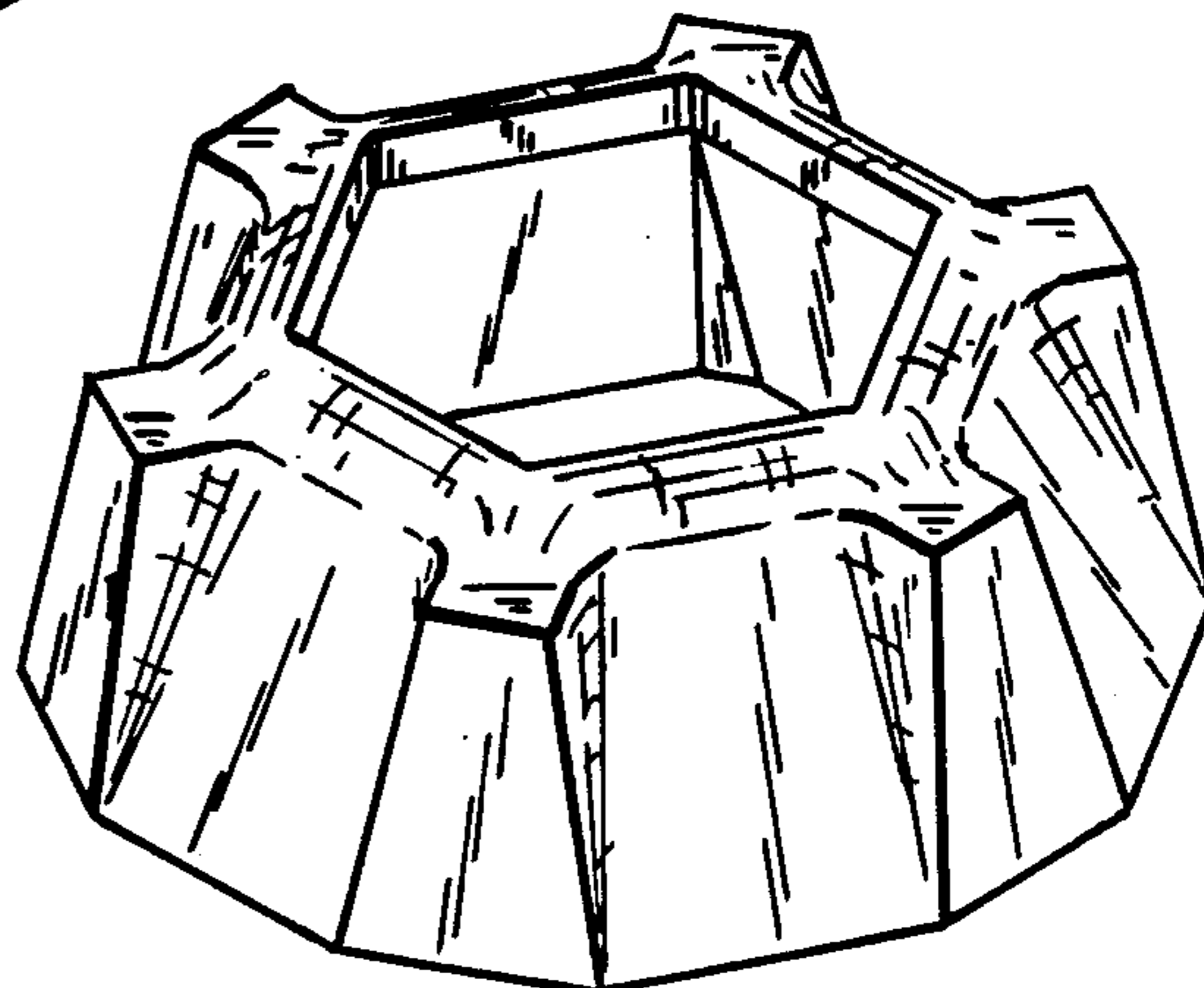
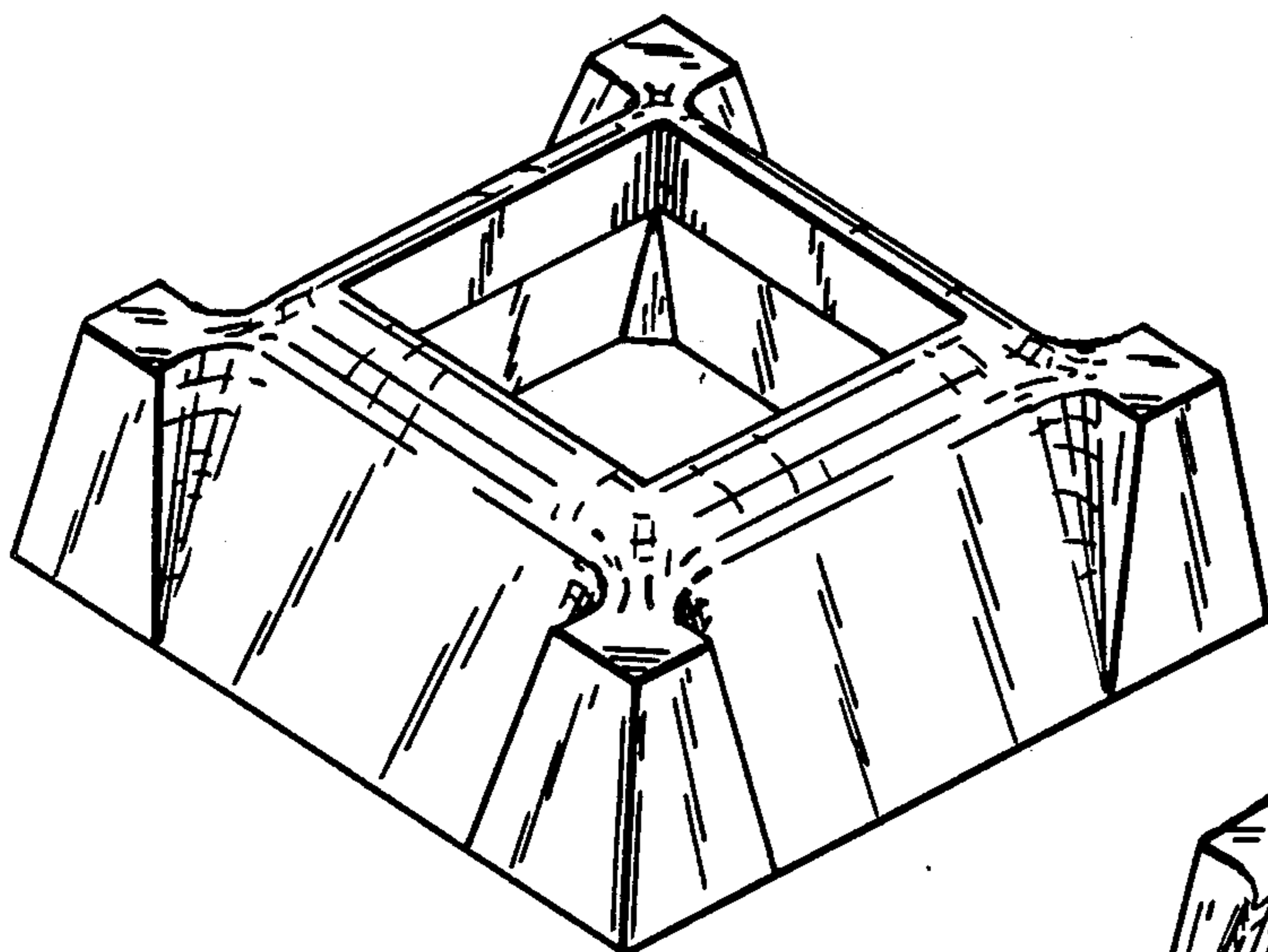

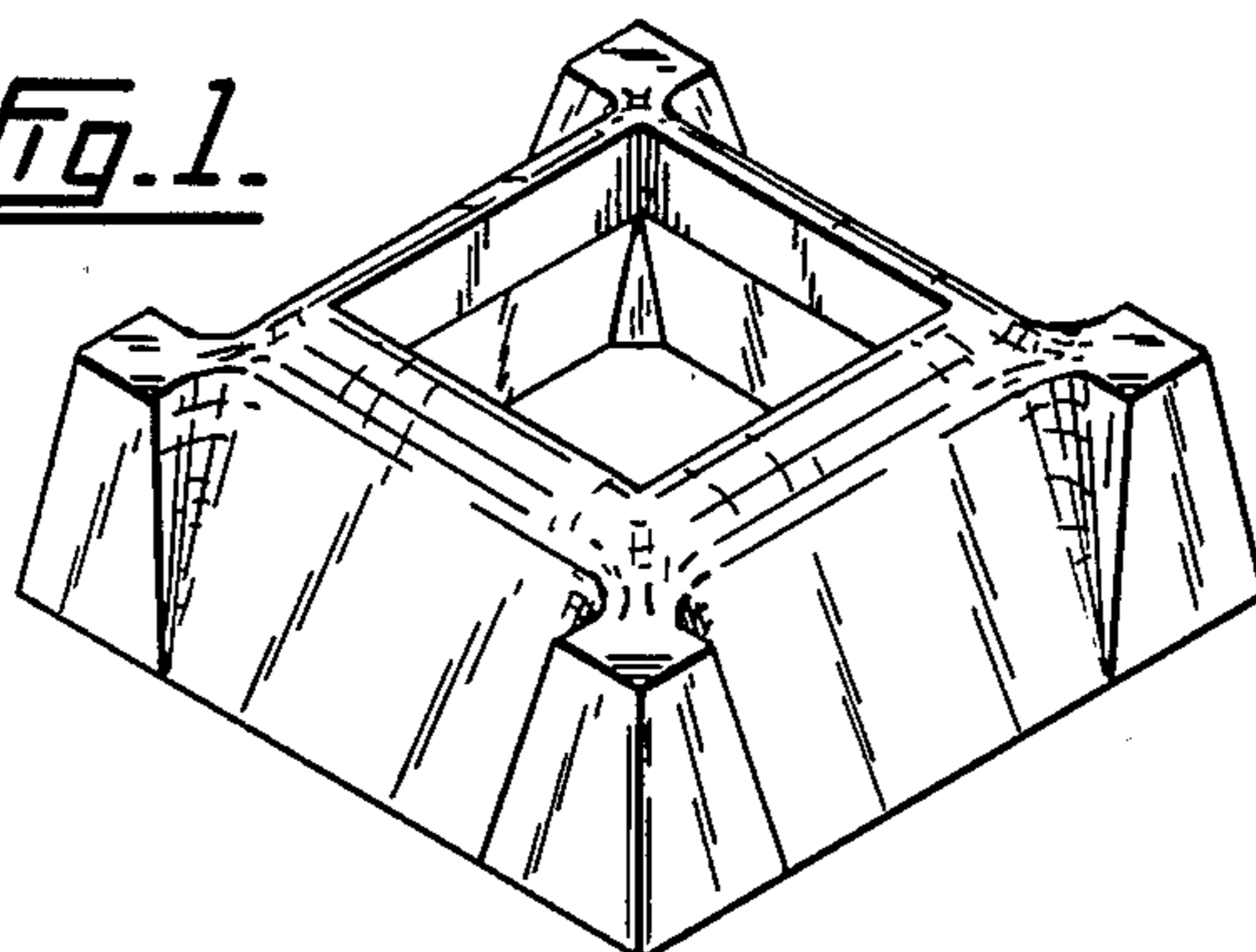

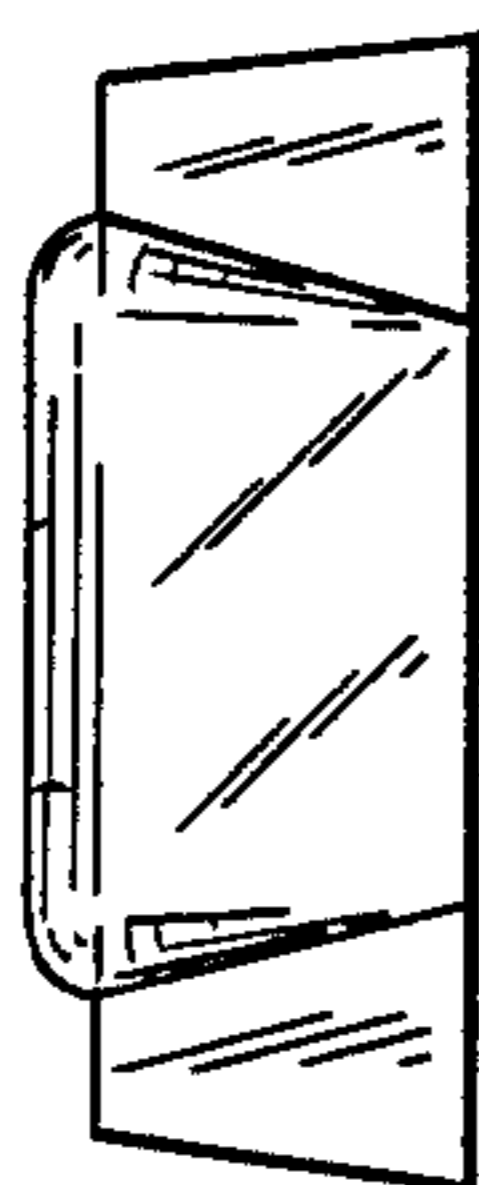

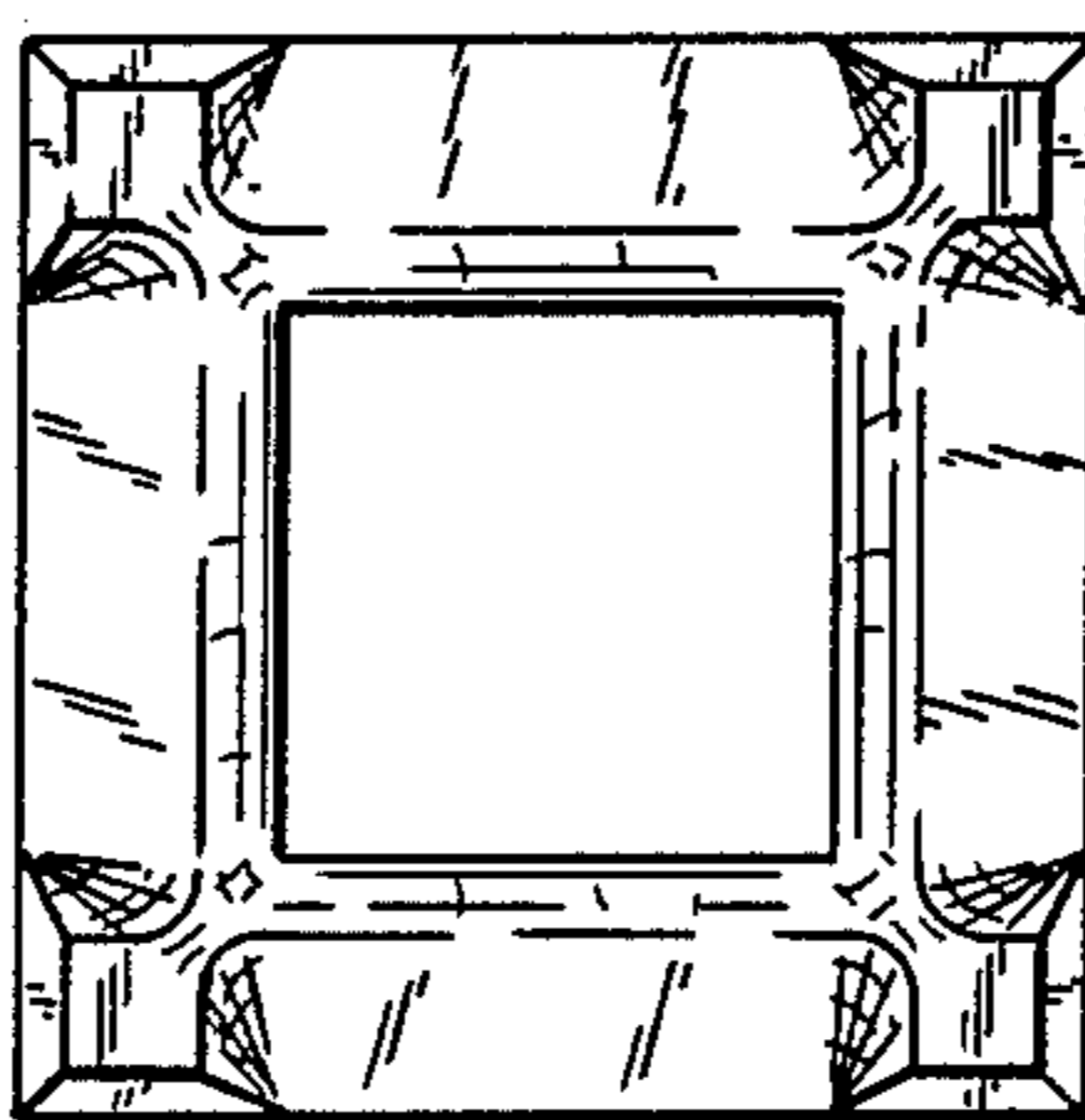

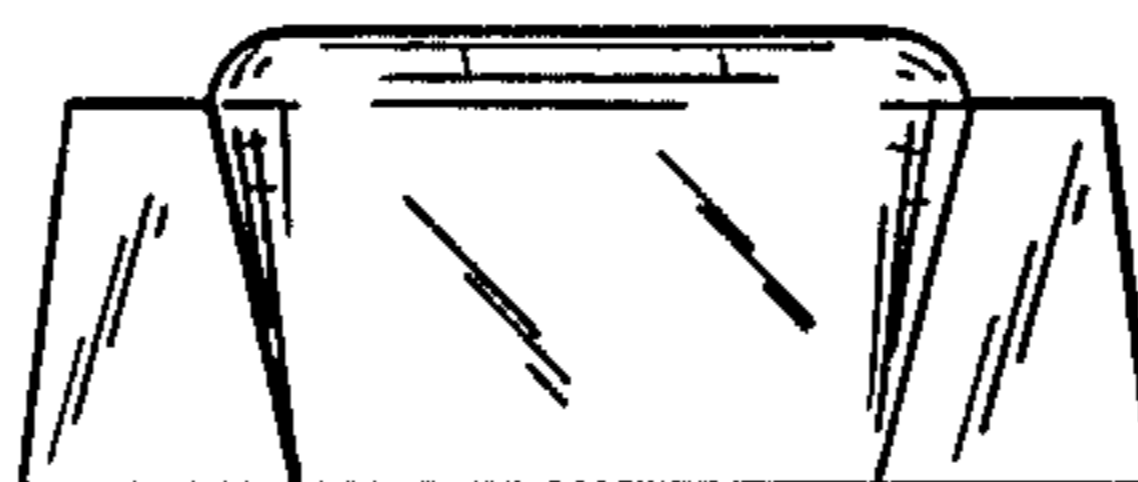

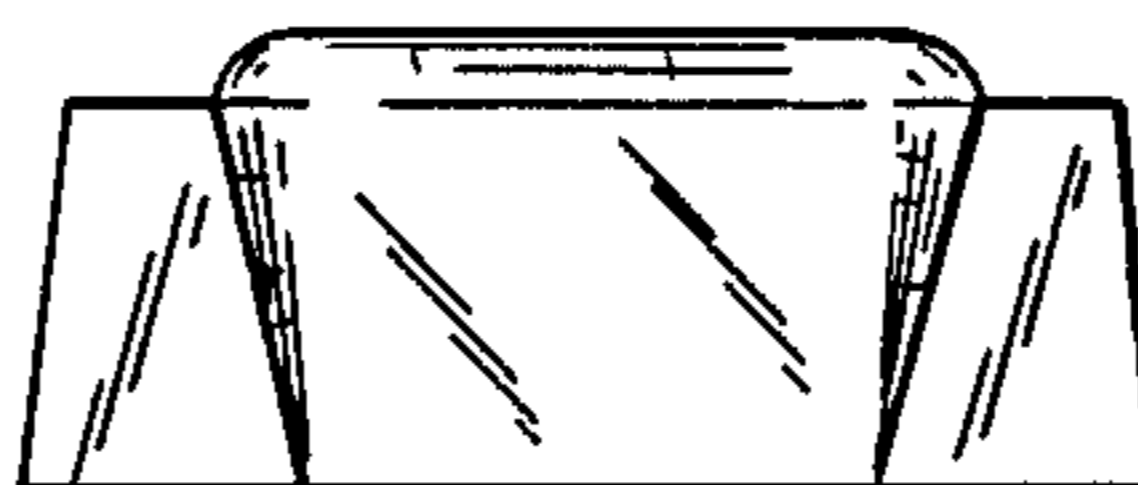

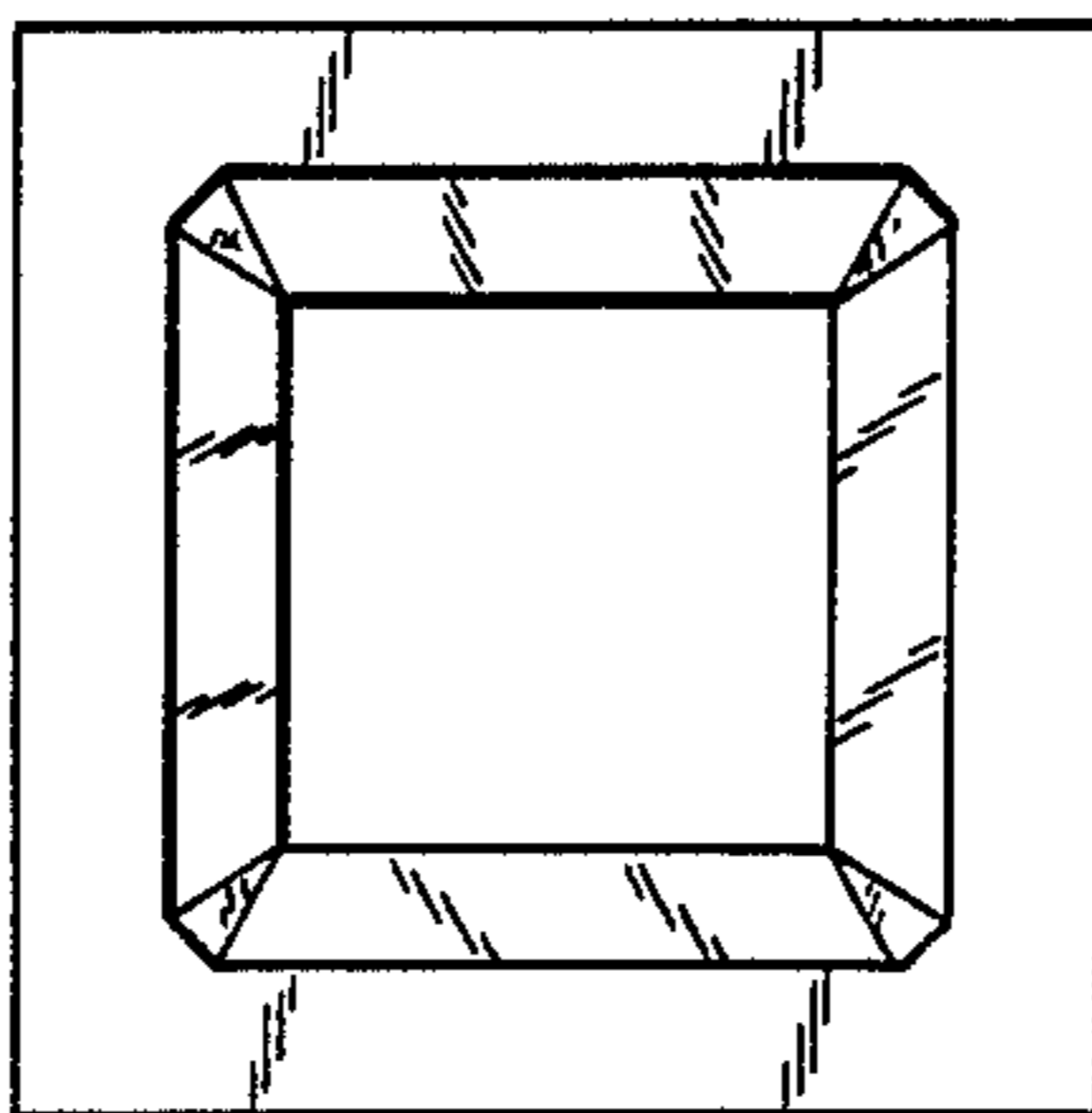

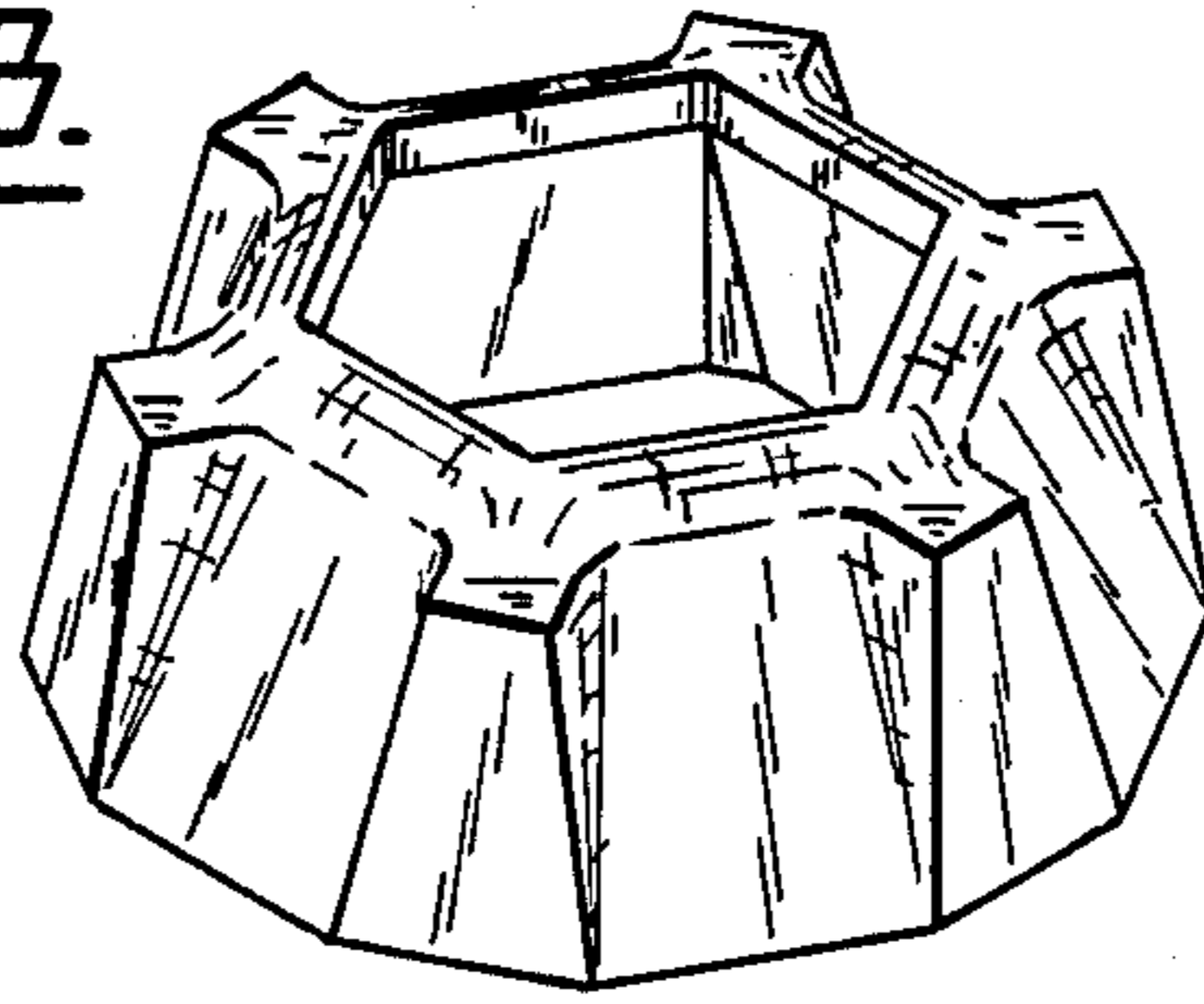

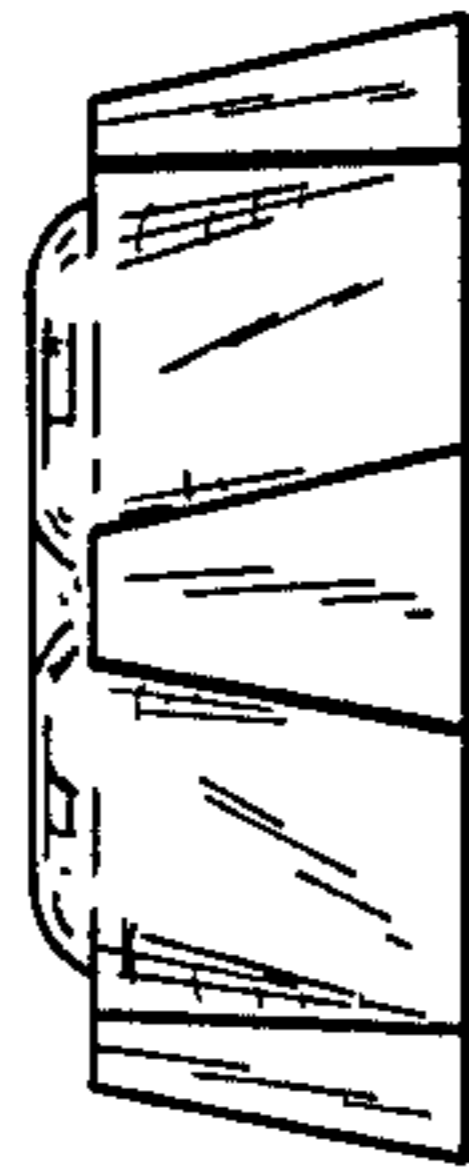

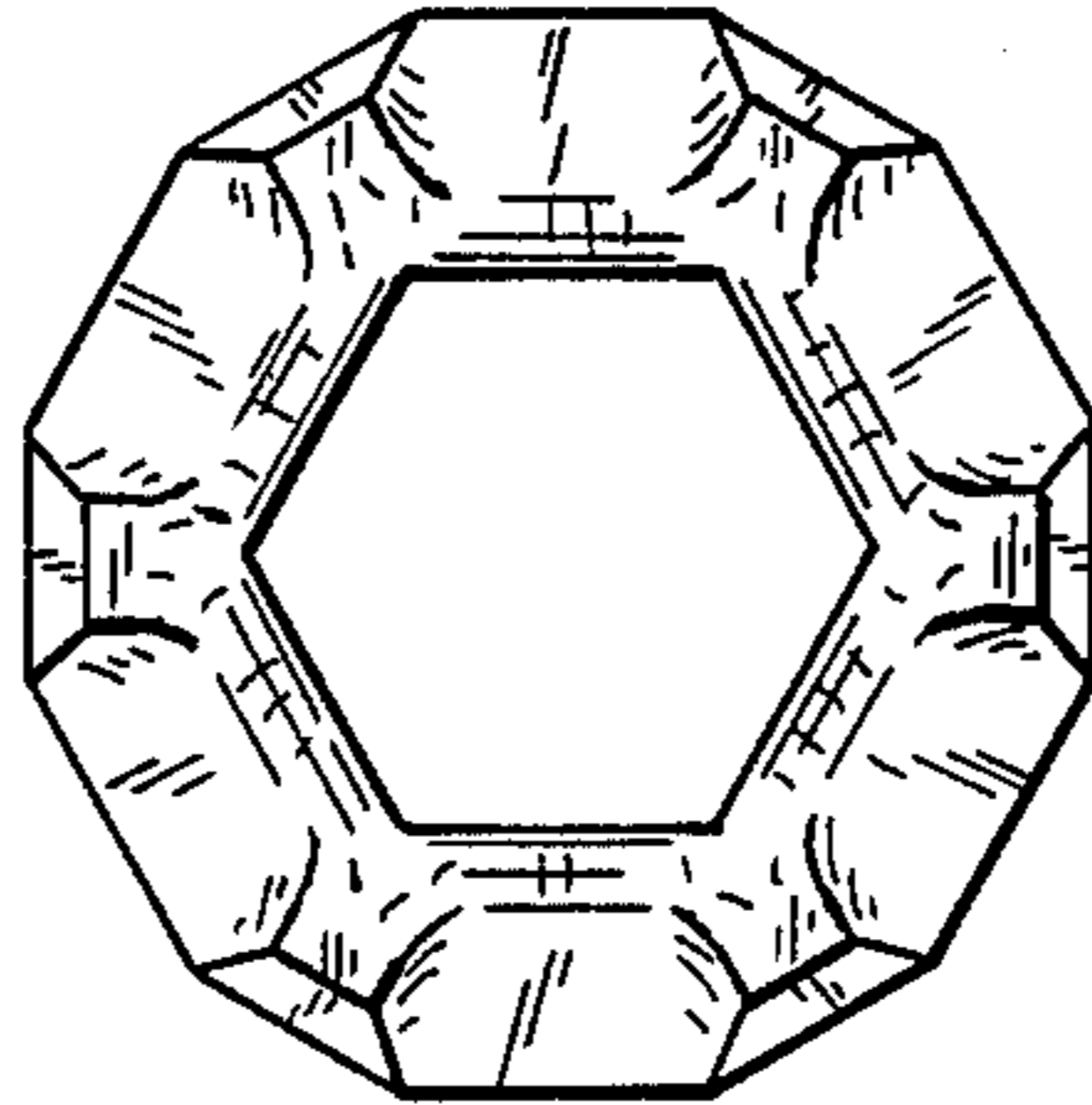

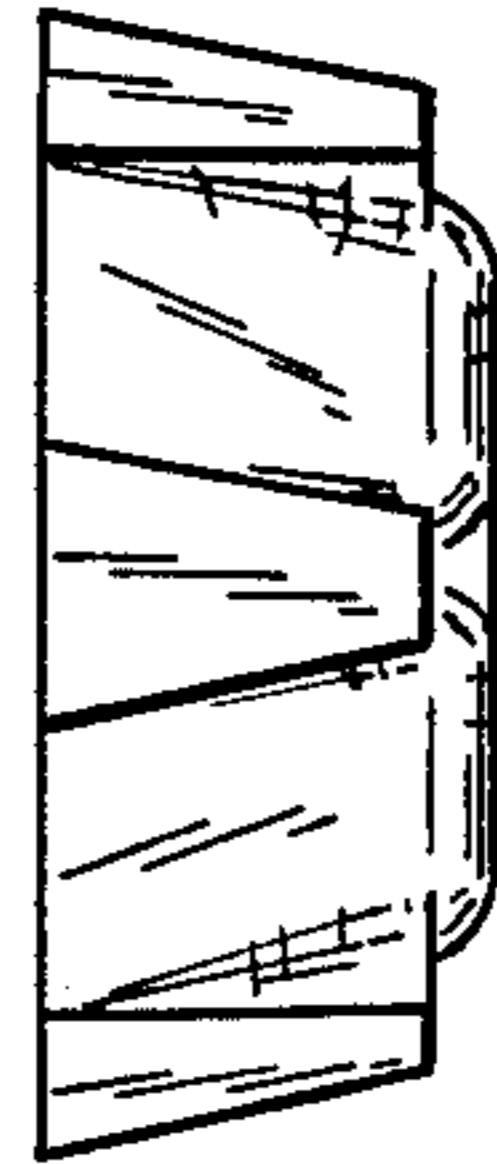

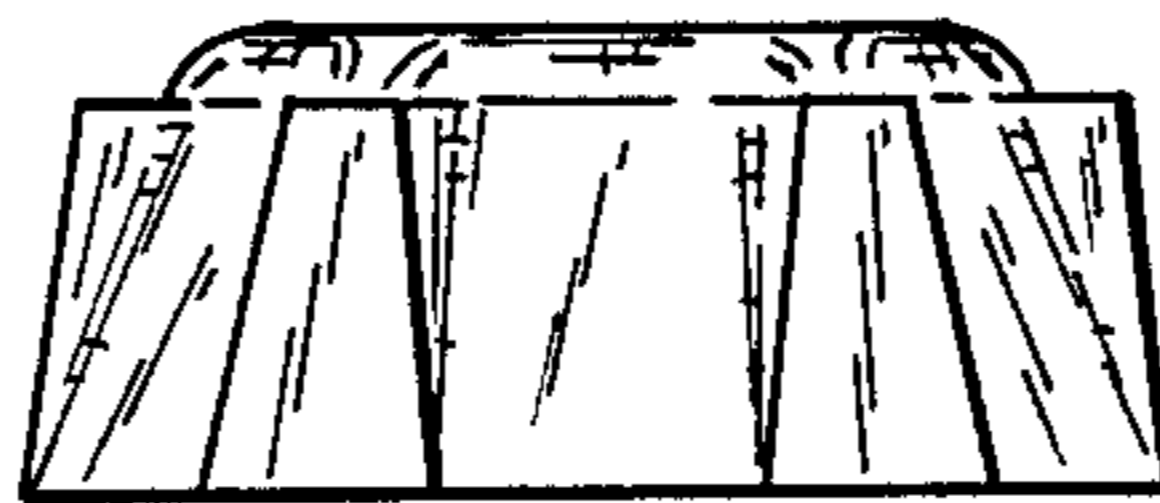

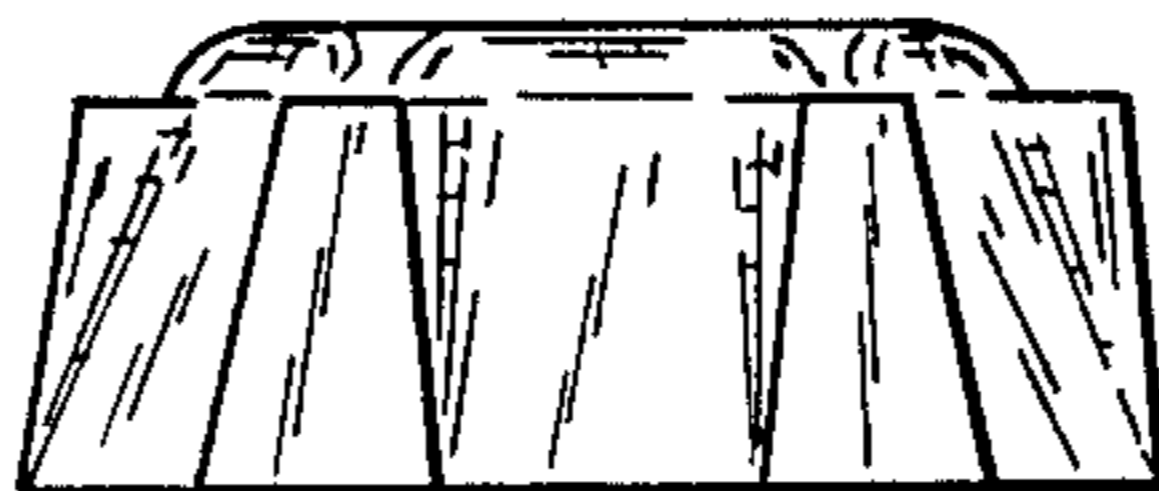

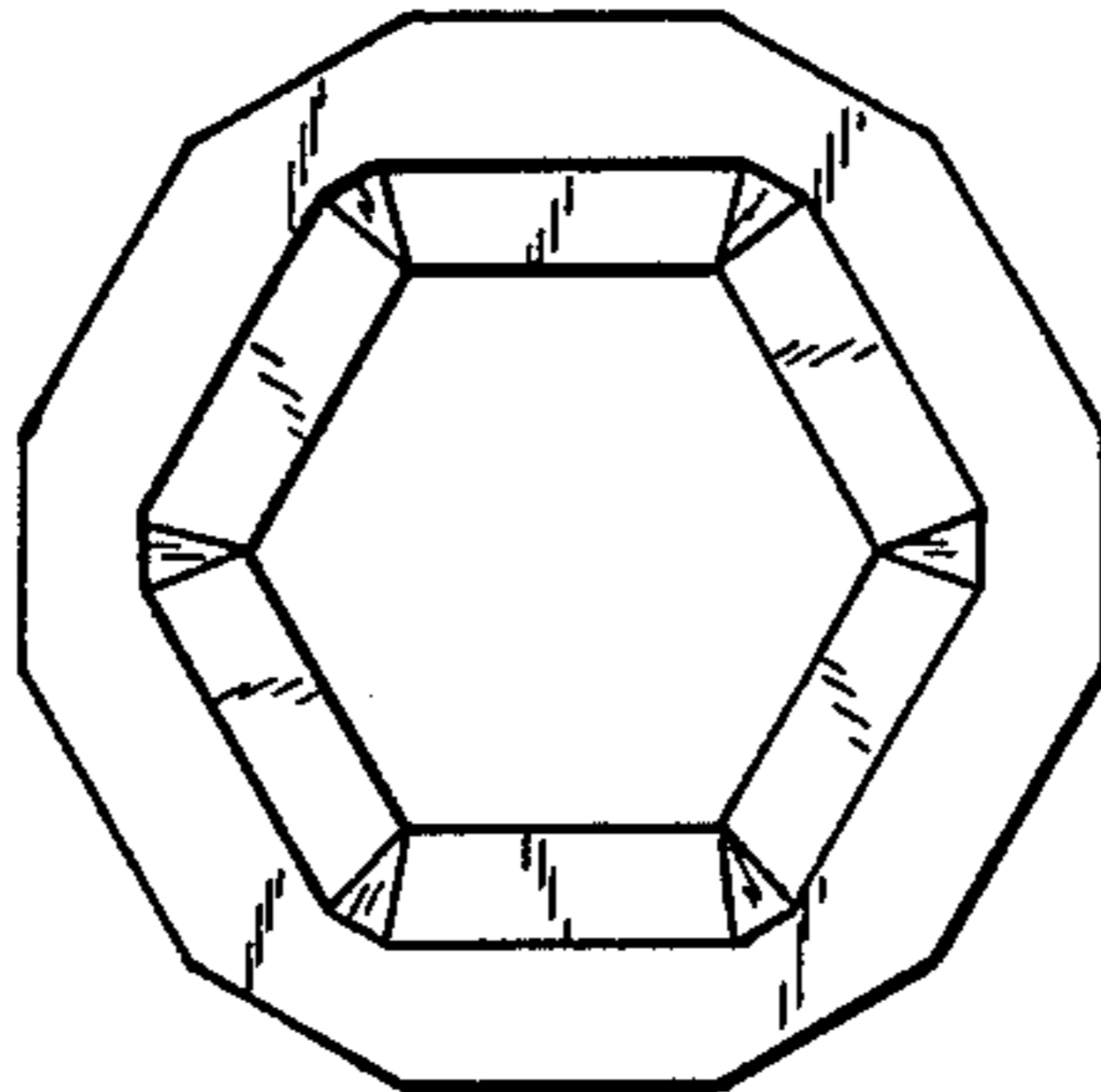

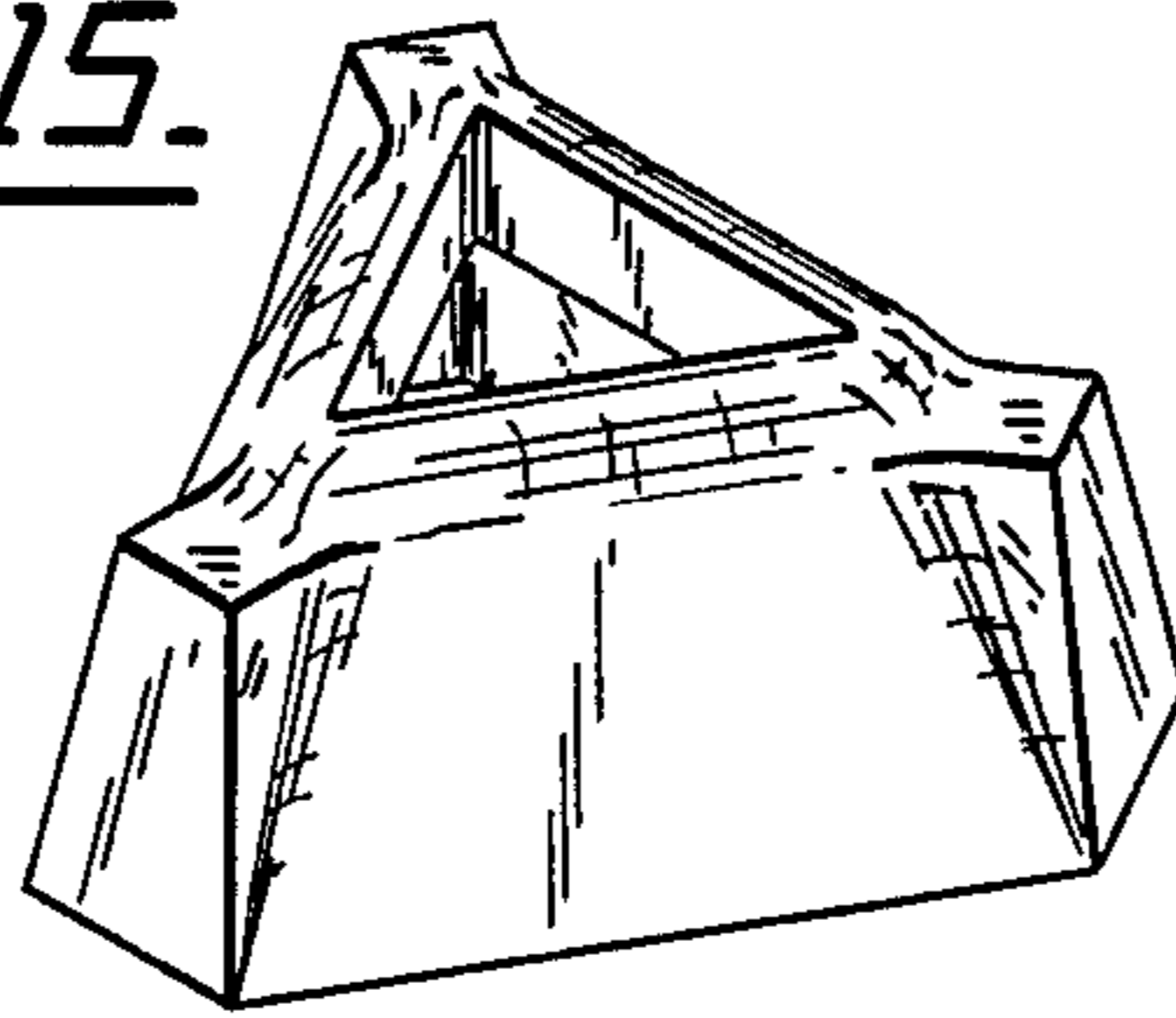

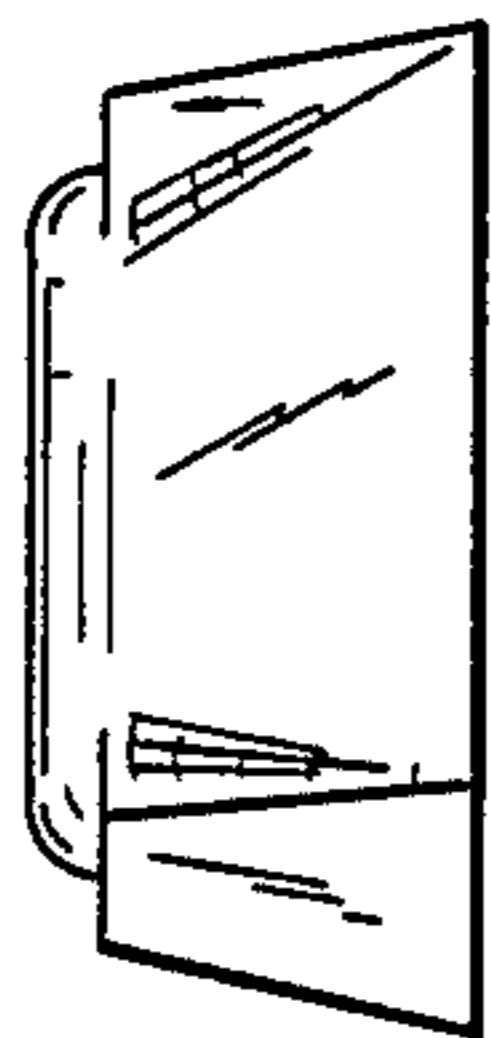

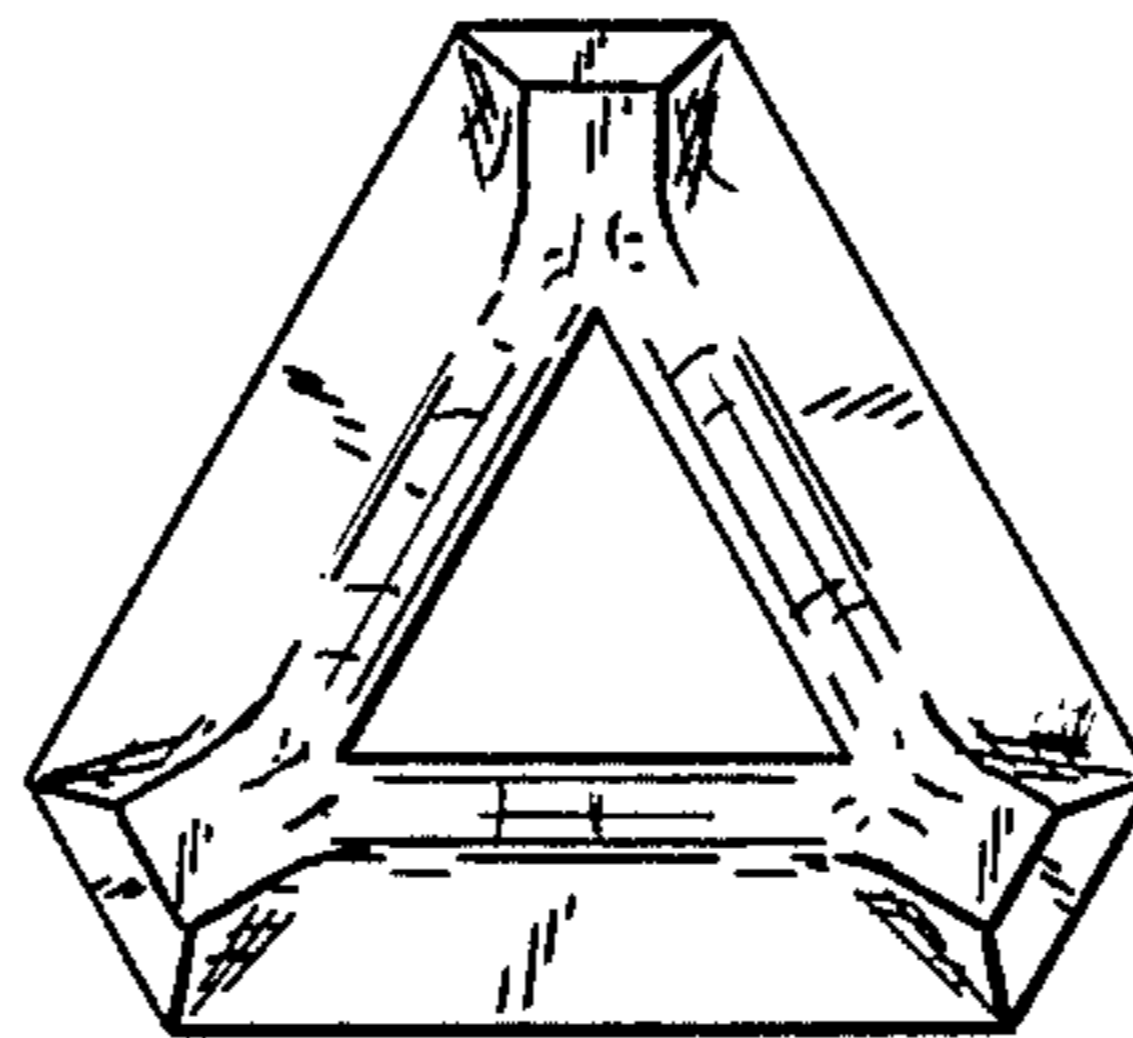

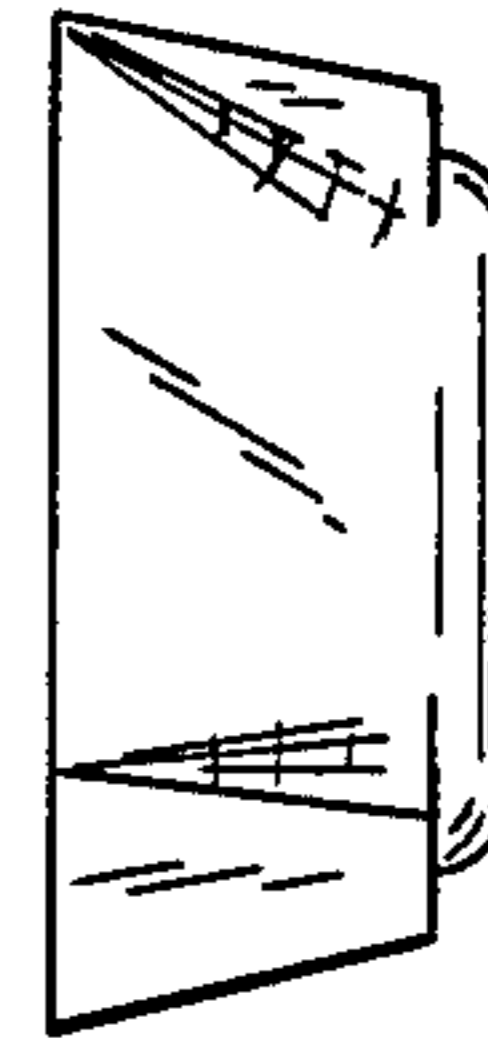

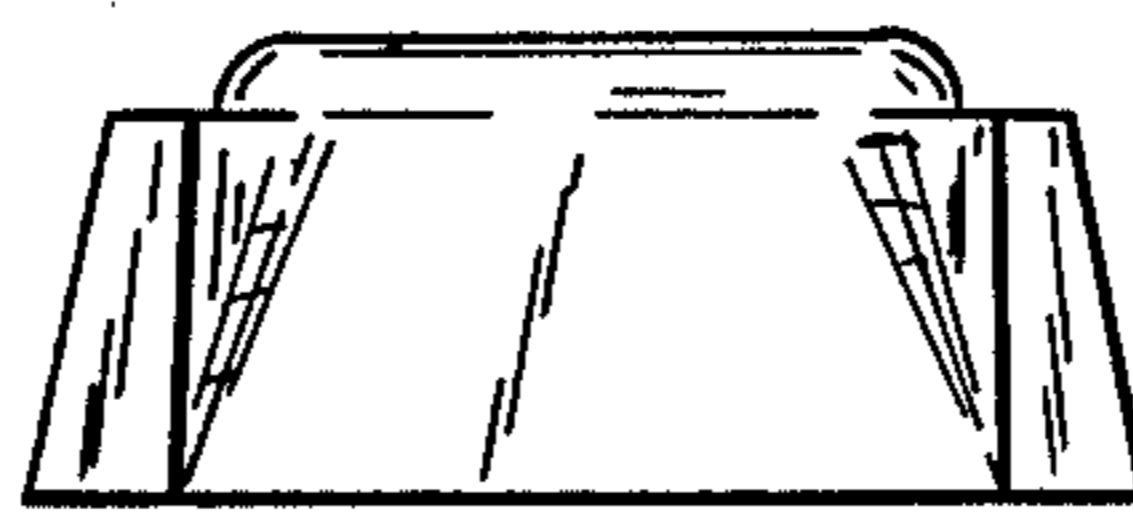

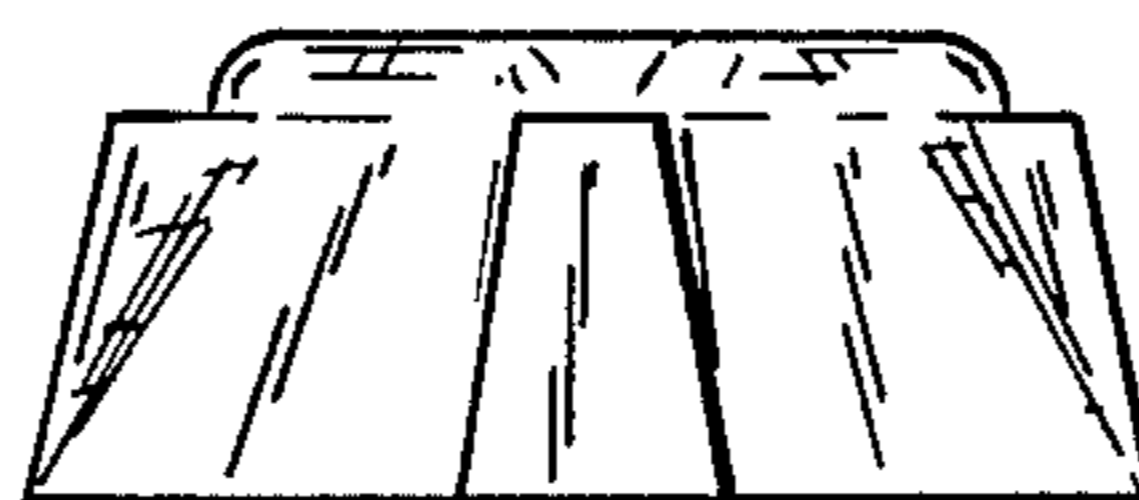
