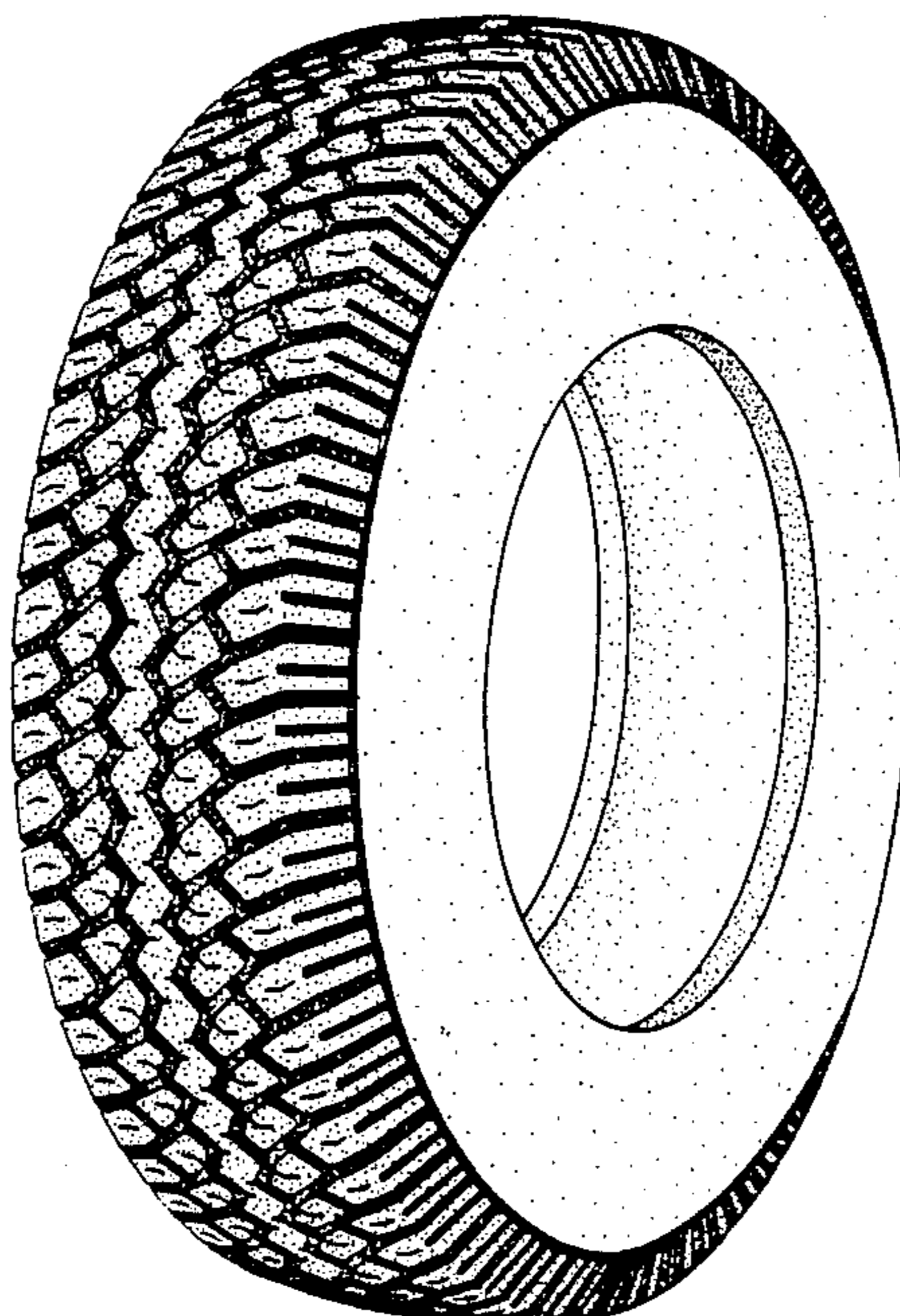

[57] CLAIM

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire showing our new design it being understood that the tread pattern is repeated throughout the circumference of the tire, the opposite side being substantially the same as that shown; FIG. 2 is a front elevation view thereof; and FIG. 3 is a side elevation view thereof on a reduced scale.



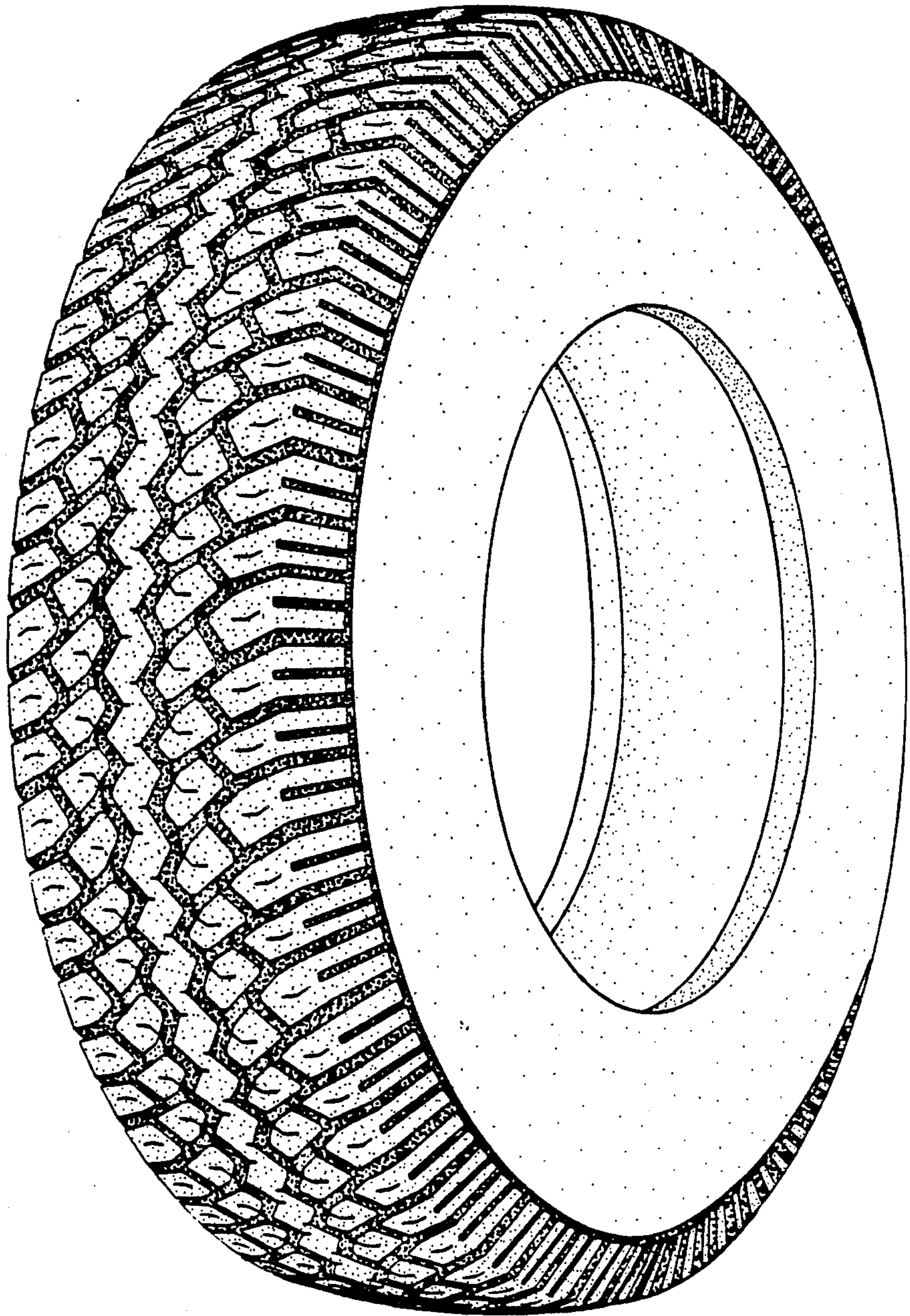

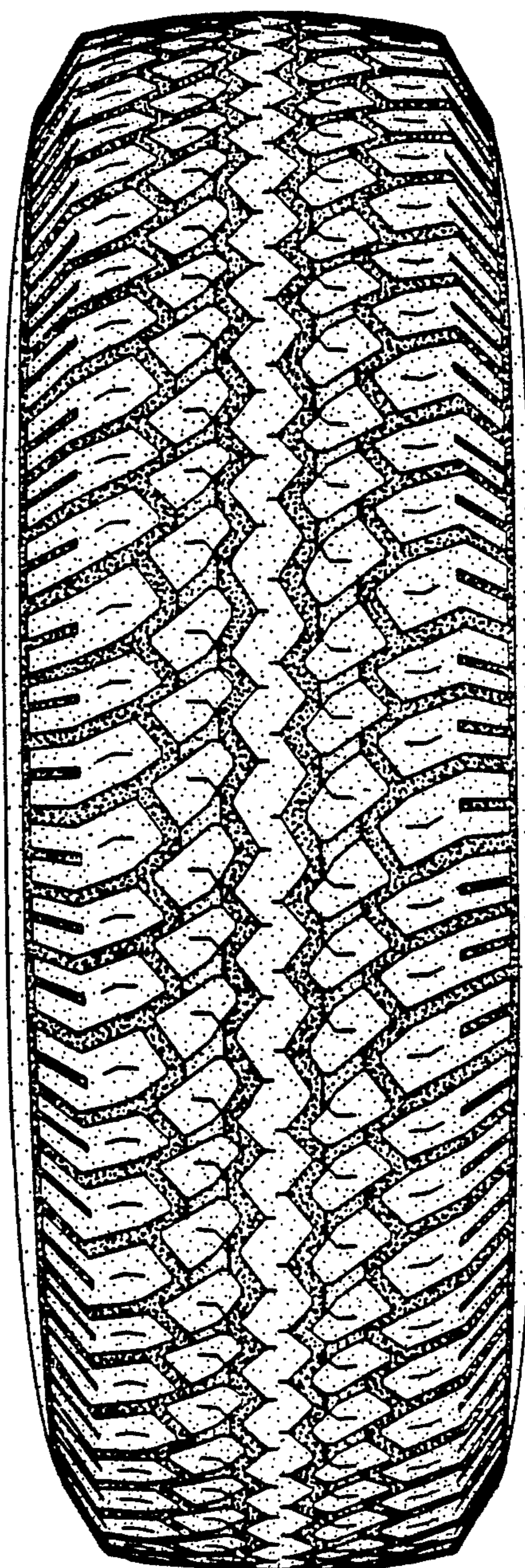

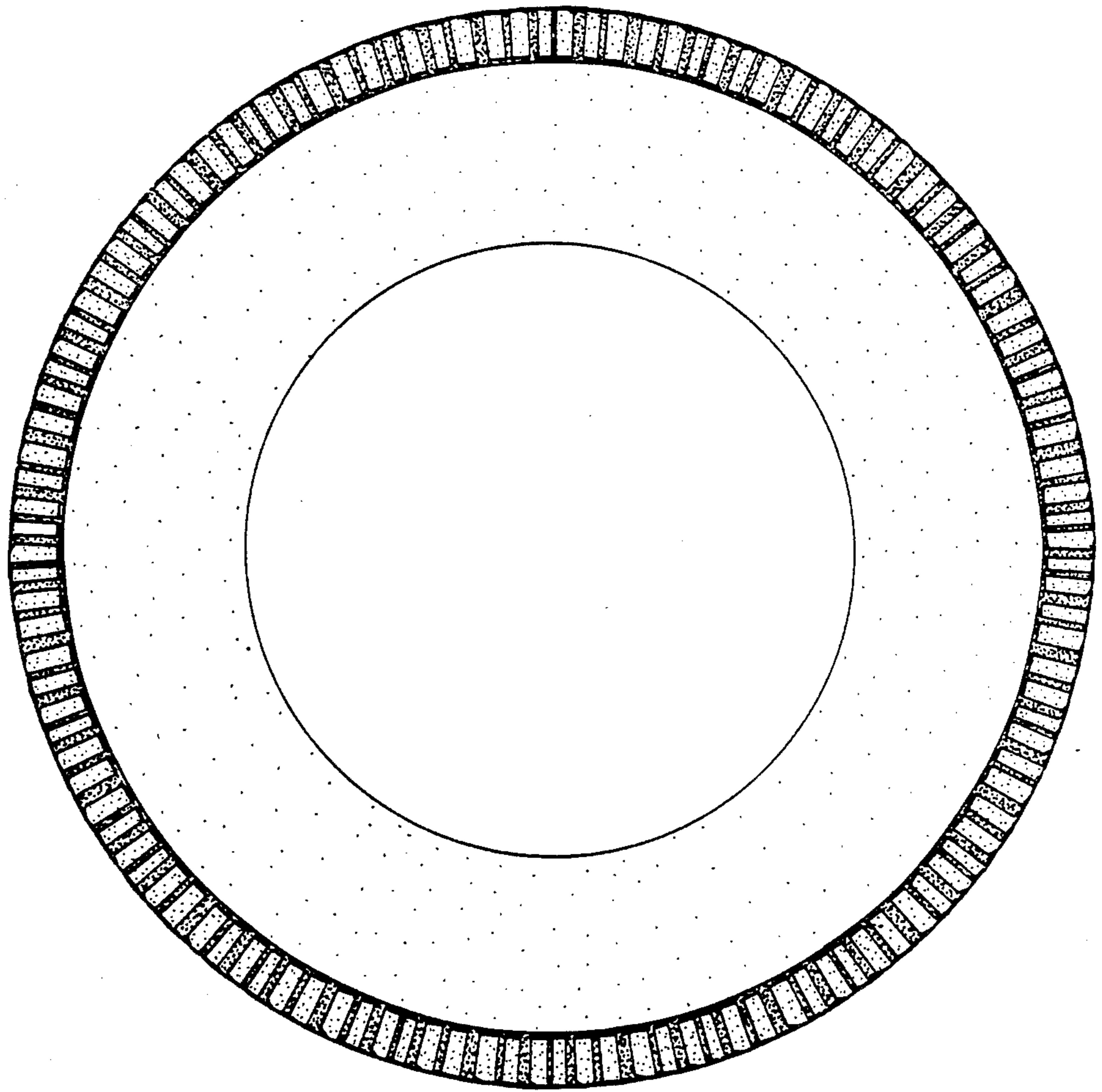
