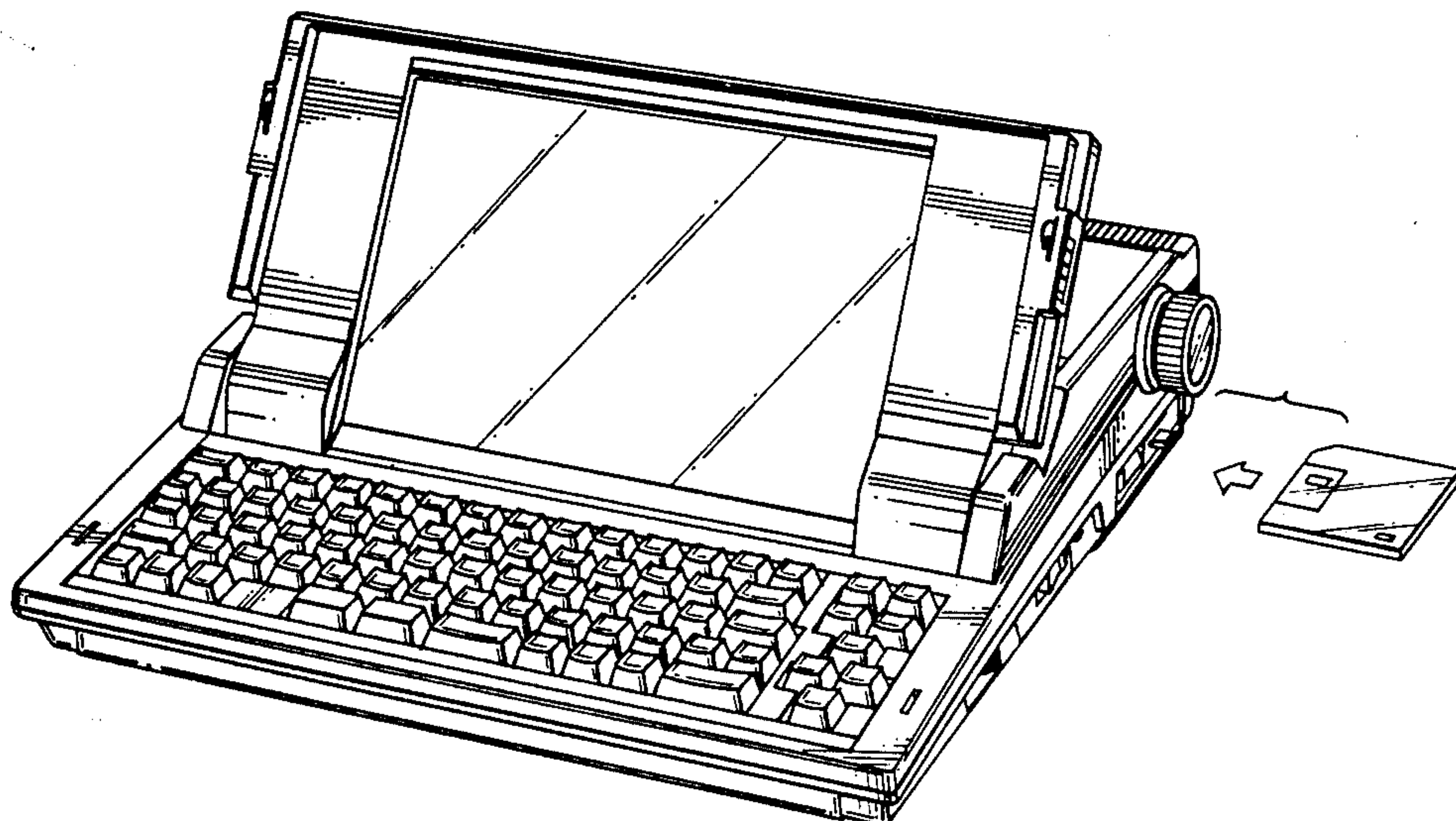

CLAIM

The ornamental design for a word processor having

function of electronic computer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a word processor having function of electronic computer showing my new design, the floppy disk being shown in broken lines for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a front elevational view thereof,

FIG. 3 is a rear elevational view thereof,

FIG. 4 is a top plan view thereof,

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left side elevational view thereof,

FIG. 7 is a right side elevational view thereof, the display panel in closed position,

FIG. 8 is a front, top and right side perspective view thereof showing the display panel in closing position, the printer cover in opening position and carrying handle in extruded position.

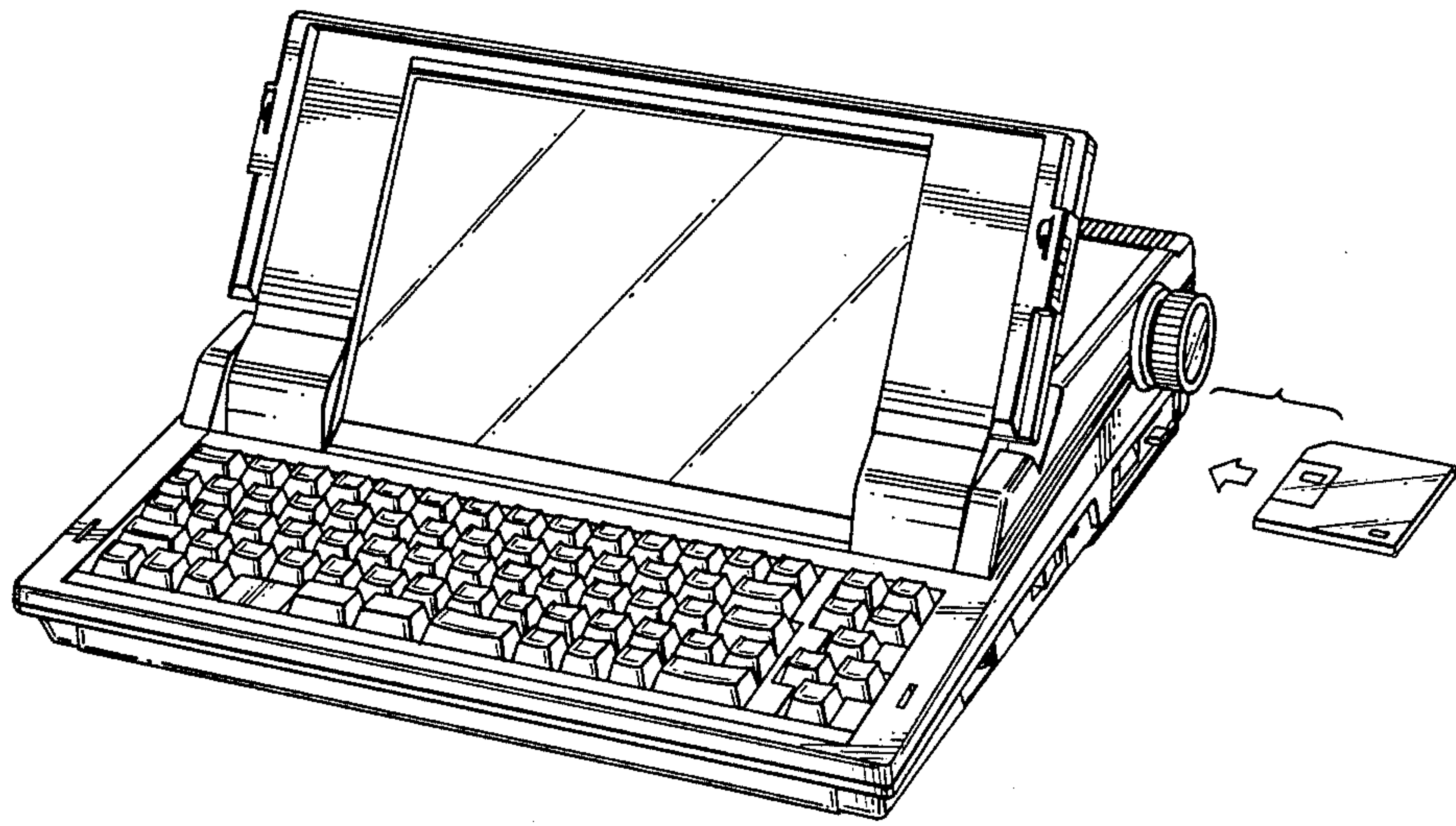

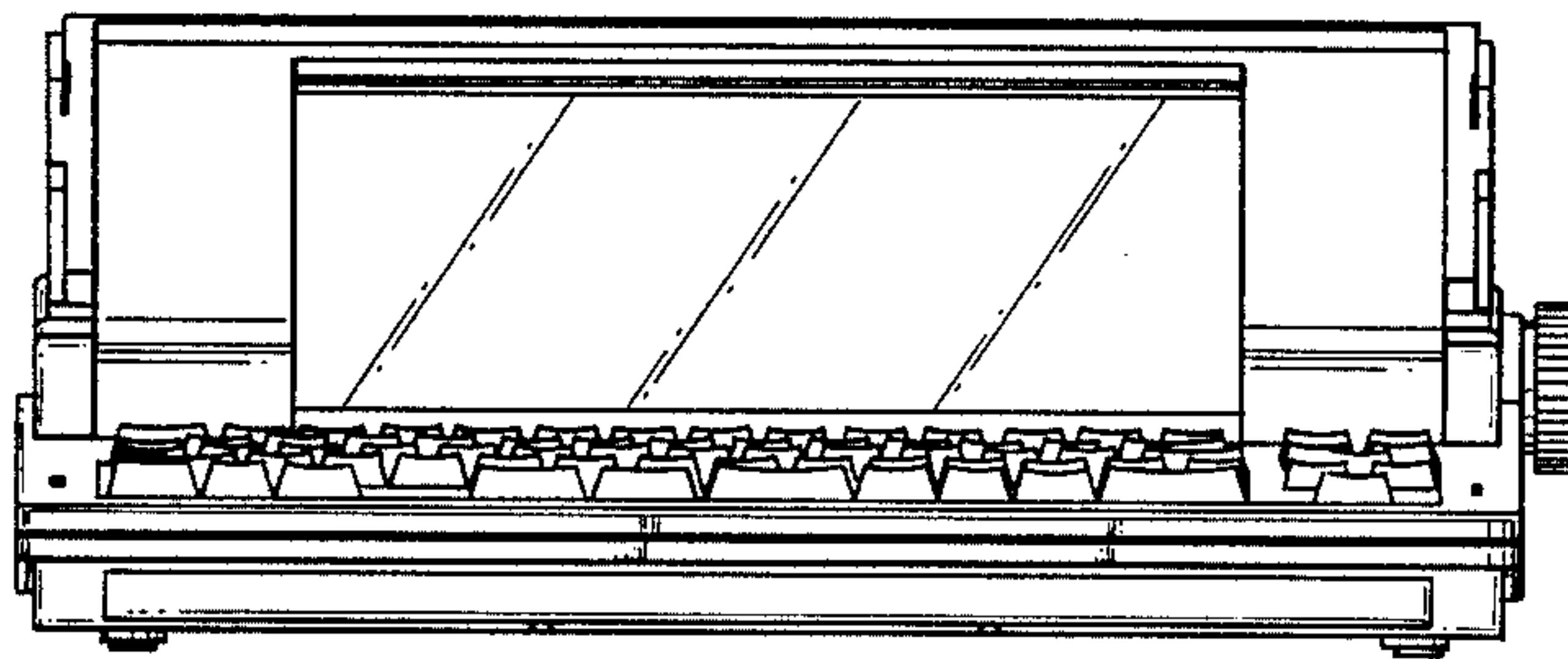

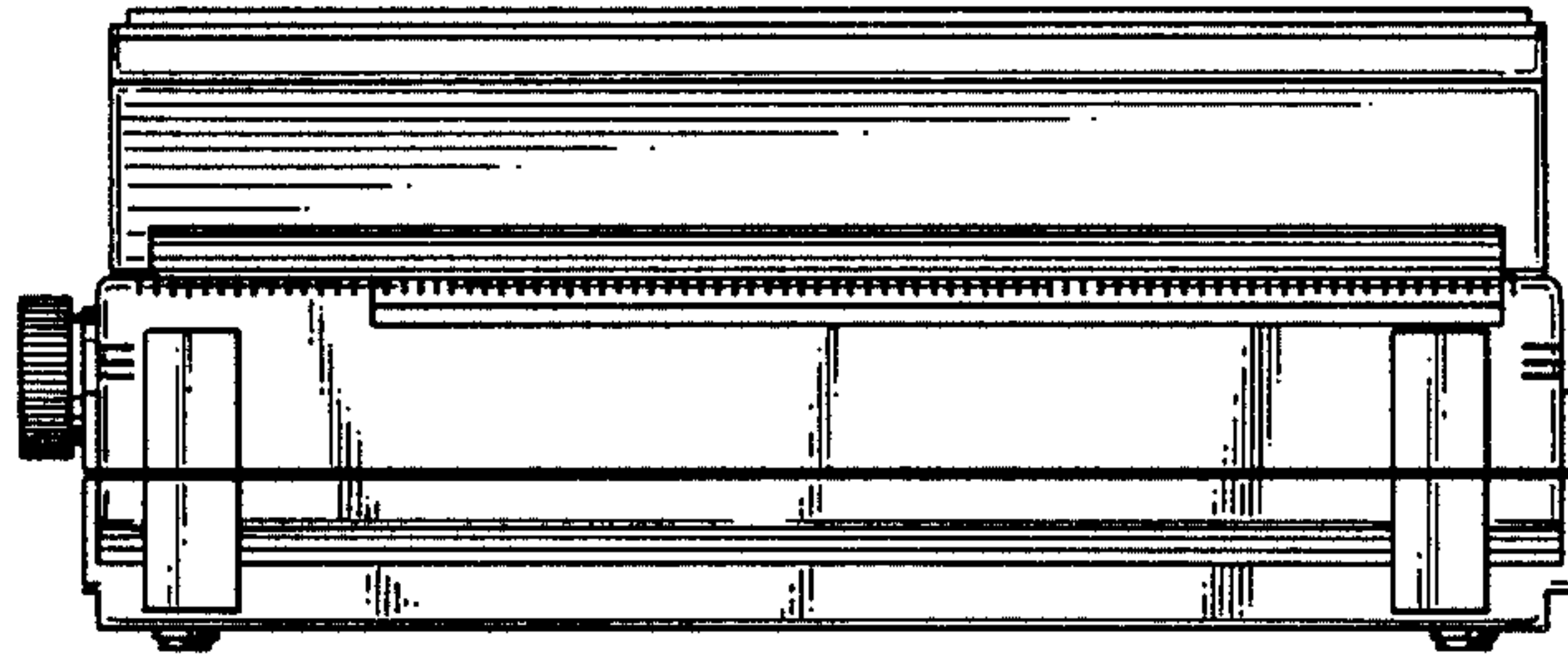

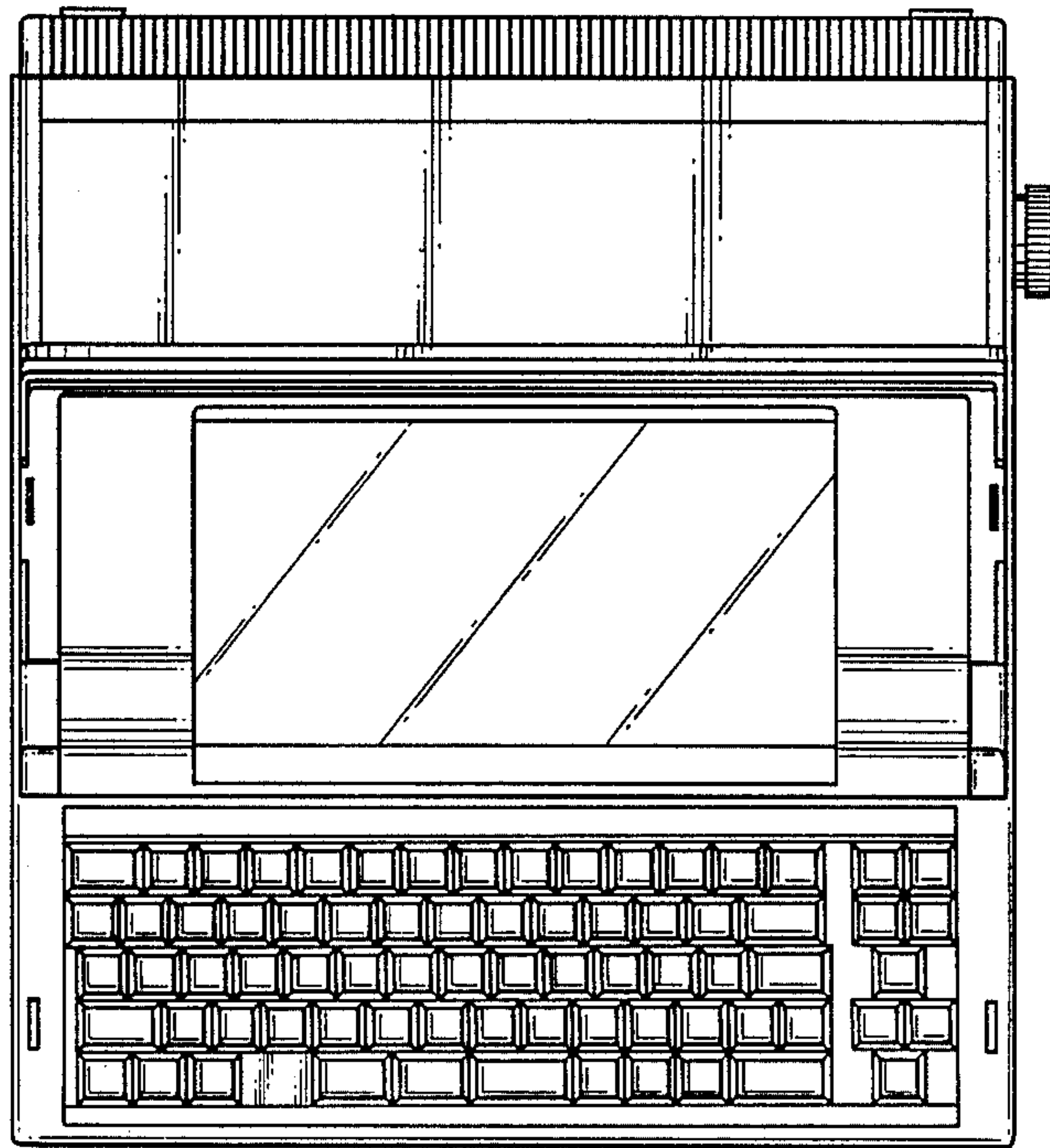

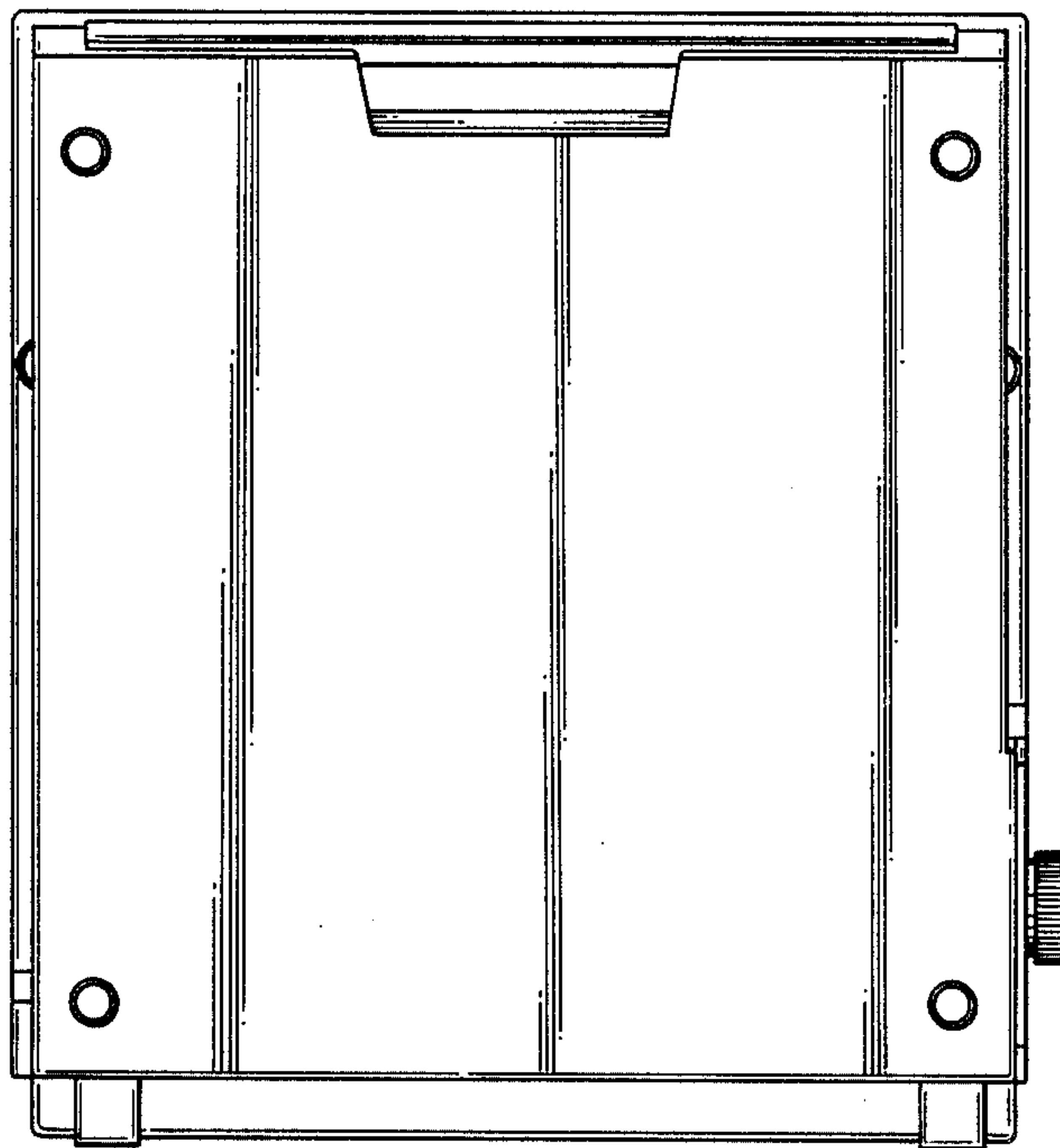

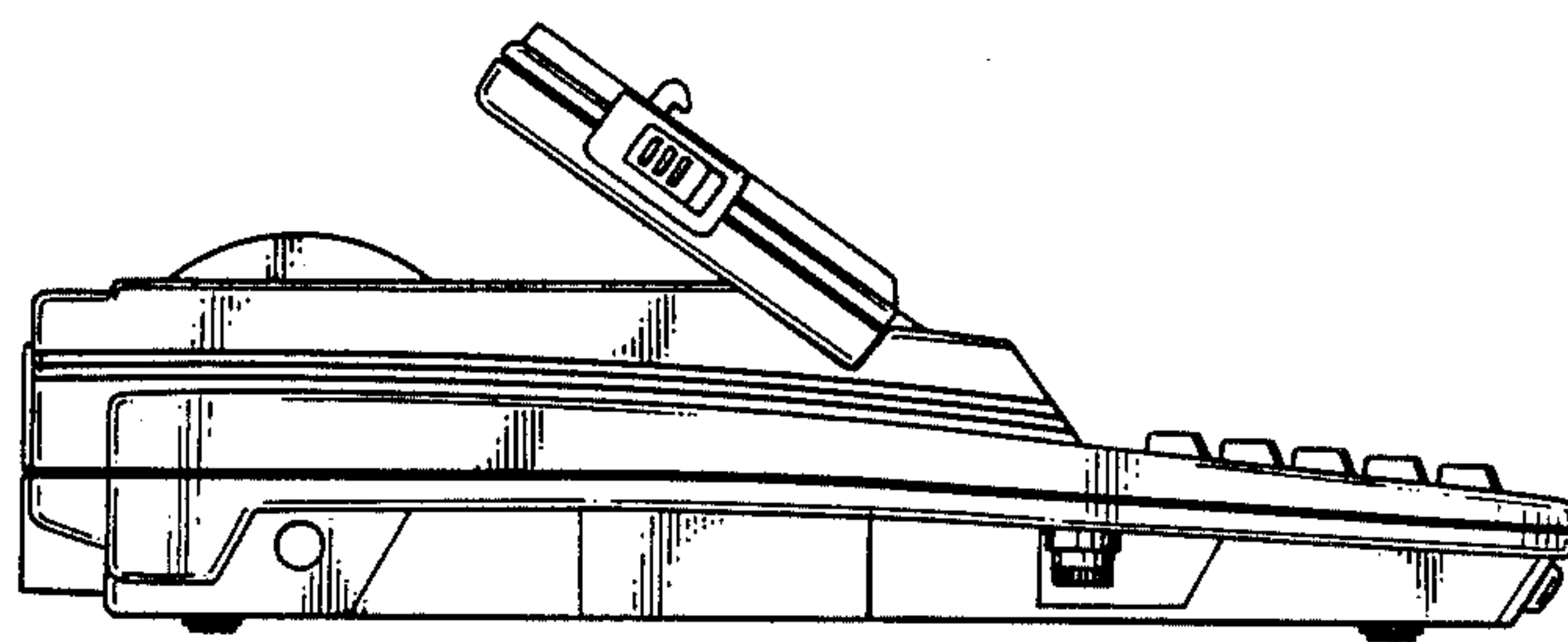

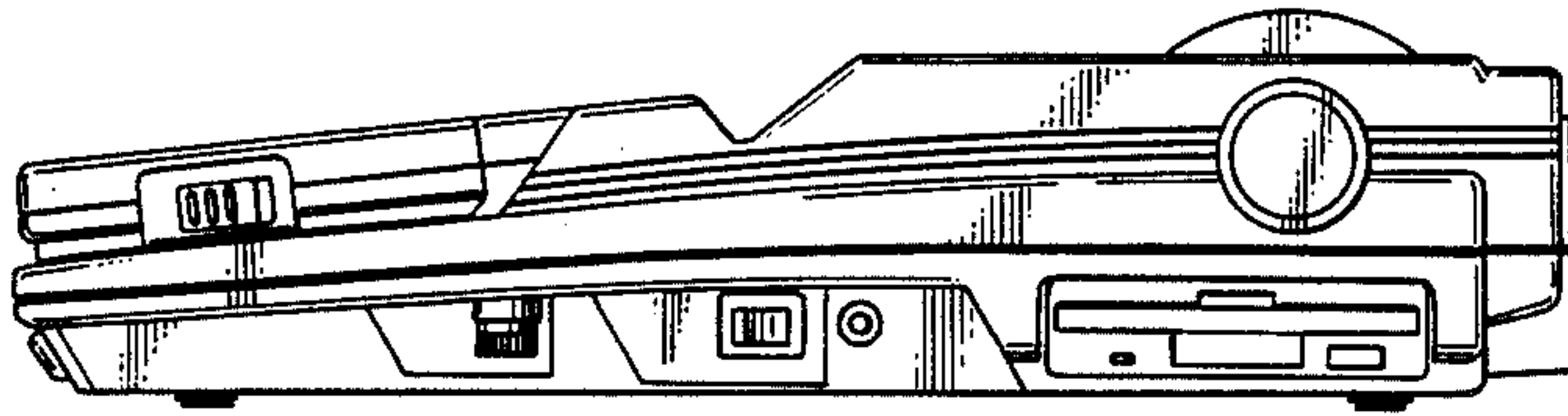
