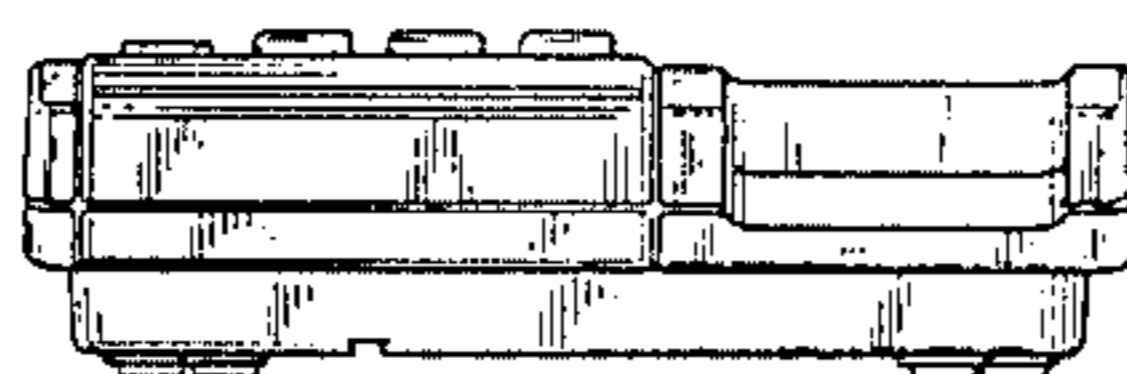
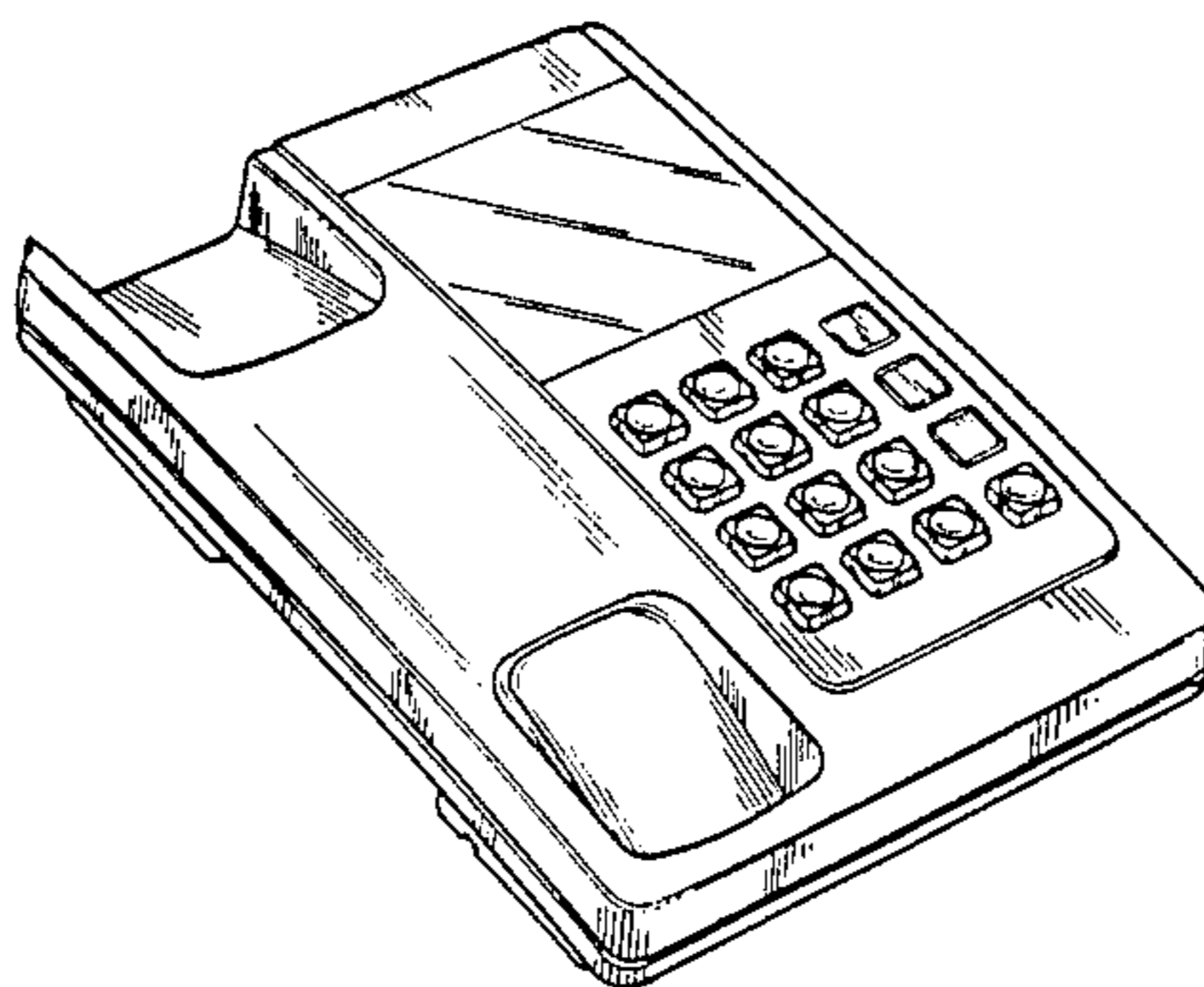

[57] CLAIM

The ornamental design for a telephone base unit, as shown and described.

DESCRIPTION

FIG. 1 is front, top and right side perspective view of a telephone instrument base showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side elevational view thereof, the side opposite being substantially a mirror image; and FIG. 4 is a bottom plan view thereof.



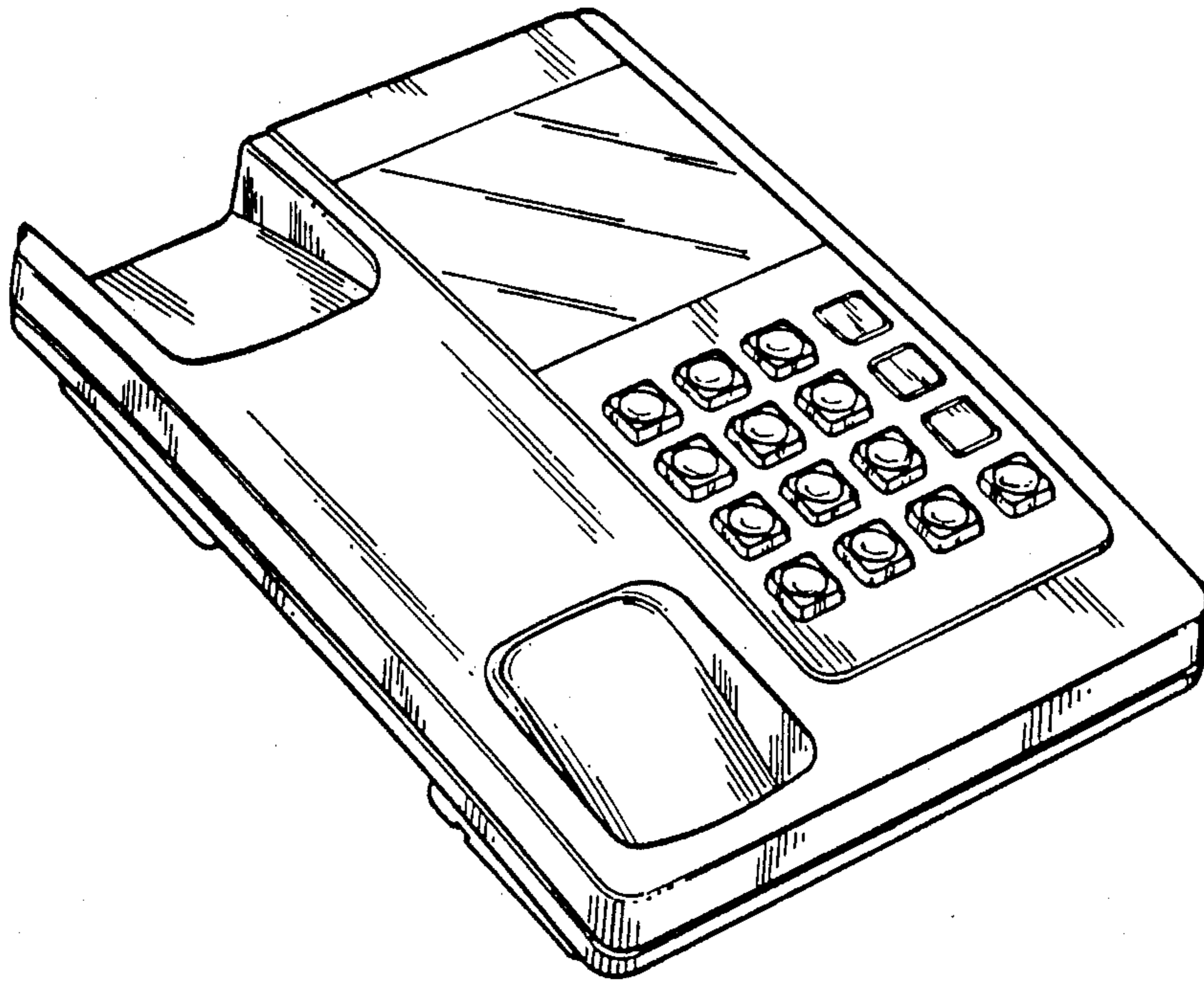

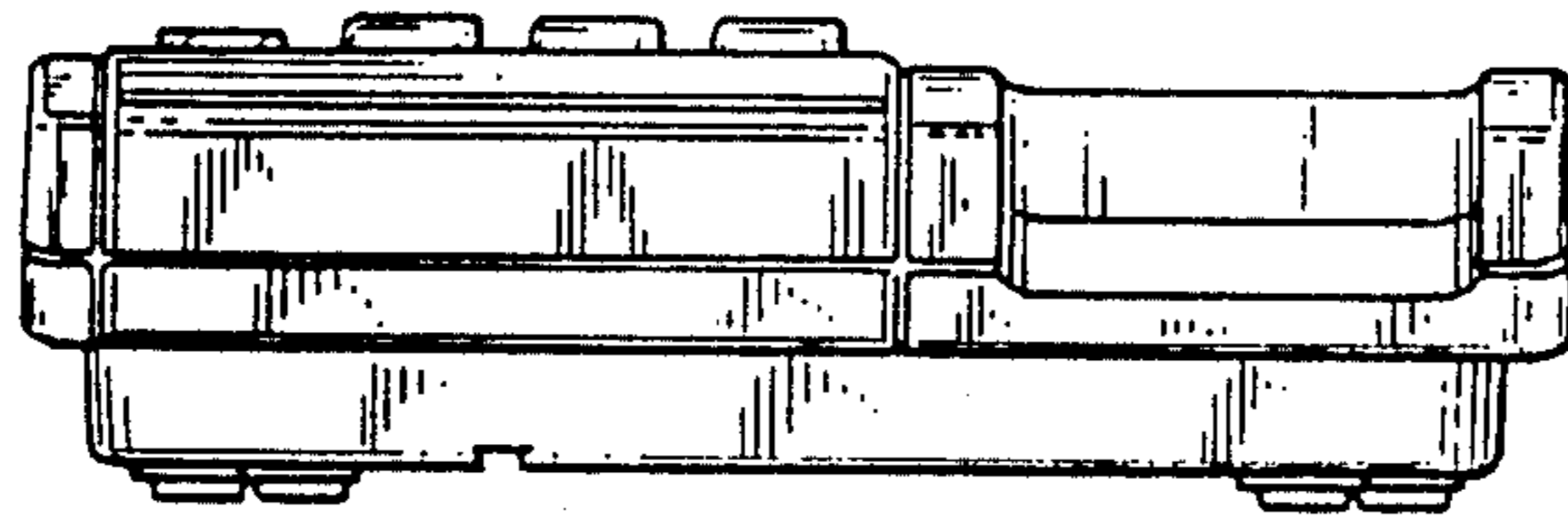

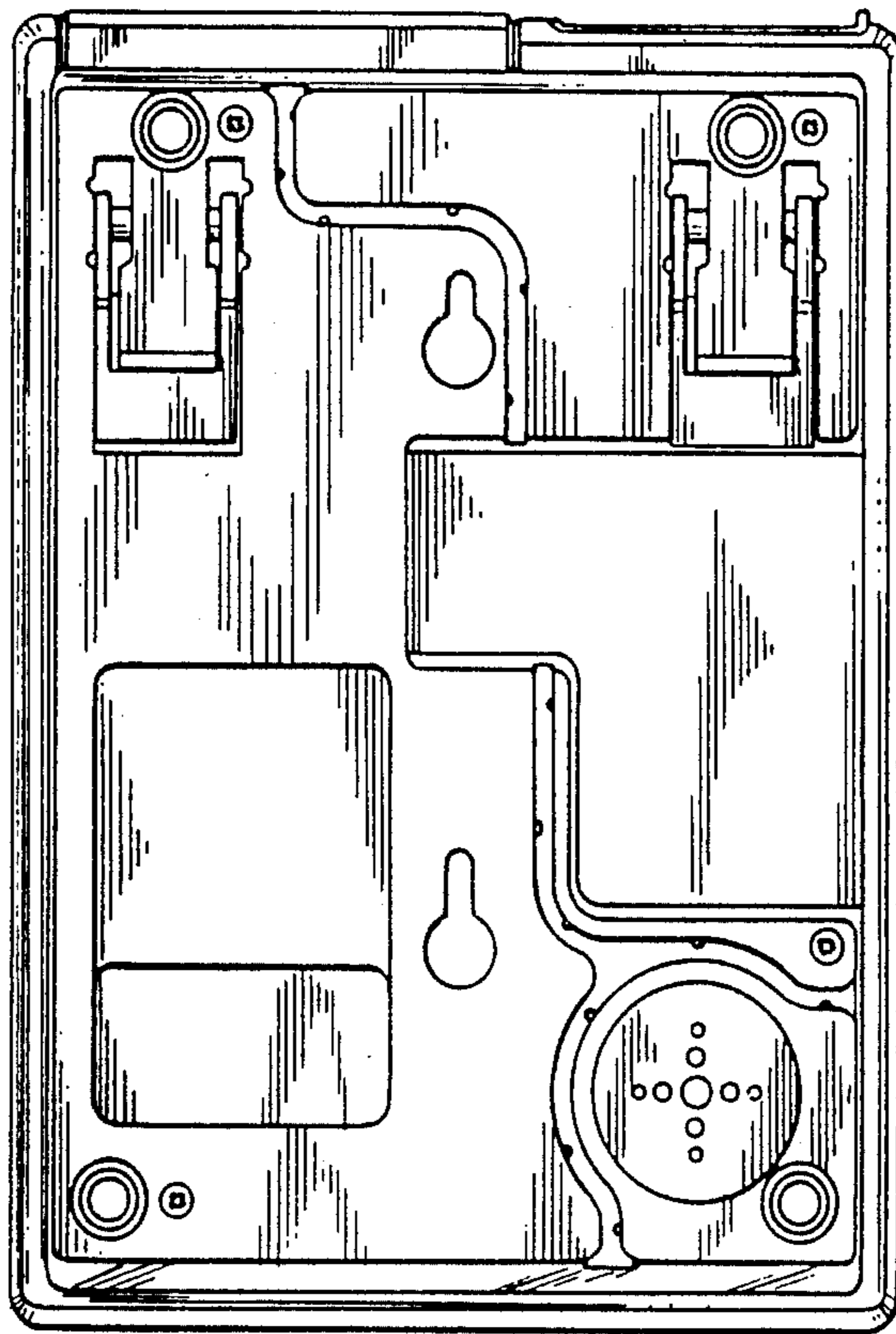

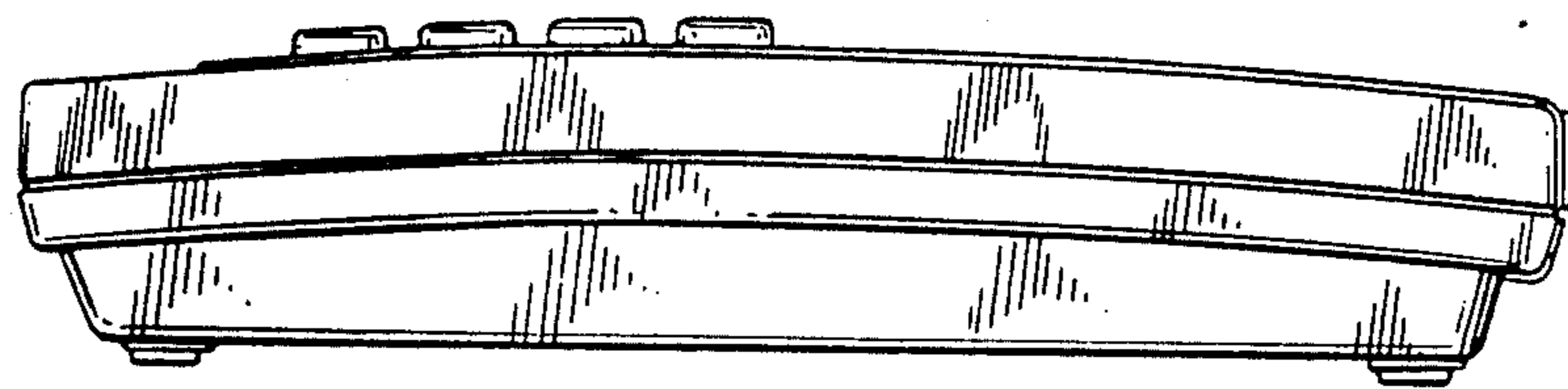
