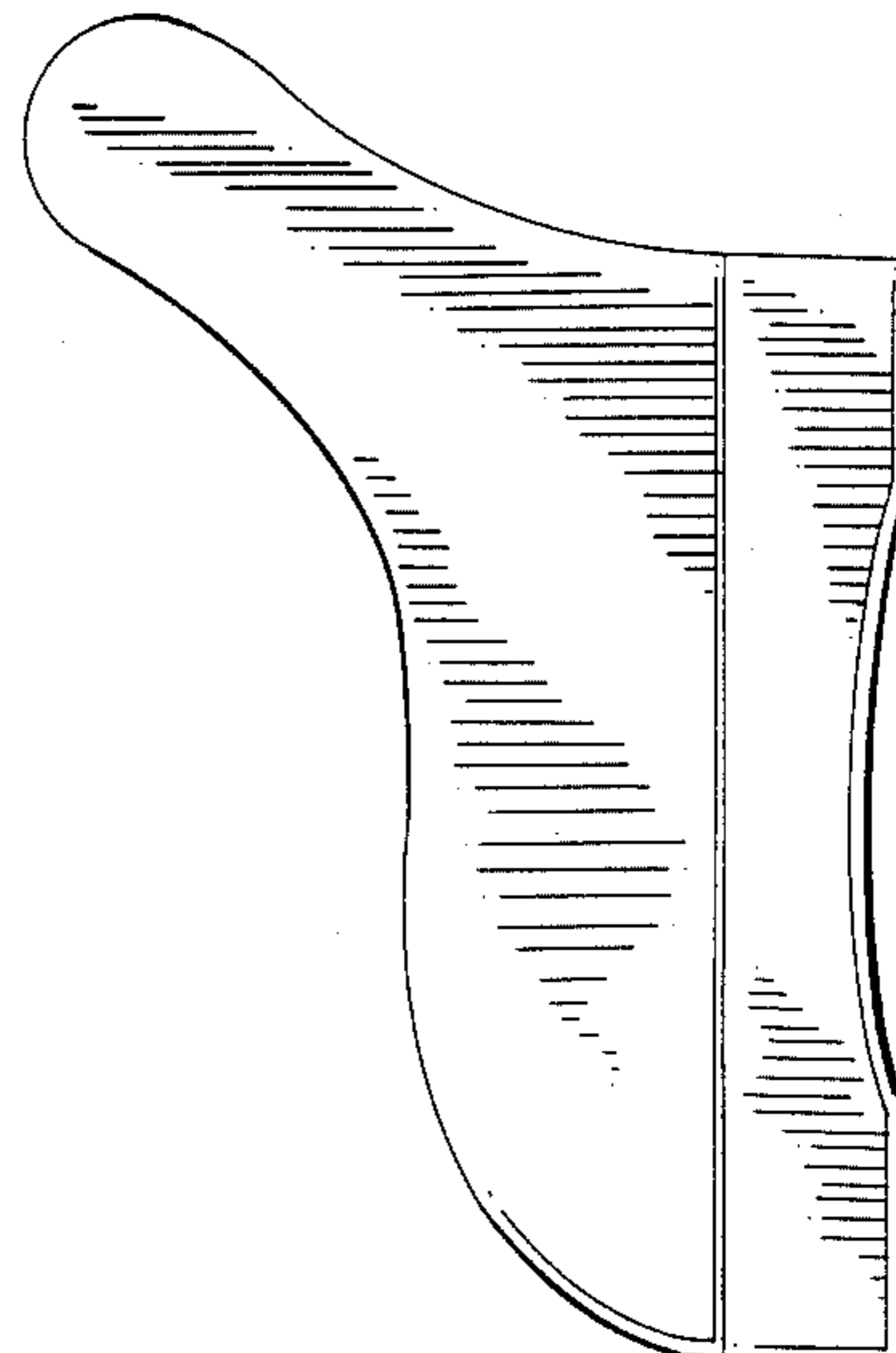
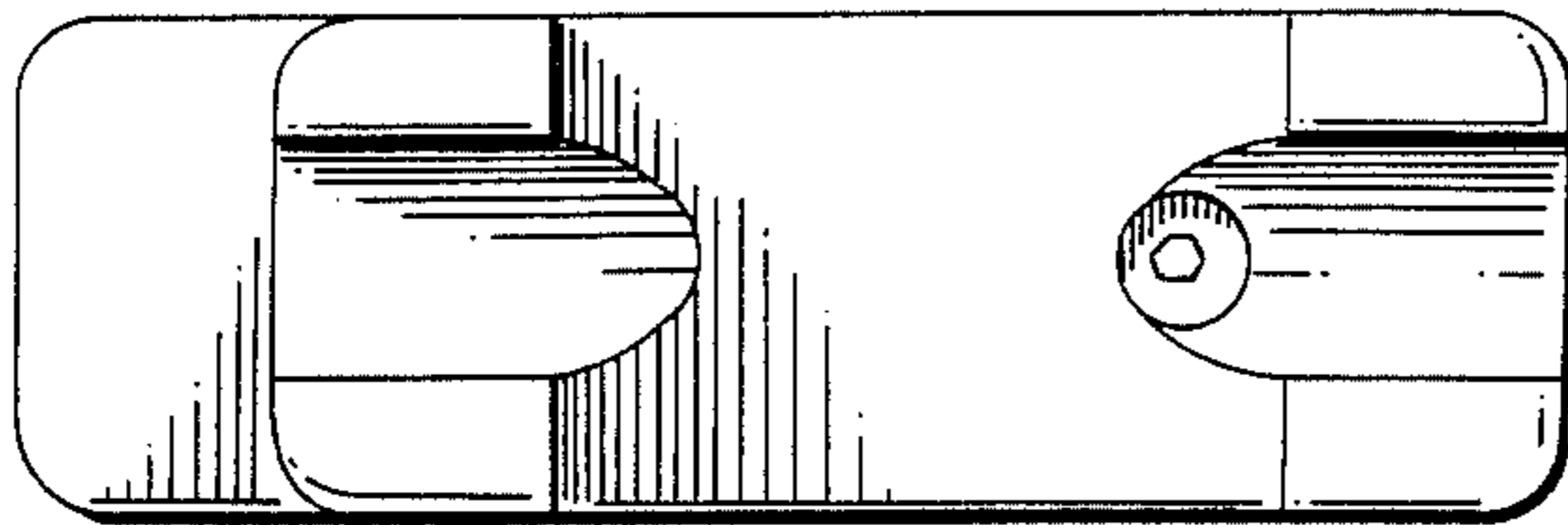
FIG. 4 is a bottom plan view thereof;

FIG. 5 is a side view taken from the right of FIG. 1;

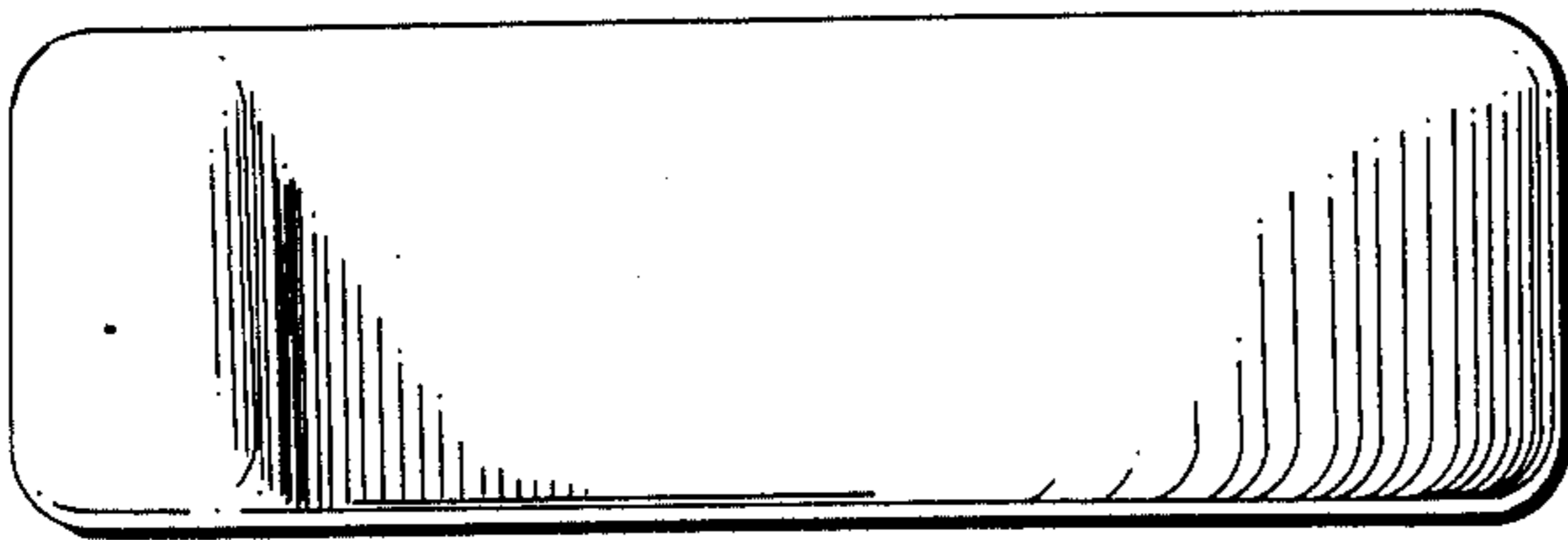
FIG. 6 is a view of the side opposite to FIG. 5;

FIG. 7 is a top and side view perspective view thereof; and

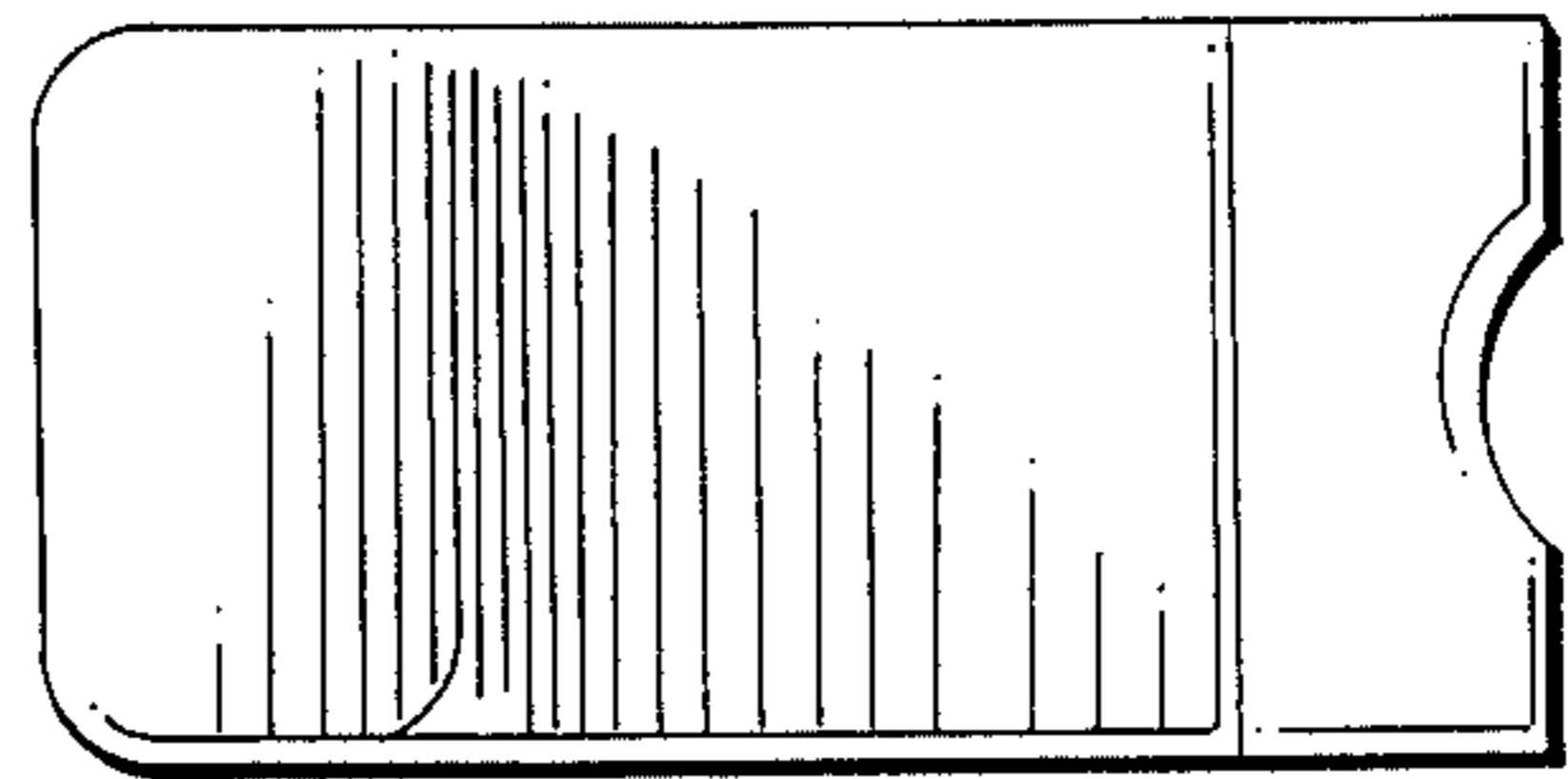
FIG. 8 is a bottom and opposite side perspective view thereof.



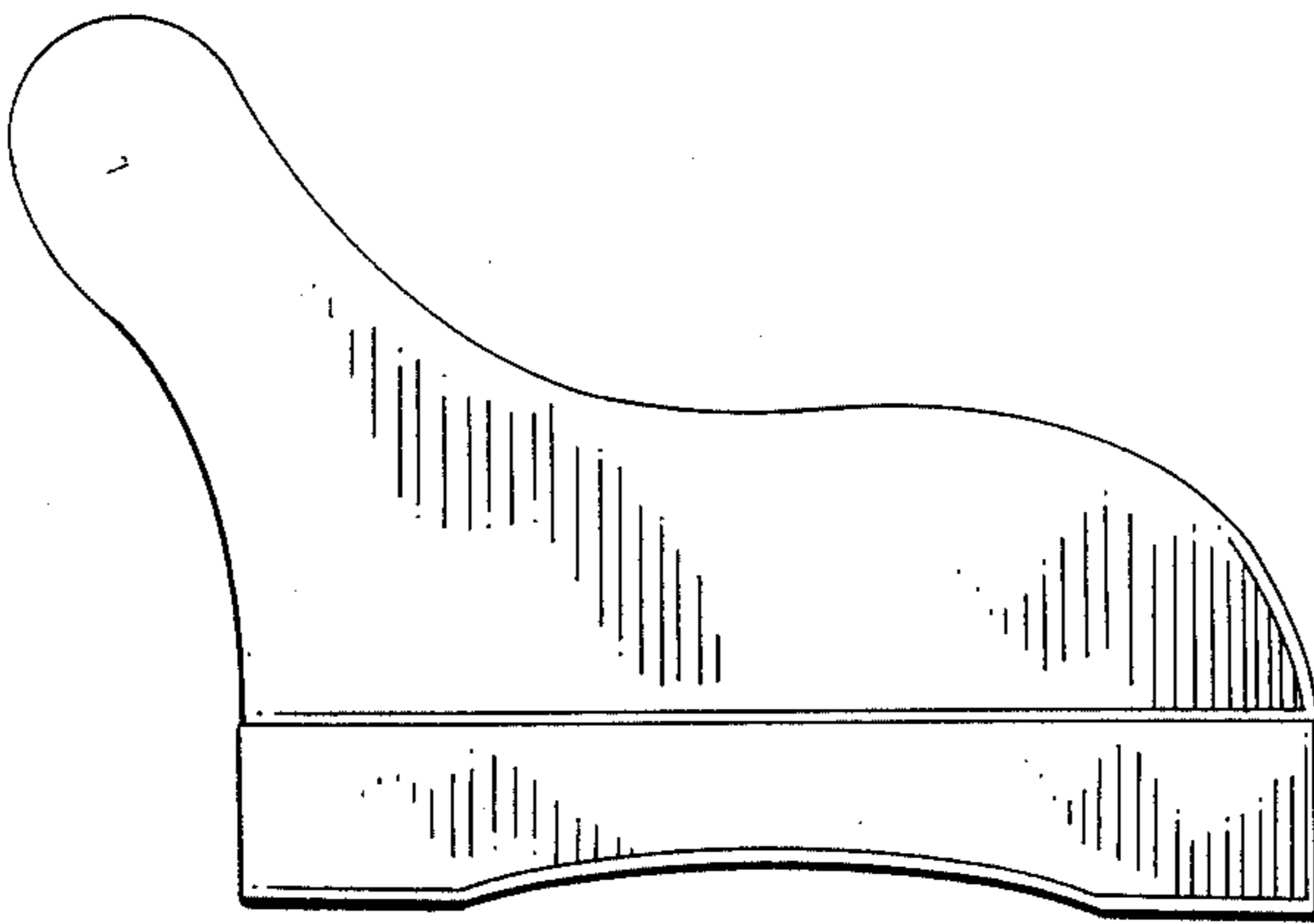

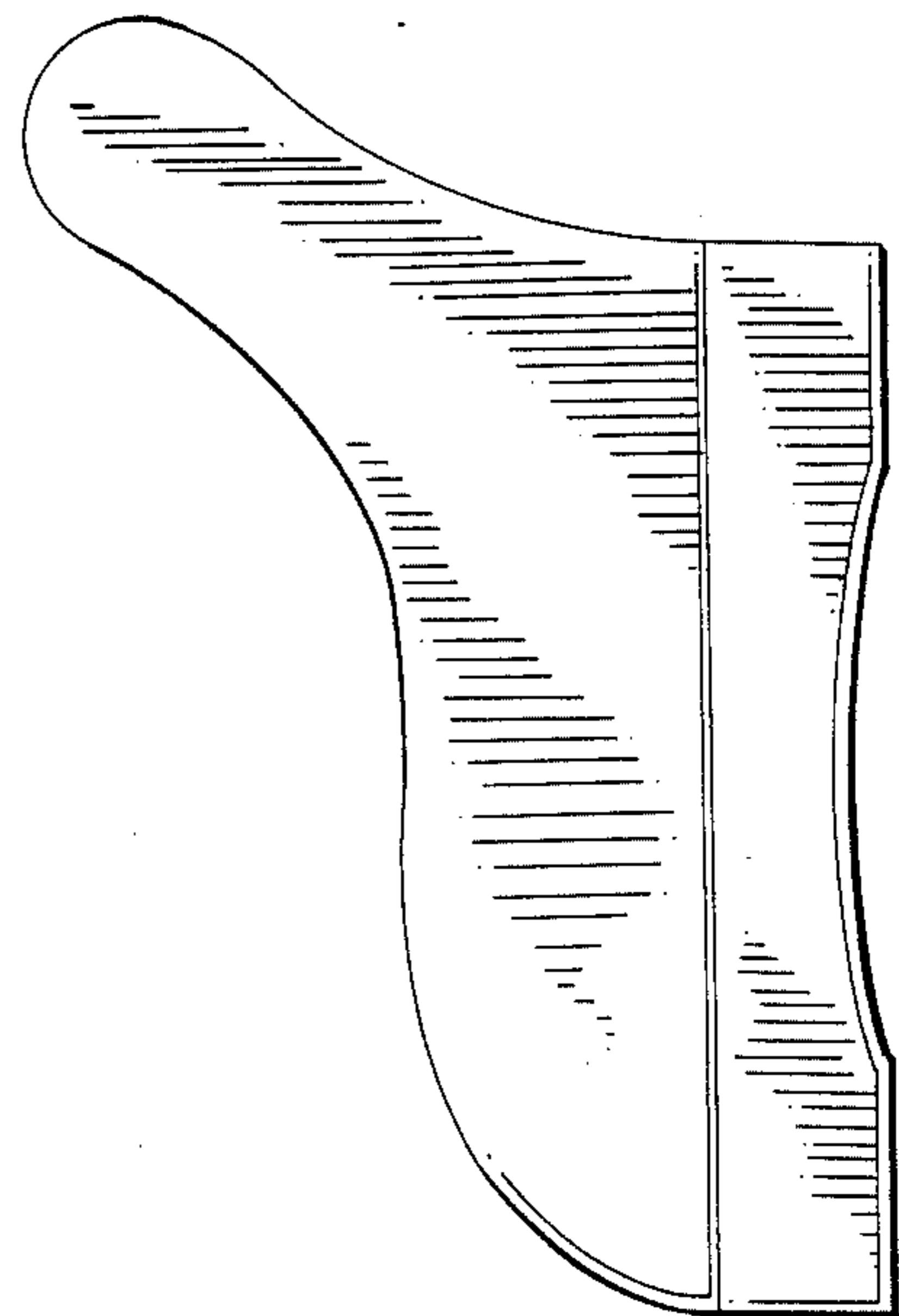

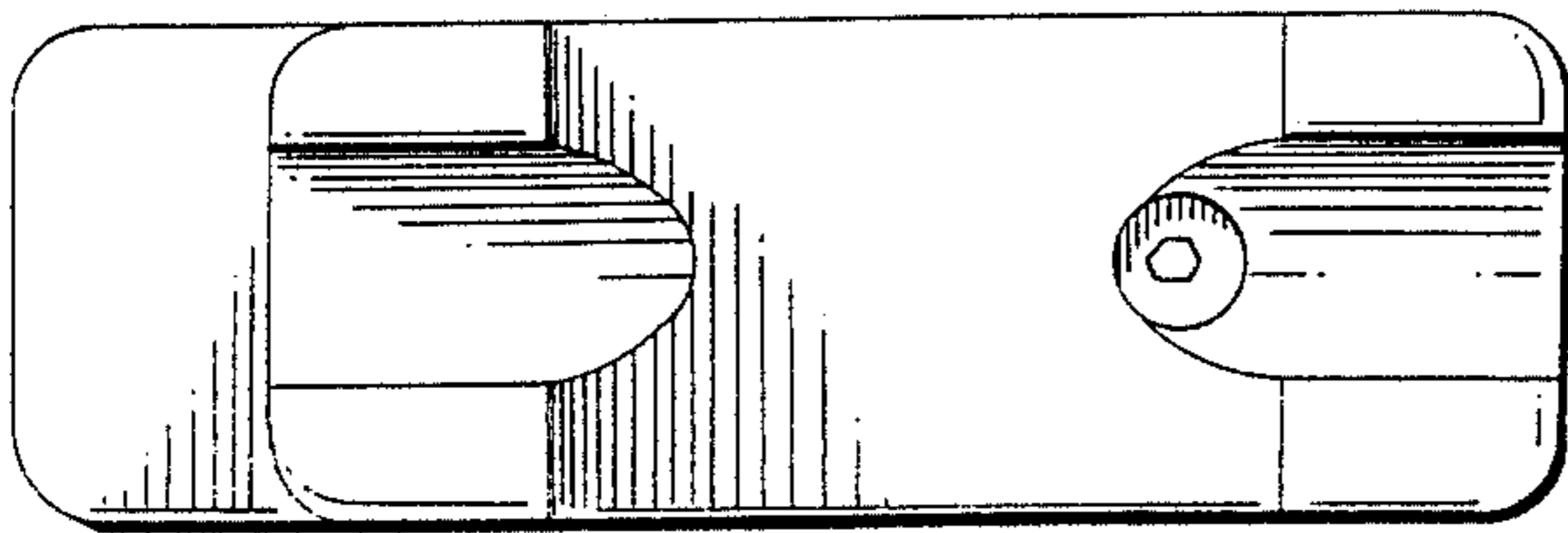

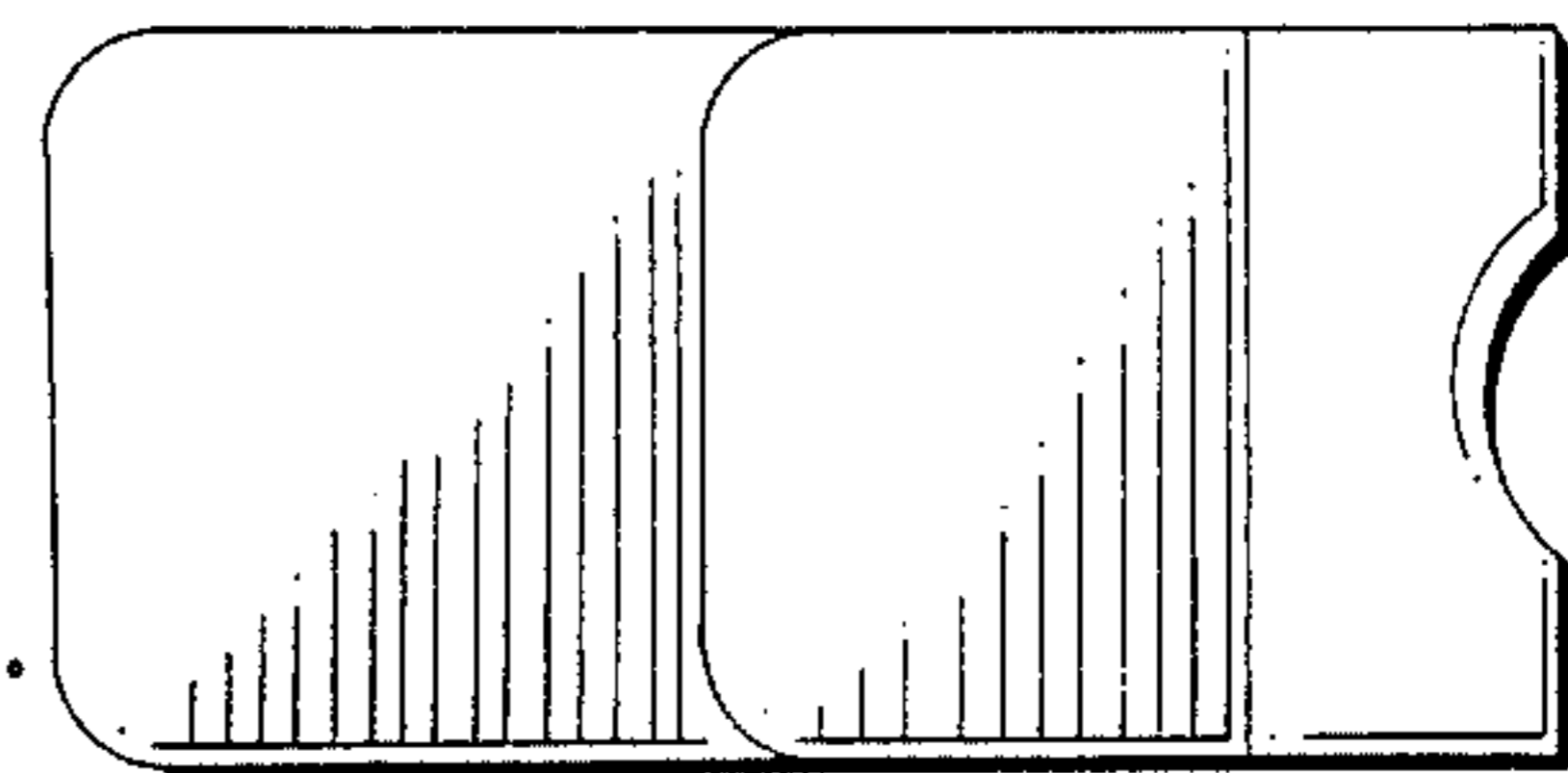

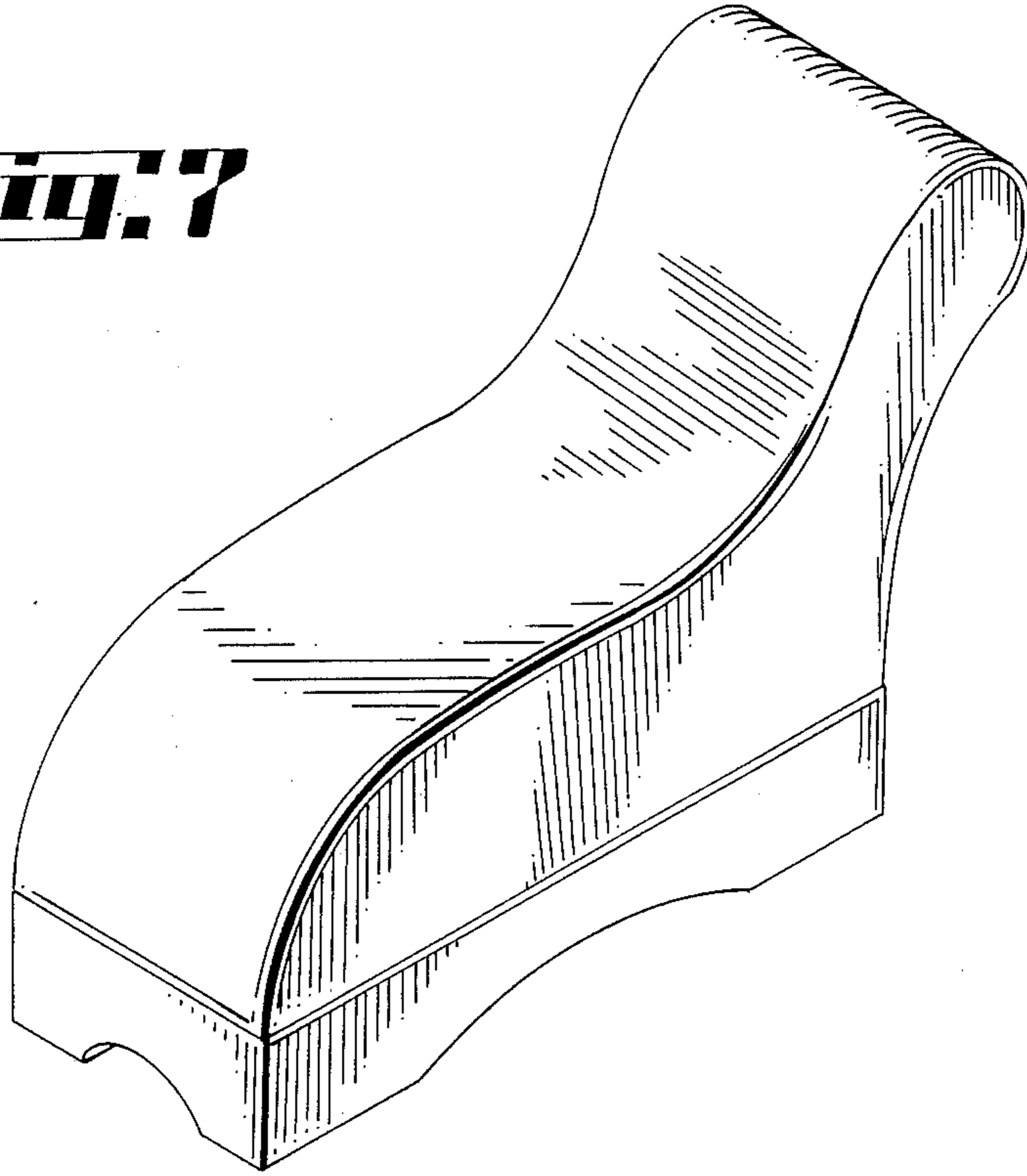
