The ornamental design for a clipboard, as shown and described.

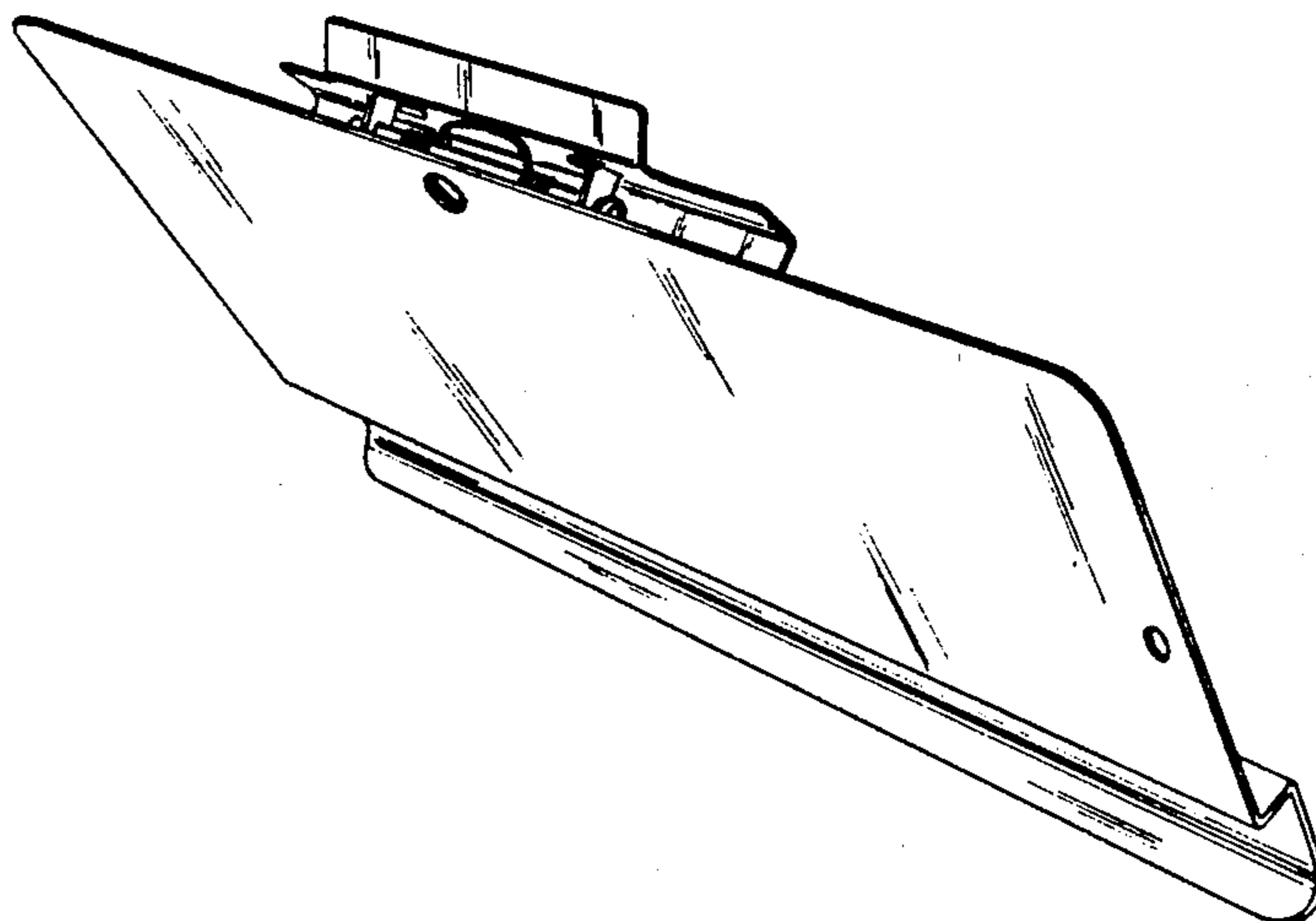
DESCRIPTION

FIG. 1 is a front perspective view of a clipboard showing my new design;

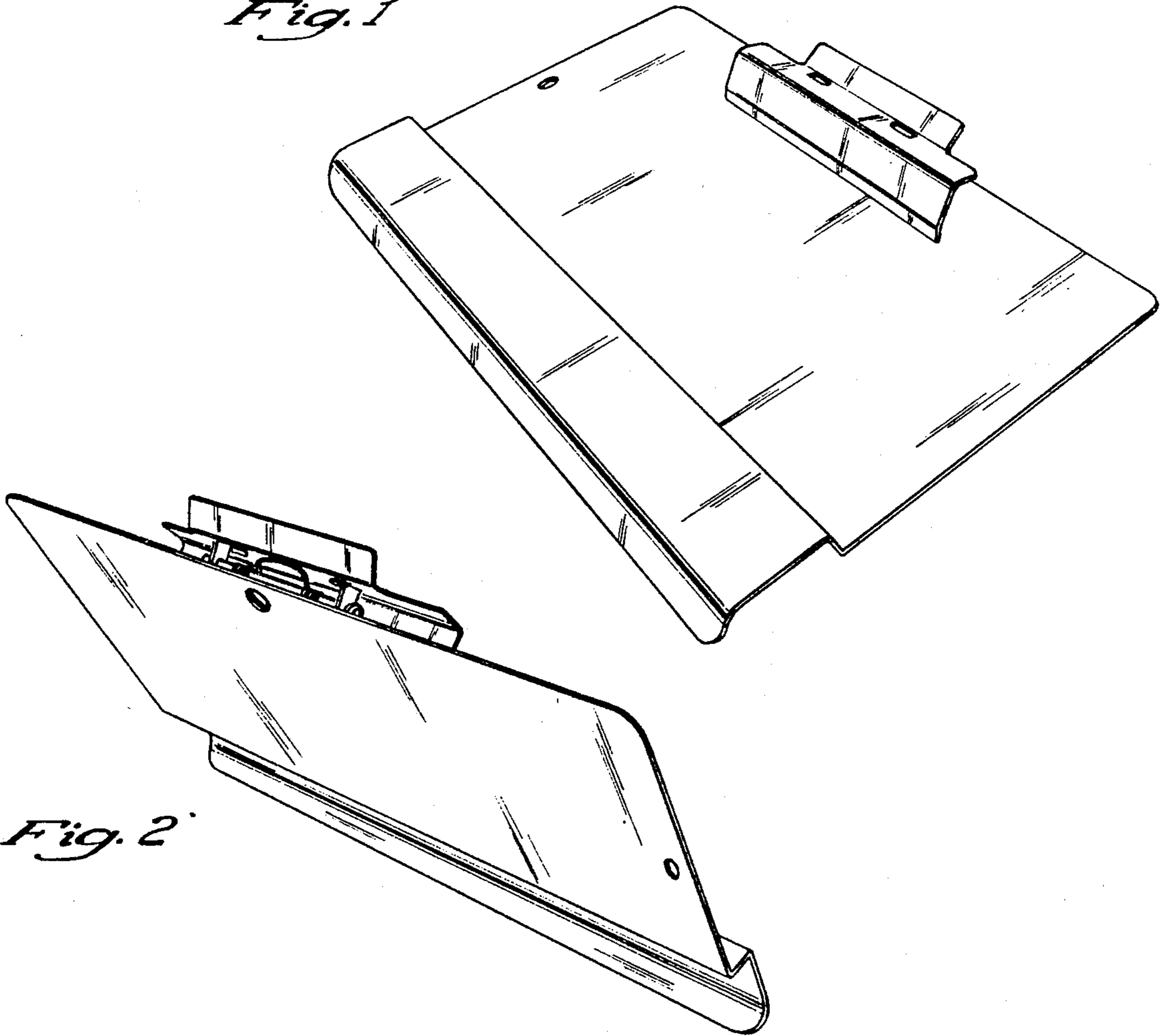
FIG. 2 is a rear perspective view;

FIG. 3 is a front elevational view; and

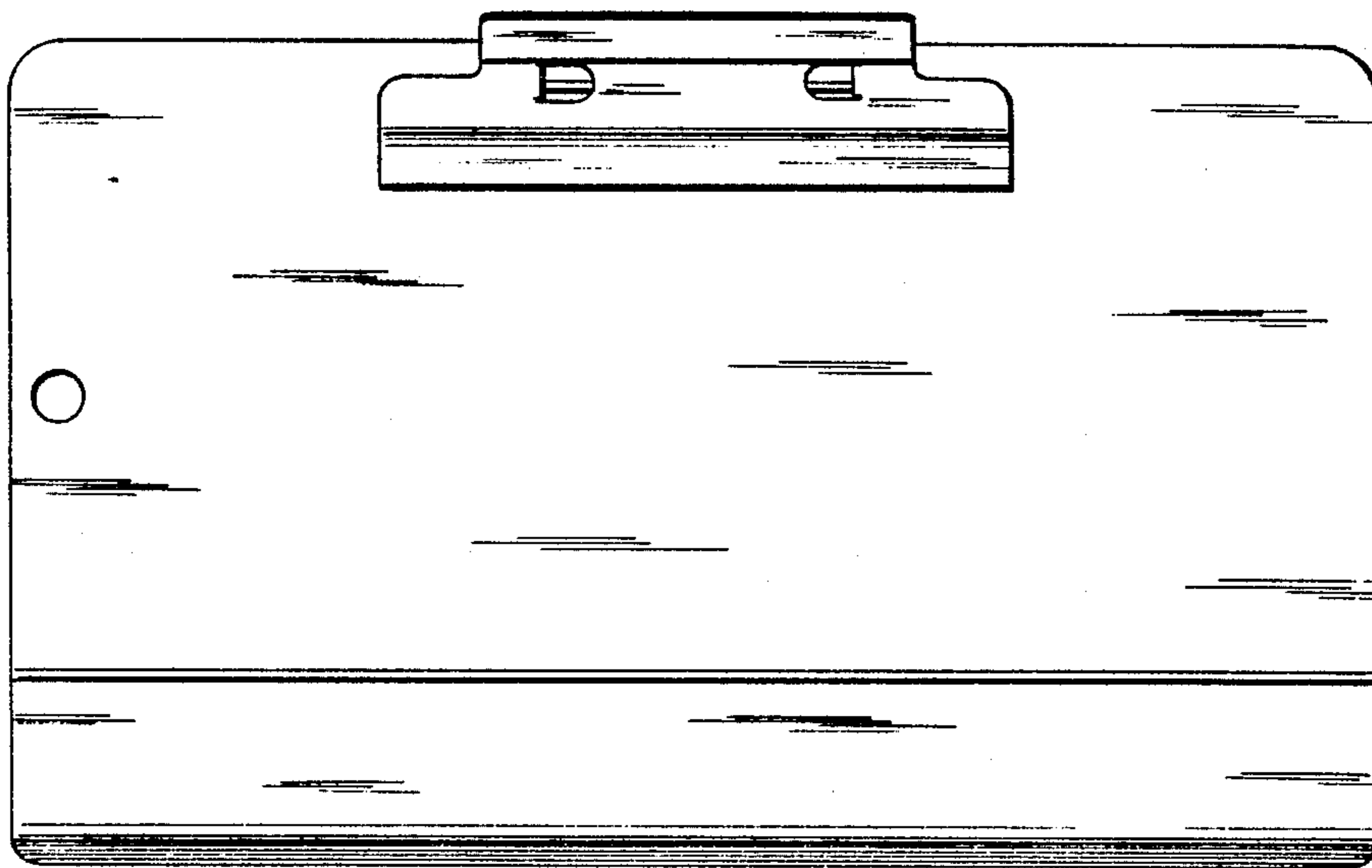
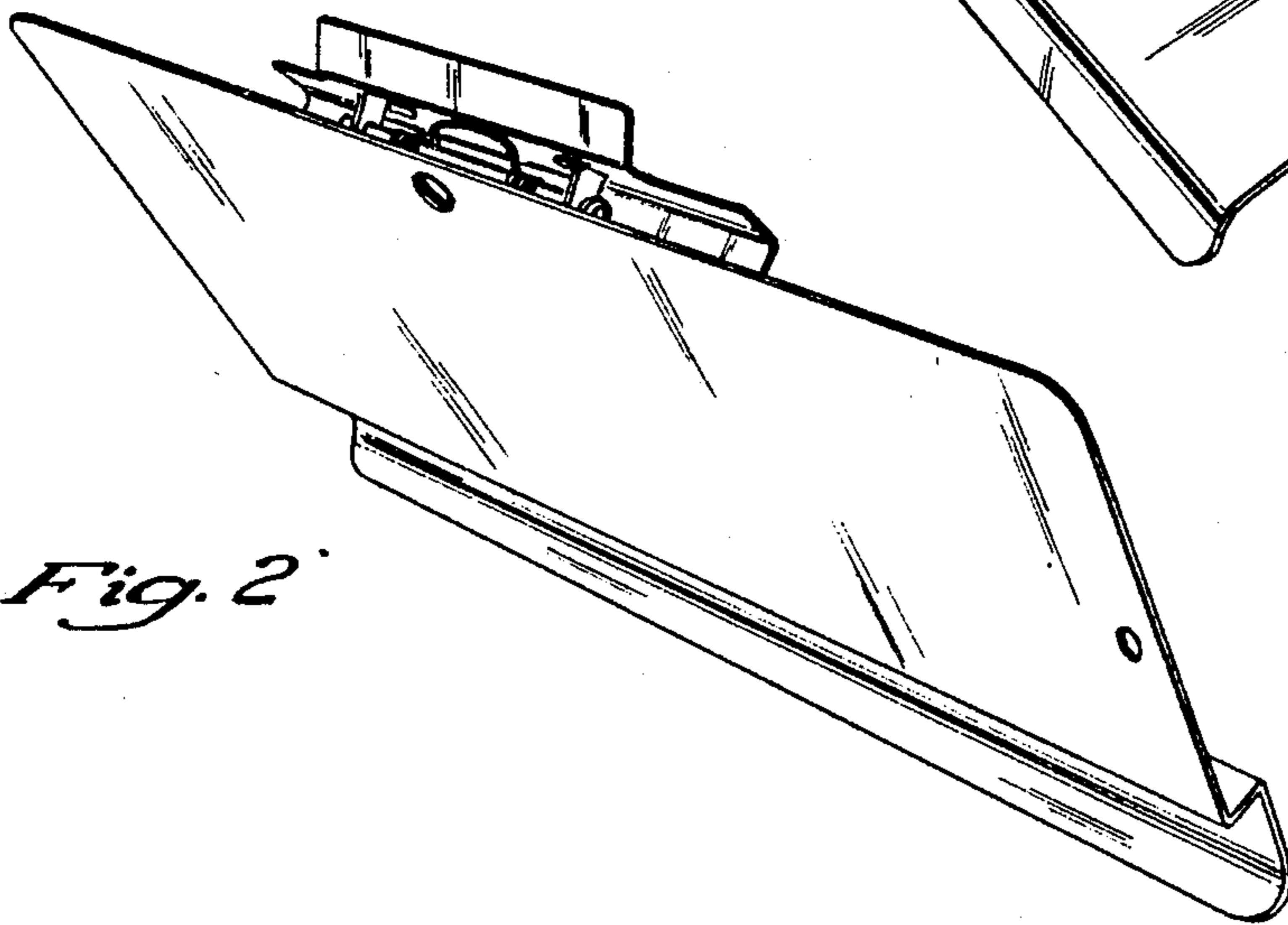
FIG. 4 is a side elevational view thereof.



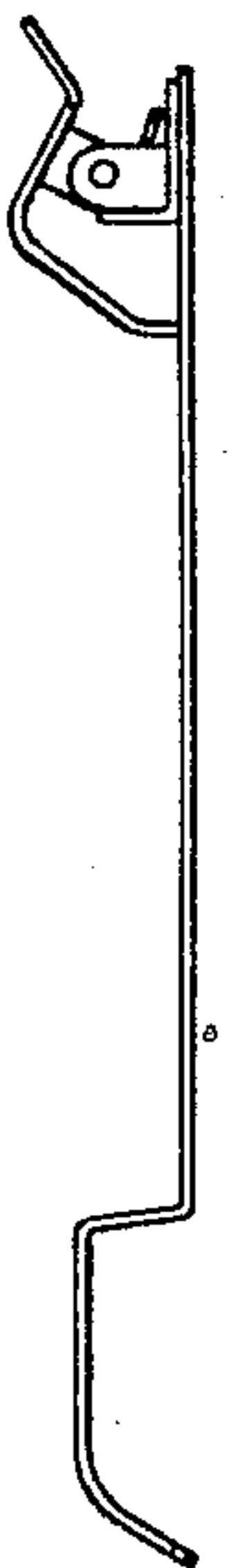
