[57] **CLAIM**

The ornamental design for a housing for article support racks, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a housing for article support rack showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view, the left side being a mirror image thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof;

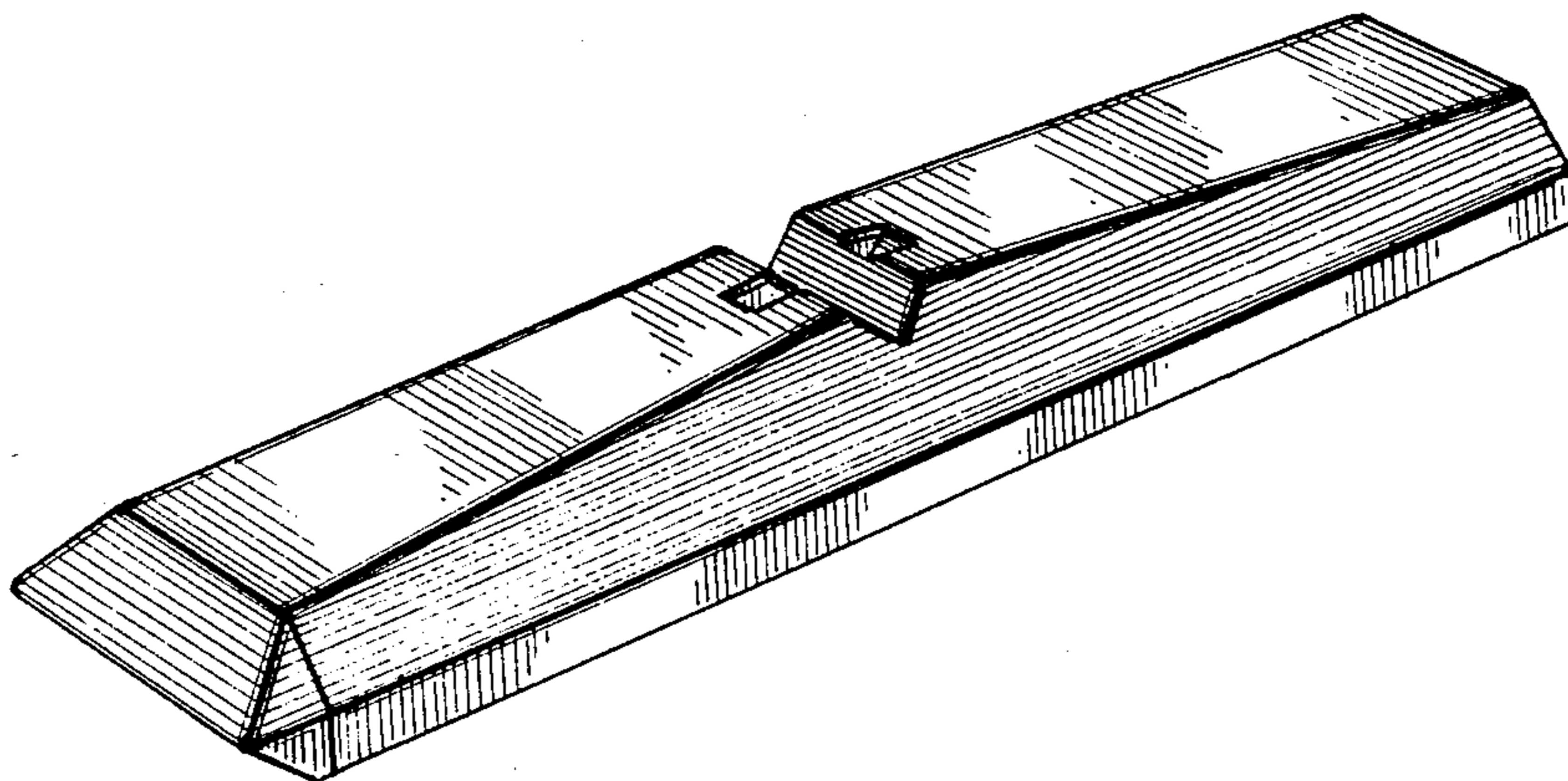
FIG. 7 is a top plan view of a second embodiment of the housing for article support racks shown in FIG. 1;

FIG. 8 is a right side elevational view, the left side being a mirror image thereof;

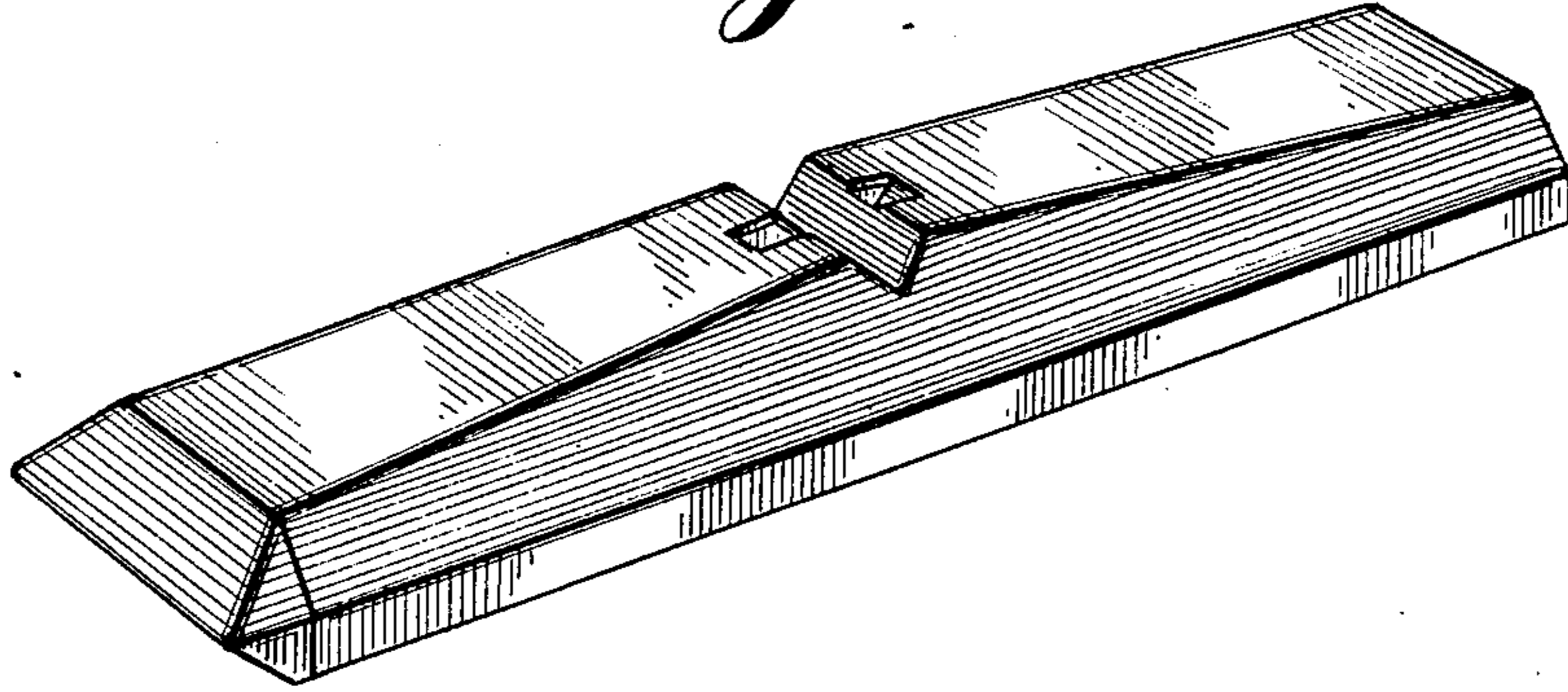
FIG. 9 is a bottom plan view thereof;

FIG. 10 is a front elevational view thereof; and

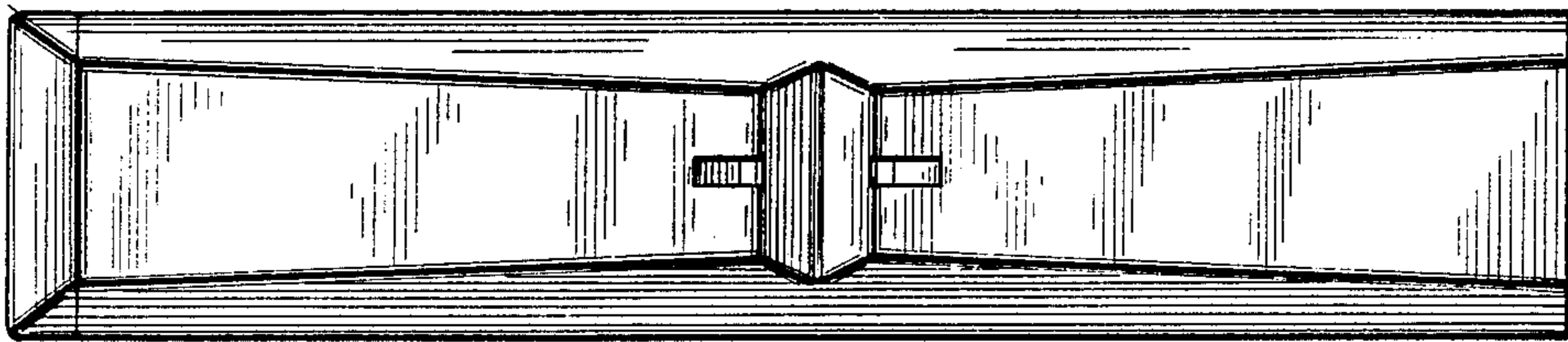
FIG. 11 is a rear elevational view thereof.

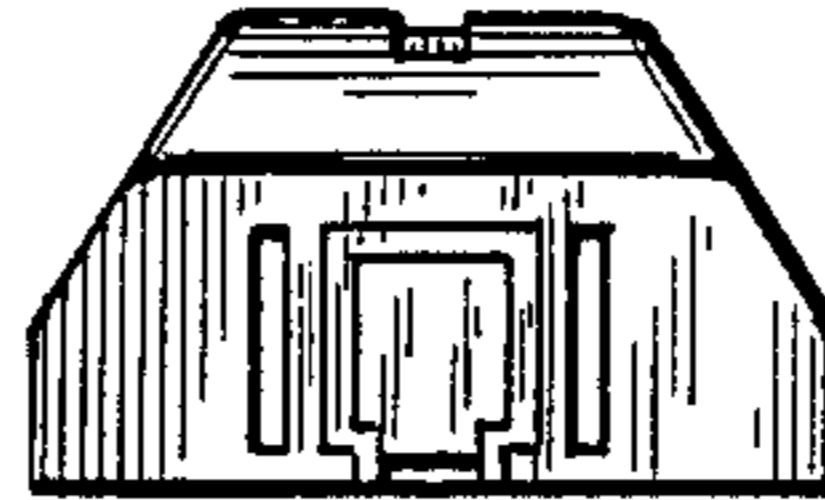

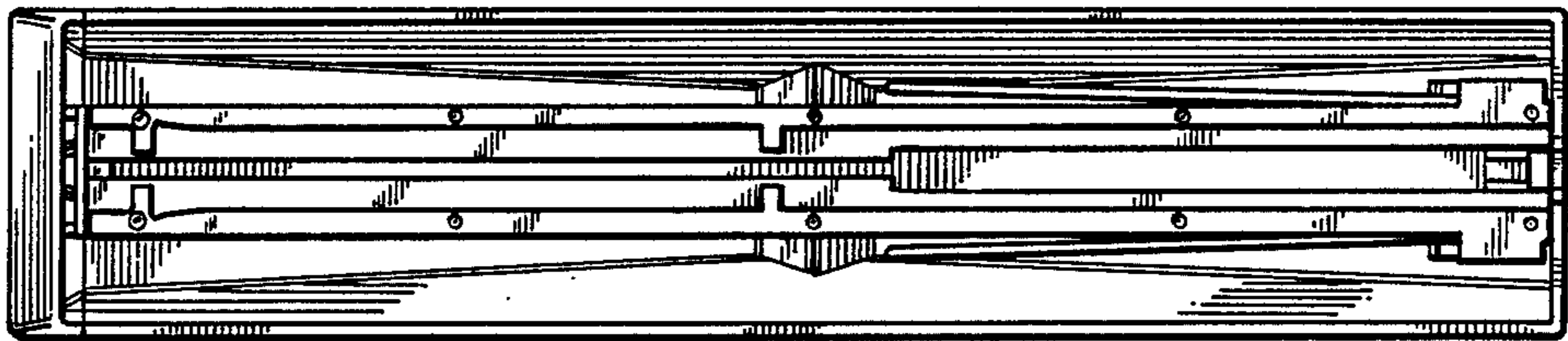

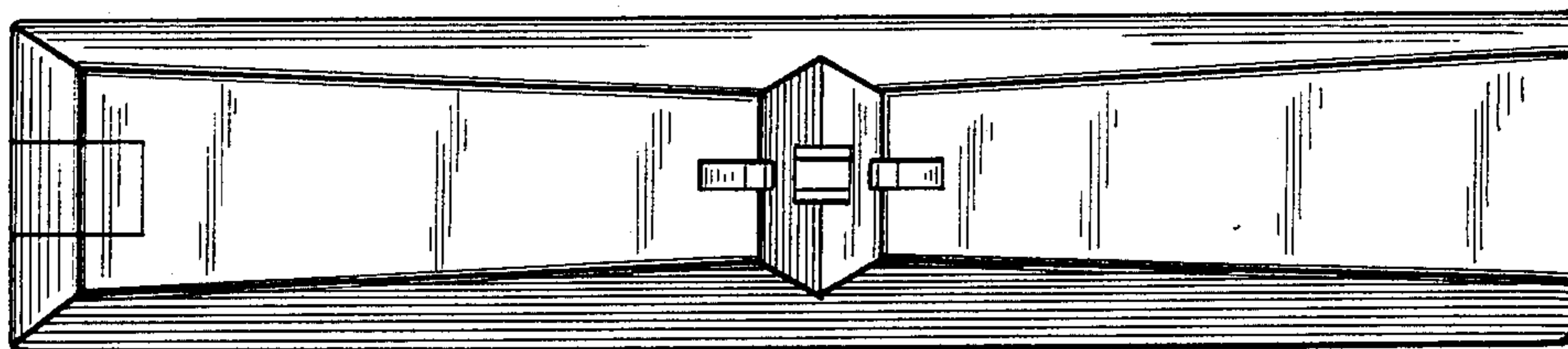

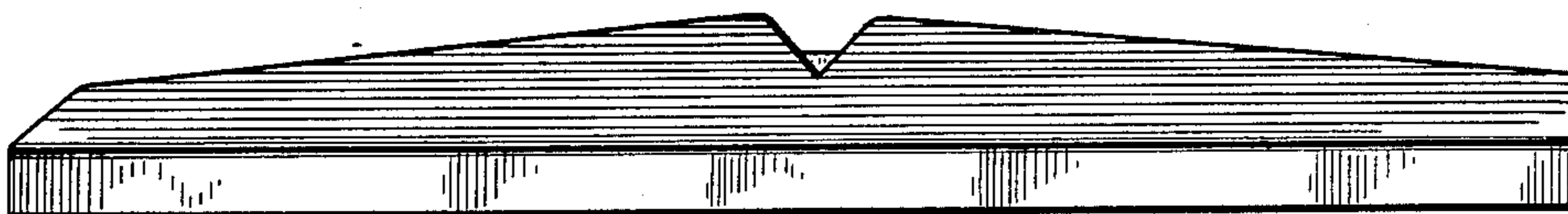

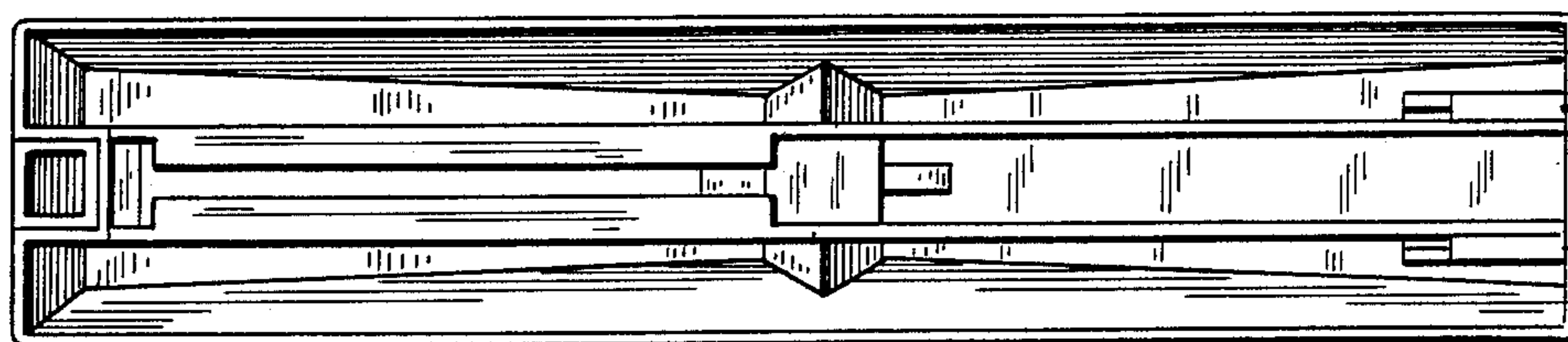

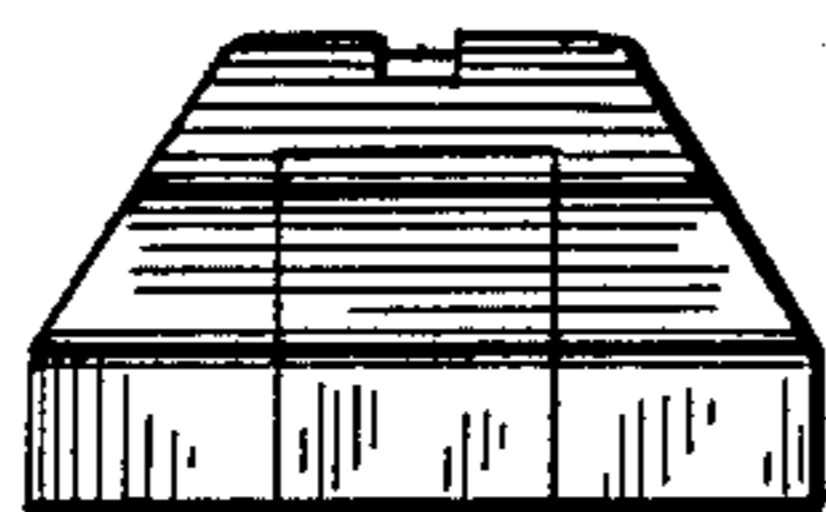
