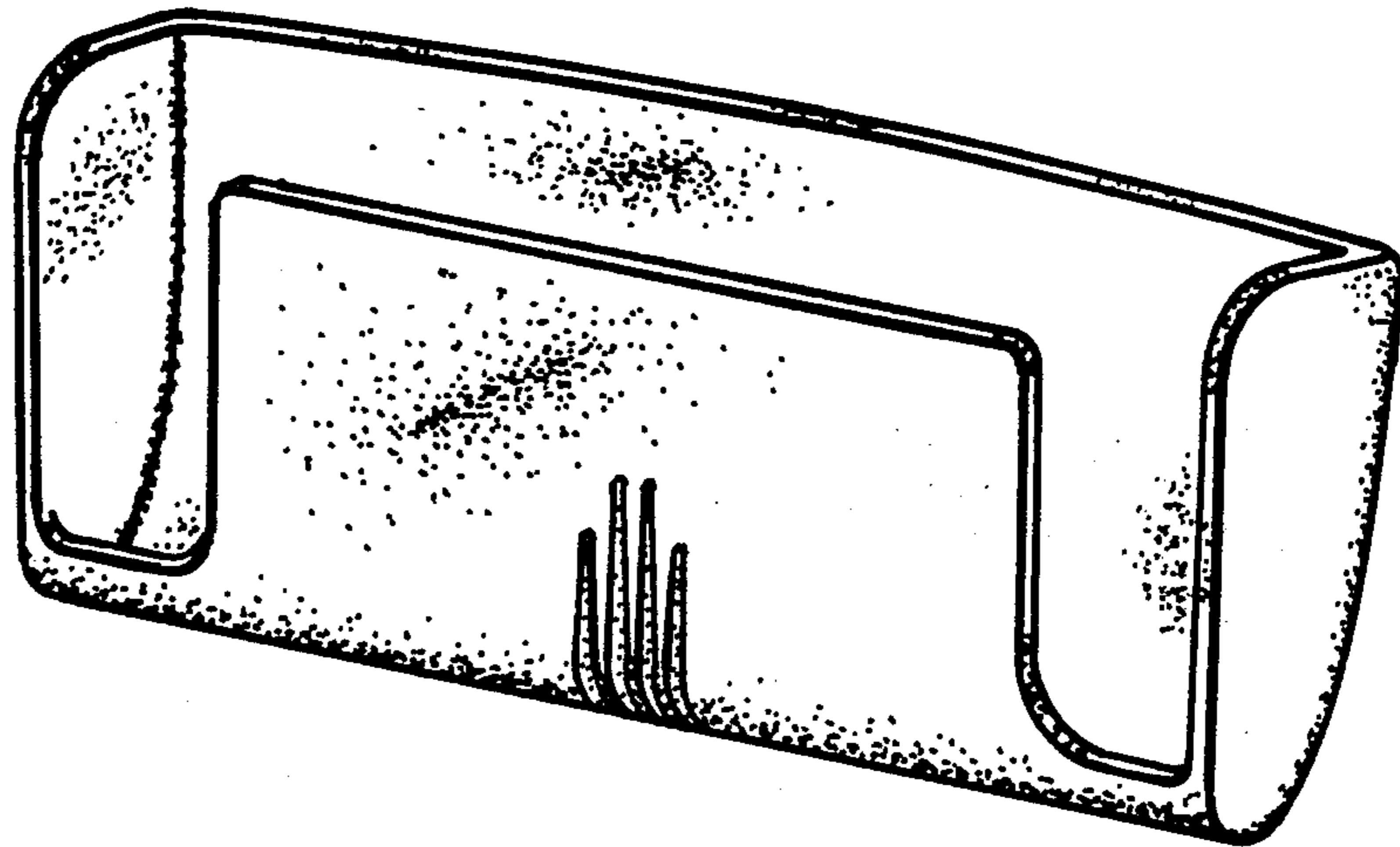
The ornamental design for a reinforcing insert for spectacle case, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a reinforcing insert for a spectacle case showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof; and  
 FIG. 7 is a cross-sectional view taken on line 7—7 of FIG. 2.

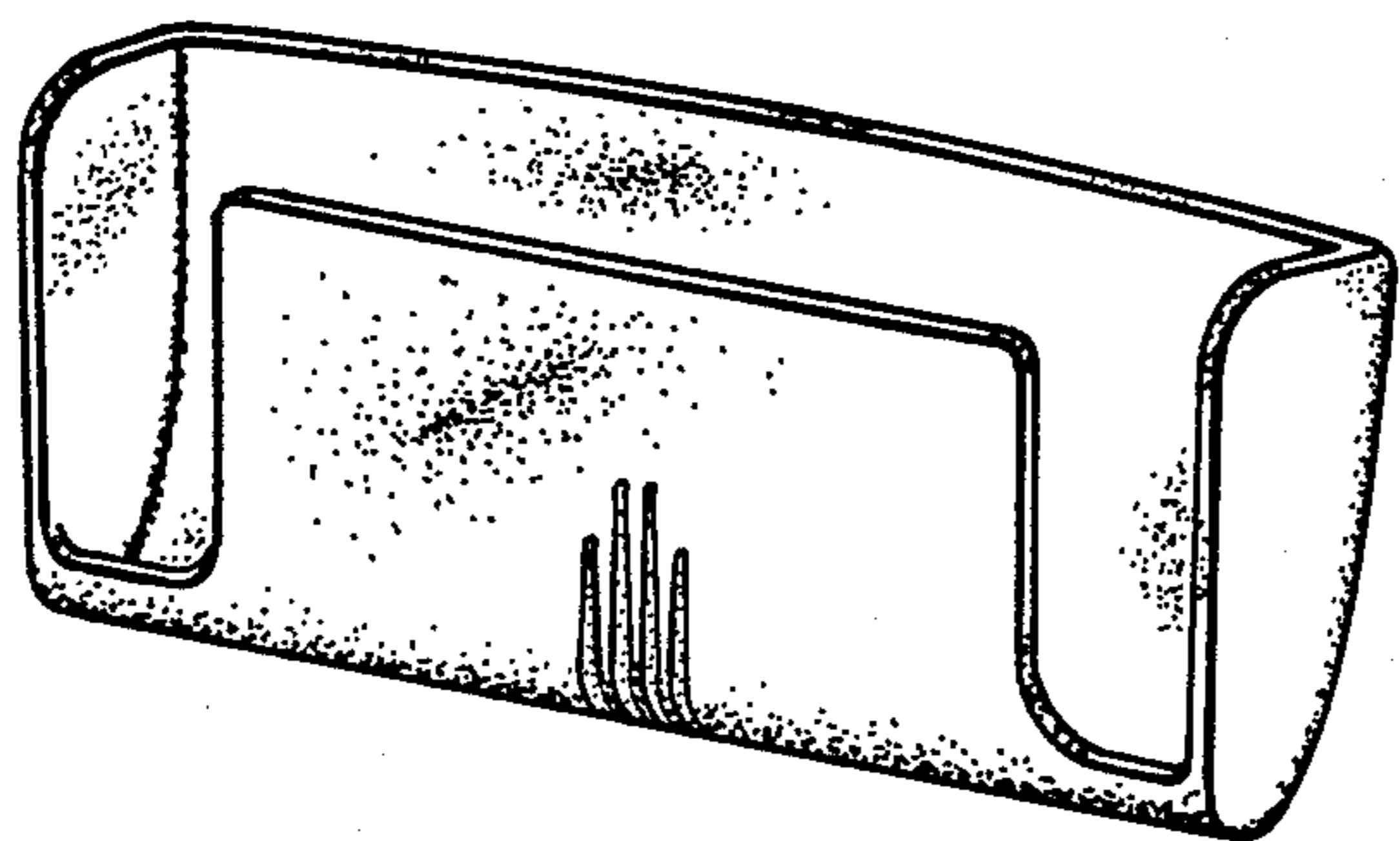
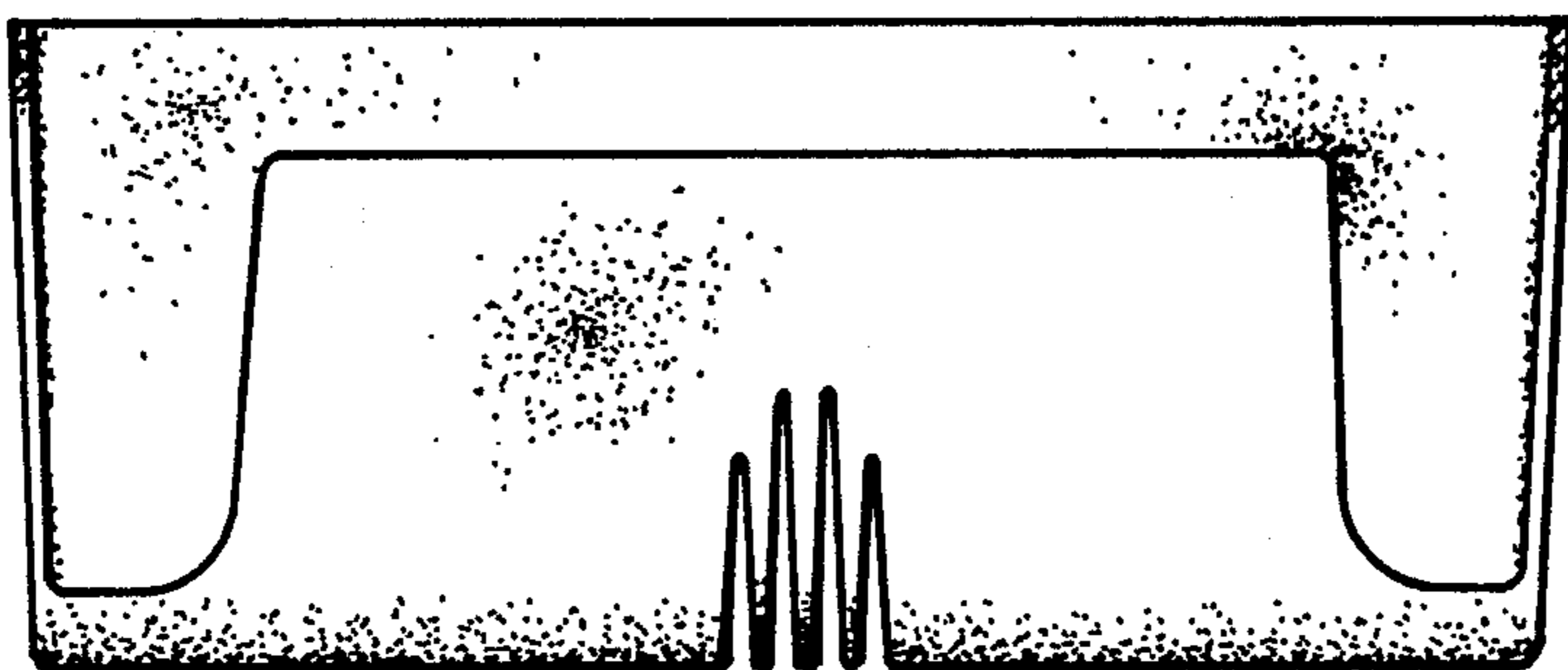

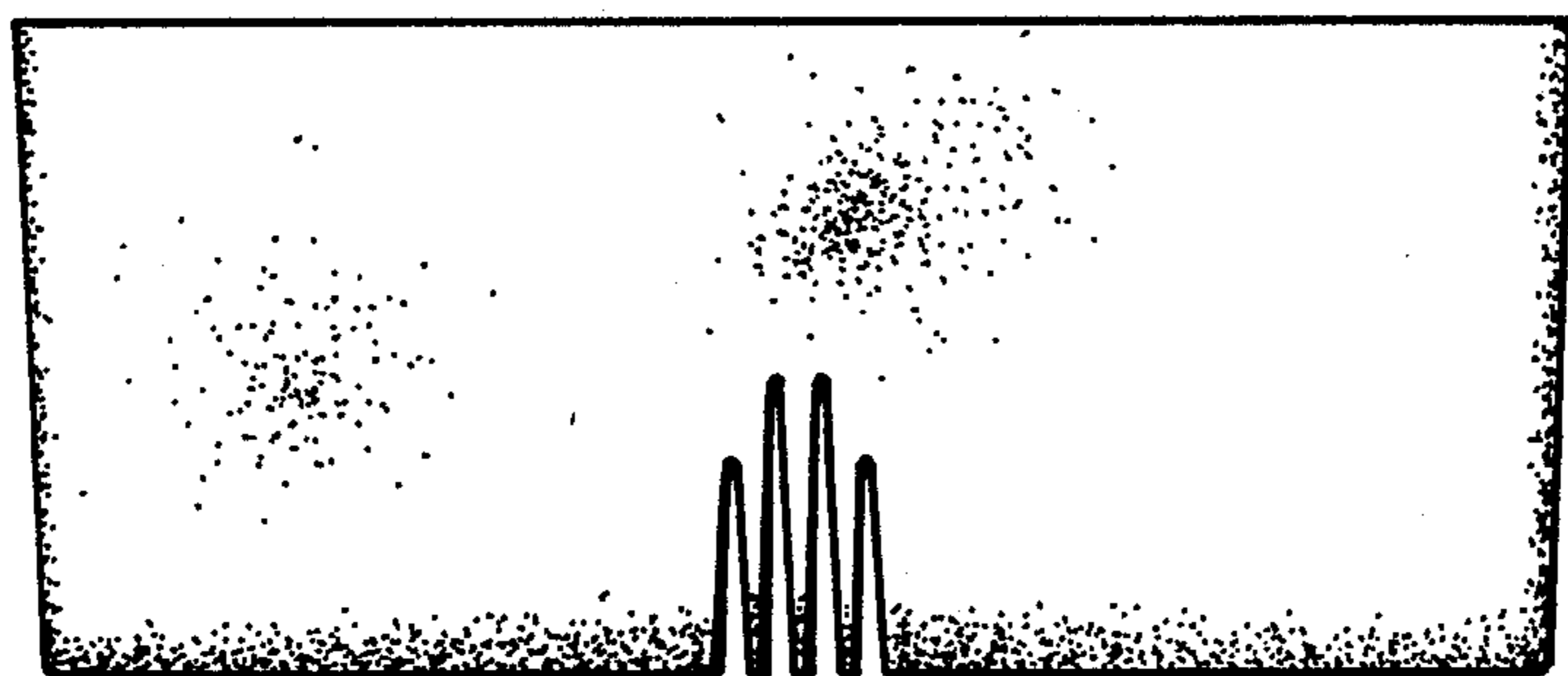

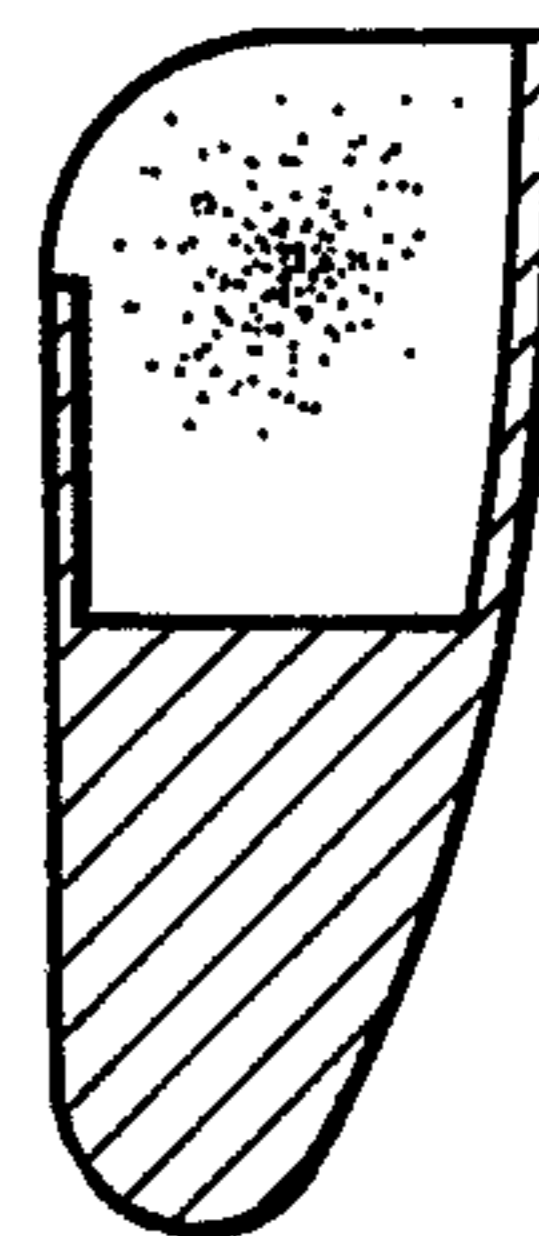
