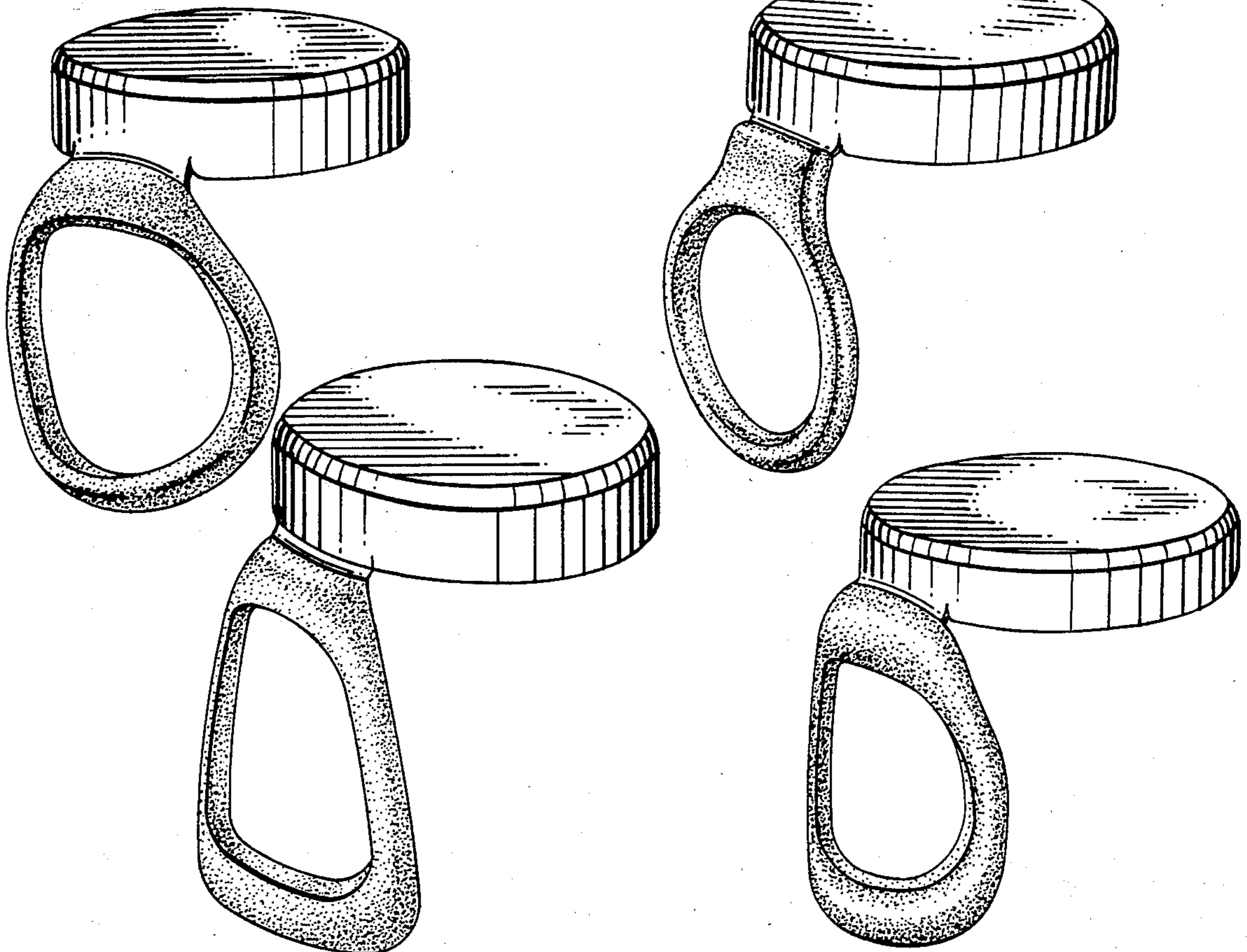

The ornamental design for a tear strip cap for bottles, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a tear strip cap for bottles showing my new design;
 FIG. 2 is a side elevational view, the opposite side being a mirror image;
 FIG. 3 is a perspective view, shown in an inverted position;
 FIG. 4 is a perspective view of a tear strip cap for bottles showing a second embodiment of my new design;
 FIG. 5 is a side elevational view of the opposite side being a mirror image;
 FIG. 6 is a perspective view, shown in an inverted position;
 FIG. 7 is a perspective view of a tear strip cap for bottles showing a third embodiment of my new design;
 FIG. 8 is a side elevational view, the opposite side being a mirror image;

 FIG. 12 is a perspective view, shown in an inverted position.



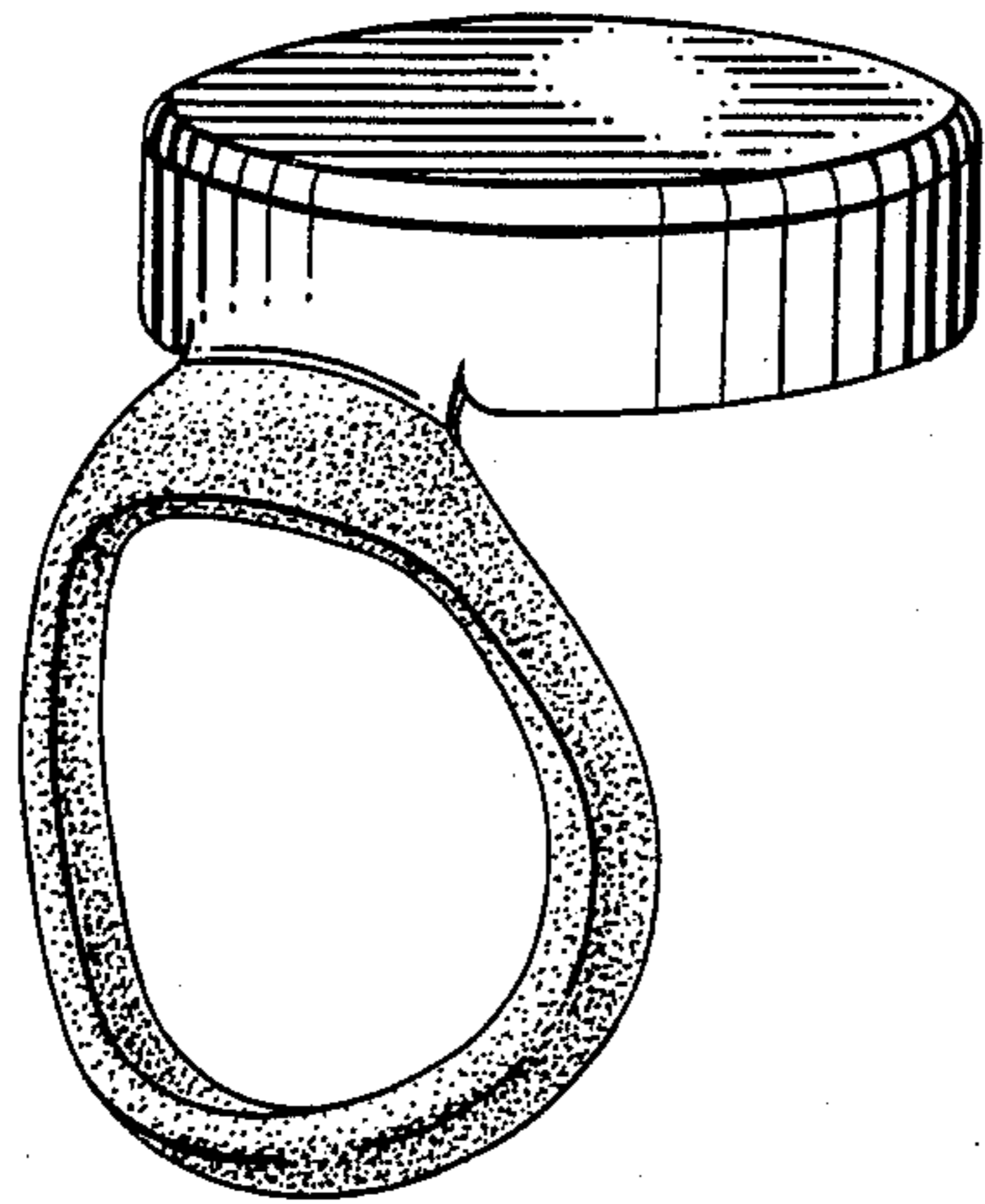

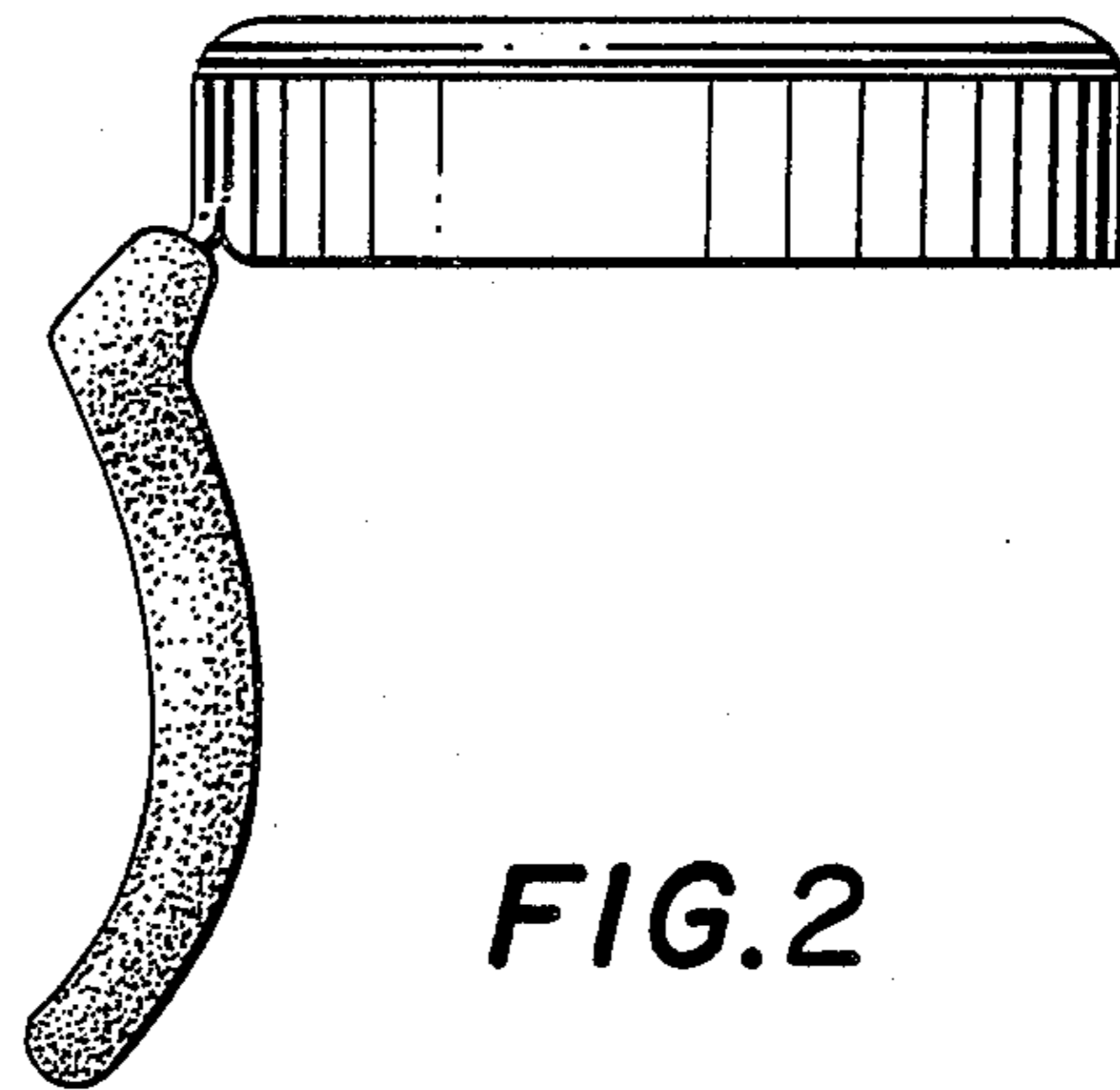

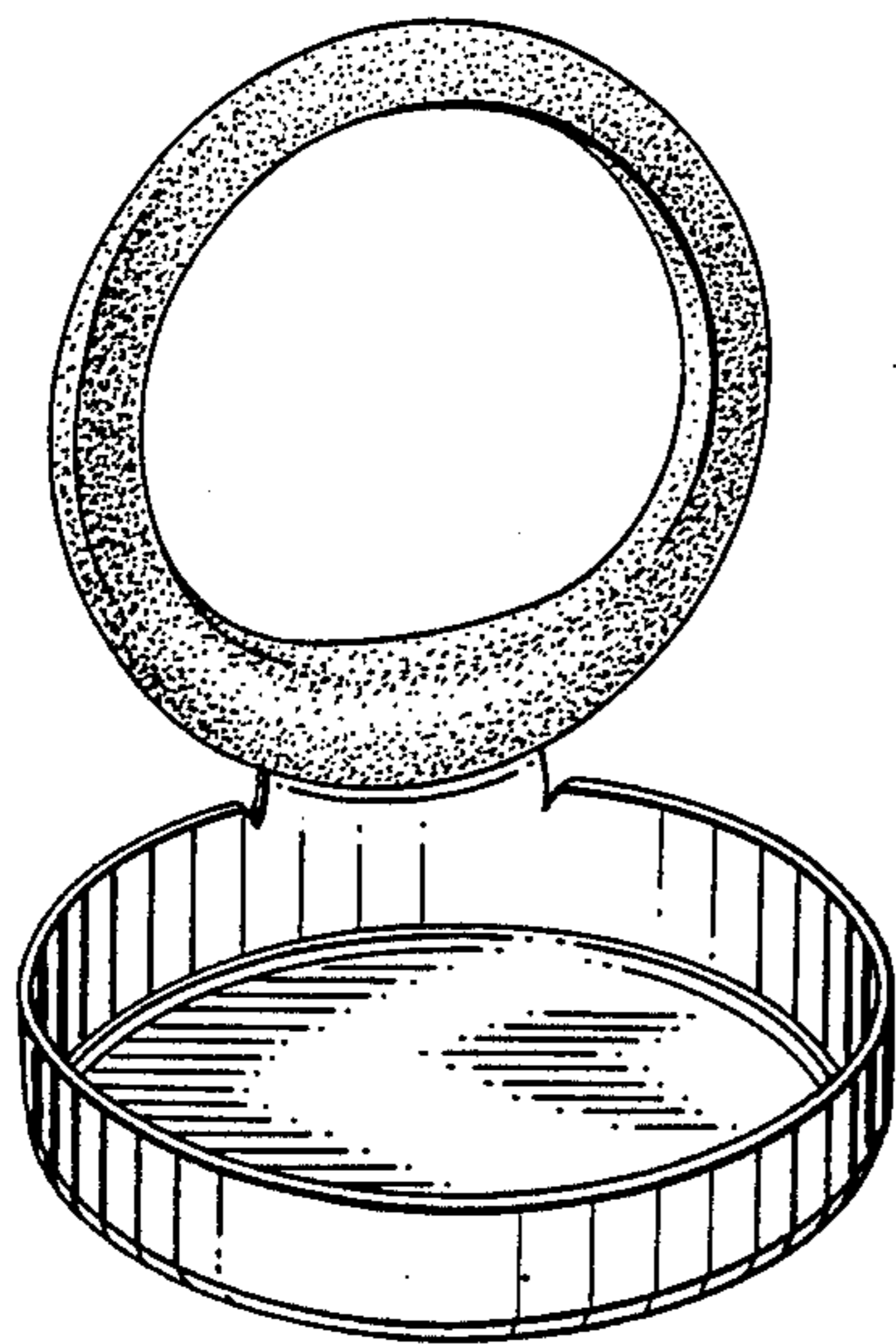

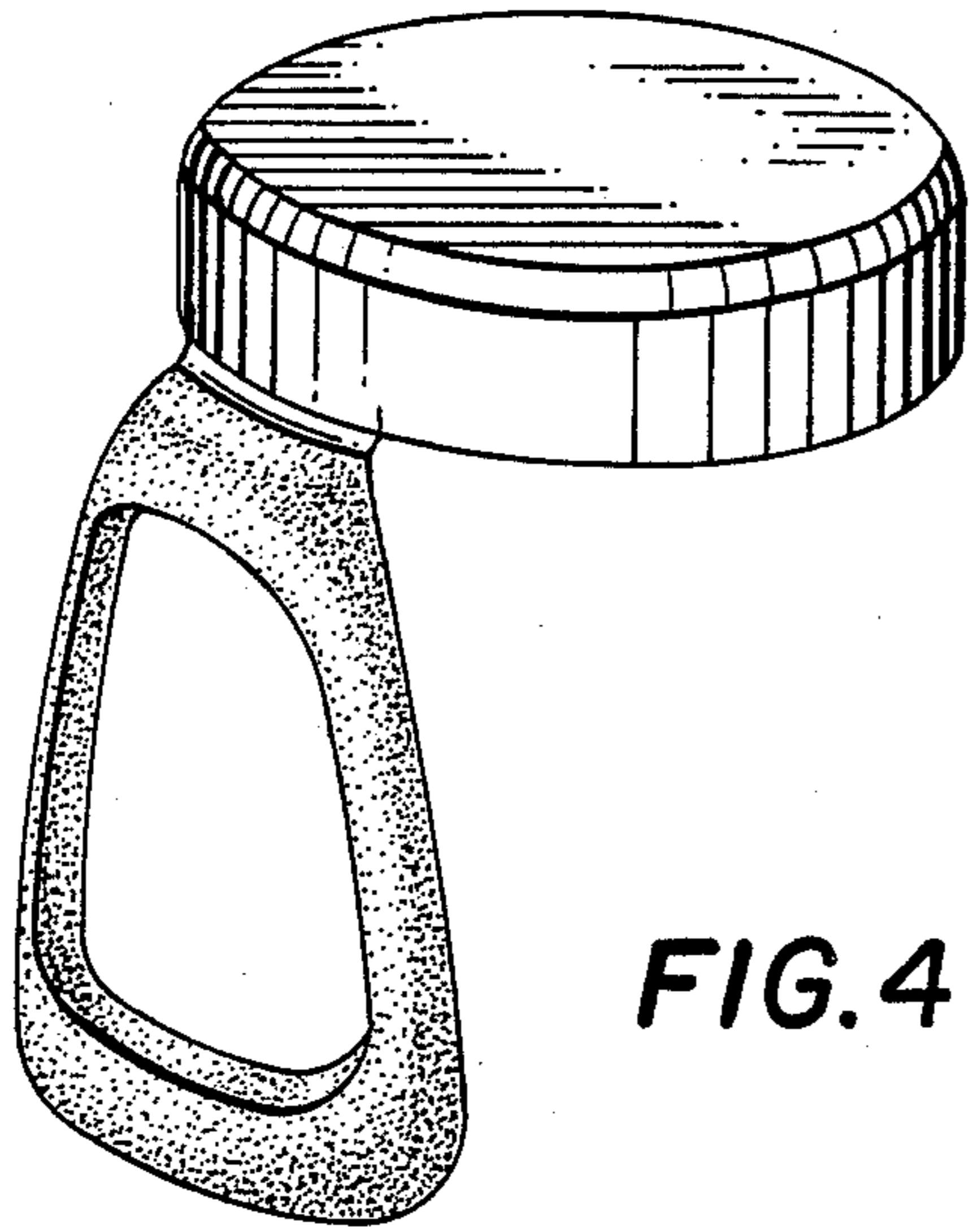

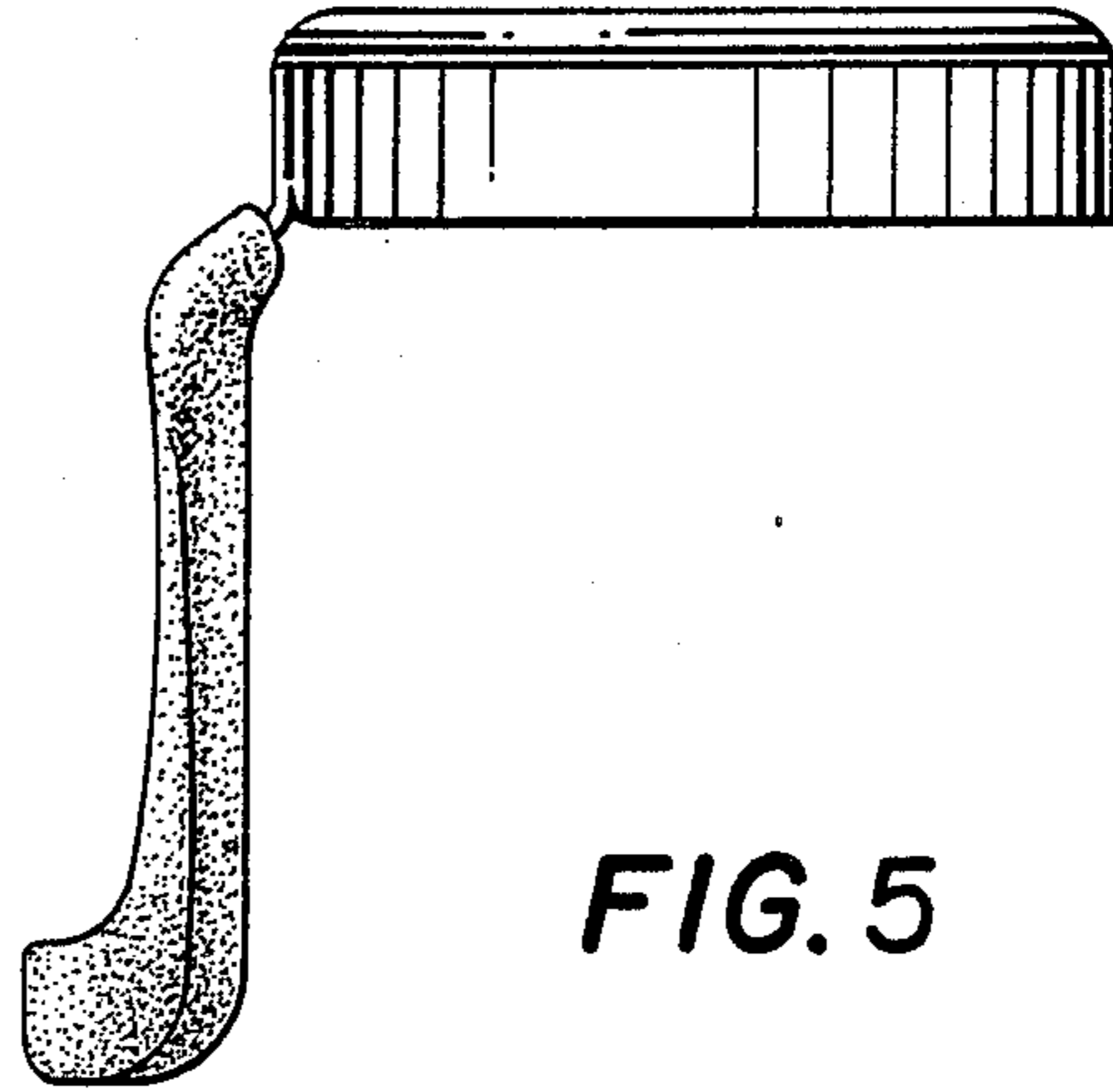

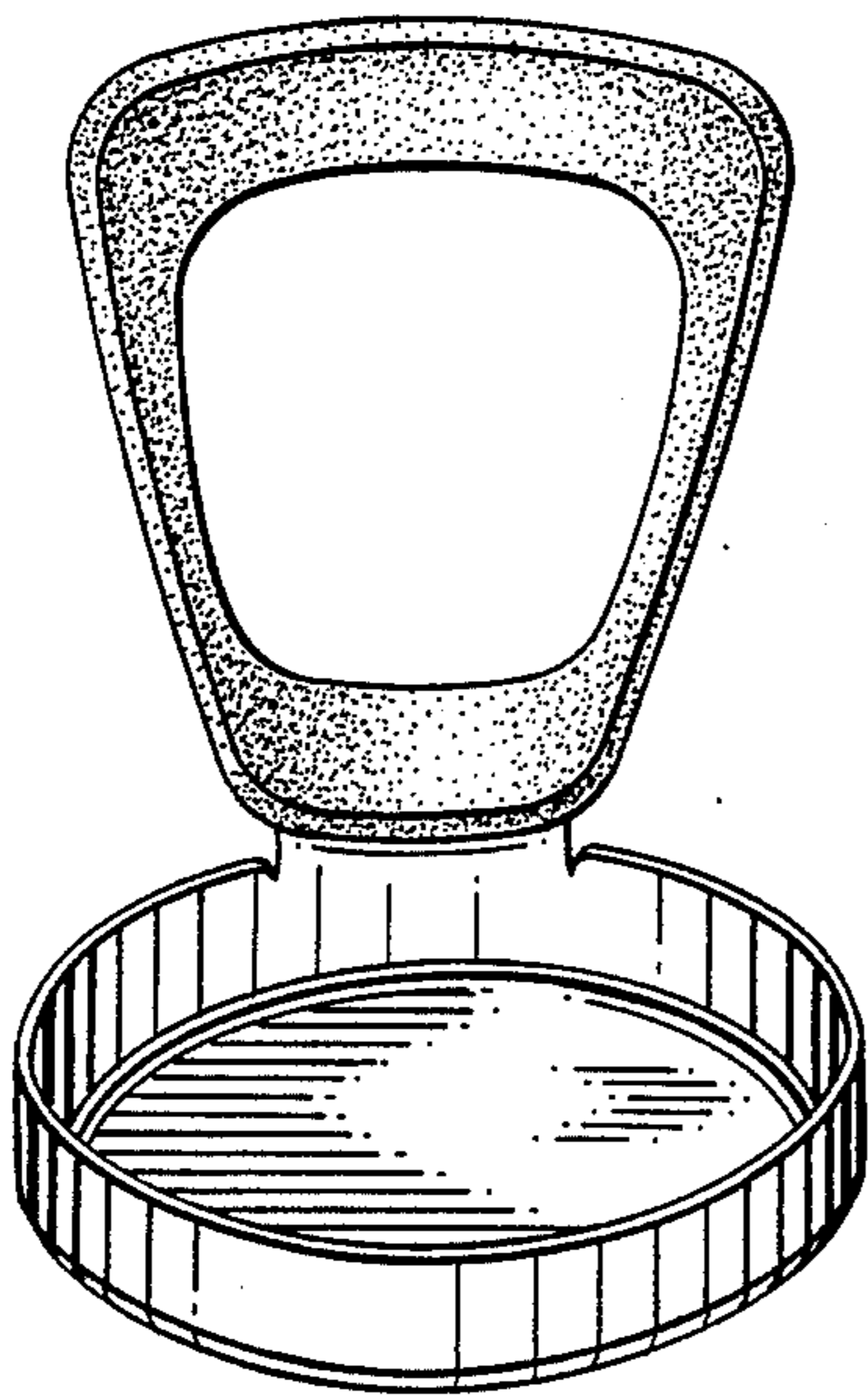

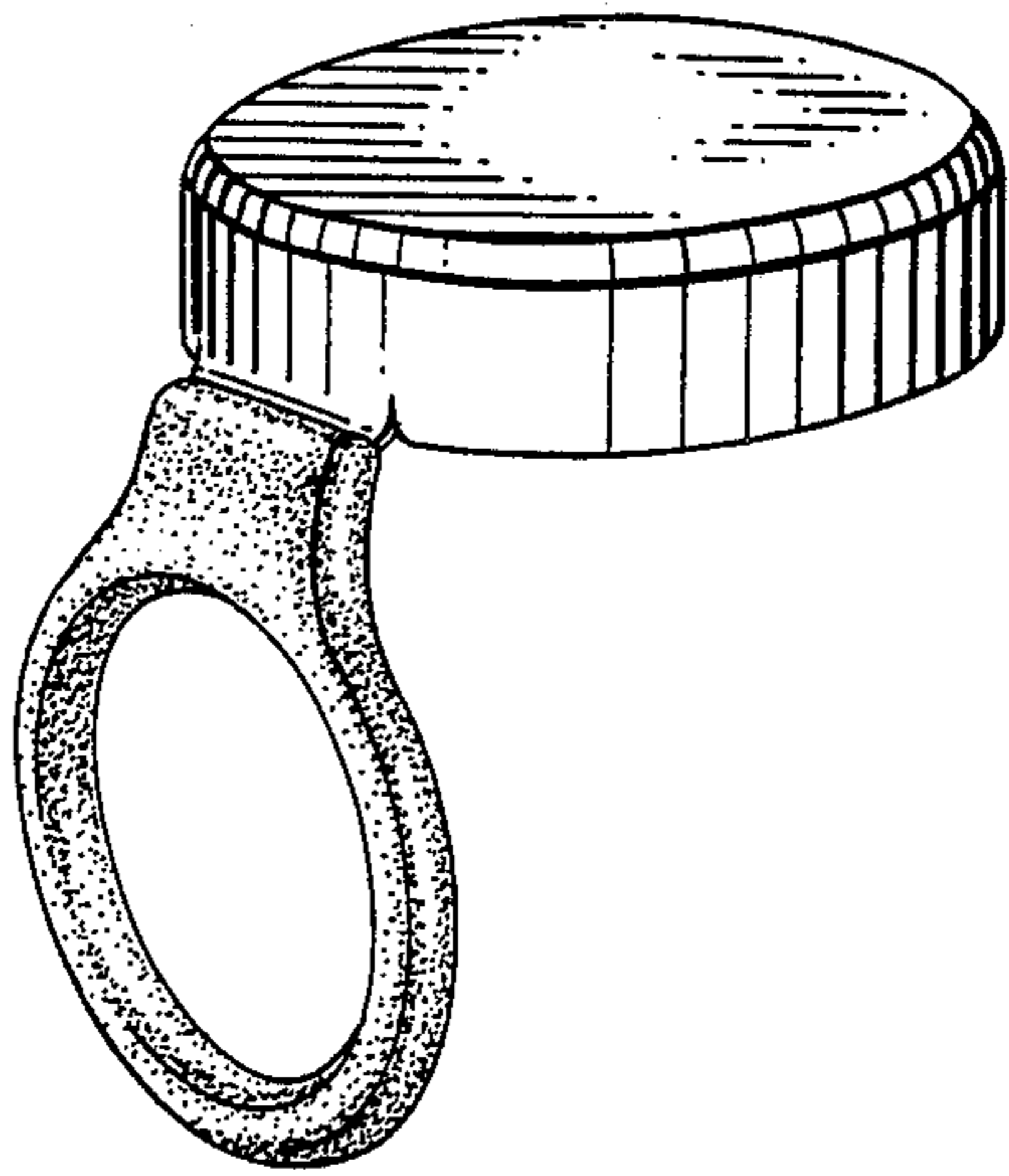

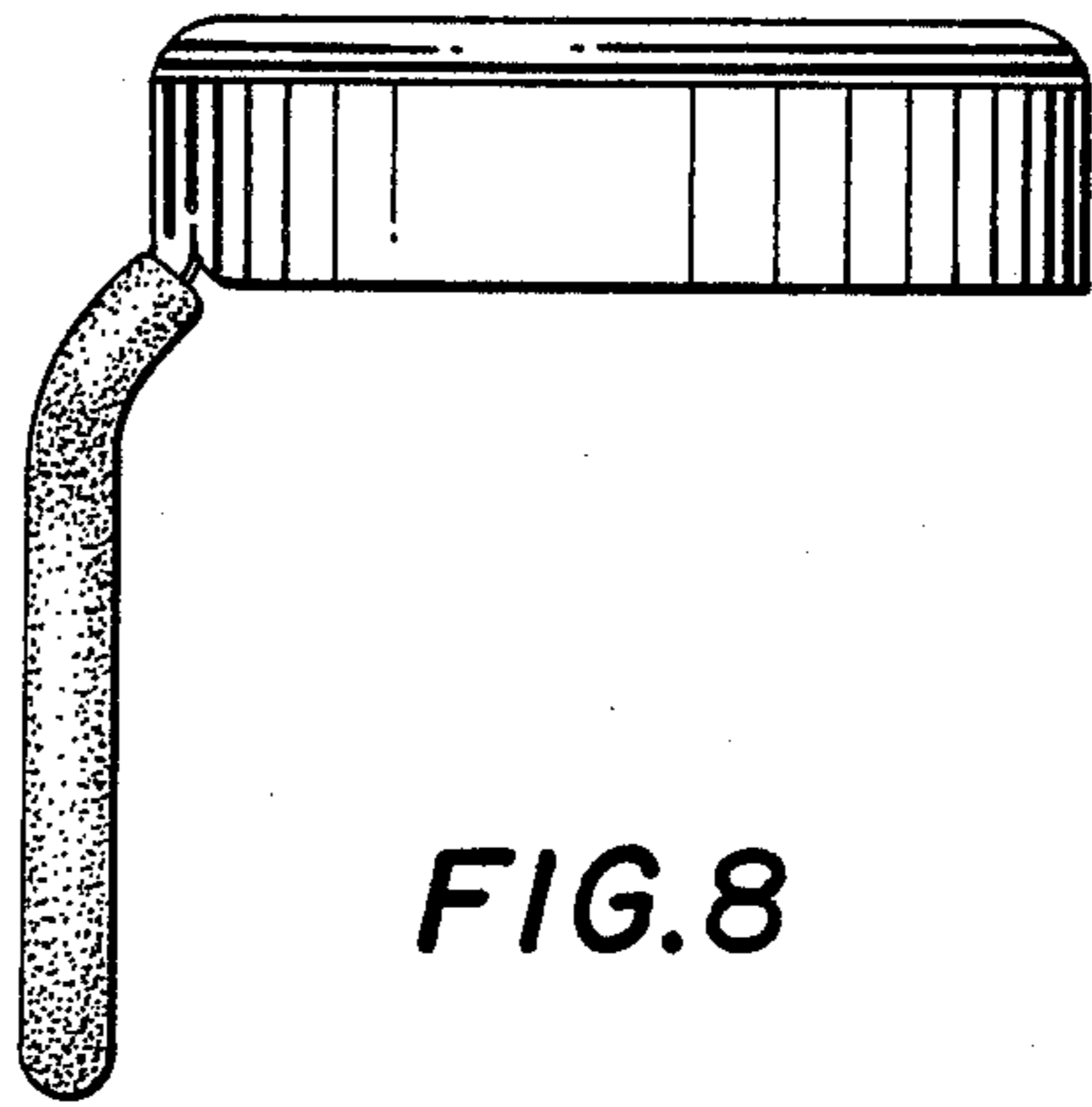

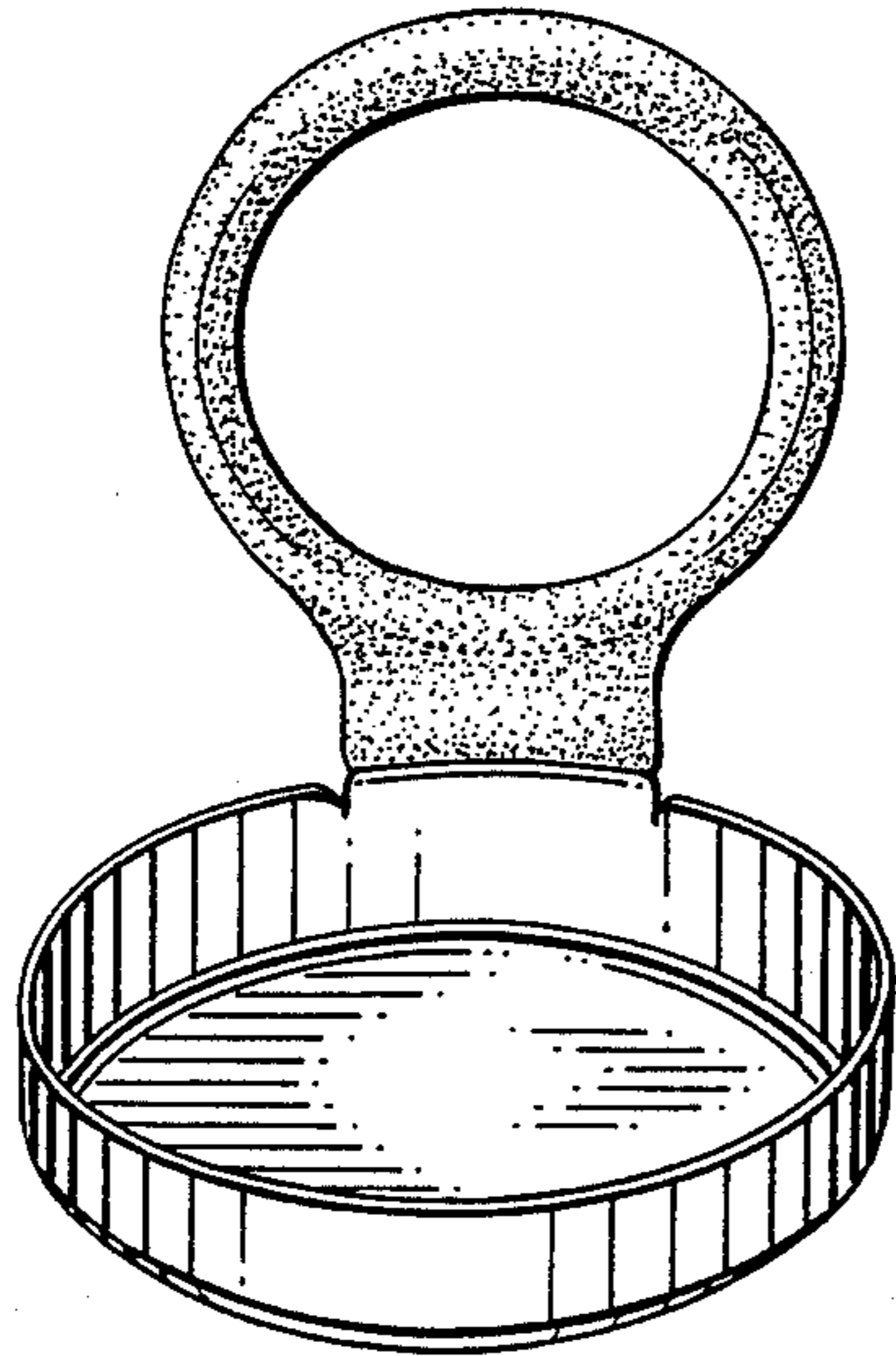

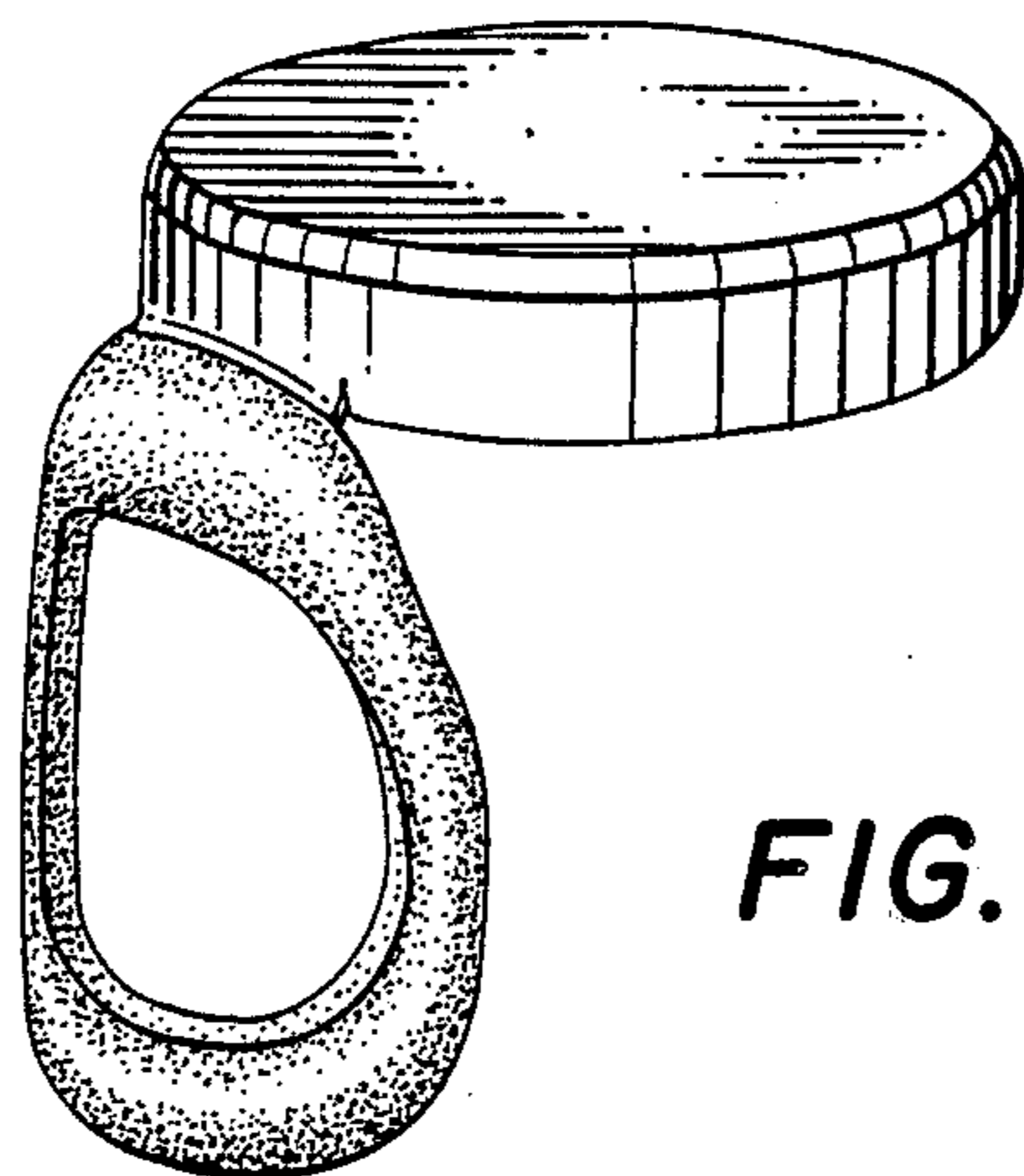

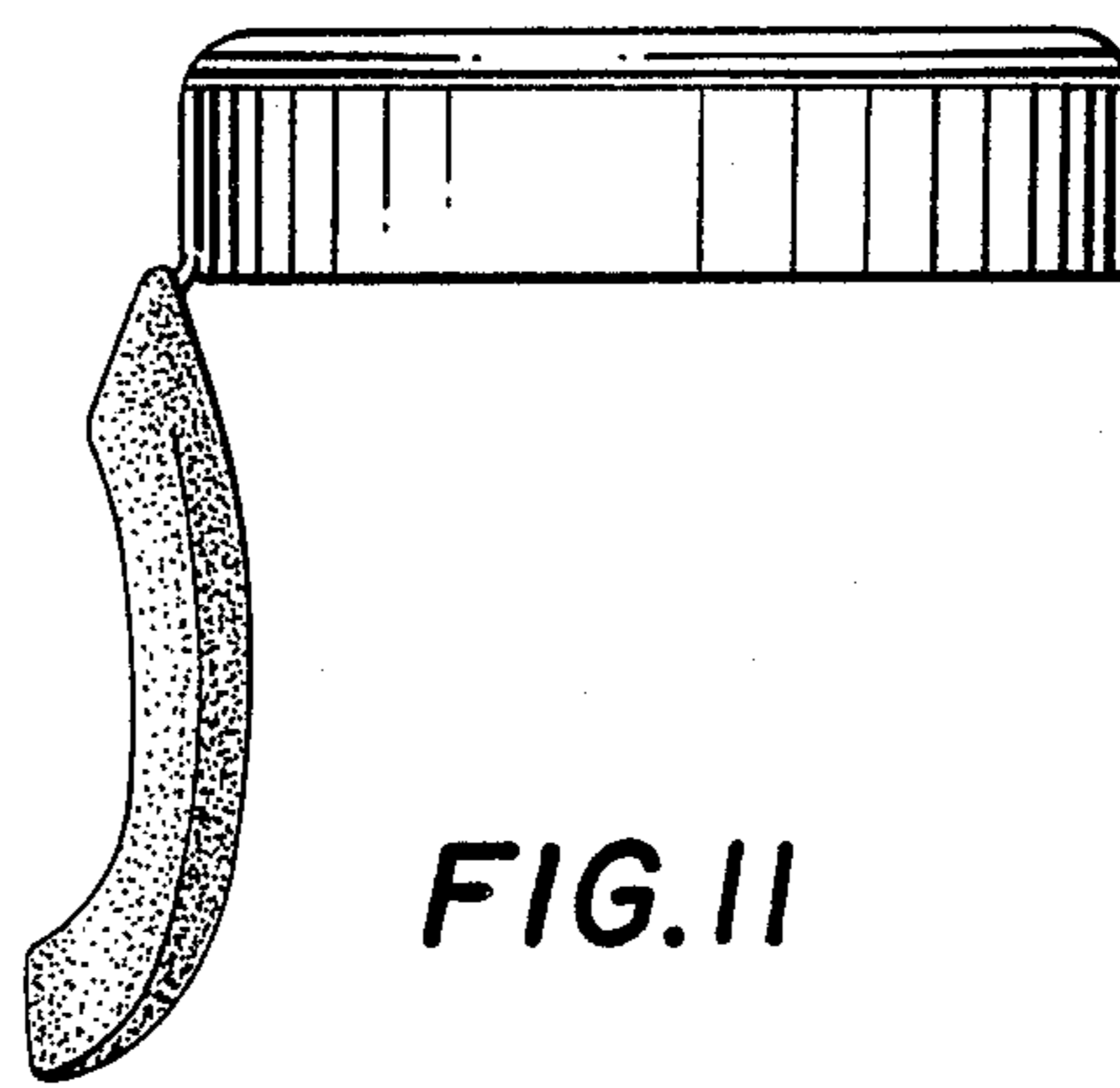

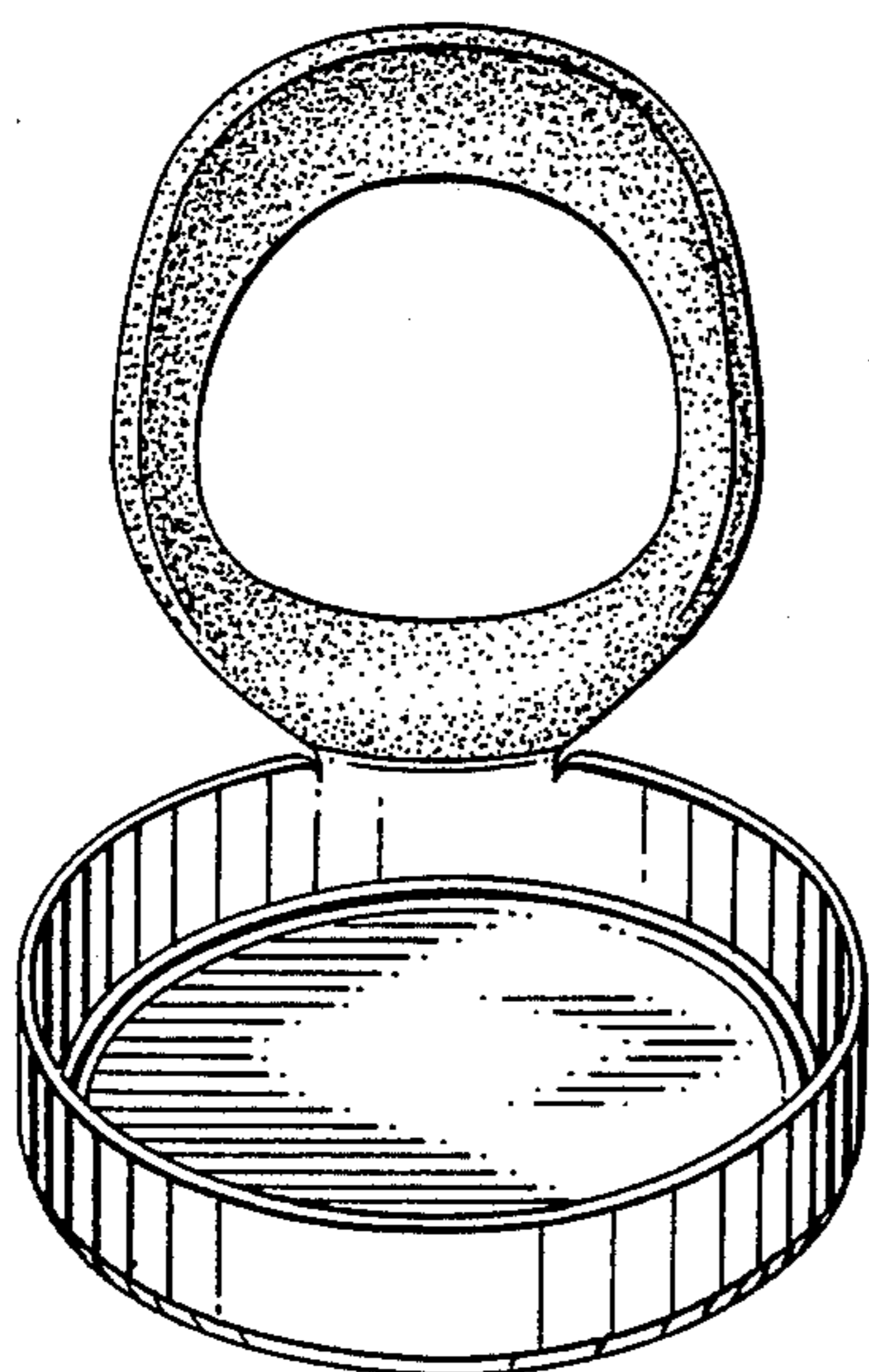
