The ornamental design for the tab portion of a shingle, as shown and described.

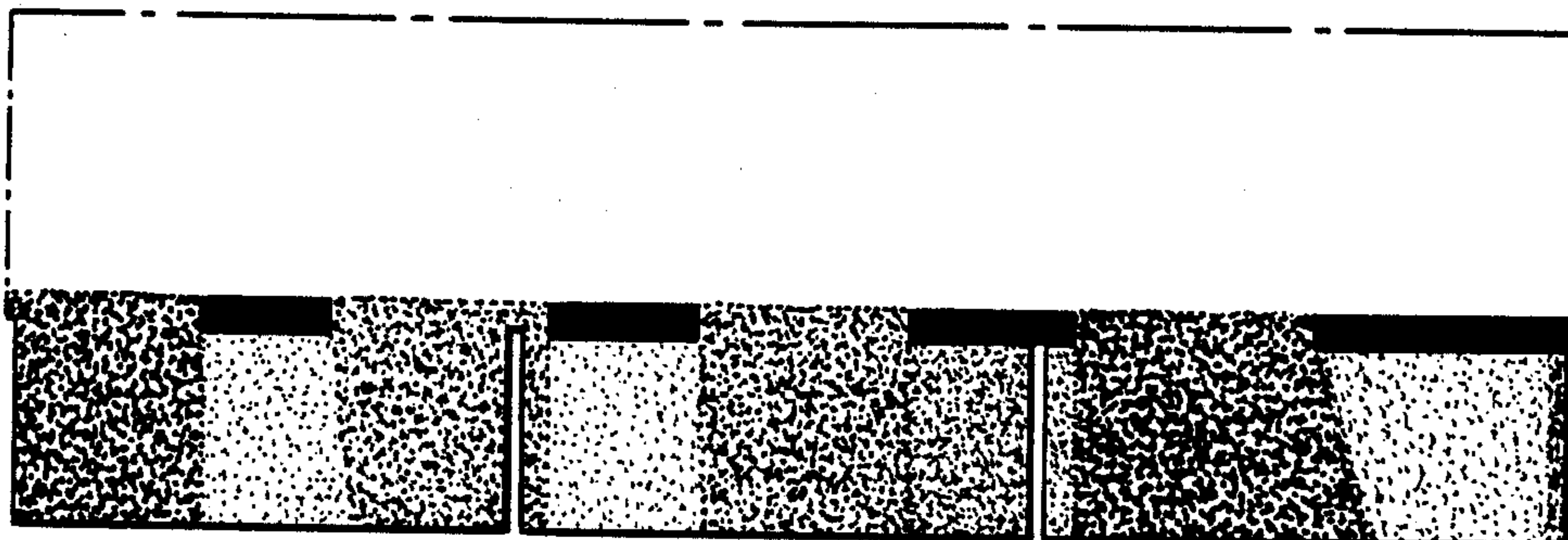
DESCRIPTION

The phantom lines indicate the outline of that portion of the shingle which does not form part of the design, but which is environmental structure.

The rear view of the shingle is plain and unornamented and the shingle is of conventional thickness.



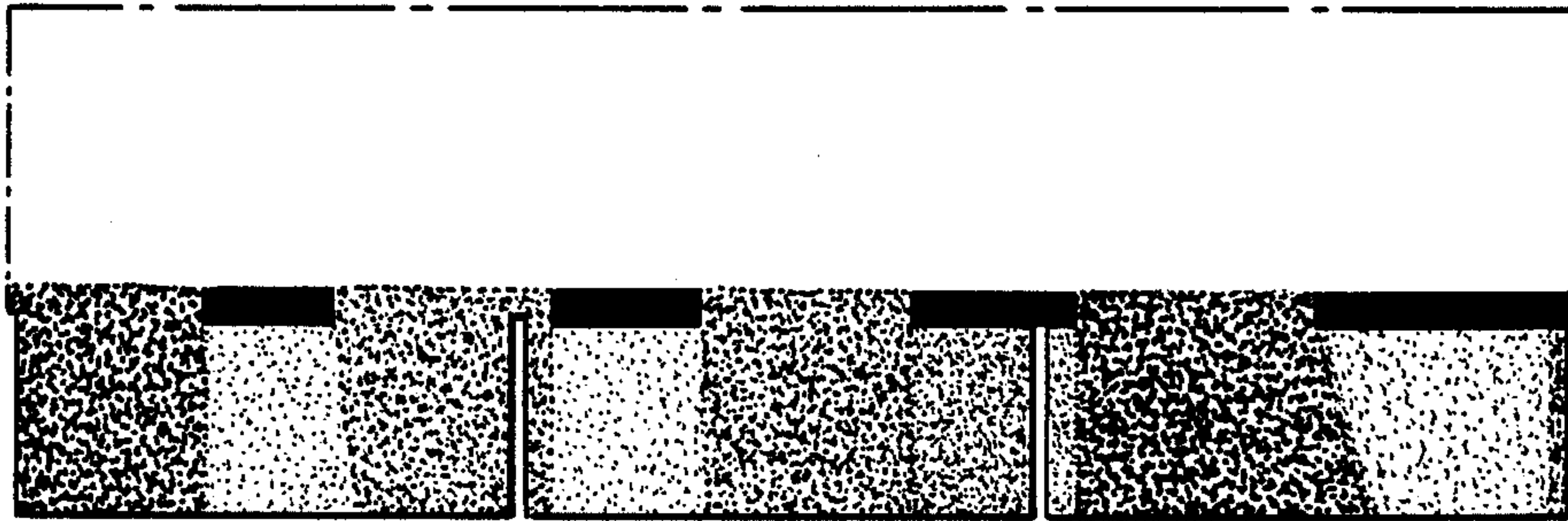

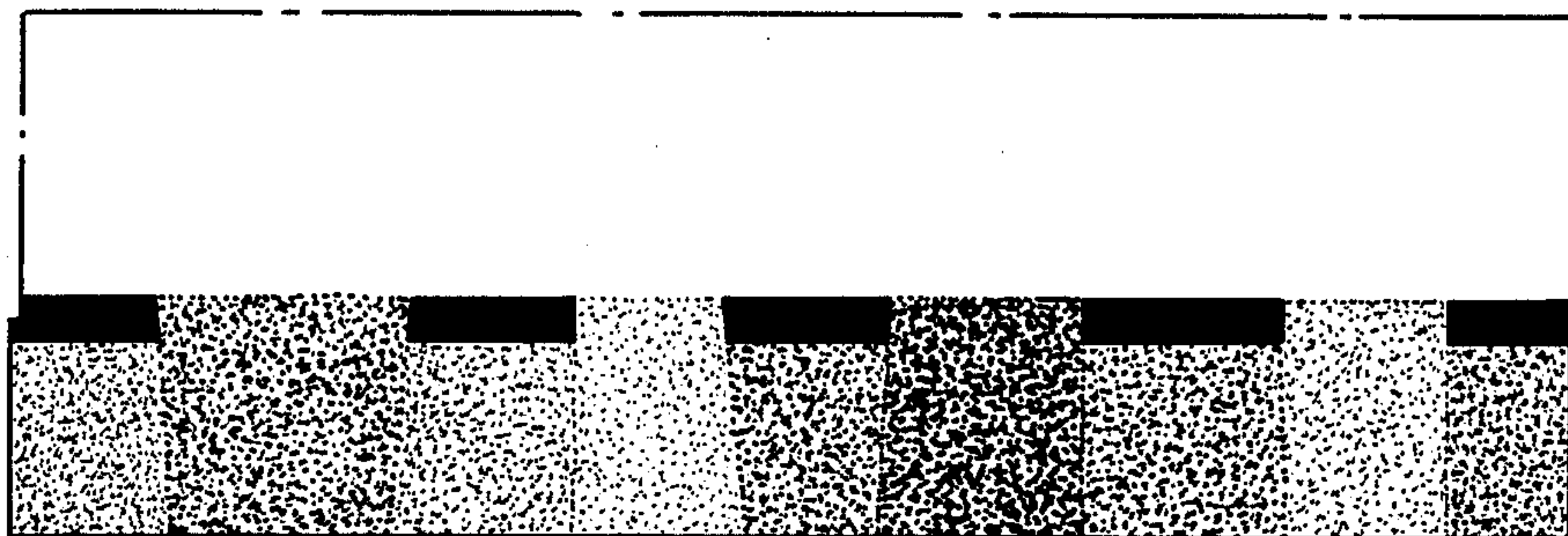

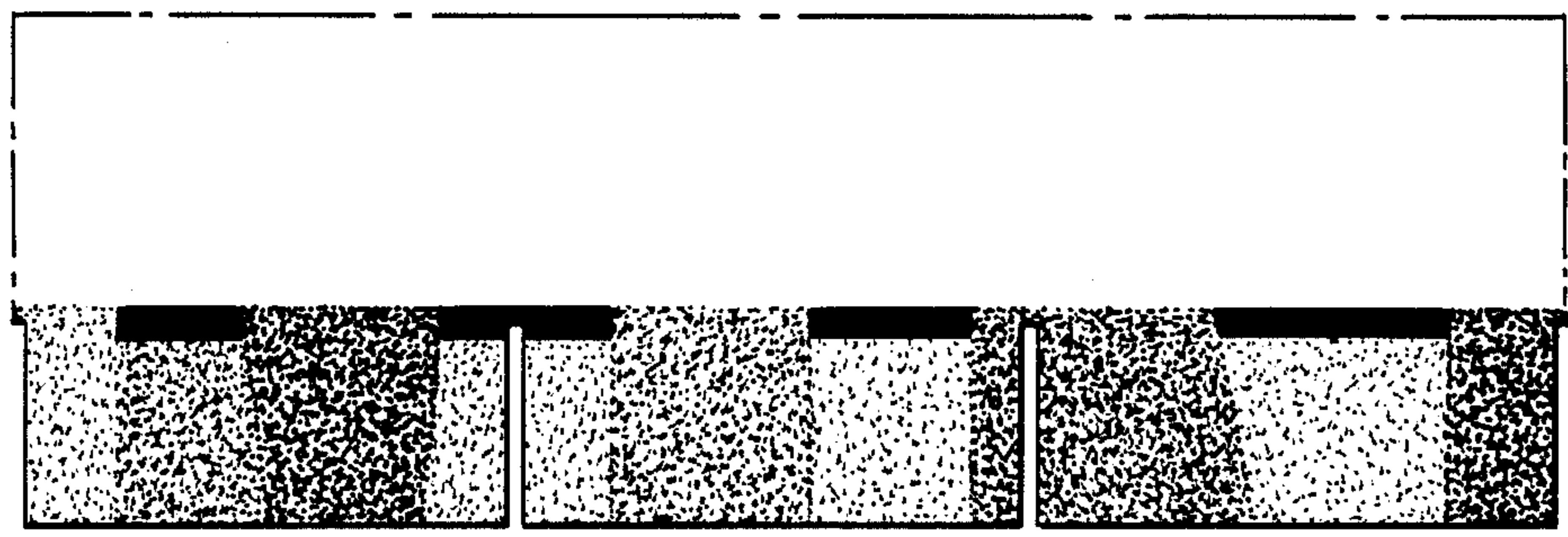

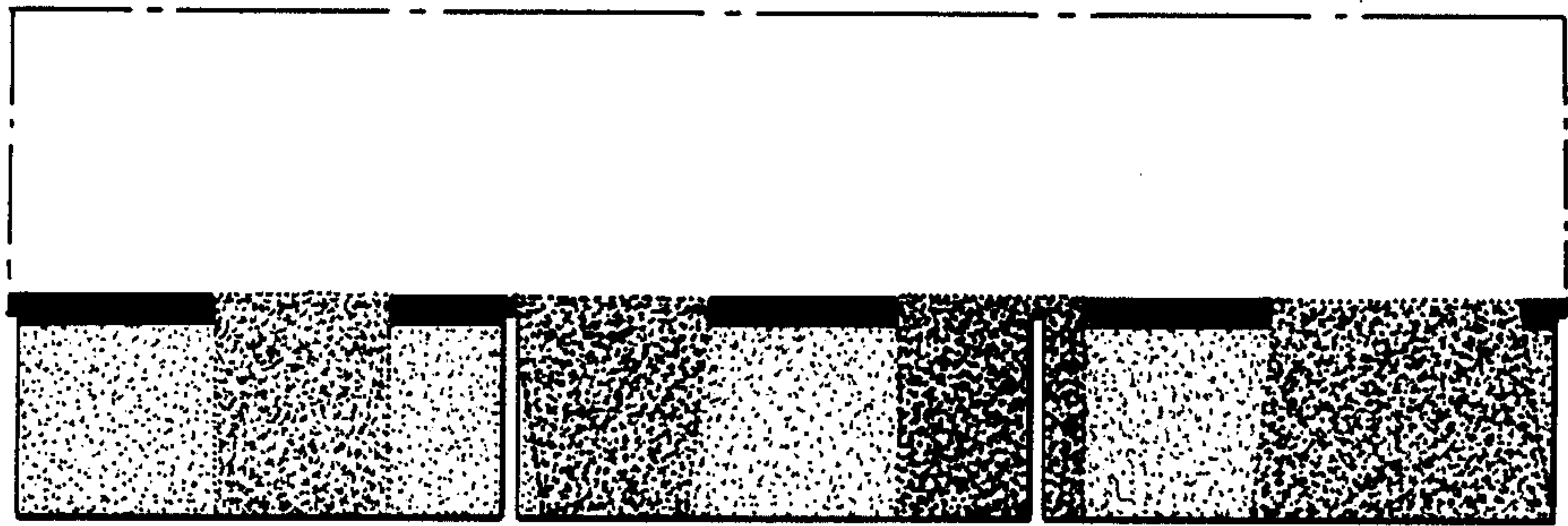

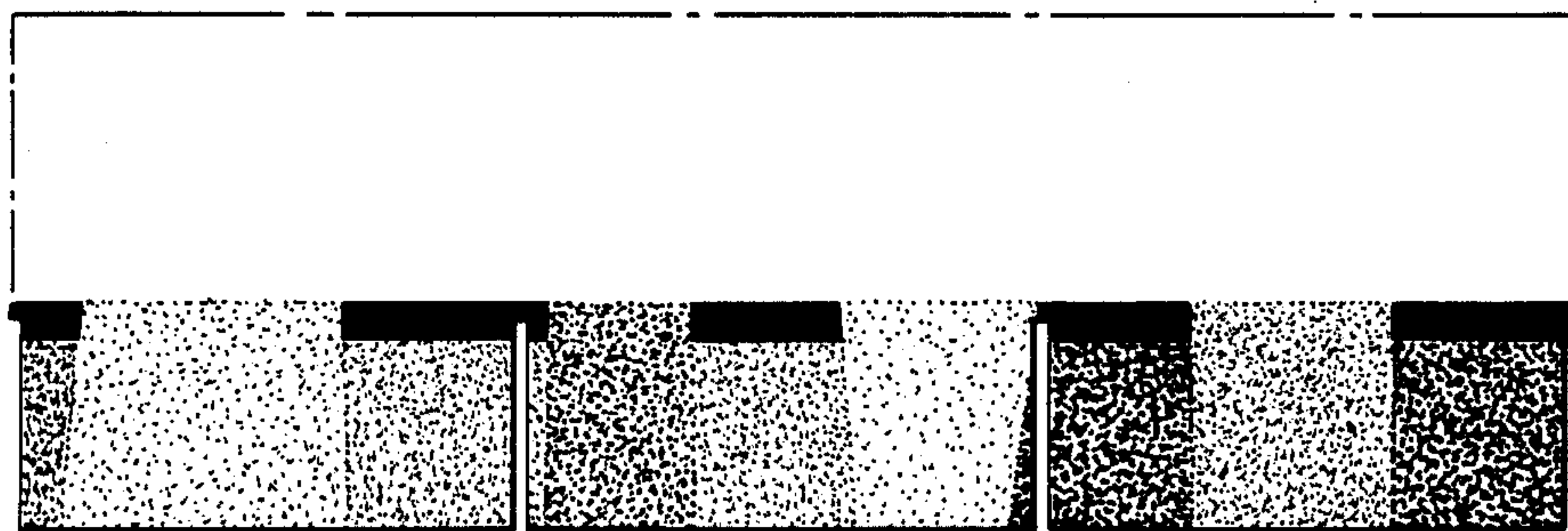

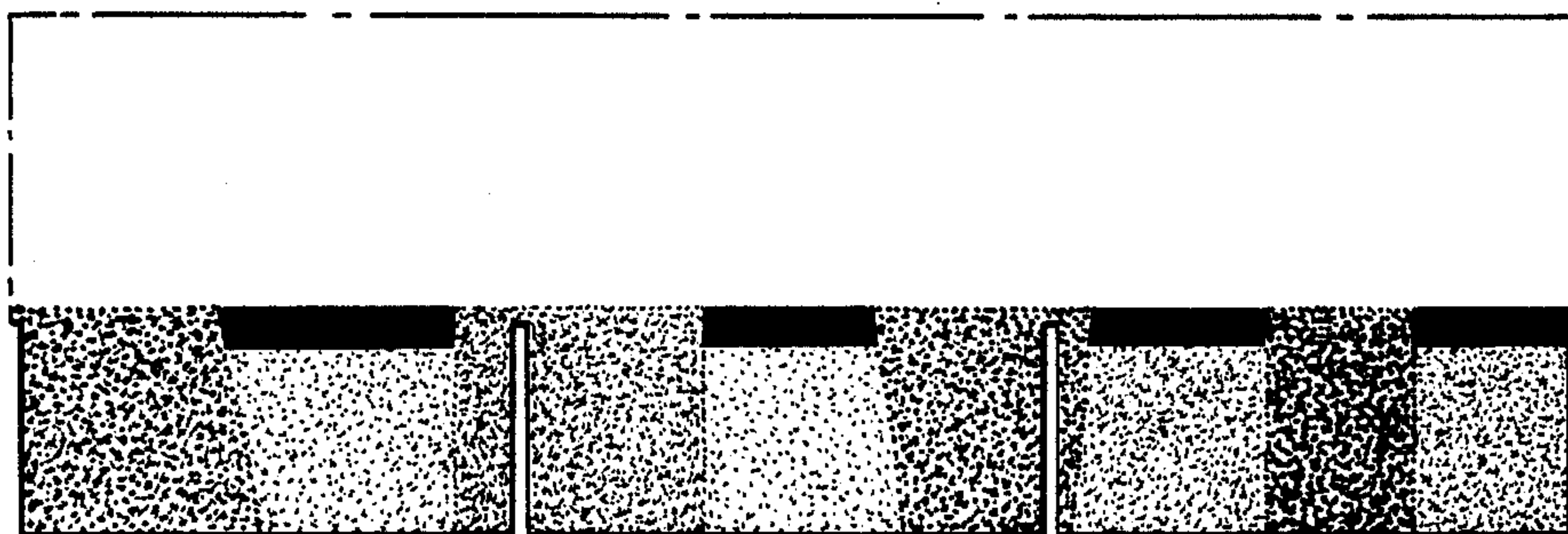

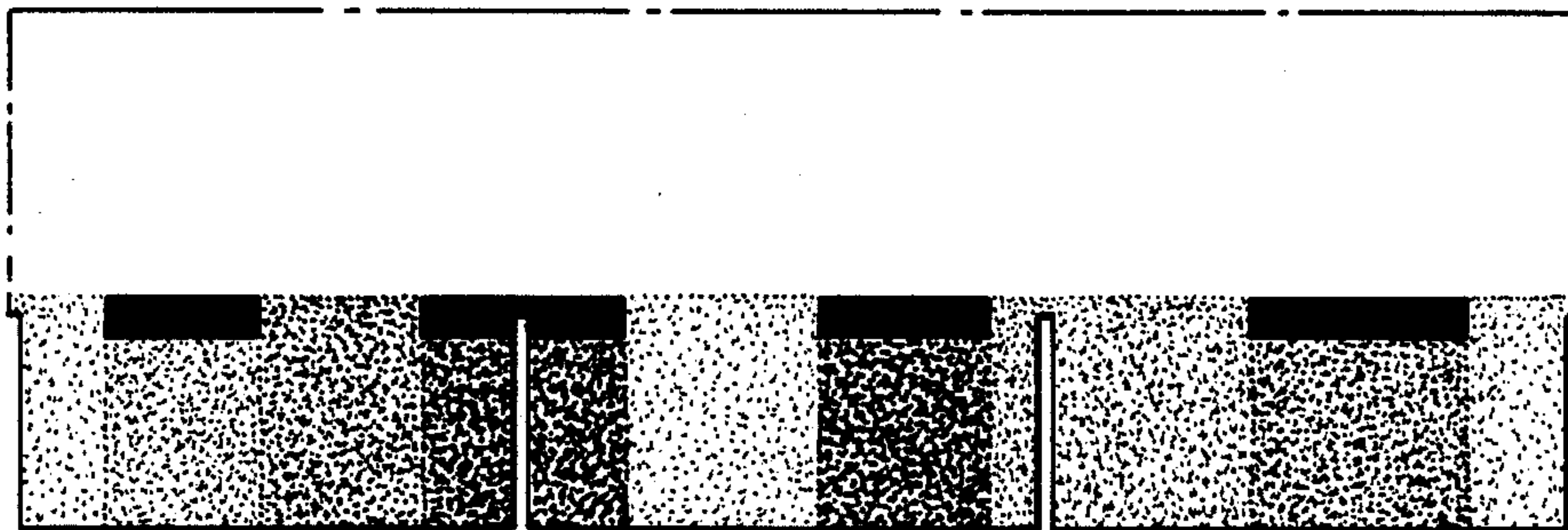

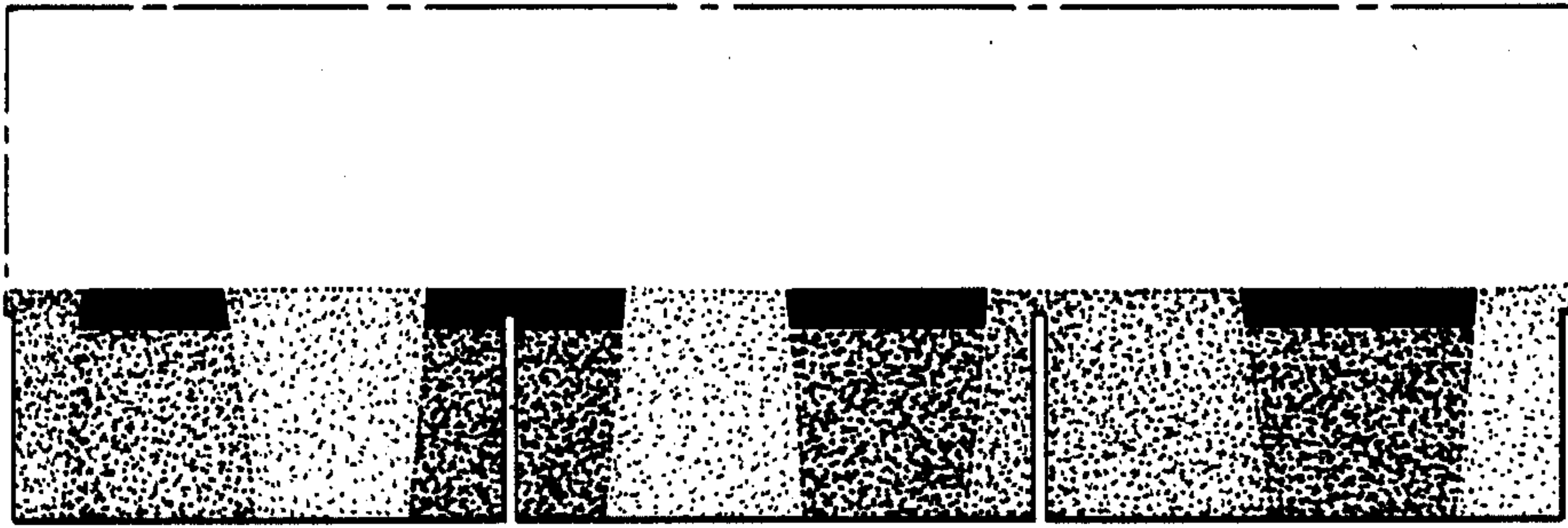

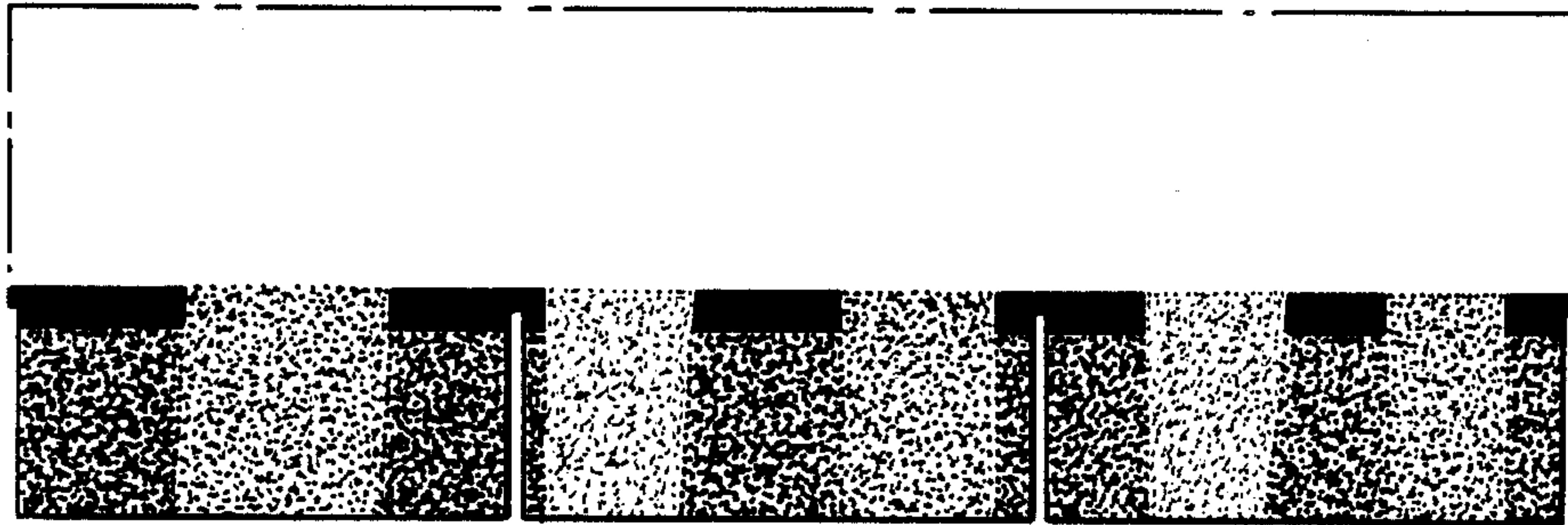

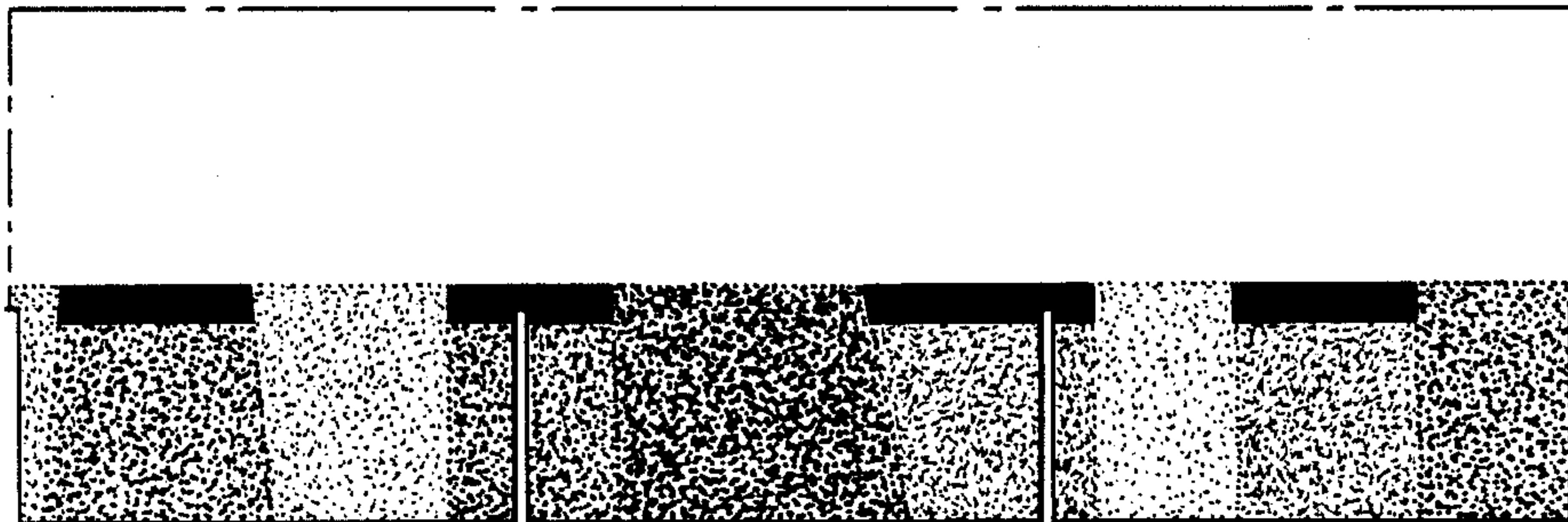
