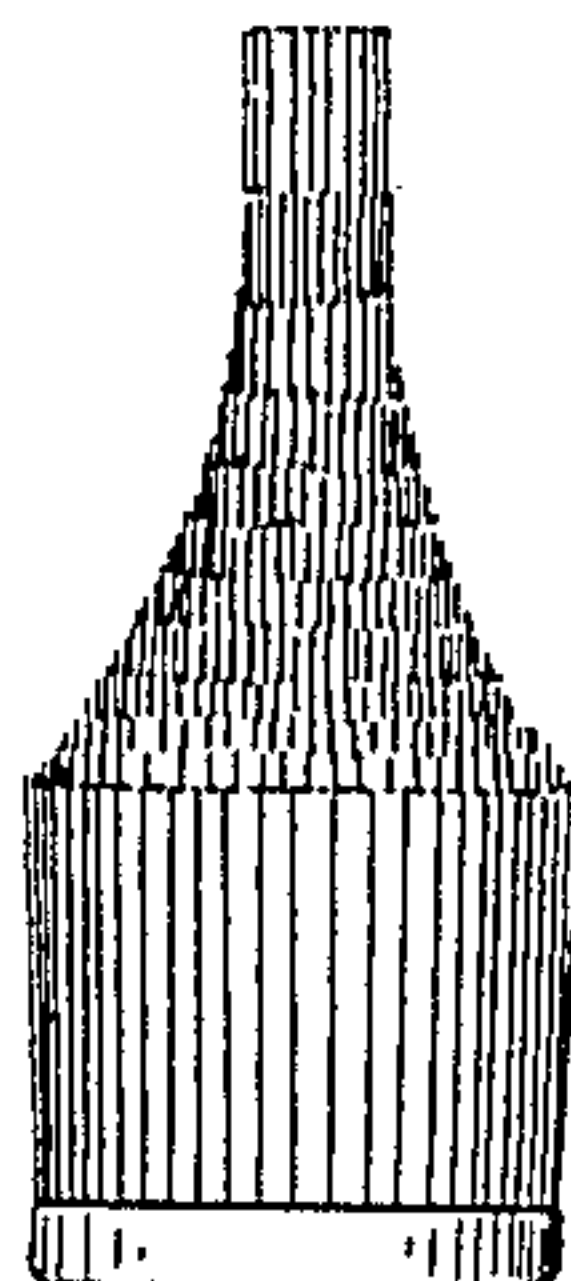

[57] CLAIM

The ornamental design for a brush head for mounting in a dental instrument, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a brush head for mounting in a dental instrument showing my new design; FIG. 2 is a side elevational view thereof, the sides opposite and adjacent being identical in appearance; and FIG. 3 is a bottom plan view thereof.



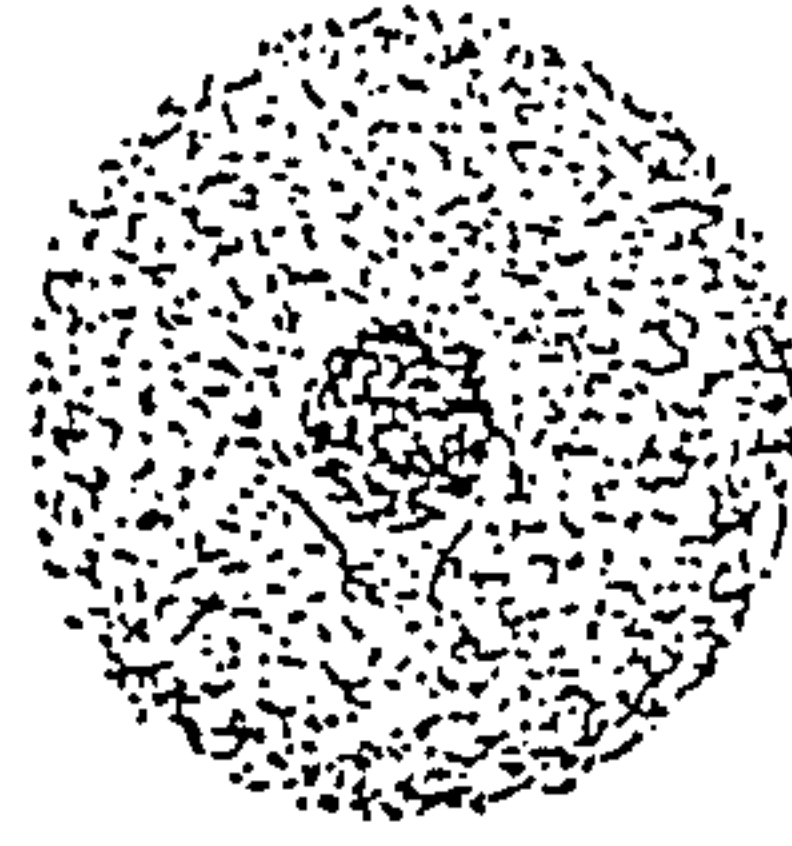

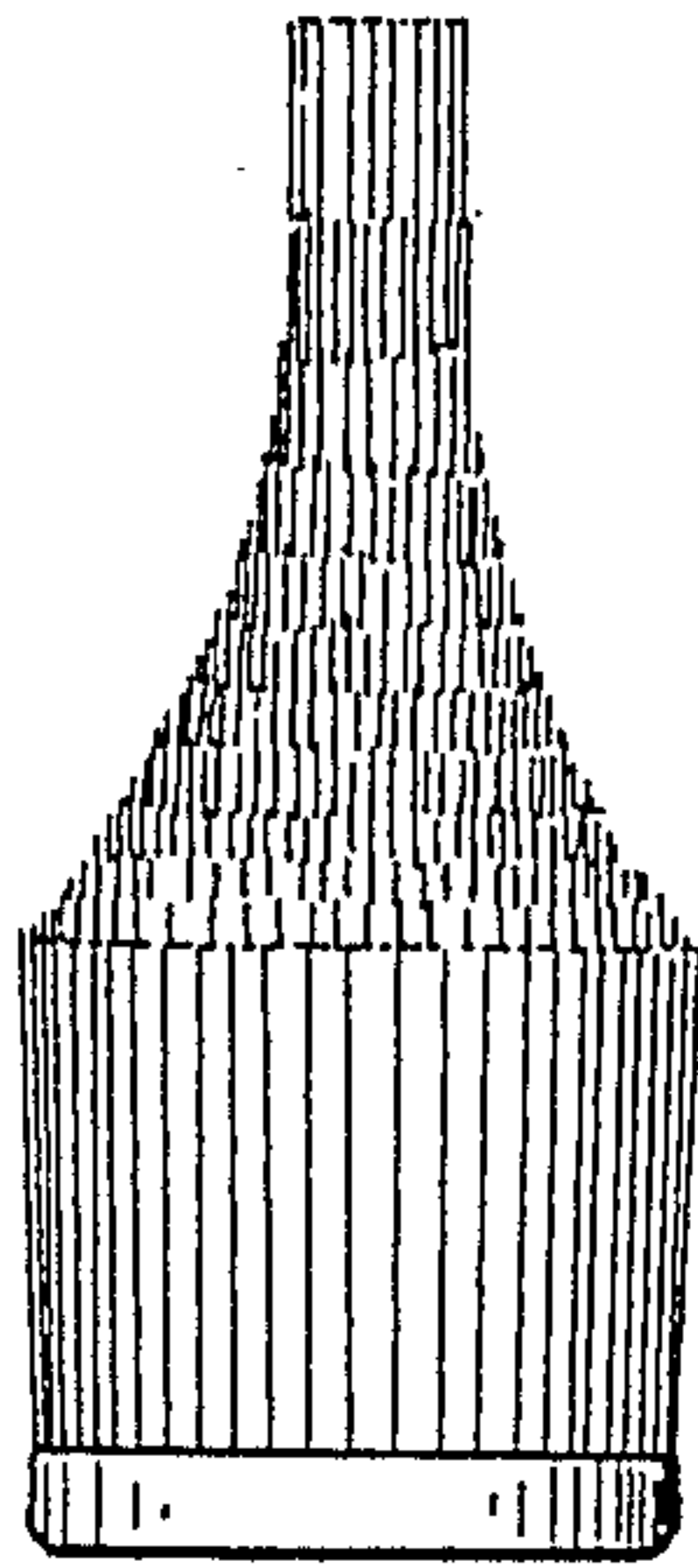

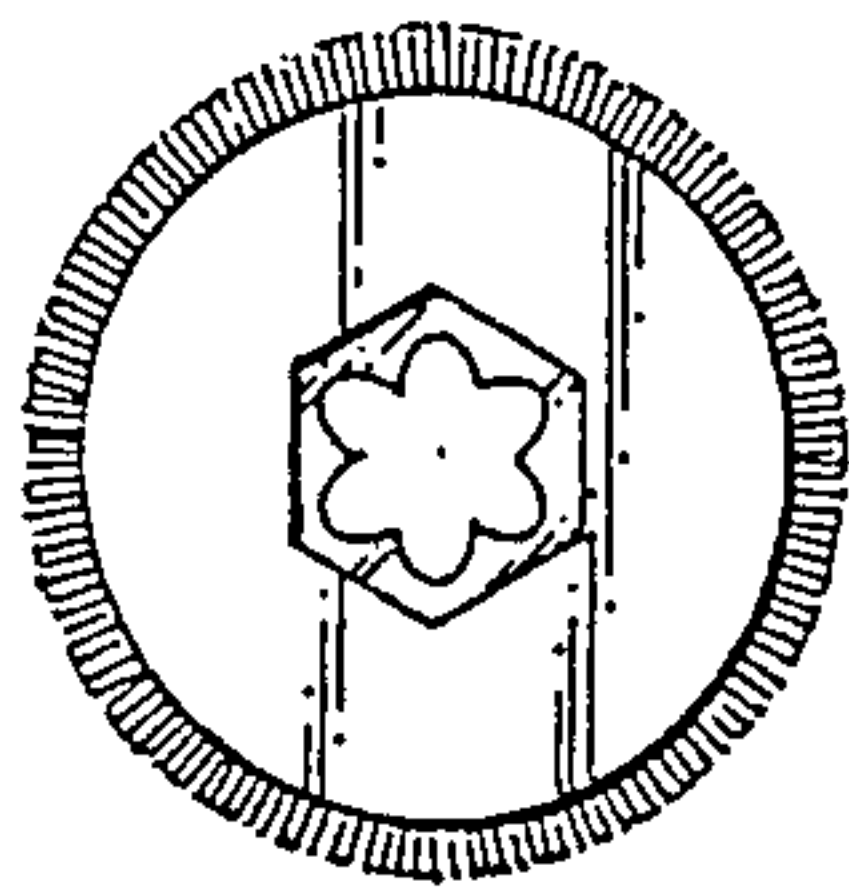
