[57] CLAIM

The ornamental design for toilet seat handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and left side of a toilet seat handle showing my new design;

FIG. 2 is a left side elevational view thereof, in a raised position;

FIG. 3 is a right side elevational view thereof in a lowered position;

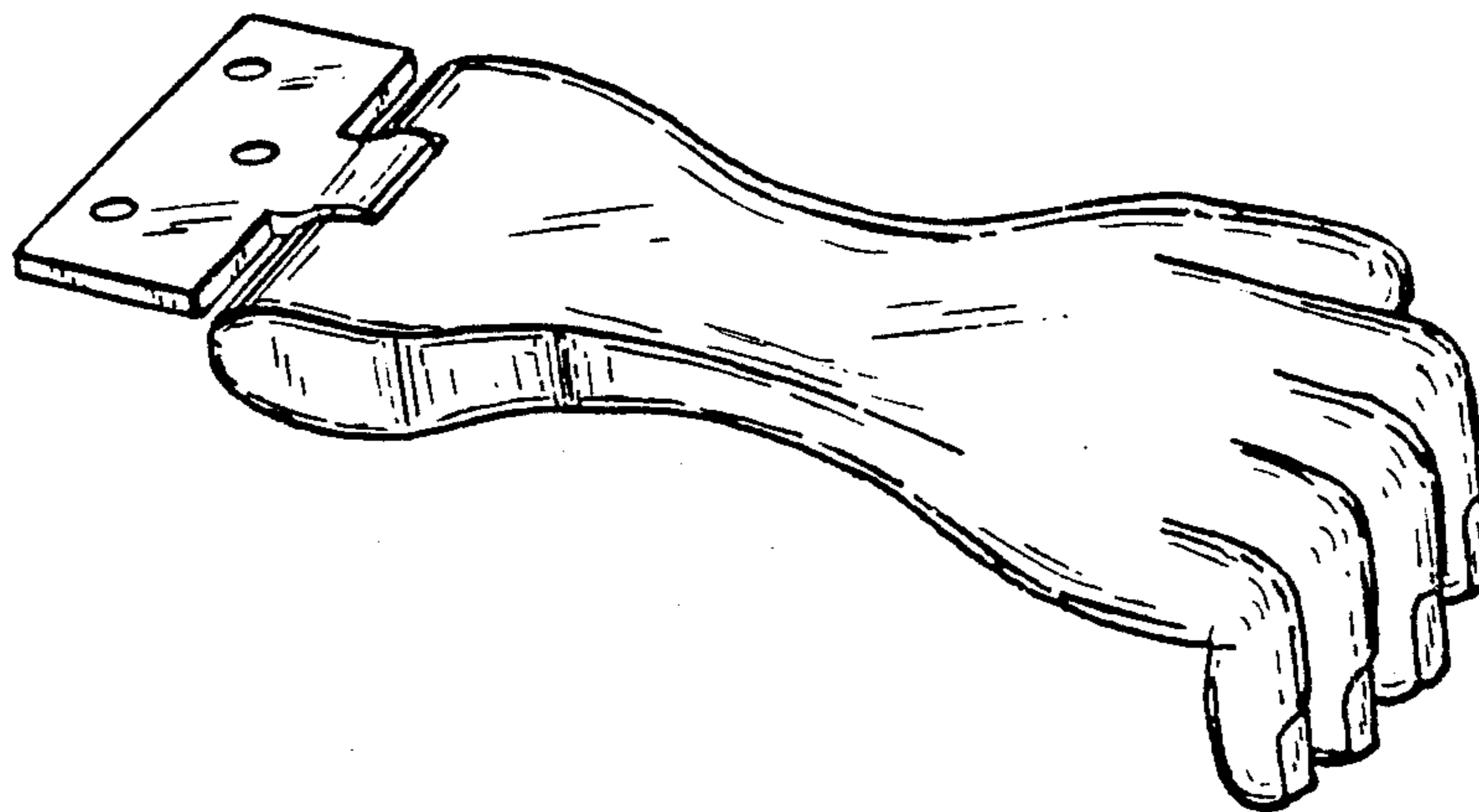
FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof; and

FIG. 7 is a front elevational view thereof.

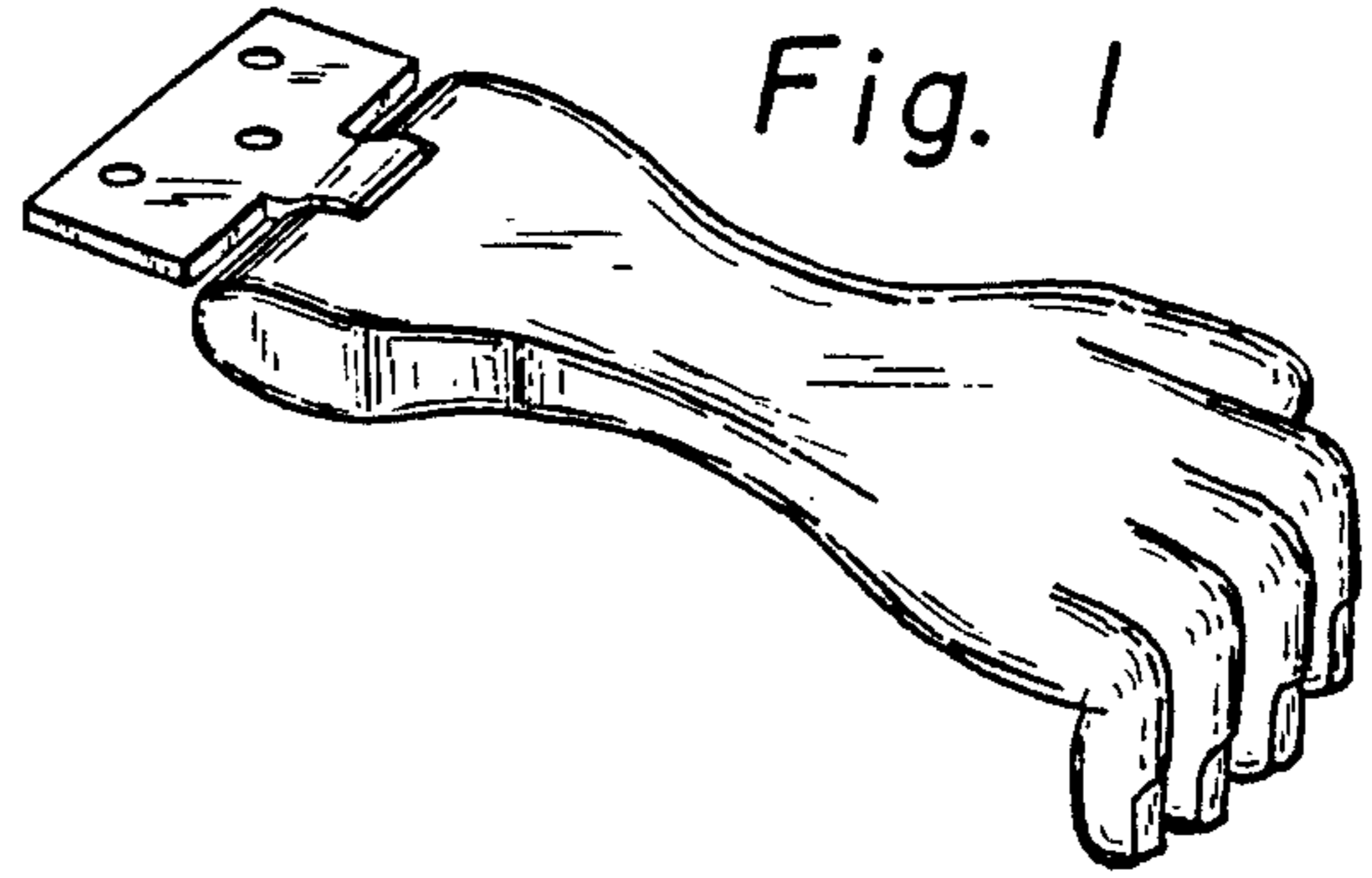

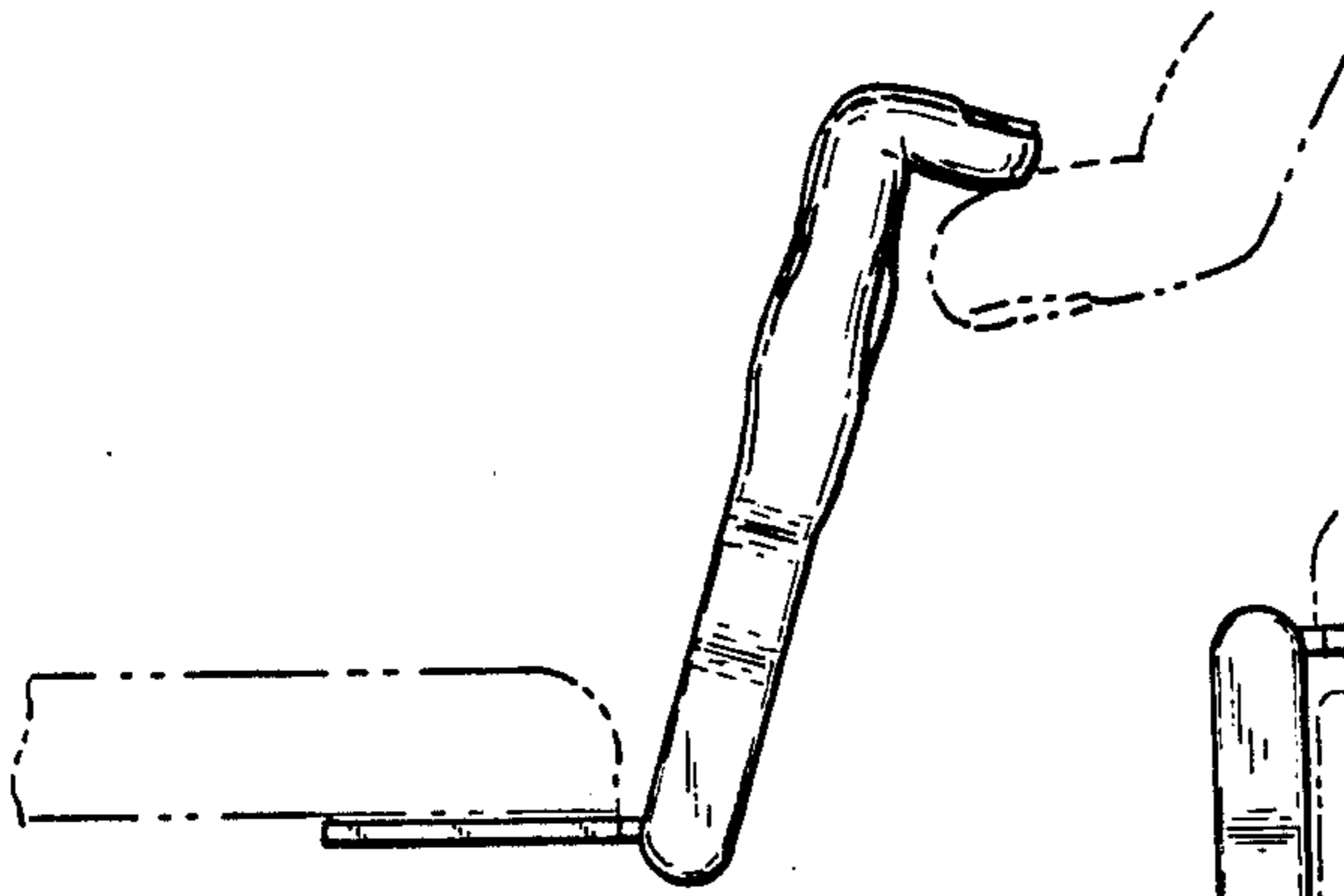

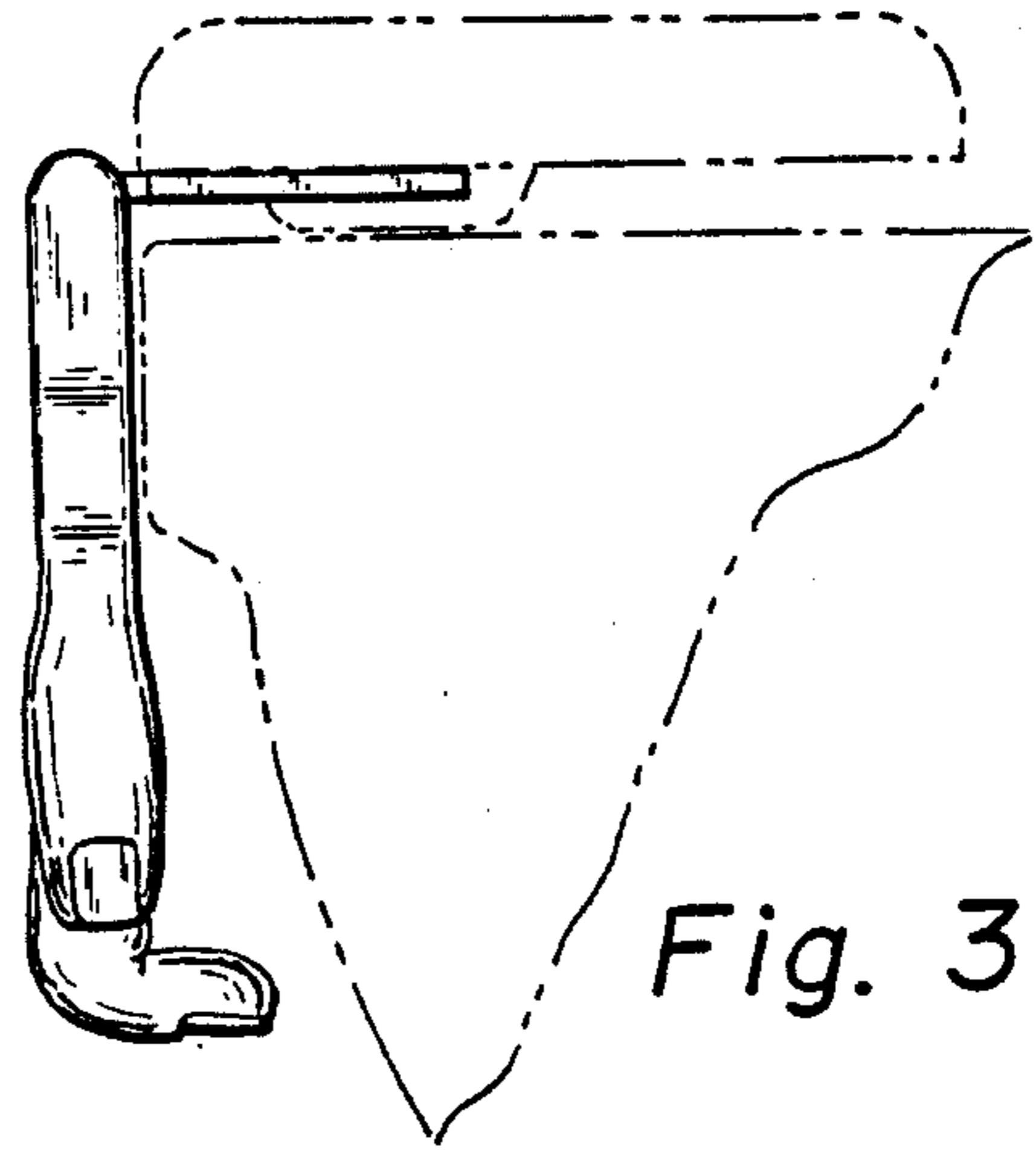

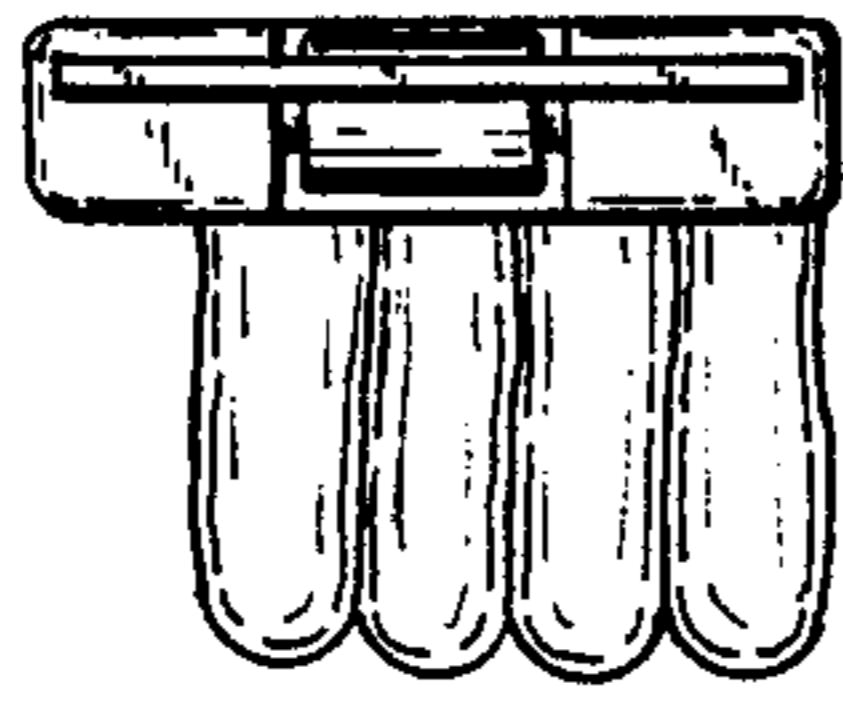

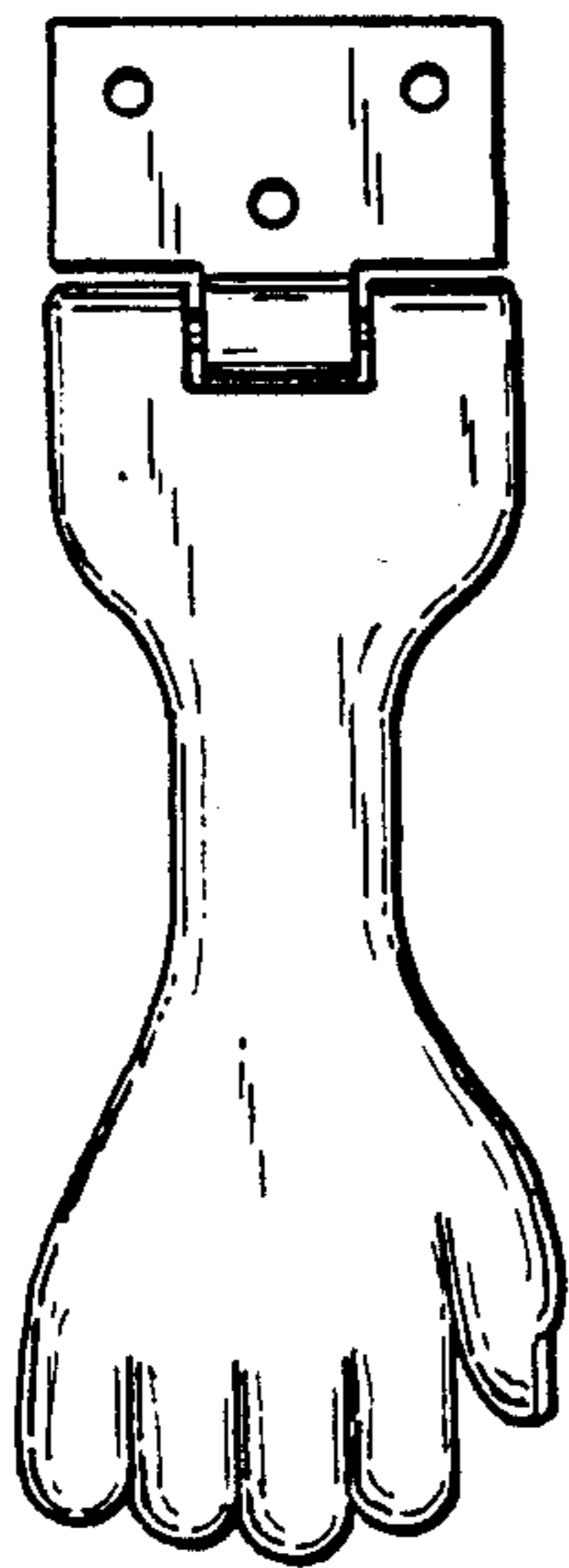

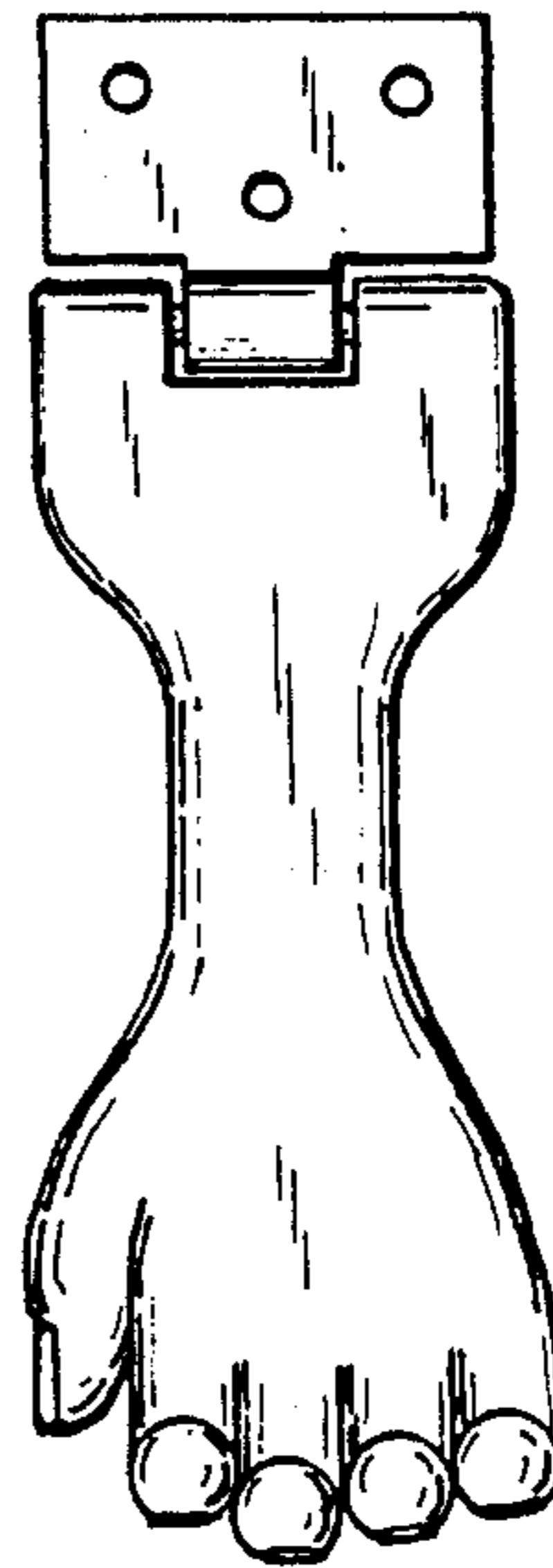

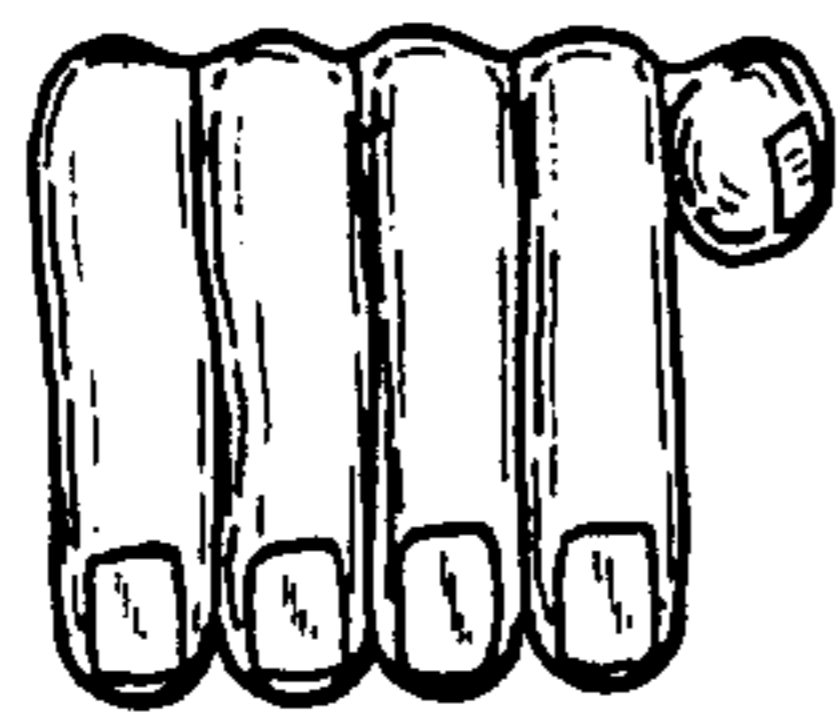
