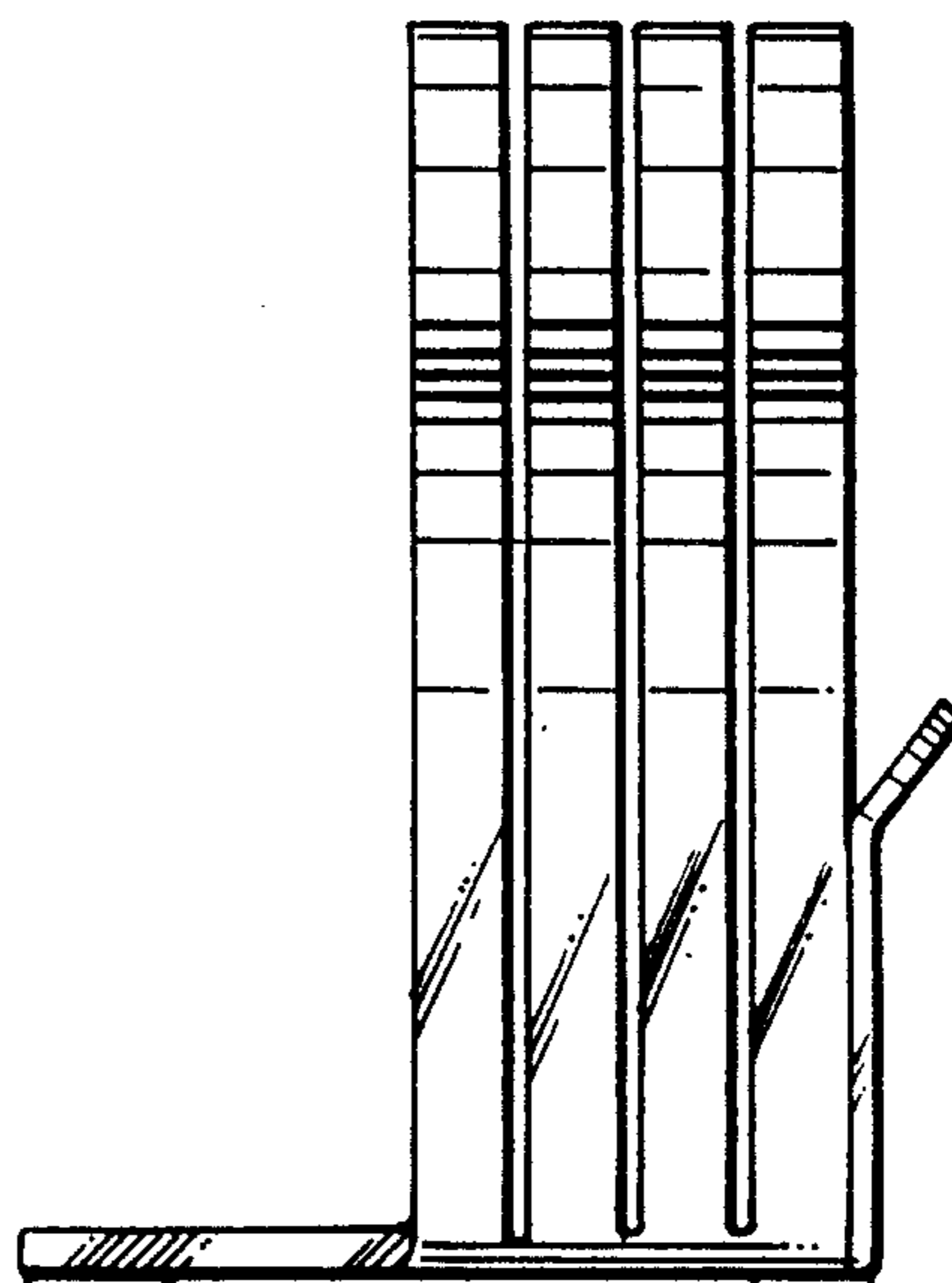
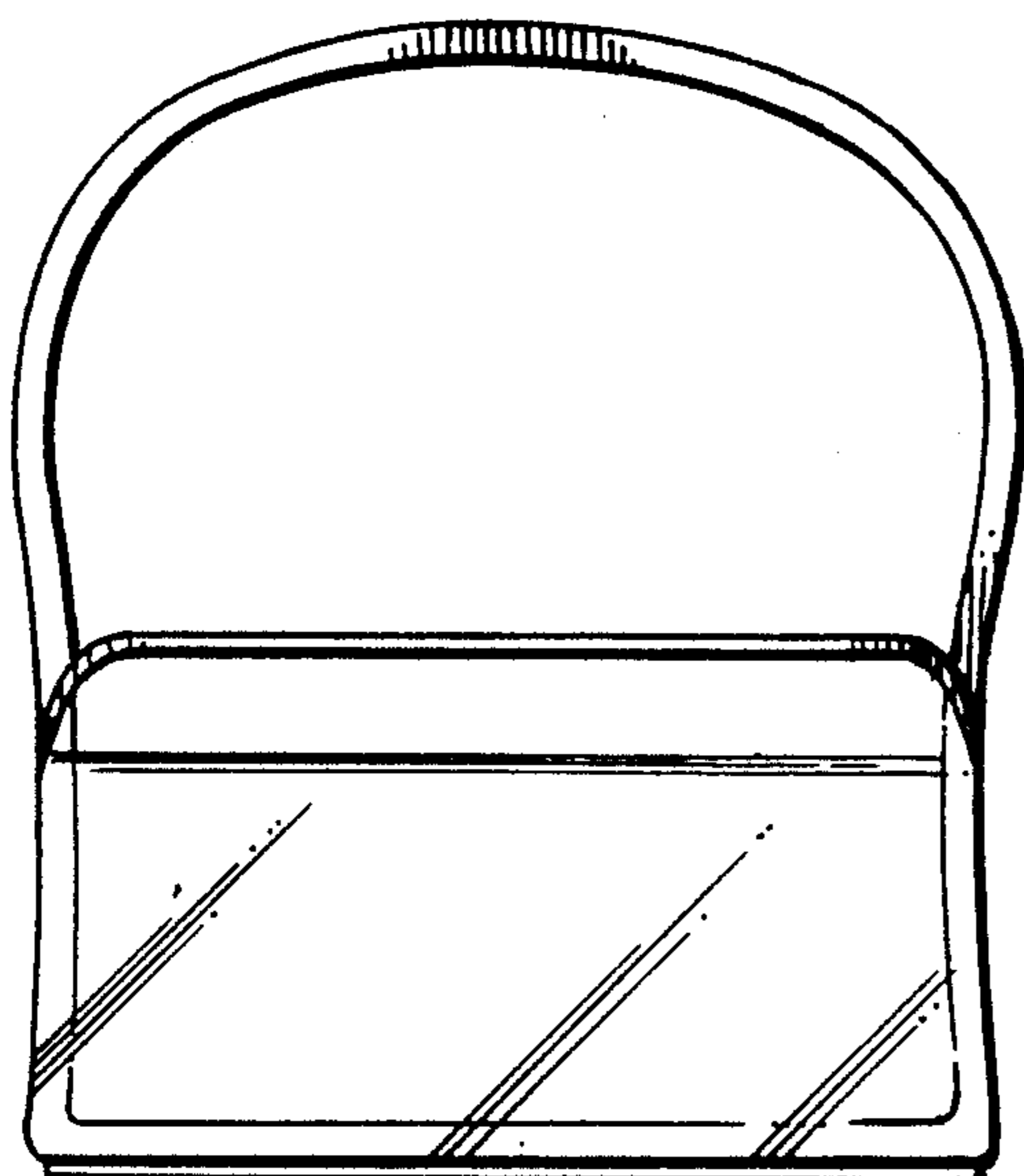

**DESCRIPTION**

FIG. 1 is a front elevational view of a slicing guide showing my new design;

 FIG. 6 is a right side elevational view thereof.



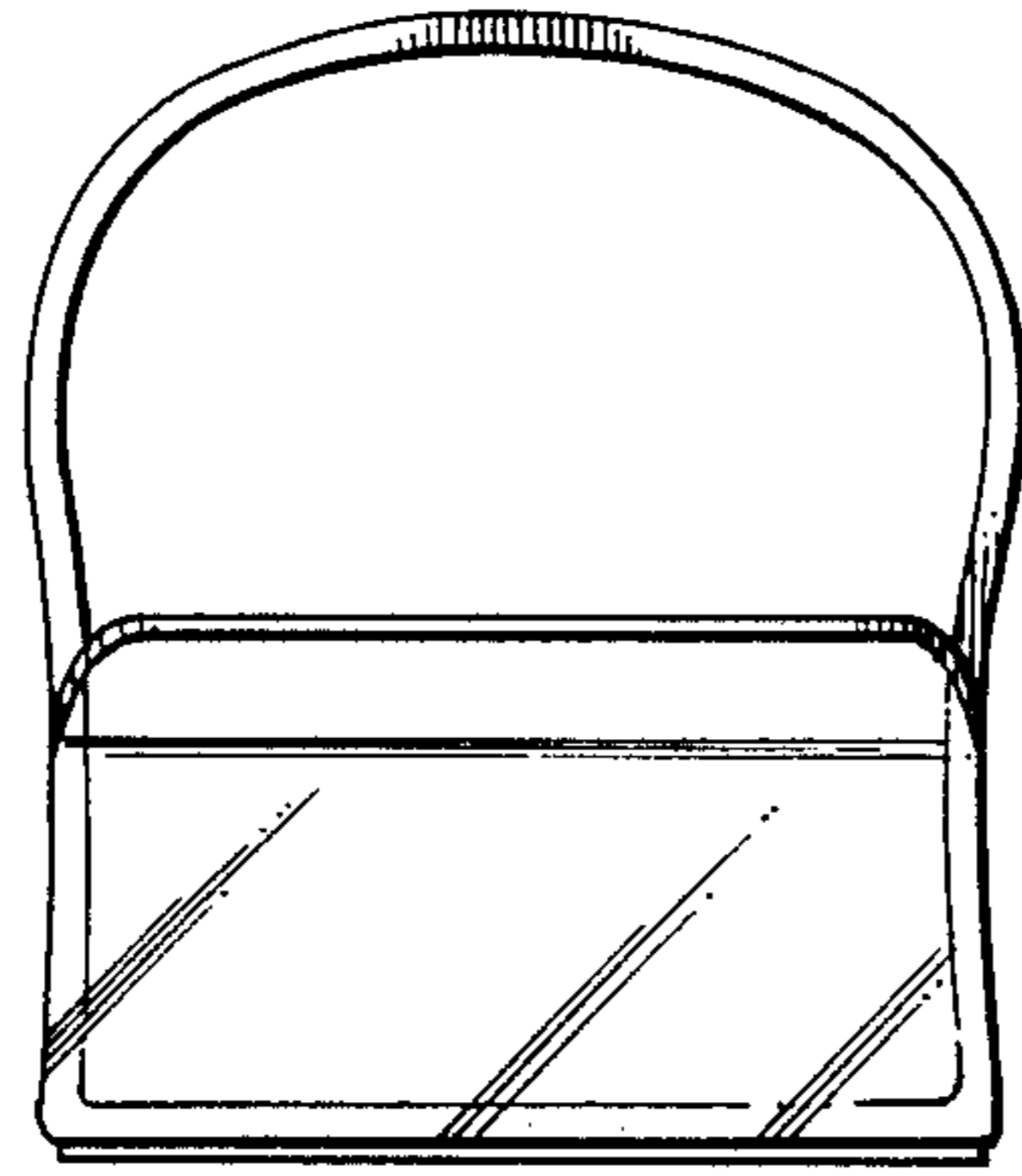

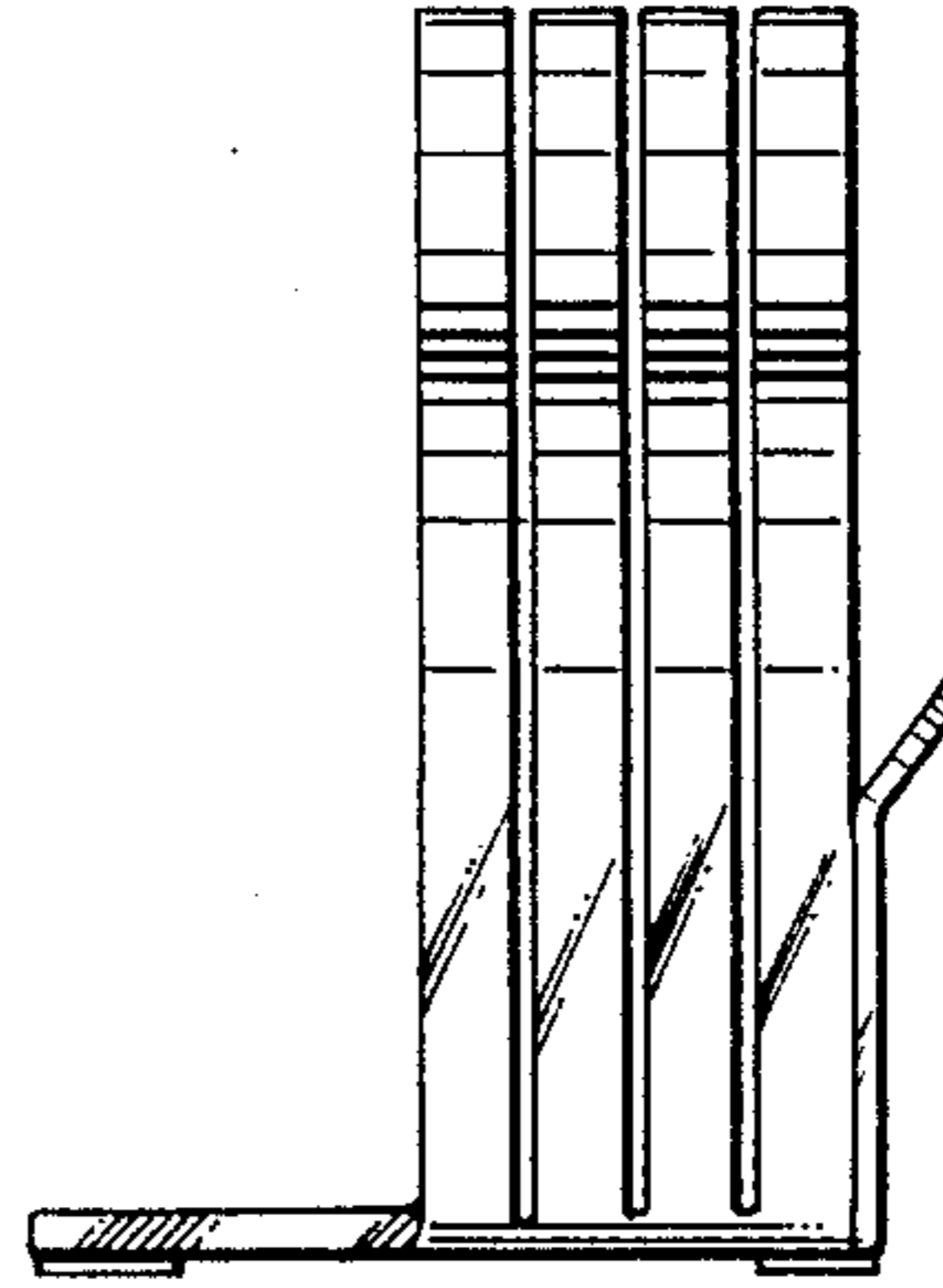

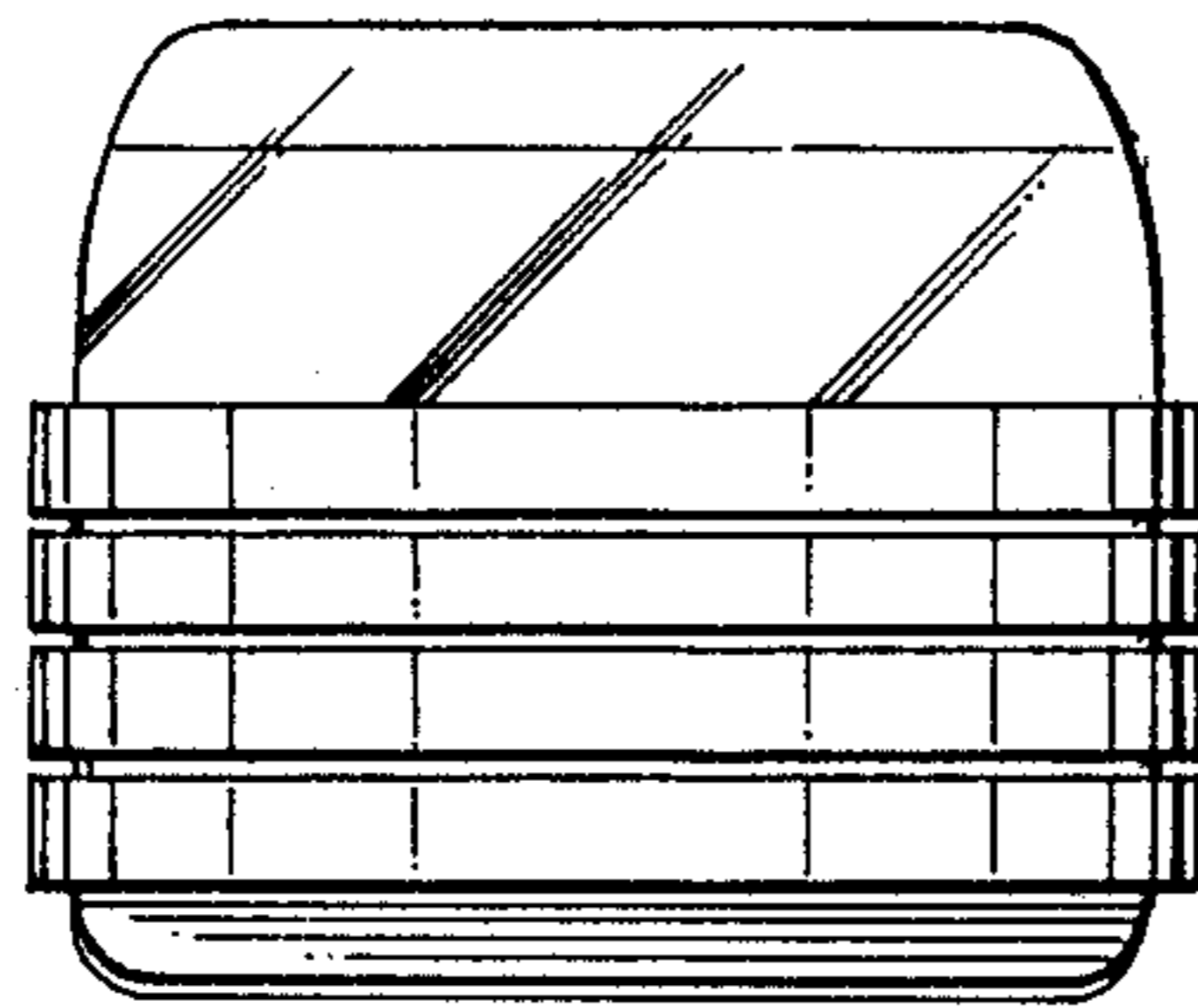

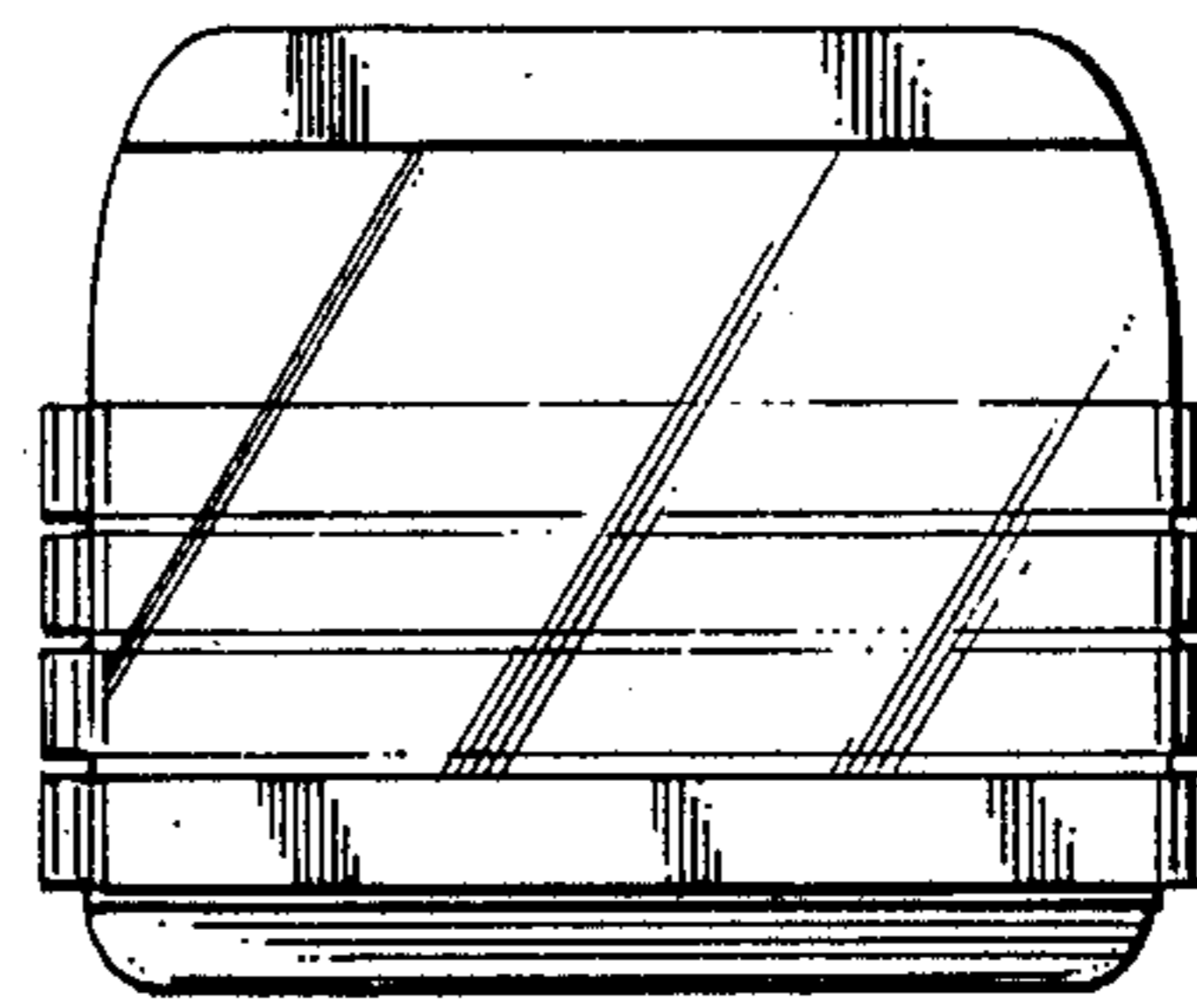

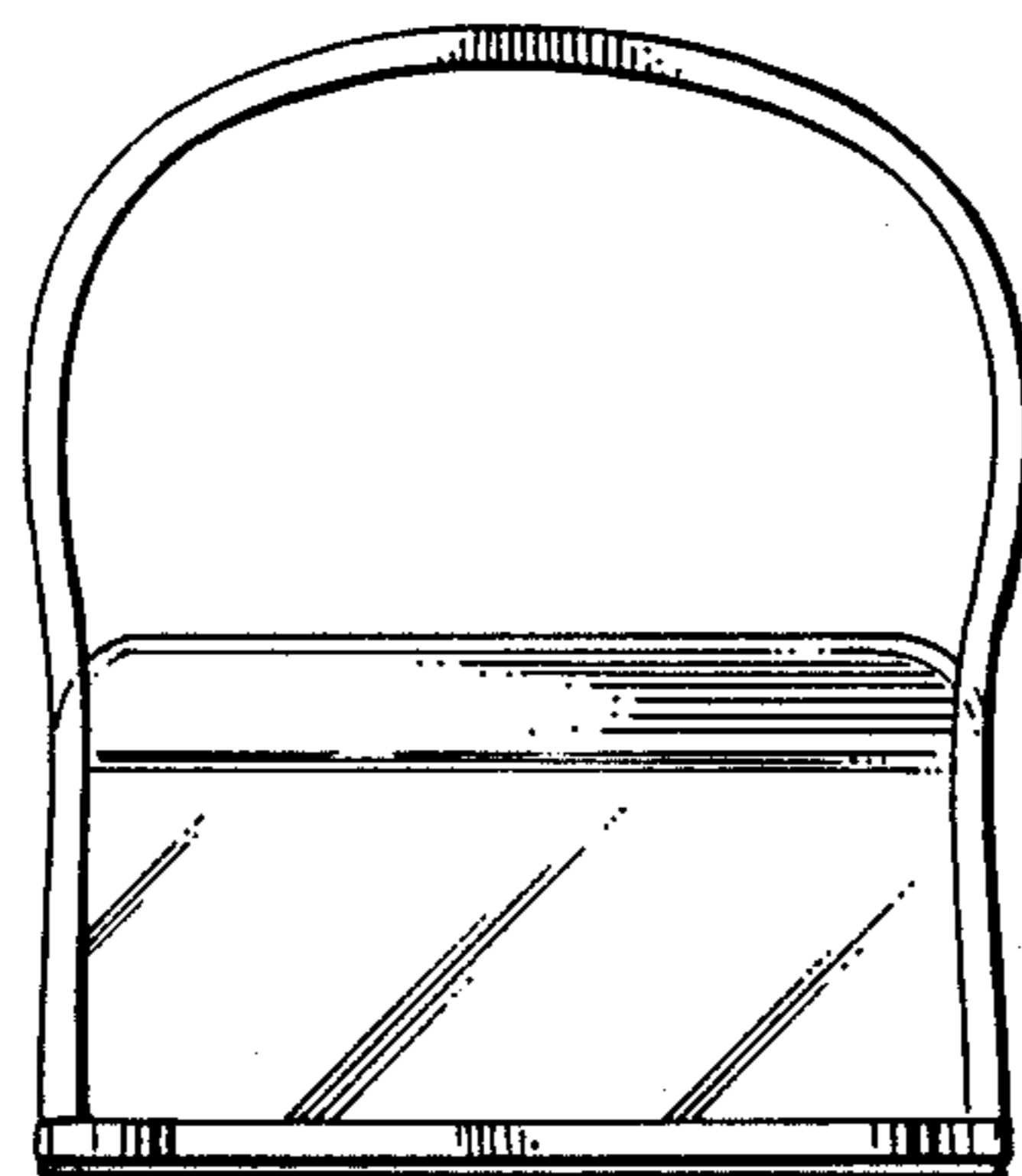

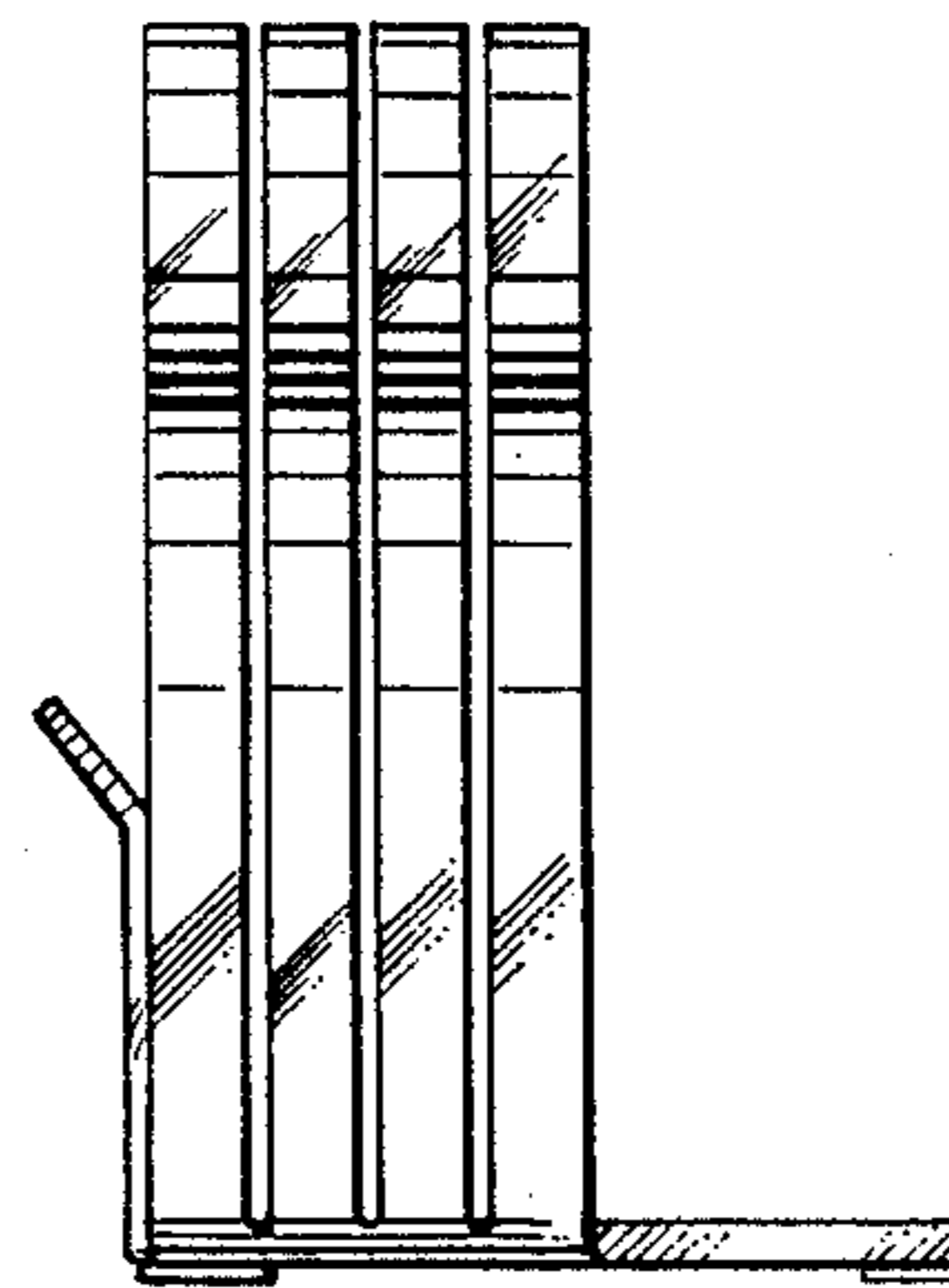
