[57] **CLAIM**

The ornamental design for a roller wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective partial view of a roller wheel showing my new design positioned within environmental structure which is depicted in broken lines for illustrative purposes only and forming no part of the claimed design;

FIGS. 2 and 3 are respectively one side elevational view thereof, and an elevational view of the opposite side; and

FIG. 4 is a rear elevational view of the roller shown in FIG. 1.

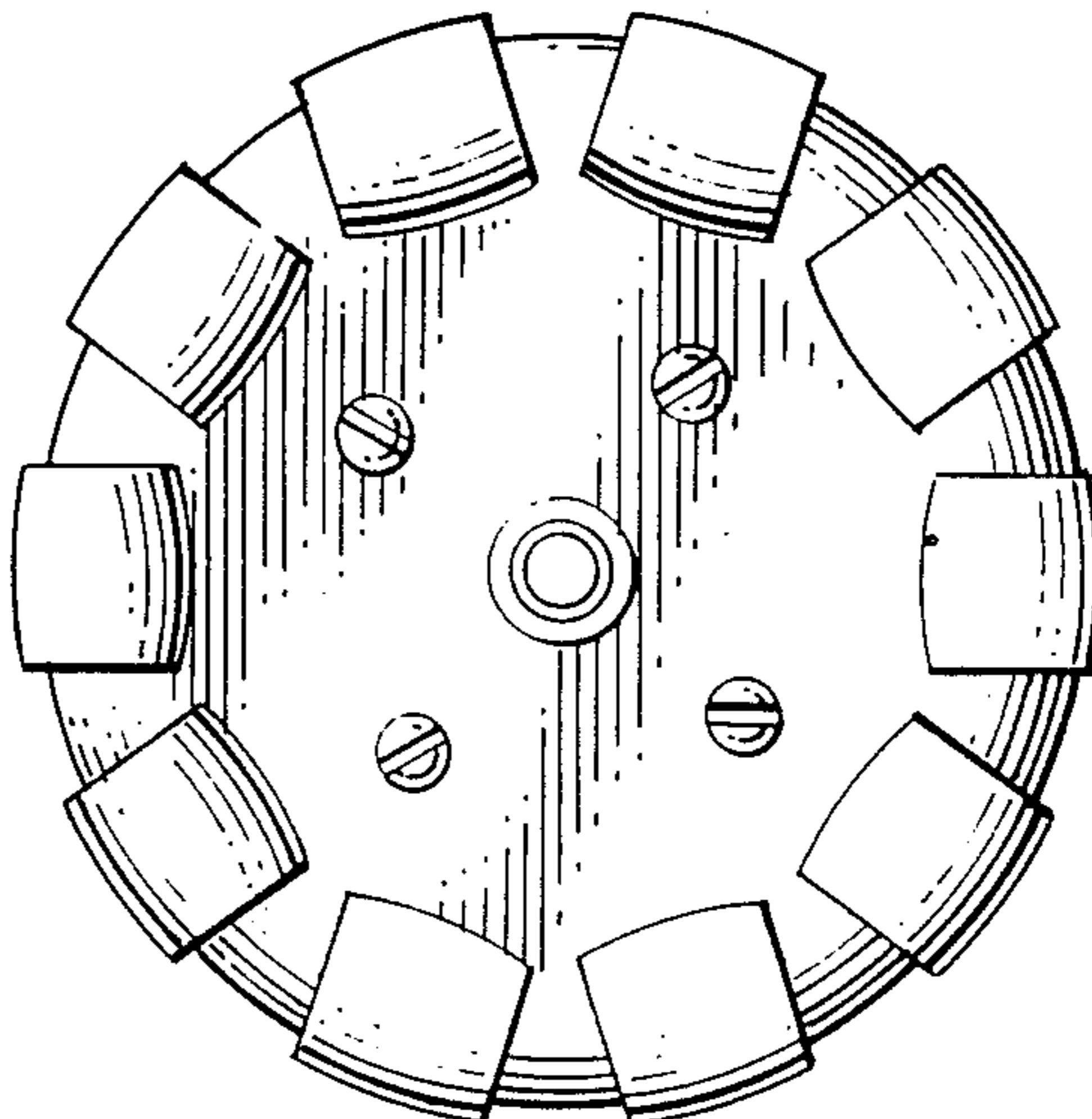
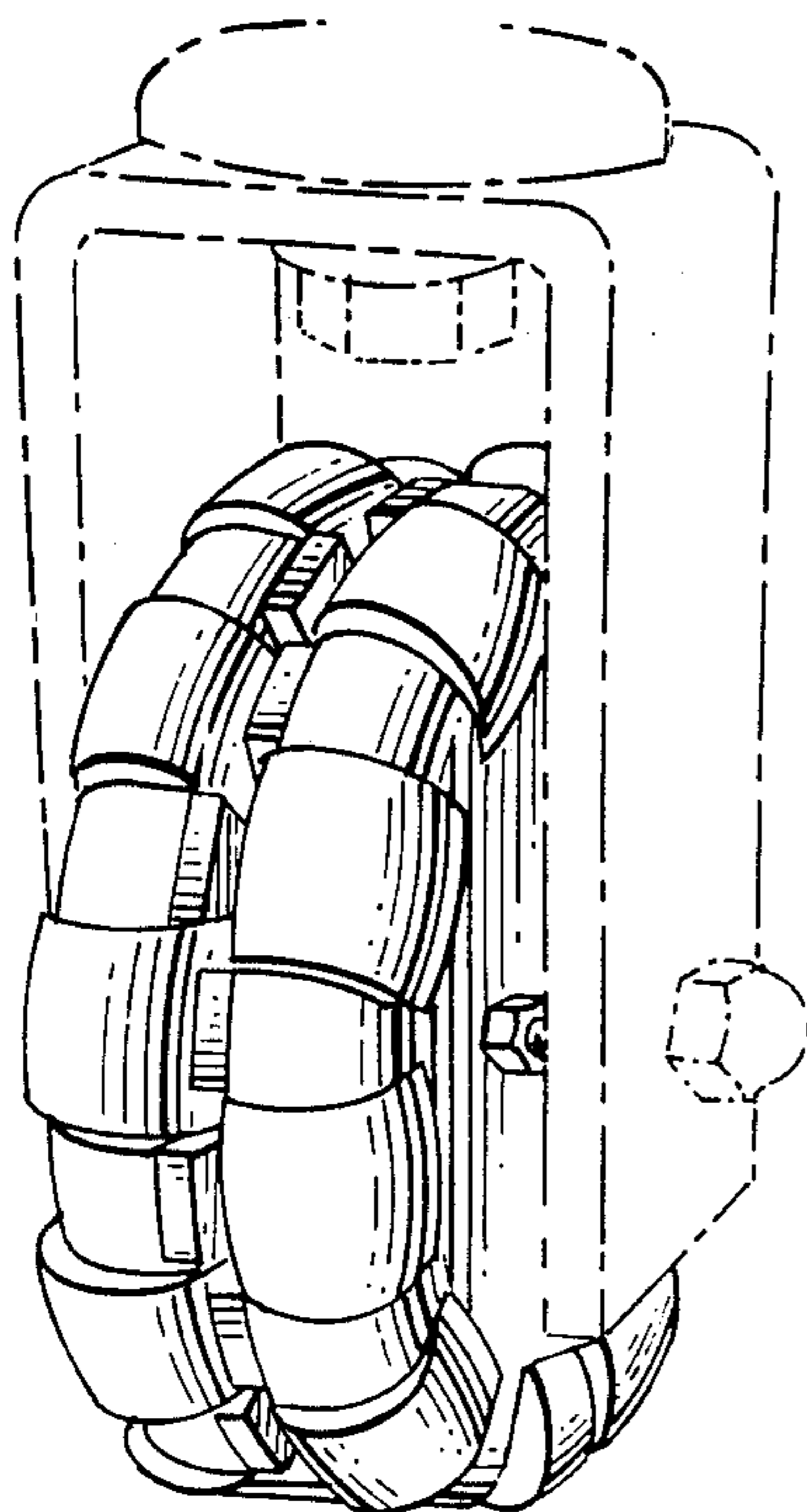

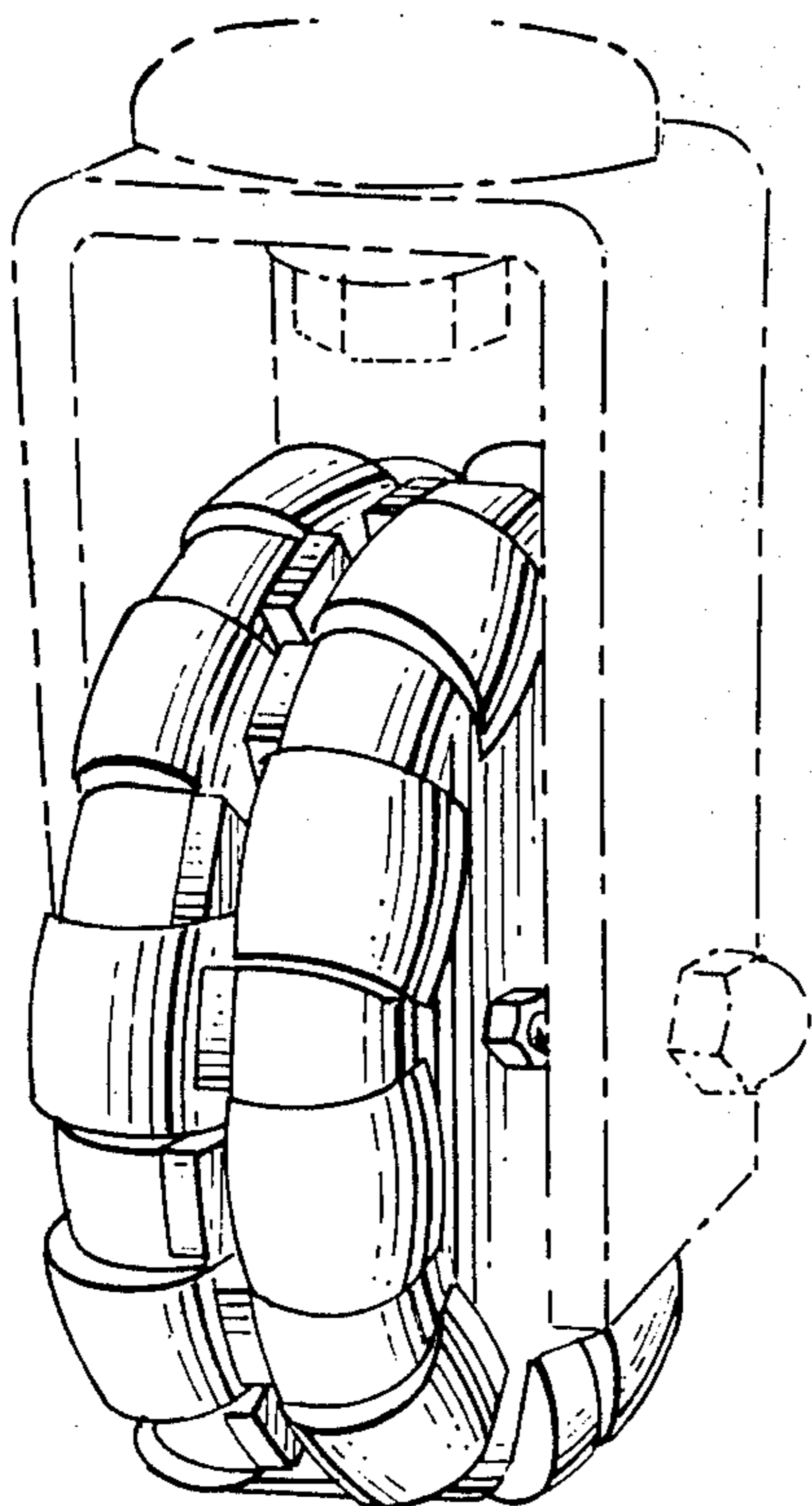

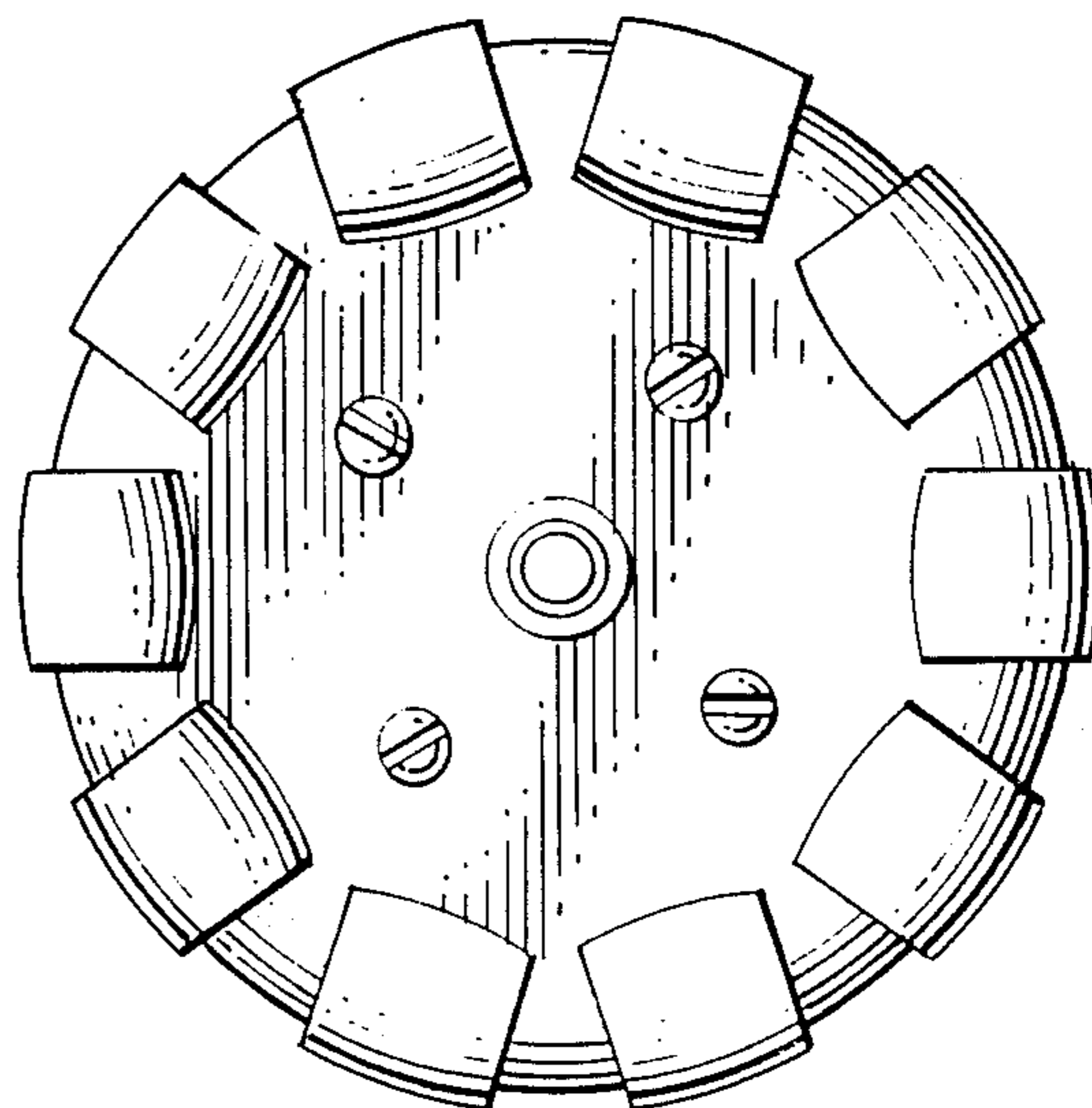

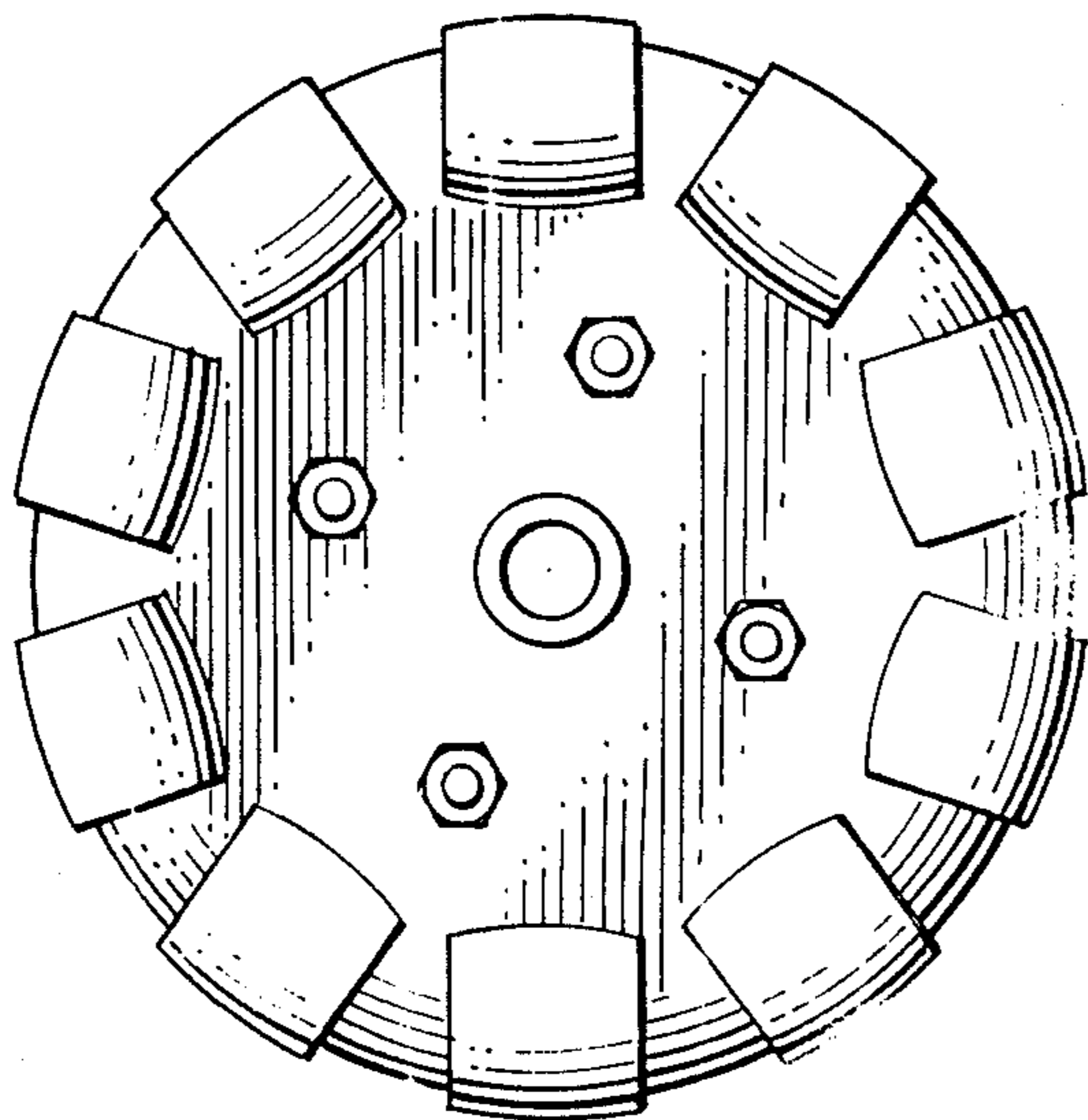
